Antiques and Fine Chocolates Store Opens in Kewaskum

Visions of candy counters from days gone by bring back memories of noses pressed against glass cases and big decisions over a few pennies. Now, thanks to Barb and Jerry Vanderwall, Kewaskum can enjoy some of Chicago's finest chocolates, along with a selection of antiques at their new store located at 131 Main Street, aptly named, "Antiques and Fine Chocolates."

The couple formerly operated the Gingerbread Antique Mall in Waupun, until the roof caved in and the owner wouldn't fix it. Their collection of antiques was moved into the garage, which meant no more room for the cars. After a period of three years searching for an ideal location, the Vanderwalls found what they were looking for in Kewaskum.

"I've always collected antiques," Barb recalls, starting with dolls and added on until her hobby became big enough to start a business. "Antique shows became a great place for us to learn, compare prices, and generally see what's available. It's a lot of fun because you never know what you're going to find."

Throughout the years, she noticed that the nicer pieces were getting more and more difficult to find. Auctions are another favorite haunt of the Vanderwalls, "and it used to be easy to find twenty items we liked there. Now it's common for us to find only one," she points out, "but it's a great place to meet alot of nice people." They also enjoy traveling out east in search of antiques, since the farther west you go in the country, the less you'll find to choose from.

Their new store offers a general line of collectibles, which means, "a little bit of everything." Since they hand pick their items, many are unique and have a story behind them. "This shoe-shine box is from a depression," Barb holds up a wooden box fashioned out of recycled fruit crates. "It's a little piece of America." She points out a turn of the century tricycle with metal wheels and a 1927 black "Hattie" doll, a rare piece made by Louis Sarge. An old erector set in the original box was the first one made, set next to an old wooden butter churn from 1840.

The two rooms are arranged so the areas remain uncluttered and easy to take

in, and the antique enthusiast can find furniture, toys, books, pictures, steins, old trunks, glassware and bowls, in a variety of price ranges. "We will be offering a large selection of furniture... pine tables, Hoosier cabinets, Vanderwall adds, "But we aren't moving it in quite yet because of the snow."

Antiques can also be brought in on consignment, or, if you have a question about a keepsake that's been in the family for years, bring it in and Barb will try to help.

The Vanderwall's line of fine chocolates were chosen from the Chicago area after sampling a variety of brands throughout the region. Rendered the *best* by their taste buds, their candy counter includes both dark and milk chocolate, filled with delicious caramel, coconut, nougat, nut clusters and more. It's impossible to leave the store without a box of your favorites in hand. (Take it from me!)

Antiques and Fine Chocolates is open from 10 to 5, Monday through Saturday, with plans to add Sunday hours once summer is here.

Centennial Plans Progressing Nicely

Momentum is picking up as members of Kewaskum's Centennial Committee gather to make plans for "Centennial in the Kettle - A Heritage Experience," celebrating the village's 100 years.

The historic event will be held June 10th at River Hill Park, and the committee invites all organizations and groups to send a representative to their next meeting, taking place February 13th, at 7 p.m. in the Council Room of the Municipal Building.

Special fund raising items and collectibles have been circulating throughout the village, including the centennial ornament picturing Chief Kewaskum, candy bars wrapped in the 100 year theme, collectible green lapel pins, and the recent arrival of 5,000 wooden nickels imprinted with the date of the village's incorporation (May 7, 1895) and the first official meeting which took place June 10, 1895. These will be sold for 50 cents each and can be redeemed for items sold during the celebration on June 10th. All articles mentioned above can be purchased at The Kewaskum Statesman, the Village Hall and many other business places throughout the village, and most items will be available at River Hill Park the day of the celebration. Centennial banners will be on display throughout the village and individuals, as well as businesses, may purchase one.

One of the highlights of the day will be an Indian ceremony, with Native Americans from the American Indian Center in Milwaukee explaining their culture through song and dance. This multi-cultural event involves three tribes, scheduled to perform at 1, 2 and 3 p.m.

A great lineup of musical entertainment is scheduled throughout the day of Centennial in the Kettle. The beer garden will be featuring the well known German sounds of the Alte Kameraden Band from Freistadt, big band music from Howard Schneider, and something for all those coun-

try music lovers by the Lonesome Highway Band. Music scheduled for the band stand in River Hill Park throughout the day, includes the Kewaskum Jazz Band, Twin Hill String Band, and the Goodtime Dutchmen.

A historic wagon train ride will travel from Ashford to Kewaskum, complete with wagons, carriages, buggies, and some will west riders all gussied up in clothing depicting the styles of 1895. Don't miss this one of a kind which we may not see for the next hundred years. If you would like to take part in the Centennial Wagon Train, please contact Dan Nauman or Bud Schmidt.

So far, other activities planned for the day include an opening ceremony with speeches and announcements, a Brownie/Girl Scout fashion show of period clothing at the band stand, a Jaycee's time capsule, as well as craft displays, fireworks, and lots of eating all the great food which will be available on all ends of River Hill Park. Desserts from the Women's Club will top off the wide array of food items and beverages being offered thus far, from the Kewaskum Kiwanis and Lions, Fire Department, Chamber of Commerce, Sno Chiefs, Legion and Ladies Auxiliary.

The Centennial Committee had discussed the idea of offering train rides through the Great Lakes Western Rail Tours, Inc., but lack of funds and manpower placed the idea on the back burner because of the \$20,000 price tag for the day. Unless someone can come up with an idea on how to raise the funds to cover the cost of the train rides, the event will be curtailed.

The Kewaskum Historical Society Museum will be open to the public, and visitors can take a step back through Kewaskum's heritage and get into the 1895 time frame.

It is also hoped some local artisans will be able to set up displays and demonstrations and members of the community with age-old skills will share their artistry to add to the authenticity of

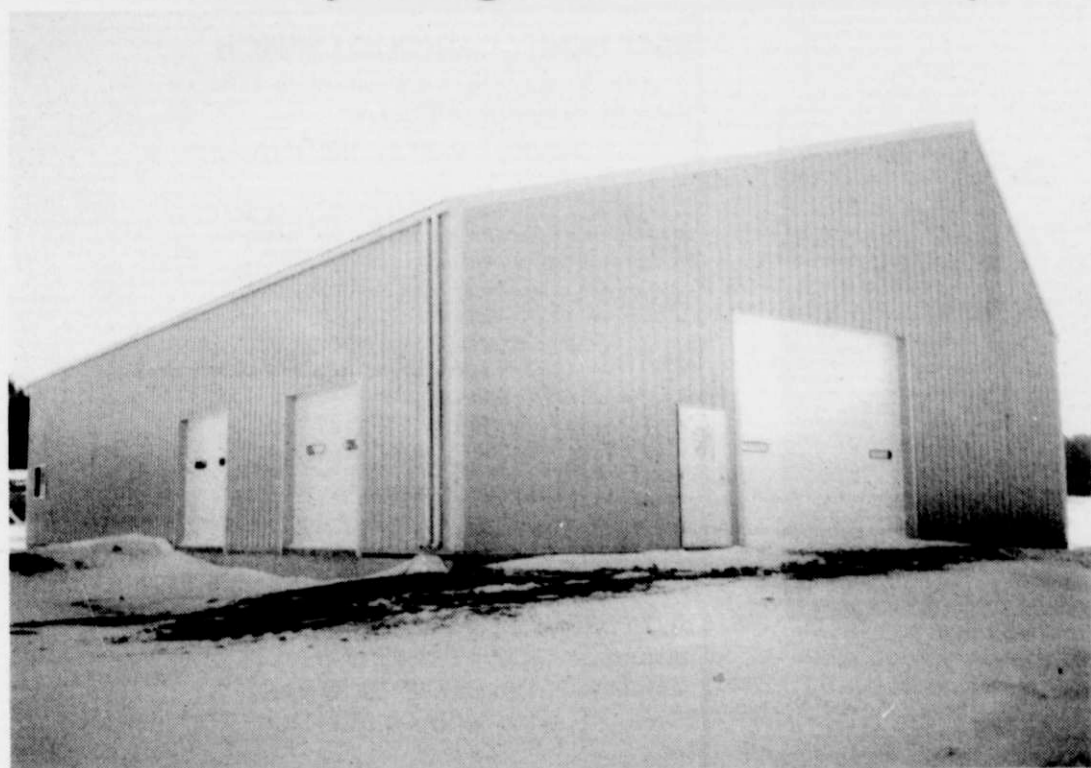

Town of Kewaskum Opening New Recycling Center Saturday



The new Town of Kewaskum Recycling Center located on Kettle Moraine Drive will be open this Saturday from 10 a.m. to 4 p.m.

At their January meeting, the Town of Kewaskum board announced the new recycling center for town residents will officially open on February 4, 1995.

The center located on Kettle Moraine Drive near the Kewaskum Town Hall will be open Saturdays from 10 a.m. to 4 p.m. The opening of the new 72' by 48' structure will mark the official closing of the recycling center on Hickory Drive.

The town reviewed bids for a plastics baler and will be purchasing one for use in the recycling center. Town Chairman George Allmann explained by law the town must accept recyclable plastics. At present, the town pays to have the plastics hauled away. If the plastics are baled, the town will receive payment for them. In addition, the baled plastics will be easier to store.

Dan Wilson from the UW Extension Office was in attendance to give a presentation on land planning. He

advised change will come and it is best to be prepared for it with a land use plan. An updated plan will help the town achieve planned objectives. Planning saves time, effort, money and provides support for future decisions that must be made.

Funds have been allocated in the 1995 budget for a town planner. Town board members will review several different options to determine which option will best serve the town needs.

Town resident Tom Gibson came before the board questioning the increase in assessed value of his property. Town assessor Ray Weinhold explained how the value was determined. The town board will delay a decision for 90 days to review all materials presented by both parties.

Town residents Ray and Agnes Schaefer appeared before the board to explain their position in the line fence dispute. Town board supervisor Rick Welch read Wisconsin State Statute #90 as it relates to line fences.

After much explanation and discussion, the board reiterated their decision regarding the line fence. The line fence must be built by March 15, 1995.

The Town of Kewaskum caucus held in early January, resulted in the nomination of the following individuals: Town Chairman, George Allmann; Town Supervisor, David Dorn, Michael Lettow and Richard Welch; Town Clerk, Barbara Wenzlaff and Town Treasurer Daniel Stoffel. Election for the various offices will be held on Tuesday, April 4, 1995.

The next town board meeting is scheduled for February 20, 1995 at the Kewaskum Town Hall.

County Veterans Receive State, Federal Benefits

Veterans in Washington County received an estimated \$15,495,698 in veterans' benefits from the state and federal governments during 1993, according to a report by the Wisconsin Department of Veterans Affairs (WDVA). This figure includes \$11,281,110 in

Guaranteed Home Loans.

Of the total amount, \$425,662 was disbursed by WDVA and \$15,070,036 came from the U.S. Department of Veterans Affairs (VA).

In the report, WDVA Secretary Raymond Boland said the county veterans service officer was instrumental

in helping veterans get the benefits they've earned.

"As a result of the county veterans service officer's effectiveness, veterans and other forms of economic assistance that stimulate the local economy, education benefits that improve the veteran's employability and overall quality of the county's workforce, and home loans that boost the housing market and

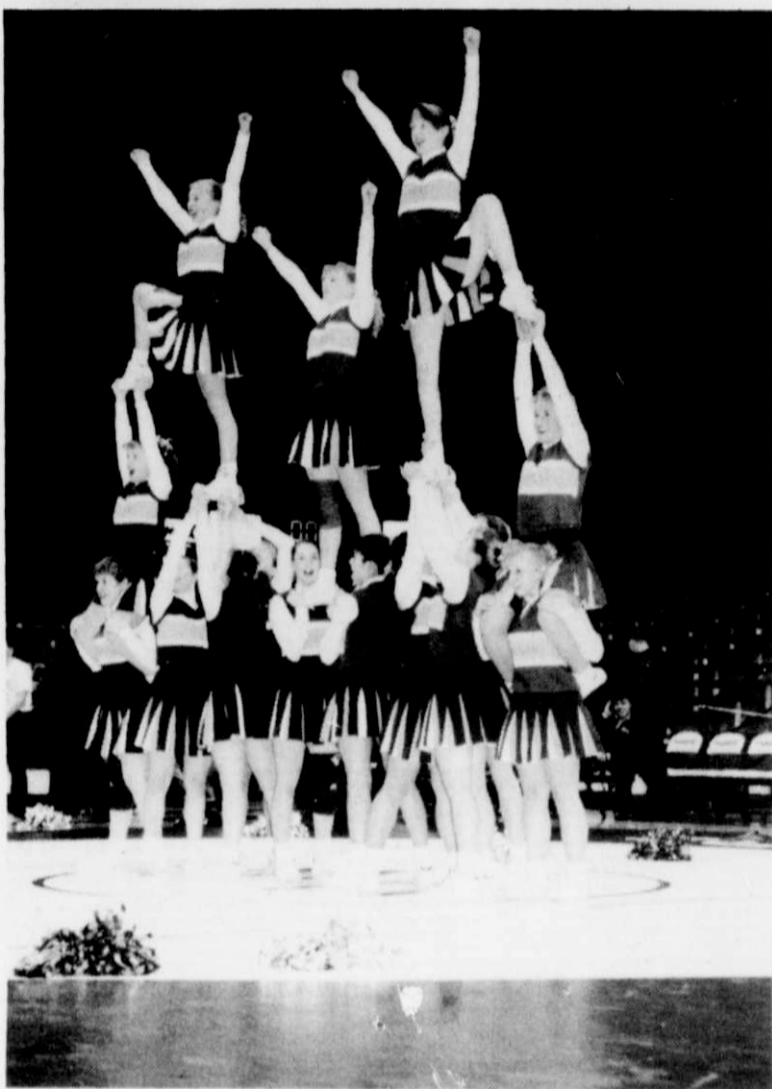

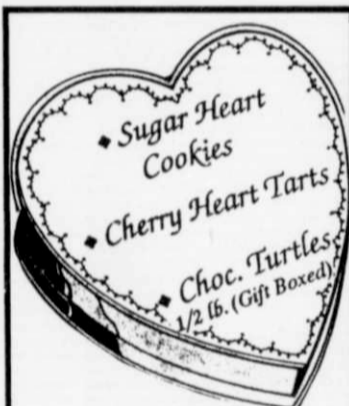

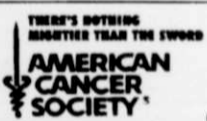

St. Francis Capital Corporation Announces 1st Quarter Earnings

MILWAUKEE -- St. Francis Capital Corporation (NASDAQ:STFR) on January 25, reported a modest decrease in earnings but increased earnings per share for the three months ended December 31, 1994, the first quarter of its fiscal year.

Net income was \$2.29 million for the three months ended December 31, 1994, compared with \$2.35 million for the three months ended December 31, 1993. Earnings per share increased 15.2% to \$0.38 for the three months ended December 31, 1994, compared with \$0.33 for the three months ended December 31, 1993. The higher earnings per share for the three months ended December 31, 1994 was the result of a lower number of shares outstanding during that period compared with 1993. The results for the quarter include the results from the Company's acquisition on November 21, 1994 of two bank offices from M&I Corporation. The new offices are being operated as a separate bank subsidiary called Bank Wisconsin.

"We are pleased with the results of our most recent quarter," stated John C. Schlosser, President and Chief Executive Officer. "The Company has achieved higher earnings per share in the face of significantly increased interest rates over the past twelve months."

Although total earnings were virtually unchanged, the Company experienced an increase in net interest income offset by a decline in other operating income and an increase in general and administrative expenses. The increase of \$1.38 million in net interest income is primarily the result of the Company's larger base of earning assets which averaged \$1.04 billion during the three months ended December 31, 1994 compared with \$825 million during 1993. The assets acquired in the Bank Wisconsin acquisition are included in average earning assets from November 21, 1994 to the end of the quarter. Other operating income declined \$701,000 as a result of a decline in gains on investments of \$861,000 partially offset by increases in various fee incomes. The decline in gains was primarily due to the effect of the general increase in interest rates on the Company's mortgage operations and in the Company's mortgage-backed securities portfolio and related option positions. G&A expenses increased \$905,000 primarily as a result of increased expenses from the Bank Wisconsin acquisition and expenses of the Company's affordable housing development subsidiary.

Total assets at December

31, 1994 were \$1.15 billion, an increase of \$123.8 million or 12% from the \$1.03 billion in assets at September 30, 1994. Of this growth in assets, approximately \$85 million was obtained from the acquisition of Bank Wisconsin. Loans receivable increased by \$73.6 million although the increase, other than that acquired through Bank Wisconsin, was \$27.9 million. Funding the growth in assets was an increase in deposits of \$93.8 million (of which \$71.8 million was acquired from the Bank Wisconsin acquisition) and an increase of \$43.7 million in borrowings.

Non-performing assets totaled \$7.6 million or 0.66% of total assets at December 31, 1994, compared with \$7.7 million or 0.75% of total assets at September 30, 1994. The allowance for loan losses increased to \$4.2 million at December 31, 1994 compared with \$3.4 million at September 30, 1994. The increase was primarily due to the Bank Wisconsin acquisition which added \$694,000 to the Company's allowance for loan losses. Net charge-offs for the three months ended December 31, 1994 were \$13,000. "The asset quality of the Company continues to compare favorably with that of our peers," commented Schlosser.

The Company's book value per share was \$19.86 at December 31, 1994 compared with \$18.40 at September 30, 1994. The Company adopted a change in accounting for ESOP plans which affects the calculation of book value per share by excluding from the calculation those ESOP shares not yet released to employees. Without the change, the Company's book value per share would have been \$18.57 at December 31, 1994. The future effect of this accounting change will lessen as shares are released from the ESOP plan.

St. Francis Capital Corporation, with \$1.15 billion in assets, is the holding

company for St. Francis Bank, F.S.B., and Bank Wisconsin. The Company operates 18 offices in Kenosha, Milwaukee, Ozaukee, Washington and Waukesha counties.



Why Should I Belong to a Club

What can a club do for me?

The most important thing a club can do for you is to provide 25,000 miles of some of the best trails in the United States right here in Wisconsin.

In Wisconsin each county has a county level association or alliance which are made up of almost all of the local clubs in that county. All of the officers and directors of that county organization are made up of members of those local clubs.

The AWSC is a state level organization with directors from each county level organization which again is made up from local clubs. Every mile of trail in the state of Wisconsin is made possible, not at the state level, or at the county level, but, you guessed it. Right back at the local club. The DNR does not put in the trails. Neither does the state or the county. It is all done at the local club level.

How do we get these trails and where does the time and money come from to make

them all possible?

To start with, every hour that is worked by club members, is time that is donated along with the equipment that is needed to make it happen.

Before a trail is even started, someone has to lay out where you want it to go. Then go to each landowner and get permission to cross his or her property. The landowners also donate the use of their property. So keep this in mind when you are on the trails. Please respect the land you are on. Stay on the trails. Once we have the agreements of all the landowners, we then have to make sure the groomer can get through without breaking anything on the drag or groomer itself. This means we sometimes have to remove rocks, stumps, or sometimes small trees, if we get the landowners' permission. We then go through and put up stacks and mark the trails with signs, so everyone knows where they're at.

What does it cost to put in and maintain a trail system?

For each mile of trail it

takes approximately 18 blazers at \$2 each, 18 2x2's at 75 cents each, four stop signs at \$4 each, and eight information signs at \$5 each. For a grand total of \$110 per mile.

When the trail is all in and the snow comes, the trail has to be groomed. A good groomer can cost anywhere from 10 to 70 thousand dollars. Then you need a drag. They cost from three to six thousand dollars. What about fuel to run the groomer? When it breaks down, who fixes it? Who drives it? Donated time again by a club member.

In the spring when everyone has put their machines away for the summer, and getting their boats ready for the lakes, the club members are back out taking down the signs and stakes. They're taking them apart and putting them away to wait for the next fall.

We hope they will let us use the trail again next year.

One more time. What can my club do for me? Or in the words of the late John F. Kennedy, Ask not what my club can do for me, but what can I do for my club.

A Message from Bonnie

Hello Kewaskum Statesman readers and how are you all doing today? Well, winter has settled in. Sorry to say that I could not bring back some warm temperatures from Florida to you all. Before I get "into the trip," I have some Postal news to share with you.

As you know, postage rate increases went into effect January 1st. We do have an ample amount of three cent stamps for those of you who still need them. Postage for a letter up to an ounce is 32 cents and 23 cents for additional ounces.

The postcard rate is now 20 cents and we also have one cent stamps available. The 32 cent stamps are available in singles, books of 10 (\$3.20), books of 20 (\$6.40), self adhesive sheets (\$5.76), rolls of 100 (\$32) and rolls of 500 (\$160). Stamped envelopes are now 38 cents.

For those of you that have various "odd" amount stamps lying around at home, just write down what you have, stop in and we will be more than happy to assist you in purchasing stamps to "add up" to the new postage rates.

For those that use our vending machine, the 32 cent stamps are now available. To assist you, 35 cents will give you one 32 cent stamp and 3-1 cent stamps. \$1 (in change) will give you 3-32 cent stamps and 4-1 cent stamps and \$1.60 (in change) will give you 5-32 cent stamps.

Many of you are still awaiting the 1994 mint set. I have the list of those interested and as soon as the shipment comes in, I will notify you, okay? For other collectors, we still have a good variety of 29 cent stamps. Please feel free to stop in and/or give me a call and I will be more than happy to assist you.

The only 32 cent stamp available at this time is the "G" stamp and as soon as others are issued, they will be on display in the "showcase" at your post office.

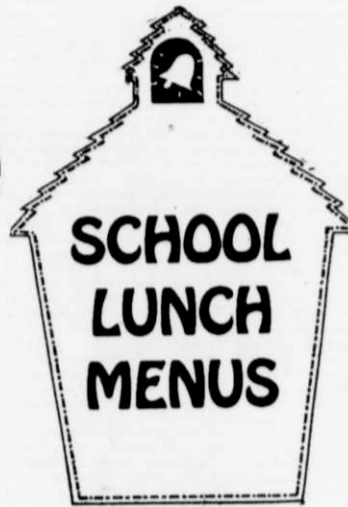
'The Art of Meditation'

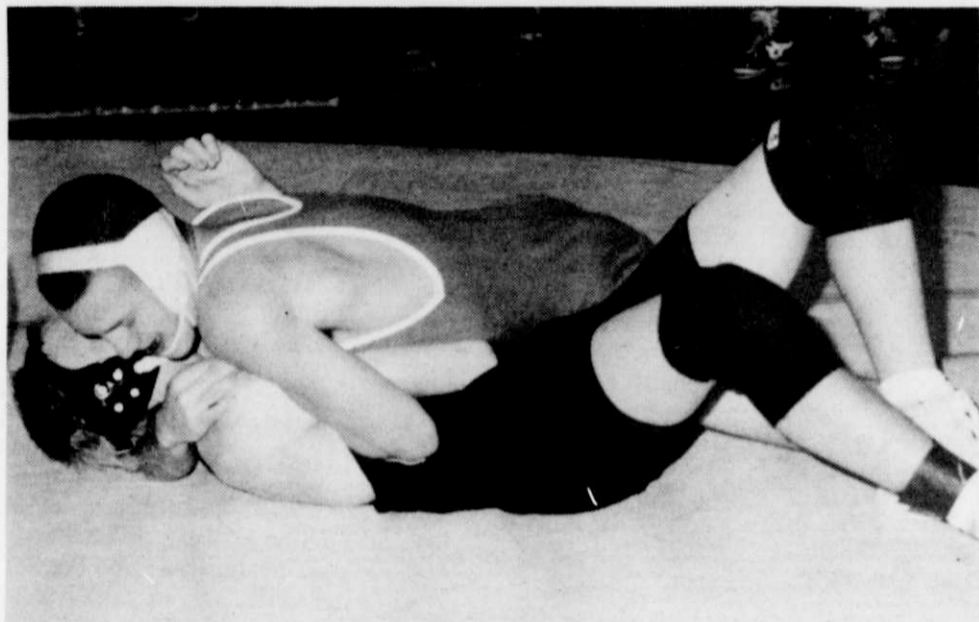

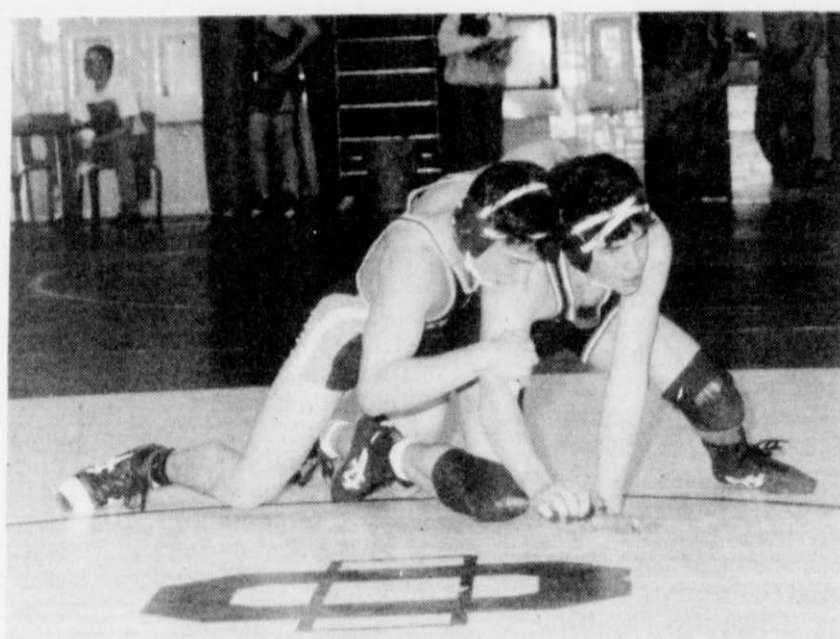

Kewaskum's next game will come on February 3, when they travel to New Holstein.

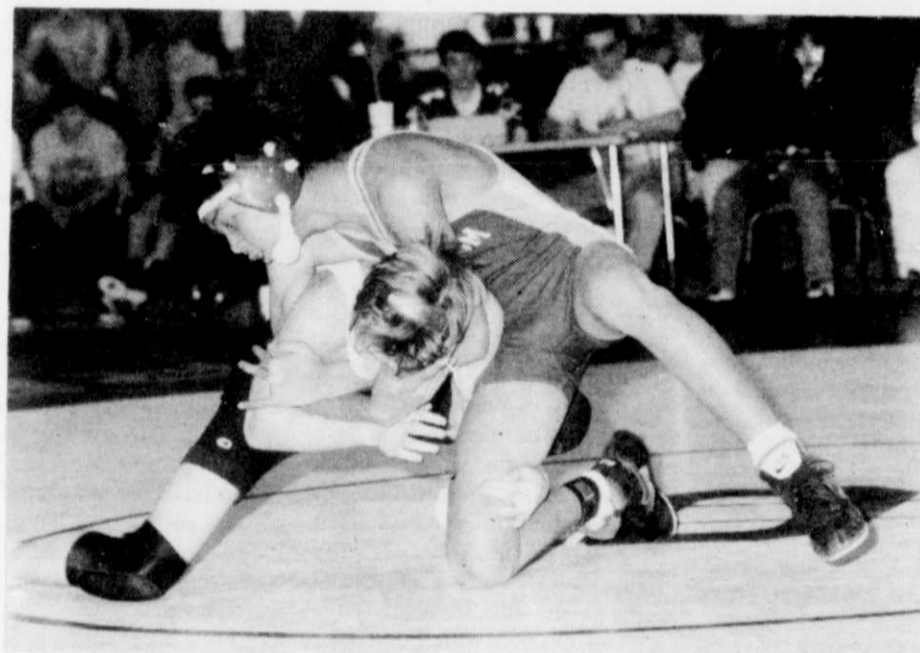
Indian JV's Defeat Random Lake
