Nadalie Reindl Places Second At State Gymnastics Meet

Nadalie Reindl capped off a spectacular season by winning a silver medal at the WIAA Division II State

Gymnastics Meet, held at Wisconsin Rapids last Friday, March 10.

After setting a new Kewaskum High School record on the floor exercise with an

8.7 earlier in the year, Nadalie was definitely "pumped" for the state meet, her second in as many years, in which she qualified for both the floor and the beam exercises.

Nadalie started off the day by netting a 7.6 on the floor, good for 19th place. "I knew what to expect, but I was still a little intimidated," she said of the tough state competition.

Although she expected to place a little higher, Nadalie was still happy with 19th place. "I just had a little too much energy," she said of a slip on the floor, which may have cost her a better score.

Nadalie next focused her energy on the beam, where she was near-perfect enroute to a score of 8.3 which earned her second place and the silver medal.

"She (Nadalie) worked hard in practice, and had a positive attitude throughout the season, and that attitude paid off at state," Kewaskum Coach Irene Heather said of Nadalie's performance. "She had a beautiful performance on the beam," Coach Heather added.

Coach Heather has also nominated Nadalie for all state recognition, an honor in which five of the state's best gymnasts are recommended for their achievements.

Public Meeting Set on US 45 Construction Here

A public information meeting is scheduled for Tuesday, March 28, on roadway construction set to start in April on US 45 in Kewaskum.

The meeting at the Kewaskum Village Municipal Building, 204 First Street, is to start at 7 p.m. Representatives of the Wisconsin Department of Transportation and the primary contractor, Musson Bors., Inc., Rhineland, will be on hand to explain the project and answer questions, said Keith King, WisDOT project manager.

The \$906,121 project will involve 1.2 miles of Kewaskum's main roadway, US 45 between Washington County Highway H and WIS Highway 28. One lane of traffic in both directions is to be kept open. The project is expected to last three to four months, weather permitting, King said.

The project includes a partial reconstruction of the roadway, repaving, widening, curb and gutter, sidewalks and traffic signals at the Highway 45 intersection.

Sno Chiefs to Celebrate 25th Anniversary

The Kewaskum Sno Chiefs Snowmobile Club will be celebrating their 25th anniversary this weekend with a special banquet at Hon-E-Kor Country Club, and a host of state officials from the AWSC will be on hand to help them commemorate this special event.

It was 1970, when Roy Warner, Rosie Kuehl, and George Hanrahan got together and decided the area needed a club for snowmobile enthusiasts. Their very first meeting was held Feb. 22nd at Barney's Hall, where they selected a name for the club and elected officers - Roy Warner, president; Al Zehren vice president; Sharon Kuehl, secretary, and Ed Volm, treasurer.

That was the beginning of their labor of love for the sport, and it did turn out to include a lot of hands on labor. After obtaining permission from landowners to run their trails through local farmlands and woods, club members volunteered their time to layout the trails, clear brush, build bridges and make up signs. They laid out a system of trails that connected with the work of other clubs, creating a network of snowmobile trails that continue throughout the state.

The Sno Chiefs work consists of private trails as well as funded systems, which has to meet approval at county and state levels, including the DNR. Most of the club's trails travel through private

lands, but a small portion does continue through state forest land, offering a scenic view of some of the state's most beautiful landscape. Gas tax money and snowmobile registration help fund these projects.

Their Tucker trail groomer is their third groomer since the club's existence, which they bought used, and is valued at \$35,000. If conditions are right, (which means they get the snow they pray for each winter), the trails are groomed twice a week, with volunteers taking turns. To finance this much needed piece of equipment, the Sno Chiefs sold their own notes, instead of borrowing from the bank. The club now grooms 35 miles of their own trails, and 25 miles for a neighboring club.

Membership in the organization has been holding steady over the past few years, with 60 families enjoying the benefits of their sport. "At the original meeting we had 24 families with us," explains George Hanrahan, "and we peaked in the mid '70's at 145. Now we've stabilized and have a great group of dedicated people who really enjoy the sport."

Considered an important part of the community, the Sno Chiefs raise monies for many local charities, including the Special Olympics. One of their goals is to donate wherever they can, realizing the importance of keeping involved in

Charges Dismissed

Charges of misconduct against former Kewaskum Middle School teacher George Allman, were dismissed in court on March 6th when Circuit Judge James Schwalbach cited the statutes inapplicable in this case.

Allmann was dismissed from his teaching position by the Kewaskum School Board in June of 1994, after it was allegedly reported he acted in inappropriate ways, including telling off-color jokes to students and passing notes of a sexual nature.

He was charged with causing mental harm to a child, by conduct demonstrating substantial disregard for the mental well being of the child, while in his temporary control.

Judge Schwalbach dismissed the charges on Monday, stating that Allmann did not have temporary

or permanent control of the child, according to the statute. As a teacher for the child identified in the criminal complaint, he had ordinary control -- not the control exercised by a parent or guardian.

Meanwhile, Allmann awaits arbitration hearings with the Kewaskum School Board within the next few weeks, seeking reinstatement as a teacher.

Attorney Robert Friebert stated that the charges should not have been filed, since his client's actions were never at any time criminal, and the matter should have remained between the school board and Allmann.

After Schwalbach's decision, Assistant District Attorney Holly Murphy said she will take the case to the State Attorney General's office to see if they want to pursue an appeal.

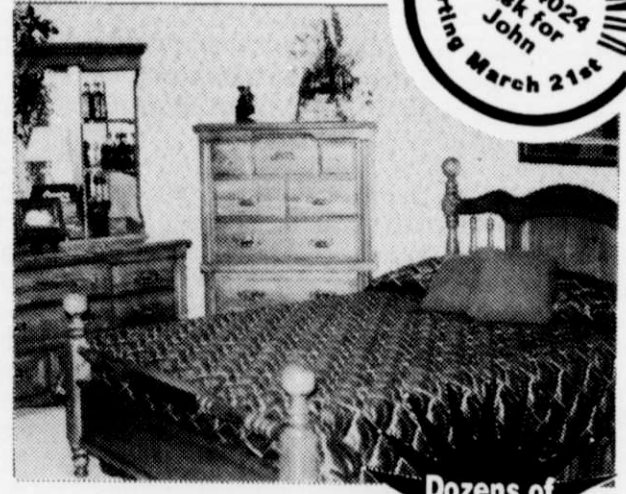

Kewaskum's activities.

Club member Bob Staehler enjoys traveling with the group on snowmobile trips, whether it's a weekend in northern Wisconsin or a trip to the mountains. "Sixteen of us just came back from a trip to Montana, and two years ago we traveled to Colorado," he points out. "We also enjoy fish fries and other activities throughout the year."

The Sno Chiefs remain active in the state association of snowmobile clubs (AWSC), and send delegates to all their functions. 23,000 families within 600 clubs are part of this organization, which lobbies to pass laws and bills which aid in the continuance of their sport. They are also active at the country level, and since 1972, have sponsored and run a snowmobile safety course, with over 1,000 children participating.

The landowners are honored every year at an appreciation dinner and dance, and are also invited for a free pancake breakfast held every year at Kettle Kountry Kolors, sponsored by the Sno Chiefs. Since they are a non-profit organization, all profits go to charities, local events, and the maintenance of their equipment.

Present officers of the club include president Richard Amerling, vice president Joel Jung, secretary Earl Heider, and treasurer Bev Rohlinger. Five board members serve a three year

term. "We formed the club to make trails and to educate the snowmobilers," Staehler adds. "That's how you control things and do away with any problems we have on the trail." The biggest problem they have with vandalism is damage to the signs, people tearing them down, and snowmobiles leaving the trails. This can cause problems for the landowners who are generous enough to allow trails to cross through their property.

"We hope for snow during the winter, and invite more snowmobilers to join our club to experience the enjoyment of the sport," Bob concludes. Their efforts have been a worthwhile addition to the community, that will be remembered for years to come.

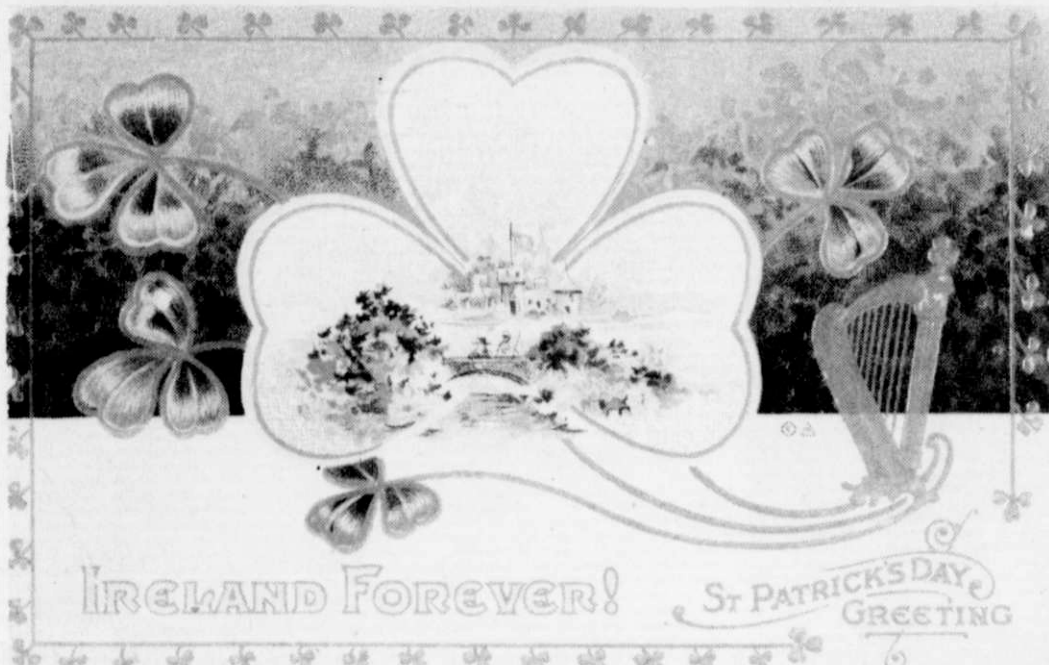

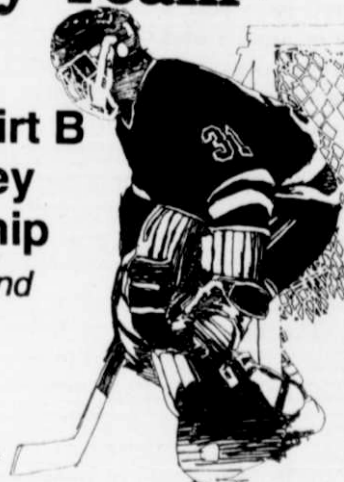

Centennial Wagon Train Rapidly Becoming Reality

It's time to prepare your wagons for the upcoming journey taking place June 10 at Kewaskum's Centennial Celebration. This special trip marks a first in the village's history.

The Wagon Train Committee needs to start organizing the trip from West Bend Elevator to River Hill Park in Kewaskum on the day of the festivities, getting underway around 10 a.m. so everyone can be at the park by noon.

Once again the community is invited to participate on horses or on foot, with wooden wheel wagons, buggies and carriages in an adventure taking you back to 1895. The setting for the event will follow an immigrant theme, remembering how our ancestors once traveled to this region looking for opportuni-

ty. "We'll be making two road crossings traveling along Friendly Drive, onto Sandy Ridge Road," explains Bud Schmidt, one of the organizers of the Wagon Train. "It was probably the trail people generally traveled up from the south on in those days -- they usually used old Indian trails." Bud knows the routine since he's spent years lining up for the Great Circus Parade in Milwaukee. Helpers will be on hand to direct the horses and keep them in line.

Everyone is urged to dress in period clothing, as Bud indicates, "we want to be 1895 for a day." Get out some photos of your great grandparents to get an idea of how they dressed, or visit a costume shop; they have lots of great looks from the past, from a country gentleman to

Sunday go to meeting clothes. Just remember there's a different kind of attire for traveling in a carriage versus riding in a wagon pulled by oxen. Immigrants came to this area from a variety of different social structures, and brought with them a rich diversity of ideas. Speaking of oxen, Bud would sure like to see a team in the Wagon Train, if anyone out there can help out, give him a call at 626-4278.

So far about ten families have signed up to be participants in the event, and hopefully more will join in, but Schmidt and the other leaders need your responses now in order to get an idea of how many wagons, horses and people they are dealing with.

"Anyone that wants to walk with us is welcome," Bud adds. "Remember not everyone could afford to travel by horse and buggy in 1895. Some of our forefathers walked with packs on their backs, and the children rode the family cow. We'd like to see some of that."

Mrs. Lorinda Tessar, long-time Kewaskum resident, will be riding in the fanciest carriage, leading the group through town to River Hill Park. Plan on staying all day to help celebrate Kewaskum's first hundred years.

State Senate Passes Year-Round Ban on Reformulated Gasoline

Senator Mary E. Panzer (R-West Bend) has announced that legislation banning the sale of reformulated gasoline containing more than two percent by volume of MTBE or ETBE, passed the Senate by a 31 to 1 vote. The ban would prohibit the sale year-round.

"I'm extremely pleased this measure passed the Senate by a bi-partisan vote," said Panzer. "This is a major step forward in finding a solution to resolve the problems with MTBE and ETBE and address the concerns of the people of Wisconsin."

Panzer added that a solution at the federal level is the most desirable, and the state will continue to seek solutions in Washington.

"We have appealed to the federal government for a suspension of reformulated fuels so Wisconsin can study the health concerns and other problems people in the affected counties are experiencing," said Panzer. "However, I believe that immediate action is warranted at the state level."

The bill, which will be

sent to the Assembly for debate, would effect 14 days after it is signed into law.

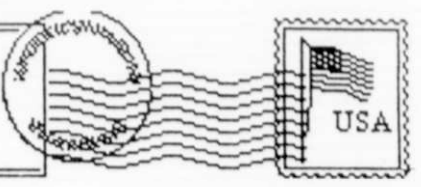

To the residents of the Kewaskum School District,

I asked recently what I liked about being on the school board this year, and what I thought we had accomplished; in giving that same thought, I realized that many people might be interested in what it is like to be on the school board here in the Kewaskum district. Recent letters and articles might indicate that we are sometimes caught up in messy business, that we are often embroiled in controversy, that we disagree with each other more often than not, or that our main interest is "getting our hands all over" your children and your money. I think that is a very unfortunate and inaccurate impression, and I believe that many of us on the board would take exception. We have had to deal with several difficult situations in the past 12 months, and since most of these have occurred in closed session, they are not open for discussion. I can say that I have found that all board members are willing to struggle with the serious issues we have faced, and are willing to put in a large amount of time and effort to do so. The public does not (indeed, cannot) know about this aspect of public service, and I believe that while difficult, it is very important and rewarding.

The public notice when things get "interesting," which is part of human

nature. When I was appointed I learned that the board has established a very workable committee system where the initial details are often worked out, and the time-consuming aspects of an issue are discussed; recommendations then go to the full board for eventual action. The board certainly does not always follow these recommendations. At times, items are sent back to committee; rules and procedures are established and followed to make efficient use of time at what can be very lengthy board meetings. Public input is welcome at the committee level and at full board meetings. Sometimes we trip over our own rules, and then get back up and get to work again. There is not an "official public body" anywhere that does not have a stubbed toe or two, but I have found that this board does have the heart of its decisions, as is our mandate. I have found this whole process interesting, as have many of you.

The board has participated in several important projects this year, including the hiring of two excellent new administrators; passing the renovation referendum; watching the youth apprenticeship program and grant develop; encouraging teacher training and support for dyslexic students; and more. This is the "fun stuff," yet I fear we are in for a rocky road ahead. The board will have to make some painful and difficult choices in the future when we see just how the spending cap will begin to affect programs that we have so far taken for granted. These critical choices will be worked out by local administrators and board members, and I can't think of a more difficult or important task. I hope you all keep yourselves informed, stay involved in your child's education, and be wary of simple answers or

hidden agendas. It has been an exciting 12 months! Stay tuned...

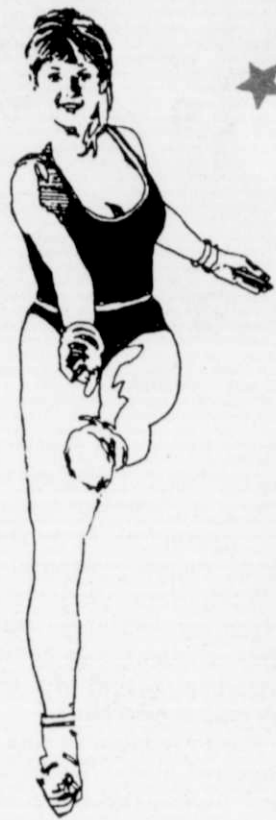

"Eligible homeowners should sign the card, detach it and mail it back to my office by Friday, March 31," Seefeldt advised. "It is a very simple process. Don't set the card aside where it can be forgotten or lost," Seefeldt continued.

"By signing the card, property owners are certifying that they were owners of the property described on the card and that they occupied it as their primary residence on January 1, 1995. The amount of the credit is not known at this time but will appear on property tax bills of eligible homeowners next December," said Seefeldt.

"Every effort was made to reach all eligible parties through the mailing, however, no mailing list is perfect. Homeowners who feel they are eligible, but did not receive a claim card in the mail, should contact my office so that a card can be sent to them," advised Seefeldt.

Bridge Replacement Contract OK'd

Governor Tommy Thompson has approved a \$302,000 contract with Lunda Construction Company, of Black River Falls, for a bridge replacement on WIS 84 in Washington County and a bridge improvement on WIS 84 in Ozaukee County.

Work will begin next summer and take about two months to complete, said Dewayne Johnson, design supervisor for the Wisconsin Department of Transportation. The roadway will be closed to all traffic in the construction areas.

"Both bridges have deteriorated. The project will enhance safety by improving structural integrity and by providing a smoother driving, better skid resistant surface," Johnson said.

Bridge and box culvert replacement is scheduled over the North Branch Milwaukee River northwest of Fillmore in Washington County.

The bridge, built in 1927 and last rehabilitated in 1972, carries about 350 vehicles daily, a number expected to reach 450 in 20 years.

The current two lane, steel plate girder bridge is 25.7 feet wide with a 23-foot wide approach. The new concrete slab structure, also two lanes, will be 26.2 feet wide with a 26-foot wide approach.

Deck resurfacing is scheduled on the bridge over the Milwaukee River in the Town of Fredonia in

Ozaukee County.

The prestressed concrete girder bridge, built in 1967, carries 1,870 vehicles daily. WIS 84 in the area is the major route between Fredonia and Waubeka.

Federal funds are to pay 80% and state funds the rest of the cost of the two projects.

NOTICE TO ALL WASHINGTON COUNTY DOG OWNERS

Pursuant to Section 174.052, Wisconsin Statutes, notice is hereby given to all owners of dogs in Washington County that dog licenses and rabies vaccinations are required.

Vaccination by a licensed veterinarian against rabies is required of all dogs (Section 95.21(2)) within 30 days after the dog reaches 4 months of age and revaccinated within one year after the initial vaccination. The owner of a dog shall have the dog revaccinated against rabies by a veterinarian when the certificate expires or within three (3) years of previous vaccination. The certificate of rabies vaccination must be presented to the collecting official before a dog license may be issued.

All dogs five (5) months of age or older require a license. The minimum license fee for neutered males or spayed females is \$3.00, upon presentation of evidence attesting to the same, and \$8.00 for the unneutered male or unspayed female dog or one-half of these amounts if the dog became five (5) months of age after July 1 of the license year. The governing body of any town, village or city may raise the minimum dog license tax. Any person who keeps or operates a kennel may apply for a kennel license. The fee is \$35.00 for twelve (12) dogs or less and an additional \$3.00 for each dog in excess of twelve (12).

Dog licenses can be obtained from your local town, village or city treasurer or designee during the course of any given year. Dog owners should notify their treasurer if their dog is given away or has died, so that you will not be considered delinquent. An affidavit of death is available.

PENALTY

Every owner of a dog 5 months of age or older who fails to obtain a license by April 1 will be assessed a late fee of \$5.00.

DOT to Make Highway Maps Available in Rest Areas in 1995

The state Department of Transportation says listening to its customers has paid off.

For decades the fear that people would empty map and literature racks and the paper would cause unsightly litter at rest areas had kept such materials out of waysides and rest areas.

But a pilot program last summer in eight Interstate rest areas found that 99.9% of travelers took only one map and other literature that they were interested in. There

were no problems with litter or vandalism.

As a result of the pilot program, the DOT has pledged to have maps and other literature available in all rest areas throughout the state by early May in time for Memorial Day travelers. "We consider the pilot program to be very successful," said Fred Ross, administrator of the Division of Highways.

"We expect that we will distribute between 600,000 and 700,000 state maps a year through these racks," Ross said. "This program is just one example of how the DOT's quality management

effort, which focuses on looking at tour programs from the customer's point of view, is paying off in better service," he added.

The program has been popular with motorists, Ross said. "The comment cards received by the rest area maintenance crews indicate that travelers are grateful for the information."

The DOT is working with the Division of Tourism to provide information about recreational and tourism opportunities in each locality where rest areas are located. "We're excited about the opportunity to inform travel-

ers about the special attractions of our state, and to invite them to spend a few more hours or days exploring our hospitality," Ross said.

The DOT expects to install another 34 literature racks, which will be filled with maps and regional tourism information in time to greet Memorial Day travelers. The racks will be stocked daily by employees of sheltered work centers that provide maintenance services at the rest areas. At four rest

areas in Juneau and Columbia County, a private company located in Wisconsin Dells will be providing additional tourist-related literature for the Dells area and restocking the racks.

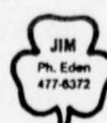
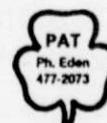

Village Board Meeting Minutes

Mid-Monthly Meeting
February 20, 1995
8:00 p.m.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Mid-Monthly Session in the Council Room of the Municipal Building, 204 First Street.

President Robert Wagner presided. All Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee Charles Waala and unanimously carried by voice vote, the minutes of the February 6, 1995 meeting were approved as printed.

Mrs. Jean Goeden was present to ask permission of the Board on behalf of the Womens Club, regarding the placement of an estimated 10 barrels with flowers on the streets for the Centennial Celebration. The Board by consensus thought the idea was a good one and agreed to support their efforts.

The public hearing on the request of R.T.K.M. LLC to look at alternatives rather than to install the extension of both Highland Avenue and Carrol Road to serve the two R-4 Multi-Family lots. The developers were present as well as an estimated 18 area property owners. President Robert Wagner asked Administrator Daniel Schmidt to give some background on the area. It was noted that the three lots on the eastern Village limits were established in 1980 and have been zoned R-4 Multi-Family Residence District since. It was further noted circumstances and conditions have changed since 1980 regarding the land to the south and east of said land.

Representatives from R.T.K.M. LLC said the request was being made to somewhat limit access and traffic in addition to reducing cost for themselves and the Kettle Moraine Condo Association. It was noted that the layout of the buildings would be nicer with a private drive versus a public street.

Residents from the condo association had some questions

and concerns regarding drainage, traffic, sidewalk and roadway abandonment. They basically felt the private drive would help answer their concerns more than the retention of the public street.

On a motion by Trustee John Borland, seconded by Trustee Charles Waala and carried by the majority roll call vote, the Board closed the public hearing at approximately 9:00 p.m. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent."

On a motion by Trustee David Goeden, seconded by Trustee William Kulas and carried by the majority roll call vote, the Board suspended the rules to take action on IX. A. Discussion and possible action regarding the status of the request of R.T.K.M. LLC to not install extension of Highland Avenue and Carrol Road. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent."

On a motion by Trustee David Goeden, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote, the Board approved by concept the private driveway versus the installation of the public streets. They also agreed to turn the matter back to the Plan Commission to proceed with the review and recommendation regarding a Conditional Use Permit and Developers Agreement. Included with the action it was noted the developers agreement should address thru-traffic and related control, storm drainage, sidewalk, security lighting and proper abandonment of the street ROW and etc.

Assistant Fire Chief Mark Herriges reviewed with the Board the 1994 annual report and submitted a copy for filing.

Assistant Fire Chief Mark Herriges, January 1995 monthly report:

Fire Calls - 2, Year to Date - 2; Jaws of Life - 3, Year to Date - 3; Rescue Calls - 21, Year to Date - 21; Transports - 19, Year to Date - 19.

Chief of Police Richard L. Knoebel, January 1995 monthly report:

Criminal Arrests - 61, Criminal Investigations - 71; Traffic Warnings - 98, Traffic Citations - 21; Adult Arrests - 41, Juvenile Arrests - 15; Property Stolen - \$981, Property Recovered - \$100; Parking Warnings - 13, Parking Tags - 68.

Chief of Police Richard L. Knoebel informed the Board that the new squad car should arrive around March 20, 1995.

Director of Public Works, Jerry Gilles informed the Board that the street lights on the west side of Fond du Lac Avenue were out because of a short near Herriges Oil. It was further noted that a temporary overhead line was used to correct the situation until the frost is out of the ground.

On a motion by Trustee

Robert Stoltzmann, seconded by Trustee John Borland and unanimously carried by voice vote, the Board approved the renewal application for an Operator's License for 94/95 upon proper payment of fees and documentation and authorized the office to issue said license as follows:

Rohlinger, Timothy J. - Kewaskum, WI.

Note: The Police Department had no objections to any of the applications.

On a motion by Trustee William Kulas, seconded by Trustee Robert Beisbier and unanimously carried by voice vote, the Board authorized the sending of letters to the delinquent personal property tax payers for 1994.

Administrator Daniel S. Schmidt reviewed the following with the Board:

1) League and Taxpayer bulletins.

2) Centennial Committee meeting update, including a list of events.

3) Review of invitation to have a joint meeting with the School Board of Kewaskum on Monday, evening February 27, 1995 at 6:00 p.m.

4) Review status of the Regional Transportation System Plan and the need to act on a Resolution regarding acknowledgement of the plan.

On a motion by Trustee John Borland, seconded by Trustee William Kulas and unanimously carried by voice vote, with Trustee Robert Stoltzmann abstaining, the Board hired Dennis Aupperle for the position of General Maintenance Worker without certification at the rate of \$8.42 per hour. It was noted as a condition of employment a physical is required and the obtaining of a water license. Mr. Aupperle is 23 years old and currently resides in rural Kewaskum.

Chairman of the Protection and Public Safety Committee, Trustee John Borland reviewed the actions of the committee as follows:

1) Securing of construction sites was discussed and it was noted to leave the matter as is currently, maintaining the same guidelines as other area units of government.

2) The committee directed the Director of Public Works and Administrator to bring back to the Board from the Wisconsin Electric Power Company, suggested street light location for Stark Street, Braatz Drive and CTH H.

3) The Committee reviewed the draft ordinance regarding the licensing of tattoo establishments. It was noted some additions and deletions need to be made and the ordinance will then be brought back for Board action.

Chairman of the Park and Recreation Committee, Charles Waala reviewed the actions of the committee as follows:

1) Recommend to the Board authorizing the low bidder to do the fencing work at the

KKCP ball diamonds at a cost of \$7,064.00.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee John Borland and unanimously carried by voice vote, the Board authorized said fencing work as recommended by the Park and Recreation Committee.

2) Discussed with the Fire Department the possibility of installing two volley ball courts at RHP south of the beer garden. The committee was agreeable to the matter, but asked that some discussion be held with the Chamber as not to interfere with Kettle Country Kolors.

Board Representative for the Plan Commission, Trustee David Goeden announced a Commission meeting scheduled for February 28, 1995 at 7:00 p.m.

Administrator Daniel S. Schmidt informed the Board a resolution would have to be brought before them to adjust the Library budget to bring us into compliance with the state's regulations. If this was not done, an estimated \$30,000 may be lost. The amount of adjustment would be \$6,509 from the outlay account to the operating side of the budget. It was further noted this action would alter the purchase date/timing of the automation system.

Administrator Daniel S. Schmidt reviewed the bid dated for the four projects out for bids and indicated the sanitary sewer lining project was postponed until February 23, 1995.

On a motion by Trustee William Kulas, seconded by Trustee Robert Beisbier and unanimously carried by voice vote, the Board affirmed the action of the Public Service Commission regarding the Water Utility Adjustments as heard at public hearing on January 26, 1995. The adjustment would average an estimated 30% increase and reflects an 8.5% rate of return. Of the area

13 water utilities, this would move the Village of Kewaskum from the second lowest to the eighth at the current time noting that some of the others are also in for rate increases. The action of the Board was to have the rate adjustment take affect on March 29, 1995 for the second quarter of 1995.

President Robert Wagner brought up for discussion a storm water type problem that was reported to him on a property on Bonnie Lane. It was noted President Wagner informed most of the other Board Members by phone to look at the problem. The consensus of the Board was that the same problem exists in many, many other areas of the Village and that in this climate there is not a lot that can be done to eliminate such problems.

On a motion by Trustee John Borland, seconded by Trustee Robert Stoltzmann and carried by the majority roll call vote, to adjourn. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent."

our district that they may use the Bible, Koran or other religious symbols as teaching aids (as currently permitted by law), the other group does not. It is no surprise that the group backing the Pledge of Allegiance is the same group wanting a district policy set reaffirming the allowance to use various religious books and symbols as teaching aids.

"Why all the fuss?" you might ask. "Aren't there more important issues?", "What about educating our kids?"

Folks, the truth is, we are at a cultural crossroads in our country. Right this minute our tax dollars are being used to fund the National Standards Project published by UCLA's National Center for History in the Schools. This project has undertaken the writing of new American History Standards and the National Standards for World History, intended to be used as the new guide to teaching history in all our schools.

This group is actually rewriting American history through the use of exclusion and political correctness. In these new standards, George Washington barely gets mentioned -- and not even as President -- and Thomas Edison, the Wright Brothers, Alexander Graham Bell, among others, are not mentioned at all. However, Joe McCarthy is mentioned 19 times. In a nutshell, these new standards are an effort to de-emphasize Western culture and its influence in the world and in our country.

According to historian Elizabeth Fox-Genovese, member of the National Council for History Standards, who has worked on these projects, "Nowhere in those standards will you find any mention of the fact that it was the Western tradition that first produced the idea of individual freedom. Nowhere will you find that it was in Christianity that the concept of individual freedom originated. That slavery is evil was a Western idea. Because the bias of the standards is so weighted against the United States and the West, you will find no acknowledgement of the fact that we have produced what no other country and tradition has." (Wall Street Journal, 12/94).

Scary, isn't it? What's even scarier is the quote from a Kewaskum Policy Committee member in a letter to the editor (3/9/95) stating, "The issues are not saying the Pledge of Allegiance or one's religious beliefs, the issues are the role of the School Board, its committees and whether any of this improves the quality of education for our children." (The italics are mine).

When a Policy Committee member fails to see the connection between these

two issues and improving the quality of education for our children, then we need to re-examine our beliefs as a district and the political make-up of our committees. Not insisting on reciting the Pledge of Allegiance to the United States is a subtle way to de-emphasize the importance of patriotism, and excluding Judeo-Christian books and other religious symbols as teaching aids is a subtle way of secularizing our schools thus ascribing our district to the religion of atheism.

Our founding fathers were deeply religious and it was on those beliefs that our country was founded. The new district policy does not advocate any religion, it merely gives teachers a clear conscience to acknowledge the religious impact on our country and to use some of the books and symbols as examples of literary forms, history and informational data in the classroom. There is more information regarding this national trend. Let me know if you would like more information.

LOSS OF A FAMILY NAME

Searching for your roots is a genealogist's nightmare, when you discover two families in neighboring towns with similar sounding surnames: Ebert and Evert. The

Evert name has been misspelled as Effert, Everett, Ebbert, and finally Ebert on documents of legality, The United States Census and church records. Was it the pronunciation of Evert from German to English that caused these mistakes? Unfortunately the Evert family descendants are now primarily calling themselves, EBERT.

The records of St. John Lutheran Church of New Fane, Wisconsin, follow the dates of celebrations of two families, in 1860, an Ebert and an Evert. By 1876, the names were predominantly entered as Ebert for both families.

William Ernst Ebert, Sr., and Dorothea Maria, nee Schulz, immigrated from Brandenburg to the Town of Scott, in 1855. Daughter Dorothea Maria married William Lubach, was widowed and second husband was William Ludwig Backhaus. Sophie was married to August Heise and Henriette married Karl Bleck. The youngest daughter Louise, married Phillip Hagner and the two sons married two Evert sisters: William Junior to Fredricke Evert and August to Maria Evert.

John Evert and Christina, nee Bork, immigrated about 1858 from Schwerin, Mecklenburg to the Town of Auburn. The probate records of John Evert, who died in 1876, have the name listed as Ebert. Also all the children are recorded and where they lived: John married Jennie Kingsburg, was a Civil War volunteer and a barber in Omro. Frederick married Rosine Gerhardt and lived in Eden. Dorothy married Mr. Miller of Milwaukee. Charles, also in the Civil War, married Louise Yarnold Backhaus, the widow of William Backhaus, who died in the Civil War. They lived for a time in the Town of Auburn and Osceola and Campbellsport. Sophie married Peter Hetzel of Boltonville; Maria and husband August Ebert lived in the Town of Scott. Wilhelmina's husband Charles Thurk, was a carpenter in Ebblesville, Town of Auburn; Fredricke married William Ebert Jr., another Civil War volunteer, living in the Town of Scott and Clintonville; two sons, William and Ferdinand lived in Milwaukee as did Amelia, who married John P. Bliffert in Milwaukee and the mother, Christina, lived with the Blifferts. Caroline and John Wiese bought the family farm in the Town of Auburn.

We've searched most records of these two families to gain the above information. Now we need help from any people in your area who may know something of the John Evert (Ebert) Family.

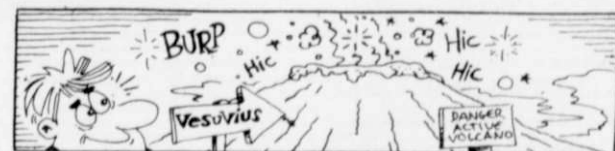

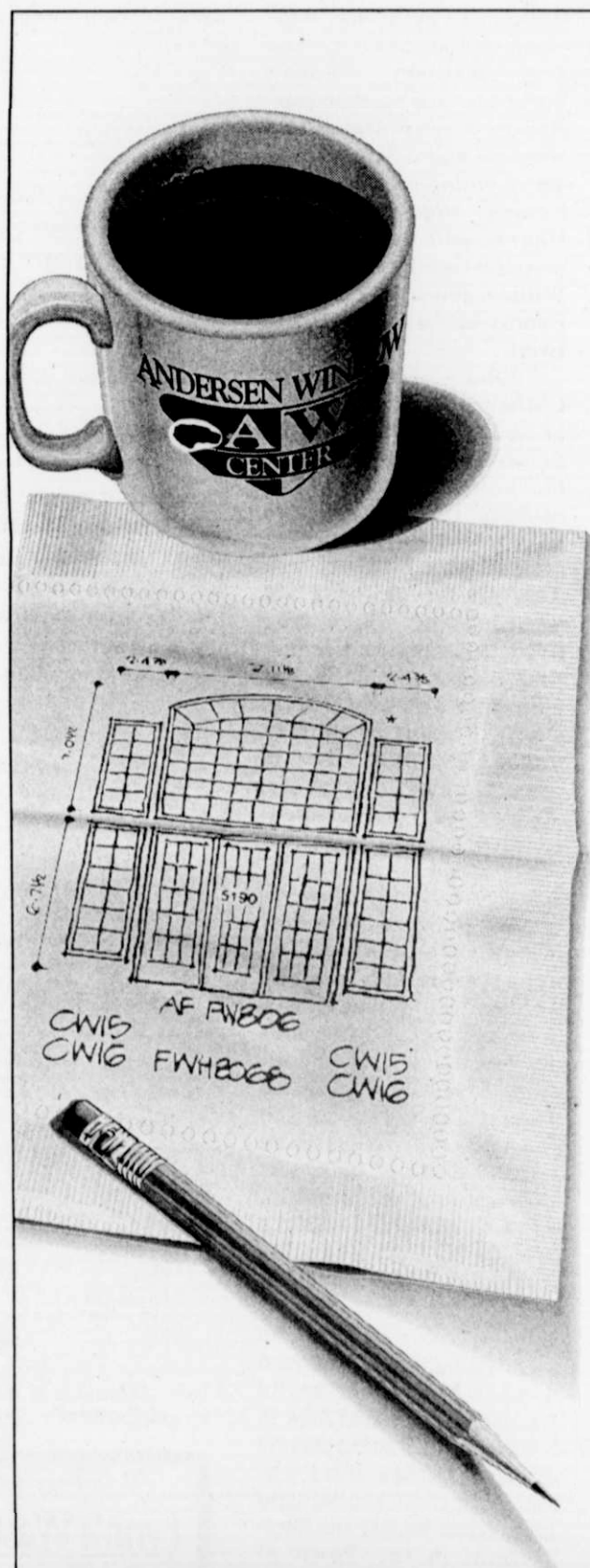
