Voters to Decide on School Board Members

Four candidates are seeking seats on the Kewaskum School District Board. Three positions are open. The two candidates with the most votes will serve a three-year term with the third candidate serving a one year term.

The one-year term results from the mid-term resignation of Janet Wolfenberg. Wolfenberg's seat would have been up for election in 1996. In order to get back on schedule, the third candidate receiving the highest number of votes will serve a one-year term and be up for reelection in 1996 if they should choose to run for office.

Three of the candidates, Ray Engelking, John Schulte and Karen Sparks, currently serve on the board. The fourth candidate seeking her first bid for public office is Mary Andera. All candidates have various reasons for running for office.

Ray Engelking is seeking his second term as a school board member. He has been a Town of Kewaskum resident for 20 years and has three children who attend school in the district. He has been involved in education for 25 years.

Engelking does not believe in bringing his own agenda to the board but believes in objectively representing the community

addressing issues as they become issues.

Some areas in which Engelking feels the next board will need to focus are: 1) budgeting within the spending caps as set by the state; 2) following the building construction progress at the high school and middle school to make sure all that was promised is delivered; 3) review the school drug and alcohol policy and 4) unity on the school board so all efforts represent the community. Engelking encourages all eligible voters to get to the polls and vote!

Village President Seeks Second Term

Robert Wagner has been a resident of Kewaskum for six years. He served as a Village Trustee for two years and in 1993, he was elected village president. Wagner is now seeking his second term, unopposed, as village president.

Wagner describes his first term as "just getting his feet wet." His goal is to work harder during his second term. He cites his involvement and term as president of Mid Moraine Municipalities as very helpful during his first term as village president.

A major concern which has been addressed and will continue to be is attracting and keeping businesses in downtown Kewaskum. Meetings with Kewaskum Area Chamber of Commerce members to possibly develop a plan to revitalize the downtown area, giving it a facelift, has been discussed. Somehow we need to attract tourists and capture the dollars they spend here in Kewaskum. The downtown parking is another area that will be addressed by the new board. Wagner wants people to know that the Highway 45 project will not result in a super highway through town.

Hopefully by the end of 1995, the South Eastern Wisconsin Regional Planning Commission (SEWRPC) will have completed their study and the board will be able to adopt or modify their plan. Wagner would like to see the village and surrounding township boards work more closely together. He explained as the village grows, the townships are going to be effected by that growth.

In relation to growth, Wagner would like to see more single family homes in the village. "We are at our limit with multi-family units."

As a possible way to save taxpayer dollars, the board may explore the possibility of combining the resources of the public library and the public school libraries. Our involvement with the county library system may also be reevaluated. The library director will now be in charge of the budgeting for the library,

The new board will evaluate the property owned by the village that formerly housed the West Bend Savings Bank and currently houses Attorney Roger McKenna's office. Several possibilities are being considered. The board will carefully weigh each possibility as the decision they make will ultimately affect the downtown area and the board wants the impact to be a positive one.

During the next term, Wagner wants Kewaskum to become a household word in Madison as he would like to become more involved in the League of Wisconsin Municipalities. He would like to improve village communications at the state, county and township level. Wagner is looking to the future with a

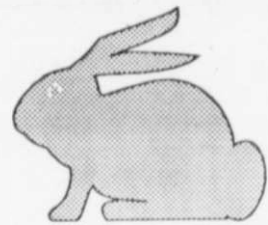

John Schulte, has served six years on the board. He resides in the Town of Scott and has a daughter attending school in the district.

Schulte describes himself as a straight-forward person, who answers questions to the best of his ability and believes in promoting strong family values. Serving on the school board gives him the opportunity to affect a little corner of our world by providing a good staff and curriculum for the students of the Kewaskum School District.

As a member of the school board, Schulte has served as chairman of the policy committee for two years. At his prompting while on this committee, the school board adopted a retention policy that basically states a student can be retained if the administration feels it is in the student's best interest.

In the last year negotiations, Schulte pushed for action on a tutoring program at Kewaskum High School. The program had been in place for about one year but had not been effectively implemented. The end result of the negotiations resulted in relieving the teaching staff of lunch hour duty and other patroling activities, thus staff is available to meet with students who need extra help.

Schulte is opposed to the newest educational philosophy "outcome based education" (OBE) which is teaching to a lower expectation from students. Schulte feels it is a concept that will not work, and is an expensive program.

As a board member, Schulte does not favor letting the district become a "site based management" (SBM) system because of lack of accountability to the public. To clarify, Schulte gave the example of SBM in the recent controversy over Christmas programs and students reciting the Pledge of Allegiance - staff making management decisions. The board has given the administration verbal directive on two occasions that they oppose SBM.

When asked why should someone be on the school

board, Schulte explained there is a real sense of accomplishment when a good change is made.

Mary Andera has been a resident of the Town of Kewaskum for 5 1/2 years. She has two sons attending school in the district. She has been employed in the public sector and is now a business owner. She is an active member of the Kewaskum Area Chamber of Commerce, Kewaskum Kettle Country Kowaskum Committee, Big Brothers/Big Sisters and most recently, the Town of Kewaskum Elections Board.

Andera believes in fiscal responsibility stating, "we all believe in decisions for the kids but the taxpayer must also be represented." Andera describes herself as a frugal person but not afraid to extend funds and thorough research and when necessary.

Andera would like to see teacher, administration and school board accountability. When funds are tight, there needs to be accountability. Andera would like to explore revising evaluation forms developing a more accurate measure of teacher and administration accomplishment and performance. Andera suggested exploring the possibility of students evaluating teachers and teachers evaluating administration. This would not be a vendetta against teachers or administration, but Andera suggests, if something is repeated over and over in the evaluation, perhaps it warrants checking into further.

Finally, Andera believes the district is doing well, spending less yet students are scoring high on achievement tests. Andera encourages more taxpayer involvement at committee meetings where policies are formed and at board meetings where policies are adopted.

Karen Sparks is the fourth candidate on the school board ballot. Sparks was appointed to complete the term of Janet Wolfenberg and has served on the board for 13 months. She has been a Washington County resident since 1982 and a Kewaskum School District resident since 1990. She has two children who attend school in the district.

Due to the state spending caps on school districts, Kewaskum needs to acquire capital improvements in an

orderly manner so the taxpayer does not encounter any huge spending surprises. According to Sparks, regular maintenance of the schools is a must!

The board needs to adopt a policy to clarify what religious reference materials can be used in the schools.

Core values are basically taught to students at home and at school with or without a school board policy. Such examples are responsibility, respect, equality, honesty and promise keeping. These areas are beginning to be addressed through Quest Skills for Growing and Development Guidance Program at the elementary level and Power of Positive Students at the high school level. Sparks is not afraid of values education but stresses the board should determine what values are taught, not whose values. Reinforcing positive values is not accomplished in short term plan, but rather in an

ongoing long term plan.

The most immediate and biggest practical question the next school board will need to focus on is how to continue to operate a quality school district within the state spending cap. Some current programs may have to be dropped or finding other ways to fund the programs will need to be addressed.

District parents want their children taught by professional teachers who are valued by the community. The Kewaskum District has many hard working teachers and they should be recognized for their efforts. Teacher morale is important.

Many difficult decisions have been made in closed session by the board. The administration has done an excellent job of documenting cases where expulsion of a student was necessary.

Serving as a school board member is a very important position but one

doesn't realize the complexity involved until one is actually serving as a member. The position can also be rewarding when something positive happens, such as the district's involvement in the Youth Apprenticeship Program.

Sparks brings to the board an educational background having taught high school math and is currently a school counselor. She has had her own business as a financial planner and treasurer of the American Association of University Women. She is a member of the Fifth Avenue Methodist Church in West Bend, where she has served on the Adult Education Commission, Staff Parish Relations Committee and was Chairman of the Finance Committee. Her family owns and operates Glacier Orchard.

Sparks has had the

The best way the residents can help myself and the board is to give feedback. I'm in electronics for a living and one thing any electronic circuit needs to work properly is feedback; that is the only way the circuit will know if it is working correctly. So please when you have a concern or something to say, call me or one of the other board members, or better still, come to the village to board meetings. "The more the merrier." I think you may find the village board meetings very informative. Sometimes what you read in the newspaper doesn't do it justice (no offense, Statesman).

Well enough talk about the past; let's look to the future. As a song goes that came out a few years ago... "The future's so bright, I need to wear shades." That's what I see. This term I plan to hit the ground running. I see I need to work harder improving the business environment to stop exodus, giving the downtown a facelift, addressing the parking concerns and traffic problems. The meeting was scheduled for 6 p.m. at the Random Lake meeting room.

Once that is completed, bids will be let and bid opening is expected to take place on April 20, followed by awarding of the contract on April 24.

The officials from the four municipalities will also be holding meetings in their respective communities to review an amended and restated joint library agreement. Adell board members held their special meeting on March 21.

been updated to accommodate changes which have taken place and are in regard to the new library facility.

The Joint Library Board will consist of nine members made up of three from the Town of Scott, three from the Town of Sherman, one from the Village of Adell, and two from the Village of Random Lake, each appointed by their respective Chairmen and Presidents and confirmed by each of the municipal boards.

Terms from the town members will be for three years with Scott and Sherman each appointing a board member each year and the Villages of Random Lake and Adell appointing its members in different years.

A budget will be submitted annually to each of the municipalities, not later than October 1, to cover income and expenses for the following calendar year. Nothing can be spent except as authorized by the budget.

The budget shall be funded, based upon the ratio of equalized valuation as it is at the current time. Each of the municipalities shall be limited to the extent of the Sheboygan County Library tax levy, unless otherwise agreed upon by all four municipalities.

The Village of Random Lake shall provide exterior maintenance and liability and casualty insurance for the building and the librarian and other employees shall be considered and treated as an employee of the village for

tax and insurance purposes.

The agreement is to continue for an indefinite period unless there is a unanimous agreement of all four for the withdrawal of any one or more municipality.

If the library should be closed or destroyed, the assets, or proceeds of such assets shall be divided among the four, in accordance with the ratio of contributions made by them.

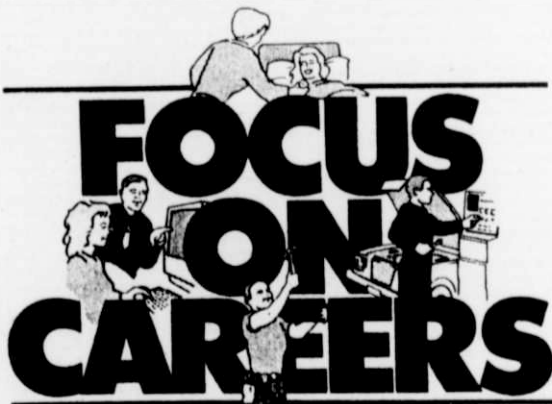

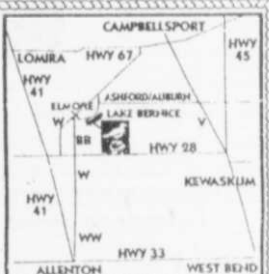

The Energy Services

Heating assistance is a one-time benefit payment during each heating season (October 1 through May 15). It is intended to help pay a portion of the annual heating costs for eligible applicants. The amount of the heating assistance benefit is determined by family size, income level and heating costs.

Crisis assistance provides both Emergency Services and Pro-Active Services.

Emergency Services provide help during the heating season to eligible households that do not have any way to pay for fuel or heating repair costs. Emergency applications are taken on a "walk-in" basis.

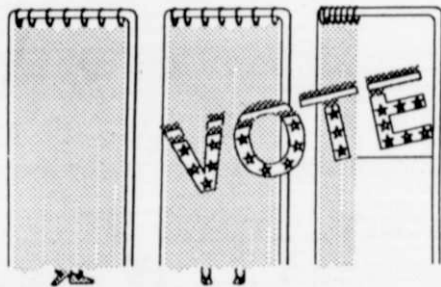

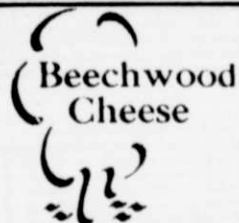

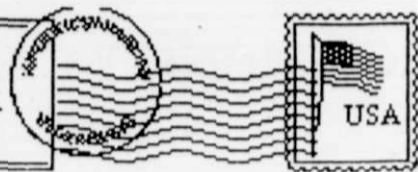

Local school boards and how well they operate are essential to a community. Whether or not they reflect the views of the voters depends directly on "you" the public. Even though school board positions are considered non-partisan; it really doesn't work that way. There is not alot of middle ground. You are choosing instead between people who are primarily liberal or conservative.

The staff at Farmington says... out with the Pledge of Allegiance; out with the Christmas program... they're too time consuming and of no educational value? Input, recommendation, and suggestions from staff have always been welcome and discussed/implemented as long as I've known. That's the way it should be. Sorry, but you don't let the teachers run the school.

Feel good approaches toward curriculum such as "whole word" with dribblings of phonics to teach reading -- quote, so that "the children feel like they know how to read," --bunk. It wastes valuable teaching time and tax dollars. A program of "systematic phonics" should be implemented FIRST and then incorporation of the whole language approach.

An over-emphasis on protecting self-esteem... it needs to be earned to be real, built up, not destroyed.

Teaching to a test -- countless times I've heard from parents that their child responds, "I don't have to know that... it's not going to be on the test." State mandated tests aren't much better -- pre-released and they compare district to district -- tells you if you've lowered your standards along with everyone else. The board really needs to have their own surprise tests. Picture that going over smoothly with administration and staff. Board approval? Not likely with the current board; after all, "they (educators) are experts and know what they're doing."

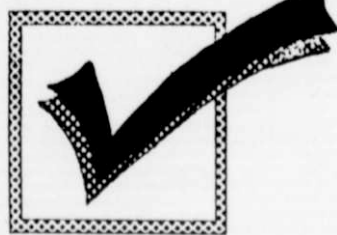

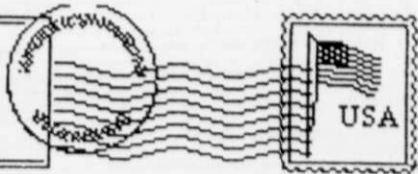

To Town of Farmington Residents:

An issue has been raised that the Farmington Town Board has not allowed the Fillmore First Responders to provide that service for the entire town. That is not exactly the issue.

The Town of Farmington provides fire protection through contracts with Fillmore Fire Department for approximately one half the town and Boltonville for the other approximately one half of the town.

The town also has agreements to provide the statutory

ambulance service through agreements with Newburg Fire Department ambulance in Fillmore's fire district and Kewaskum Fire Department ambulance in Boltonville's fire district.

Through fire contracts, the town pays each fire department in excess of \$45,000.00 annually or approximately \$34.00 per capita. Town of Trenton pays approximately \$20.00 per capita for fire protection. This is a major budget issue. As fire departments add a service they increase costs. With the major source of income being the town there is consensus that the tax dollars will not reach.

Another factor is safety. Kewaskum ambulance is approximately three miles away from the Boltonville area they serve. Fillmore would be six miles away from, for example, St. Michaels. With as many as 15 First Responders possibly responding, and may not physically be able to get to the call before the ambulance, safety seems to be an issue which needs a lot of consideration.

Boltonville has five trained First Responders, who along

with the fire department, would respond to a motor vehicle accident or if the fire department is paged.

Both Newburg and Kewaskum ambulance are excellent in response to calls and provide a very professional service. At the present time this is paid for on a user fee basis, but if sometime, as has been discussed in the past, the town has to contract this service, the tax dollars may not reach. The whole financial picture has to be looked at regarding service providers.

If First Responders are used in the Boltonville fire area, Boltonville Fire Department would be asked to provide that service.

Please note on Tuesday, April 4, vote for Frank Mayer and Dick Schneider, who have demonstrated the ability to make tough decisions which are in the best interest of the town residents.

EXPLANATORY STATEMENT AND EFFECT OF VOTE

The referendum election ballot will ask District electors to vote "yes" or "no" on the referendum election question as set forth above.

A "yes" vote on the Resolution Authorizing the School District Budget to Exceed Revenue Limit by \$400,000 for Non-Recurring Purposes is in favor of said Resolution and is a vote to authorize the School District of Kewaskum budget for the 1995-96 school year to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$400,000, for non-recurring purposes consisting of roof replacement and repair.

A "no" vote on the Resolution Authorizing the School District Budget to Exceed Revenue Limit by \$400,000 for Non-Recurring Purposes is opposed to said Resolution and is a vote to deny that the School District of Kewaskum budget for the 1995-96 school year exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by an amount of \$400,000, for non-recurring purposes consisting of roof replacement and repair.

In the event a majority of the electors voting vote "Yes" on the Resolution Authorizing the School District Budget to Exceed Revenue Limit by \$400,000 for Non-Recurring Purposes, the District will be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, in the 1995-96 school year by an amount of \$400,000, for non-recurring purposes consisting of roof replacement and repair; if a majority vote "No" on the question set forth above, the District will not be so authorized.

POLLING PLACES AND HOURS

District electors must vote at the times and places at which they cast their ballots at regularly scheduled elections.

INFORMATION TO ELECTORS

(a) Upon entering the polling place, an elector shall give his or her name and address before being permitted to vote. Where ballots are distributed to electors, the initials of 2 inspectors must appear on the ballot. Upon being permitted to vote, the elector shall retire alone to a voting booth or machine and cast his or her vote, except that an elector who is a parent or guardian may be accompanied by the elector's minor child or minor ward. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

(b) (i) If paper ballots or lever machines are used, then on the special election question, the elector shall make a cross (X) in the square at the right of or depress the button or lever next to the answer which he or she intends to give.

(ii) If a punch card voting system is used, then on the special election question, the elector shall make a punch or a hole at the right of "yes" if in favor of the question, or the elector shall make a punch or a hole at the right of "no" if opposed to the question.

(iii) If a mark sense voting system is used, then on the special election question, the elector shall make a mark in the space at the right of "yes" if in favor of the question, or the elector shall make a mark in the space at the right of "no" if opposed to the question.

(c) The vote should not be cast in any other manner. If the elector spoils a ballot, he or she shall return it to an election official who shall issue another in its place, but not more than 3 ballots shall be issued to any one elector. If the ballot has not been initiated by 2 inspectors or is defective in any other way, the elector shall return it to the election official, who shall issue a proper ballot in its place. Not more than 5 minutes' time shall be allowed inside a voting booth or machine. Unofficial ballots or a memorandum to assist the elector in marking or punching his or her ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

(d) (i) After an official paper ballot is marked, it shall be folded so the inside marks do not show but so the printed endorsements and inspectors' initials on the outside do show. After casting his or her vote, the elector shall leave the voting machine or booth and, where paper ballots are distributed to the electors, deposit his or her folded ballot in the ballot box or deliver it to an inspector for deposit in the box, and shall leave the polling place promptly.

(ii) If a punch card voting system is used, then after an official ballot is punched, it shall be inserted in the envelope provided so the punches do not show. After casting his or her vote, the elector shall leave the booth, deposit the envelope containing his or her ballot in the ballot box, or deliver the envelope to an inspector for deposit, and shall leave the polling place promptly.

(iii) If a mark sense voting system is used, then after an official ballot is marked it shall be inserted in the envelope provided so the marks do not show. After casting his or her vote, the elector shall leave the booth, insert the ballot in the voting device, discard the envelope, and shall leave the polling place promptly.

(e) An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty in reading, writing or understanding English, or that due to disability is unable to cast his or her vote. The selected individual rendering assistance may not be the elector's employer or an agent of that employer or an officer or agent of a labor organization which represents the elector.

NOTE: Electors residing in municipalities which require voter registration must be registered to vote in this referendum. You can register by contacting your municipal clerk.

NOTICE OF REFERENDUM ELECTION

APRIL 4, 1995

NOTICE IS HEREBY GIVEN, that an election to be held in the several towns, villages, wards, and election districts of the State of Wisconsin, on Tuesday, April 4, 1995, the following proposed amendments to the Constitution of the State of Wisconsin, having been approved by two successive legislatures, will be submitted to a vote of the people pursuant to law:

1995 Senate Joint Resolution 3

1995 ENROLLED JOINT RESOLUTION 2

To amend section 24 (6) (a) of article IV of the constitution; relating to: authorizing a sports lottery, with the proceeds dedicated to athletic facilities (2nd consideration).

Whereas, the 1993 legislature in regular session proposed an amendment to the constitution by 1993 Senate Joint Resolution 49 (1993 Enrolled Joint Resolution 27) and agreed to it by a majority of the members elected to each of the 2 houses, which amendment reads as follows:

SECTION 1. Section 24 (6) (a) of article IV of the constitution, as affected by 1993 Enrolled Joint Resolution 3, is amended to read:

[Article IV] Section 24 (6) (a) The legislature may authorize the creation of a lottery to be operated by the state as provided by law. The expenditure of public funds or of revenues derived from lottery operations to engage in promotional advertising of the Wisconsin state lottery is prohibited. Any advertising of the state lottery shall indicate the odds of a specific lottery ticket to be selected as the winning ticket for each prize amount offered. The net proceeds of the state lottery shall be deposited in the treasury of the state, to be used for property tax relief as provided by law. As part of the lottery authorized under this subsection, the state may operate separate and distinct lottery games denominated the Wisconsin sports lottery, and the proceeds of the Wisconsin sports lottery shall be dedicated to athletic facilities as provided by law.

Now, therefore, be it resolved by the senate, the assembly concurring, That the foregoing amendment to the constitution is agreed to by the 1995 legislature; and, be it further

Resolved, That the foregoing amendment be submitted to a vote of the people at the election to be held on the first Tuesday of April, 1995; and, be it further

Resolved, That the question concerning ratification of the foregoing amendment be stated on the ballot as follows:

QUESTION 1: "Wisconsin sports lottery. Shall section 24 (6) (a) of article IV of the constitution be amended to permit the state to operate lottery games that have their proceeds dedicated to athletic facilities?"

EXPLANATION

Section 24 of article IV of the Wisconsin Constitution provides that the net proceeds of lottery games operated by the state shall be deposited in the state treasury to be used for property tax relief as provided by law. This constitutional amendment would amend section 24 of article IV to permit the state to operate lottery games that have their proceeds dedicated to athletic facilities as provided by the Legislature rather than to property tax relief.

A "yes" vote on this constitutional amendment would authorize the state to operate lottery games called the Wisconsin Sports Lottery and dedicate the proceeds to athletic facilities as provided by law. A "no" vote would mean that the state was not authorized to operate lottery games called the Wisconsin Sports Lottery and would not be able to dedicate lottery proceeds to athletic facilities.

1995 Assembly Joint Resolution 12

1995 ENROLLED JOINT RESOLUTION 3

To amend sections 3, 7, 9, 19 and 21 (2) of article I, sections 6, 12, 13 and 23a of article IV, sections 4 and 6 of article V, section 2 of article VI, sections 1 and 12 of article VII, section 3a of article XI and sections 4, 11 and 12 (6) of article XIII of the constitution; relating to: removing from the constitution unnecessary references to the masculine gender (2nd consideration).

Whereas, the 1993 legislature in regular session proposed an amendment to the constitution by 1993 Assembly Joint Resolution 121 (Enrolled Joint Resolution 21) and agreed to it by a majority of the members elected to each of the 2 houses, which amendment reads as follows:

SECTION 1. Sections 3, 7, 9, 19 and 21 (2) of article I of the constitution are amended to read:

[Article I] Section 3. Every person All persons may freely speak, write and publish his their sentiments on all subjects, being responsible for the abuse of that right, and no laws shall be passed to restrain or abridge the liberty of speech or of the press. In all criminal prosecutions or indictments for libel, the truth may be given in evidence, and if it shall appear appears to the jury that the matter charged as libelous be true, and was published with good motives and for justifiable ends, the party shall be acquitted; and the jury shall have the right to determine the law and the fact.

Section 7. In all criminal prosecutions the accused and counsel for the accused shall enjoy the right to be heard by himself and counsel; to demand the nature and cause of the accusation against him the accused; to meet the witnesses face to face; to have compulsory process to compel the attendance of witnesses in his on behalf of the accused; and in prosecutions by indictment, or information, to a speedy public trial by an impartial jury of the county or district wherein the offense shall have been was committed; which county or district shall have been previously ascertained by law.

Section 9. Every person is entitled to a certain remedy in the laws for all injuries, or wrongs which he the person may receive in his the person's person, property, or character; he every person ought to obtain justice freely, and without being obliged to purchase it, completely and without denial, promptly and without delay, conformably to the laws.

Section 19. No religious tests shall ever be required as a qualification for any office of public trust under the state, and no person shall be rendered incompetent to give evidence in any court of law or equity in consequence of his the person's opinions on the subject of religion.

Section 21 (2) In any court of this state, any suitor may prosecute or defend his the person's suit either in his the person's own proper person or by an attorney of the suitor's choice.

SECTION 2. Sections 6, 12, 13 and 23a of article IV of the constitution are amended to read:

[Article IV] Section 6. No person shall be eligible to the legislature who shall not have resided one year within the state, and be a qualified elector in the district which he the person may be chosen to represent.

Section 12. No member of the legislature shall, during the term for which he the legislator was elected, be appointed or elected to any civil office in the state, which shall have been created, or the emoluments of which shall have been increased, during the term for which he the legislator was elected.

Section 13. No person being who is a member of congress, or holding who holds any military or civil office under the United States, shall be eligible to a seat in the legislature; and if any person shall, after his the person's election as a member of the legislature, be elected to congress, or be appointed to any office, civil or military, under the government of the United States, his the person's acceptance thereof shall vacate his the person's seat. This restriction shall not prohibit a legislator from accepting short periods of active duty as a member of the reserve or from serving in the armed forces during any emergency declared by the executive.

Section 23a (1) Every resolution or ordinance passed by the county board in any county shall, before it becomes effective, be presented to the chief executive officer. If he the chief executive officer approves, he the

chief executive officer shall sign it; if not, he the chief executive officer shall return it with his the chief executive officer's objections, which objections shall be entered at large upon the journal and the board shall proceed to reconsider the matter.

(2) Appropriations may be approved in whole or in part by the chief executive officer and the part approved shall become law, and the part objected to shall be returned in the same manner as provided for in other resolutions or ordinances.

(3) If, after such reconsideration, two-thirds of the members-elect of the county board agree to pass the resolution or ordinance or the part of the resolution or ordinance objected to, it shall become effective on the date prescribed but not earlier than the date of passage following reconsideration.

(4) In all such cases, the votes of the members of the county board shall be determined by ayes and noes and the names of the members voting for or against the resolution or ordinance or the part thereof objected to shall be entered on the journal.

(5) If any resolution or ordinance is not returned by the chief executive officer to the county board at its first meeting occurring not less than 6 days, Sundays excepted, after it has been was presented to him the chief executive officer, it shall become effective unless the county board has recessed or adjourned for a period in excess of 60 days, in which case it shall not be effective without his the chief executive officer's approval.

SECTION 3. Sections 4 and 6 of article V of the constitution are amended to read:

[Article V] Section 4 (1) The governor shall be commander in chief of the military and naval forces of the state. He shall have power to

(2) The governor may convene the legislature on extraordinary occasions, and in case of invasion, or danger from the prevalence of contagious disease at the seat of government, he the governor may convene them the legislature at any other suitable place within the state. He

(3) The governor shall communicate to the legislature, at every session, the condition of the state, and recommend such matters to them the legislature for their its consideration as he may deem the governor deems expedient. He

(4) The governor shall transact all necessary business with the officers of the government, civil and military. He

(5) The governor shall expedite all such measures as may be resolved upon by the legislature, and shall take care that the laws be faithfully executed.

Section 6 (1) The governor shall have power to may grant reprieves, commutations and pardons, after conviction, for all offenses, except treason and cases of impeachment, upon such conditions and with such restrictions and limitations as he may think the governor thinks proper, subject to such regulations as may be provided by law relative to the manner of applying for pardons.

(2) Upon conviction for treason he shall have the power to, the governor may suspend the execution of the sentence until the case shall be is reported to the legislature at its next meeting, when the legislature shall either pardon, or commute the sentence, direct the execution of the sentence, or grant a further reprieve. He

(3) The governor shall annually communicate to the legislature each case of reprieve, commutation or pardon granted, stating the name of the convict, the crime of which he that person was convicted, the sentence and its date, and the date of the commutation, pardon or reprieve, with his the governor's reasons for granting the same.

SECTION 4. Section 2 of article VI of the constitution is amended to read:

[Article VI] Section 2. The secretary of state shall keep a fair record of the official acts of the legislature and executive department of the state, and shall, when required, lay the same and all matters relative thereto before either branch of the legislature. He The secretary of state shall perform such other duties as shall be are assigned him to the secretary of state by law. He The secretary of state shall receive as a compensation for his services yearly such sum as shall be is provided by law, and shall keep his the office of the secretary of state at the seat of government.

SECTION 5. Sections 1 and 12 of the article VII of the constitution are amended to read:

[Article VII] Section 1 (1) The court for the trial of impeachments shall be composed of the senate. The assembly shall have the power of impeaching all civil officers of this state for corrupt conduct in office, or for crimes and misdemeanors; but a majority of all the members elected shall concur in an impeachment. On the trial of an impeachment against the governor, the lieutenant governor shall not act as a member of the court. No judicial officer shall exercise his that office, after he shall have the judicial officer has been impeached, until his acquittal acquitted.

(2) Before the trial of an impeachment the members of the court shall take an oath or affirmation truly and impartially to try the impeachment according to evidence; and no person shall be convicted without the concurrence of two-thirds of the members present.

(3) Judgment in cases of impeachment shall not extend further than to removal from office, or removal from office and disqualification to hold any office of honor, profit or trust under the state; but the party impeached shall be liable to indictment, trial and punishment according to law.

Section 12 (1) There shall be a clerk of the circuit court chosen in each county organized for judicial purposes by the qualified electors thereof, who shall hold his office for two 2 years, subject to removal as shall be provided by law-in.

(2) In case of a vacancy, the judge of the circuit court shall have power to may appoint a clerk until the vacancy shall be is filled by an election-the. The clerk of the circuit court thus elected or appointed shall give such security as the legislature may require requires by law.

(3) The supreme court shall appoint its own clerk, and may appoint a clerk of the circuit court may to be appointed-a the clerk of the supreme court.

SECTION 6. Section 3a of article XI of the constitution is amended to read:

[Article XI] Section 3a (1) The state or any of its counties, cities, towns or villages may acquire by gift, dedication, purchase, or condemnation lands for establishing, laying out, widening, enlarging, extending, and maintaining memorial grounds, streets, highways, squares, parkways, boulevards, parks, playgrounds, sites for public buildings, and reservations in and about and along and leading to any or all of the same; and after the establishment, layout, and completion of such improvements, may convey any such real estate thus acquired and not necessary for such improvements, with reservations concerning the future use and occupation of such real estate, so as to protect such public works and improvements, and their environs, and to preserve the view, appearance, light, air, and usefulness of such public works.

(2) If the governing body of a county, city, town or village elects to accept a gift or dedication of land made on condition that the land be devoted to a special purpose and the condition subsequently becomes impossible or impracticable, such governing body may by resolution or ordinance enacted by a two-thirds vote of its members elect either to grant the land back to the donor or dedicator or his the donor's or dedicator's heirs or accept from the donor or dedicator or his the donor's or dedicator's heirs a grant relieving the county, city, town or village of the condition; however, if the donor or dedicator or his the donor's or dedicator's heirs are unknown or cannot be found, such resolution or ordinance may provide for the commencement of proceedings in the manner and in the courts as the legislature shall designate by law for the purpose of relieving the county, city, town or village from the condition of the gift or dedication.

SECTION 7. Sections 4, 11 and 12 (6) of article XIII of the constitution are amended to read:

[Article XIII] Section 4. It shall be the duty of the The legislature to shall, by law, provide a great seal for the state, which shall be kept by the secretary of state, and all official acts of the governor, his the governor's approval of the laws excepted, shall be thereby authenticated.

Section 11 (1) No person, association, copartnership, or corporation, shall promise, offer or give, for any purpose, to any political committee, or any member or employe thereof, to any candidate for, or incumbent of any office or position under the constitution or laws, or under any ordinance of any town or municipality, of this state, or to any person at the request or for the advantage of all or any of them, any free pass or frank, or any privilege withheld from any person, for the traveling accommodation or transportation of any person or property, or the transmission of any

(2) No political committee, and no member or employe thereof, no candidate for and no incumbent of any office or position under the constitution or laws, or under any ordinance of any town or municipality of this state, shall ask for, or accept, from any person, association, copartnership, or corporation, or use, in any manner, or for any purpose, any free pass or frank, or any privilege withheld from any person, for the traveling accommodation or transportation of any person or property, or the transmission of any message or communication.

(3) Any violation of any of the above provisions sub. (1) or (2) shall be bribery and punished as provided by law, and if any officer or any member of the legislature be guilty thereof, his or her office shall become vacant.

(4) No person within the purview of this act shall be privileged from testifying in relation to anything therein prohibited; and no person having so testified shall be liable to any prosecution or punishment for any offense concerning which he the person was required to give his or her testimony or produce any documentary evidence. **Notaries**

(5) This section does not apply to notaries public and or to regular employes of a railroad or other public utilities utility who are candidates for or hold public offices for which the annual compensation is not more than three hundred dollars \$300 to whom no passes or privileges are extended beyond those which they are extended to other regular employes of such corporations are excepted from the provisions of this section.

Section 12 (6) After one such petition and recall election, no further recall petition shall be filed against the same officer during the term for which he the officer was elected.

SECTION 8. Reconciliation with other constitutional amendments. In recommending the constitutional amendments contained in the present joint resolution to the 1995 legislature for 2nd consideration approval and to the people for ratification, the 1993 legislature expresses its intent to limit the effect of the present joint resolution to nonsubstantive changes removing from the constitution of this state any remaining unnecessary references to the masculine gender. If, prior to or simultaneously with the ratification of the amendments contained in this resolution, the people of this state ratify any other constitutional amendment making substantive changes in any of the sections of the constitution treated in the present joint resolution, then the wording and structure of such section or sections of the constitution as affected by the substantive-change amendment shall control.

Now, therefore, be it resolved by the assembly, the senate concurring, That the foregoing amendment to the constitution is agreed to by the 1995 legislature; and, be it further

Resolved, That the foregoing amendment be submitted to a vote of the people at the election to be held on the first Tuesday in April, 1995; and, be it further

Resolved, That the question concerning ratification of the foregoing amendment be stated on the ballot as follows:

QUESTION 1: "References to masculine gender removed. Shall articles I, IV, V, VI, VII, XI and XIII of the constitution be amended to remove unnecessary masculine gender pronouns?"

EXPLANATION

A "yes" vote on this constitutional amendment would result in unnecessary masculine gender pronouns such as "he," "his" and "him," being replaced in the constitution by references to the specific officer, such as "governor" or "officer" or other appropriate gender-neutral words such as "person." The joint resolution authorizing the referendum states the Legislature's intent to limit the effect of the resolution to nonsubstantive changes. A "no" vote would retain the present language of the constitution.

Commercial Exhibit Space For Farm Progress Day

The 1995 Wisconsin Farm Progress Day Show will be held in Washington County on July 11, 12 and 13, 1995. The host family is the Dan and Marge Neuburg farm located south of Slinger.

The show is expected to attract over 100,000 visitors and will provide an excellent opportunity for businesses to exhibit their products, merchandise and services. Exhibitor space is provided in the 65 acre "Tent City" area. Outdoor lots and booths located in tents are available.

Exhibits in the show will include many of the manufacturers of farm machinery, equipment, seeds, supplies, services and other items important to agriculture. However, many of the exhibits relate to items used by farm families and other families.

Indoor exhibit booths, located in large tents, are 12 ft. x 12 ft. in size and priced at \$350, including 120 volt electricity. Outdoor lots are 25 ft. x 50 ft. in size and priced at \$225. Electricity for outdoor lots is \$90 for 120 volt and \$160 for 240 volt service.

The show has provided for a total of 930 lots and 240 booths. The spaces are filling fast. As of March 15th, 872 (94%) of the lots were committed. Booth space is also limited, with 193 or 81% of the booths also taken.

1995 Assembly Joint Resolution 15

1995 ENROLLED JOINT RESOLUTION 4

To amend section 10 (1) of article VII of the constitution; relating to: permitting a judge to assume a nonjudicial office of public trust after vacating the judicial office during that term of office (2nd consideration).

Whereas, the 1993 legislature in regular session proposed an amendment to the constitution by 1993 Assembly Joint Resolution 81 (1993 Enrolled Joint Resolution 20) and agreed to it by a majority of the members elected to each of the 2 houses, which amendment reads as follows:

SECTION 1. Section 10 (1) of article VII of the constitution is amended to read:

[Article VII] Section 10 (1) No justice of the supreme court or judge of any court of record shall hold any other office of public trust, except a judicial office, during the term for which elected. No person shall be eligible to the office of judge who shall not, at the time of election or appointment, be a qualified elector within the jurisdiction for which chosen.

Now, therefore, be it resolved by the assembly, the senate concurring, That the foregoing amendment to the constitution is agreed to by the 1995 legislature; and, be it further

Resolved, That the foregoing amendment be submitted to a vote of the people at the election to be held on the first Tuesday of April, 1995; and, be it further

Resolved, That the question concerning ratification of the foregoing amendment be stated on the ballot as follows:

QUESTION 1: "Eligibility of judges for nonjudicial office. Shall section 10 (1) of article VII of the constitution be amended to permit a judge to assume a nonjudicial office of public trust after vacating the judicial office during that term of office?"

EXPLANATION

Article VII, section 10(1) of the Wisconsin Constitution presently prohibits any justice of the supreme court or any judge of a court of record from holding any other office of public trust, except a judicial office, during the term for which the justice or judge was elected. A "yes" vote on this constitutional amendment would allow a justice or judge to be elected or appointed to a different office of public trust if the justice or judge vacated the judicial office before assuming the different office. A "no" vote would retain the present language of section 10(1) of article VII of the Wisconsin Constitution and would continue the prohibition against a justice or a judge holding any other office of public trust, except a judicial office, during the term for which the justice or judge was elected.

Village Board Meeting Minutes

Regular Meeting
March 6, 1995
8:00 p.m.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Regular Session in the Council Room of the Municipal Building, 204 First Street.

President Robert Wagner presided. Trustee Charles Waala was late for he was in attendance at a Library Board. All other Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee John Borland, seconded by Trustee William Kulas and carried by the majority voice vote, the Board approved the minutes of February 20, 1995 as printed. Trustee David Goeden voting nay.

A public hearing was held on the special assessments for Municipal Improvements (installation of curb/gutter, sidewalk and restoration/landscaping etc. as contained in section 8 of the Municipal Code) for the area known as Fond du Lac Avenue (north of the existing urbanized street section). It was noted that this work is being completed by the WI DOT state project no. 4070-04-70. It was noted that 15 notices were sent to area property owners and that only 10 of them would be assessed any dollar amount for proposed work. The engineering for the project was completed by the WI DOT and Mid-State Engineers. The cost of the sidewalk and curbing as bid and let, considering the state would be paying for a portion of the cost, is saving those involved property owners from 150 to 250%. On a motion by Trustee Robert Beisbier, seconded by Trustee Robert Stoltzmann and carried by the majority roll call vote, the Board closed the public hearing. - 1) The Village had their third water main break for the season located on the south end of Roseland Drive.
- 2) Discussion regarding the sludge storage facility, more specially the possible weeping of

one spot within the wall.

3) Discussion regarding the possible lifting of the Winter Parking Restrictions.

- 5) Informed the Board that the next Centennial Meeting was scheduled for March 13, 1995 at 7:00 p.m.

Chairman of the Administrative Committee, Robert Beisbier recommended the payment of bills. On a motion by Trustee John Borland, seconded by Trustee Charles Waala and unanimously carried by voice vote, the Board approved the payment of bills as recommended by the Administrative Committee. Chairman of the Park and Recreation Committee, Charles Waala indicated nothing definite had been received from either the Chamber of Commerce or the Fire Department regarding the placement of one or two volleyball courts at RHP. It was further noted that a Park and Recreation meeting was being scheduled for March 20, 1995 at 7:00 p.m. The Board indicated the Chamber and Fire Department should be notified that the volleyball courts would be discussed at that meeting. It was further noted that the Fire Department should verify the proper depth at which the sand should be placed for safety purposes. One other item to be brought up at the committee meeting will be the establishment of a Thursday Mens softball league.
