Beechwood Rest Home Continues Family Traditions

The Beechwood Rest Home has been in existence since 1961, when sisters Delores Rammer and Virginia Benzschawel decided to follow in their parents footsteps and open a home for elderly citizens. Their family had run a small nursing home in Sheboygan Falls in the 1950s, and the family tradition seems to continue to this day.

Now Rammer's children, Lee, Scott, Barry and Chris Firme have been running the state licensed facility for the past 15 years, although, as Scott points out, they grew up at Beechwood Rest Home. "We've done everything here from cutting the grass to working in the kitchen and doing the dishes."

The home is divided into two separate sections. Twenty-six residents live in the state licensed Skilled Nursing Facility, with RN Joan Eippert as the Director of Nursing, along with a staff of 25, which includes regis-

tered nurses, LPNs, and certified nursing assistants.

Activity Director Louise Hafermann, along with an aide and other volunteers, help to keep the resident's minds and bodies active, even those that are wheelchair bound. "Because Beechwood is a small nursing home, the atmosphere here is that of one big family," Louise remarks. Everyone cares about each other, and life-long friendships are formed, even among the staff members. She's been employed at the home for 19 years, and organizes a variety of activities throughout the year.

Exercises are held each morning, and include working the arms and legs, along with daily walks for those who are able. The residents also enjoy music sessions, crafts, cards, games, trivia, spelling and math, table volleyball, and church services. Denominations include Catholic, Methodist, Lutheran, and the United Church of Christ. Catholic services are

held every Friday, and others are done with cassette tapes. Once a month, ministers come from area churches to perform special services.

A resident counsel fund collects money through donations, as well as offering for sale a selection of crafts made by members of the staff, family members of the residents, and volunteers, with help from the residents themselves. The money from this fund is used to pay for entertainment, and buy bingo prizes, which is played once a month.

Beechwood Rest Home welcomes visitors from various community organizations that come to entertain, such as 4-H groups like the Scott Pioneers, the Sherman Center Pals and the Sherman Workers. Twice a year the Random Lake High School Choir performs musical selections, and even the staff members volunteer their time on their days off to share

their talents. Pets are also welcome to come and visit; they provide great therapy for the residents who enjoy petting them, and holding the smaller animals on their laps.

A part-time social worker is also provided, and an Occupational and Physical Therapist come in from Cedar Haven to work with individuals. Louise also helps out as an O.T. Other employees serving on the staff include a food service supervisor, a dietary department, which provides special diets according to need, a consultant dietician, and the house-keeping staff.

Administrative assistant Scott Rammer has been a part of the full time crew for the past 12 years. "In 1988, an addition was put on the

original home, and the skilled care unit was moved into the new section," he explains. The original facility is now a CBRF, or Community Based Residential Facility, licensed by the state. The residential area provides assisted living arrangements for 13 residents, offering private or shared rooms. A large sitting and dining area contains big windows, creating a bright and cheery atmosphere.

Beechwood Rest Home is located on Highway A, in a quiet, residential neighborhood, surrounded by spacious lawns. The home-like setting provides the residents with dignity and a chance to develop friendships, while receiving the quality care that they need and deserve.

Regal Ware Has Played a Major Role in Kewaskum's History

This week Regal Ware, Inc. will be celebrating their 50th Anniversary as one of the world's leading cookware and electric manufacturers, with offices and facilities throughout the United States and internationally.

President and Chief Executive Officer, Jeffrey A. Reigle, states that the company has worked diligently to build an organization with the flexibility to meet customers' needs and react quickly to their changing needs in the future. Quality products have been the hallmark of the company, since its creation in 1945, and is sought after as a world class housewares source.

Specializing in cookware and kitchen electrics, Regal offers one of the most complete lines under the Regal, Club, Kitchen Pro, ProTech and Royal Diamond trade names, and supports this board product line with impressive manufacturing resources and a well trained force. The work environment is dedicated to training and team development, which encourages product change and improvement.

The company began operations in 1945, when James O. Reigle and a small group of investors purchased the Kewaskum Aluminum Company, which at the time was manufacturing shell casings for the U.S. military for use in World War II. Two weeks after the change of ownership the war ended, the government contract was canceled, and the business switched back to the cookware end of the trade.

In order to understand the development behind a worldwide company such as Regal Ware, it's important to look at the history of the aluminum cookware industry prior to 1945, especially since Wisconsin played an important role as a center of this sector of Commerce. Luckily, we have a wealth of information available from Dean Roe of Kewaskum, who finished a master's thesis on the Kewaskum Aluminum Company in 1971. Much of this article contains the well researched information Roe included in his thesis, earning him a Master of Science in teaching history from UW-Oshkosh. (Our thanks to Mr. Roe for sharing his information with us).

Aluminum, or the method now used to separate aluminum from its oxide was developed simultaneously in France and Ohio in 1886. Martin Hall patented and received exclusive rights to the process in the United States, and by 1888, a factory in Pennsylvania was producing raw aluminum. In 1895,

Joseph Koenig established the first Aluminum Manufacturing Company in Wisconsin, located in Two Rivers, and from there a series of events led to the creation of many "spin-off" businesses, or copies of the original company started by Koenig, most often using former employees.

In 1911, Ben Ziegler of West Bend began producing aluminum cookware, and became highly successful in a short period of time, inspiring Kewaskum native Adolph Rosenheimer to decide to enter the aluminum industry. Rosenheimer had been enjoying success as owner of the village's Malt and Grain Company, but on July 1, 1919, prohibition was put into effect by the 18th Amendment, and the production of malt ceased.

The Rosenheimer name was synonymous with Kewaskum, originating when Moritz Rosenheimer moved to the village in 1874, with his brother Adolph following in 1876. This family helped develop Kewaskum as a market and trade center for the surrounding farm people, with a population of around 471 village residents and 1,436 in the township by 1880. They owned and operated the largest general store in Kewaskum, as well as a bank, malting house, creamery, insurance company, electric light and heating company, and the aluminum business.

Adolph, known as a capable entrepreneur with "sterling qualities of mind and character," (who also served as the first village president after Kewaskum was incorporated in 1895) hired two assistants away from Ziegler's company by the names of Al Hron and Art Manthei, rented a building in Kewas-

kum and began aluminum production in 1920. It has been said that a rivalry existed between Ziegler and Rosenheimer, who were both in the banking and insurance business.

In watching the business begin to unfold, the editor of the Kewaskum Statesman had this to say on October 25, 1919: "No matter where you go, everyone is talking of the great boom at hand, everyone is planning to make some improvements, every individual means business, there is no shirking. Kewaskum has started, and it will now as it has always done, in whatever it undertook in the past, 'go the limit', for the citizens of our village absolutely believe, that which is for the good, for the welfare and promotion of Kewaskum, and to the outside world wherever the products of our factories will be made use of, as well... so bright future prospects appear for the village, that predictions now are that within the course of a few years, the citizens of the village and county will look upon our little hamlet with astonishment at a new Kewaskum."

The West Bend newspapers ridiculed the people of Kewaskum during this time for their "pie in the sky" attitudes, and their attempt to develop an aluminum factory, but the townspeople persisted with their optimistic outlook.

With an initial workforce of about 60 employees, an early workman recalled that the starting wage was 22 cents per hour doing inside finishing work on the cooking utensils. The company was engaged in the sale and manufacture of the "Kewasko" brand of aluminum cookware until 1942, also adding a copperware and novelty

line in 1932 to increase sales, and the development of stainless steel in 1938, in an effort to restore profits, after losses from the depression and a disastrous fire in 1925.

Products were sold through mail order houses, chain stores, and retail stores. Before a utensil was sold, it was stamped with the trademark of the company, an Indian head. By 1929, the company was the eleventh largest in U.S. cookware sales.

The depression caused the company great financial losses, but Rosenheimer's philosophy at the time was one of keeping as many of their employees on the payroll as possible, having men paint the plant and maintain the property. Workers received a twelve cent cut in wages, and were required to accept one-half of their money in script issued by the Bank of Kewaskum.

Early in 1941, the government discontinued the use of aluminum for cookware production, as well as stainless

steel, reserving the metals for war production. The Kewaskum Aluminum Company received contracts with the war department to manufacture brass and steel cartridges and mortar rocket cases, and also carried on experimental research in the development of the steel cartridge cases, leading the nation in this endeavor. In 1944, the company began to experience labor problems over vacations, overtime, wages and shift premiums, and the rise of the unions to power became a difficult time for the business.

Adolph Rosenheimer died in 1943, and the two remaining brothers, who knew nothing of the business, took over the plant. As production on the war contracts neared completion, the subject of postwar permanency was discussed among the stockholders. No one knew when the government would release the use of metals for cookware production. The general attitude seemed to be, "let's get out while the getting out is possible."

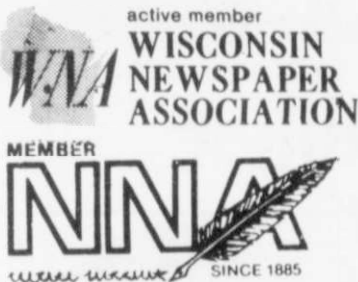

ble."

Several different companies contemplated the purchase of the Kewaskum Aluminum Company, including the Katzinger Company, Great Lakes Springs Corporation, and Reynolds Metals. On May 19, 1945, a special meeting of the company's Board of Directors was held to discuss the sale of certain assets of the company to James O. Reigle, at a price of \$125,000, for certain fixed assets in addition to inventories and facilities, and by September, after 26 year of operation, the company ceased to exist, and became the nucleus of the present Regal Ware operations.

Reigle and his group of men changed the name to the Kewaskum Utensil Company, and in 1953, to Regal Ware, Inc. The firm is today the major industry in Kewaskum, employing approximately 800 individuals in its main offices and plant. The resulting influence upon the community and the surrounding area is one of great magnitude.

After the war, the company scrambled to convert their line back to producing a consumer product, making stainless steel sauce pans. The quality cookware became popular with post-war consumers, and during the

early years, the great demand for consumer goods helped create an impressive growth record. The timing was right, and Regal Ware rapidly expanded their line to include a wide selection of range top cookware, coffee makers and electric appliances. Timely acquisitions as well, helped the business adapt to changing market conditions.

Regal was a pioneer in the development of non-stick cookware (Teflon), dramatically changing the way the world cooks, and also introduced what would become the most popular percolator in America, the PolyPerk coffee maker. They continued to expand their line of products that today include gourmet cookware sets with warranties that range from one year to a lifetime (with the new Royal Diamond line), coffee makers, food processors, breadmakers, steamers, electric knives, meal makers and more.

The impressive growth of the company is attributed to three generations of consistent leadership, from its founder James O. Reigle, to his son, James D. Reigle, and presently grandson, Jeffrey Reigle, along with the hard work and dedication of thousands of Regal employees over the years. The international company includes manufacturing facilities in Canada, South America and Japan, and is actively marketing its products in well over 100 countries

around the world.

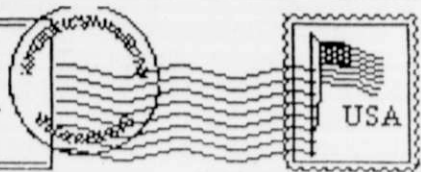

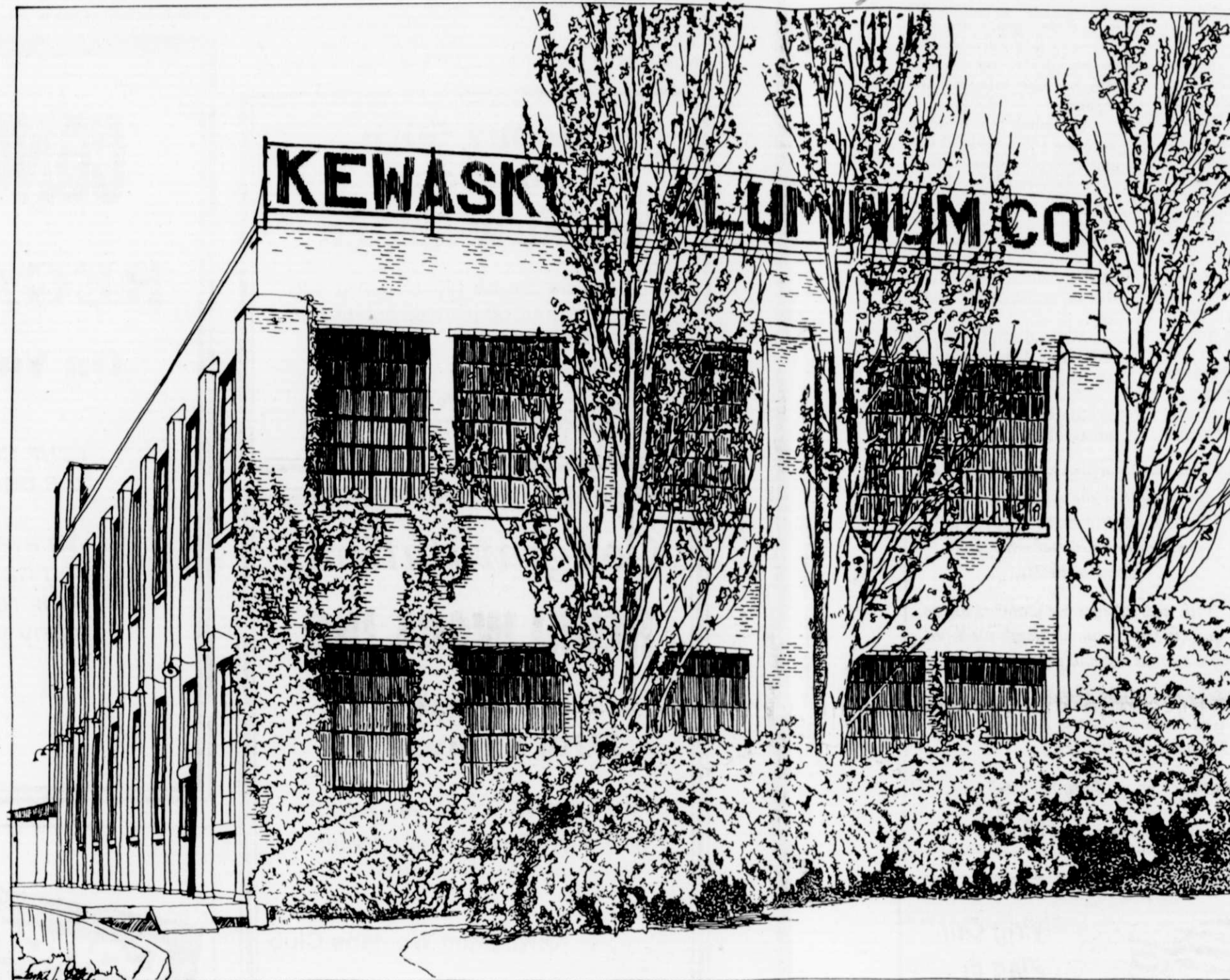

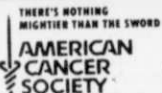

A Tribute to Coach Tony Butschlick



Holy Trinity basketball coach Tony Butschlick has retired.

No doubt anyone who knows Tony Butschlick could very easily believe his first words as a child must have been "basketball."

As surely as the ritual of geese flying south every fall, Coach Butschlick geared up for another exciting year of basketball at Holy Trinity School and Parish. This ritual has been put to rest after eighteen dedicated years of coaching.

Each year was a new challenge, as players moved on, as players matured from one season to the next, Coach Butschlick inspired the players to be the best they could be. They may not have been the tallest or quickest or the most coordinated but if the team played as a team, gave all they had, they could be proud of the outcome, win or lose.

Butschlick was honored at the Holy Trinity Athletic Banquet amid a standing ovation as he humbly praised the students and their parents. Those in attendance enjoyed a bulletin board displaying team pictures and highlights from over the years. A table was adorned with trophies, plaques and memorabilia from the past eighteen years of coaching.

Butschlick graduated from Kewaskum High School in 1970 and was a member of, as some would say, the "best high school basketball team in Kewaskum's history."

He began as a referee at Holy Trinity in 1976 and in 1977 he joined the coaching staff. His contributions and team accomplishments over the following years would be numerous, all for the players and "the love of the game."

During the season of '82-'83, his B team boys earned the League Championship defeating Campbellsport, 24-23, with a repeat title in '83-'84.

Under Coach Butschlick, the B team boys savored their first tournament championship game in '83-'84 at St. Kilians in Hartford. In an intense game, three of the team starters fouled out but the bench came in to win the tournament, 27-26.

The A team boys were league champs in '87-'88 with a 10-0 record, again in '91-'92 with a 10-1 record defeating St. Marys of Eden and finally in '93-'94 with a 10-1 record defeating St. Marys of Barton.

The A team boys won their first tournament championship in '93-'94 at St. Mary's Springs High School and earned the championship title in '94-'95 at the West Bend Early Bird Tournament.

Butschlick leaves Holy Trinity with five league championships, three tournament championships and five second place teams.

No one can begin to tally the hours of practice, the number of miles driven to the approximately 300 games he coached, the anxiety experienced on the bench of the close games, the pride in winning and the humbleness of defeat. Coach Butschlick brought a Christian attitude to each team, a total commitment to the players and to the game.

Coach Butschlick will be missed as he moves on. We are thankful for the many years of dedication he gave Holy Trinity and without a doubt we all know his heart is as big as a basketball. Thanks for the memories, Coach!

Village Board Meeting Minutes

Mid-Monthly Meeting
April 17, 1995
8:00 p.m.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Mid-Monthly Session in the Council Room of the Municipal Building, 204 First Street.

President Robert Wagner presided. All Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee Robert Beisbier and unanimously carried by voice vote, the minutes of the April 3, 1995 meeting were approved as printed.

Mr. John Knepel of the accounting firm of Conley McDonald Certified Public Accountants & Consultants was present to review and answer questions on the latest audit prepared for the Village of Kewaskum for year ending December 31, 1994. Mr. Knepel explained the entire audit and financial statements regarding the General Fund and Utilities audit and associated financial statements. The audit revealed the Village to be in a healthy financial position.

It was further noted that the General Fund ended with a positive balance. The Water Utility reflected a rate of return equal to a 1.34% and that the Public Service Commission had authorized a 6% rate of return. It was noted that the Public Service Commission had completed their finding on an adjustment and the Village Board had acted affirmatively on approving a rate adjustment effective for the 2nd quarter of 1995 and that the new rate of return is 8.25%. The Sewer Utility reflected a rate of return equal to 3.38%, .62% less than last year. It was noted that the TIF District and Debt, if all goes as currently projected, will be paid off approximately four years early. The Village's overall debt is at 41% of what the law provides.

Trustee David Goeden asked Mr. Knepel if he had any thoughts regarding impact fees. He said they were the rage, but advised that if not done correctly would be more of a problem. One community he deals with had to refund the bulk of the money collected and that extensive engineering work is needed to put together a sound and reasonable fee. He indicated the legislation regarding impact fees is relatively new and it will take a while to see problems resolved.

Mr. Knepel thanked the staff for their assistance and good records. He further indicated the Administrator and Deputy Clerk do an excellent job on maintaining good records and control over spending, etc.

President Robert Wagner thanked Mr. Knepel and also thanked the Administrator and Staff for continuing to do an outstanding job.

A public hearing was held on the passage of Resolution No. 95-5, A Resolution Discontinuing and Vacating a Portion of Highland Avenue, which was introduced on March 6, 1995. No comments either pro or con were heard. On a motion by Trustee Charles Waala, seconded by Trustee William Kulas and

carried by the majority roll call vote, the Board closed the public hearing. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent."

A public hearing was held on the application of the Kwaskum Athletic Club, KKCP for a Class "B" Fermented Malt Beverage License for the period commencing April 18, 1995 and ending October 17, 1995. On a motion by Trustee William Kulas, seconded by Trustee Robert Beisbier and carried by the majority roll call vote, the Board closed the public hearing. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent."

Assistant Fire Chief Mark Herriges presented the March, 1995 monthly report: Fire calls - 3, Year to date - 6; Jaws of Life - 1, Year to date - 7; Rescue calls - 16, Year to date --; Training - 262, Year to date - 610; Extra training - 95, Year to date - 326.15.

Assistant Fire Chief Mark Herriges shared information regarding the specs and estimated cost for the proposed new tank truck with the Board. Further investigation and a refining of the specs will take place and brought back to the Board.

Chief of Police Richard L. Knoebel, March 1995 monthly report: Criminal arrests - 35, Criminal investigations - 52; Traffic warnings - 144, Traffic citations - 34; Adult arrests - 20, Juvenile arrests - 24; Property stolen - \$824, Property recovered - \$85; Parking warnings - 24, Parking tags - 50.

Director of Public Works, Jerry Gilles reviewed the following with the Board:

1) The annual water samples required by the DNR are in the process of being taken.

2) The hydrant flushing is scheduled for Wednesday and Thursday of this week.

3) The new roof at the KKCP is completed and the painting will be accomplished soon.

4) The seven replacement light poles have been completed on Fond du Lac Avenue and the southerly new concrete poles have been installed on Fond du Lac Avenue and may be energized in about a week.

On a motion by Trustee Robert Beisbier, seconded by Trustee Charles Waala and unanimously carried by voice vote, the Board approved the hiring of the DPW and WPC summer part-time employees as listed.

Trustee William Kulas reported that the U.S. Flag is scheduled to be put up and taken down several times within a short period of time and he would recommend that they be flown from May 26 through July 10, 1995. This would include Memorial Day, The Village of Kewaskum's Centennial, July 4th and the Firemen/Legion Picnic. On a motion by Trustee Charles Waala, seconded by Trustee William Kulas and unanimously carried by voice vote, the Board directed that Old Glory remain flying during the period of the aforementioned holidays.

Administrator Daniel S. Schmidt reviewed the following with the Board:

1) Reviewed the building permits through March 31, 1995.

2) Reviewed League and Taxpayer bulletins.

3) Reminded the Board of the Spring cleanup scheduled for April 22, 1995.

4) Reviewed Senate Bill 111 changing the dates for the Presidential year elections.

5) Reviewed exposures on Old Fond du Lac Road in reference to the railroad signal

request/petition.

6) Reminded the Board of the Committee, Commission and Board appointments for May 1, 1995.

7) Reviewed the letter received from Kemp/Marigold Foods, Inc. regarding the closing of the Kewaskum plant effective June 24, 1995.

Chairman of the Park and Recreation Committee, Charles Waala reviewed the following:

1) Request of the Kewaskum Athletic Club to make a 5 year commitment to Coke so as to have an electric scoreboard placed on the SW diamond. The Committee was in favor of the idea but needed a few questions answered. Ron Theusch will review these questions with Coke and report back to the Board.

2) The committee recommended providing \$1,000 financial assistance to the Fire Department for the RHP volleyball court. On a motion by Trustee Robert Beisbier, seconded by Trustee William Kulas and unanimously carried by voice vote, the Board authorized the \$1,000 volleyball court assistance. It was noted the net would remain up during the recreation season for everyone to enjoy.

3) The committee recommended the hiring of summer part-time employees for the Summer Recreation Program. On a motion by Trustee Robert Stoltzmann, seconded by Trustee John Borland and unanimously carried by voice vote, the Board approved the hiring of the Summer part-time recreation employees as listed.

Board Representative for the Plan Commission, Trustee David Goeden informed the Board of a Plan Commission meeting scheduled for April 26, 1995 at 7:00 p.m.

Trustee Robert Stoltzmann reported that at the last Mid-Moraine Municipal Association Legislative Committee Meeting they discussed the VALUE program. Trustee Stoltzmann informed the Board that the Village already uses the program and realizes substantial savings but that the organizers were hoping to make the program easier to use for small purchases, etc.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee John Borland and carried by the majority voice vote, the Board authorized the open cutting of Edgewood Road for the estimated five water and sewer laterals due to the DNR and Army Corp not allowing the extension of both North and Forest Avenues. The permission to open cut was based on the saw cutting of the street, slurry back filling with a hot mix patch and followed with an overall heat patch to blend the area. Trustee David Goeden and Trustee Charles Waala voting "Nay."

On a motion by Trustee William Kulas, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote, the Board accepted the audit report as prepared and presented for the year ending December 31, 1994.

On a motion by Trustee Robert Beisbier, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote, the Board authorized the signing of a three year agreement for accounting/auditing service from Conley McDonald Certified Public Accountants & Consultants. The agreement reflects the cost of living increase annually. That being from 3.8% to 4.2%.

Action was taken on Resolution No. 95-11, A

Resolution Regarding Overdrafts on Accounts Year Ending December 31, 1994 as attached hereto:

Action was taken on Resolution No. 95-5, A Resolution Discontinuing and Vacating A Portion of Highland Avenue and as heard at public hearing April 17, 1995 as attached hereto:

The CSM for RTKM, LLC. was not received and was tabled.

The Conditional Use Permit/Planned Unit Development Agreement for RTKM LLC was discussed and it was brought to the Board's attention they wished to construct the three buildings in a timed manner which would reflect accomplishing the improvements over a period of time versus by occupancy permit issuance. Discussion was also held regarding the placement of sidewalk and the resurfacing of a portion of Stark Street and Highland Avenue. Further discussion will take place at the Plan Commission meeting April 26, 1995.

On a motion by Trustee Charles Waala, seconded by Trustee John Borland and carried by the majority roll call vote, the Board authorized the issuance of the Class "B" Fermented Malt Beverage License for the Kewaskum Athletic Club, KKCP, for the period commencing April 18, 1995 and ending October 17, 1995 upon payment of proper fees and as heard at public hearing. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent."

On a motion by Trustee Robert Beisbier, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote, the Board approved the appointment of Ronald Theusch as the agent for the aforementioned Class "B."

Review of the Intergovernmental Contract to be entered into with the Kewaskum School District as previously discussed with the School Board took place. On a motion by Trustee David Goeden, seconded by Trustee John Borland and carried by the majority voice vote, the Board indicated paragraph 5, page 2, should reflect the Kewaskum School District paying for 100% of the cost for said sidewalk installation. President Robert Wagner voting "Nay."

Further discussion pursued regarding the width of the sidewalk. The main concern was that the ADA requires a 60" wide sidewalk at least every 200' for wheelchair passing. On a motion by Trustee William Kulas, seconded by Trustee Robert Stoltzmann and carried by the majority voice vote, the Board directed that 5 foot wide sidewalks be installed rather than four foot wide sidewalks because of the ADA rules and regulations. It was felt it would look better and be easier to maintain. Trustee Charles Waala, Trustee Robert Beisbier and President Robert Wagner voted "Nay." The Administrator is to have the Contract redrafted reflecting the noted changes.

On a motion by Trustee John Borland, seconded by Trustee William Kulas and carried by the majority voice vote, the Board established the position of General Maintenance Lead Worker within the Department of Public Works with a job description for said position. Trustee David Goeden

and Trustee Charles Waala voting "Nay."

The Board reviewed the pay schedule as proposed for the newly created position. On a motion by Trustee William Kulas, seconded by Trustee Robert Beisbier and defeated by the majority voice vote, the Board rejected the pay schedule as proposed and the matter was sent back for further discussion. Trustee Charles Waala, Trustee David Goeden, Trustee Robert Stoltzmann and Trustee John Borland voted "Nay."

The union notification and posting of the aforementioned was tabled because of the lack of having a pay schedule.

Administrator Daniel S. Schmidt reviewed the recycling update report for 1994/1995. It was noted that the Village is in the third year of curbside recycling and that all is going well. The total amount of the recycling grant for 1994 is estimated at \$1,137.79. It was also projected that the avoided disposal cost savings for 1994 is \$15,117.68. This is 346.1 tons at \$43.68 per ton.

The recycling grant for 1995 is estimated at \$17,519.00. It was further noted that the recycling grant money is scheduled to sunset in 1999 and basically decrease on an annual basis.

The contract/agreement that the Village of Kewaskum has with Hechimovich Sanitary Landfill is scheduled to terminate on December 31, 1995. The contract/agreement does have an extension clause that simplifies the process slightly. The Village may ask the contractor to submit a written proposal for an additional two year period. This request is to be filed prior to September 15, 1995 and the contractor has a 30 day response time. Then the Village reviews the two year extension proposal before a formal decision is made. On a motion by Trustee Charles Waala, seconded by Trustee John Borland and unanimously carried by voice vote, the Board authorized the signing and submission of the Final Payment Request Form as required by the DNR.

On a motion by Trustee Robert Beisbier, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote, the Board authorized the purchasing of fireworks for the Centennial Celebration and July 3rd Celebration from Spielbauer Fireworks, Green Bay, WI. Donations have been very good and number 45 to date. The June 10th display will be the largest ever in the Village at a cost of \$5,400 and the July 3rd display will be the second largest ever at a cost of \$4,300. It was noted that Bank Wisconsin donated \$1,500 and was named the Centennial Fireworks Corporate sponsor. A thank you will be going out to all those who have donated money in the local newspaper.

Action was taken on a Proclamation in recognition of the 50th Anniversary of Regal Ware, Inc. as attached hereto:

It was mentioned that the Postmaster has asked the Village President to assist her with the planting of a tree in the park for Arbor Day. The Board indicated a thank you should be sent after the planting.

Representative Glen Grothman was present and addressed the Board. One topic was the reformulated gas issue. The Board will act on a resolution regarding the getting Washington County out of the

The talented trio broke the meet record (14'4") which was held by five teams, including a Kewaskum team of Pam Osterbrink, Ingrid Ankerson, and Andrea Fleiss (1990).

When asked about his jumpers, Koth said, "The girls have been improving each week. Jessica and Sarah are both freshmen and Kelly is only a junior, so we are going to have some very good jumpers for awhile." Koth went on to say, "We actually have four quality high jumpers this year, Jamie Gaffke (sophomore) can also jump real well, but has been out with a sprained ankle. Keith Amundson has been doing an excellent job for years with the jumpers and he is showing his stuff again this year."

Another place where the future looks bright is in the shot and discus events. Kewaskum took first place in both events led by Becky Yogerst, Katie Yogerst and Rachel Nysse. "Both Rachel and Katie are sophomores and have been throwing very well each week," stated Koth, "and Becky is solid. I depend on her leadership."

Greta Kuphal, Jenny Strobel, Erin Stockhausen and Jenny Jagielski combined for a first in the 800m relay and a second in the 400m relay. "Our handoffs in

the 400m relay were awful, but we still managed a second place, so I can't complain too much," said Koth about his two normal relays. Koth added, "Our times are not great yet, but we seem to be ahead of everyone else, so I guess we will be OK when we need to be."

In the 3 x 100m high hurdle event, the girls, led by state qualifier Mary Yahr, along with freshman Joanne Thull, and sophomore Jenny Keller (who was running the hurdles for the first time since last year), managed to finish second to winner Valders. While in the 3 x 300m low hurdles, Yahr along with freshman Carrie Wiesner and fellow senior Missy Rohrer, again captured a second place. Rohrer, who, according to coach Koth, has not worked on hurdles since her freshman year, ran a respectable 56, while Wiesner and Yahr ran 55 and 54.

In the distance medley, Laura Weiss, Greta Kuphal, Jenny Jagielski and Marni Lynn stole first place from New Holstein, who traditionally wins this event. This race matched up two of the better distance runners in the conference, Marni Lynn of Kewaskum and Sheila Kabat of New Holstein (both have been state qualifiers).

"When they both received the baton along side each other, you knew it was going to be a great finish!" said Koth. Both runners ran

stride for stride for the first 500 meters, but then on the back stretch Lynn began to pull away from Kabat to finish 15-20 meters ahead.

"Marni knew who she was running against and her competitiveness took over. She worked very hard in practice last night so I was surprised how strong she looked tonight, I didn't expect that," said Koth.

According to Koth, Jamie Gaffke ran her leg of the 1600m relay in a personal best time of 63.1 seconds while Julie Froemming ran a 66.6 despite running with a slight muscle pull.

Other places and participants were: 480m relay (Marni Lynn, Missy Rohrer and Jenny Immel) fourth; Sprint Medley (Mary Yahr, Jenny Strobel, Erin Stockhausen Carrie Wiesner third; Long Jump (Erin Stockhausen, Carrie Wiesner and Jill Wichtowski) fifth; Triple Jump (Nadalie Reindl, Kathy Deshotels and Missy Rohrer) fifth; 1600m relay (Julie Froemming, Tracy Jacak, Jamie Gaffke and Laura Weiss) fourth.

"It was a team win. Anybody who scored a point for us can honestly say that they helped win that meet for us. It doesn't get any better than that," said coach Koth about the team's victory.

The Kewaskum Girls Varsity fastpitch softball team had a busy schedule last week, playing four games in as many days.

The girls started off the week by traveling to New Holstein to face the Huskies. Kewaskum gave up four runs early, while Huskie pitcher Becky Haensgen held the Indians hitless through the third inning. Tanya Krahn collected the Kewaskum's first hit, a double in the fourth.

After stealing third, Krahn scored on a ground out. Later in the inning, Shelly Williams reached on a fielder's choice and scored on a base hit by Tiffany Laubach.

New Holstein added a run in the bottom of the fifth and held Kewaskum scoreless the rest of the way, making it a 5-2 Huskie victory. Michelle Thull picked up the loss for Kewaskum, striking out one, and walking three in six innings of work. Laubach and Williams led the Indians at the plate, each collecting two hits in three at-bats.

At home on Tuesday, Kewaskum hammered Elkhart Lake, scoring 15 runs in just three innings, enroute to a 15-5 decision.

The host Indians sent all nine batters to the plate in the first inning, scoring six times. Tanya Krahn, Debbie Neumann, Misty Luedtke, Michelle Thull, Molly Cech-

vala, and Stacy Gavin all scored in the inning, which was highlighted when Gavin hit a two-run double.

The Indians chalked up another run in the second inning, before exploding for eight runs in the third. Cechvala started the bombardment with a triple, later scoring on a passed ball.

Kewaskum then loaded the bases on two errors and a single by Kori Ritz, and a walk, coupled with an Elkhart Lake error gave the Indians two more runs. With no one out and the bases still loaded, Neumann smacked a three-run single, making the score 13-3 in Kewaskum's favor. The girls weren't done

scoring yet, adding two more runs before the inning was over.

Elkhart Lake squeezed in two runs in the fourth inning, but was shut out in the fifth, and Kewaskum picked up the win via the ten-run mercy rule, 15-5.

After having Wednesday off, the Lady Indians headed to Kiel for a double header.

"The errors killed us," coach Janet Molebash said of her team, which committed 13 errors in a wild game and lost 17-7 in six innings. Kewaskum actually led the game 3-2 after the first inning, but Kiel scored six times in the second and never looked back.

Tanya Krahn, Debbie Neumann and Stacy Gavin were the leading hitters for Kewaskum, going 3x3, 3x4 and 2x2 respectively.

The Indians played host in the second game, and only committed two errors, but the result was the same, as they dropped the game, 11-4.

Kewaskum, down 2-0 early, scored twice in the third to tie the game, only to see Kiel score four times in the fourth inning to regain the lead.

Kewaskum chipped away at the Kiel lead, cutting it to just two runs going into the seventh inning, but Kiel spoiled the comeback by scoring five times in the last inning.

Shelly Williams (2x3) and Kris Hafermann (2x3) led Kewaskum at the plate, as the Indians record fell to 2-6, 3-8 overall.

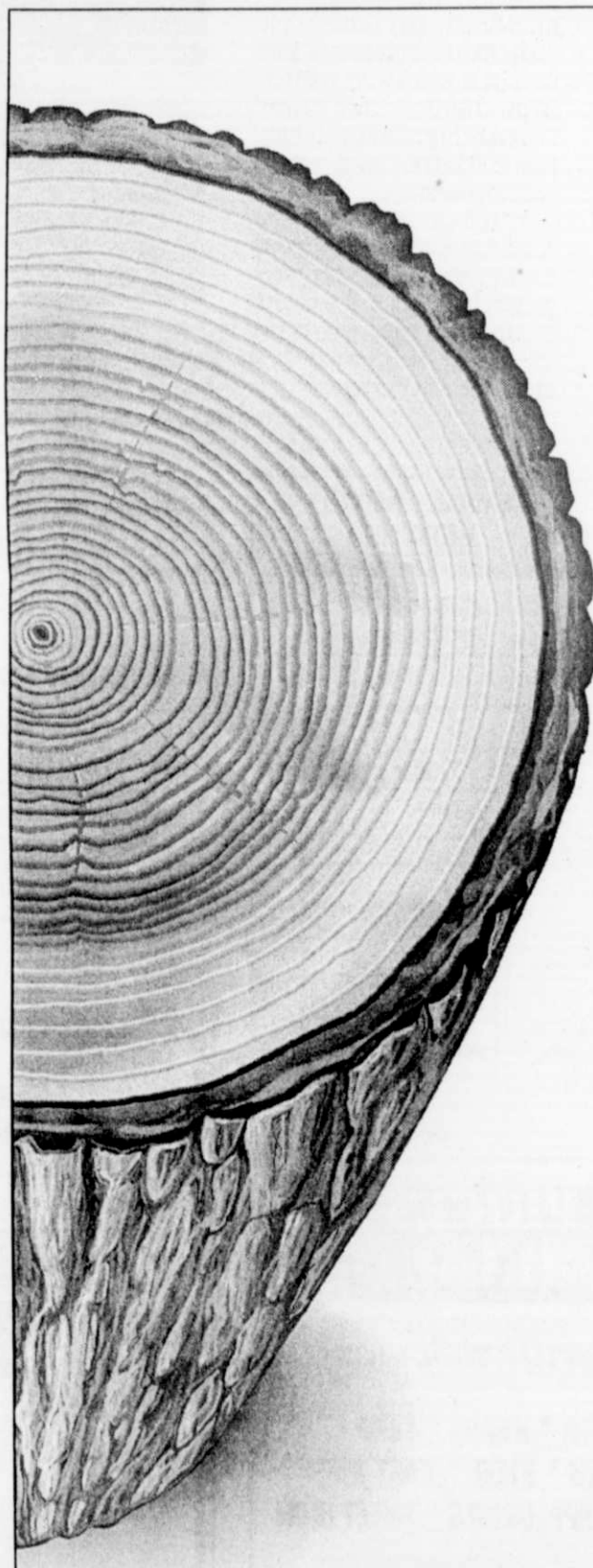
