## Kirst Aids in Rescue of Fighter Pilot

By now, Kewaskum and the rest of the nation has seen our hometown hero, Glenn Kirst, on local and national television news. In fact, his parents, Robert and Mary Jane Kirst, first heard the news of his involvement in the rescue of Capt. Scott O'Grady from Bosnia while they were watching the Channel 12 News.

"Glenn was pointing to the bullet holes in the helicopter," Mary Jane reports, and Glenn later called his parents from Italy on Saturday, while Kewaskum was in the midst of their Centennial celebrations, and told them the historic news. "Luckily I hadn't gone over to the park yet, and then the phone rang, and I'm glad I was home!"

On Thursday, June 8, Corporal Kirst served as part

of an elite team of U.S. Marines that rescued O'Grady in Bosnia to rescue O'Grady, the F-16 fighter pilot who was shot down while on NATO patrol by a Serbian missile on June 2.

"We knew he was on the ship," Mary Jane indicated, referring to the USS Kearsarge Kirst had been serving on in the Adriatic Sea, "but we had no idea he was a part of this."

According to the conversation she had with her son, Glenn, who is a crew leader, was on the first helicopter that landed for the rescue operation, and the infantrymen from his helicopter went out in search of O'Grady. They had been picking up his radio signals, and traced him to this area.

"Scott came running out of the woods, and got on the second helicopter," she related. "Then Glenn had to go

out and get back the infantrymen from his helicopter and get out as fast as they could. They were about 85 miles from their ship, or halfway back, when both helicopters were hit by gunfire. When he told me they were hit by gunfire, I said, 'Glenn, you could have been shot!'"

But it's all in the line of duty for Kirst, who graduated from Kewaskum High School in 1991 and has been in the Marines for the past 3 1/2 years, thoroughly enjoying serving his country.

The Kirsts have no idea

when Glenn will be coming home, as he has three more months to go on the ship, and then will be stationed at New River Marine Corp. Air Station in North Carolina.

Bob and Mary Jane are proud of the role their son played in the rescue of Scott O'Grady, and are happy the pilot is safely home. But all this celebrity status is a bit overwhelming for a small town family.

"Channel 6 and 12 came up and interviewed us, and we were on the news," she states in disbelief. "Bob went

up to the Centennial and told some people and I guess a news reporter overheard and the word spread like wildfire."

The entire community of Kewaskum congratulates Glenn on his part in the heroic rescue, and looks forward to thanking him in person for proving once again, that those Americans that serve and defend the United States of America, make it a country we can be proud to call home.

## Board Retains Custodial Positions

Three janitor/custodians for the Kewaskum School District will be able to keep their job classifications as well as health benefits after the school board voted down an approval that would have reduced their support staff positions, at Monday night's meeting.

The topic was raised at last month's board meeting, after budget workshops indicated a need to cut costs and tighten belts to meet revenue cap limits, and the three custodial positions were one of many items considered for

the chopping block.

The reclassification from full-time to full-time school year, would have saved the district around \$25,000. Adding fuel to the fire was the fact that the district had already approved the hiring of two additional janitors, at a cost of \$33,579.

The emotional issue roused anger on both sides of the fence, with some members of the board feeling the overblown publicity the agenda item received was unfair and uncalled for, seeing they had listened to the employees' grievances at last month's meeting, and had

tabled the item until more information could be gathered.

Board President Neal Weare opened the discussion, stating, "I think this has been discussed at great length by the newspapers, the radio, letters that we've (the board members) all received, and at great length at last month's meeting."

Support staff member Betty Mikkelsen told the board, "I think this impact is definitely wrong... you're taking away our livelihood." "We haven't done anything yet," Weare indicated.

Board member Jeanne

Goeden confronted Betty about her recent live radio conversation. "I have to be honest with you. When you went on the radio I got a very bitter taste in my mouth. We listened to you and your statements at the last meeting and took all this into consideration. We did not take any action or push the matter."

Mikkelsen responded by saying the public had a right to know what was going on, and that she was being harassed and threatened by all this.

Goeden pointed out that

none of this had been done behind closed doors, as some rumors were stating. All meetings were open to the public, including the budget workshops, and the position cuts were only one of many items chosen to reduce expenses. "We did not even know at the time who filled these positions," Goeden added.

Community member Larry Fechter spoke to the board, and thought that there

could be a different way of achieving what they were trying to achieve, and wondered what other savings might be possible in place of reducing these positions.

As a closing comment, board member Karen Sparks related her opinion that this entire matter shows proof that the system works. "It's not that this committee was gunning for anyone. When we first get information of this type, we don't always put a face on it, because it's in the midst of other decisions going on. In the meantime,

you've followed the correct process - you've circulated petitions, you've informed us... this indicates the process works, of committees, of people finding out what's happening, showing up for things, lobbying, writing letters, it works."

The board unanimously voted the item down, and indicated that in the future, the positions could change to school year only when people retire, or through attrition, causing less disruption, and less of a burden on the school board itself.

moved to the north parking lot.

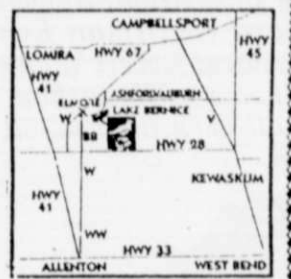

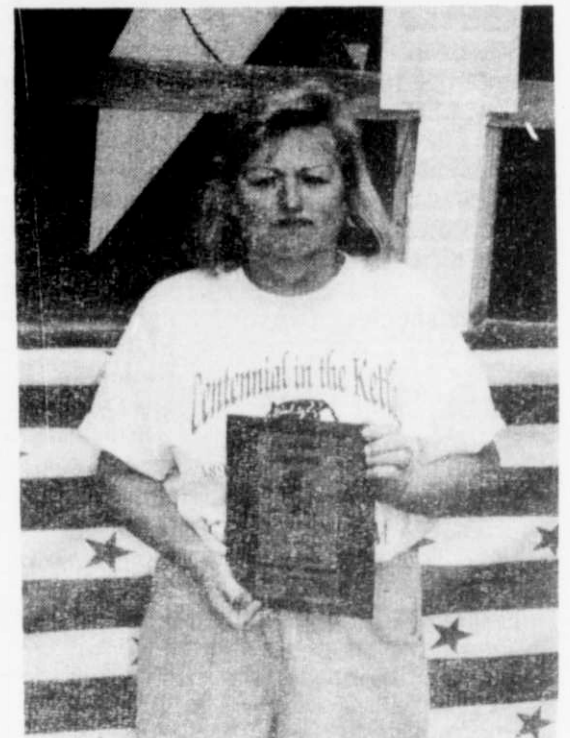

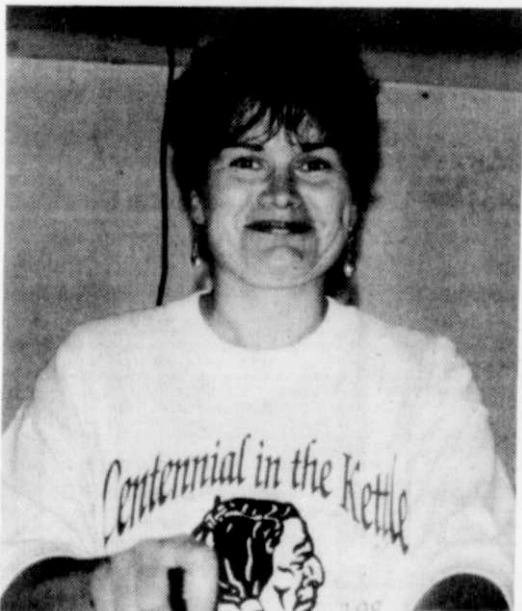

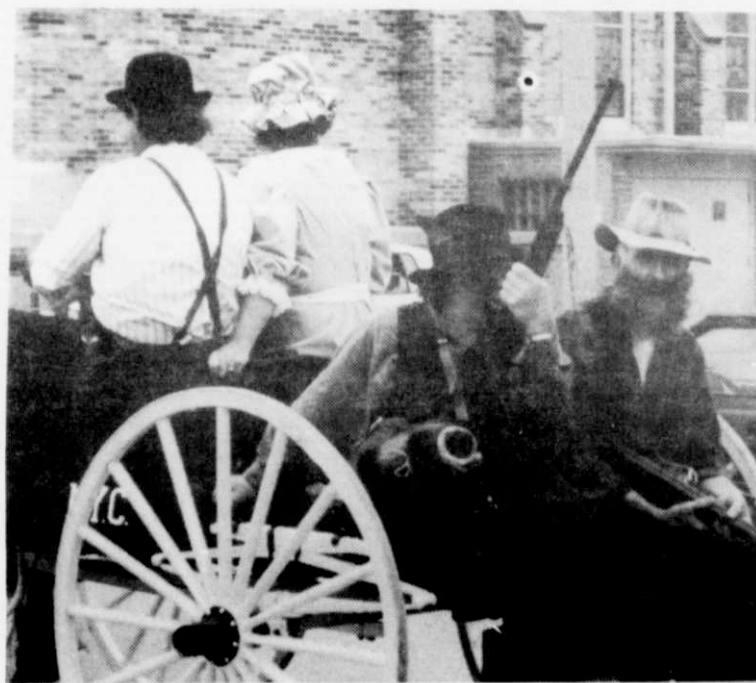

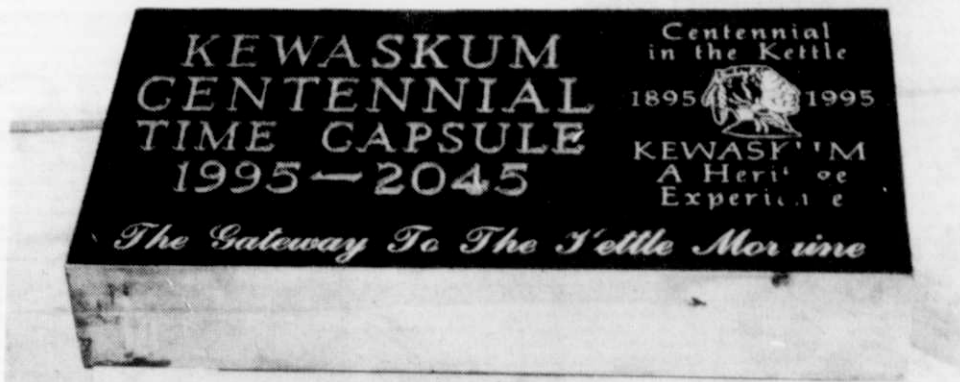

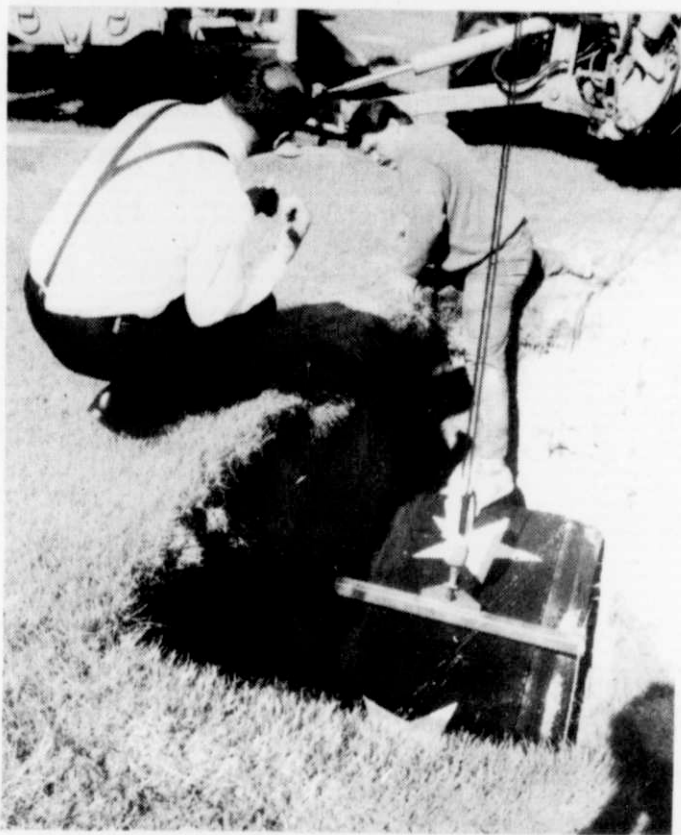

May 15, 1995

The Village Board of Kewaskum, Washington County, Wisconsin, met in Mid-Monthly Session in the Council Room of the Municipal Building, 204 First Street.

President Robert Wagner presided. Trustee John Borland asked to be excused and was absent. All other Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

Three neighbors were present to listen to the information provided with no comments. On a motion by Trustee William Kulas, seconded by Trustee Robert Stoltzmann and carried by the majority roll call vote, the Board closed the public hearing. Roll call vote was 5 "Aye" 0 "Nay" 1 "Absent" 1 "Abstention."

Two bids were received and reviewed for the underground storage tank removal and replacement as follows:

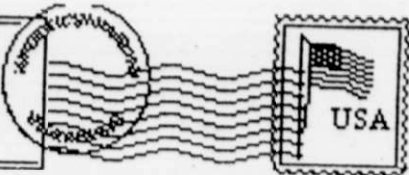

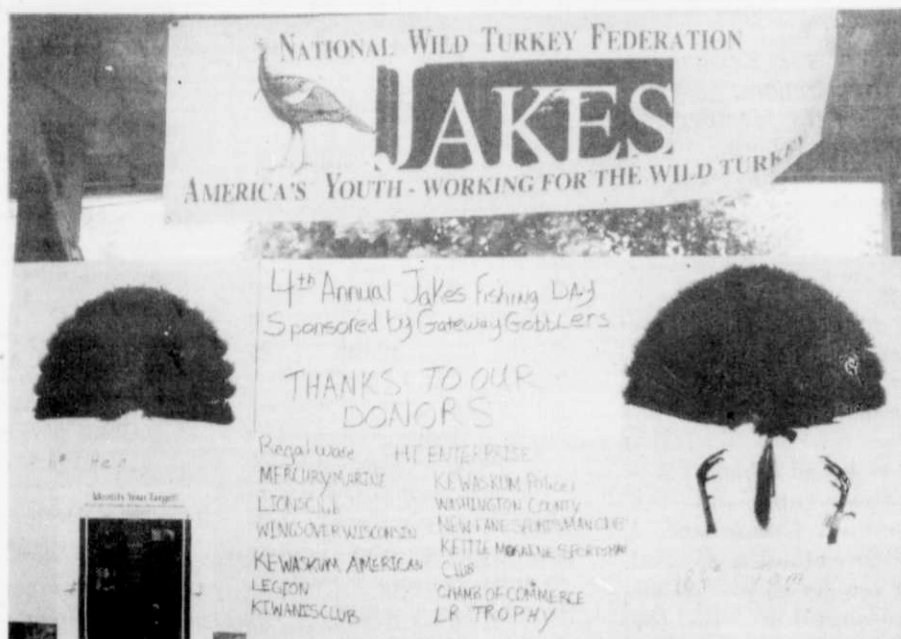
# JAKES Fishing Day Held in River Hill Park

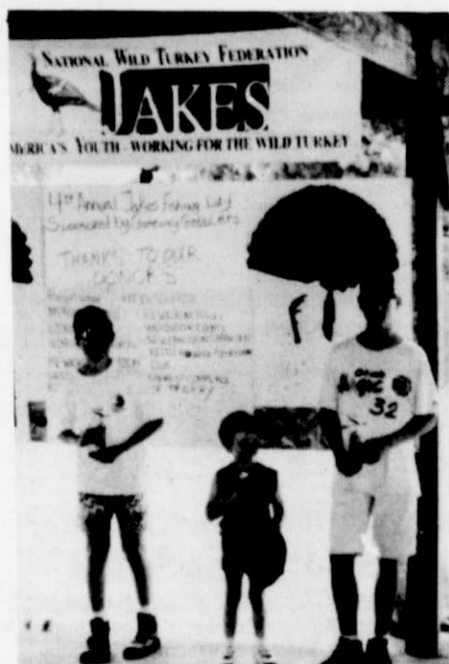

Note: The Police Department had no objections to any of the applications.

Administrator Daniel S. Schmidt reviewed the following with the Board:

The Open Book is scheduled for Tuesday, May 16, 1995 10:00 a.m. to noon and 1:00 p.m. to 7:00 p.m. as well as on Wednesday, May 17, 1995 1:00 p.m. to 7:00 p.m. The Board of Review is scheduled for Monday, May 22, 1995 10:00 a.m. to noon and 1:00 p.m. to 4:00 p.m. It was noted that if the Village would not have reassessed, the new State ratio would have been 58% instead of last year's 71%.
- 2) Review of the Budget Control Sheet for April 30, 1995.
- 3) Review of Mid-Moraine Municipal Association meeting scheduled for May 24, 1995.
- 4) Centennial Celebration update.
- 5) Review of League and Taxpayer bulletins.
- 6) Announcement of Dairy Queens' opening on Wednesday, May 17, 1995, at 10:30 a.m.

Chief of Police Richard L. Knoebel recommended to the Board the high bid received for the 1993 squad car of \$5,850 should be taken. On a motion by Trustee Robert Stoltzmann, seconded by Trustee William Kulas and unanimously carried by voice vote, the Board approved the sale of the squad car to Diversi Fleet, Kansas City, MO for \$5,850.

Chairman of the Park and Recreation Committee, Gary Gavin announced no action was needed on the electric Coke sign yet.

Board Representative for the Plan Commission, Trustee David Goeden informed the Board of a Plan Commission meeting scheduled for May 23, 1995 at 7:00 p.m.

Board Representative for the Mid-Moraine Municipal Association, Legislative Committee, Trustee Robert Stoltzmann reported that the MMMA Legislative Committee acted on two resolutions, one on the State annexation laws and the other on reformulated gas.

Action was taken on Ordinance No. 95-4 An Ordinance To Amend The Zoning of Village Land as attached hereto:

On a motion by Trustee David Goeden, seconded by Trustee Harry Roecker and carried by the majority voice vote, the Board approved the Certified Survey Map for Gary and Linda Gavin and authorized the signing of the CSM. Trustee Gary Gavin abstained from voting.

Attorney Gerald Kiefer was present as well as RTKM LLC and their Attorney Roger McKenna. The Village Board reviewed the Conditional Use Permit/Planned Unit Development Agreement and Consent and Waiver for RTKM LLC. It was noted the changes as proposed were all made with the exception of (4) under Roads and Street, which the Planning Commission asked that the Village Board revisit. Discussion was held on the topic of milling and resurfacing a portion of Highland Avenue and Stark Street. It was noted that Highland Avenue to the west side of the intersection with Stark Street needed to be cut into for water access. On a motion by Trustee Robert Stoltzmann, seconded by Trustee William Kulas and carried by the majority voice vote, the Board directed that only the milling and resurfacing of that portion of Highland Avenue and Stark Street/ Highland Avenue intersection be milled and resurfaced by the Village and billed back to the developer when the Village does the adjacent streets. This topic is to be covered in the agreement and consent and waiver.

Discussion regarding the landscape buffer was then discussed and it was noted that at least 3 foot plantings were to be used and that a landscape exhibit accompany the PUD Agreement. It was further noted that an Exhibit for the entire layout including the 5 foot concrete sidewalk, roads/streets, and etc. as well as an Exhibit for the water and sewer and storm sewer be provided. When the WEPCo. has the street light layout completed that Exhibit is also to be included. The Board reviewed and briefly discussed Class "A" & "B" Liquor License Fees. The survey results reflected that the Village was under what the communities in the surrounding area charge. ## ORDINANCE NO. 95-5

### AN ORDINANCE TO AMEND THE GENERAL ORDINANCES OF THE VILLAGE OF KEWASKUM, WISCONSIN

WHEREAS, it is deemed expedient and necessary that the Municipal Code of the Village of Kewaskum be brought up to date; and

WHEREAS, ordinances adopted through Ordinance #95-1, dated February 6, 1995, and changes necessitated by changes in State law have now been incorporated into the Municipal Code; and

WHEREAS, a copy of such amended Code has been on file and open for public inspection in the office of the Village Clerk/Treasurer for not less than 2 weeks, as required by Wis. Statutes 66.035, and notice thereof was given by publication on May 11 and May 25, 1995 in the Kewaskum Statesman;

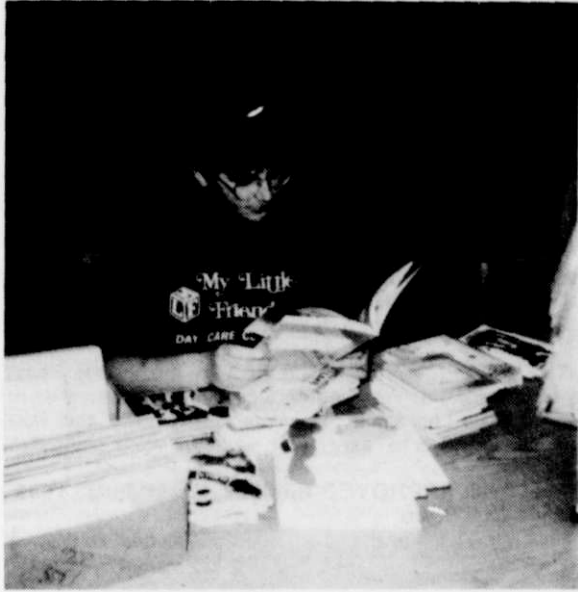

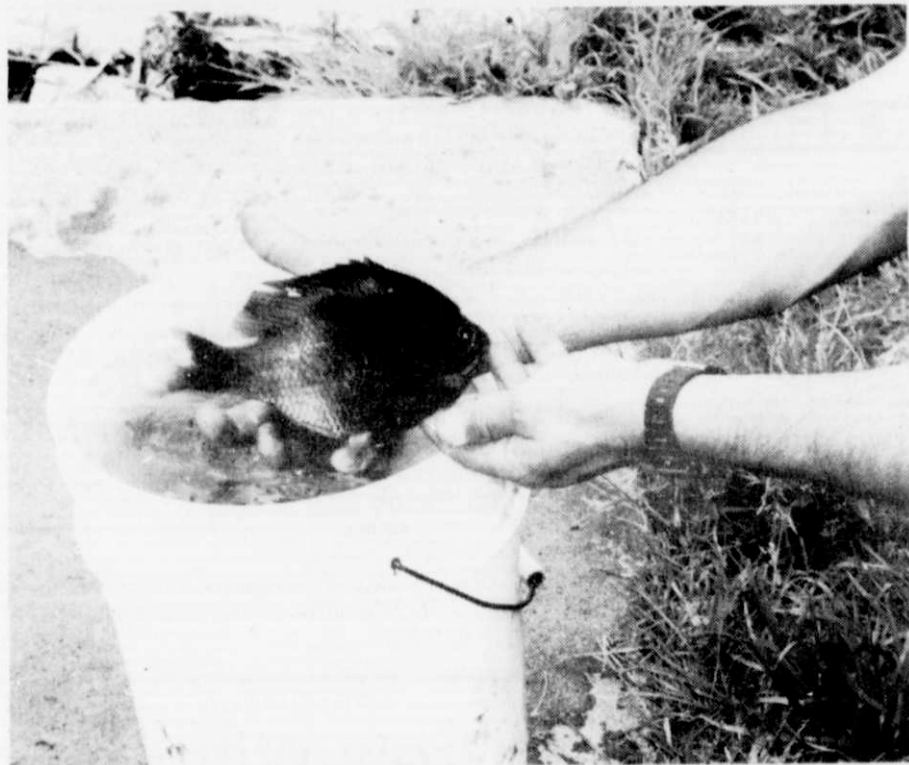

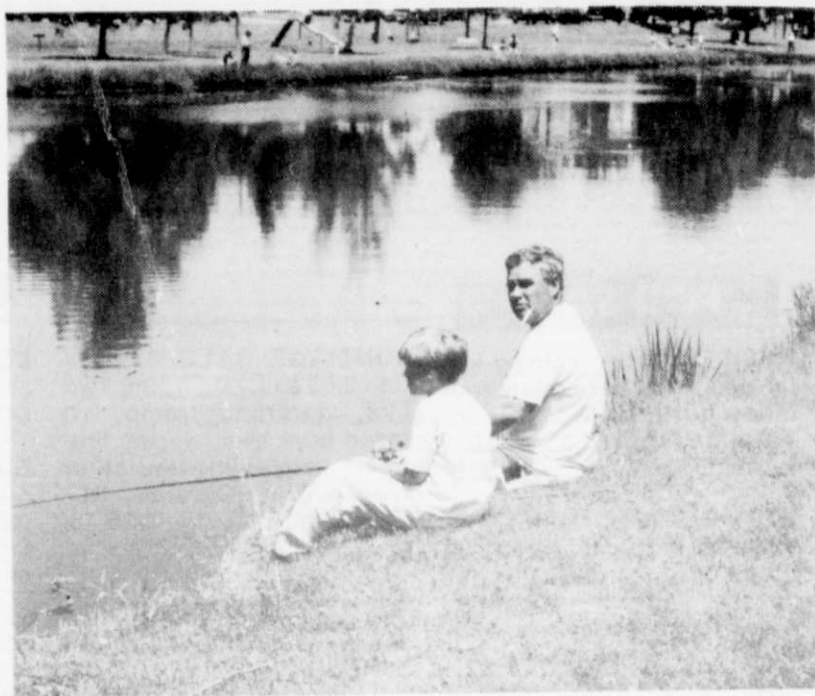
# 800 More Fish Planted In Milwaukee River Here

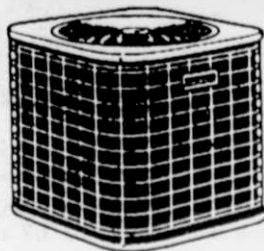

**Indian Bats Are Back!**

With the conference schedule starting last week, the Kewaskum varsity baseball team was looking to snap a four game skid against Kiel on Monday. Over the course of the team's last four games, Kewaskum's offense had been virtually non-existent, scoring just once in each of the contests.

The Indian bats were awakened against Kiel, however, as Kewaskum banged home three runs in each of the first two innings, to jump out to a 6-0 lead. The Indians were held scoreless the rest of the way, but pitcher Dan Jeserig had another fine performance for Kewaskum, going the distance and allowing only three hits, while striking out six Raider batsmen and walking only one. Jeserig's effort was enough to hold off Kiel, as Kewaskum went on to pick up a 6-4 victory.

On Tuesday, Kewaskum

made the long trip to Hilbert, but rain set in before the players could set foot on the field, cancelling the game. A June 16th make-up date has been scheduled.

Rain was again the Indians worst enemy on Wednesday, when Kewaskum hosted archrival Plymouth. The Indians scored four times in the first inning, led by Dan Survis and Tim Gundrum, who each had RBI singles.

The Indians scored twice in the third and once more in the fourth to gain a solid 7-1 lead, when lightning delayed the contest. Players from both sides sat in the dugouts to wait out the storm and hopefully resume play, but the ensuing downpour ended the game.

Because Plymouth had not been able to bat in the fifth inning, the game could not be postponed, thus leaving the Indian's effort for naught, with the game to be started over on a later date.

The Kewaskum players were noticeably upset on Friday, when they boarded the bus to Two Rivers, still angered by Wednesday's wasted effort.

Things quickly changed, though, when coach Mark Heise read aloud a section of the W.I.A.A. rule book, which stated that the game should instead be postponed. This meant that instead of restarting the game vs. Plymouth, the game would continue from the point which it ended, with Kewaskum up 7-1 in the top of the fifth inning.

At Two Rivers, the Indians came out looking a little flat, giving up three runs in the first inning, but they quickly responded by scoring four runs of their own to take

a 4-3 lead. The game soon became a slugfest, with the teams trading runs each inning.

With the Indians down 8-9 in the fifth inning, Tom Menger hit a two-out single, and Andy Rix reached on an error. After Menger scored on another error to tie the game, Kevin Klahn stroked a single that scored Rix and gave Kewaskum a 10-9 lead.

With the score still at 10-9 in the seventh, and Kewaskum needing just three outs for the win, Indian pitcher Tim Gundrum walked two of the first three batters, putting the game on the line. Gundrum then struck out the next Raider hitter, putting Kewaskum just one out away from victory. Coach Heise decided to give an intentional walk to the next Two Rivers batter, loading the bases and giving Kewaskum a chance for a play at every base.

Two Rivers catcher Kevin Smogoleski then stepped to the plate, looking to win the game for the Raiders. Gundrum would have no part of it however, as he struck out Smogoleski to end the game, preserving a 10-9 victory for the Indians.

Leading Kewaskum at the plate were Tim Strigenz (2x4, 4 RBI's), Gundrum (3x4, homerun), and Kevin Klahn (1x2, three walks).

After beating Two Rivers, who many have picked to win the conference title, Kewaskum lies atop the EW at 2-0.

# Lynn Sets New School Record

## Indians Shine at State Track Meet

### Jacak 3rd, Girls Place 4th, 6th, 8th, 10th

The Kewaskum girls track season ended with a number of girls competing at the WIAA State Track and Field Meet held at UW La Crosse on June 2 and 3. Competing in four events, the girls represented Kewaskum well by placing fourth, sixth, eighth and tenth. It celebrated the 100th year of the boys meet and the 25th year for the girls.

On Friday, sophomore Marni Lynn started the action by placing fourth in the 1600 meter run. Lynn set a new school record in the event by going the 1600 meters in 5:13.95, breaking her own record which she had set earlier this season.

Lynn found herself in eighth place with one lap remaining, but started her kick coming out of the first turn and was able to pass four runners who were in front of her, including New Holstein's ace distance runner Sheila Kabat.

As far as breaking the school record was concerned, it came as no surprise to Coach Perry Koth. "I could see that Marni was peaking at just the right time and pretty much expected that she would have her best run of the year at the State Meet," said Koth. "Marni trains hard for her events year round and really is one of the hardest workers I have on the team. I am really happy for her and her family that all that hard work has been rewarded."

This was Lynn's second appearance at the State Meet where last year she placed in the 800m run. With Lynn only a sophomore this year, Coach Koth can rest easy knowing that he will have an outstanding distance runner for the next two years.

The other final event on Friday was the shot put, in which senior Becky Yogerst closed out her four year career. Yogerst placed 10th with a throw of 34'6". It was not her best throw of the year, but it was a throw that she will always remember because it occurred at the State Meet.

Yogerst indicated after the event that she was disappointed in herself for not throwing better, but Coach Koth was quick to let her know that he wasn't at all disappointed with his senior thrower. "I'm not!" was Koth's response to hearing her remark about being disappointed in herself. "Just getting to this event is an outstanding achievement and there is nothing you should feel bad about," he continued. "Becky has been a leader for us all year in the throwing events and really deserved to get to the State

Meet. She can be proud of what she has done this year."

On Saturday, Kewaskum had two relay races to compete in, the 800meter relay and the 400 meter relay. Both races were going to be run by the same four girls, Greta Kuphal, Jenny Strobel, Erin Stockhausen, and Jenny Jagielski.

All four girls had made it to State last year in the 800m relay (Kuphal, Stockhausen, and Jagielski as runners, while Strobel was an alternate) so it looked good for their chances of medaling this year in this event. One thing you can count on though, at the State Meet, is that nothing is for sure.

In the 800m relay everything went well until the second handoff, when the runner coming in could not catch the runner going out to exchange the baton. The result was lost time and an eighth place finish, with a time of 1:50.6.

The top eight places score points for the team, but only the top six get medals. This left the girls with somewhat of a dilemma. They had expected to medal in the 800m relay, and had made some changes in the 400m relay in an effort to improve their time.

The changes in the 400m relay however, were of an all or nothing type of change. "We extended the handoffs to a maximum, we would either hit them perfectly or miss them completely and finish last," said Koth. "I asked Greta after the 800m relay if they wanted to use the old handoffs, which we had used all year, for the next race. But they wouldn't even consider it. They didn't want to play it safe, they wanted to go for it," added Koth.

They didn't have to wait very long to find out how they would do, because the 400m relay was run about 20 minutes later. With all or nothing on the line, they executed the handoffs perfectly and finished in sixth place with a time of 51.6.

Jenny Jagielski ran another strong anchor leg to pass some runners and move into the sixth spot. In a very close finish, it appeared that she had finished in fifth place, but the finish line equipment did not see it that way and the official position was listed as sixth.

"To come back after having missed a handoff in a previous race, and then execute the handoffs perfectly is outstanding," said Koth. "It really shows you what they are made of. I guess what I am really proud of the most about these girls, is the decision they made to not play it safe in the second race. It showed the confidence they have in themselves and the

attitude they have about not being afraid to fail. A lot of people would have played it safe."

The 400m relay marked the end of an outstanding career for senior Greta Kuphal. Kuphal made several appearances at the State Track Meet, set several school records, was the MVP of the conference champion Indians this year, and was an individual conference champion in five events during her career. About Kuphal, Koth said, "Greta was always the model athlete for me, her attitude, work habits, and leadership were exactly what a coach would want from his MVP. You just don't replace someone like Greta."

While not everything went exactly the way they would have liked it to have gone, Coach Koth was still very pleased with the results. "Getting to this meet is so difficult! As a coach, you are proud of your athletes no matter how they perform when they get to this level. I just hope the girls realize exactly what they have achieved. I certainly do," added Koth, "and I am very proud of every one of them. In my book, they are all champions."
