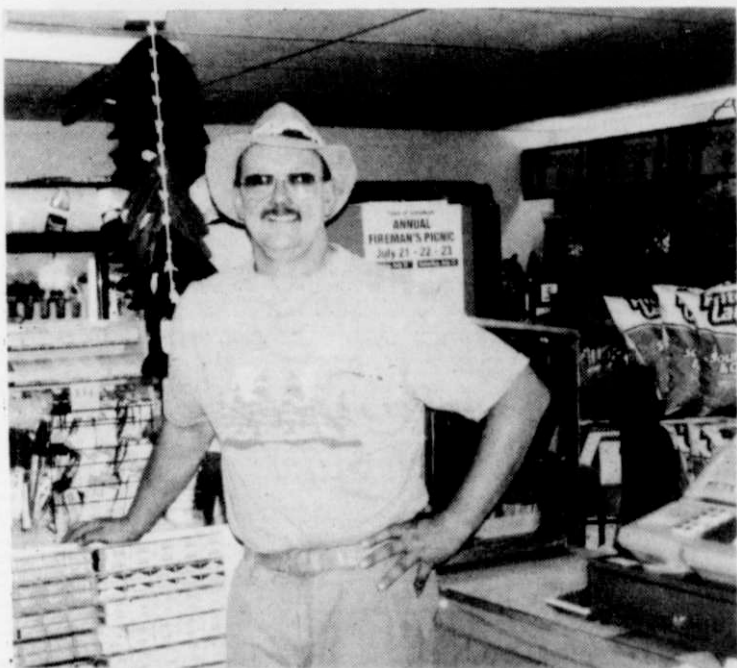

Desterhofts Purchase Parkview General Store

The Parkview General Store has a new look these days, thanks to the energy and enthusiasm of new owners, Mike and Julia Desterhoft, who reopened the store on June 30.

The couple had been looking into the resort business, touring upper Michigan in search of a business opportunity. They'd also been through the Mauthe Lake area several times, and when they saw the store was for

sale, they decided it was an ideal location for them, since their son could remain in the Kewaskum School District. The Desterhofts moved from their home in Boltonville and spent the next five weeks intensively cleaning and remodeling the old store.

"We moved on Memorial Day weekend, and it was a non-stop rush to get the store in shape and open for the season," explains Mike, greeting tourists from the nearby campground with his warm

Board Votes to Stick With VALUE Program

In other business that transpired at the Kewaskum Village Board meeting last week Monday Police Chief Richard Knoebel brought up a letter he had received from the VALUE bidding program.

The letter stated if the Village would still like to be involved in the VALUE program, they would like to bid it early because Chevrolet is not going to bid any 1996 Chevy squad cars. They will first be filling their 1995 backorders and they won't be making the Caprice.

According to Chief Knoebel, "They would like to

get the bids earlier, but the squads will still come some time after January 1."

The fact was brought up that Ford will be the only company making squad cars, as Chrysler still has not gotten back into it.

Trustee Gary Gavin inquired, "It sounds like the price is up though, quite a bit at \$20,000?"

Knoebel answered, "She said she figured high, because we got burned so bad last year. Last year we paid \$17,500, but see with only one company bidding... she said, the lady from Waukesha purchasing, everybody's budget got stung so

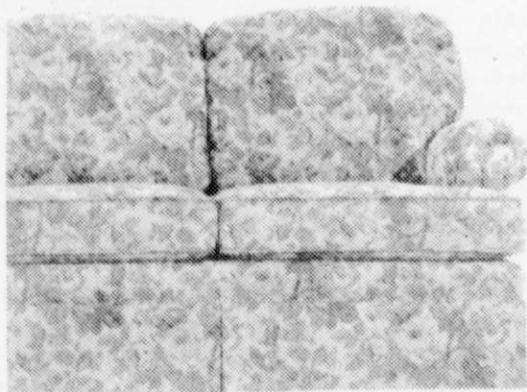

Roger Vetter Observes 40th Year With Beechwood Cheese Factory

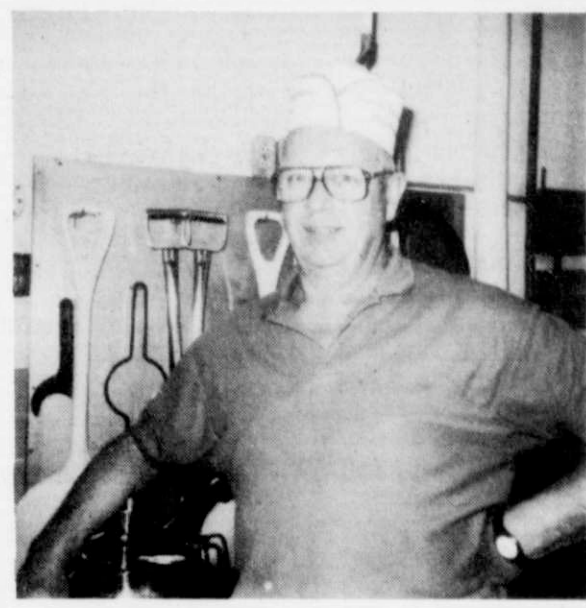
Roger Vetter, resident of the Beechwood area, has marked 40 years of service at the Beechwood Cheese Factory.

Leaving high school at 16, Roger began his career on June 1, 1955. After a year and a half on the job, he was able to earn his Wisconsin Cheesemaker's License. His father, Ruben, a cheesemaker for 28 years, worked at the cheese factory until 1953.

When Roger started, the factory made only Cheddar cheese, working a 10-hour day. Now, the company has expanded into American-type specialty cheeses and improved to an 8-hour work day. When asked the biggest change between then and now, he cited the change from can milk to bulk handling.

Roger has lived in the Beechwood area almost all his life. He and wife Elaine, an employee of M&I Bank in West Bend, have two children. Their daughter Amy (Don) Nelson resides in Omro with her family. Son Mike and wife Annette (Klahn) reside in Campbellsport.

Daggett Wins Bastille Title

The soaring temperatures slowed down everyone recently except Sue Daggett.

Sue, a graduate of Random Lake High School who competed in the NCAA Track and Field Championships in May, added a victory in the Bastille Days 5K run in Milwaukee to her growing resume of first place titles.

In a race many runners failed to finish because of the high temperatures, the Illinois State University junior earned the overall title in a women's field of over 1,000 runners with a time of 16 minutes, 40 seconds; over a minute and a half ahead of her nearest competitor.

The Bastille Days run began at 9:30 p.m. and started two blocks from Milwaukee's Lakefront. But that didn't make for cooler temperatures, according to Sue's father, Wally Daggett.

There was little time to celebrate, however, as Sue had to be at her job with the Department of Natural Resources at 7 a.m.

"She was just happy to win," said her dad. "She has a great desire to win. I said that it was hot, and it is a fun run, but that didn't matter."

and genuine nature.

Desterhofs first attempt at the retail business, although he did run a lawn and garden shop in Germantown for several years. His wife, Julia, works for Fleming Materials in Milwaukee, and will be working with him at the store in the evenings and on weekends. They have two sons, Chris and Nick Bailey.

The couple decided to stay with the name, Parkview General Store, but that's basically all that remains of the old business. Completely revamped inside, the modern interior has the look of a 90's mini-mart, with a wide array of inviting services and fresh foods.

One side has been converted into a game room, with picnic tables, a juke box, pool table and foosball, and seven different video games. "Our goal is to give the high school kids a place to come to for some low budget entertainment," Mike points out, and adds that after Labor Day, he'd like to see some pool, foosball leagues and video game tournaments start up for the area youth. The room also contains two new coin operated washers and two dryers, and will remain open until 9 p.m. Monday through Saturday. No smoking or alcohol is allowed.

Their inventory is boastful for a small country store, and includes fishing equipment and bait (all popular worms and leeches -- with minnows to arrive shortly), buckets, lures, nets, a wide array of camping supplies, toiletries, paper products, groceries, cleaning supplies, charcoal and grilling supplies, to mention just some of the stock.

The Desterhofs have made it a point to tempt their customers with food and refreshments, and their assortment includes pizza right out of the pizza oven, popcorn and a microwave for popping, fresh bakery,

including those huge muffins, Chilly Willees (two flavors of slush), a Cappuccino machine, hot chocolate and coffee, dairy products, Kewaskum Frozen Foods meats and sausages, cold beer and soda, liquor, ice cream, candy and other irresistible munchies.

"We've structured our pricing so as not to be outrageous," Mike maintains, "and our everyday prices are right in line with what you find on grocery store shelves." Next spring they plan on adding a soda fountain with ice cream, and are looking into carrying bicycles, cross country skis, boats and canoes for rental. "Also, watch for a line of hunting supplies this fall," Mike adds.

Unique to the area, Parkview General Store carries the only line of sportswear with Mauthe Lake and Kettle Moraine State Forest logos. T-Shirts are \$12.50 and sweatshirts go for \$18.75. "I feel this entire area could be well served by a business owner's organization," Mike states. "We could

really promote our tourism through co-op advertising, and I'd like to try and spark some interest in starting a State Forest Chamber of Commerce."

The store also offers an LP tank filling facility for customer convenience, and will refill LP bottles from their tank. "We've been working with the DNR to become a game registration station, and I think it would be a good idea to offer leaded regular gas for off-road use," he remarks, with so many snowmobile trails being made use of close to the store.

Parkview General Store is open from 7 a.m. to 9 p.m., Monday through Saturday, and on Sundays from 9 to 5. Stop in and meet the new owners on your way to the beach, and check out the store's new look. You'll be pleasantly surprised.

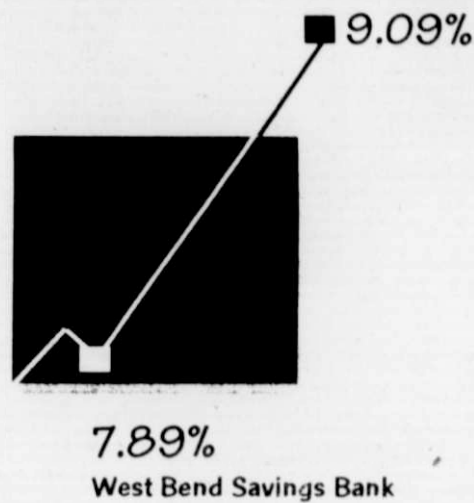

bad last year, that they're worried again this year."

Gavin stated, "It sounds like they're going to start holding everybody up for ransom."

Knoebel stressed, "There's no cars, you can't get a car."

President Robert Wagner asked, "Wouldn't Ford be cheaper though, maybe?"

Knoebel answered, "Well, we don't know, we're hoping."

Village Administrator Dan Schmidt added, "Fords are maybe a little cheaper, but there's also less resale."

Knoebel added, "Chevrolets are bringing like \$2,000 to \$3,000 more than the Fords at the auctions."

Schmidt reiterated, "You do have an option, you can say well we can just bid normal, however, you still did not get your local dealers to bid, because they're not going to be making anything. You could go out to other dealers to bid, however, if you look at the comparables, we save \$5,000 through the VALUE program. The dealer does have the option to bid locally, and they always have."

Knoebel added, "Ever since we've been in the VALUE now, it's always been less than the other bids. We've always gotten the lowest bid through VALUE, because they've got the most power. They're ordering 300

and some cars. Even the State of Wisconsin bid was higher."

Trustee Gavin stated, "It seems like they've got you and they're squeezing." He also asked, "Is this just for Chevys?"

Knoebel added, "We'll go for anybody that's going to bid. But Chevy basically told her, 'we're not bidding this year.' You never know, all of a sudden Chrysler if they see this, they could pop through. And I'd gladly see Chrysler come back because they always had good squad cars."

Trustee Gavin asked, "What about keeping that car another year?"

Knoebel said, "By that

time, there would be well over 120,000 or 130,000 miles (on that car). Then you'd lose your total resale value. You'd lose the \$6,000 or \$7,000 you would get on that resale. So if you figure with the Chevy that we're going to get rid of now, I'd say with that car..., we're probably going to get between \$8,000 and \$10,000 for that Chevy next year."

After further discussion it was decided to stick with the VALUE program.

Discussion was also held on the Highway 45 project work and the new stoplights at the intersection of Highways 45 and H. Chief Knoebel explained all the

stoplights will be going back on sensors. There won't be any on time. The light on the top of the hill went into full operation this past Tuesday.

Knoebel stated, "The biggest problem we'll have with local people is they're not going to be used to it. I hope we won't have a lot of accidents. People are going to have to really use their heads. Think about it... just watch... and as soon as the light turns green, don't pull out instantly on Highway H. I'd kind of watch a little bit. We'll see how it works."

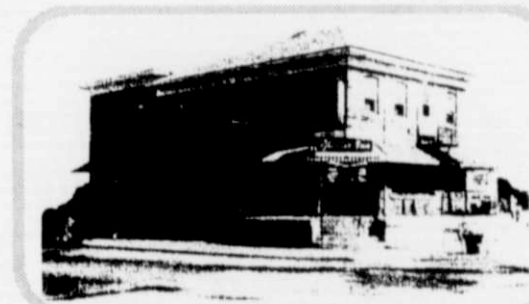

The Wisconsin Lions International hosted a week long Youth Exchange Camp in Dundee recently, giving students from all over the world a chance to experience summer in Wisconsin.

This is the fourth year in a row the Lion's Club has sponsored this event, which was held at Father Joseph Fischer's Camp Vista from July 16th through July 23rd. 65 young people from 29 different countries gathered at the camp to exchange ideas, and experience new cultures.

Ranging in age from 16 to 22, each individual was sponsored by a Lion's Club, after passing through an evaluation, or perhaps an essay contest, or other form of eligibility in their own country. "Each student is chosen as a representative of their country," Lion's Club spokesperson John Zino of New Berlin

explained during Thursday's Olympic Games. The youth enjoyed dividing up into teams to compete in various track and field events, and afterwards enjoyed a swim at their own private lake - a refreshing way to end a hot day.

All of the kids involved in the program speak English, and have been spending six weeks out of their summer with a host family in Wisconsin. The group toured Madison and the state Capital during their stay, and were treated to a special dinner, hosted by the Lions. Some of the countries represented included Austria, the Czech Republic, Hungary, Finland, India, Israel, Peru, Taiwan, Bangladesh, Ireland, Japan, and Italy.

Lions Club members volunteered as adult chaperones for the Camp Vista retreat, and volunteers from various

colleges served as youth counselors. Activities throughout the week included swimming, sports, crafts, and a Saturday night dance, and gift exchange. They also picked names out of a hat, which served as their secret pal. "They had to keep it a secret all week, yet be nice to the person and make it a point to talk to them," John explained, "and on Saturday the names were revealed, and gifts were given to their secret pal." Before their departure, each participant had to give a speech about

their country.

The Lions Club is an international organization, with 1.46 million Lions clubs in the world. They are a non profit organization started by a group of Chicago Lawyers that were challenged by Helen Keller. One day she asked them to do something to help the blind, and they've been helping people ever since.

On Thursday, some of the Lions Club's district governors visited the camp (the state has ten districts), and

expressed their enthusiasm for the program, and also stressed that the club is always looking for host families. You do not have to be a Lion to host a youth for a summer.

Joining the Lions Club is by invitation only, and those interested in finding out more about the organization, or being a host family, should contact a local Lions Club member, or call their Chamber of Commerce to locate someone in their community.

TOWN OF WAYNE ORDINANCE NO. 2511

AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE TOWN OF WAYNE, WASHINGTON COUNTY, WISCONSIN.

THE TOWN BOARD OF THE TOWN OF WAYNE, WASHINGTON COUNTY, WISCONSIN, DOES ORDAIN AS FOLLOWS:

Section 1. That the Zoning Ordinance of the Town of Wayne, Washington County, Wisconsin, is amended as follows:

1. Section 1.27, CULVERT PERMIT is created as follows:
1. PERMIT REQUIRED. No person shall construct, install or replace any culvert without first obtaining a culvert permit from the Zoning Administrator or his designee approved by the Town Board. The applicant for a culvert permit shall file the application with the Zoning Administrator.
2. FEE; DEPOSIT. The fee for a culvert permit is \$50.00 and shall accompany the application. In addition, a security deposit of \$250.00 shall accompany the application.
3. SPECIFICATIONS:
(a) Size and Location. All culverts placed on, in or along the highways of the Town, either under private driveways leading from the public highways to private property or otherwise, shall be of sufficient size and constructed in such manner and of such materials as to provide means for the flow of water naturally accumulating or flowing along the ditches on such highways. Such culvert shall be of corrugated steel construction and be not less than 18 inches in diameter or of same volume capacity and shall be at least 24 feet (40 feet for property zoned commercial or industrial) in length (plus endwalls) to prevent injury to persons or property in the use of the highways and the entrance to and exits from the highways over and across such culverts. The Zoning Administrator or his designee shall determine the size and length of the culvert required. All culvert shall be installed on a gravel bed of at least 4 inches and be covered with sufficient gravel to prevent injury to the culvert. Any culvert hereafter installed in the Town shall have steel panels; concrete panels are prohibited. No concrete surface shall be allowed within the highway right-of-way.
(b) Existing Culverts. The Zoning Administrator or his designee may investigate, approve or disapprove the various existing culverts or other drain pipes placed in the highways in the Town. The Zoning Administrator or his designee may require steel end panels to be placed on existing culvert installations where he determines it to be in the best interest of the Town and the abutting property owners. The Zoning Administrator or his designee may also require the owner of an abutting property to remove, or cause to be removed or replaced with adequate facilities, any culverts or drain pipes which do not conform to the requirements as provided herein when, in his judgment, it is necessary to do so, either for the orderly construction, maintenance or repair of any such highway or in providing for a proper drainage system thereon.
4. CONSTRUCTION PROCEDURE. Upon receiving an application for a new or replacement culvert, the Zoning Administrator or his designee shall provide the owner with specific specifications and cause the project to be staked out within 7 days. After completion of the project (or if new construction, after occupancy permit has been issued), the owner shall request the Zoning Administrator or his designee to inspect it and, if the Zoning Administrator or his designee determines that the construction is in accordance with the specifications, the security deposit required under Section 1 above shall be returned. If not, the owner shall have 30 days to make the required corrections and, if not so made, the Zoning Administrator or his designee shall cause the same to be made and deduct the expense thereof from said security deposit and return the balance to the owner.

Section 2. The Plan Commission of the Town of Wayne recommended the adoption of this Ordinance.

Section 3. Pursuant to and in accordance with the Laws of the State of Wisconsin, the Town Board of Supervisors held a public hearing on this Ordinance on the 19th day of July, 1995.

Section 4. This Ordinance shall take effect upon posting and publishing as provided by law.

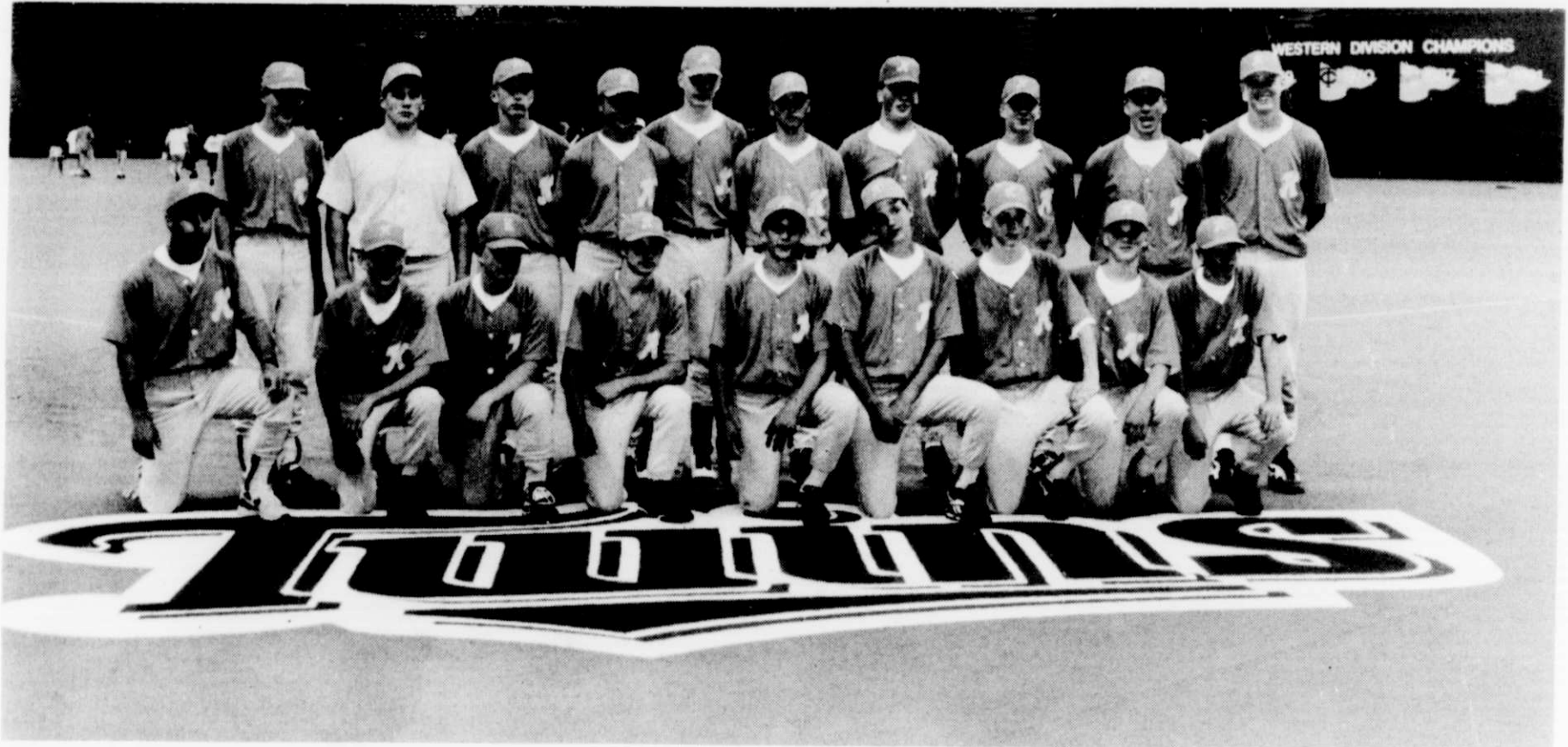
