## Shelfond Mobil Mart Reopens Following Extensive Remodeling



*Shelfond Mobil Mart has a new look inside and out, and is once again serving customers after a remodeling shutdown.*

Shelfond Mobil Mart closed on May 30 to begin remodeling and installation of new tanks and pumps. The project was scheduled to coincide with the Hwy. 45 resurfacing project and was

necessary to comply with EPA Clean Air Act standards. The remodeling included the installation of vapor recovery lines from the pumps to capture and burn any gasoline vapors instead

of releasing them into the atmosphere.

During the project contaminated soil was removed and taken to a state approved land fill site for treatment.

## Dr. Heather Resigns From School District

District Administrator, Dr. David Heather, submitted his resignation to school board president Neal Weare last Thursday.

The board had been aware of Dr. Heather's decision to leave the district, and knew it was just a matter of time before the announcement came. Heather has accepted the position of Superintendent of Schools in Sturgeon Bay, and will be officially resigning as of November 1, with his last official day with the district scheduled for October 25.

"I'll be sad to see him leave," stated Weare. "Over the past seven years he's accomplished quite a bit for the district, and we can see that now with the referendum and the completion of the building projects." Weare also indicated that Heather's job was two-fold, as he had also served as the school district's business manager, thereby saving the taxpayers the cost of paying another full time employee.

The board will act on his resignation at their Septem-

ber 11th meeting, and will be looking to name an interim administrator for this school year. "I'm not in a big hurry to just fill the position with another warm body," Weare pointed out. "This would be counterproductive to the district. We have a standard to maintain, and most positions are already filled."

He remarked that it would be beneficial if the board could locate a retired superintendent to fill the position, who could help them post the job and go through interviews, which would take place sometime in the spring of next year.

Dr. Heather and his family will reside in Kewaskum for the remainder of the school year, since his wife, Irene, teaches special education at KHS, and his son, Matt, will be completing his senior year. Heather said he plans to commute home on the week-ends.

"I've enjoyed the past seven years here, working with the parents, the teachers, and the children, to instill the values of a better education," Dr. Heather said on Monday.

smile, indicating she can roll with the punches. She is happy with all the new beginnings, and ready to start her new career in Kewaskum.

McKenna's other employees include his daughter, Bridget Zehren, receptionist, Patricia Peters, probate secretary, and Audrey McKenna, bookkeeper.

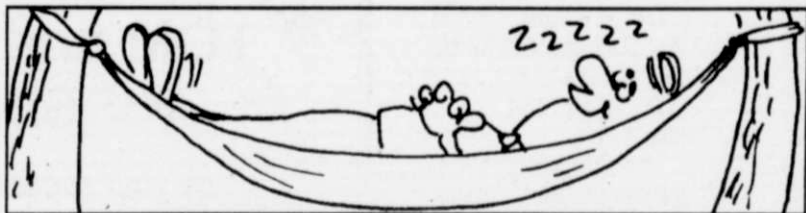

Clean soil was brought in and compacted before a new canopy was erected and pumps installed. New tanks were installed on the north end of the site after the old tanks were removed and disposed of.

The building was remodeled and brought up to ADA requirements. The building exterior, was given a modern new look with a maintenance free surface. The inside has a new shelving system that gives a more open feeling. Computerized cash registers and controls make purchases go faster and the new pay at the pump dispensers allow customers to pay with a credit card or ATM debit card (Tyme) without having to go inside.

The store reopened on Tuesday of last week Aug. 22, and will be open from 5:00 a.m. to midnight.

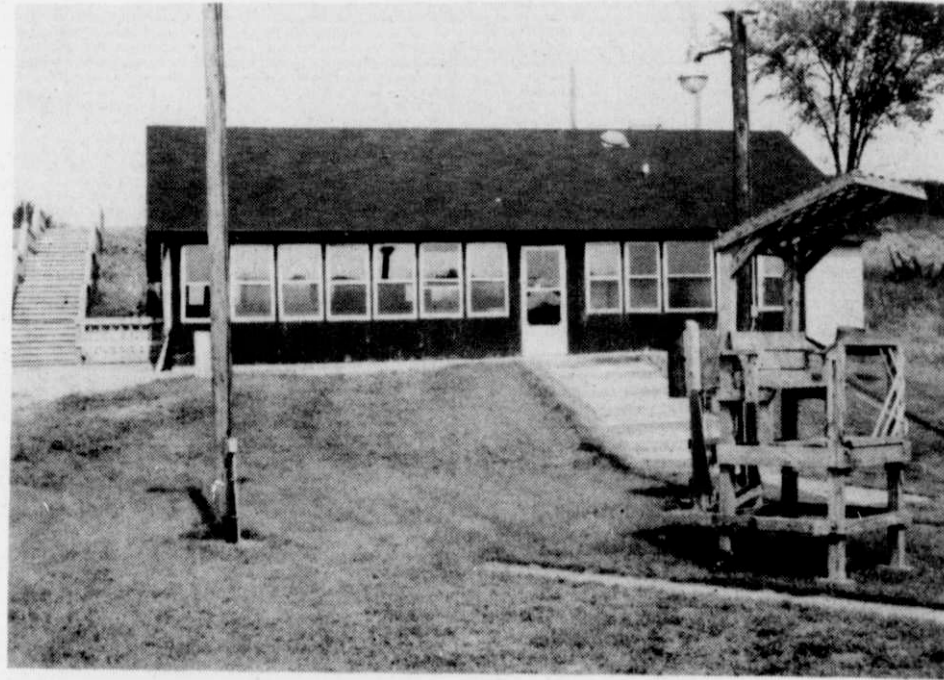

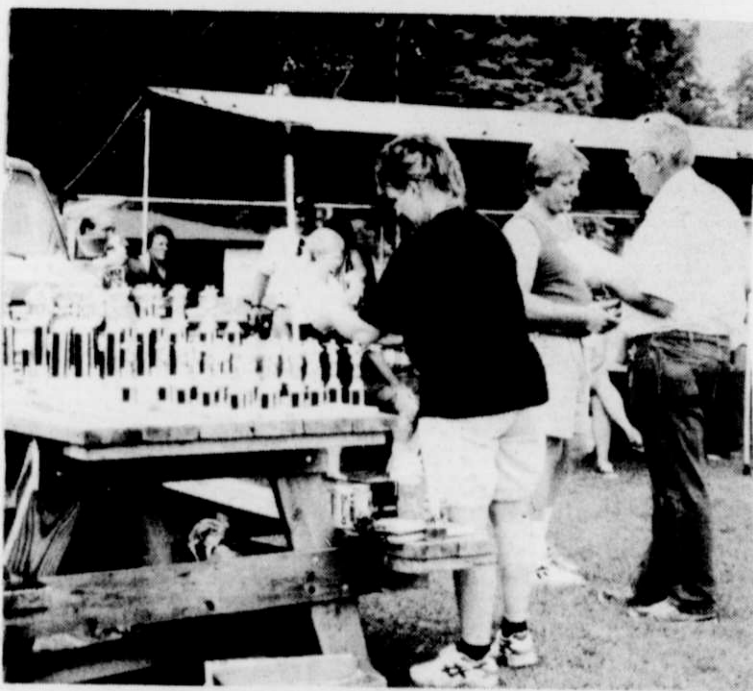
# New Fane Sportsman's Club Has Long History of Community Service

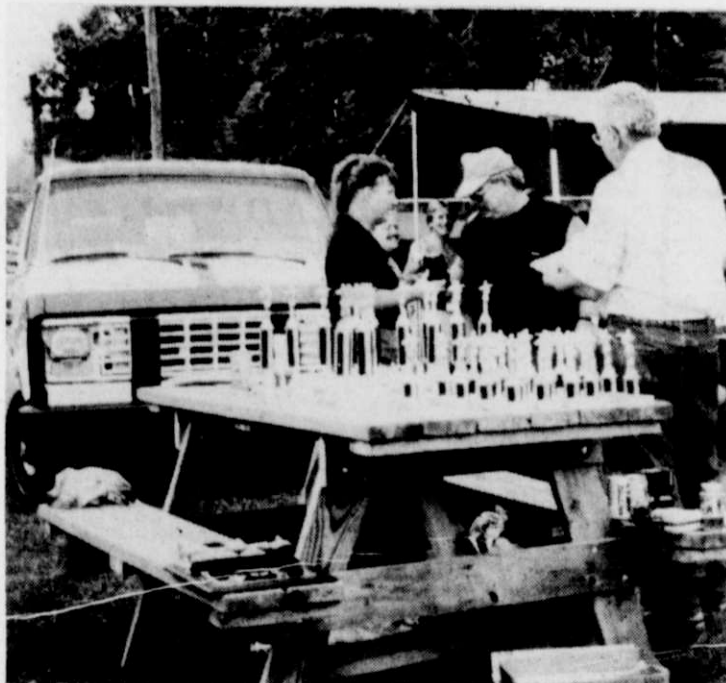

The New Fane Sportsman's Club, Inc., treated their trapshooters to a year end cookout at their awards banquet this past Saturday. The club has a long history of service to the community, and membership has climbed in

recent years, as gun enthusiasts gather there to hone their shooting skills with like-minded men and women.

The club is built on property that was at one time the Heberer family farm. Local resident Bill Heberer, founder of the New Fane Sportsman's Club, remem-

bers when his grandfather, William, worked the 117 acre parcel, until Bill's parents, John and Mildred, eventually took over the homestead. "As a matter of fact, I was born on that farm," Bill mentions.

In the early 60's, cousins Bill and Ira, who both worked second shift, spent a

great deal of their spare time hunting together. In order to improve their hunting skills, they bought a hand-thrower trap, and that's all it took to fire up some grander plans. "It just grew from that point," Heberer recalls. "In 1963, Ira and I started talking with other people about forming a

sportsman's club, and we got about 40 members together, made up of family, close friends, and neighbors." They incorporated that same year, and held their meetings at Larry and Irene's Tap in New Fane.

In the meantime, Bill had purchased 13 acres from his father, with plans to build a shooting range and clubhouse. The group held dances, and other fund-raisers to raise enough money to improve the land and put up a building. In 1965, they hired two carpenters and with the help of a lot of volunteers, put up an all block building with a flat roof. It served as their clubhouse through the decades, and it was just in the last few years that it was remodeled to better serve their growing membership.

Trap leagues were formed in the mid to late 60's, with only one trap to shoot clay birds, until a second trap, which is automatic and can hold up to 450 loaded birds.

"All through the years, we've kept improving the

grounds and the building," Bill remarks, and seven years ago the clubhouse was upgraded with a new roof and cathedral ceiling, as well as a 10 x 30 foot addition for storage. The rustic interior holds a large bar, seating area, enclosed porch, cooler, bathrooms, and a side room. Five years ago, Bill purchased an additional 17 acres from his father, and the club-grounds now totals 30 acres.

A few years ago, the Kewaskum Kiwanis Club began holding their annual Turkey Shoot at the New Fane Sportsman's Club, an event which always promises to draw large crowds. This year it will be held on Sept. 10th. Six years ago the Kiwanis donated materials to put up a new garage, which members of the club erected south east of the main building. During the Turkey Shoot, the Sportsman's Club sponsors a gun raffle, and turns all proceeds over to the Kiwanis. It's a great example of club's working together to benefit the entire community.

Today the New Fane Sportsman's Club has 188 members, and 22 teams in their trap league. They run spring, summer and fall leagues, from April through November, with open shooting every Friday night, and also sponsor a traveling league, which shoots on Tuesday nights. The club is always open to new members, and recently, more women have become involved in the sport of trap shooting. A 100 yard rifle range is used for target practice, and for siting in their high powered equipment. The only fund-raiser they annually hold is their Wild Game Feed, which was started about seven years ago. Held at the Amerahn in Kewaskum, the dinner draws over 400 people each year, and the funds raised are donated to a variety of organizations. The club supports Wings Over Wisconsin, The Rocky Mountain Elk Foundation, DARE, the Kewaskum Library, the Wild Turkey Federation, Fond du Lac County 4-H, AWARE (hunting educational programs), and the Kiwanis, just to name a few.

Officers are elected once a year, and this year, members serving in an office include: Charlie Walls, President; Jim Hodge, Vice President; Randy Delcore, Secretary, and Steve Volm, Treasurer. They also have a four man board of directors.

In the future, they hope to set up some shooting sports activities for the youth in the area, as they continue to grow as a club, and promote the idea that shooting is a form of recreation that a family can enjoy doing together.

Administrator Daniel S. Schmidt reviewed the proposed 1996 budget of the Municipal Court. It was noted that the budget had a substantial increase which was caused by the Village of Grafton and City of Port Washington joining the system. The Village of Kewaskum's share of the expenses are projected to decrease by 1% and the revenues as projected are anticipated to increase by \$892.00.

Chairman of the Protection and Public Safety Committee, Trustee John Borland reviewed the results of the committee

meeting held earlier in the evening. The committee recommended leaving Bilgo Lane alone and to place no parking restrictions on the north side of Third Street from Bilgo to Parkview during school hours (est. 7:00 a.m. to 4:00 p.m.). 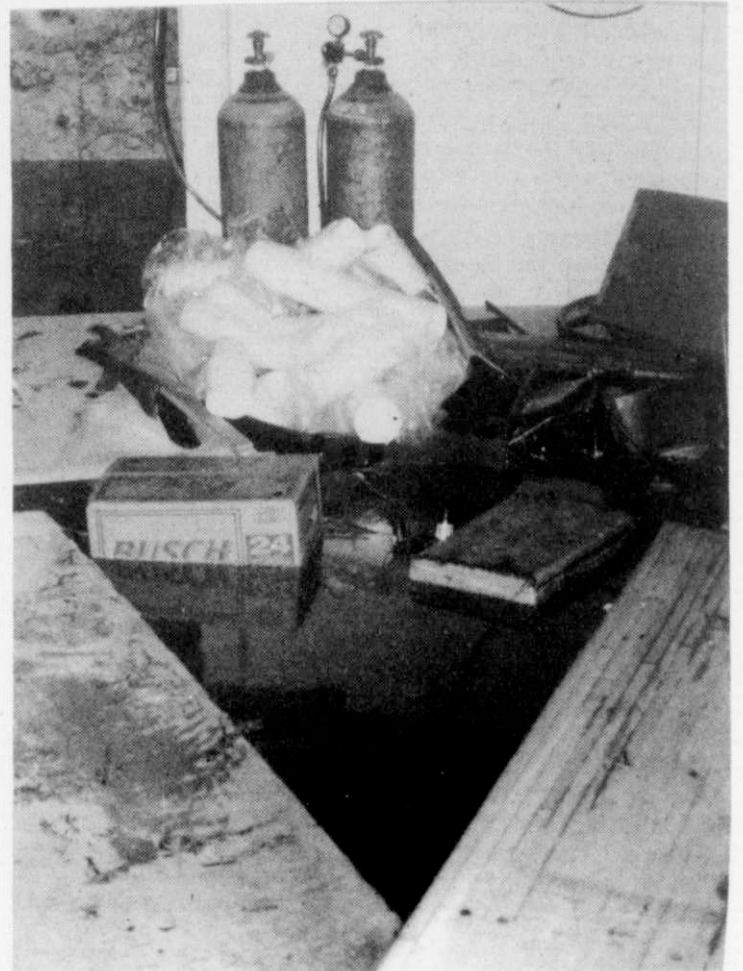

## State Patrol Urges Motorists to Slow Down Labor Day Motorists Face Few Construction Zone Delays

As motorists enjoy the last three-day weekend of the summer, they'll find most of their journey free of orange barrels. Wisconsin Department of Transportation Secretary Charles H. Thompson says that work in construction zones is expected to cease as of around noon on Friday, September 1. It won't resume until 6 a.m. on Tuesday, September 5.

"We want motorists in Wisconsin to have a safe holiday weekend," said Secretary Thompson. "The best way they can do that is by obeying the speed limit, anticipating construction zones, and keeping cool when traffic builds up."

Secretary Thompson noted that while there won't be any actual construction going on during the three-day Labor Day weekend, several construction zones will remain in place. On the Interstate, motorists can expect a few places where traffic will likely be slowed due to construction. The most congestion is expected on I-94 just north of Tomah, where traffic will be narrowed to one lane in each direction on the same side of the median. During the July 4th holiday weekend, lengthy delays developed there as traffic tried to funnel through the construction zone. Motorists can use US 12, which parallels the Interstate, to bypass the construction zone.

Secretary Thompson urged motorists to slow down and be alert when they approach -- and drive through -- construction zones. "Construction zones generally have narrow lanes and shoulders, uneven pavements, and slower-moving traffic," he said. "Patience,

moderate speed, and good separation between vehicles will keep traffic flowing smoothly not only through construction zones, but on all state roads this holiday weekend. And remember, fines are double for violations in construction zones."

Wisconsin State Patrol Administrator William Singletary said that throughout the summer, his troopers have been noticing an increase in the speeds at which vehicles are traveling. "Our troopers have had to respond to a number of crashes in which motorists, because of their speed, have drifted off the roadway onto the shoulder, where they over-corrected, lost control, and crashed. Some of the victims did not survive." He urged motorists to avoid excessive speed, to buckle up, and to refrain from drinking and driving, adding that motorists who are suspected of drinking and driving will lose their license on the spot.

"Every available trooper will be on duty during the Labor Day weekend's peak travel times to assist stranded motorists, enforce traffic laws, and respond to emergencies," Singletary said. Peak travel times are expected to be between noon and 8 p.m. on Friday, September 1, and again between noon and 8 p.m. on Monday, September 5.

Last year, ten people lost their lives in Labor Day weekend accidents.

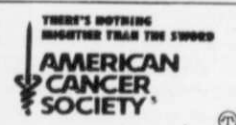

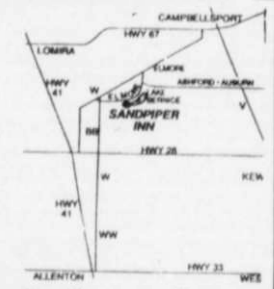

**ORDINANCE NO. 95-8**

**An Ordinance Amending Sec. 13.21 (1) & (4) and Sec. 13.39 (8) & (11)(a) of the Municipal Code of the Village of Kewaskum, Washington County, Wisconsin. (Municipal Court)**

The Village Board of the Village of Kewaskum, Washington County, Wisconsin do ORDAIN that Section 13.21 (1) & (4) and 13.39 (8) & (11)(a) of the Municipal Code of Kewaskum, Wisconsin is hereby amended to read as follows:

**13.21 DELINQUENT WATER BILLS.** (1) Quarterly water bills due and not paid within 20 days of issuance, a late payment charge of 1 1/2 percent per month will be added to the bills per PSC Rate File Mg-1. This late payment charge will be applicable to all customers. The utility customer **may** be given written notice that the bill is overdue no sooner than 20 days after the bill is issued. Unless payment or satisfactory arrangement for payment is made with the Treasurer within the next eight days, service **may** be disconnected pursuant to Public Service Commission, Rule 185.37 Wis. Adm. Code.

(4) On October 15 in each year notice shall be given to the owner or occupant of all lots or parcels of real estate to which water has been furnished prior to October 1 by the water utility operated by the Village and payment for which is owing and in arrears at the time of giving notice. The department in charge of the utility shall furnish the treasurer with a list of all such lots or parcels of real estate, and the notice shall be given by the treasurer. Such notice shall be in writing and shall state the amount of such arrears, including any penalty assessed pursuant to the rules of such utility and PSC Rate File Mg-1; that unless the same is paid by November 1 thereafter a penalty of 10 percent of the amount of such arrears will be added thereto; and that unless such arrears, with any such penalty, shall be paid by November 15 thereafter, the same will be levied as a tax against the lot or parcel of real estate to which water was furnished and for which payment is delinquent as above specified. Such notice **may** be served by delivery to either such owner or occupant personally, or by letter addressed to such owner or occupant at the post office address of such lot or parcel of real estate. On November 16 the department issuing the notice shall certify and file with the clerk a list of all lots or parcels of real estate, giving the legal description thereof, and the owner or occupants of which notice of arrears in payment were given as above specified and which arrears still remain unpaid, and stating the amount of such arrears together with added penalty thereon as herein provided. Each such delinquent amount, including such penalty, shall thereon become a lien upon the lot or parcel of real estate.

**13.39 ANNUAL BUDGET AND METHOD OF PAYMENT OF CHARGES.**

(8) SEWER SERVICE CHARGES. Sewer service charges shall be billed quarterly and shall be payable at the Village Treasurer's office or at any officially designated location. Statements for such charges and assessments levied and assessed in accordance with this section shall be due and payable within 20 days from and after the billing date. Quarterly sewer bills due and not paid within 20 days of issuance, a late payment charge of 1 percent per month will be added to the bills. This late payment charge will be applicable to all customers. (NOTE: The afore mentioned charge of 1 percent per month will first take effect upon the 3 quarter billing for 1995. The billings of the 4 quarter of 1994 and the 1 and 2 quarters of 1995 will be charged at 12% per quarter.) The utility owner or customer **may** be given written notice that the bill is overdue not sooner than 20 days after the bill is issued. Unless payment or satisfactory arrangement for payment is made within the next eight days, service **may** be disconnected pursuant to Wis. Stats.

(11) DELINQUENT ACCOUNTS. Pursuant to the authority granted under ss. 66.60(16)(a) and 66.069(1), Wis. Stats., the following procedure shall apply to collection of delinquent accounts for sewer service:

(a) **Notice of Payment Due.** On October 15 in each year notice shall be given to the owner or occupant of all lots or parcels of real estate to which sewer has been furnished prior to October 1 by the sewer utility operated by the Village and payment for which is owing and in arrears at the time of giving notice. The department in charge of the utility shall furnish the treasurer with a list of all such lots or parcels of real estate, and the notice shall be given by the treasurer. Such notice shall be in writing and shall state the amount of such arrears, including any penalty assessed pursuant to the rules of such utility; that unless the same is paid by November 1 thereafter a penalty of 10 percent of the amount of such arrears will be added thereto; and that unless such arrears, with any such penalty, shall be paid by November 15 thereafter, the same will be levied as a tax against the lot or parcel of real estate to which sewer was furnished and for which payment is delinquent as above specified. Such notice **may** be served by delivery to either such owner or occupant personally, or by letter addressed to such owner or occupant at the post office address of the owner or occupant of such lot or parcel of real estate. On November 16 the department issuing the notice shall certify and file with the clerk a list of all lots or parcels of real estate, giving the legal description thereof, to the owner or occupants of which notice of arrears in payment were given as above specified and which arrears still remain unpaid, and stating the amount of such arrears together with added penalty thereon as herein provided. Each such delinquent amount, including such penalty, shall thereon become a lien upon the lot or parcel of real estate.

This Ordinance shall take effect upon passage and publication as provided by law.

The Director of Public Works shall approve the location of such cluster mailbox before the permit shall be issued. The term "cluster mailbox" shall not be construed to mean "a cluster of mailboxes." If the permit is for other than a formal cluster mailbox unit(s) a detail drawing reflecting size, type of construction and location need to be submitted for Village Board approval, as well as any other information requested by the Village Board. No individual mailboxes shall be allowed in the Village. The existing individual mailboxes need to be maintained in a pleasing and safe manner adjacent to the specific address served by such mailbox. Only "cluster mailboxes" or approved alternatives shall be allowed in the Village.

(1) Cluster Mailbox Permit Fee. The fee for a permit for locating a cluster mailbox shall be \$10.00 payable in advance of permit being issued.

This ordinance shall take effect upon passage and publication as provided by law.

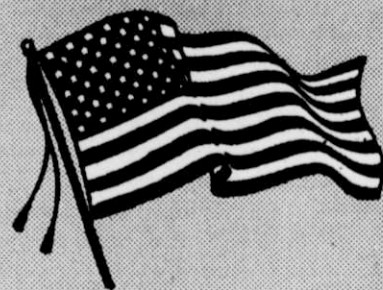

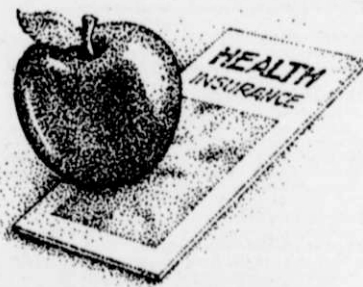

day. Trustee William Kulas brought up for discussion a telephone call he received from an area businessman, Mr. Robert Schmitt, who was in attendance. Mr. Schmitt had concerns regarding the parking of his delivery trucks in front of his establishment since the completion of Fond du Lac Avenue (USH 45). The Chief of Police Richard Knoebel indicated that his department was trying to work with the businesses as to the unloading matter and that everyone basically has been cooperating with one exception

and unloading just south of Prime Time. Mr. Schmitt indicated the 150 feet was too far for his delivery people to go and that he did not want the delivery trucks to turn around on his parking lot to the rear of his establishment. He also felt that it was no big deal to close down the south bound through lane of traffic on USH 45 for an hour and one half both in the morning and afternoon. Chief Richard Knoebel advised the Board of Wis. Stats. 346.52; Stopping prohibited in certain specified places. (1) No person shall stop or leave standing any vehicle, whether attended or unattended and whether temporarily or otherwise, in any of the following places: (a) Within an intersection. It was noted the Board

could not do anything, but adhere to state law. It was also noted that they acknowledged Mr. Schmitt's problem but hope that he could work with his delivery people as well as his neighbors to resolve and minimize the problems.

Administrator Daniel S. Schmidt reviewed with the Board Ordinance No. 95-8 an ordinance amending the "Municipal Utilities" section of the code to bring them into agreement with Wis. Stats. and the Public Service Commission Rulings and Villages Rate File. The matter will come up for action on August 21, 1995.

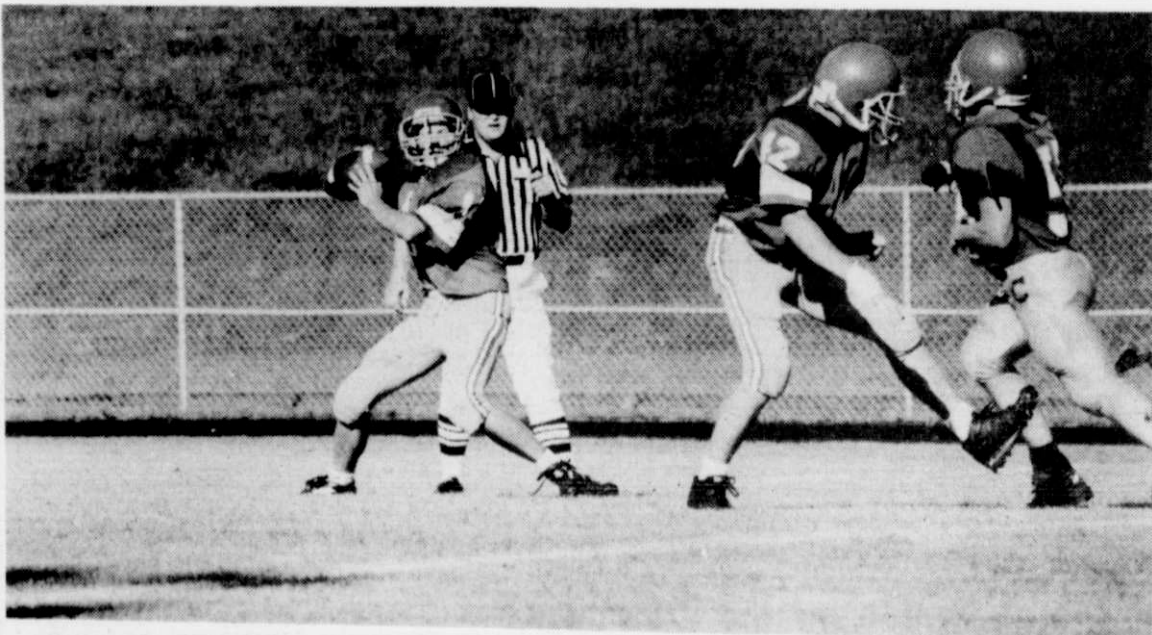

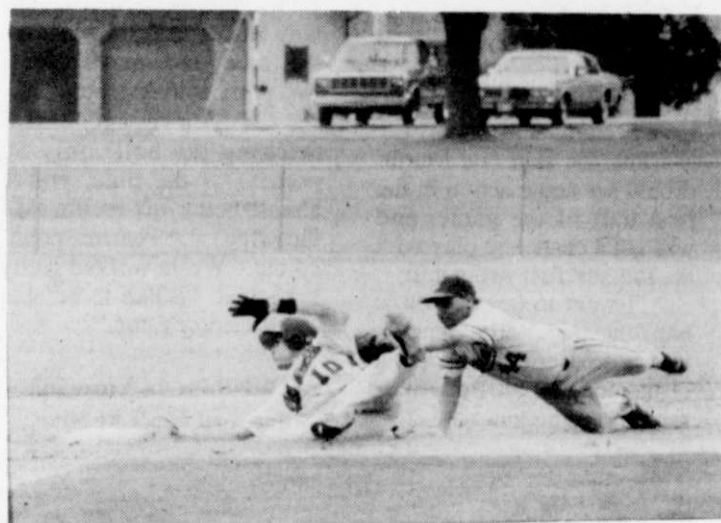

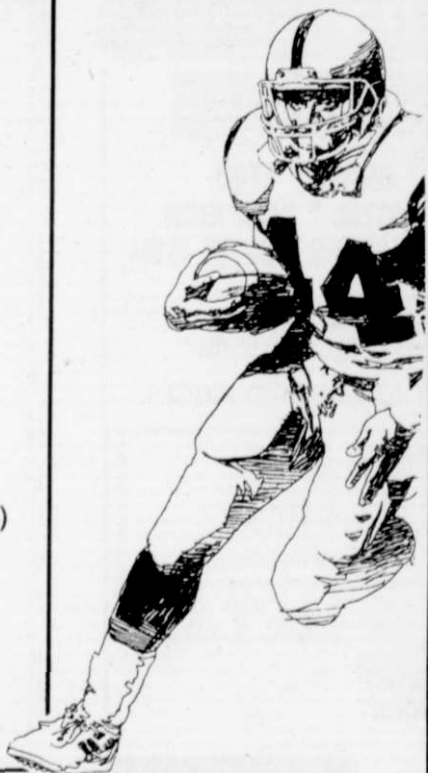

# Indians Beat Cougars, 10-7 Kicking Game a Key

CAMPBELLSPORT - For those fans looking to see a lot of scoring, it may not be a wise idea to take in a Kewaskum High School football game this fall. Staying home and watching a Milwaukee Brewers contest may result in more points being scored.

But those football purists that enjoy some tough defense, and a ground-it-out offense, the Indians may be just what you've been looking for.

At least that held true here, last Friday night, as the Indians didn't play their best, yet still came away with a thrilling 10-7 victory over rival Campbellsport in the season opener for both squads.

It was the third straight year that the Indians have downed their old foes from the west. The victory gave KHS coach Clark Pearson good reason to smile, but he knows that his team is capable of much better performances.

"It was a real good football game, very exciting," Pearson said. "But we need to get better in all phases of the game. The whole team needs to improve."

The game did see the Indians improve dramatically in one area, the kicking game. Senior Luke Chesak's 30-yard field goal midway through the second quarter turned out to be the game-winner for KHS, which has failed in past attempts to establish a consistent kicking game.

"We've worked at it pretty hard," Pearson said.

Defensively, the Indians continued to shine, following a trend that has seen dramatic improvement in that area in recent years. Capping off a fine defensive effort was Ryan Herman's interception deep in KHS territory with less than a minute to play.

Campbellsport had driven the ball to the Indian 15-yard-line, but a Seamus McCready pass was picked off by Herman near the end zone. Herman headed the other way 97 yards before McCready caught up with him just before the goalline.

"That was real big," Pearson said of Herman's pick, which nearly resulted in a KHS score. "The quarterback had the angle on him, and tackled him. It was a good effort on (Mc-Cready's) part."

McCready had hooked up with Dave Bothe on a 25-yard touchdown pass on the Cougars' first possession of the game. The extra point gave the hosts a 7-0 lead, but that advantage was short-lived.

"It was a perfectly thrown ball," Pearson said of the Cougar scoring strike. "He (Bothe) got a step on our defensive back, and the ball was right there in the corner."

The Indians came right back and marched 70 yards in 19 plays, a drive culminating in quarterback Brian Butschlick's one-yard sneak into the end zone. Chesak's extra point promptly tied the game at 7-all.

"Our longest play on the drive was 12 yards," Pearson pointed out, noting running back Aaron Kurth scampered for a pair of 12-yard gains on the drive. Kurth, however, only finished with 33 yards in his eight carries.

Campbellsport fumbled on its next series at its own 19-yard-line, Pearson noted. The Indians couldn't muster a first down on their ensuing possession, however, and settled for Chesak's 30-yard boot, giving them a 10-7 lead.

The Cougars threatened again before halftime, but the KHS defense stiffened inside their own 20, forcing Campbellsport to turn the ball over on downs.

In the second half, the Indians drove to the Campbellsport 18-yard-line, but eventually turned the ball over when one of Butschlick's passes was picked off.

The teams traded several possessions with neither mounting a serious scoring threat. That changed in the fourth quarter, however, as the Cougars gave a last chance effort to either send the game into overtime, or pull out the victory.

But Herman snatched away any Cougar hopes with his interception, and ensured the Indians on starting off a promising campaign with a win.

"We had a solid defensive effort," Pearson said, singling out Herman and defensive end Matt Wiedmeyer. "He played an excellent game. He was in on a lot of tackles," noting Wiedmeyer led the team in defensive points.

Offensively, Pearson

cited guard Shawn Parrish and tackle Jason Schmidt. "I thought that they blocked very well," Pearson said of the pair.

Tim Gundrum, a 220-pound fullback, led the Indians with 43 yards on 11 carries. "He ran real hard," Pearson said.

Offensively, the KHS coach plans to get junior Kevin Martin some action at the quarterback spot. Martin, an exceptional athlete, missed about a week of practice early on after he injured himself in a swimming accident.

"He's pretty lucky," Pearson said, noting he was told that Martin jammed his neck after entering a pool. "He's okay now, but it could have been much worse."

Pearson said that Martin should see some action in the first half of the game, and will get a chance to play with the Indians' first string unit.

"I want to take a look at him," he said, noting that the injury prevented him from challenging Brian Butschlick for the starting job.

Campbellsport last Friday night. An extra point and a 30-yard field goal by the KHS kicker proved to be the difference in the contest.

"Our kicking game won us the ballgame," Pearson said, trying to remember the last time he was able to utter those words. "That's a real nice feeling."

"He has a real good leg, real strong," Pearson said of Chesak's attributes. "He is very capable, now it's just a matter of getting him the experience and the confidence."

Pearson appears to have a great deal of confidence in Chesak's skills, noting that he wouldn't have qualms using Chesak for as long as a 45-yard field goal try.

"He could probably kick it up to about 45 yards," Pearson said. His leg is that strong."

A strong leg doesn't ensure kicking success, however, and Pearson is fully aware of that fact.

"You have to have a good snap, and a reliable holder, too," Pearson said, noting center Nathan Scheel and defensive back/holder Jim Westerman are showing signs of completing that trio.

But Chesak has to remain consistent in future games, otherwise the Indians may resort to trying to gain the three yards needed for a two-point conversion.

"If you're successful (kicking the ball) only 50 percent of the time, you're almost better off running (or throwing) it," Pearson pointed out. "We've worked pretty hard at it. I'd like to be able to kick every game."
