Mediator to Attempt to Resolve Dog Complaint

James Korth, representing Hon-E-Kor Country Club and Attorney Edward Ritger and Helen Sramek, representing residents of Maple Dale Manor were before the Town of Kewaskum board at their October meeting when the board would decide whether to continue or revoke a dog kennel permit issued in 1979 to Hon-E-Kor Country Club or the operator of Hon-E-Kor.

The matter was brought before the board for review because of alleged continuous barking of the dogs in the kennel which is disturbing and annoying to many residents at Maple Dale Manor particularly during the evening and early morning hours. The barking has been a problem since 1993 when the Kewaskum Police Department responded to a

noise complaint. However, it has just recently been under review by the town board since August when the problem was brought to their attention.

The issued permit states the party who holds the permit must have ownership of the dogs and that up to eight dogs are allowed at the kennel. Prior to the construction of Maple Dale Manor Resident Home there were very few, if any, filed complaints regarding the kennel, the dogs or their barking.

Attorney Ritger contends that Randall Dreher of Kewaskum, rather than Korth or Hon-E-Kor is the owner of the dogs and that more than eight dogs have been seen in the kennel which would be a direct violation of the kennel permit and reason to revoke the permit. Korth explained that the dogs are mutually

Lt. Governor Urges Benson to Grant Kewaskum Waiver

Lieutenant Governor Scott McCallum said last Wednesday, October 25, he fully supports the Kewaskum School Board in its attempts to name an Interim Superintendent.

The board has chosen Charles Johnson, although he lacks state certification or licensure as an administrator. According to the Kewaskum School Board he has the leadership skills and experience it is looking for in selecting a district leader.

In a letter of support to State School Superintendent John Benson, who has the authority to grant a waiver on the certification requirement, McCallum said the success of education is helped immensely by local control -- decision making by parents, communities and the schools, not the state.

In an attempt to encourage more local decision making, McCallum proposed and continues to support the waiver process for administrators, business managers and principals.

This allows a school board to ask the state superintendent to waive licensure or certification requirements.

"In reaching this stage of the waiver and candidate selection process, the Kewaskum School Board has given a great deal of time and thought into the qualifications of Mr. Johnson," McCallum wrote to Benson. "By approving this request I believe you can send the message that we trust the ability of local communities to provide the best education possible for their children."

"I ask that you give the Kewaskum School Board the flexibility to hire the individual they feel is most qualified to serve as district administrator. We gave the Milwaukee School Board this opportunity when it hired Dr. Howard Fuller, and the evidence shows the needs of its students were well served. I think Kewaskum and every other community in the state deserves the same opportunity," said McCallum.

TO RESIDENTS OF THE KEWASKUM SCHOOL DISTRICT,

At the Public Hearing on Monday evening, October 23, 1995, the Kewaskum Board of Education voted 4-3 to proceed with requesting a waiver of certification requirements for a new superintendent. Board President Neal Weare cast the tiebreaking vote. Public comments were overwhelmingly against this course of action.

There was a comment by a Board member late in the meeting that the audience was all teachers and did not represent the district. I would like to clarify this comment as I had counted the number

of people in attendance at one point during the meeting and counted over 180 residents, students, teachers, parents. Following this comment, it was determined that no more than 45 of those in attendance were district employees -- teachers and support staff -- and many of them are residents, parents, and taxpayers in the district as well. A very small number of these staff made comments in the three hour hearing.

With their 4-3 vote, the School Board completely disregarded the comments from the residents, taxpayers, parents and others who strongly feel this is not a good decision for the education of our children.

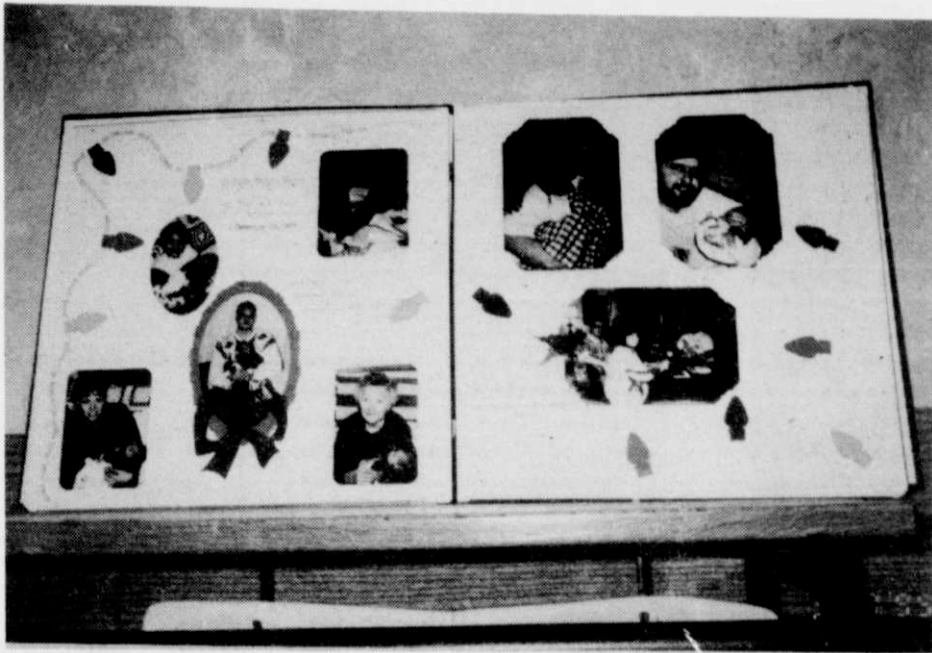

owned by himself and Dreher and that the times when there may have been more than eight dogs in the kennel was when puppies were born and were too young to remove.

Korth further explained that there have been efforts made to quiet the dogs by using bark collars and shielding the kennel to the north and west so the dogs have no visual contact of people walking through River Hill Park which might entice them to bark.

Town Supervisor Dave Dorn added he had made an unscheduled visit to the kennel and found everything in order, the pens clean, eight pens for eight dogs, feeding is done inside in attempt to reduce barking, viewed the shielding as Korth explained and found the fencing to be adequate to contain the dogs.

In view of all information presented, both parties agreed to try and resolve the problem with Gordon Hoffman, town zoning administrator, acting as mediator.

Diane Horlamus, executive director from the Washington County Humane Society made a brief presentation urging the board to consider adopting an ordinance to regulate wolf hybrids that are beginning to appear in Washington County. The wolf-dog cross are instinctive hunters and potentially dangerous - prone to attack. A sudden movement or high-pitched sound can trigger the animal's predator response. A sample ordinance from another municipality will be reviewed by the town attorney and taken into

consideration.

A conditional use permit was approved for Robert and Brenda Kirchner to operate a home industry gift business from their home on Badger Road. Kirchner's business will consist of decorations done with balloons and some flowers.

Acting on the recommendation of the Plan Commission, the board approved the modified proposed plan presented by Excel Engineering for the Shagbark Hickory Estates Subdivision to be located on Hickory Drive. The preliminary land division was approved at a previous meeting before the town's building moratorium went into effect thus road construction can begin and

lots sold.

Robert and Michael Grota from Grota Appraisals have been contracted as the town assessor for one year. The company replaces Raymond Weinhold who retired earlier this year.

And finally, Board Chairman George Allmann, announced the 1995 tax rate for the town will be no higher than the 1994 rate which was \$2.99 per thousand.

A Land Planning meeting is scheduled for Monday, November 13, 1995 at 7:00 p.m. with the next Town of Kewaskum board meeting set for Monday, November 20, 1995 at 7:30 p.m. Both will be held at the town hall.

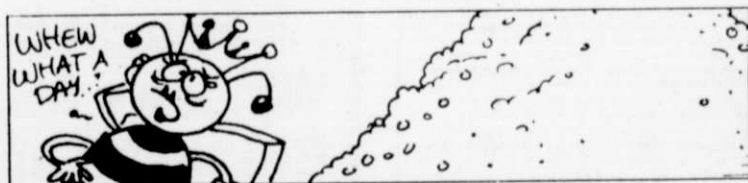

A professional is a professional because of their education, qualifications and abilities. Professions are professions because of what standards are required and maintained. Professionals are required to get specialized training. Certification is a part of the BIG "qualification" picture. "On the job" experience and continuing education are a must. Certification alone does not qualify a candidate for a top administrative position. A school district administrator can be hired with a certificate, and maybe even a waiver of that certificate. But this is a minimum requirement. Shouldn't we be searching for a candidate who has more than the minimum? Does military experience justify education experience. Shouldn't we be searching for a candidate who has a background in public education? There is an enormous amount of information that will be asked of a district administrator. Who will answer those questions while a candidate who is unfamiliar with the operations of a K-12 district needs to first figure out what the teachers and the community members are asking of him? Standards are established to promote excellence and success. If standards don't count where the futures of all of our children are at stake and thousands of our tax dollars are used, where do they count? It is not only the lack Mr. Johnson's teaching experience that causes me to ask the board to re-think their decision of October 23, but it is the fact that he does not have the background or experience in working with a public school system, young children, special needs children, apprentice programs, school standards and Goals 2000, to name a few. Let's set our standards high! We must join as a community and let the school board know that we will not accept minimum standards.

Who did attend the public hearing? Was it only teachers? And what if it was?

Listening to the conversation regarding the public hearing that was held on Monday, October 23, 1995, it has become obvious that a few facts have been twisted. In addition to the facts being twisted, it seems that the personal editorials being offered at the local lunch counters are being offered in an attempt to sway the public away from the fact that four members of the Kewaskum School Board ignored the public opinion that evening. If stories get twisted enough, maybe there will be a few

The final fact I will address, "it was all teachers that approached Mr. Weare after the public hearing and asked him to resign," can again be corrected with, four community members, none of whom is a Kewaskum district teacher, approached Mr. Weare to call for his resignation. (which was a suggestion made by him during the meeting) In fact, when wanting to further explain why we were calling for his resignation, Mr. Weare commented, "you don't need to say another word, you've got it (my resignation)." I understand that his resignation has not yet been submitted.????? We as community members with children being served by this school system, need to support the board members who show, through their vote, that they listen to those who cared enough to share their views at a public hearing.

I am as eager as anyone to find a candidate that will have the answers for the Kewaskum School District. I would like for our district to be a leader in school reform. During the public hearing on October 23, Board President Neal Weare offered to resign and there are many reasons why this would be very good for this district.

1) The Board of Education no longer listens to the voice of the people as evidenced by the 4-3 vote at the public hearing on October 23 and proceeding with a waiver for an uncertified superintendent. This vote followed numerous comments from the audience that did not favor this course of action. Only four comments, two of which came from spouses of majority (4 votes) Board members, favored this action.

2) Why is the Board allowing Kewaskum to be used as a 'test case' for the new waiver law in WI. We need a superintendent familiar with education today as well as budgeting, personnel, school law and more. It's not a simple question of two years teaching experience. The entire selection process and limited verification of credentials leave many unanswered questions.

3) There is a high level of uncertainty and concern as to where the Board will take this district next on their 'hidden' agenda. 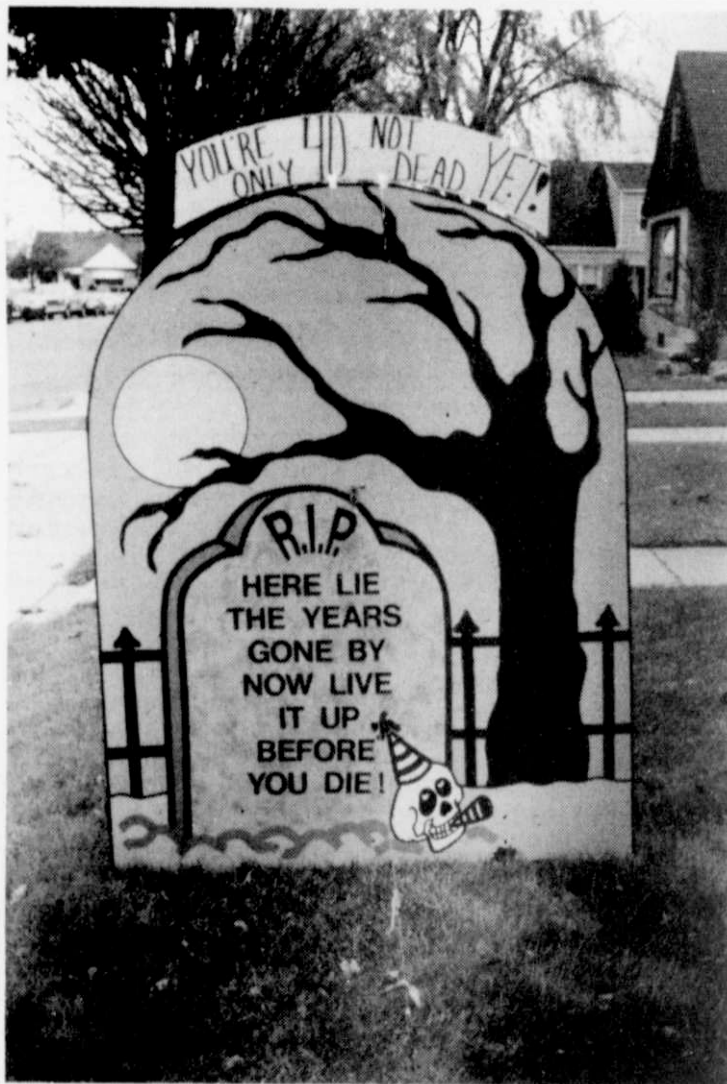

A Message from Bonnie

Hello Kewaskum Statesman readers!! Yep--it is REALLY ME and FINALLY able to sit down and convey my thoughts and feelings to all of you and let you know how I am doing!! FIRST of all, words cannot truly express the thankfulness I have for so many of you that remembered me (and still do) with cards, flowers and telephone calls!! As I have told so many--the prayers, love and support of my family and friends has really assisted in giving me the terrific attitude I can have in the midst of this illness!!

The illness has given me a TOTALLY different outlook on just about everything. Please let me tell you about it: I've ALWAYS been a healthy person--in the hospital for the normal things--have your tonsils out and have a baby. My doctor saw so little of me that he hardly knew me. THEN--THIS happened!! How did it start? Well, late in May I was having backaches at work. I blamed it on physical work and even the shoes that I was wearing but it did not get any better--got steadily worse!! I finally went to the doctor and he diagnosed it as Pancreatitis and immediately hospitalized me putting me on "IV's and ice chips." About a week later, I was out--somewhat feeling better but little did I know that a week later, I would be back in the hospital for another week--same thing!! Got out AGAIN and this time, was set up to go to Milwaukee to get what was called an ERCP done. This is NOT a fun procedure and you are not "totally out" for it. Some blockage

was discovered in one of the ducts of my digestive system and a so-called "stint" was placed in to alleviate and correct the situation. I went back home, back to work and felt that it was over and corrected. That was FAR FROM THE REALITY!! With-in a very short time, I was having problems every night after supper. Somewhere along the line, I was put on a low-fat diet and was adhering to that STRICTLY but to NO avail. So many people have questioned me about--"what type of sickness did you have?" "weren't you able to keep food down?" Well, I was eating all the right foods and keeping all the food down but I was getting a "come out of nowhere pain that pierced my stomach" and the so-called attacks lasted 30-45 minutes long!! I called the doctor and guess what? Back to St. Luke's for yet another ERCP!!

It was the second time back to St. Luke's that my family and I found out that the pancreatic duct was NOT gone into the first time (and this is where the blood work pointed to where the problem was). We were pretty upset and discouraged but it was time to see what had to be done and find out what the problem truly was!! It was a tumor in the pancreas about the size of a grapefruit!! It NEVER showed up on ANY of the tests that were done and believe me--I "had em all." They say that it was "kind of hidden" but really made no difference--they did not find it for TWO MONTHS and to say the least--I was a bit discouraged!! TIME TO LOOK

AHEAD AND BE POSITIVE!!

A surgeon came in to see my family and I. He explained a surgery called the WHIPPLE but spoke of the seriousness of the operation and possible side effects. He was very honest in telling us that there was a possibility that the WHIPPLE could not be done. They would make a small incision near my belly button and go in with a camera. If there was cancer and it had spread, they would not operate. If it looked okay, they would go ahead with the WHIPPLE. He told my parents that they would know if he could not operate--"If I come out after only one hour in the operation room." I asked how I would know and he told me--"If you wake up and you are NOT in ICU, then, we did not and could not operate." What a last thing to think of before being put out for surgery huh? Oh well, got to think positive on this one!!

HOORAY, after an 8 hour surgery, I woke up in ICU and at least that part would be positive. I did remarkably well but then did get pneumonia and there was a slight set back. I did get out of the hospital 15 days after the surgery and started my recuperation period. That is about a month and half ago and I do feel 100% better but tire so very easily. My doctor says that it is normal but I am not used to that at all as I was always "on the run."

My lifestyle has changed and I look at life in a completely new perspective that is for sure!! Liked to be back in Kewaskum with each and everyone of you right now

but know I have to be patient, listen to the doctor and in "good time," I will once again return to Kewaskum as YOUR Postmaster. I started "chemo" and radiation treatments recently and they are taking a "toll on me." I tire very easily afterwards and just do not feel like my old self--that is for sure!! My treatments are expected to last until shortly before Christmas so -- HOPEFULLY, I can POSSIBLY plan on being back with you all sometime in January.

ONCE AGAIN, from the bottom of my heart; I want to thank each and everyone of you for your cards, flowers, telephone calls--that type of support is about the best medicine in the world and KEEPS ME GOING!!

Never in my life did I think that I would be going

through something like this but--just goes to prove--one never knows. I used to drive past the new Cancer center in Fondy and think--"what a nice building--I'll never have to use it"--Yea Right!!

In closing, be assured that I HAVE a VERY POSITIVE attitude!! I look back to all the things that I have accomplished in my life and think AHEAD of all I STILL will accomplish in the years ahead. RECYCLING TODAY In the Village of Kewaskum

The Village of Kewaskum employs the Hechimovich Company of Mayville to do the recycling collection program in the village.

Recently village officials have visited the recycling operations in Mayville. Dan Schmidt, Village Administrator, met with Hechimovich representatives on current issues and observed operations. The Lake Area Public Works Association toured the facility with Director of Public Works Jerry Gilles representing Kewaskum.

The MRF system used by Hechimovich uses an assemblyline approach for separating the plastics, glass, cans, etc. A magnet is used to pick off the metal cans and con-

tainers.

Currently, the top grade of plastics are worth about 10 cents a pound. A four cent deduct is applied to containers with the plastic lid on it. For plastic purchasers, the cap on a container is a contaminant. The separated plastic is fed into a compactor and then baled into 1,400 pound bales.

Three years ago, when the MRF system went on line, only a small portion of its capacity was being used. Today, the system is operating at near its full potential. With the building space being consumed with the MRF operations, paper sorting and handling has been moved into a new location in

Menomonee Falls.

As late as January of 1994, finding markets for paper was difficult at best. Today the paper and cardboard markets are very good. Paper has been over \$100 a ton in the past six months and cardboard hit \$180 a ton, after processing. Today markets are in a down trend, with prices dropping sharply.

Currently, Hechimovich is developing and building an automated machine to break open and empty the bags that are now being opened and emptied by hand.

Another related industry business has opened in Mayville called Premier Plastics. This company purchases baled recycled plastics, plastic disposables from manufacturing and other sources. The plastic is "flaked" into a product that is marketed for injection molding and other uses. The oper-

ation requires removal of most of the paper from the plastics before marketing.

The process is very interesting, and much of the equipment has been custom made to function in this relatively new field. The business recycles its own wash and process water, reusing it over in the process. The HDPE and PETE plastics currently have the most demand in the market.

While market trends seem to be fluctuating both up and down recently, the fact that markets exist and recycling seems to be developing products that can be marketed and used is encouraging to the recycling effort. It was noted during the tour that smaller communities (like Kewaskum) seem to be providing recyclables with cleaner containers at the curb and the caps removed from more containers.

Village Board Meeting Minutes

Regular Meeting
October 2, 1995
8:04 p.m.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Regular Session in the Council Room of the Municipal Building, 204 First Street.

President Robert Wagner presided. All Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee John Borland, seconded by Trustee David Goeden and unanimously carried by voice vote, the minutes of the September 18, 1995 meeting were approved as printed.

Mr. Kelly Scannell of the Kewaskum Area Jaycees was present to inform the Board that the Kewaskum Jaycees would more than likely disband at the end of 1995. It is hopeful some organization will come forward to manage and run the Little League program in the future. With the disbanding of the Jaycees, the membership agreed to donate \$2,000 to go toward the construction of the SE T-Ball diamond south of the existing lighted diamond. The Jaycees will have a plaque made for placement adjacent to the new diamond. On a motion by Trustee William Kulas, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote, the Board accepted the Kewaskum Jaycees' donation of \$2,000 to go toward the construction of the SE T-Ball Diamond and expressed their sincere thanks for the Jaycees' efforts over the last 25 years.

Director of Public Works, Jerry Gilles informed the Board that there was an outage on the Main Street lighting system which was repaired and that the Clarifier Project at the Water Pollution Control Department has been completed.

Administrator Daniel S. Schmidt reviewed the following with the Board:

1) Review of the Taxpayer and League bulletins.

2) Review of the League Resolution that will be heard at the League Conference next week.

3) Informed the Board that the final payment on the 1994 recycling grant was received and the amount was \$5,818.65.

4) Miscellaneous correspondence.

On a motion by Trustee Harry Roecker, seconded by Trustee John Borland and unanimously carried by voice vote, the Board approved the payment of bills as recommended by the Administrative Committee. The total of all claims as recommended are as follows:

Chairman of the Administrative Committee, Robert Stoltzmann informed the Board that the Committee reviewed the Administrative portion of the proposed budget

for 1996 and it was projected that an overall decrease could be expected of an estimated \$25,969 or 6.2%. It was noted that the Debt Service fund is down, which contributes to the overall status of those accounts. It was further indicated that some minor adjustment will be made and brought back to the Board.

Chairman of the Public Works Committee, Trustee William Kulas informed the Board that a Committee meeting is scheduled for October 16, 1995 at 6:30 p.m. to review the department's proposed budget for 1996. The Committee will be invited to inspect the #1 and #2 pump houses prior to the meeting at 6:00 p.m.

Chairman of the Park and Recreation Committee, Gary Gavin reviewed the Summer statistics for the beach. It was noted 1995 was the fourth highest recorded usage of the beach with the total attendance at 10,416 and the daily attendance at 115.7.

The results of a survey the Village participated in were then reviewed. It was noted and agreed to that the Village was on the low side of the fees being charged for swimming. A few recommendations were discussed. On a motion by Trustee Gary Gavin, seconded by Trustee Robert Stoltzmann and carried by the majority voice vote of 4 to 3, the Board directed the Administrator to use option #1 for the revenue calculations for the budget and to also prepare a rate schedule for the Board to consider adjusting the fees. The three Board members voting against were Trustee William Kulas, Trustee John Borland and Village President Robert Wagner. These three indicated they would prefer to see the increase implemented over a two year period.

Board Representative for the Plan Commission, Trustee David Goeden, informed the Board that the Commission reviewed the request of Steve Olig on the dividing of two lots into four lots in Pheasant Run estates. The Commission rejected the concept because of it being contrary to the original approved by both the Commission and Village Board.

Board Representative for the Library Board, Trustee Harry Roecker, informed the Board that the circulation of the library was still on the rise and that the proposed budget for 1996 was being turned in by the Library Board which is \$2,000 less than the 1995 budget.

Board Representative for the Mid-Moraine Municipal Association, Legislative Committee, Trustee Robert Stoltzmann reported that a Committee meeting was held on September 20, 1995 at which Administrator Daniel Schmidt was the speaker

to review the Special Task Force survey results. A meeting is scheduled for October.

Administrator Daniel S. Schmidt reviewed briefly some changes as requested in the Park and Recreation proposed budget for 1996 and changes to the Fire Department proposed budget information. The 1995-96) Tax Facts were reviewed by the Board. The Village Board will review the Fire Department proposed Budget for 1996 again on the 16th of October and will determine what amounts are to be sent to the Townships regarding their service contracts.

Discussion was also held on the possibility of requesting a State Trust Fund Loan already to get on the waiting list for said funds. The consensus was to have the Administrator proceed with the process.

On a motion by Trustee John Borland, seconded by Trustee William Kulas and unanimously carried by voice vote, the Board authorized the signing of the Industrial Wastewater Discharge Permit between the Village and Farmers Union Milk Marketing Co-Op. It was noted that the agreement is basically identical to the last with only the dates changed.

On a motion by Trustee John Borland, seconded by Trustee David Goeden and carried by the majority roll call vote, the Board approved the application for a Temporary Class "B" Retail License for the Kewaskum Sno-Chiefs for October 7 & 8, 1995 at River Hill Park. The event is Kettle Kountry Kolors. Note: The Police Department had no objections to any of the applications. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent."

On a motion by Trustee William Kulas, seconded by Trustee Harry Roecker and unanimously carried by voice vote, the Board approved the appointment of Beverly Rohlinger as the agent for the Sno-Chiefs.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee William Kulas and unanimously carried by voice vote, the Board approved the agent and name change on the previously issued Class "B" Fermented Malt Beverage and Intoxicating Liquor License for the period commencing October 3, 1995 and ending June 30, 1996 for T & Veris. Mr. Timothy Rohlinger replaces Mr. Thomas Piwoni on the noted licenses.

On a motion by Trustee Harry Roecker, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote, the Board approved the Trick or Treat hours for the Village of Kewaskum. They will be October 29, 1995 from 2:00 p.m. to 4:00 p.m.

Bonus Antlerless Permits Will Go On Sale Nov. 4

MADISON -- Approximately 71,000 remaining antlerless bonus permits for the 1995 deer hunting seasons will go on sale November 4, over the counter at select Department of Natural Resources offices around the state and over the phone.

A bonus permit allows a hunter to take an additional antlerless deer in the unit for which it was issued. Hunters may purchase up to three bonus permits, only one of which may be in a Northern Forest Deer Management Unit.

Bonus permits will be available for the following Deer Management Units: 1, 3, 6, 7, 12, 13, 14, 17, 18, 20, 24, 28, 29B, 39, 40, 50, 51A, 51B, 54C, 59C, 59M, 60, 60A, 61, 63A, 67B, 68A, 70, 70A, 70E, 70G, 71, 73C, 75, 76, 76M, 77B, 77C, 77M, 78, 80A, 80B, 80C, 81.

There were a total of 577,335 antlerless permits available statewide, not including metro units, for the 1995 seasons. There were 414,300 deer hunters who applied for hunter's choice permits for the 1995 deer season by the September 20 deadline. Additionally, more than 120,000 permits were sold through mail-in applications that were offered to hunters who purchased Hunter's Choice permits.

Due to mailing delays, people in some areas did not receive their application

forms to purchase bonus permits prior to the mail-in deadline. Those individuals may still return their applications by November 7.

Permits will go on sale at most locations Saturday, November 4, beginning at 9 a.m. Most offices will remain open until 6 p.m. Saturday. There will be no over-the-counter sales on Sunday, November 5. Over-the-counter sales will resume on Monday and continue until all permits are sold or until November 17. Most offices have extended business hours until 6 p.m. for permit sales.

Permits may be purchased over the phone by calling 1-800-695-HUNT (4868). The phone sales will operate 24-hours-a-day through November 9. Permits may only be purchased over the phone by using a MasterCard or Visa card.

People interested in purchasing bonus permits can call 1-800-282-0367 for current updates on which units have bonus permits available.
