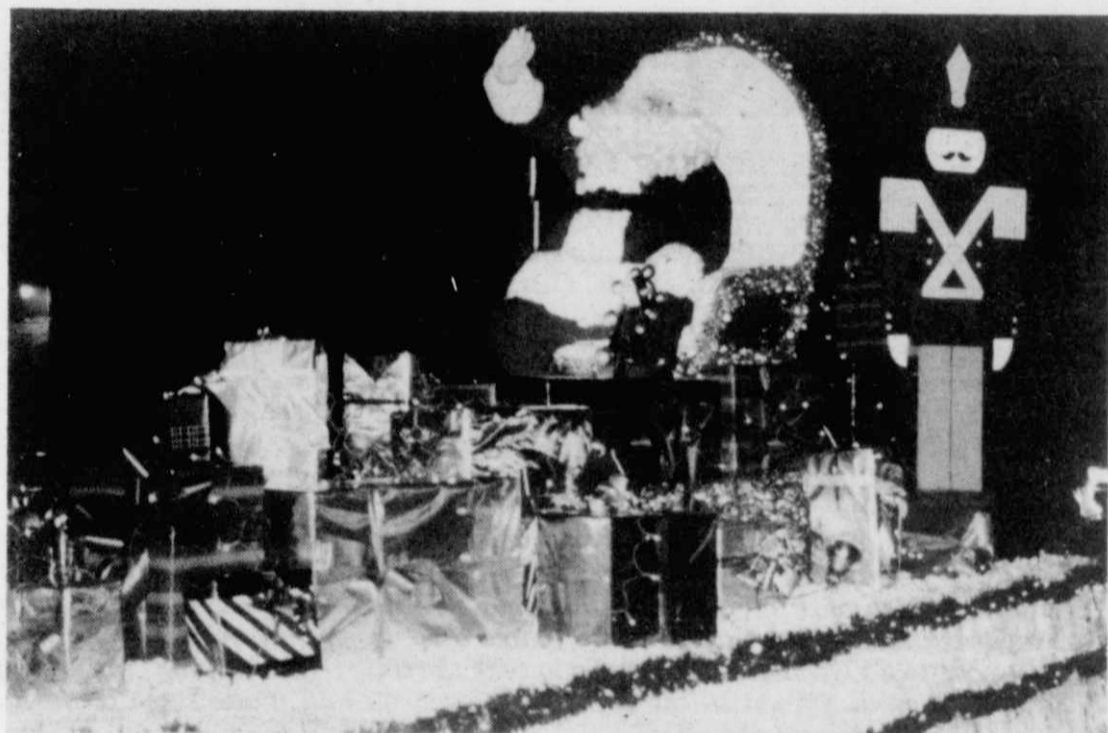

## Eight Candidates to Vie for Three School Board Seats

December 5th was the deadline for filing candidacy papers for three expiring seats on the Kewaskum School District Board of Education, with the upcoming election scheduled to take place earlier than usual next year on Tuesday, March 19, 1996.

School board member Ron Beimborn, whose term is up for re-election, failed to file papers for non-candidacy, therefore, due to new election laws, the deadline for filing papers was moved up 72 hours, to Friday, December 8, at 5 p.m.

Incumbents Ruth Schmitt and Karen Sparks, whose three-year terms as board members also expire, have filed papers seeking re-election. Sparks has been on the board since she was

appointed to replace Janet Wolfenberg in January of 1994, and Schmitt was elected to her position in April of 1987, and also served as board president for one year.

Six new individuals have entered the arena as candidates, making this one of the largest turnouts of new candidates seen in this district, and creating the need for a Primary Election. The Primary will be held on Tuesday, February 6, 1996, to eliminate two positions, providing no one else files papers by Friday.

Vying for the three positions on next year's school board are newcomers John Downs, Larry Fechter, Lisa Maul, Don Nowak, Thomas Timblin, and Richard Welch.

In the village race, three trustee positions

will be up for re-election in March, 1996, with two of the three trustees stepping down from their positions.

William Kulas and John Borland are not seeking re-election, and the deadline for filing candidacy papers was also extended at the village level until 5 p.m. Friday, since Kulas failed to file non-candidacy papers. Incumbent Robert Stoltzmann has returned his nomination papers, along with newcomer Warren Dums. Papers were also taken out by John D. Kenworthy, but he has not, as yet, returned them.

All those still interested in seeking positions as a school board member or village trustee now have until Friday, December 8, at 5 p.m. to file papers.

## Town of Kewaskum OK's Mini-Warehouses

Following the recommendation of the Plan Commission, the Town of Kewaskum Board approved plans presented at the November meeting by Myron and Becky Strobel of Hastro, Inc. for mini-warehousing to be located on approximately three acres behind Strobel Propane tanks along Highway 45.

The Strobels will begin with the construction of one building hoping to have rental space available in the spring of 1996 and have approval to build up to three buildings for a total of 100 units.

The board took no further action on the Hon-E-Kor conditional use permit to operate a dog kennel. Town zoning administrator Gordon Hoffman has been unsuccessful in meeting with the parties involved to resolve the differences and alleged problems expressed at the October meeting. Since that meeting, Hoffman has visited the kennel and found no violations of the conditional use permit.

To comply with state

requirements, the board adopted a policy for a drug/alcohol test management program. As a pre-employment requirement, any new employee hired after January 1, 1996, will be required to undergo this testing.

In other matters before the board, approval was given for the 1995 fire contract with the Village of Kewaskum for \$60,333 to be made in quarterly payments, nine applications for operators licenses at Sunburst Ski Hill were approved as well as a coin operator license and a one year contract was approved with Hechimovich Sanitary Landfill, Inc. to pick up solid waste for \$250 per month. Town of Kewaskum residents will benefit from a tax levy decrease which went from the 1994 net rate of \$22.90 per thousand to \$22.46 per thousand for 1995.

A town land planning meeting is scheduled for Monday, December 11, at 7 p.m. at the Town Hall with the next monthly board meeting set for Monday, December 18, also at the Town Hall.

## Kriewaldt is New Principal

The Kewaskum School Board recently hired Kieth Kriewaldt as the new principal for Wayne and Farmington elementary schools.

Kriewaldt replaces Kevin Steinhilber, who left after serving as principal for only one year, to take a position in Appleton, with retired principal Tom Larsen filling in until Kriewaldt was hired.

A former elementary teacher at Horizon School in Plymouth, Kriewaldt is waiting to receive a provisional license from the DPI, which usually takes four to eight weeks, while he continues to work on completing his Master's Degree in K-8 educational Leadership for School Administration. Presently he is finishing up his third class at Cardinal Stritch College, and has two more courses to go before his program is completed. "I should be done by the end of the summer," he stated in a recent interview.

His first official day with the district was Nov. 20th, at a starting salary of \$52,000. Kriewaldt will be splitting his time between the two schools, spending three and a half days at Wayne, and the rest of the time at Farmington. "It's great to be here, and exciting," he said of his new career, adding that he liked the idea of working with both schools, and felt it was an excellent opportunity to gain new experience. "It was time for me to move on and start a new career," he expressed.

Kriewaldt previously

worked in a multi-age classroom in Plymouth, combining 4th and 5th grades, which he feels works well in the right setting. For now, his main concerns are listening to the staff and students, as well as meeting the needs of the community.

"The role of a principal is more an educational leader than an administrator," he noted, and looks forward to meeting parents and getting to know the students.

The new principal resides in Plymouth, with his wife Julie, who works in the computer field at Ross Inc. in Sheboygan. The couple have two children, David, 3 1/2, and Laura, 13 months.

### Gauvin Enrolled At Centre College

DANVILLE, KY -- Suzanne Gauvin has enrolled this year at Centre College, a selective liberal arts school. Centre had a record freshman enrollment this year of 301 students. Gauvin is the daughter of Daniel and June Gauvin of Kewaskum and is a 1995 graduate of Kewaskum High School.

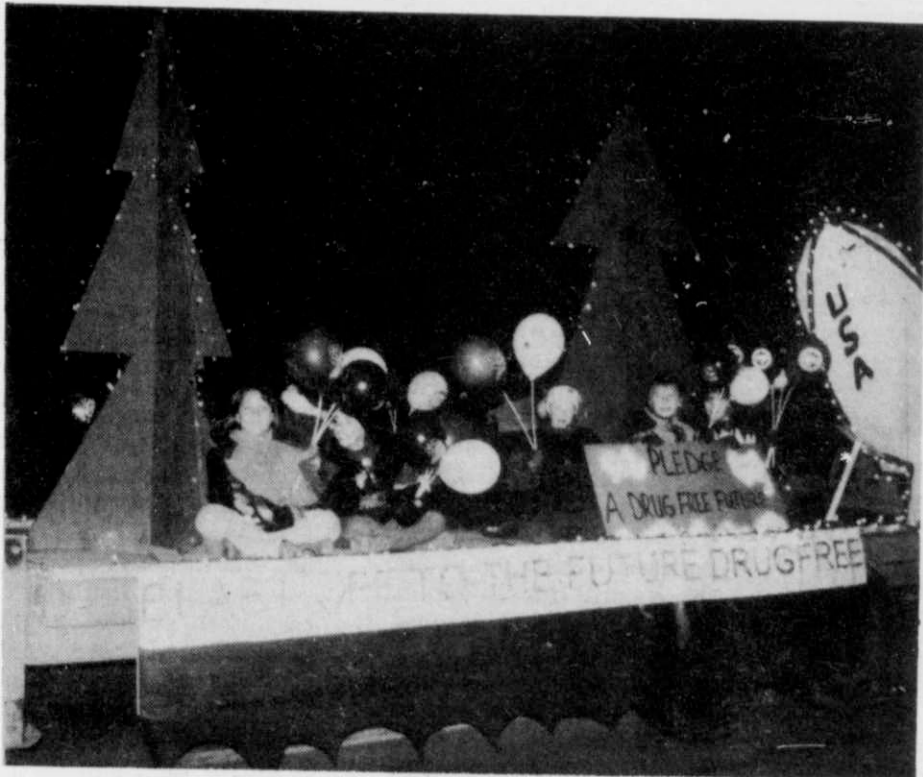

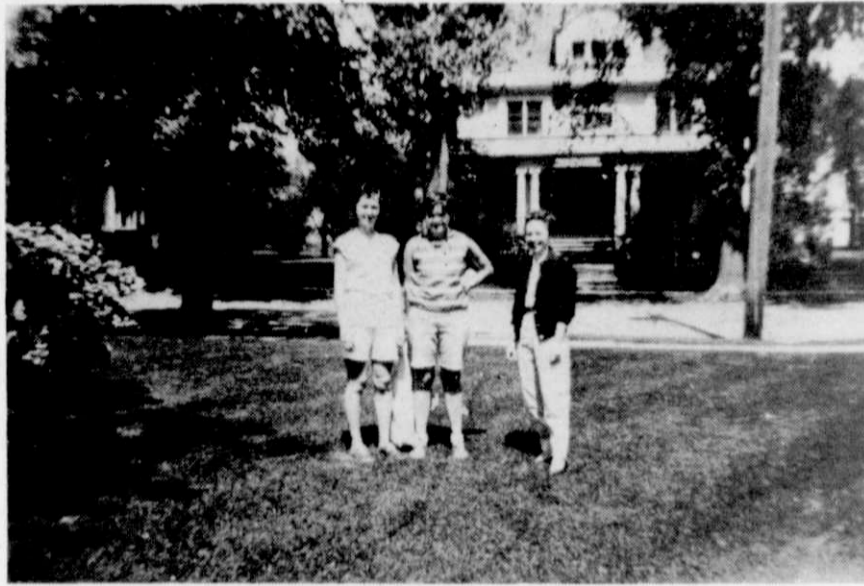

## Hazardous Waste Clean Sweep Program to Be Held in County

Disposal of Hazardous Waste has been a persistent problem throughout history. Disposing of our wastes down the drain or on the garbage truck are inadequate for disposing of materials we no longer want or need.

Toxic chemicals are stored in almost every room of a typical American home. We have cleaners in the kitchen, disinfectants and fresheners in the bathroom, hobby supplies and pesticides in the basement or garage, to name a few.

In June, the Washington County Board of Supervisors passed a resolution to apply for a grant for a Household Hazardous Waste Clean Sweep Program.

The Washington County Board of Supervisors also passed a resolution in July to apply for a grant for an Agricultural Clean Sweep Program.

Washington County has been awarded \$15,000 from the Department of Natural Resources, and \$35,000 from the Department of Agriculture, Trade and Consumer Protection to provide the community with a convenient, central collection point for the safe, economical and environmentally sound transport, treatment and/or

disposal of hazardous wastes.

The County will not be accepting paint as part of the Clean Sweep. It's too costly for the County to dispose of the paint. Residents can dispose of paint by letting it dry and putting the dried paint in with the regular trash. Thin layers of paint in a shallow box work best for drying the paint.

The last time the County had a Household Clean Sweep it cost about \$124,000 to dispose of the chemicals, and almost two thirds of that cost was to dispose of paint, according to Director of Emergency Government James H. Pamperin.

In 1996, an Agricultural Clean Sweep will be run in conjunction with the Household Clean Sweep. The exact date for both clean sweeps has not been determined at this time, but it is anticipated to be late summer or early fall of 1996.

## Holiday Spirit Visits Post Office Early

The holiday season may still be a few weeks away for most local residents, but at the Kewaskum Post Office, preparations are already underway to help customers handle the busiest time of the year.

"Here at the post office, we start thinking about the next holiday season almost as soon as the current one is over," said Officer In Charge Laurie Fechter. "For us, it just seems natural to be going into full swing for the holidays so early. It enables us to be ready to help our customers when they begin mailing gifts and greetings all over the world."

The heavy holiday mailing season starts the day after Thanksgiving, and the avalanche of cards and parcels does not let up until the end of December. The Postal Service expects to handle 139 million cards and letters every day during that period. Add in a mountain of more than 99 million parcels, and it is easy to imagine how busy postal workers will be delivering gifts and cheerful greetings here in Kewaskum and around the world.

To help ease the flow of incoming mail, the post office here asks you to please bring bundles of mail directly to the front counter where trays will be available for local and out-of-town mail.

"That high mail volume might make some people thirsty thinking about licking all those stamps," said Laurie Fechter. "That won't be a worry this year, because we are selling several different varieties of self-adhesive holiday stamps. All you have to do is peel

and stick and your mail is on its way."

"Every year we try to get a little better at anticipating our customers' needs during this busy time," added Fechter. "This year we are providing lobby materials that will help customers understand what we have to offer."

Another time-saver from the Postal Service is the sale of a variety of stamp-related gift items. From inexpensive Stamp Folios to hard-bound books relating to exciting stamp subjects, these gift items offer value and the convenience of one-stop shopping.

Recognizing that for many customers last-minute shopping is as much a part of the holiday experience as visiting friends and family, the Postal Service also offers services that can get packages to their destinations in short order. Priority Mail will get items across the country in about two or three days.

For guaranteed overnight delivery, check with the post office about Express Mail Service. Express Mail is delivered 365 days a year, even on Sundays and holidays. Foreign destinations can be reached on short notice as well, with Express Mail International Service. While it's best to mail early, these expedited services let customers who have procrastinated breathe easier at the last minute.

Laurie invites everyone to stop in and welcome their new window clerk, Sally Retzlaff. She also wants the community to know that the post office will be closed at noon on Saturday, De-

ember 23 instead of the usual 2 p.m.

Laurie and the whole staff at the post office hope you'll stop in on Friday, December 22, for a cup of coffee and some Christmas treats courtesy of your postal employees. Share the spirit.

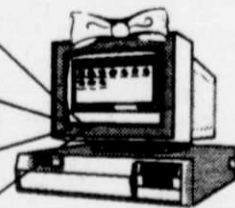

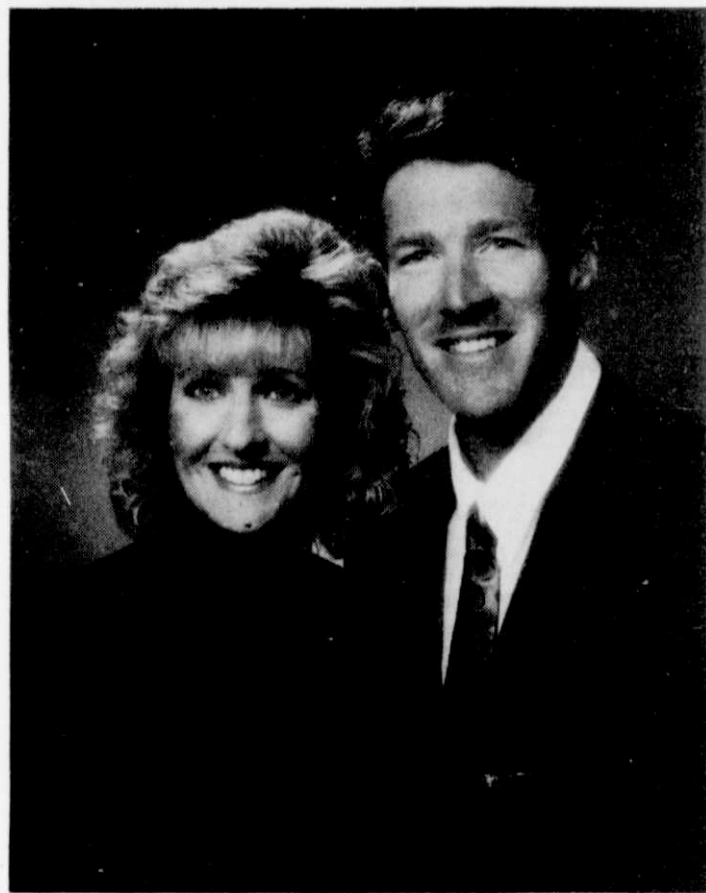

Foreign high school students are scheduled to arrive soon for academic semesters homestays, and the sponsoring organization needs a few more local host families.

According to Pacific Intercultural Exchange (P.I.E.) Executive Director, John Doty, the students are all between the ages of 15 and 18 years, are English-speaking, have their own spending money, carry accident and health insurance, and are anxious to share their cultural experiences with their new American families. P.I.E. currently has programs to match almost every family's needs, ranging in length from a semester to a full academic year, where the students attend local high schools.

P.I.E. area representatives match students with host families by finding common interests and lifestyles through an informal in-home meeting. Prospective host families are able to review student applications and select the perfect match. As there are no "typical" host families, P.I.E. can fit a student into just about any situation, whether it be a single parent, a childless couple, a retired couple or a large family.

Families who host for P.I.E. are also eligible to claim a \$50.00 per month charitable contribution deduction on their itemized tax returns for each month they host a sponsored student.

For the upcoming programs, P.I.E. has students from Spain, Germany, Poland, Russia, Finland, Denmark, Argentina, Brazil, Colombia, Paraguay, Australia, New Zealand, Croatia, and many other countries. P.I.E. has also been invited to participate in a special government-funded program to bring scholarship students from the Newly Independent States of the former Soviet Union to the United States. P.I.E. is a non-profit educational organiza-

tion that has sponsored more than 18,000 students from 40 countries since its founding in 1975. The organization is designated by the United States Information Agency and is listed by the Council on Standards for International Educational Travel (CSIET), certifying that the organization complies with the standards set forth in CSIET's Standards for International Educational Travel Programs.

Doty encourages families to contact the program immediately, as it will allow the proper time for the students and hosts to get to know one another before they actually meet for the first time.

## What is Co-op Program at Kewaskum High School?

Co-op programs (Co-operative Employment Experiences) are available as part of the School-To-Work initiative to juniors and seniors at Kewaskum High School.

Co-op education provides opportunities for students to have actual on the job work experiences. To participate, students must attend or have completed prerequisite courses that are related to their career choices.

To participate in a co-op, in addition to the required course work, students must be recommended by their teachers and must be interviewed by the high school Co-op advisors, Carol Martin (Family and Consumer Education), Dale Schatz (Business Education) and Keith Amundson (Technical Education).

Coordinator Schatz said, "The best thing about Co-op is that kids develop a good work attitude and develop an ability to get along with co-workers and supervisors."

After successfully completing the requirements, a partnership is developed between a job super-

visor, the student and the advisor. Together these three people develop an individual training program based on the needs of the student and the employer.

At KHS, Dale, Carol and Keith make regular job site visits to coordinate the students on site-training and they monitor the classroom instruction. Students are responsible to communicate regularly with their advisors and a training agreement/contract must be signed by the students, the parents, the school coordinator and the employer.

The Co-op program at KHS has been in place for five years. The co-op experience leads to job opportunities for some students after graduation and provides them with valuable work experience for the future.

According to Coordinator Carol Martin, "Our Co-op program provides invaluable experience for students. Employers love KHS students for Co-op. I feel proud that we get many more requests for co-op students than we have students. This speaks volumes for the program."

## Just Say No Clubs Receive Grant

A \$1,000.00 student mini-grant from the Department of Public Instruction was awarded to the Just Say No Clubs of Kewaskum School District's elementary schools. The grant is a part of the Alcohol and Other Drug Abuse programs for the state. It is awarded each year to innovative prevention and wellness programs in which students take an active role. This is the second time the Clubs have received the competitive grant.

In a letter to the District Administrator, State Superintendent John T. Benson stated, "The student mini-grants are designed to encourage youth to become involved in the development and implementation of programs that are meaningful to them. It is my belief that without your help and active participation we will not succeed in dealing with health and safety issues in our society."

Elementary Guidance Counselor Cheryl Taylor founded the Clubs seven years ago. An estimated 560 total elementary school children have joined the Club since then. Nearly 200 third, fourth, and fifth graders

are currently members. Alberta Clements leads the Kewaskum Club. Cheryl Taylor is the Club Leader for the Farmington and Wayne Clubs.

The DPI mini-grant will help finance Club activities during the 1995-96 school year, including the purchase of Club t-shirts for the members. Each year the Just Say No Clubs choose a theme upon which to base their activities. This year's theme is "We are the Future—Let's Make it Drug free." In keeping with the Kewaskum Centennial, the District's three clubs proclaim a drug free future for the next one hundred years.

The Just Say No Clubs will also earn money through the sale of lollipops for the purchase of red ribbons, scholarships for drug free high school seniors and a special Christmas gift giving project for area children. The Club has also been assisted generously by Wendy and Malcolm Wade and Bridget Walters. The Wades provided last year's and this year's floats for the Christmas parade and Mrs. Walters donated t-shirts to the Wayne Club last year.

## 'Keeping Humor in the Holidays' Important For People with Chronic Lung Disease

Sharing laughter with friends and maintaining an upbeat attitude during a busy holiday season can be more difficult for people who have trouble breathing every day of the year.

That's the reason Maggie Seideman, R.N., chose "Keep Humor in Your Holidays" as her program topic for the December 13 meeting of the Pulmonary Rehabilitation Support Group sponsored by St. Joseph's Community Hospital of West Bend.

The group will meet from 6:30 to 8 p.m. in the hospital cafeteria. People with chronic lung disease or breathing problems, their spouses, friends and family are invited to attend the free event, which includes socializing, snacks and refreshments.

"We'll spend a little time going down the road map of humor, and how your attitudes have to change in order to be able to laugh. We'll take time for everybody to share some humor and a favorite joke," said Seideman, coordinator of the Pulmonary Rehabilitation Program at the hospital.

"It's a special challenge to keep a sense of humor when chronic lung disease makes ordinary activities more difficult. We think a positive, optimistic attitude and paced activities can help people with chronic lung disease socialize comfortably and feel good about the holidays," Seideman said.

Rosina Thull, 75, who lives outside of Kewaskum, pulls her tank of oxygen with her wherever she goes, but she takes

along a good sense of humor too.

"I was out on Thanksgiving. I had a hilarious time," she said, who last summer spent six weeks in the hospital with pneumonia, including three difficult weeks on a ventilator.

"I was really weak when I came home," she said.

Through St. Joseph's Pulmonary Rehabilitation Program, she's learned controlled breathing and exercises that help her conserve energy. And she's proud to note that she's increased her time on the treadmill from two minutes to 15 minutes.

Seideman said attitude affects the body, and humor and laughter are incredible positive forces. That's especially important for someone with pulmonary problems, she said.

"When you become short of breath, anxiety goes up," said Nancy Kasper, respiratory therapist at St. Joseph's.

Certain things can cause stress over the holidays, Seideman noted. They include being out in crowds, shopping for gifts and once-pleasurable tasks, like baking cookies.

"It takes too much effort. In situations where we get frustrated, it helps to develop a different way of looking at things," she said.

"When you can't get your breath, you panic," said Dorothy Boll of rural Kewaskum. She recently joined the rehabilitation program. Though she has only 70 percent lung capacity, she's looking forward to the holidays.

"Getting through is

not a problem. I love the holidays," she said.

She said techniques she learned in the program enabled her to safely pace snow shoveling activity: "I shoveled three shovels full, then stopped and did my purse-lip breathing."

Reservations for the support group meeting are needed by December 13, by calling 334-8237. Participants may park in the Oak Street parking lot on the southeast side of the hospital, and enter at the employee entrance. The cafeteria is to the left.

The support group was initiated in March and complements the Hospital's Pulmonary Rehabilitation Program begun in August, 1994. The support group meets quarterly and offers continuing education, speakers and social opportunities.

The Pulmonary Rehabilitation Program educates participants about their disease, diet, exercise, stress management, and presents techniques to improve breathing and conserve energy. Members meet twice a week for monitored exercise and education.

Pulmonary disease is the third leading cause of death in the United States. Chronic obstructive pulmonary disease (COPD) is the general term for diseases such as emphysema, chronic bronchitis and asthma.

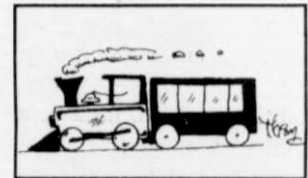

## Town of Scott Forms Committee On Possible Acquisition of Beechwood School

At the November meeting of the Town of Scott, it was decided sludge haulers in the Town of Scott will experience a \$25 increase in permit fees, beginning at the expiration of their contracts. Most contracts expire in March. At the present time cost of a permit is \$50 per site. The town has 19 approved sites.

Town of Scott Supervisor Richard Bemis has commended the town's official newspaper, the "Sounder" for its fine offering of local news. He said, "In the *Sounder*, you can find news from all around. It gives us a chance to find out how other municipalities handle certain situations. It is a good paper."

A bill which is over ten years old and was shared by five different family members has town board members scratching their heads. Each owed \$110.05 as a fine imposed upon them in a law suit with the town. All but one party has paid the fine. Accumulating interest at the rate

of 12%, the amount owed has escalated to \$305.18. As a means of collecting the unpaid debt, it was the board's intention to place it on the tax roll in the form of a special assessment. However, the party no longer owns property in the town.

Upon a bit of investigation, Chairman Lester Benzschawel has learned that although this party is no longer a town property owner, there are provisions in the State Statutes which for a \$5 fee, the town has the right to place a lien on property anywhere, not only in the town. The board has taken action to do just that.

A committee has been formed to make an attempt to gain possession of the Beechwood school from the Kewaskum School District. Members of the committee are Loren Hendrickson, Terry Weber, Barbara Bank, Ron Rozell, Cindy Krause, Dale Burke, Clarence Janz and Lester Benzschawel. They will be meeting with school officials in the near future.

Hillside Drive which originates at its intersection with Highway 28 north of Batavia has been extended further east and then north to join County Road A. Action was taken to continue the name Hillside Drive on the entire stretch of road.

In other action, a conditional use permit was approved for Tim Geidel to operate a carpenter business in his garage on the former Ken Kohl property. No outdoor storage will be allowed.

A rezoning request from Glenn Knepprath was tabled because Knepprath is not the legal owner of the property in question. The owner must make the request.

Joining of a consortium for drug testing for drivers holding a CDL license was tabled until December.

Assessor Ernie Matthes was reappointed for another year at a cost of \$5,100.

The board discussed the declining price of recyclables and made a decision to advertise for bids for a new truck and plow.

## Village Board Meeting Minutes

**Regular Meeting  
November 6, 1995  
8:00 p.m.**

The Village Board of Kewaskum, Washington County, Wisconsin, met in Regular Session in the Council Room of the Municipal Building, 204 First Street.

President Robert Wagner presided. Trustee William Kulas asked to be excused and was absent, all Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee John Borland, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote, the minutes of the October 16, 1995 meeting were approved as printed.

Ms. Diane Horlamous of the Washington County Humane Society appeared to address the Board regarding the establishment of a wolf hybrid ordinance and to thank the Board for county wide support for animal control. By consensus of the Board, the Administrator was advised to check with the Village Attorney on the possible creation of a wolf hybrid ordinance.

Chief of Police Richard L. Knoebel informed the Board that 78 applications have been received for the creation of an employment list for the Police Department. It was noted the Police and Fire Commission will be working on the matter in early 1996.

Director of Public Works Jerry Gilles reviewed with the Board some growth information. It was noted that the Village experienced 5.6% growth between 1980 to 1990 and for that period 1990 to 1995 experienced 18% growth.

Administrator Daniel S. Schmidt reviewed the following with the Board:

- 1) Review of Taxpayer and League bulletins.
- 2) Review of the building permits for October 1995.
- 3) Review of correspondence.

On a motion by Trustee John Borland, seconded by Trustee David Goeden and unanimously carried by voice vote, the Board approved the payment of bills as recommended by the Administrative Committee. The total of all claims as recommended are as follows:

Board Representative for the Plan Commission, Trustee David Goeden reported on the Plan Commission meeting of October 31, 1995. He advised the Village Board to

review the preliminary Land Use Map as provided by SEWRPC.

Administrator Daniel S. Schmidt reviewed the proposed 1996 Library Fund Budget. It was noted operating expense was up by \$1,507 or 3.0% while the expenditure side of the budget was down by \$2,112 or 2.3%. It was further noted that the Village's overall contribution was down by \$6,162 or 10.6%. This was caused by the completion of the purchase of the automation system.

Board Representative for the County-Wide Library Board, Frank Beesten, reported on the October 17, 1995 meeting. It was stated Mr. Beesten is the Village delegate until 1998 and that the Committee is starting to work on a new four year contract for county-wide services. The October circulation for 1995 was 4,046 compared to 3,422 of 1994 and that the overall circulation is up by 1,312 from 1994 YTD.

Action was taken on Resolution No. 95-24 a resolution to Request Tax Exemption from the County-Wide Library System Tax Levy under provisions of Wisconsin Statutes 43.64(2) as attached hereto:

Administrator Daniel S. Schmidt reviewed the overall proposed 1996 budget and notice for public hearing. It was noted that on the notice an increase is reflected but that is being caused by the dropping of the separate Capital Projects budget as well as other adjustments previously caused by the expenditure restraint program. In reality the budget is decreasing a total of \$173,577 or 10.4%. At the same time, an increase in the total dollars being levied is occurring because of the growth in value of the Village. The property tax levy is actually reflecting a zero dollar and percent increase. It was further noted that even with the

stable tax rate, because of the revaluation, different classifications will experience adjustments in their taxes to be paid. This process is established by the State of Wisconsin and Department of Revenue. The Village Board doesn't have any real control over this procedure, but is mandated to work within those rules. The public hearing is scheduled for November 27, 1995 at 7:00 p.m.

The TIF proposed budget for 1996 was reviewed indicating the revenues have increased due to growth and that it is hopeful the TIF will be able to be closed out in the spring of 1996. The Capital Outlay Fund has been incorporated into the general budget because of the lack of benefit for the expenditure restraint program for 1996.

The Debt Service Fund reflects a decrease for 1996 of \$31,973 or 14.4% and it was noted the TIF debt appears in this category as well.

The Special Revenue Fund also reflects a decrease of \$31,905 or 74%. The Board is using less money from the Open Space Fund for park projects in 1996.

The Water Fund proposed budget for 1996 reflects an increase of \$49,245 in revenue or 18.4% while on the expenditure side an increase of \$20,300 or 8%. This would reflect the PSC requirement to have a rate of return equal or greater than 8.5%.

The Sewer Fund as proposed for 1996 reflects a decrease in revenue of \$51,507 or 11.7% and on the expenditure side an increase of \$11,812 or 3%. At this time no adjustment of rates is proposed but will be revisited possibly during the third quarter of 1996. Both in the proposed Sewer Budget and Capital Outlay Fund, items are being looked at to reduce expenditures and to save money in

reductions of utility expenses.

Both utility budgets will also be heard at public hearing on November 27, 1995 at 7:00 p.m.

Discussion was held on the request of RTKM to hold off on the installation of 100% of the asphalt prior to occupancy permits being issued. The matter was reviewed with the Contractor, Building Inspector, Director of Public Works and Engineer and all parties recommend postponing a portion of asphalt installation because of the wetness of the area. On a motion by Trustee Gary Gavin, seconded by Trustee Harry Roecker and carried by the majority roll call vote, the Board approved postponing a portion of asphalt installation, but noted it had to be installed by July 1, 1996. Trustee David Goeden and Trustee John Borland voted "Nay."

Action was taken on Resolution No. 95-25 a resolution to Authorize the Submission of the Construction Report for 1994 and 1995 as attached hereto:

On a motion by Trustee Gary Gavin, seconded by Trustee Harry Roecker and unanimously carried by voice vote, the Board canceled the November 20, 1995 meeting as well as the December 4 and 18, 1995 meeting and rescheduling them as follows November 27, 1995 at 7:00 p.m. and December 11, 1995 at 8:00 p.m.

On a motion by Trustee John Borland, seconded by Trustee Robert Stoltzmann and carried by the majority roll call vote, to adjourn to closed session under

Chapter 19.85(1) (g) of the statutes to confer with legal counsel for the governmental body who rendering oral or written advice concerning strategy to be adopted by the body with respect to litigation in which it is or is likely to become involved. Roll call vote was 6 "Aye" 0 "Nay" 1 "Absent."
