Primary Election Tuesday

When area voters go to the polls on Tuesday, their ballots will decide which candidates' names will appear at the polls for the Spring Election on March 19.

With more candidates than positions in the Kewaskum Board of Education race, electors' interest should be peaked enough to draw a substantial voter turnout February 6 for the Primary Election.

A record setting eight candidates are vying for the three terms of school board seats expiring on the district's board. Two of the candidates are incumbents Ruth Schmitt and Karen Sparks, who are being challenged by Donald Nowak, Lisa A. Maul, Richard J. Welch, Larry Fechter, Jon A. Downs, and Thomas H. Timblin. The third board member whose seat expires, Ron Beimborn, decided not to seek reelection.

Schmitt will be seeking her fourth term on the school board, and Sparks her second term, having been appointed in 1994 to replace Janet Wolfenberg.

The Primary will eliminate two candidates, and the six with the most votes will win the chance to be contenders in the spring race. Voters should cast their ballots for not more than three candidates for school board.

The School District of Kewaskum includes the towns of Barton, Farmington, Kewaskum, Wayne and the Village of Kewaskum. (See page eight of this issue for notices of election, hours, and places to vote for each township).

On the state level, electors will be narrowing down the selection of a Justice of the Supreme Court, from a group of seven candidates. The seat on the Supreme Court will be filled to replace a retiring justice.

Candidates, as they appear on the ballot, include Charles B. Schudson, Ralph Adam Fine, Lawrence J. Bugge, Stanley A. Miller, Harold V. Froehlich, Ted E. Wedemeyer Jr., and Patrick Crooks. Electors should vote for only one judicial candidate.

People wishing to vote vor any write-in candidates must remember they have to write in the individual's name on the ballot, as well as mark or punch their vote on the ballot. Failure to do both steps will void a write-in vote.

Forum Held for School Board Candidates

A large, attentive crowd was present in the Kewaskum High School cafeteria on Wednesday evening, January 24, for the Kewaskum Junior Women's Club's school board candidates' forum.

The rules of the forum were quite simple and explained to the candidates and members of the audience. Questions by Junior Women's Club members and also questions submitted anonymously by members of the audience were placed in a basket and drawn randomly one at a time after the previous question had been answered by all candidates.

The names of the candidates were also placed in a basket and one was drawn with each question which decided which candidate would answer first. The person seated to that person's left would answer the question next and so on down the line.

Mediator Meri Lou Chambers opened the proceedings by introducing candidates Karen Sparks, Jon Downs, Lisa Maul, Larry Fechter, Rick Welch, Ruth Schmitt and Tom Timblin, who gave brief, introductory remarks about themselves and the reasons they decided to run for school board.

Don Nowak, also a school board candidate and first person on the primary ballot, was not present at the forum.

Following the opening statements, 11 questions were

addressed by each one of the candidates. Some questions were pertinent to someone vying for a seat on the board, some were not relevant, and some were quite similiar in nature.

The first question asked was in reference to gradepoint averages in regards to
participating in sports and
Tom Timblin was the first
candidate chosen to respond.
He felt, "The gradepoint
average should be higher
than 1.5 for athletics." He
also felt all those participating in sports should be on the
honor roll, for these are the
role models in the school.

Jon Downs stated, "there may be some children out there that are doing their very best and it's kind of tough to say that wasn't good enough."

Downs added though that it was his gut feeling that it should at least be a C average.

Lisa Maul tended to agree but added, "I think alot of the parents out there set their own standards for their childen"

Larry Fechter added, "I agree that the grade average has to be increased to be a participant. But I also must state that we have to give our children a good reason to participate in a sports program. Personally I don't like to see us lower the standards so we get more kids, I'd like to see us increase the performance of our athletic department and programs that our kids want to become involved and will work to

achieve a C average."

Question number two asked about year round school and question three was in reference to the candidate's opinions of limiting the number of terms a board member may serve. The decisions on both of these questions, however, are not in the hands of school board members.

Question number four asked the candidates, "How would you view your role as an individual board member and as a member of this team?"

The name drawn to answer this question first was Ruth Schmitt, who stated, "As an individual board member the most important thing that I do is to do my homework. I study the issue, I take advantage of any opportunity to learn about the subject. I then come and hopefully share my ideas and come to listen to other ideas and eventually reach a compromise which will benefit the students above all and put aside any personal interest.'

Tom Timblin added his viewpoint, stating, "I have a real problem with the name calling. I'm going to be independent and make the decisions what's best for the Kewaskum kids, the taxpayers, and the parents. I think that's what we need is more togetherness on the board to get us out of the newspapers."

Jon Downs said, "You have to access the information on every issue that comes up. Once that information is received, then the discussion starts. That discussion is based on communication. It's not always what is said, but how it is said. It's not going to be a case where everyone is always going to agree. Sometimes it's a matter of how you disagree."

Larry Fechter added, "the minority must respect the majority's right to make the decision, based on the major-

ity."

On question number five, regarding computers in the classroom, Rick Welch, was the first to answer. "I think it all depends on the class, the subject and the way the teacher wants to teach the class."

Ruth Schmitt added, "I believe it would release the teacher for more time to give individual attention to students."

Tom Timblin stated, "I think the more we expand the computers in the schools I think it's nothing but positive for the future of our kids."

Most of the candidates agreed on this issue, including Karen Sparks who added, "the computer is a daily tool and if we don't give our students the maximum exposure in the right ways to the right kinds of technology... our kids need more than they are getting."

Larry Fechter also stated that "there has to be a fiscal end to computer acquisitions."

Lisa Maul also strongly felt the computer should play a big role in the children's education.

Regarding the discipline process in the high school, question number seven was addressed by Rick Welch who thought the "chain of command" you would be able to accomplish any problems that needed taking care of and it would be up to the board to back that chain of command.

The subject of curriculum

was question number ten and Karen Sparks stated, "curriculum is the single most important area the board addresses." She added there was an "ongoing process of curriculum development in the district."

All the candidates gave

very astute, carefully considered answers, however, time and space contraints, prevent us from reporting all the questions in detail and all the answers given. It is this reporter's sincere wish that all voters could have attended this forum.

Now the decision on which candidates will survive the Primary Election on Tuesday is in the hands of the voter. No matter how you feel on the issues, whether you agree or disagree, it is up to you to exercise your right to vote.

On referenda questions, the elector shall make a punch or a hole in the space designated for "yes" in favor of the question, or the elector shall make a punch or a hole in the space designated for "no" if opposed to the question

86,000 Apply for **Spring Turkey Permits**

MADISON -- More than 86,000 hunters applied for a record 75,597 turkey permits for the Spring 1996 season. The Department of Natural Resources mailed out permits to successful applicants last week, and successful applicants should have received their permits by February 2.

This was the highest number of applications

and the highest number of permits for a spring turkey season, according to Tom Howard, DNR wildlife biologist and turkey specialist. The highest number of permits were issued in turkey management zones 2, 3 and 4, with 4,500, 7,800 and 5,100 permits issued respec-

Landowners, who are given preference over

non-landowners, received 9,703 permits, and 4,929 hunters received second permits because they applied for zones and time periods for which there were fewer applicants than permits available, Howard said.

"Applicants who are willing to accept permits in later time periods in certain zones were the most successful in receiving two permits," Howard said. The highest number of second permits were issued in zones: 3 - 718 permits; 4 - 657 permits,

and 11 - 905 permits.

Some applicants who applied for a permit for only an earlier time period in some zones did not receive a permit because all available permits had been issued by the time their names were drawn. On the other hand, some applicants who indicated they would accept any available time period received two permits in those same zones," Howard said.

The spring turkey season is conducted in six five-day periods beginning April 10. Each period runs Wednesday through Sunday. The last period ends May 19. The bag limit is one bearded or male turkey.

Winter weather has not been severe for turkeys to this point, although there are areas of deep snow in several northern turkey zones and we are only half-way through the winter, Howard said.

Snow depths of greater than 10 inches for extended periods can limit turkey mobility, and reduce survival.

OFFICE OF THE WASHINGTON COUNTY CLERK TO THE ELECTORS OF WASHINGTON COUNTY:

Notice is hereby given of a spring primary election to be held in Washington County, on February 6, 1996, at which the officers named below shall be nominated. The names of the candidates for each office, whose nominations have been certified to or filed in this office, are given under the title of the office, each in its proper column, together with the questions submitted to a vote, for a referendum, if any, in the sample ballot below.

INFORMATION TO ELECTORS

Upon entering the polling place, an elector shall give his or her name and address before being permitted to vote. Where ballots are distributed to electors, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the elector shall retire alone to a voting booth or machine and cast his or her ballot except that an elector who is a parent or guardian may be accompanied by the elector's minor child or minor ward. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice

At the spring primary election, where lever machines are used, depress the lever or button at the right of the candidate's name. To vote for a person whose name does not appear on the ballot, the elector shall write in the name of the candidate of his or her choice in the space provided for a write-in vote

Where a marksense system is used, the elector shall fill in the oval next to the candidate's name of his or her choice for each office for whom he or she intends to vote. To vote for a person whose name does not appear on the ballot, the elector shall write in the name of the candidate of his or her choice in the space provided and fill in the oval on the write-in line.

The vote should not be cast in any other manner. If an elector spoils a ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one elector. If the ballot has not been initialed by two inspectors or is defective in any other way, the elector shall return it to the election official who shall issue a proper ballot in its place. Not more than five minutes' time shall be allowed inside a voting booth or machine. Unofficial ballots or a memorandum to assist the elector in marking his or her ballot card may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official marksense ballot is marked, it shall be inserted in the ballot sleeve provided so the marks do not show. After casting his or her vote, the elector shall leave the voting booth, insert the ballot into the voting device, and promptly leave the polling place.

An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty reading, writing, or understanding English, or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the elector's employer or an agent of that employer or an officer or agent of a labor organization which represents the elector.



Sturgeon Season to Open February 10

The 1996 sturgeon spearing season is set to open on Saturday, Feb. 10th. Recent high harvests over the past years have the DNR along with spearers concerned that the harvest is too high.

A number of public meetings have been held to obtain input from the fishermen and this years season may vary from

nine day season has been approved for this years Sturgeon Spearing Season. It will begin on Feb. 10th, on Monday, Feb. 12th, water clarity will be evaluated and if the clarity is poor the season will be extended. How long could it be extended? That will depend on the water clarity, but it could be extended through March 1st, which would be the normal season length.

The upper lakes which are also due to open for Sturgeon Spearing this year, will be open on the second weekend, Feb. 17th and 18th and then will close. The upper lakes include Lake Butte des Mort, Poyan, and Winneconne. There has been a spearing season on these lakes in the past, the last being in

1991, and it has always been a two day season.

What are the chances that the season on Lake Winnebago will be extended? That will depend on the water clarity but reports are that it is not very clear at the present time.

One final note for all you Conservation Patron License holders, your Sturgeon Spearing License and Tag will be mailed to you beginning on Feb. 1st. If you do not receive anything in the mail by the 5th, I would suggest you make a call to Madison and have one sent out.
