## Public Hearing on Land Rezoning For West Bend Clinic Facility, Kewaskum Frozen Foods Addition

The Village Plan Commission met with the Paradise Development Group on Jan. 30th to discuss rezoning property on Fond du Lac Ave. for the purpose of constructing West Bend Clinic's new facilities.

The 10+ acre parcel located at 1731 Fond du Lac Ave., was purchased by the group from Gerald Stoffel, and is currently

zoned AG-1 Exclusive Agricultural District. The plan commission listened to the request to rezone the land to B-2 General Retail and Service District. The remaining 60 acres of farmland will stay agricultural.

Future development of the site will include the proposed two level, 5,600 sq. ft. West Bend Clinic and pharmacy, and the potential for office/retail

space in the future.

Paradise Development Group administrator Bruce Steinert told the plan commission the clinic would like to begin construction of the main building by the end of this month, and the pharmacy sometime in April. "It is our intention to complete construction of the facility by the fall of '96, at which time Dr.

## Two Incumbents, Four Newcomers On March Ballot

Unofficial totals Wednesday morning show incumbents Ruth Schmitt and Karen Sparks will be listed on the ballot for the March 19 Spring Election, along with four newcomers.

Larry Fechter was the top vote getter with 568, followed by Thomas Timblin with 481. Other candidates and their totals include Jon A. Downs - 421, Karen Sparks - 376, Ruth Schmitt - 351, Lisa A. Maul - 320, Richard

Welch - 264, and Donald Nowak - 225.

A total of 3,006 votes were cast for the primary election, and the outcome of their ballots eliminates Richard Welch and Donald Nowak from the spring ballot. Fechter, Timblin, Downs, Sparks, Schmitt and Maul will now compete for the three seats on the school board on March 19.

On the state level, Patrick Crooks and Ralph Adam Fine defeated five other candidates

William and Valera McDonald, owners and operators of Rustic Inn, formerly McDonald's Tavern, located on Main Street in Kewaskum recently donated \$500 to the Kewaskum Fire Department.

"It (the donation) is something my wife and I have always wanted to do," McDonald explains.

The McDonalds had first hand experience watching the firefighters in action on January 14, 1992 when the Barrel Haus across the street

from them caught fire. As smoke bellowed from the structure, McDonald recalls thinking how brave the firefighters were as they fought the blaze in the blinding smoke and cold.

Originally from the Oconomowoc area, the McDonalds came to Kewaskum nine years ago. They recently changed their business name to "Rustic Inn" and serve food and refreshments Wednesday through Friday after 4:30 p.m. and on Saturday and Sunday after 2:30

p.m.

The donated funds will be applied towards the purchase of communication equipment for the new fire truck tanker the village and fire department are currently seeking bids on.

Announcement of the donation was made to the 42 volunteer fire department members at their February 1st meeting. Department officers, members and Kewaskum area residents sincerely thank the McDonalds for their generosity.

**Baby, it's cold outside!** The village crew may have been using some choicer words last week, when frigid, arctic-like conditions kept some of them awake for over 48 hours repairing water main breaks around town.

The first break occurred Tuesday evening in front of West Bend Savings Bank on Fond du Lac Ave. "I think this cold spell hit so hard and so fast, the ground really shifted when the frost penetrated," said Jerry Gilles, Director of Public Works for the Village of Kewaskum. The crew worked from 5:30 p.m. Tuesday until 7 a.m. the next morning putting in the replacement sleeve in way below zero temperatures. Between 50 and 75 residents experienced a water shutoff during the emergency repair.

But rest was not in sight for village crew workers Alan Kuehl, Brad Rodenkirch, Craig Gruber and Dennis Aupperle. Another water main broke on Roseland Dr., Wednesday, and a third occurred Friday night on Stark St. The crew made this last, but probably not final repair, Saturday morning.

More problems arose when an underground two inch main gas line was punctured at the Roseland Dr. site. Lead

operator Alan Kuehl explained that Digger's Hotline had incorrectly marked the location of the gas line. Residents commented they could smell the gas throughout that end of town, and work came to a halt, until gas company employees arrived to remedy the situation. "It's something we always have to watch for during these breaks," Kuehl pointed out.

Some city of Milwaukee workers are predicting more underground breaks will occur this week, due to warming temperatures creating more ground shifts. "It's a theory, but it's really unpredictable," Gilles states. Sometimes it's best to think positive when in the hands of Mother Nature.

On Thursday, weather conditions caused another unusual occurrence, this time in the village water towers. After strange readings were found on some of the equipment, it was discovered ice was building up in the small tower next to Regal Ware.

Lane Tank Company was called in to help with the problem, but a steamer had to be located to complete the job. After a short search, one was brought in from Menomonee Falls, and Lane hoisted the big hose up to the top of the tower, and dropped it inside to steam the tank free of ice.

Since then, a small amount of ice still remains in the tower despite warmer temperatures, and the village has been keeping this under control by running more water through the evenings and on weekends (the off hours) to increase circulation with in the water towers.

Moving out of the village and into the country, some area lakes were in danger of freezing through, and members of the Kettle Moraine Lake Association had to scramble with chainsaws in the bitter cold to cut air holes through the 20 inch thick ice in order to set up the aeration system. Freeze-outs can upset the lake's ecological balance for up to ten years, not to mention destroying mountains of fish.

Despite school closings, cars refusing to start, kids refusing to wear their hats and mittens, frozen water pipes, cabin fever and back

aches from shoveling, we've made it half way through (knock on wood) one of the worst winters since 1936.

The bitter cold broke records, but built character, and the Statesman Staff expresses their appreciation for a village crew that got Kewaskum through an emergency situation, despite their own discomfort. Your

dedication to the community goes above and beyond the normal call of duty. Thanks guys!

David Brown, Family Practice, will be joining Dr. Sison in the new office," he stated.

The new West Bend Clinic will be nearly identical to their new offices in Jackson, which are scheduled to open in March. Plan Commission and Village Board members are invited to take advantage of the opportunity to view the Jackson facilities to see how the Kewaskum clinic will appear when completed.

"We are very excited about the opportunity to expand the scope of medical care to the patients in and around the Kewaskum area," Steinert commented.

Blueprints of the proposed interior of the building include 12 examining rooms, two nurses stations, areas for offices, staff and administration, X-ray, labs and blood work rooms, a reception area, medical records, and a large waiting room with a designated play area for the children.

Another request for rezoning and a proposal for future business expansion within the village came from Robert Beisbier, owner of Kewaskum Frozen Foods.

Beisbier appeared before the Plan Commission to request a public hearing to rezone property located at 130 Forest Ave. from R-2 Single Family Residence

District, to B-4 General Business and Warehouse District, to accommodate the construction of an addition to the existing Kewaskum Frozen Foods facility. He also requested a Conditional Use Permit to allow for maintenance of the two residential structures on the front side or abutting Forest Ave.

Beisbier explained that the new production work area would give them 2,500 sq. ft. of expansion onto the present Kewaskum Frozen Foods, and will include a cooler and freezer. "We need more room to work in," Bob pointed out, "as we continue to grow in the wholesale area of our business."

A public hearing on

the two rezoning requests and conditional use permit will be held Feb. 19th at 7 p.m.

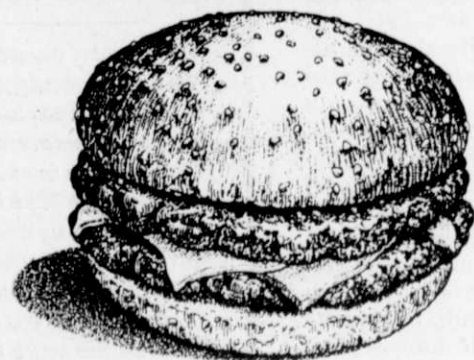
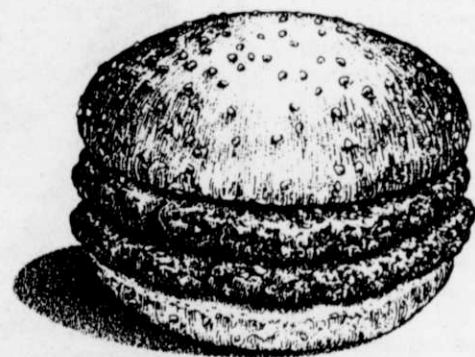

## Modern Woodmen Honor Marvin Martin



The Modern Woodmen of America honor Marvin Martin (far left-seated) for his years of dedicated service.

Marvin Arthur Martin was born June 7, 1907 in Kewaskum. He was baptized and confirmed in St. Lucas Lutheran Church by the late Rev. G. Reve.

Marvin is a life-long member of the church. He served on the church board. He attended the public schools in Kewaskum and took insurance courses at the University of Wisconsin. He served on the Village of Kewaskum board when the Pump House #2 was constructed and the Village Community Center and Library were built.

Marvin married Minerva Sommerfeld on Dec. 26, 1938 at St. Peters Lutheran Church at Fond du Lac. They are the parents of four children: George and family of Vienna, VA., Craig (deceased), Dawn of West Allis, and Dean of Brookfield, and they have seven grandchildren.

Marvin was employed at Kewaskum Aluminum Co. during the summer months while he was still in high school, which was during the depression when copper utensils were made. Marvin worked for Regal Ware for 30 years as a tool and die maker, and a total of 42 years.

He helped organize the union at Regal Ware and served as its 1st local president. He also operated the Marvin Martin Insurance Agency as a side-line, sports, travel, business, casualty, special coverage, fire and allied lines, were some of his extra coverages.

He is a charter member of the Kewaskum Kiwanis Club, organized in 1947. He had perfect attendance for 47 years of membership. Marvin served as Club President

in 1959 and later as Lt. Governor, and also served on different committees. He was Secretary of Branch 26 of Aid Assoc. for Lutherans for 45 years, serving as President of South Wisconsin Federation of local branches. He served on the Washington County Red Cross Board, and also held the position of chairman. He taught first aid for 30 years in Washington and Fond du Lac counties, through the Red Cross and Vocational School Systems.

He helped organize the Kewaskum Fire Department Rescue Squad in about 1943 and served as a member for 33 years - retiring as a Lieutenant. He was a Civil Defense Director for the Village of Kewaskum, and secretary of the CETA (Education Program). He served on both the Village and School Board in Kewaskum, also on the A.F.S. board for nine years. The Martins hosted students from New Zealand. The Columbia Student Exchange

Program hosted his son George in Lima, Peru.

Marvin is a member of the 25 Year Club of Regal Ware, the Kewaskum Historical Society, Kewaskum XYZ Senior Citizens of Beechwood and Kewaskum, and Campbellsport organizations.

Marvin enjoyed sports, camping, hunting and painting during his retirement and has toured from coast to coast, in the U.S.A., Canada and South America. He is still living a full life, as his health permits.

## Former Resident Battles Leukemia Seeking Support For Fireworks

Although almost all siblings are known to get into arguments every once in a while, it seems that deep down most brothers and sisters are willing to do anything to help one another.

John Koerble of Northfield, MN, recently discovered just how true that is. His sister, Jean Bleskacek of Wisconsin, decided to donate a significant amount of her bone marrow to him. And what's more, she's very excited to do it.

John is the son of Donald and Edith Koerble, N3887 Hwy. 67, Campbellsport, WI 53010.

"She's totally scared of needles, but she wants to do it so much. She was overjoyed when she found out she could do something to help," Koerble explained, Bleskacek will be donating a liter of bone marrow, which will be extracted by 100 punctures through her bones.

Koerble, a father of three, needs the bone marrow to replace his own because he is suffering from a rare form of leukemia, called APL leukemia. He is lucky that he has a large family, four sisters and a brother, because each sibling has a 25-percent chance of being a match. Without the marrow, Koerble said, he "probably wouldn't make it."

Yet all his siblings didn't have to go through the genetic match test. Koerble and Bleskacek previously had their blood tested because they had hoped to donate a kidney to a sister who was suffering from diabetes. Unfortunately, the sister died before she could get a transplant, but the record of the compatibility still existed.

"If you would have asked me before who I thought I was most compatible with, I would have said Jean... We get along so well," Koerble said.

Koerble was first diagnosed with leukemia just over a year ago and since then, his life has been a rollercoaster ride. The doctors gave him an experimental drug and chemotherapy, which put the disease into remission.

Unfortunately, this December the disease resurfaced. Koerble was feeling ill and he went to a local clinic to have his white blood cell counted, and the count came back very low. The leukemia mutates the white blood cells, which causes sufferers to lose their entire

immunity.

Koerble spent the month of December in the University of Minnesota Hospital. He was given more chemotherapy, radiation and finally the experimental drug, which he did not respond to well. And in February, Koerble goes back to the hospital for the more serious, and hopefully more successful, treatment.

After some extensive testing, Koerble will go through a regimen of very powerful chemotherapy and radiation. Once all of his bone marrow is killed, then it can be replaced with his sister's marrow.

Extracting the marrow may be painful. "I've only had 11 bone marrow biopsies and I can't imagine having 100," Koerble said. The marrow will be taken from Bleskacek's thigh bone while she is "under." She will probably spend only one night in the hospital to recuperate, and her bone marrow will replace itself.

"The biggest risk in a marrow transplant is that it won't recognize the body. It's the same problem with organ transplants that are rejected," Koerble explained. The marrow will be injected into his blood stream and it will work its way into his bones.

According to Koerble, it's healthy for the bone marrow to have a small rejection reaction. "My sister and I always joke about it. She says she could never fully reject me, but maybe just a little," he said.

Although his experiences have been very painful, Koerble said that some good has come from it. He is a health-care analyst and he has learned first hand how difficult the health-care system can be.

"It makes me more sensitive to how plans I've developed affect people. I think we tend to lose sight of the individuals and concentrate on facts and figures," Koerble said.

Koerble also said that the old cliches about learning to stop and smell the roses are true. There were times when he simply thought he was going to die. His wife, Linda, said that when he was first diagnosed the doctors made them think that it was going to be fatal.

"They said right away that there is this experimental drug he can take.

When we heard this, we thought it was all over and done with. That was a horrible day," Linda Koerble said. The next day, however, the doctors told them that treatments for leukemia have a good success rate.

After facing his own mortality, Koerble says he has his priorities firmly in place. "This has really changed my life. People live these lives so quickly. The most important thing to me is my family and the time I can spend helping others," he said.

Another challenge facing the Koerbles is paying for the medical bills while being out of work. To help them offset some of their burden, a fund was set up at Norwest Bank, 700 Water St., Northfield, MN 55057. Donations can be made anonymously by simply explaining that you want to give to the Koerble account.

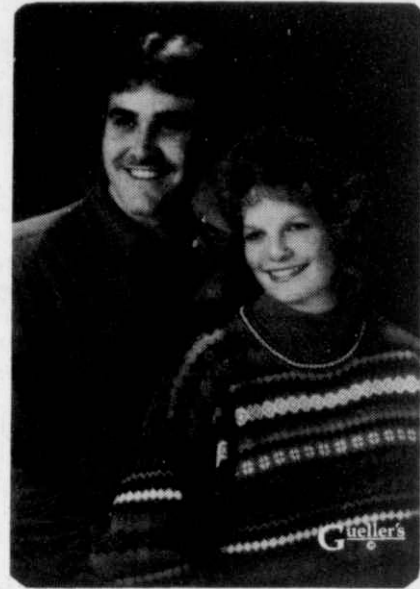

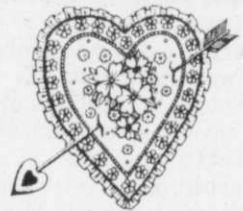

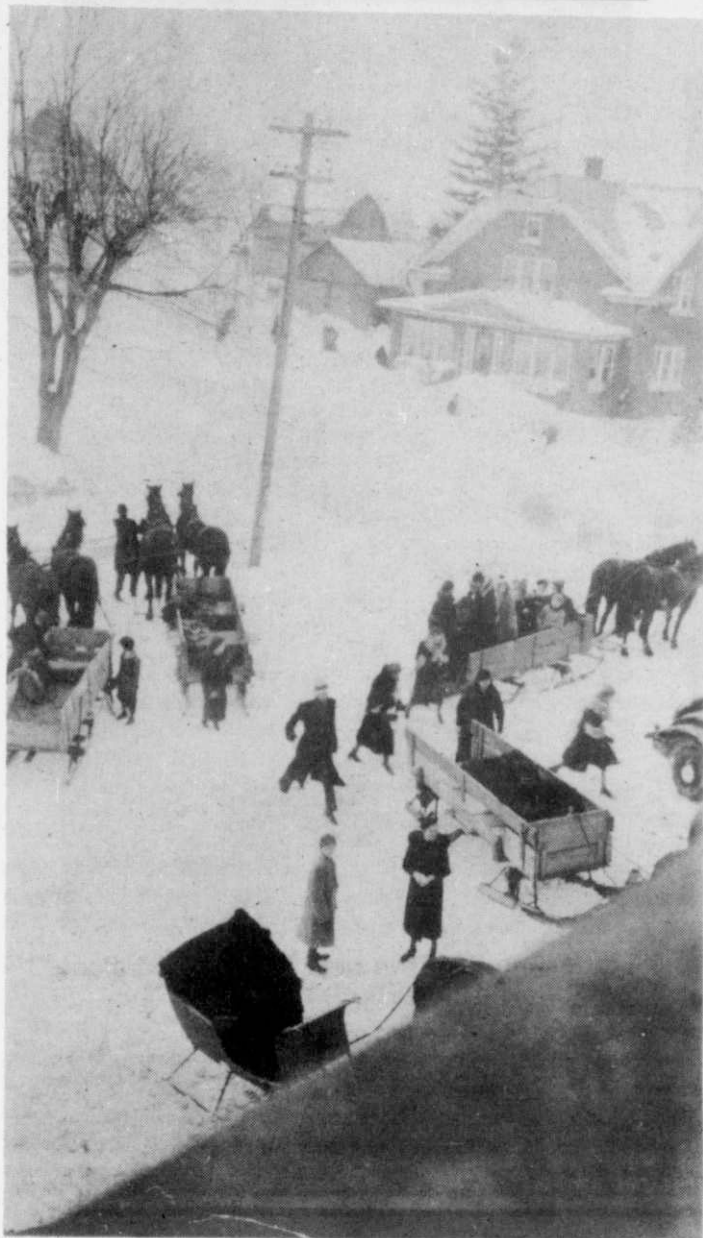

The above timely photo of the great 1936 snowstorm was submitted by Sally Reindl. The photo was taken from the roof of the Strachota's Tavern and General Store in St. Kilian, after Sunday Mass at St. Kilian Church. Travel was by bobsled and cutter and many of the roads were closed until springtime. 1936 has been referred to as the year of "The Great Heat and Great Snow" (sound familiar?), and in the midst of the depression, local residents suffered through severe weather conditions. 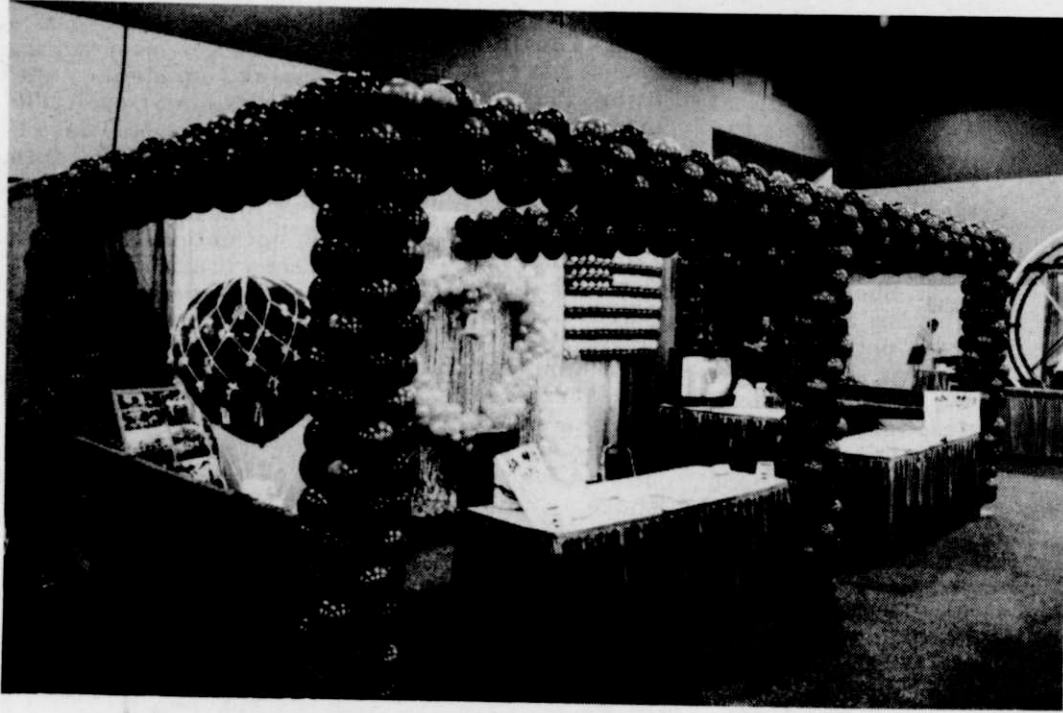

## Balloons by Brenda Features New Art Form

Brenda's Kirchner's career has recently "ballooned" into something unique and innovative, and her newly opened business is the first of its kind in the area.

Balloons by Brenda offers something out of the ordinary when it comes to gifts made out of balloons, and her artistic creations will surprise and delight the young at heart.

"I think what I do is fairly new," Brenda explains. "It's a lot more than blowing up a balloon and tying a string on it." Kirchner, from Kewaskum, is a qualified balloon artist, having completed courses in Milwaukee and Chicago to learn the trade.

It all began a couple of years ago when Brenda was looking for something different to do. She was helping her husband Robert run their dairy farm and was experiencing some back problems from the job. "I attended a trade show in Milwaukee and saw the displays by balloon artists, and that's how I got into it," she points out.

She specializes in balloon decor, bouquets, stuffing, and fruit baskets, and yes, all the fruit really are shaped from small balloons that look like the real thing. You have to see it to believe.

Her talents unleashed for weddings, anniversaries, birthday and holiday celebrations, turn banquet halls into festive fairy tales with giant balloon archways, towering candy canes, life size

brides and grooms, tropical birds, or whatever theme your heart desires. Imagine a ceiling filled with two thousand balloons tied with metallic or iridescent streamers glittering down above the crowd. The effect is impressive.

"I try to make things that are different and unique, and make them last as long as possible," she relates, and her gift items are difficult to choose from. Teddy bears, roses, candy, and more, are captured inside balloons of all shapes and sizes, nestled in confetti and dressed in shiny ribbons. Bride and groom bears, bandaged bears baring get well messages, and currently, valentine bears, fill her work room as she fills orders custom designed for that special occasion.

Kirchner uses a special treatment that makes the balloons last longer. She points out some roses in glass bud vases preserved inside opaque heart balloons. "I made this for a show three weeks ago," she explains. They still look fresh and new, sealed from the outside world. She works with both helium and nitrogen; the latter is similar to air and used for balloons not required to float.

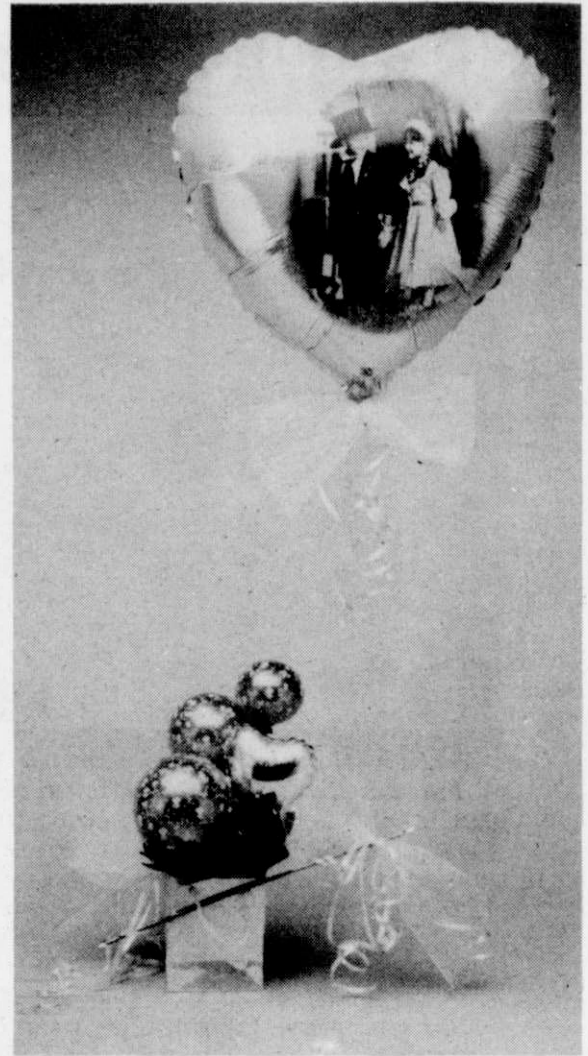
Custom colors can be created by pulling one balloon inside another, creating rich colors like burgundies and forest greens. "It's great for matching wedding colors," Brenda states. Another new item is "Verkerke" balloons, adorned with photographs printed onto the

exterior.

Large, hot air balloons reach four feet in diameter, carrying baskets filled with customer's requests. "I can work with any theme they want, and any price range," she maintains, including children's gifts made easy to afford. Stars, footballs, birds, bears, pumpkins, you name it, Brenda can find a balloon that fits the need.

Currently, she's busy filling orders for Valentine's Day, using roses and chocolates and old fashioned confectioner's jars filled with candy hearts. Those romantics out there will love her new scented balloons, and if you order by Feb. 10th delivery is free.

Balloons by Brenda is available for any party, including business luncheons, corporate parties, grand openings, or special sales promotions. As far as she's concerned, no job is too big or too small. Her sister Pam, and her husband, help out with decorating large halls to meet the deadline. With a \$15 minimum order, delivery is free in Kewaskum.



An example of the new Verkerke balloons in a display done by Brenda.

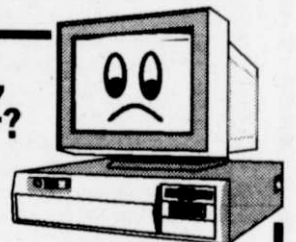

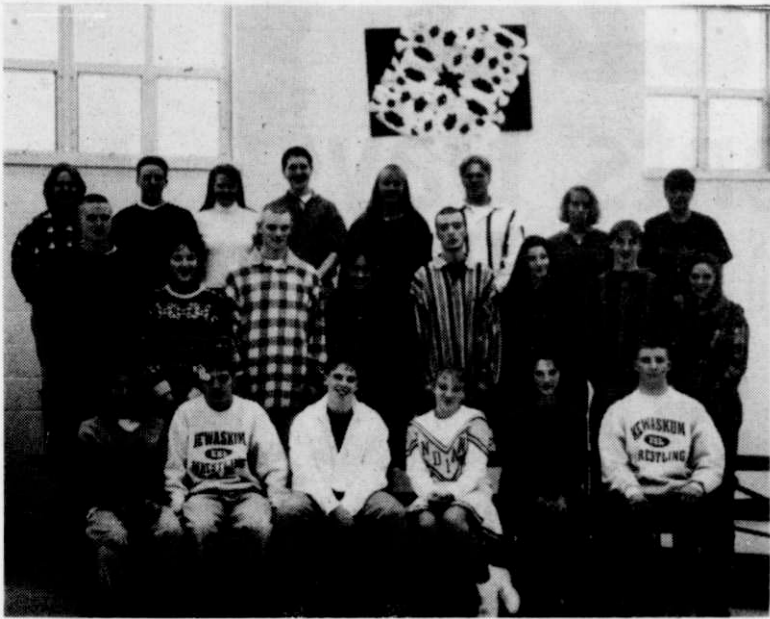

## 'Heart of Winter Mall Walk' To Help Fight Heart Disease

Healthy hearts are a family affair, according to Bob Tuszynski, chairman of the first annual "Heart of Winter Mall Walk" to raise funds for the American Heart Association's (AHA) fight against heart disease and stroke.

Sponsored by St. Joseph's Community Hospital, the five-mile walk takes place Saturday, February 10, at Paradise Mall.

Tuszynski said the walk's theme of "Celebrating Families and Healthy Hearts" coincides with Celebrate Families Week February 4-11, and points to the importance of family education and support in reducing the risks of heart disease.

"Hopefully, kids can realize there are things they can do. For instance, if they stop smoking cigarettes, it can be a big help in fighting back against heart disease," said Tuszynski, who is vice president and director of mutual funds at B.C. Ziegler and serves on the board of the Washington County Division of the AHA.

"It's going to be a nice family event. We're trying to make it not only fun, but informative. We hope to help people become more educated about the disease," he noted.

The morning's events include free blood pressure checks, free foot and

lower leg massages during the walk provided by St. Joseph's Massage Therapy Department, and heart health presentations by Dr. Robert Gibson of the West Bend Clinic and Sallie Konruff, dietitian and Manager of Food and Nutrition Services at St. Joseph's. Heart-healthy snacks will be provided by SuperSaver.

Tuszynski said his own parents' experiences with heart disease made him more aware of the risks of heart disease and the importance of diet and exercise. His dad, who died of cancer last year, had two valve replacements and his mother had bypass surgery.

"It's made me watch what I eat, and limit cholesterol. I believe very strongly in exercise, and I play basketball regularly," said Tuszynski.

Barb Knutzen, Director of Professional and Support Services at the hospital and also an AHA board member, said that the association stresses not only fund-raising but education to fight heart disease.

"This is the first main event of the year for the division, and it's also Heart Month. We're hoping for good participation from individuals, families and corporate teams, because heart disease affects so many people,"

she said.

According to Wisconsin Department of Health and Social Services statistics, 329 of the total 715 deaths in Washington County in 1994, or 46 percent, were due to cardiovascular disease including stroke. In Wisconsin, 19,075 of the 44,420 deaths in 1994 were from cardiovascular disease.

Registration fees for the walk are \$10 for adults (\$12 on the day of the walk), \$7 for children and \$30 for a family with up to four members. Registration is free with \$35 in pledges or donations. A T-shirt is included with registration.

Registration is from 7 to 7:30 a.m., with the walk from 7:30 to 9 a.m. Heart health presentations will take place between 9 and 9:30 a.m. followed by awards and door prizes. Pledge prizes include: first place, \$100 gift certificate from Kohl's; second place, \$75 gift certificate from ShopKo; third place, \$50 gift certificate from The Fast Foot. All children age 12 and under, who collect \$25 or more in donations, will receive a prize, and all who raise over \$100 in donations

will receive an AHA cookbook. Participants will also receive discount coupons on the day of the event.

### Public Meeting to Discuss Proposed Long Lake Wastewater Treatment System

MILWAUKEE, Wis. -- The Department of Natural Resources is proposing to upgrade the wastewater treatment system that serves the Long Lake Recreation area at the Kettle Moraine State Forest-Northern Unit. An informational meeting will be held on Tuesday, Feb. 13 at 7 p.m. at the Henry S. Reuss Ice Age Visitor Center. The center is located on State Highway 67 about one-quarter mile west of Dundee. Several representatives of the DNR will be on hand to give a short presentation on the proposal and to answer questions.

The proposed system includes pumping facilities and a ten-acre spray irrigation system near the intersection of Butler

Lake and Division Roads. Crops will be grown on the irrigation field to remove the nutrients in the wastewater. A groundwater monitoring system will also be installed around the system to ensure that there are no adverse impacts to the groundwater of the Milwaukee River Drainage Basin.

The proposed upgrade also includes regrading and relining of the existing ponds for stabilizing and holding the wastewater.

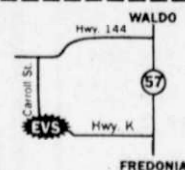

## 25 Years Ago

February 12, 1971

Two resolutions that authorize borrowing a total of \$685,000 to finance two municipal projects were given village board approval at an adjourned meeting Wednesday evening. Included is the sum of \$490,000 to finance additions and improvements to the village sewage treatment plant and \$195,000 to finance sewer and water installation in Bel-Ric Acres subdivision.

Father William Bonesho, pastor of St. Michael's Church, St. Michaels, located three miles east of Kewaskum, just off Highway 28, said, "we will rebuild." The church was entirely destroyed by fire, except for the brick walls and tower, in an early morning fire January 4 when it was struck by lightning in a freak mid-winter electrical storm. Father Bonesho reported that the congregation has designated a building committee and has begun plans for the project. It has not yet been determined whether the congregation will rebuild the old church, using the wall shell of the structure, or construct a new building.

The parish was founded in 1846 when a log church was built. In 1855 a stone church was constructed and was later replaced in 1884 by the building which was destroyed by fire early this year.

While cleaning a sidewalk at the nearby Harry Koch home, during the snowstorm last Friday morning, Brett Warner, 10, son of Mr. and Mrs. Roy Warner, 537 Habeck Street, got his mitten caught in a snowblower, which pulled his right hand into the blower and severed the tips of three fingers.

## 50 Years Ago

February 5, 1971

and Mrs. Paul Behring, a young married couple from the Boltonville area. The Behrings took possession of the business, located on Fond du Lac Avenue at the intersection with Main Street on January 1. As in the past, the business will be operated under the same name of Yoost Meat Market. Elmer and Ocelia Yoost will continue to assist the Behrings on a part-time basis.

An early morning fire Monday destroyed a guest house on the property owned by Mr. and Mrs. Ned Sengpiel in the Town of Kewaskum on CTH H, about 1 1/2 miles west of Kewaskum. The Village Board of Kewaskum, Washington County, Wisconsin, met in Regular Session in the Council Room of the Municipal Building, 204 First Street.

President Robert Wagner presided. Trustee William Kulas asked to be excused and was absent. All other Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee John Borland and unanimously carried by voice vote, the minutes of the December 11, 1995 were approved as printed.

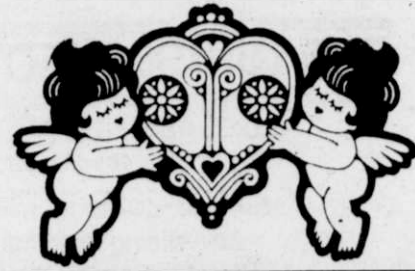

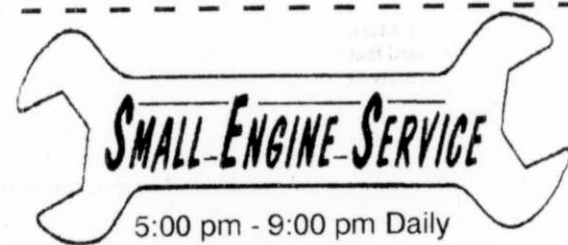
