## Every Month On This Calendar Shows 'A Glance Back' at Kewaskum's Historic Past



February's feature photo from 1910 is the former Corner Drug Store, located on the corner of Fond du Lac Avenue and Main Street in Kewaskum. The building at one point in time also housed The American Hotel.

Local graphic designer Sheila Susen has created a calendar called, "A Glance Back."

The calendar features historic photos from the village of Kewaskum. Each month highlights a different historic photo.

The month of February features a 1910 photo of the building at the corner of Fond du Lac Avenue and Main Street. Well known as The Corner Drug Store, the building was once The American Hotel, used as a rooming and boarding house for travelers. In 1881, The American Hotel was one of six hotels in the village. Records show that Nicolaus Guth, Jr. was the successor of his father, Nicolaus, in this hotel business. Guth is also listed as a lumber dealer. This landmark remains at the corner today.

Other months of the calendar feature landmarks and buildings as they once were in the early 1900's like the 1905 photo of the old sawmill at the dam on the Milwaukee River. The area

was once known as Myer's Mill, named after Mr. Jesse H. Myers. Myers constructed the primitive sawmill, in 1852. Along with H.P. Eames, Myers made the first plat of the village.

Susen decided to put together this calendar to

remind us of how the village was once a thriving trade center of the surrounding countryside. Many of the establishments have either closed their doors or have been destroyed by fire. "The

## Fire Damages Heritage Square Offices Saturday

The Kewaskum Fire Department was called out to fight a blaze that destroyed the interior roof and attic area of Heritage Square on Fond du Lac Avenue Saturday afternoon.

Firefighters were on the scene for an hour and a half, working to keep the fire from spreading down into the main floor, which houses Lori's Hair and Things Beauty Salon, McKenna Law Offices and the Steve Van Ess Dental Clinic.

The fire apparently originated in the attic space above the rest room of the vacant office and appears to have been electrical in origin, although it is still under

investigation.

"About 90% of the roof trusses are burned, and there's quite a bit of smoke damage," Dr. Van Ess stated as owner of the building. He added that the entire roof will need to be replaced.

The Dental Clinic and Hair Salon are closed while electrical and telephone repairs take place this week. Van Ess said he would be seeing patients again Friday morning, if all went well.

The McKenna Law Offices have been open since Tuesday. "We have to be," stated Bridget McKenna. "It's tax time."

Hair and Things announced they will be closed for the next four to six weeks.

## Board Commends Dept. of Public Works; Discusses Leasing Portion of Water Tower

This month's first village board meeting carried a light agenda, although Director of Public Works Jerry Gilles provided enough topics, as his crew battled extreme weather conditions the past couple weeks, and remedied some emergency situations.

Village workers will presently be concentrating on cleaning up large piles of snow that are creating visibility problems at some of the intersections around town. Gilles told the board that residents need to be reminded to make sure fire hydrants are cleared off, and easily accessible. Board President Robert Wagner publicly thanked the village workers for doing such a great job in an adverse situation, and stated it's been a rough January for everyone.

Administrator Dan Schmidt reviewed the village tax collection process, with deadlines ending last week. Although payments were still coming in through the mail, as of last week roughly 35 outstanding tax payments were not received, reflecting about 3 1/2% of village taxes, which Schmidt explained is normal. "Probably by the time we turn it into the county, it will be below 3%," he told the board.

Last month, 14 building permits were issued

including two single family homes, compared to last year's 13, which were all remodeling. This could reflect an increase in the village's growth for this year.

A discussion centered around the fact the district will take in enough money in 1996 to retire itself through the budget process. Normal retirement was scheduled for the year 2002. Bank One has agreed to handle the closure, as they were the financial institution the village dealt with in reference to bonding. There will be some close-out costs, including a required audit in 1997. The board unanimously approved the item, 6-0, with Trustee Gary Gavin absent from the meeting.

The board also approved formal action extending the village's cable franchise agreement, which expired January 5. The University of Wisconsin Communications Department is handling negotiations for the area, which were held up because of a buy-out of Star Cablevision by Marcus Cable. The University feels an agreement can be reached prior to April 16.

A preliminary resolution declaring intent to exercise special assessment police powers was approved by the Village Board, involving 150 feet of Timblin Drive that was not completed as part of the original project area. Special assessments will be levied upon properties at 241, 202, and 262 Timblin Drive, 701 and 702 Memorial Drive and 224 Bonnie Lane, for the installation of storm sewers, catch basins, street/roadway, lighting, curb/gutter, sidewalk, and other related improvements. Only four of the properties listed will have charges assessed back for curb, gutter and sidewalk, put into the budget, but Dan Schmidt related that all abutting properties are listed that the village may be working in front of.

Schmidt also asked for input on the request from a cellular phone company (Sprint) for permission to mount an antenna on the village's water tower. The village would receive \$8,000 annually for use of the space, but there were some concerns regarding the lease, and exclusive rights to the tower, which is scheduled for repainting in about three years.

The lease would include a 20 x 20 foot piece of land beneath the tower. The board agreed to look into the matter and discuss it when more information was obtained.

Other announcements included bids being sent out for a tank truck for the Fire Department, to be opened and reviewed at the Fire Station on March 2, a scheduled meeting of the Park and Recreation Committee for February 19 at 7 p.m., and a Department of Transportation Public Information Meeting on February 21, from 4 to 6 p.m. in the Community Room of the Municipal Building, to discuss improvements on Hwy. 45 from County Highways H, west to D.

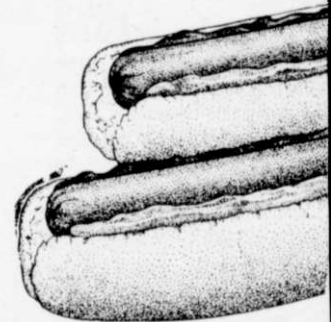

### Wisconsin State Patrol Law of the Month Left Turns Need to Be Done the Right Way

Sloppy left turns not only can raise the blood pressure of other motorists because you cut them off, they can also cause crashes. That could wreck your whole day and several more while you wait for your car to be repaired.

"When properly done, left turns can help keep traffic flowing smoothly and avoid unnecessary interaction with other traffic," said Trooper Joan German of the State Patrol's district office in Fond du Lac. "When done poorly, they could increase interaction between vehicles, causing other motorists to take evasive action. That could endanger you and others."

Trooper German said that when making a left turn from a two-way street onto an intersecting two-way street, a motorist should turn into the lane immediately to the right of the center line or dividing island. The only exception to this is if two left turn lanes are marked. Then you should stay in your proper lane.

"After making your turn," Trooper German said, "if on a multi-lane roadway, you should move to the right lane as soon as safely possible. That will get you out of the 'fast lane' and allow you to accelerate to the proper speed without interrupting traffic flow in that lane."

"If turning left from a

two-lane street to a one-lane street, motorists should turn onto the traffic lane closest to the left-hand curb or edge," Trooper German said.

If convicted of making an improper left turn, you are subject to forfeitures and court costs totaling \$116.90 and three demerit points against your driving record.

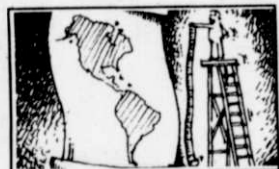

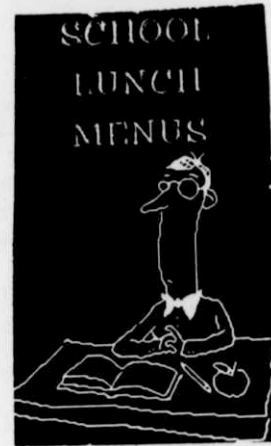

## WB Art Museum to Celebrate 35th Anniversary with Dedication, Unveiling

The West Bend Art Museum is celebrating its 35th anniversary on Feb. 18th with a building dedication and the unveiling of a complete reorganization of its collections.

The museum will be closed from Feb. 12 to 16th in preparation for the reorganization and the Sunday dedication which begins at 1:30 p.m. with remarks from Sharon Ziegler, the President of the museum's governing board.

Joan Marr Pick who together with her family founded the museum in 1961 will be recognized for the generous contribution that allowed the museum to complete the building addition last year.

The addition added over 3,000 square feet to the museum which is used for collections' storage, exhibition shipping and receiving, business

office, maintenance work space, a class room and rest room facilities. All spaces will be available for public viewing after the program. The addition was designed by Tom Van Dalen of Van Dalen & Association and built by Doede Construction of West Bend.

Chairman of the Friends of the Art Museum, Eric Lund, will recognize several other individuals and groups including Friends of the Art Museum who have held that status for 20 years or longer.

The program will conclude with the unveiling of the museum's recently acquired and restored painting, ADORATION OF THE CHRIST CHILD, by Carl Von Marr. Adoration of the Christ Child measures seven feet and 10 inches by 13 feet and three inches and is in its original

gilded wood/gesso frame. It is the second largest framed canvas known to exist by Marr and was acquired by the West Bend Art Museum with funds donated by the estate of Constance E. Dentzler and with memorials given in her memory. Dentzler was a weaver and long-time board member of the West Bend Memorial Foundation which operates the museum.

Tours and refreshments will be available after the program. The public is invited to attend.

## Retiring Hospital Director O'Meara Reflects On Changes in Paying for Health Care

In his 16 years on the Board of Directors of St. Joseph's Community Hospital of West Bend, Stephen O'Meara has seen many changes in the way health care services are delivered. Hospital stays are shorter. The number of outpatient procedures has increased. People demand more health and wellness services, and technology makes more of those services possible.

But a dramatic change is also happening today, according to O'Meara, in the way people pay for health care services.

O'Meara reflected on that change, following his recent announcement of retirement from the board.

"The big change is that we

are going from a fee-for-service to capitation system. With fee for-service, a doctor or health care provider gets paid what they charge for services they provide. With capitation, everyone who belongs to an HMO, or organization similar to it, pays the same amount, no matter how many or how few medical services they use," said O'Meara.

On a local level, the change to "capitation" or managed care will help St. Joseph's fulfill its stated mission in developing a community-based health delivery system, and will provide needed restraints on rising health care costs for employers and patients alike, according to O'Meara.

As the hospital develops a managed care concept for the community and works with employers, physicians and other providers of care, the hospital will be able to hold down costs and continue to provide a high level of services, O'Meara observed.

"We're now in the midst of a change over from fee-for-service to capitation, and because this involves a different transfer of funds for the services, it causes apprehension by everyone in the health care field, because they don't know exactly how they're going to be paid and how they're going to be serviced by the HMOs," said O'Meara.

But he believes the

changes are needed.

As an independent, not-for-profit hospital, St. Joseph's Community Hospital historically has been able to hold down patient care costs, O'Meara said. The hospital wants to continue to be the low-cost health care facility in Southeastern Wisconsin.

O'Meara, 78, practiced law for over 50 years in West Bend and retired in 1991 from the firm of O'Meara, Eckert, Poulos and Gonring. He attended the University of Notre Dame and received his law degree from the University of Wisconsin. During his tenure on the hospital board, he was a member of the Audit and Finance Committee, chairman of the Nominating Committee and, since 1994, was a member of the Forward Planning Committee, helping the hospital to set its strategic plan and direction for the future.

O'Meara participated in numerous major accomplishments for the hospital over the years, among them the \$8 million expansion in 1989, the addition of new outpatient and emergency areas and the New Life center, and the addition of advanced technology, specialized services and wellness programs.

In a January 23 resolution honoring O'Meara, the hospital's Board of Directors said O'Meara provided vital leadership for the hospital and helped ensure its continued success and financial viability.

As chairman of the nominating committee, he provided important leadership in guiding the board's education and professional development and preparing for director and officer succession,

the board's resolution stated. O'Meara and his wife, Virginia, raised seven sons and have 13 grandchildren. Virginia has also served the hospital and is currently president of the St. Joseph's Community Hospital Auxiliary.

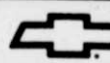

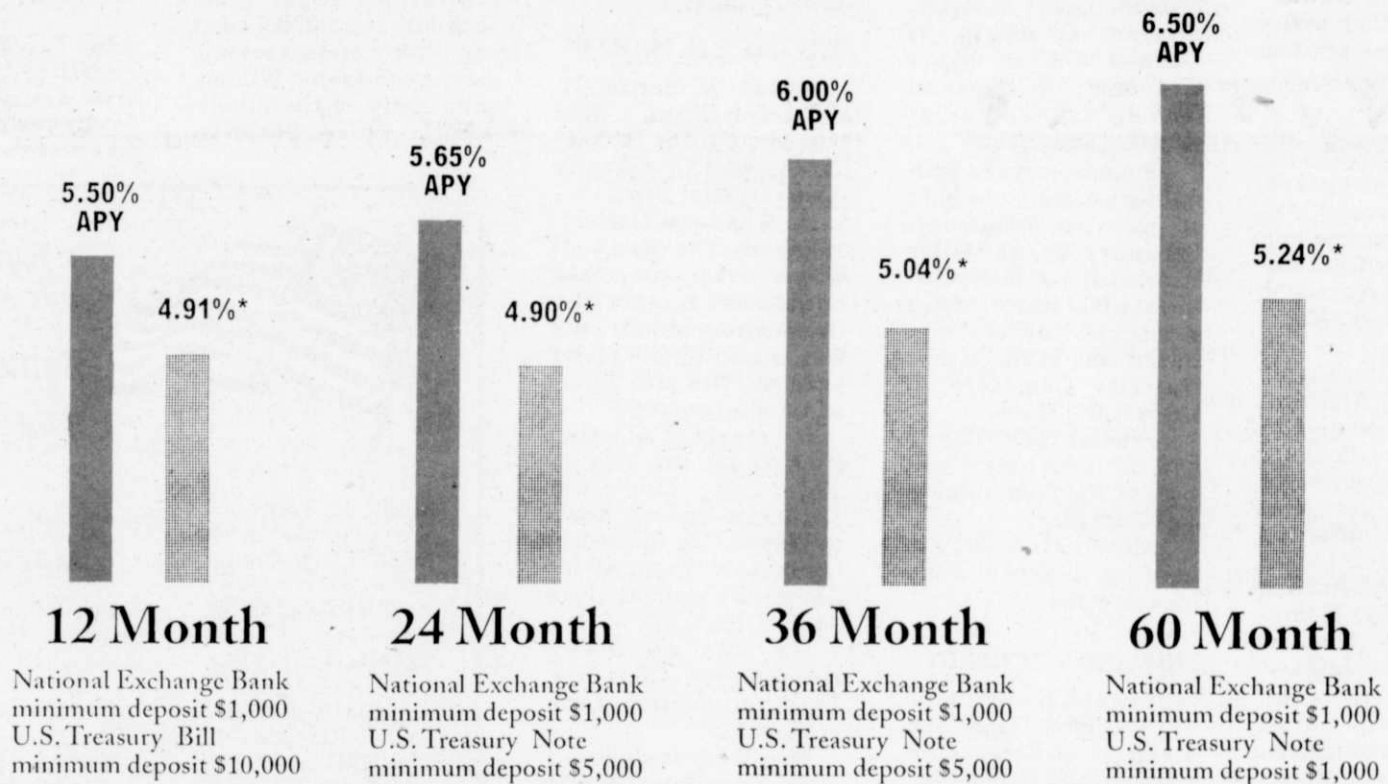

## Village Board Meeting Minutes

Mid-Monthly Meeting  
January 22, 1996  
8:00 p.m.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Mid-Monthly Session in the Council Room of the Municipal Building, 204 First Street.

President Robert Wagner presided. All Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee John Borland and unanimously carried by voice vote, the minutes of the January 8, 1996 were approved as printed.

A public hearing on the request to change School Street to a one-way traveling northwesterly was conducted. Neal Weare and Jeanne Goeden were present from the School Board. Charles Kleinke was present from Johnson Bus. David Bath, a resident adjacent to the street, was present. John Meiser and Joyce Wagner were also in attendance. Everyone spoke in favor of the change and all realized possibly more action was needed to make the situation even safer for all involved. On a motion by Trustee Robert Stoltzmann, seconded by Trustee William Kulas and carried by the majority roll call vote, the Board closed the public hearing. Roll call vote was 7 "Aye," 0 "Nay," 0 "Absent."

On a motion by Trustee Robert Stoltzmann, seconded by Trustee Harry Roecker and carried by the majority roll call vote, the Board suspended the rules to take action on the request to change School Street to a one-way street traveling northwesterly. Roll call vote as 7 "Aye," 0 "Nay," 0 "Absent."

On a motion by Trustee Gary Gavin, seconded by Trustee William Kulas and unanimously carried by voice vote, the Board changed School Street to a one-way street traveling in the northwesterly direction. The street will officially become one-way on February 5, 1996.

It was noted the re-bidding of the fire tank is proceeding and should be in the mail later this week.

The police spending, statewide comparison reveals that the state-wide per capita for 1994 was \$128.67 per person and the average in the Milwaukee area suburbs was \$151.52 per person. In the Village of Kewaskum for 1994 the police spending per capita was \$116.35 per person.

2) Review of Taxpayer and League bulletins.

3) Review of upcoming Mid-Moraine Municipal Association meeting.

4) Review the garbage and recycling counts for 1996 and projected cost.

5) Review of record of building permits for 1995. Single family permits were up by 5.6% residential in general were up by 16%. Mercantile in general dropped by 40%, but permits overall reflect an overall 5%.

6) Review of a news notes fireworks alert in reference to community support.

Chairman of the Administrative Committee, Robert Stoltzmann reviewed an insurance matter of the extension of the Umbrella Liability coverage over the Linebacker policy. The cost for said coverage is \$1,550.00. On a motion by Trustee John Borland, seconded by Trustee William Kulas and unanimously carried by voice vote, the Board rejected adding additional coverage over the Linebacker policy at this time.

Chairman of the Parks and Recreation Committee, Gary Gavin reviewed the committee meeting which was held earlier in the evening. It was the committee's recommendation to approve the portable toilet contract with Schulties Sanitation, the low quote of \$62.50 per unit. Also the committee recommended adjusting the summer/recreation employees pay by an estimated 3.5%.

Survivors include his parents of Campbellsport; one brother, James of Lomira; and one sister, Karen Burgert of Campbellsport.

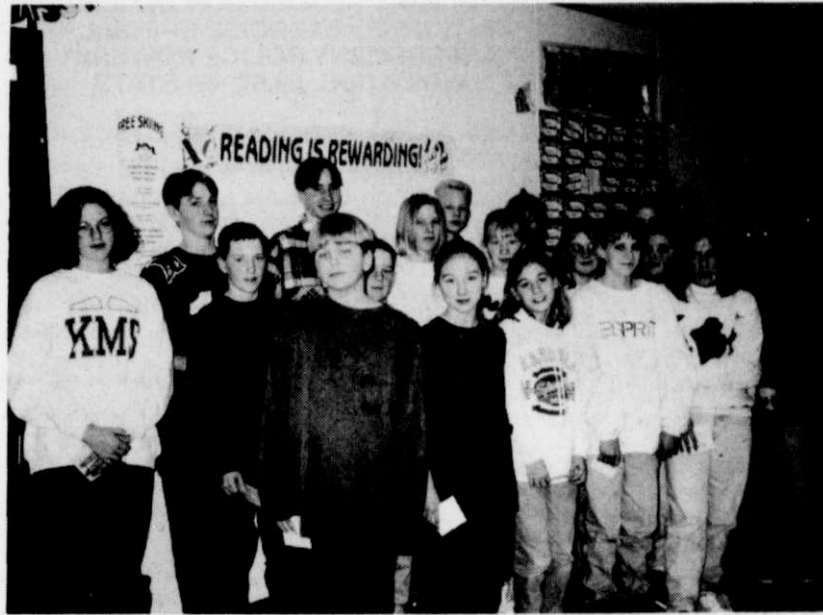

1. The Village Board hereby declares its intention to exercise its power under Sec. 66.60, Wis. Stats., to levy special assessments upon property within the following described area for special benefits conferred upon such property by improvement of the following streets:

2. The public improvements shall be the installation of storm sewer, catch basins, street/roadway, street lighting, curb/gutter, sidewalk and other related improvements deemed necessary by the Village of Kewaskum, Village Engineers of the Village of Kewaskum and other related specifications contained in Section 8 of the Municipal Code of the Village of Kewaskum and under the Village Engineers specification for utility and street improvements. The improvements will basically take place on Timblin Drive (west end) and Memorial Drive (south end).

3. The total amount assessed against the properties in the defined assessment district shall not exceed 100% of the total cost of the improvements. The Village Board determines that the improvement constitutes an exercise of police power and the amount assessed against each parcel shall be based on the lineal footage of said parcel on Timblin Drive and Memorial Drive.

4. The assessment against any parcel may be paid in cash or in annual installments the number of which shall be determined at the public hearing on the proposed assessment.

5. The Village Department of Public Works, Administrator, and Village Engineer shall prepare a report which shall consist of:

- Preliminary or final plans and specifications for the improvements.
- An estimate of the entire cost of these proposed improvements.
- Schedule of proposed assessments against each parcel.

6. When the report is completed, the Village Department of Public Works and Village Engineer shall file a copy of the report with the Village Clerk for public inspection.

7. Upon receiving the report of the Village of Public Works, Village Engineer, the Clerk shall cause a notice to be given stating the nature of the proposed improvements, the general boundary lines of the proposed assessment district, the time and place at which the report may be inspected, and the time and place of the public hearing on the matters contained in the preliminary resolution and the report. This notice shall be published as a Class 1 notice and a copy shall be mailed at 10 days before the hearing to every interested party.

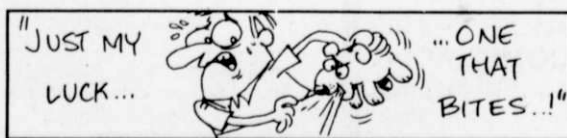

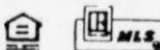

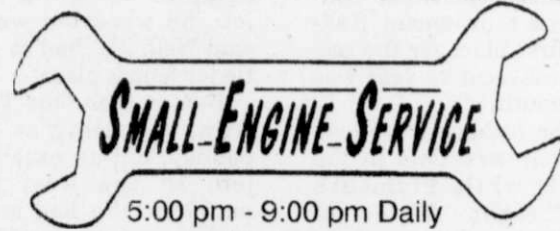

## Dziedzic, Olla, Gundrum Are EW Conference Wrestling Champions

The Kewaskum wrestling team tied for second place with Chilton at the Eastern Wisconsin Conference tournament. Taking first place for the second consecutive year was Plymouth.

The Indians placed six of their wrestlers in the finals while Plymouth had eight. Three of Kewaskum's wrestlers won in the finals while all of Plymouth's wrestlers won.

At 103 pounds, freshman John Immel wound up with sixth place. "John has really come around for us," said Coach John Nell. In John's first match, he lost to a kid from Chilton. "The match could have gone either way," stated Coach Nell.

Josh Dieringer, who dropped from 119 pounds to 112 pounds, pinned his first opponent. In the semi-finals, Dieringer ran into Jason TenPas of Plymouth. "Josh wrestled real tough," stated Nell. In Dieringer's consolation match he pinned his opponent in a quick :12 and finished with third place.

Freshman Adam Shileny, who dropped down to 119 pounds after wrestling most of the season at 135 pounds, wrestled real tough according to Nell. "He did a nice job."

At 125 pounds, returning conference champ Joel Dziedzic had a bye in the first round, and then in the semi-finals he wrestled Mike Broker of Chilton. Dziedzic beat him 20-9. In the finals, Dziedzic ran into Chad Marti of Sheboygan Falls. Dziedzic wound up pinning him in the second period. "Dziedzic is looking tougher and tougher," said Nell.

At the next weight class, 130 pounds, sophomore Troy Staehler wound up with a fifth place finish. Troy had a very tough bracket losing to DJ Fellows of Plymouth. Winning the 130 pound weight class was Chilton's Nathan Kleinhans. Also taking fifth for the Indians was Josh Sterr at 135 pounds. Sterr wrestled really tough losing to Scott Huber of Kiel.

At 140 pounds, the Indians has senior Joe Hawig. Hawig beat his first opponent Shawn Berzinsky of Two Rivers. In the second round, Hawig ran into Sheboygan Falls' Shawn Carpenter, the number one

seed. Then in the consolation match for third place, Hawig lost by default. "Joe did a nice job, he wrestled well," said Nell. Joe had to settle for fourth place.

Senior standout Tony Olla, wrestling at 145 pounds, did an excellent job. In the first two matches Olla had a bye and then he beat Mike Nolan from Chilton. In the finals Tony had to face Dennis Meyer of Kiel. Olla lost to Meyer earlier in the year, 14-6.

This time it was a different story. Olla wrestled very well and ended up with a conference championship winning in the finals by a score of 7-2.

At 152 pounds, Erik Kopecky had a good day ending up with a second place finish. Erik also had a bye the first round and then in the semi-finals he wrestled Nick Bonde of Kiel. Erik beat him pretty handily by a score of 12-4. In the finals, Kopecky ran into Russell Fuerst of Ply-

mouth. Kopecky lost to him for the second time this year, by a score of 9-1.

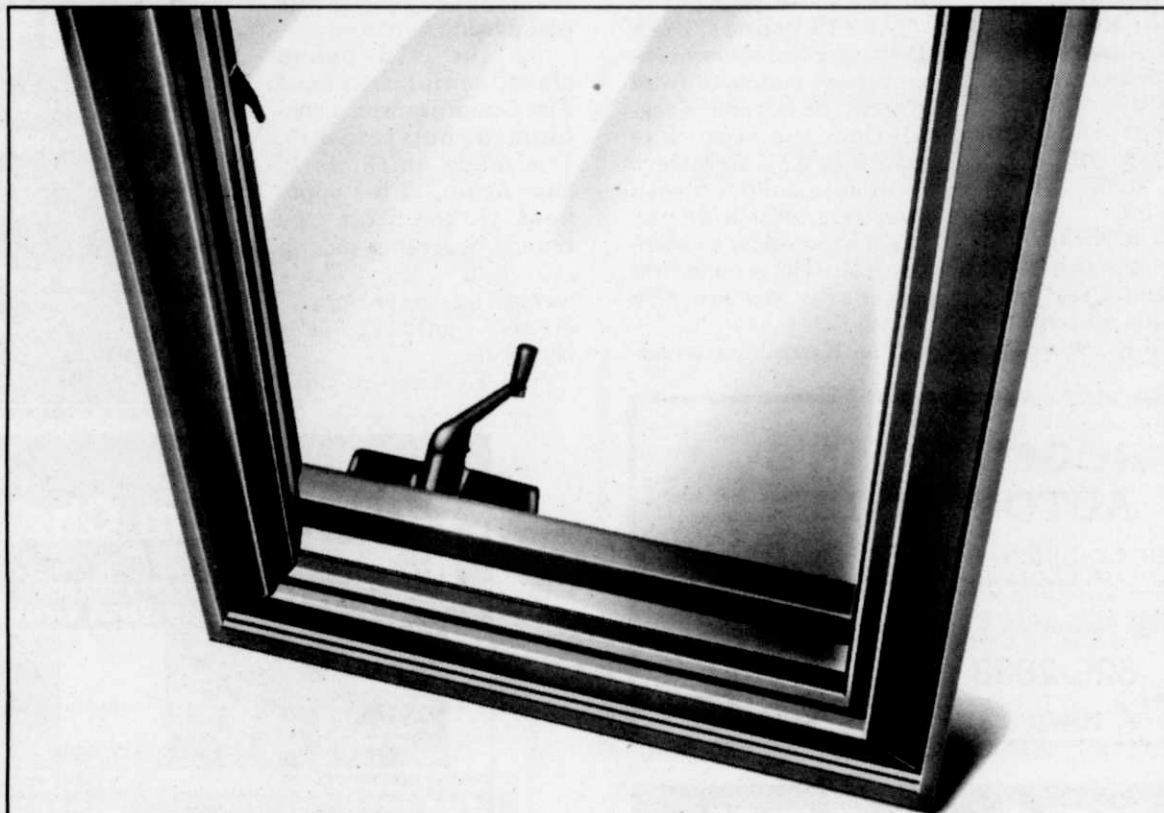
