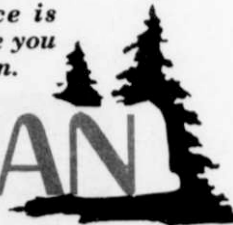

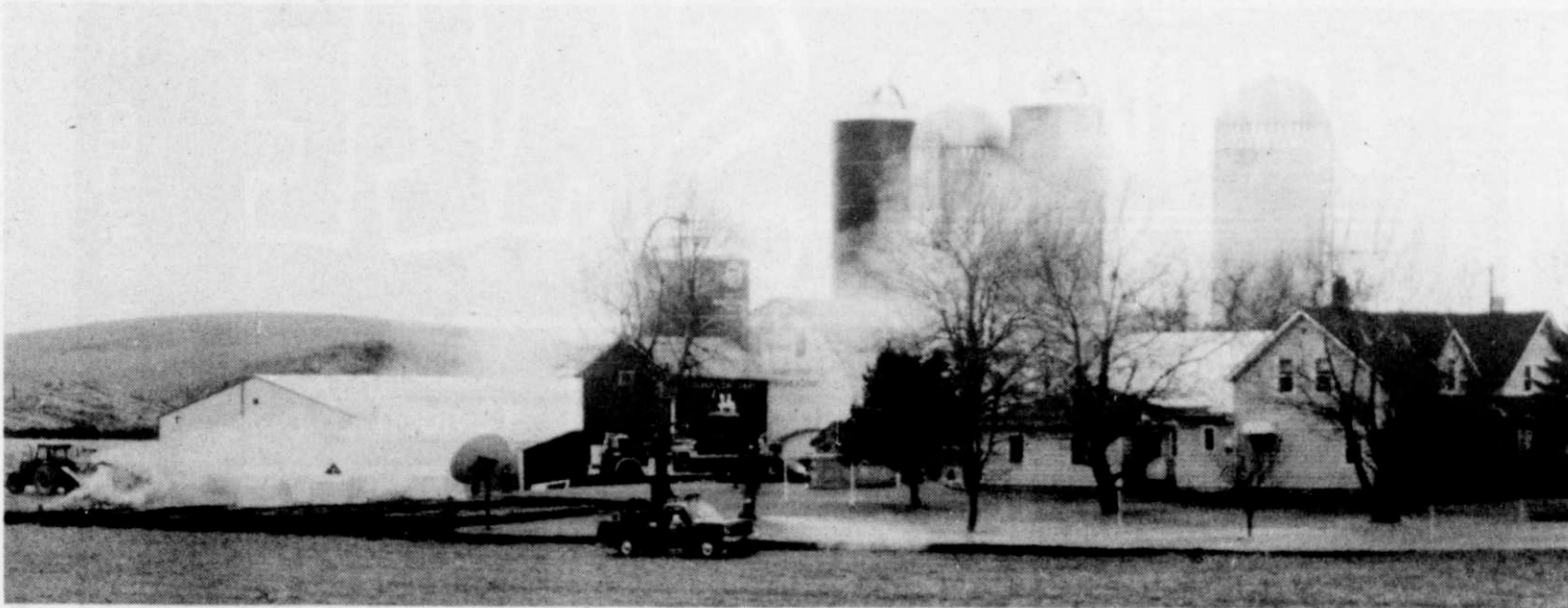

## Numerous Grass Fires Snuffed Out Saturday

The Washington and Fond du Lac County Sheriffs' Departments were inundated with a massive amount of grass fire calls on Saturday, March 23.

Washington County fire-

fighters from Kewaskum, Kohlsville, Boltonville, Fillmore, Newburg, Allenton, Richfield, Slinger, St. Lawrence and Hartford were paged out 16 times on fire calls just in Washington County alone.

There were two runs made in the Town of Farmington,

one in the Town of Kewaskum, two in the Town of Addison, three in the Town of Erin, two in the Town of Hartford, two in the Town of Richfield, two in the Town of Trenton and one each in the Towns of Jackson and Polk.

In addition, area fire departments were called to

Fond du Lac County and on mutual aid to Dodge County. Fond du Lac County had a total of 17 fire calls on Saturday.

The Kewaskum Fire Department answered three calls including the above

grass fire approaching the Henry Oppermann farm at W908 Auburn Ashford Road just prior to 3 p.m. on Saturday. Firefighters were on the scene nearly two hours before the fire was contained.

## Custom Wood Designs Moves to Kewaskum

Business is booming for Jeff Olsen these days. In fact, it's been so good he's had to relocate into larger facilities

three times in the past year.

The last move brought him to Kewaskum, where he recently set up shop at 885 Prospect Drive, the building previously occupied by

Leitheiser Car Company.

Owner of Custom Wood Designs, Jeff is still in the process of putting everything in its place, in-between finishing his custom furniture orders for retail stores located in Mequon and Brookfield. "Since March 1, we've been running so much production, there's not much time to arrange the store or business," he maintains.

"I've always loved working with wood, beginning with classes I took in high school," Olsen explains. Originally from Bonduel, Jeff and his wife Mary, moved to the West Bend area five years ago, with plans to open a business of their own. The couple worked together at KMC Stampings in Port Washington, where Mary is still employed. After earning a degree from MSOE, Jeff worked as KMC's inside sales manager, but a year and a half ago he ventured out to try his hand in the business of building and designing custom furniture and wood cabinets.

Olsen's clientele includes commercial, wholesale, and

retail customers, and he plans on concentrating more on the retail end of things now that he's at his new location. "By the end of this year, we should be working 50% wholesale/50% retail," he points out.

The front showroom of the building will be turned into a retail section, and the back half has been serving as his workshop since March 1.

Custom Wood Designs features hand-crafted entertainment centers, bunk bed systems, bedroom and office furniture, and kitchen and commercial cabinets and countertops, which include complete installation. Customers can order custom designed pieces, or choose a standard item, but change the dimensions to suit their needs, or pick the color of the stain to match the interior of their home.

"Clients can come in with an idea, and we can work out the specific design for them," Olsen states. "It's basically whatever the customer wants." One of his recent jobs included building all new showcases for Husar's

House of Fine Diamonds in West Bend.

With 3,500 square feet of working space, which is three times bigger than his last business location, Olsen has added new equipment, and works with one full time and one part time employee. By summer, he plans on hiring an additional full time employee.

His wife, Mary, will be running the retail end of the business, with the showroom slated to open this May, as well as the book work. The couple have a 17-month-old son, Cameron, and Jeff hopes to make this a family business. "It's something I'm setting up for our children's future," Olsen said. They also plan on moving to Kewaskum sometime in the near future.

Jeff is also an active member of the West Bend Jaycees, and promotes the work the organization is well known for.

Custom Wood Designs is open from 7:30 a.m. to 4 p.m. five days a week, and weekends by chance. For more information call 626-8009.

# Town of Kewaskum Adopts Land Use Plan

The Kewaskum Town Board, after months of meetings and public input unanimously adopted a land use plan this past week that will take the Township into the first decade of the 21st century.

The plan as adopted, has as its goals, the following objectives:

1. Protect the Town's agricultural lands and farming operations.
2. Maintain and enhance the rural landscape.
3. Accommodate residential development in areas designated for rural housing.
4. Provide for commercial and industrial development in designated locations.
5. Preserve the environmental resources.
6. Protect the Kettle Moraine State Forest.
7. Maintain the existing boundaries in the Township.
8. Maintain a safe transportation system through cooperative planning with county, state and local officials.

Basically the plan includes six districts. District One or the agricultural preservation district preserves prime agricultural lands. It limits lot size to 35 acres and includes nearly all of the west side of the township and the southern tier of sections to the east.

District Two includes the open space areas mainly surrounding the Kettle Moraine State Forest and limits lot sizes to a minimum of five acres in the environmentally sensitive areas and three acres minimum outside of those areas.

District Three provides for residential development with one to three acre minimums and basically surrounds the Village of Kewaskum.

This district is consistent with the Village's proposed land use plan providing for Village extension into the Township as development becomes appropriate.

District Four provides for business development and this includes lands along Highway 45 north and south of the Village of Kewaskum.

District Five is called the public land district and relates to forest lands managed by the Wisconsin Department of Natural Resources. While the Town has no direct control over these properties, the district provides for policies related to land adjacent to the forest or future acquisition.

District Six is the commercial recreation district and includes areas such as Sunburst Ski Hill and the Hon-E-Kor golf course. Permitted uses in this district include parks, rustic campgrounds and golf courses.

While it is impossible to please everyone in developing a land use plan, this plan represents the feelings and beliefs of a majority of the Township residents who responded to public survey and attended the information and monthly Plan Commission meetings.

The Town Board and Plan Commission were assisted in developing the plan by Camiros and Associates of Madison, a professional consulting firm.

The Plan Commission and Town Board will now contract to re-write the current zoning ordinance to reflect the changes adopted in the land use plan. Once this is completed by late June, another public hearing will be held prior to adop-

tion. Other changes will include the following: In May, the Plan Commission will increase to seven members. Five citizen members will be appointed by the Town Board, along with two Town Board members. The Board of Appeals will

also be increased from three to five. The Board handles all appeals on building permit applications which have been denied by the building and zoning administrator.

## Chemistry Demonstration Presented to Students



Four hundred third, fourth and fifth graders from Wayne, Farmington and Kewaskum Elementary Schools were given a noisy and bubbly chemistry demonstration on Wednesday, March 13, by Dr. Gery Essenmacher from the University of Wisconsin - Madison.

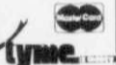

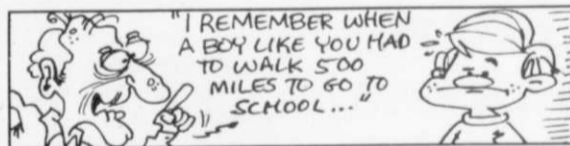

### March is Healthy Baby Month

This month has been declared Healthy Baby Month by Governor Tommy Thompson and is being promoted statewide by the Wisconsin Alcohol, Other Drug and Pregnancy Work Group. The aim of this annual campaign is to make citizens more aware of Fetal Alcohol Syndrome, (FAS), the dangers of tobacco and other drug use during pregnancy and ways

to prevent harm to the unborn child.

FAS is one of the nation's three leading causes of known birth defects with accompanying mental retardation. Other fetal alcohol effects include infant irritability and hyperactivity. FAS is caused by the consumption of alcohol during pregnancy. No one knows exactly how much alcohol causes these problems.

Alcohol-related birth defects cannot be cured. However, they can all be prevented if women do not drink during pregnancy, and if they receive help if they have a drinking problem.

Tobacco and other drugs such as marijuana and cocaine are also harmful. They can endanger the pregnancy and the newborn's health causing low birth weight, premature birth and

other health problems.

It is important for all people of childbearing age to be aware of the dangers that alcohol, tobacco and other drugs pose to the pregnancy, the woman, the fetus and the health of the newborn. Pregnant women and their partners should be informed about the dangers of using alcohol, tobacco, and other drugs during pregnancy. There is help available for those


who require intervention of a caring health professional for treatment to deal with alcohol, tobacco and other drug problems.

The COUNCIL on Alcohol and Other Drug abuse of Washington County has informational materials and videos available on the effects of alcohol and other drugs on pregnancy. Trained, professional staff members are available to address these issues with your business, professional or civic group. ## Dear Editor:

I don't have a degree in education. I'm not "college educated." I'm not a member of a group. I do have common sense, logic, a freshman son at KHS struggling with Dyslexia (which is still not taken seriously), and a sixth grade son at KMS, who earned a 3.58 grade point average for the second quarter.

The following are observations I've made and experiences I've had over the years of my kids' attendance in Kewaskum schools:

Rote learning (memorization) - It's boring. It's not fun. Is there another way to learn multiplication tables? Or how about the chemical symbols for the elements on the Periodic Chart for the Physical Science class recommended for freshmen? Memorization skills take practice.

Spelling - In elementary school we don't want to inhibit or discourage creativity by correcting spelling. So we let children spell the way they think a word would be spelled. In middle school, "the computer has spell check." My oldest son especially, is very creative. In high school, his creativity nor a computer spell check helps him one bit when he loses 1/2 points for spelling errors on tests. Is spelling important or not? Good spelling takes practice.

Cursive writing - Unnecessary? My kids learned cursive writing during the second semester of second grade. During third, fourth and fifth grades there were some penmanship papers done, but it was pretty much up to the students if they wanted to "write" or print their work. My sixth grader is now being docked points because he forgets to use cursive in

some of his classes. To be proficient in cursive takes practice.

Computers - My oldest son had keyboarding for a semester in sixth grade. He didn't master it. In seventh and eighth grades he used the "hunt and peck" method for assignments that required a printed copy. This was fine and dandy. Speed isn't important. As a freshman, he is taking Computer Literacy, but because of his "unfamiliarity of the keyboard," it is impossible for him to succeed in this class. He will retake this class after he has received private tutoring in typing.

Inflated grades - The high school wants to know why my son's difficulties are being dumped on them. Looking back at middle school report cards and finding Bs and Cs, another administrator informed me that he had been given "inflated" grades. What a great idea! How do I know my sixth grader is getting the preparation he needs for high school?

School-to-Work, Co-Op, Apprenticeship - Designed for non-college bound students. I recently met with Administration to get information on the apprenticeship program for my freshman son. After looking at his grades, it was determined that he wouldn't be a candidate for the Apprenticeship Program. Rather than tell us what would be needed in order for my son to qualify and try to encourage him, my 15-year-old was written off as not good enough. What I do know about the Apprenticeship Program is that it was set up to give non-college bound juniors and seniors an opportunity. There is a lot of funding being paid to the schools and businesses to participate in these programs. But somehow, someone got the idea that only students with top scholastic achievement would be acceptable candidates. This leads me to believe that unless a student is self-motivated and self-directed by the time they're freshmen, they're not worth further time and attention.

Has anyone else noticed any of these conflicting philosophies as their children move from grade to grade or from school to school, within the same district no less?

I agree that the basics of reading, writing and arithmetic are not enough for the 90s, but they are the basics no

matter what the year. These basics still need to come FIRST. If there are not enough hours in a day to have students read aloud to make sure every student can READ, computers can wait.

I know some of us "computer illiterates" have been led to believe that kids need to be plopped in front of a computer as soon as they can sit at a desk in order to get a job when they graduate. It's not that complicated! With a "focus" on keyboarding and instruction of a good program at the fourth or fifth grade level, a student could be proficient on a computer in one semester. He would have the "basics" down pat and still learn the computer in plenty of time to gain experience doing reports, etc. in middle school.

I am not criticizing teachers. Each teacher is doing what they believe to be right for their class. But what about the expectations of future teachers? This all needs to fit together. My son has jumped from "feel good about yourself no matter how you perform," to "welcome to the real world -- ready or not" in high school. He was not prepared.

I understand the curriculum is being overhauled. I've been hearing that for almost four years. Some things to keep in mind while this is being done:

We've got to stop teaching them survival skills instead of giving them the skills, excitement and motivation to continue their schooling; we need to make sure our kids have the skills to get through school successfully before we worry about sending them off to work; and we need good, thorough "basic" education courses throughout high school instead of a watered down version of

a technical school curriculum at the high school level.

You've heard the saying, "What the kids learn today is obsolete tomorrow." That may be true of a lot of things, especially in the world of technology. But with a good foundation of reading, writing and arithmetic, our kids will "feel good" because they will feel secure and confident and can learn anything, anytime! Even computers!

Some changes need to be made and with each school board election I'm hopeful. If the new members are as logical and common sensical as they appear, maybe now is the time. If they are considered to be radical, I guess I'm a radical too.

Mr. Goeden had lunch with the students and had a clever and fun way to demonstrate the steps necessary to deal with a customer who is looking to have car repairs done.

According to Mr. Goeden, public relations and customer satisfaction is a big part of his business so he had the students role play and learn about the steps necessary to get a car repaired and have a happy, satisfied customer.

John Q. Public drove his 1994 Toyota car in with a damaged front end. Mr. Goeden demonstrated how he deals with the insurance agent, the parts store distributor, and the paint store owner to properly fix Mr. Public's car. He purchased the parts, fixed the car and then demonstrated how to mix the paint to match.

Using a formula card and help from the students, he actually measured ingredients and mixed paint the correct color for a 1994 Toyota. As a result of winning the district title, Kewaskum now advances to Regional tournament competition at Beaver Dam this weekend.

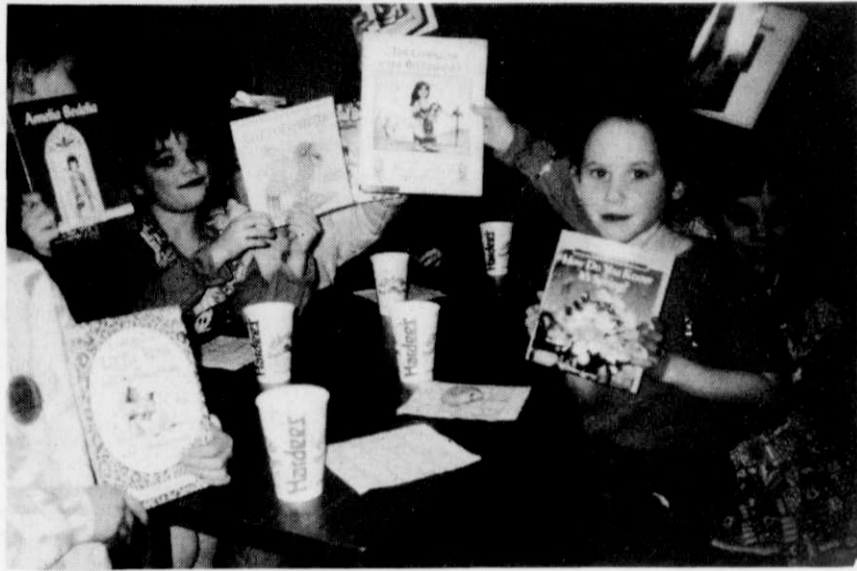

The Village Board of Kewaskum, Washington County, Wisconsin, met in Regular Session in the Council Room of the Municipal Building, 204 First Street.

President Robert Wagner presided. Trustee William Kulas and Trustee Harry Roecker asked to be excused and were absent; all other Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee John Borland, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote, the minutes of the February 19, 1996 meeting were approved as printed.

President Robert Wagner and the entire Village Board asked the Administrator to talk with the Fire Department to see if it would be possible to get a copy of their monthly meeting minutes. This would help keep them more informed as to the happenings of the Department.

Chief of Police Richard L. Knoebel asked for authorization to advertise for sale the 1994 squad car. On a motion by Trustee Gary Gavin, seconded by Trustee John Borland and unanimously carried by voice vote, the Board authorized the advertising for sale of the 1994 Chevrolet squad car.

Director of Public Works, Jerry Gilles informed the Board of the following:

1) Two street lights on Fond du Lac Avenue are out of service because of burnt off wires. It was further noted the one light pole at the Main Street and Fond du Lac Avenue intersection will need to be replaced.

2) On March 2, 1996 a water main break was repaired on Clinton Street adjacent to Shefond Mobil.

3) The bids for the purchase of a new lawn mower were reviewed with the Board.

It was noted the revenue side of the budget came in at 2.9% better than budgeted, while the expenditure side came in at 5.7% better than budgeted. With the amount of money used from the restricted fund the retained earnings is down as well as reserved funds. The TIF Fund did well with a retained earnings of \$219,992.09. The Water Utility Fund did well with a retained earnings of \$98,734.14. The Water Pollution Control Department also did well with a retained earnings of \$123,628.53.

3) It was mentioned that the Mid-Moraine Municipal Association would be meeting the 27th of March in Grafton.

4) The Board was reminded of the School District meeting to be held March 28th and the County Planning Zoning Workshop scheduled for March 16, 1996.

Chairman of the Administrative Committee, Robert Stoltzmann recommended the payment of bills as reviewed. On a motion by Trustee David Goeden, seconded by Trustee John Borland and unanimously carried by voice vote, the Board approved the payment of bills as recommended by the Administrative Committee. 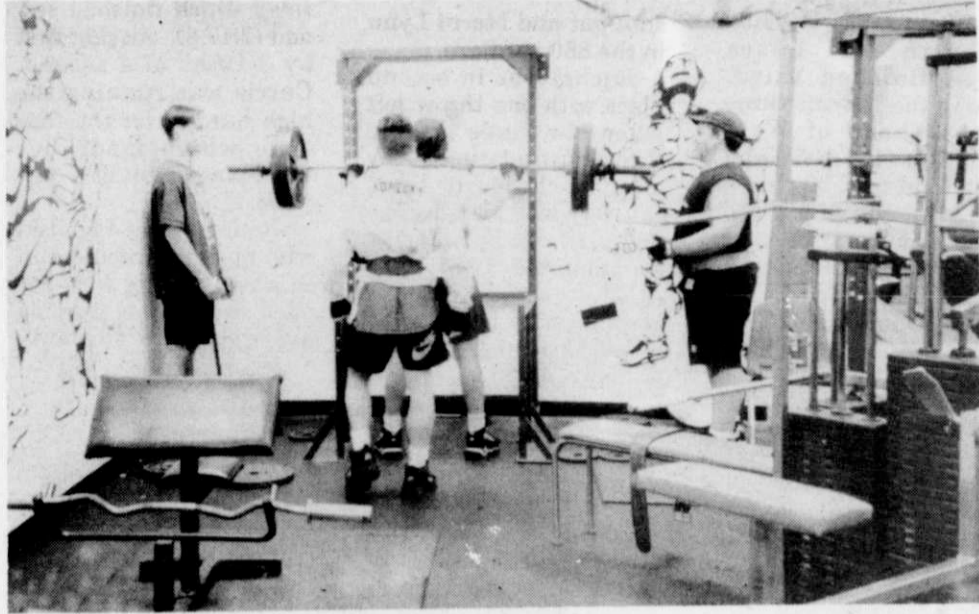

Matt Wiedmeyer, left, and Jeff Heller, right, spot Nate Judnik as he squats 250 pounds while Eric Kopecky observes.



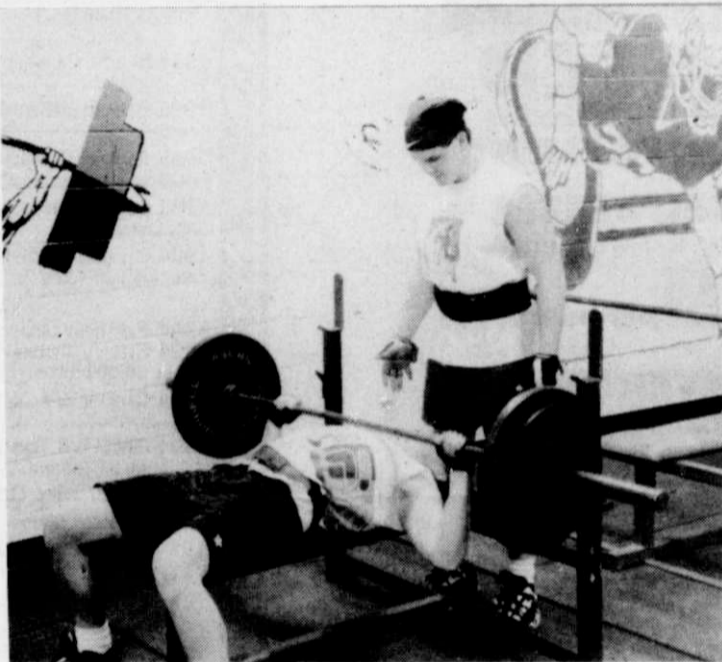

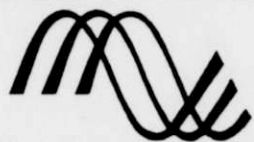
