## KES Principal Richard Zarling Retires Outgoing Board Addresses CVC and Consultant Firm

The Kewaskum School Board addressed various issues under new business at their April meeting.

Following an update on 1996-97 staffing and the Strategic Planning Workshop, Dr. Johnson brought up the fact the Village of Kewaskum has recently put up for sale the CVC (Central Village Complex) on Main Street for \$200,000.

Dr. Johnson stated he believed the issue should be left to the Building and Grounds Committee to initiate a review to see if that does fit any need of the district in the future. He added he was also pursuing any other options such as lease with option to buy, etc.

School Board Officers Elected



Election of officers was the first order of business at Monday evening's Kewaskum School Board Re-Organizational Meeting. Former Board President Neal Weare was nominated but in a surprise announcement, said he had decided to decline the nomination. Shown above are the 1996-97 School Board Officers. It was the first "official" meeting for the new board members. Clerk Andera commented, "I would like to take this opportunity on behalf of Mrs. Goeden, Mr. Schulte and myself to thank you Mr. Weare for your past year as president of the Kewaskum School Board. In representing our views you professionally and vigilantly navigated the board through some very turbulent waters this year. You displayed exemplary integrity and leadership by taking the responsibility for the entire board on controversial matters handling adversity with dignity and courage and never losing your cool. The good of the Kewaskum School District was in focus at all times and you never changed that focus. We believe that our district is on the right course to not only achieving excellence in education but to setting the standards for excellence in accountability as well. Your efforts are imbedded deeply into this action and for that we are grateful. Thank you.'

Dr. Johnson had prepared data on the costs of upgrading the building and longer term issues on accessibility, stating, "There's no obstacle that couldn't be overcome, even in accessibility, if the board viewed that as a building that could be of use to the district in the future."

When asked about parking, Dr. Johnson stated there would be an easement with eight parking spaces and it was his understanding the whole area was going to be utilized as a parking area.

Board member Ron Beimborn reminded his fellow board members about the sidewalk issue and urged Dr. Johnson, however the decision ends up, to get in writing any options needed for parking access.

President Weare stated, "I will ask the Building and Grounds Committee to make sure those questions are answered to your satisfaction before they bring a recommendation back to the board."

Newly-elected board member Tom Timblin stated he had talked to Village Administrator Dan Schmidt and stated, "When all the dust settles, I don't think parking is going to be an issue. We'll just have to go into it with our eyes open." Timblin then asked, being a new board member and a little naive, what the process would be if the board would have an interest in purchasing the building.

Dr. Johnson stated the board is restricted and cannot simply buy a property without notifying the public and it being put on the annual meeting agenda. Johnson added, "I don't want to talk out of school, but I suspect that if the school district if we saw that it fit so that we could free up the current district office for what it was intended for ... which we will have a need next year for another classroom. I would think if the district made its intention clear at some point, then perhaps the village would take into account that our particular situation that until July 22 there could be no real decision at all. It's only theory until then."

question, President Weare added the Building and Grounds Committee would look at it, review it and see, along with the Feasibility Study Group, if it does fit into the plans. If it would, it would be announced properly to get it onto the Annual Meeting agenda and ask the voters to either give permission to purchase the property or vote it down.

Board member Ruth Schmitt stated if there was enough money within the budget to purchase it, then that decision could be made without a special meeting. Schmitt also asked if there were any plans to put any classes of students in the building or if it was going to be utilized strictly for administrative.

#### Dr. Johnson answered he believed this could be used as a future training/education building, stating, "There is a lot of potential in that building for both training and education. There's classroom space downstairs; there's a large meeting room; there's separate access... you can lock up the administration area and still use the building. It's set up to have functions going at the same time. My hope is that this would be a complex that could include classrooms, or could include professional development, or could include night classes for the community ... I think it should be a building that is really used."

development, Johnson stated, "It has just unlimited potential. If you let a few minds go on this thing, within the faculty, I think we could develop all kinds of ideas. I clearly think it's a building worthy of your look... your critical review."

(When the Building and Grounds Committee visited the CVC Building on Monday evening, April 15, it was recommended to consult an architectural firm to get a cost estimate on exactly how much it would cost the district to upgrade the building to suit their needs. The firm will also be taking a look at the outlying schools to give a recommendation on whether or not these schools could be expanded to accommodate growing enrollment if necessary and what these costs would be.)

The Board approved a post secondary enrollment request, a remedial reading teacher contract, the appointment of Patricia Lato as KMS assistant volleyball coach, named Perry Koth as head football coach, and the resignation of an OM coach.

The Board also moved to accept with regret the retirement notice of Kewaskum Elementary School Principal and Director of Special Education Richard Zarling who will retire effective July 1, 1996. Principal Zarling has served the Kewaskum School District for 36 years.

The last item on the agende concerned the approval of a consulting firm for the School District Superintendent Search. President Weare stated, "At the interviews that were conducted on March 26, it was the consensus of the majority of the board at that time, to recommend WASB as the consulting firm."

Board member Karen Sparks addressed the board, saying, "Not all the board members were at that whole meeting, and I would say that there was not a consensus, a consensus means everyone agrees. Three people felt that we should accept the WASB process and I felt that we should go with the Emerald Group."

Sparks stated the difference in the presentations made by the two groups were fairly substantial. She said, pool is narrow and shallow because they will not go out and actively recruit their members. That's their policy. The Emerald Group will actively recruit. I personally like the process the Emerald Group uses in getting community input into the profile. They have an 800 phone number that's assigned to our district where anyone in the community can call and leave a recorded message about their feelings or their opinions as to what qualities would be appropriate for the

candidate." Sparks added she felt going with the WASB would definitely limit the pool of candidates. She stressed that her feelings do not indicate that Dr. Johnson would not be a viable candidate for the position.

She stated, "I believe if we go through a real to real search and Dr. Johnson comes out to be the best candidate that will validate him in his role and empower him where if we do a search that is half-hearted, we will simply continue with divisiveness. If we just go through the motions, it will do more harm than good."

Sparks added the difference in the cost she felt was really very minimal... \$6,000 as compared to \$9,000 or \$10,000.

Jean Goeden stated she had attended a workshop for WASB and they would also come to the district and take a profile. They would also visit the staff, the community and interview the board members and go from there. Goeden said, "They do a very thorough search and come to the community to talk to them about it. I also believe that the Emerald Group is very good... they are very thorough... Mr. Richert was very forthright and also a very good salesman. I guess I just question the word headhunter when he did so state that." For that reason Goeden stated she was sticking to her recommendation to go with the WASB.

A member of the audience, Mike Miller, stated he felt the community needs to be openly involved in setting the profile. Another member of the audience, Laura Waehler, added she was very impressed with the Emerald Group and as a community member she would like to see the board go with the Emerald Group.

Future board member Larry Fechter stated he was concerned about the Emerald Group because they do go out and seek people themself without advertising and soliciting. Fechter added he thought community involvement was important "but the thing to keep in mind is that there is a faction in the community that don't even want us to do a search."

The board then voted on Goeden's motion to go with WASB. It became a mute issue, with the vote going three to three, Goeden, Schulte and Weare voting yes, and Schmitt, Sparks and Beimborn voting no.

Karen Sparks then made a motion to go with the Emerald Group which also died on a three to three vote with Goeden, Schulte and Weare voting no and Schmitt, Sparks and Beimborn voting yes.

President Weare stated because the vote on the consultant search became a mute issue it would have to be taken up at a later date. If there were no objections, he asked if it could be placed on the next agenda.






full line of fresh cut meats in their expanded departments. Kewaskum Frozen





While spending 151 days at sea, Christensen also visited Greece, Italy and Malta and had an opportunity to visit local sites

Christensen's involvement in the deployment is an example of

how U.S. men and women are serving in the Navy and Marine Corps around the world in support of U.S. interests. These highly trained naval forces provide a unique forward presence and crisis-response option, which can be withdrawn quickly when no longer needed.

He joined the Marine Corps in December 1990. Christensen is a graduate of Ohio State University, Columbus, Ohio, with a BS degree.

## In the Service

Marine Capt. Erik L. Christensen, a 1986 graduate of Campbellsport High School, has returned to Beaufort, South Carolina, after completing a six-month overseas deployment to the Adriatic Sea near Bosnia and to the Persian Gulf near Iraq serving with Marine All Weather Fighter Attack Squadron 251 embarked aboard the aircraft carrier USS America. Christensen is one of 300 squadron members who completed the 51,000-mile voyage aboard the carrier.

Christensen first traveled to the Adriatic Sea near Bosnia, where the 1,047-foot-long aircraft carrier and its nine aircraft squadrons participated in three days of NATO air strikes against Bosnian-Serb military targets in support of U.Sn initiatives in Bosnia. Aircraft in Christensen's squadron flew 10 missions in support of the air strikes over Bosnia, which targeted military storage and ammunition depots, anti-aircraft missile defense systems, command and control facilities, and military communications systems. Christensen also

traveled into the Persian Gulf to help enforce the international no-fly zone over southern Iraq. While in the Persian Gulf, Christensen was ordered back to the Adriatic Sea near Bosnia. Traveling more than 4,200 miles in just nine days, Christensen and fellow Marines were back in the Adriatic before the peace implementation forces began to pour into Bosnia from around the world. During the six-month deployment, aircraft from Christensen's squadron flew more than 1,900 missions and completed 1.954 arrested landings aboard the carrier. In all, Christensen's squadron

## Tornado Awareness Week April 22-28 Statewide Tornado Safety Campaign Planned



#### FIRST IN A SERIES

Wisconsin lies on the northern fringe of the famed path of tornado destruction, aptly named "Tornado Alley." Many Wisconsin communities and people have felt the strength of a tornado -one of nature's most violent phenomena.

No one can stop a tornado, but there are precautions you can take to protect your life and your property. That's why the Wisconsin Division of Emergency Government, the National Weather Service, and County Emergency Government Directors have joined forces to make sure this tornado season is not remembered as one of the worst to hit our state.

Governor Tommy G. Thompson has pro-claimed April 22 through 28, 1996 "Tornado Awareness Week." A number of activities are planned to inform all citizens of the dangers involved -- and safety precautions necessary -- in the event of a tornado. On Thursday, April 25, a simulated tornado drill will be conducted statewide. Schools, office buildings, industries, nursing homes, and hospitals are encouraged to take part. Time after time, the biggest tragedies occur in areas where tornados have never been reported and have no precedent in most people's memories.

To find out more about tornado safety, contact your county emergency government director and watch for the second part of this series, entitled, "Tornado Safety Precautions Can Save Lives, Property."

#### Tornado Watch/Warning

Do you know the difference between a <u>torna-</u> <u>do watch</u> and a <u>tornado</u> <u>warning?</u> These terms are used by the National Weather Service and knowing what they mean can save your life.

A watch is issued when conditions are favorable for the development of tornadoes. If a tornado watch is issued for this area, you should get ready to take emergency action. When a tornado warning is issued, it means that a tornado has actually been spotted or seen on radar. The warning will tell you where the tornado is and the direction it is moving. If you are in or near its path, you should take shelter immediately. **REMEMBER:** A tornado watch means that tornadoes are possible. A tornado warning means that a tornado has been spotted and may be heading your way. There may not be a tornado in your future, but don't bet your life on it.

## Town of Scott Will Seek Bids for 1996 Road Work



Also, a town with its own zoning ordinance would not be subject to the extraterritorial plat approval authority of neighboring cities and villages; and

The comprehensive land use plan should be filed with the respective county. The comprehensive land use plan should be updated at least every ten years and refiled with the county; and

WHEREAS, the Village has received aggregate tax increments with respect to TID No. 1 in an amount which is sufficient to pay the portion of the principal of and interest on the Outstanding Obligations issued to pay Project Costs when invested as provided herei

WHEREAS, the Village Board hereby finds and determines that it is desirable and in the best interests of the Village to deposit a portion of the tax increments in the special fund for TID No. 1 (the "Tax Increment Fund") into an escrow fund and to invest and apply the escrow fund to repay the portion of the Outstanding Obligations issued to pay Project Costs as they come due; and Costs as they come due; and

Section 3. Creation of Escrow Fund. There is hereby created by the Village and established with the Escrow Agent a fund designated \*Village of Kewaskum Escrow Fund for Outstanding TID. No. 1 Obligations' (the 'Escrow Fund').

Section 4. Deposit Into Escrow Fund. There shall be deposited in the Escrow Fund from monies on deposit in the Tax Increment Fund, together with certain other available Village funds, an amount which, together with investment earnings thereon, will be sufficient to pay the principal of and interest on the portion of the Outstanding Obligations issued to pay Project Costs.

Section 5. Investment of Escrow Fund: No Arbitrage, Said monies shall be deposited in the Escrow Fund with the Escrow Agent, pursuant to the Escrow Agreement (reference below) for the purpose of retaining the required amount of cash, if any, and acquiring the U.S. Obligations provided for in said Escrow Agreement. The Village covenants and agrees that no investment of monies on deposit in the Escrow Fund shall be made in a manner that would cause any of the Outstanding Obligations to be "arbitrage bonds" within the meaning of Section 148 of the Internal Revenue Code of 1986, as amended or any income tax regulations promulgated or proposed thereunder.

<u>Section 6. Debt Service Fund Account</u>. The Escrow Fund shall hereinafter serve as a portion of the Debt Service Fund Accounts, or Interest and Principal Accounts of the Special Redemption Funds, as applicable, for the Outstanding Obligations. The Escrow Agent shall serve as custodian of said portion of the Debt Service Fund Accounts or Interest and Principal Accounts and Principal Accounts.

And the merchandise you are required to buy will be **GROSSLY** overpriced, as has been the case with the water filters and purifiers and the vita-

mins that are often marked to the LUCKY WINNERS.

EVERY DAY, consumers throughout the United States lose many thousands of dollars to unscrupulous these **FREE** prize promoters. Their operations, known as the "boiler rooms" are staffed with high pressure sales people armed with sophisticated selling techniques designed to get YOU to send them some money. DON'T be swayed by their carefully scripted sales pitches and pressure tactics. Even better, arm yourself in the best possible way against falling victim to these kinds of frauds--by **KNOWING** how these con men operate and being prepared to IGNORE their COME-ONS!!!

If you receive a mailing promising you a free prize, or if you have been VICTIMIZED in a free prize promotion through the mail. PLEASE contact me and I will do my utmost to assist you. THIS is a very important issue and I know that many of you receive these type of mailings day by day. PLEASE, do not be a VICTIM--if you are unsure and want to participate in a "free prize" or "give away," PLEASE bring it in to me and we can take a look at it and I will advise you to the best of my knowledge or else we will send it to the **Postal Inspection Service** for their review.



## Governor Approves Hwy. 33 Project in West Bend

Governor Tommy Thompson has approved a \$4.5 million contract to reconstruct and widen about one mile of Washington Street (WIS 33) between Seventh and 18th Avenues in West Bend.

The contractor, James Cape & Sons Co., of Racine, was scheduled to begin the work that is expected to be finished in the fall of 1997, said Project Manager Dave Buschkopf of the Wisconsin Department of Transportation.

Buschkopf said work started on the west end of the project and proceed east. About half the project, 18th Avenue to Silverbrook Drive, is to be finished in 1996.

One lane in both directions will be kept open to traffic. Access to properties will be maintained as much as possible, although occasional short term closures will be necessary, Buschkopf said.

The existing roadway, nearly 40 years old, is deteriorated and severely congested with an accident rate 2.3 times higher than that for comparable streets. Washington Street will be rebuilt and widened by 22 feet, accommodating two through lanes in both directions and adding a fifth lane in the center for two-way left turns.

The project also will include new concrete pavement, sidewalks, storm and sanitary sewers, new water mains, replacement of some traffic signals and addition of other signals.

The additional lane for turns, improved signals and elimination of parking along Washington Street, along with the new surface, will enhance traffic flow and safety, Buschkopf said.

The project originally had been planned for 1993, but was delayed three years because soil contaminated by gasoline, oil and dry cleaning materials had to be removed from seven sites along the route.

Washington Street, a major east-west arterial serving West Bend's main business district, carries an average daily traffic volume of 21,420 vehicles in the area. The number is expected to reach 28,768 in 20 years.

West Bend is to pay for lighting, signals, sanitary sewers and water mains. The rest of the cost sharing will be 76% by the federal government and 24% by the state.


