# St. Joseph's Hospital Awarded Highest Level of Accreditation

St. Joseph's Community Hospital of West Bend has been awarded the highest level of accreditation by the Joint Commission on Accreditation of Healthcare Organizations, the nation's oldest and largest accrediting body.

The hospital has been Accredited with Commendation following an on-site survey by the commission. Only 12% of hospitals surveyed in 1995 received this highest level of accreditation, according to the commission.

"We are extremely pleased to have achieved this designation," said Gregory T. Burns, executive director of St. Joseph's Community Hospital. "It is a visible recognition of our hospital's

commitment to excellence and the efforts of physicians and staff to provide the best possible health care to our patients. Accreditation with Commendation is an added incentive to continue the active performance improvement processes we have in place."

"St. Joseph's Community Hospital and the community can be extremely proud. Accreditation with Commendation reflects the hospital's outstanding dedication in meeting high national standards of health care. It's an assurance of quality and value for everyone the hospital serves," said Thomas Kieckhafer, president and chairman of the hospital's board of directors.

Burns also expressed his thanks and congratulations to everyone associated with the hospital for the dedicated work that produced the exceptional survey result.

## A Message from Bonnie

Hello Kewaskum Statesman readers and how is everyone doing today?

Like you... I am waiting for the good weather to come and stay. Mom and dad are returning May 6th for the summer and got to have good weather for the Floridians, right?

Before starting this week's column, please make note of the phone number for our office. It is 626-2575. It seems that there is a "really dear lady" that has a phone number very similar to ours and she is getting quite a few phone calls. Please dial carefully when calling us and maybe we can alleviate this dear lady from getting our calls. Thanks for your continued co-operation in this matter.

This week, we are going to talk about chain letters and do hope that you find it interesting and informative.

A chain letter is a "get rich quick" scheme that promises that your mail box will soon be stuffed full of cash if you decide to participate. You're told you can make thousands of dollars every month if you follow the detailed instructions in the letter.

A typical chain letter includes names and addresses of several individuals whom you may or may not know. You are instructed to send a certain amount of money -- usually \$5 to the person at the top of the list and then eliminate that name and add yours to the bottom. You are then instructed to mail copies of your letter to a few more individuals who will hopefully repeat the entire process. The letter promises that if they follow the same procedure, your name will gradually move to the top of the list and you'll receive money... lots of it!

There's at least one

problem with chain letters. They're illegal if they request money or other items of value and promise a substantial return to the participants. Chain letters are a form of gambling, and sending them through the mail (or delivering them in person or by computer, but mailing money to participate) violates United States Code, Section 1302, the Postal Lottery Statute. (Chain letters that ask for items of minor value, like picture postcards or recipes may be mailed since such items are not things of value within the meaning of the law.

Recently, high-tech chain letters have begun surfacing. They may be disseminated by the Internet, or may require the copying and mailing of computer disks rather than the paper. Regardless of what technology is used to advance the scheme, if the mail is used at any step along the way... it's illegal.

The main thing to remember is that a chain letter is simply a bad investment. You certainly won't get rich. You will receive little or no money. The few dollars that you may get will probably not be as much as you spend making and mailing copies of the chain letter.

Chain letters don't work because they promise that all participants in a chain letter will be winners is mathematically impossible. Also, many people participate, but do not send money to the person at the top of the list. Some others create a chain letter that lists their name numerous times -- in various forms with different addresses. So, in reality, all the money in a chain is going to one person.

Do not be fooled if the chain letter is used to sell inexpensive reports on credit, mail order sales,

mailing lists or other topics. The primary purpose is to take your money, not to sell information. "Selling a product" does not insure legality. Be doubly suspicious if there's a claim that the U.S. Postal Service or the U.S. Postal Inspection Service has declared the letter legal. This is said only to mislead you. Neither the Postal Service or the Postal Inspection Service give prior approval to any chain letter.

Participating in a chain letter is a losing proposition. Turn over any chain letter that you receive that asks for money or other items of value to us, as your Kewaskum Post Office. Write on the envelope of the letter or in a separate transmittal letter. "I have received this in the mail and believe it may be illegal." This will then, in turn, be sent to the Postal Inspection Service for investigation.

#### IN SUMMARY:

Please don't get caught up with chain letters. You can help yourself, your neighbors and the Postal Service by turning in these letters to the Post Office. If you just toss them away, you are "helping the cause." Too many people get blindly caught up with these type of scams daily and only by a unified effort can we stop this illegal movement. We, at your local Post Office cannot determine legality of a chain letter but will be more than willing to send them on to the Postal Inspection Service in Milwaukee. Let us put a stop to chain letters.

Hope you found this column interesting and not too lengthy. It is an important issue and nothing could be left out to fully explain the severity of this problem. Until next time, try to have a good day... a happy everyday.

# Retired Educators To Meet May 21

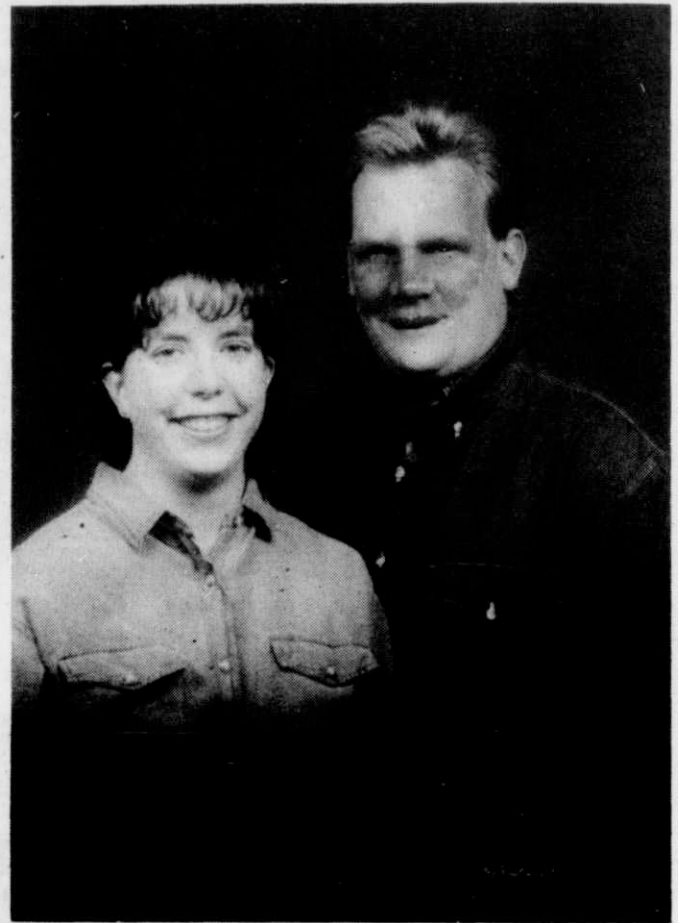

## Lac Lawrann Wildlife Sale

Now that the ground is thawed and spring is finally here, volunteers at Lac Lawrann Conservancy are busy again preparing the plants for the Conservancy's Ninth Annual Wildflower and Perennial Sale.

Preparations for this year's sale started last summer by starting prairie plants from seed. Seed was also collected through the fall and cleaned and packaged for sale over the winter. Early spring was the time to build grapevine and willow trellises, a new addition to this year's sale. The trellises are one-of-a-kind and range from two feet to use in potted plants to six feet tall for clematis, roses and other climbing plants.

Most of the plants for sale come from the woodlands and gardens of the Conservancy's Friends, volunteers and other sup-

porters. Others are "rescued" from construction sites when they would otherwise be destroyed. Each year the sale has grown as customers come back and bring their friends. After nine years, some of our first customers are now supporting us in another way -- by donating plants from their established wildflower gardens. The sale is held at Lac Lawrann Conservancy, 300 Schmidt Road in West Bend, on Saturday, May 11 beginning at 9 a.m. Joan Rosenberger, co-chairperson and veteran gardener warns, "Come early! We have thousands of plants and lots of seed, but everything goes fast!"

## A Perfect Day to Turn Into a Cloud



On April 22, the third grade of Holy Trinity School in Kewaskum visited Riveredge Nature Center in Newburg to study Nature's Recycling.

Mrs. Feucht, Mrs. Tuscynski, Mrs. Uelmen and Bea Weiss drove and accompanied the group on the field exercise.

The group was guided by Naturalists Mary and Joan.

The students played in the role of clouds. Andrea Theisen and Todd Warnecke liked this part because they used sponges and water in the evaporation-condensation cycle to make it "rain." More seriously, water cycles were discussed in terms of evaporation, condensation, precipitation, transpiration and the students learned that perspiration is sweat (and vice versa).

When asked about the most important things they learned on the trip:

Ross Kuehl felt that he learned that cycles are all around us.

Josh Riebe and Rachel Dums agreed that cycles never begin or end but are continuous and we are all very much a part of them and they of us.

Nicole Feucht learned that a 5 foot by 5 foot patch of Rain Forest produces oxygen for one person each day and Amanda Herriges feels

that this is reason enough to not cut down trees.

Stacy Gajewski added that while people inhale oxygen and exhale carbon dioxide, plants do just the reverse by producing oxygen after converting it from carbon dioxide through chlorophyll and photosynthesis. It seems that plants and people need each other.

Alex Herriges pointed out that rocks and soil can filter river water to clean it. Noah Schoofs and Carrie Fechter learned that sun, water and air are all involved in the biggest and most important cycles and that the water we use today has been recycling for over 100 million years.

Jason Tuscynski is fascinated with a cycle that begins with a tooth which falls out and becomes part of the soil which feeds a plant which is eaten by a cow to produce the milk which some kids drink to produce another tooth!

Griffin King, Ryan Hesprich, Brian Timmers and Eric Nass learned that even though they

never got to sit around, it was a lot of fun because they walked forever and got right back to where they had begun.

Katie Uelman and Michael Neumann learned about the importance of insects which act as decomposers of logs, leaves and plants to produce our topsoil.

Plants and people absolutely need soil, air and water to live!

What a day! The students turned into clouds and found decomposers! They think they should do this every year because "it was great and I think the second grade would like it too!"

## Area Legislators Denounce Lawsuit Against Woman's Right to Know Act

MADISON -- Following Governor Tommy Thompson's signing into law the Woman's Right to Know Act, Planned Parenthood of Wisconsin has temporarily blocked the new law which requires comprehensive informed consent and 24-hour reflection period prior to an abortion.

We are extremely disappointed that Planned Parenthood has decided to file a lawsuit to try to prevent the State of Wisconsin from implementing our new Woman's Right to Know law. Because they were successful in getting a temporary restraining order, Planned Parenthood will allow themselves to continue to treat their patients with a callousness which would be unheard of by any other medical health professional. We are therefore calling on all other abortion clinics to take the following voluntary action:

1. Stop asking for payment for abortions before your perfunctory counseling. Other medical health professionals wait until after a decision has been made to ask for payment. By asking for payment first, you create a situation in which a woman feels it is too late to turn back. We can think of no other "service" in which you must pay first before you find out about it.

2. Have the doctor spend at least a few minutes with the patient before the abortion. Reviewing the procedure with an unlicensed professional is an insult to women. For the income being earned, this is certainly the minimum expected.

3. Institute a reflection period. Health care professionals in other fields always give their patients a time to reflect after they explain a significant elective procedure. This is out of respect for the patient to make sure he/she is doing something he/she will not regret. No other medical professional would consider it an "undue burden" to go to a clinic twice.

4. Take some time to explain the development of the unborn child. Interviews with some women who have had abortions indicate that they believed their child was a shapeless form when aborted. This of course was not true. By referring to the child as

"tissue" you show a bias as more appropriate for a salesman on commission than a health care professional

It also disturbs us that in our litigious society, you have elected to go to court over a law that is modeled after a Pennsylvania law which has already been ruled constitutional. You not only thwart the will of the people of Wisconsin, you also subject the women of this state to this demeaning process, but will cost the State of Wisconsin money in attorney's fees.

We therefore call on every abortion doctor in Wisconsin to voluntarily comply with the information and reflection period requirements in the Woman's Right to Know Act. While it is possible this may cause the clinics to lose a fee from time to time, it is the minimum a civilized professional

would do.

## Ostrowski Rides High Groove To EWSCA Modified Victory

PLYMOUTH -- Former track champion Pete Ostrowski of Milwaukee rode the high groove to victory in the 30 lap Modified feature as the Eastern Wisconsin Stock Car Association kicked off its 36th season of racing Saturday night at Sheboygan County Fair Park.

After an aborted start for a flip in turn three involving Plymouth's Chuck Melis, polesitter Ken Schulz of Plymouth drove into the lead in turn one of the opening lap. On lap five, outside front row starter Bill Wenninger of Kewaskum roared into the lead in turn one.

While Wenninger held the top spot in the early stages of the race, Ostrowski was making his way to the front by using the high line. By lap 11, the tenth starting Ostrowski had worked his way into second place.

Three laps later, the 1994 Modified champ moved in to challenge Wenninger. On lap 15, Ostrowski powered his Outhouse Engineering Modified around Wenninger exiting turn four. Wenninger fought back to retake the lead briefly on lap 16 when Ostrowski encountered heavy lapped traffic. However, the 15 year veteran Modified and Sprint Car pilot steered around Wenninger on the next circuit to take the lead for good.

Over the final 14 laps, Ostrowski sliced his way through lapped traffic to notch his sixth career EWSCA Modified feature victory by a half lap margin.

Pete's younger brother Leroy, who also hails from Milwaukee, came from the eighth starting spot to take second. Kewaskum's Eddie Staehler finished third, Wenninger ended up fourth and Schulz placed fifth.

After 14 years of competition in the Sportsman division, Keith Borth of Sheboygan picked up his first career 25 lap feature victory in impressive fashion.

Outside front row starter Dave Herr of Sheboygan jumped into the lead on the drop of the green flag. Herr held the top spot until lap two when he got loose in turn four. Herr's bobble allowed second row starter Dave Jessen of Fredonia to take command of

the event.

Jessen quickly bolted away from second place John Scharenbroch of Sheboygan Falls to open up a half straightaway lead by lap six.

Borth, who started 10th, powered his way into second place on lap nine and gradually began to reel in Jessen. The lone red flag of the event appeared on lap 12 when Kiel's Dave Enders rolled to stop on the backstretch.

When the race resumed, Jessen maintained the lead with Borth in hot pursuit. After a tight side-by-side duel, Borth finally ducked under Jessen on lap 18 entering turn three. Borth proceeded to pull away from the field in the final seven laps to post a full straightaway margin of victory over runnerup Jessen.

Glenbeulah's Howie Weiss finished third, Scharenbroch wound up fourth and Mark Zimmermann of Kohler charged up from his seventh row starting spot to take fifth place.

Two-time track champion Rick Hed of Cleveland picked up right where he left off in 1995 by capturing the checkered flag in the 20 lap Hobby Stock main event.

Kiel's Dave Horneck led the first 17 laps of the race from the pole position. On lap 18, Hed worked up from the thirteenth starting position to take the lead.

The defending Hobby Stock co-champion cruised over the final two laps to record his 21st career feature victory at Sheboygan County Fair Park.

Horneck was second, Sheboygan's Mike Anderson placed third, two-time Hobby Stock champ Steve Schad of Cleveland moved up from the eighth row at the start to finish fourth and defending Hobby Stock co-champion Tim Thompson of Campbellsport took fifth after starting sixteenth.

Grafton's Dennis Klumb captured the victory in the 15 lap Modified B semi-feature. John Borth of Sheboygan won the 15 lap Sportsman semi-feature while Dave Kuhlow of New Holstein came home victorious in the 15 lap Hobby Stock semi-feature race.

Before the racing program EWSCA officials elected to wipe out all existing track records and incorporate new track records in the Modified and Sportsman

divisions after off-season modifications lengthened the dimensions of the track slightly in each corner.

However, Sheboygan Falls driver Greg Otte went about establishing a new Modified track record in grand style as he ripped off a blistering lap of 12.661 seconds which shattered the old record of 12.714 set by West Bend's Frankie Heimerl on June 20, 1992.

In the Sportsman division, Tim Buhler of Glenbeulah set a new track record with a qualifying lap of 14.756 seconds. Buhler's lap was not far off the old record of 14.627 set on the shorter track by Sheboygan's Jim Lavey on June 20, 1992.

Second year Modified driver Kevin Scholten escaped serious injury in a frightening incident during his second qualifying attempt.

Scholten drifted high in turn four and slammed into the frontstretch wall before catapulting through the catch fence along the front straightaway. The initial impact knocked Scholten unconscious, but the young Modified pilot was able to regain consciousness and exit his machine under his own power.

Scholten was transported to Valley View Medical Center in Plymouth for observation and was released later in the evening.

Paul Pokorski of West Bend flipped hard in the Modified B semi-feature. He was not injured.

Defending Modified champion K.J. Skelton of Cascade started the season on a sour note as his car suffered an engine failure in the third Modified heat race. Skelton did not compete in the Modified feature event.

EWSCA racing continues every Saturday night at Sheboygan County Fair Park through September 7. Time trials start at 6 p.m. with racing at 7.

## 25 Years Ago

April 9, 1971

The Distinguished Flying Cross for extraordinary achievement while participating in aerial flight on May 22, 1969, has been awarded posthumously to Technical Sergeant Charles F. Dreher, who served in the United States Air Force. Mrs. Dreher, who now resides here at 1433 Park View Drive, with their three children, received the award last week. Sgt. Dreher was the son of Mr. and Mrs. Earl "Pat" Dreher of 1541 Fond du Lac Avenue, Kewaskum. Mrs. Dreher is the former Charleen Vetter, daughter of Mr. and Mrs. Ruben J. Vetter of Beechwood. A citation that accompanied the Distinguished Flying Cross Award reads: "Technical Sergeant Charles F. Dreher distinguished himself by extraordinary achievement while participating in aerial flight as an RC 135C Inflight Maintenance Technician, 55th Strategic Reconnaissance Wing, Strategic Air Command, on 22 May, 1969. On that date, Sergeant Dreher demonstrated outstanding airmanship and courage while flying this special mission under extremely hazardous conditions. His successful completion of this mission produced information of vital importance to the nation's security. The professional competence, aerial skill and devotion to duty displayed by Sergeant Dreher in the dedication of his service to his country reflect great credit upon himself and the United States Air Force." Sgt. Dreher was aboard a Strategic Air Command (SAC) reconnaissance plane that disappeared just 14 days later, on June 5, 1969, over the Bering Sea with 19 men aboard. (Although a thorough search was made for the plane, they have not been heard from since.) The SAC jet disappeared just 30 minutes after takeoff from Shemya at the tip of the Aleutian Island chain. It was on a flight to Eielson Air Force Base near Fairbanks. Headquarters for SAC said then the RC135 was on a routine mission and made its last radio report about 250 miles east of Shemya.

The Kewaskum School Board referendum lost by almost a 2 to 1 margin in Tuesday's Spring Election. The final total showed 685 votes in favor of building the

additions to the schools and 1,356 against. The much publicized \$2.9 million school board referendum brought out a heavy vote throughout the school district. Over 2,000 voters cast their ballots as compared to light turnouts in many communities. The vote was heavy in the Village of Kewaskum, where 538 persons cast their ballot out of a possible 900 eligible voters. In the Village of Kewaskum, Cyril Wietor was re-elected president, receiving 437 votes. He was unopposed. Trustees Orval Behnke, Alfred Kral and Charles Miller, all incumbents, were re-elected to two year terms.

Members of the Village Board voted Monday night to increase the salary of the village president from \$600 to \$1,000 per year and the salary of village trustees from \$300 to \$600 per year.

When firemen arrived, smoke was pouring out of the house and it took some time before they could reach the basement to get at the source of the fire due to the thick, black, choking smoke. **REMEMBER:** A tornado watch means that tornadoes are possible. A tornado warning means that a tornado has been spotted and may be heading your way. There may not be a tornado in your future, but don't bet your life on it.

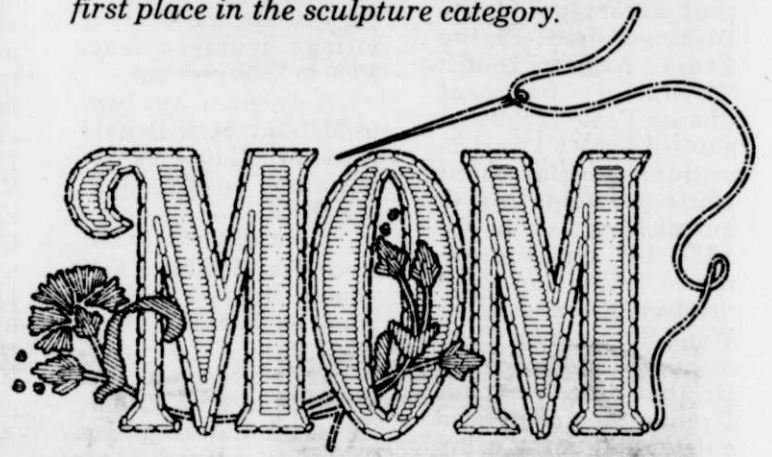

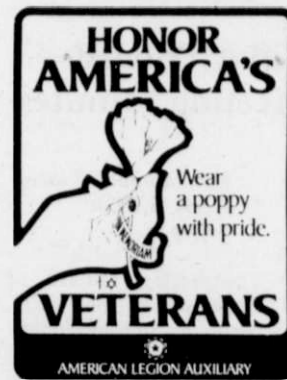

## Village Board Meeting Minutes

Mid-Monthly Meeting  
April 15, 1996  
8:00 p.m.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Mid-Monthly Session in the Council Room of the Municipal Building, 204 First Street.

President Robert Wagner presided. All Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee John Borland and unanimously carried by voice vote, the minutes of the April 1, 1996 meeting were approved as printed.

Mr. John Knepel and Ms. Joy Towel of the accounting firm of Conley McDonald LLP. were present to review and answer questions on the latest audit prepared for the Village of Kewaskum for year ending December 31, 1995. Mr. Knepel explained the entire audit and financial statements regarding the General and Utility Funds portion of the audit and associated financial statements. The audit revealed the Village to be in a healthy financial position.

It was further noted the General Fund ended with a positive balance but not quite as positive as in the past. The Water Utility reflected a balanced rate of return as requested by the PSC. The Sewer Utility also ended with a positive balance. It was noted that the Village would be able to retire the TID six years early and would discuss this matter later at this meeting. The Village's overall debt is at 31.6% of what the law provides. It was also noted that upon the closing out of the TID, that level will drop to 22.2% of what the law allows.

A variety of questions was asked of Mr. Knepel which were answered. Mr. Knepel thanked the staff for their assistance and good records. He further indicated the Administrator and Deputy Clerk do an excellent job on maintaining good records and control over spending, etc.

On a motion by Trustee William Kulas, seconded by Trustee Robert Stoltzmann and carried by the majority roll call vote, the Board suspended the rules to take action on IX. New Business points A. through D. relating to audit information. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent."

On a motion by Trustee William Kulas, seconded by Trustee Harry Roecker and unanimously carried by voice vote, the Board accepted the audit report as prepared and presented for the year ending December 31, 1995.

On a motion by Trustee John Borland, seconded by

Trustee David Goeden and unanimously carried by voice vote, the Board authorized the signing of an agreement for a TID/TIF Audit for the Village of Kewaskum for the period January 1, 1986 through August 31, 1996 at a projected cost of between \$2,500 and \$3,500.

A public hearing was held on the special assessment of Municipal Improvements (installation of storm sewer, catch basins, sidewalk, curb/gutter, street/roadway, street base/surface and restoration/landscaping as well as other related specifications contained in Section 8 of the Municipal Code) for the area known as the west end of Timblin Drive. The process of what is to be assessed was reviewed with the Board. It was noted that one property is being given the choice of tapered landscaping versus a retaining wall. Mr. Wendt was present and asked that the work be accomplished as reasonable as possible, by means of landscaping. It was noted that a consent & waiver needed to be signed by Mr. Wendt prior to the Village proceeding in that manner. On a motion by Trustee David Goeden, seconded by Trustee Robert Stoltzmann and carried by the majority roll call vote, the Board closed the public hearing. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent."

A public hearing was held on the application of the Kewaskum Athletic Club Inc. Kiwanis Park, Kewaskum, for a Class "B" Fermented Malt Beverage License for the period commencing April 16, 1996 and ending October 16, 1996. On a motion by Trustee John Borland, seconded by Trustee William Kulas and carried by the majority roll call vote, the Board closed the public hearing. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent."

A public hearing was held on the application of the Kewaskum Athletic Association Inc. Kiwanis Park, Kewaskum for a Class "B" Fermented Malt Beverage License for the period commencing April 16, 1996 and ending October 16, 1996. On a motion by Trustee William Kulas, seconded by Trustee John Borland and carried by the majority roll call vote, the Board closed the public hearing. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent."

Director of Public Works Jerry Gilles reviewed the bids received for the 1996 asphalt pavement work. Two bids were received as follows:

Scott Construction - \$74,582; Payne & Dolan - \$69,090.

Director Gilles informed the Board that the price of asphalt had a substantial increase over last year, placing both bids over budget. The budget amount equalled \$65,986. Director Gilles also informed the Board that the short section of street from Third Street to the High School drive/parking area was not included originally, not knowing if the school was planning to resurface their facility. That short section would add an estimated \$1,500 to \$2,000 to the total.

Assistant Fire Chief Mark Herriges presented the March 1996 monthly report:

Fire calls 4, Year to date 8; Jaws of Life 4, Year to date 7; Rescue Calls 14.

Chief of Police Richard L. Knoebel reviewed the Police

Departments Annual Report for the year ending December 31, 1995 as follows:

1. Total index crimes, those reported to the State on a monthly basis, decreased by 11.5%, largely due to a decrease in theft and burglary.

2. During 1995, all crime rates in Kewaskum were considerably less than both those of comparable communities and those of the entire state.

3. During 1995, 36 of 77, or 46.8% of reported index crimes were cleared by arrest. This 1995 clearance rate is much greater than the 1995 statewide clearance rate of 26.6%, and the 1994 Kewaskum clearance rate of 31%.

4. Total adult arrests increased by 3.2% from 220 in 1994 to 227 in 1995.

5. Total juvenile arrests increased by 84% from 131 during 1994 to 241 in 1995.

6. The property recovery rate for Kewaskum of 37% was very similar to both its 1994 rate of 36.7% and the 1995 Statewide recovery rate of 38%.

7. There were a total of 481 traffic citations issued in 1995, while there were a total of 1,852 traffic warnings given during the same period. That is 1 citation issued for approximately every 5 vehicles stopped by the Kewaskum Police Department in 1995.

8. The Kewaskum Police Department handled 1,892 complaints in 1995 compared to 1,751 in 1994.

9. The Kewaskum Police Department patrolled a total of 70,348 miles in 1995.

Chief of Police Richard L. Knoebel reported that a total of 8 applicants for the position of Police Secretary were interviewed and that he would recommend the hiring of Ms. Dorine Ruplinger at \$7.50 per hour. On a motion by Trustee Gary Gavin, seconded by Trustee William Kulas and unanimously carried by voice vote, the Board approved the hiring of Dorine Ruplinger, with a scheduled start date of April 18, 1996.

Director of Public Works, Jerry Gilles reviewed the fact that the Kewaskum Water Department was recently honored by receiving a State Award - the prestigious "1996 Water System of the Year Award." The Board expressed their appreciation and dedication by all of the Department of Public Works employees.

Director of Public Works, Jerry Gilles reminded the Board that the Spring Clean Up is scheduled for Saturday, April 20, 1996 from 9:00 a.m. to 1:00 p.m. It was noted that next year the Board consider a time of 10:30 a.m. to 2:30 p.m.

On a motion by Trustee John Borland, seconded by Trustee William Kulas and unanimously carried by voice vote, the Board authorized the hiring of DPW and WPC summer part-time employees as listed.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee John Borland and unanimously carried by voice vote, the Board approved the issuance of an Operators License upon proper payment of fees and documentation for the following:

Ramthun, Sharyl A., Kewaskum, WI.

Administrator Daniel S.

Schmidt reviewed the following with the Board:

1) Review of the building permits for March, 1996.

2) Review of Taxpayer and League bulletins.

3. Discussion regarding League of Wisconsin Municipal meetings.

4) Review of correspondence.

Chairman of the Park and Recreation Committee, Gary Gavin informed the Board that the Kewaskum Athletic Club Inc. has requested permission to paint their logo and art type work on the dugouts at the SW diamonds. The Committee did ask for a sketch describing the work prior to approval. Also the Committee recommended hiring summer part-time park employees as listed. On a motion by Trustee William Kulas, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote, the Board hired the summer Park & Recreation part-time employees as listed.

Board Representative for the Plan Commission, Trustee David Goeden informed the Board of a Commission Meeting scheduled for April 23, 1996 at 7:00 p.m.

Board Representative for the Mid-Moraine Municipal Association, Legislative Committee, Trustee Robert Stoltzmann, reviewed the last Mid-Moraine Municipal Association Legislative meeting with the Board and the comments made by the speaker from the Department of Revenue.

Action was taken on Resolution No. 96-10 A Final Resolution Regarding Sidewalk Installation, Curb/Gutter, Storm Sewer, Catch Basins, Street/Roadway and Street Base/ Surface and Restoration/Landscaping, as well as other Improvements and levying Special Assessments Against Benefitted Properties Under Sec. 66.60 WI. Statutes as heard at public hearing and attached hereto:

Director of Public Works, Jerry Gilles again reviewed the bids from the asphalt contractors as received. Director Gilles advised the Board that Bilgo Lane, if dropped and completed in 1997, would lower the total to \$60,465.00 bringing the total within budget. Trustee Gary Gavin suggested that money possibly could be found to transfer into the account to complete the entire Bilgo Lane project. Administrator Daniel S. Schmidt informed the Board the purchase of a truck could be delayed until 1997 and some of those funds used. It was further noted that if the Railroad does opt to proceed with the upgrade of the Second Street railroad crossing additional funds will need to be transferred. ## KHS Boys Second at Pewaukee Invitational

What a difference three days and a different level of competition makes. The KHS boys track team had one of their best showings of the season with a second place finish Friday night, April 26, at the Alt-heimer Invitational Track Meet at Pewaukee.

St. Francis won the meet with 95 points, but Kewaskum finished in second place with 78 points., just ahead of Elkhorn's 77 points. Union Grove was third with 68, Cedar Grove fourth with 66, host Pewaukee 53, Thomas Moore had 45 and Westosha Central acquired 39 points.

Highlights for the Kewaskum boys included two first places, four seconds, and three thirds with some of these places occurring in the same event.

Seniors Matt Tonn and Joe Rettler provided good scoring for the KHS boys team by taking two places in the 400m dash. Tonn finished in first place with a time of 54.12 and Rettler finished in third with a time of 55.14.

Senior Ryan Herman came back strong in the 200m dash finals to win in 24.30. "His time in the preliminaries wasn't his best. I was happy for him that he ran better in the finals," reported Coach Jerry Gosa. Senior Andy Rix also scored points in the 22m dash by placing fifth in 24.89.

Both KHS relay teams placed second. The 400m relay of Andy Rix, Aaron Kurth, Brian Butschlick and Ryan Herman again ran well placing second in 46.56. "They did a nice job," commented Coach Gosa, "but our handoffs need a little work."

Four sophomores in the high jump and pole vault provided a lot of points for the Indians. In the high jump, Matt Hammen got second place with a jump of 5'8" without any misses and Sean Cotter tied for third also with a jump of 5'8" with one miss. Troy Staehler made 9'6" in the pole vault, good for second place, and Brad Hermann jumped 8'6" for fourth.

The 1600m relay team was in for a good race from Cedar Grove. After Andy Rix led off with a good leg, Joe Rettler had the Indians in first place and Aaron Kurth kept the lead fighting off the third run-

That disappointment was replaced with happiness as the final results for the meet were announced.

Brian Butschlick returned to form and jumped a season best jump of 19' 2 1/2" in the long jump good for third place. "Brian has been doing a great job on the 400m relay team and his points in the long jump came at a good time," stated Coach Gosa.

Brian Liegl took fifth place in the shot put with a good throw of 43' and sixth place in the discus with a toss of 128'8".

"When you look at the final point totals for the meet, our athletes now should understand that every place and every point is very important to the team," commented their coach.

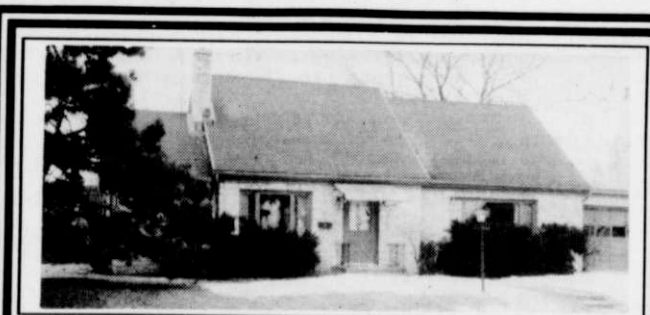

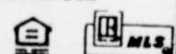

# Boys 1600m Relay Team Sets New School Record

Even though the Kewaskum boys track team finished fifth out of eight teams at the VanderPan Invitational Track and Field Meet at Sheboygan Falls Friday night, May 3, the KHS boys 1600m (4x400) relay team just about set the track on fire.

The foursome of Ryan Herman, Joe Rettler, Aaron Kurth and Matt Tonn won the relay in a school record time of 3:32.3. This broke the old record of 3:33.5 set in 1980 by Joel Herriges, Scott Brendemihl, Jeff Decker and Steve Becker. "All four runners ran a fantastic race," reported an obviously pleased coach Jerry Gosa.

The record was set with a new line-up. Ryan Herman was switched from anchor to the lead-off man to replace Andy Rix, who was out with a slightly pulled hamstring. Matt Tonn rejoined the relay unit in his usual anchor position for the first time since his return from mononucleosis.

Kewaskum had the second fastest seed time for the 1600m relay behind Sheboygan Falls. Herman led off, Rettler increased the lead with both Kurth and Tonn stretching the lead and finishing almost a full seven seconds ahead of second place Sheboygan Falls. "We knew that Falls has a great anchor runner in Tyler Schuefner," who had earlier won the 400m dash in 51.6, "and that we had to have a big lead in order to win," commented coach Gosa. This school record was one of their goals for the season. "They want to be Conference Champions in this event, and... but we'll take them one at a time," cautioned their coach.

The 400m relay (4x100) team also needed a change in the line-up due to the injury of Andy Rix. After Rix warmed up and decided that he couldn't run at 100%, Joe Rettler was moved into the relay to run the lead-off position. Rettler had just finished placing third in the 400m dash and the 400m relay was the next event.

"I give both of them a lot of credit," commented their coach. "Rix for putting the team first and Rettler for stepping up and doing such a good job on the relay." The unit of Rettler, Aaron Kurth, Brian Butschlick

and Ryan Herman finished second in 46.8 in a very tight race.

In the 400m dash, Matt Tonn took second place with a time of 53.3 and Joe Rettler took third with a time of 53.8 giving Kewaskum 14 points in this event. Ryan Herman took third place in the 200m dash with a time of 24.3, just 0.1 out of second place. Other highlights include the second place by Brian Butschlick in the long jump with a leap of 19' 1/2" and sophomore Matt Hammen tying for third in the high jump at 5'8".

Junior Brian Liegl returned to form in the discus with a toss of 136'6" good for fifth and

also placed sixth in the shot put with a throw of 41'3 1/2". Regarding his throw in the discus, his coach commented that, "it was good to see Brian back up there with the conference meet coming up next week."

In the 800m run, sophomore Troy Staehler placed sixth in 2:15.7 and junior Eric Kopecky placed seventh in 2:16.3. Brad Luterbach and Troy Staehler both had an off day in the pole vault, but Luterbach still managed 9'0" for eighth place.

Plymouth won the boys portion of the meet with 149.5 points over host Sheboygan Falls' 125 points. Another conference school, New

Holstein, placed third with 95.5 points. Oostburg had 68 points, followed by Kewaskum with 64.5 points for fifth, Howards Grove had 62 points, Elkhart Lake 50 and Southern Door scored 43.5 points.

On Thursday, May 9, the Eastern Wisconsin Conference Coed Track and Field Championships will be held at Kewaskum High School. Field events and the 3200m relay start at 3 p.m., preliminaries in the running

events at 3:30 p.m. and finals at 4:30 p.m.



# KHS Girls Track Team Wins VanderPan Invite

With the Conference Meet only six days away, last Friday's VanderPan Invitational was a final tuneup before the girls defend their Eastern Wisconsin Conference Championship on Thursday, May 9, at home.

For the first time this outdoor season, the Kewaskum girls track team headed into a meet with all of its' athletes available and healthy. It appears that the team is primed and ready as they won the eight-team Invitational held at Sheboygan Falls.

Kewaskum has experienced a great deal of success the last seven years in this meet, winning it four times and finishing second three times. This year's contest was one of the closest in the past seven years, however, as Kewaskum edged out conference schools New Holstein and Sheboygan Falls by four and five points respectively (Kewaskum - 120.5, New Holstein - 116.5, Sheboygan Falls - 115.5).

While the final results were what the team was hoping for, the meet did not start out as expected. The 100m high hurdles has been one of Kewaskum's strongest events this season, and the Kewaskum coaches expect-

ed to score a lot of points in this event, but to everyone's surprise, none of the KHS hurdlers made it to the finals.

Junior Heather Downs fell after the eighth hurdle and sophomore Carrie Wiesner got off to a bad start and never recovered. While it didn't look good at that point of the meet, better results soon started coming in.

First the results of the discus came in, another one of the teams strongest events, with a 1-2 finish. Katie Yogerst and Rachel Nysse both threw their personal bests for the season with throws of 120'1" and 106'7". Yogerst's throw was the best of her career.

Next came the 100m dash with Jenny Jagielski (first) and Jenny Strobel (fourth). Jagielski ran her fastest time of the year, a 13.0 second clocking. Then the 1600m run with two more places as junior Marni Lynn competing in only her second outdoor meet of the year, placed third (5:30.6) followed by freshman Carol Neumann (5:38) in fourth place.

So it continued the rest of the meet with two places coming in the high jump, Kelly Schreffler, (third, 4'10"), with her personal best of the year, and Jessica Repovsch (eighth, 4'8"), shot put

Rachel Nysse (third, 34'10"), and Katie Yogerst (fourth, 32' 2 1/2"), 300m low hurdles, Carrie Wiesner (second, 51.9) and Jackie Michaels (fourth, 54.0), 800m run, Marni Lynn (second, 2:23.2) and Carol Neumann (fifth, 2:36), and the 200m dash, Jenny Jagielski (second, 27.2) and Erin Stockhausen (fifth, 28.8).

The end result was a great team effort for another invitational championship.

Wiesner also placed sixth in the long jump with a leap of 14'4 1/4". The relays ran well with the 800m relay placing the highest of the group scoring a second place finish in 1:52.9, their fastest of the year (Strobel, Stockhausen, Wiesner, Jagielski). These girls have run very well this entire season for the Indians.

The 400m relay finished fourth (Strobel, Stockhausen, Kenzie Downs, Bridget Baum) in 55.4, along with the 3200m relays' time of 12:12.6 (Ann Bodden, Jenny Immel, Laura Weiss, Becky Repovsch).

The 1600m relay insured the victory by placing sixth in a time of 4:37.0 (Jamie Gaffke, Kelly Schreffler, Jessica Repovsch, Bridget Baum). It was a nice win

for a hard working group of girls.

The conference meet will be a real challenge for these athletes with Two Rivers coming in with a real powerhouse of a team, along with always strong New Holstein. One thing is for sure though, Kewaskum will be well represented in the Conference Meet by this fine group of athletes.
