

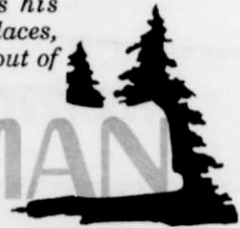

## KEWASKUM SCHOOL DISTRICT Common Themes From Interviews Conducted May 7, 1996

Groups interviewed included: Parents; Students; Administrators; Administrative Staff; Teachers; Support Staff; Community Members; Chamber/Service Club Members; Town Officials; Past Board Members; Each Current Board Member. A total of 23 groups were interviewed by Marv Lansing and Pam Rewey, Wisconsin Association of School Boards Search Services Staff. This summary was prepared jointly by Mr. Lansing and Mrs. Rewey.

### UNIQUENESS:

Kewaskum is an attractive rural community that is experiencing in-migration from primarily Southeastern Wisconsin. Therefore, it is, and will continue, growing. New people may be more like long time residents than is thought. Newcomers are looking for values of a small stable community. Parents who have lived elsewhere think it's unique that every teacher knows their child and that teachers here really care about kids.

Most groups stated that Kewaskum is very conservative fiscally and values traditional mid-western traits, such as hard work, honesty, fami-

ly life, etc. However, most groups commented that labels like religious right or similar labels are inaccurate terms used to describe anyone who believes that students need to know fundamental skills. Some feel this is more of a misunderstanding than a real difference in values, since there is agreement that children should be able to read, write, etc. at a high level. Labeling, misused terms, buzz-words and generalizations about what children in Kewaskum are learning are causing unnecessary anxiety and conflict.

Recent board/administration/staff/citizen conflict was cited as unique and needs to be addressed. Also, the poor public image augmented by press, letters to the editor, etc., may be unique and should be turned around.

### STRENGTHS:

The district is near to a large city, but has a small community environment. Many excellent teachers, neighborhood schools, board commitment to small elementary class size and good parental involvement were cited over and over as strengths. The community (good people who

care about each other and support traditional values) and parent support for schools was mentioned ("but want money spent wisely"), as was the passage of the referendum. Marv Lansing notes: "Good communication is critical as to how money is spent."

There is some optimism about the new board... it is viewed as a good mix of conservatives and moderates. Many feel that the community mix of long time residents and newcomers is a strength. Parents report good rapport with teachers. Teachers care and attend to kids' needs. Diverse needs are being met even with economic limits. Additional strengths cited: teachers know their students; computer education and technology is in place; the middle school concept is in place; opportunities for kids, academic and extra-curricular, are good; and many comments were made about Kewaskum graduates "doing well."

### PERCEIVED WEAKNESSES:

Many groups cited inadequate curriculum coordination (K-12) as a weakness. Most also mentioned that the

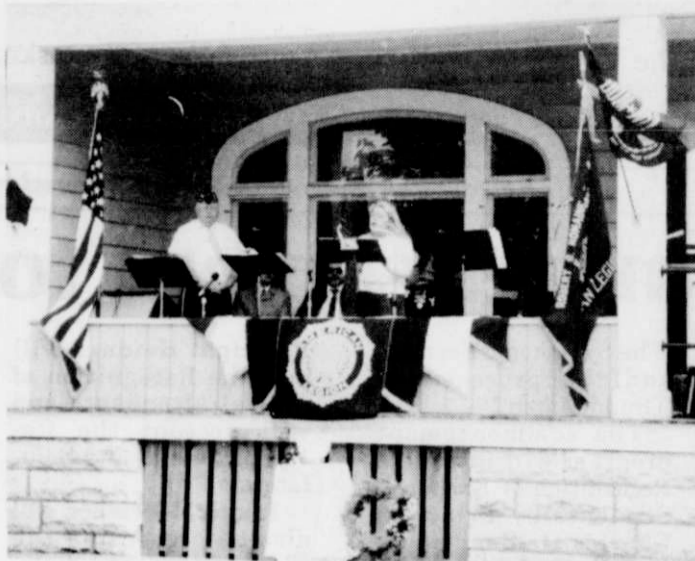

## Nighs to Leave for Russia

Former residents, David and Barbara Nigh, will be leaving in July to spend a year living in the former Soviet Union. The Nighs will be serving with the CoMission participating in ministry activities. The CoMission is a cooperative effort of over 80 Christian organizations committed to sharing the gospel in Eastern Bloc nations.

Back in 1990 the JESUS Film premiered in Moscow. Several Russian Ministry of Education officials were so moved by the film that they invited Campus Crusade for Christ to make the film available to the public schools across their country. An invitation was also extended to developing a curriculum to supplement the JESUS Film. It is called, "Christian Ethics and Morality: A Foundation for Society."

Four-day convocations were launched in May 1991 to expose Soviet teachers to a Christian world view and train them to use the morals and ethics curriculum. Since then more than 33,000 teachers have been trained resulting in many of these teachers coming to a personal faith in Christ and using the curriculum in their schools.

Part of the work of the CoMission is effective follow-up and continued training of teachers. The Nighs will be working in the school system aiding teachers with showing the JESUS Film and implementing the morals and ethics curriculum. The Nighs will also be conducting Bible studies for the teachers as well as neighborhood Bible studies and JESUS Film showings for local residents. Discipleship and followup of new believers is a crucial part of the work.

Dave and Barbara are

excited that God has invited them to join Him in His work in the former USSR. You can also join God and His work of being part of the Nighs support team. # Students Learn About Advertising and Marketing

5th Graders in Mrs. Sandy Stern's class had an opportunity to learn about advertising and marketing from a businessman who is in the business of "selling a message." Dave Zoerb, Senior Vice President and Creative Director at Frank Mayer and Associates in Grafton, visited Kewaskum Elementary School and talked to students about product advertising and marketing.

Students were asked to identify the ten companies that spend the most money annually on advertising. Students brain stormed for about 10 minutes and came up with the answers - #1 was AT&T and Number 10 was Warner Brothers, with Ford, Sears, Kelloggs, McDonalds, Chevrolet, Dodge, Toyota and MCI in between.

Did you know that the term advertising comes from the Latin word meaning "To Turn"? "Trying to influence a purchase decision through a paid message" said Zoerb.

Using the story board concept, Mr. Zoerb explained how a commercial is made. He also talked with the children about the different kinds of advertising - electronic, outdoor, newspaper, magazine, and licensing advertising, the fastest growing area in advertising today.

Another area of marketing and advertising the children were exposed to was Point of Purchase Displays which is a large part of Mr. Zoerb's business.

For the month of May, Mrs. Stern's fifth graders are studying entrepreneurs and are learning about successful businesses like J C Penney, Procter and Gamble,



superintendent has assigned the coordination task to an administrator and some progress is occurring. There is a need to provide training on the instructional use of technology. Academic expectations should be high for all children. There is a concern about easy grading at the high school. There has been a history of poor communication and lack of long range planning. Space needs elevated for now, but not for future. Administration and staff must identify issues and work together to help solve them. There are some turf issues between buildings. A pervasive sense of mistrust remains. The last couple of years has produced an "us against them" mentality. Negative comments about the staff and administration has encouraged parents and some staff to "go right to board members," which leads to board micro-managing. A small group of negative staff has added to the lack of trust. The conflicts among board members and the board and administration has also fueled mistrust.

These issues have helped create poor staff morale, a loss of public confidence and a poor public image. All parties (board, staff, students and community) want this fixed and hope the new board and new administration can effectively address these concerns. A community member summed it up with "we need less politics and more focus on kids." Some groups feel that these concerns are beginning to be addressed.

## FUTURE OF THE DISTRICT:

People agree that the district will grow, and upgraded and/or new facilities will be needed. Most hope that the curriculum will improve. Many also expect improved discipline. Everyone wants the children to have a strong work ethic. That will mean higher expectations for learning. More children from single parent families, may create additional needs. People hope that morale will improve as board and staff conduct and overall district leadership improves. They also hope that the staff will work with the board and administration for the kids... and they hope that doing this will bring positive press and news about students' achieve-

ments.

There are high expectations for things to get better - soon.

Most feel that much will also depend upon the district's leadership and the willingness of all to focus on the future.

## MAJOR FOCUS FOR IMPROVEMENT:

Most groups would like to see: upgraded and coordinated curriculum, coupled with related staff development; accountability improved across the district; and focus on the basics (clarify meaning) at the elementary level. Every group wants higher expectations for all. Every student should come to school ready to learn (parent support) and should leave competent in reading, writing and math and should have good study skills. Technology should be improved at the high school... need to upgrade graphics and drafting/design. District should offer additional science (advanced) classes. Parents want increased home work expectations. The district should plan now for future building, space needs (some would like to see an auditorium.) Maintenance of the buildings should be a priority. The arts and music need recognition. Groups would like to see overall administration effectiveness and consistency. Make sure policies are consistent and administered consistently. Many would like to see "joyfulness" and enthusiasm among staff. The district should improve public relations (let controversy die) and board/administration/staff relations.

A community group said "stop gossip and half truths." Some said that the board needs to see first hand what's happening in the classroom. There's a feeling that what is read about (from out of state or other districts) is assumed to be a problem here. Some teachers suggested that board members should be invited to visit classes, not to "look for something wrong" but to find out what's real and what's working.

The board, administration and all staff should model respect for self and others. Respect for self and others should be an expectation for all children. There is hope that the board, administration, staff, kids and community will work collaboratively to set and meet high expectations for learning.

## STRENGTHS NEEDED IN A SUPERINTENDENT:

Integrity, honesty... good "character." A strong leader who is organized and decisive. Someone who is not afraid to stand up to the board and staff (clarify roles and expectations). Friendly, good interpersonal skills. Effective speaking and listening skills. Must be available and visible to staff and to students and to the community (open door.) Should have ability to evaluate programs and communicate how kids are doing to parents and community. Should have ability to explain how money is spent. Able to delegate (use each person's strengths) and to define what is expected... then provide support and guide teamwork. Able to define who is responsible for what and to whom. Able to take responsibility for success of students and district - knows that "buck stops here." Has financial management and personnel skills. Accountable, humble... doesn't care who gets the credit for what's going right. Knowledgeable about education. Seeks input from others. Has vision of excellence for Kewaskum.

## BEST USE OF SUPERINTENDENT'S TIME:

Manage the district and provide oversight. Organize, delegate and be accountable. Provide leadership so staff and students are focused on excellence. Planning. Must get out of the office and be visible in the buildings and community. Get to know everyone.

Focus on issues not personalities. Provide pros and cons to board. Help solve problems. Public image is low, so time needs to be spent on a credible public relations plan that relies on actions not words or brochures. Rebuild trust - community, staff and students must know the superintendent to be able to do that. Must develop mutual trust and respect to get through "tough" times.

## SUPERINTENDENT SHOULD BE PREPARED TO HANDLE:

The affect of past conflict and low morale. Positive decisions and actions will help this. Developing a team approach is expected with each member accountable and the superintendent taking final responsibility.

Superintendent should not focus on the

past. Move ahead - it's a new day - get on with it. Do not forget the students - their morale is also low from fallout from above.

## BOARD MEMBERS:

Members of the new board expect the board to be more cohesive and to be a better team. They hope that, as a result, relations will improve with administrators and staff. There is an overall belief that student achievement needs improving. Staff morale needs improving... moving forward, letting go of the past is important. A factor will be the leadership style of the superintendent and the new high school principal - a critical position.

basis.

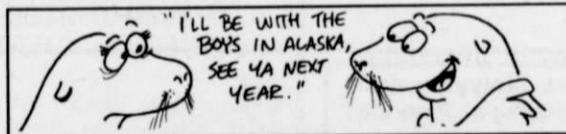

Rettler left the exchange zone five meters behind the Mayville runner. Rettler closed the distance on the back stretch, only to have the Mayville runner increase the lead coming out of the last turn.

Meanwhile, Lomira was coming up behind Kewaskum and managed to get ahead of Aaron Kurth at the end of the third leg of the relay. Matt Tonn received the baton and passed Lomira on the back stretch only to be passed, in turn by Tony Tagliapietra of Lomira coming into the finish line.

What had potentially started as a race for first place, ended up being a race for second, as Mayville easily won the race and set a new school record of 3:26.0 in the process. Lomira was second with a time of 3:28.72 and also set a new school record. Kewaskum had to settle for third with a time of 3:29.92. This time was only 0.62 off Kewaskum's best time of the season.

"I know our four runners were very disappointed after they fin-

ished. They felt like they had done poorly and had let each other down after finishing in third," commented their coach Jerry Gosa. "They will have to bounce back on Thursday at Sectionals or their season is over," concluded their coach. Only the top two relay teams automatically qualify for the state track meet.

The 400m relay unit of Andy Rix, Aaron Kurth, Brian Butschlick and Ryan Herman ran their fastest time of the season in 46.12 and placed third and the right to move on to Sectionals. "Even though they ran their fastest time of the season, their handoffs need a lot of practice," reported their coach.

In the individual events, junior Brian Liegl placed second in the discus with a throw of 133'6". "It was good to see him qualify. Brian has been working hard and he is starting to regain his consistency," stated his coach.

In the 200m dash, senior Ryan Herman placed second in 23.74 to move on. Matt Tonn got off to a slow start and placed third in the 400m dash with a time of 52.85. Fellow teammate Joe Rettler placed fifth in 53.81. "I was a little disappointed with their times, especially with how well they both ran at the Conference meet," stated Coach Gosa. "They both feel that their best chance to make it to state is in the 1600m relay and not in the 400m open."

With the rains coming down early in the meet, Brad Herman surprised himself and his coach by placing second in the pole vault with a height of 9'6".

Other places for Kewaskum include Troy Staehler placing fourth in the 800m dash with a personal best time of 2:11.96, only 0.11 seconds

out of third place.

Matt Hammen placed fifth in the high jump with a jump of 5'8". Staehler and Josh Die-ringer placed fifth and sixth respectively in the pole vault with a height of 8'0". Andy Rix placed seventh in the 200m dash with a time of 24.7.

In team competition, host Mayville won the meet by scoring a very impressive 205 points. North Fond du Lac followed with 78 points and Lomira placed third with 70 points. Kewaskum placed fourth with 67 points. A total of ten schools competed at the regional.

On Thursday, May 23, the qualifiers from the Mayville Regional, Palmyra-Eagle Regional, and Pewaukee Regional traveled to Waterford for the Sectional competition. The first two finishers in each individual event or relay, plus the individuals and relay teams whose performances in sectional finals rank among the eight best of all sectional performances in Division 2, will participate at the state meet on May 31-June 1 at UW LaCrosse.

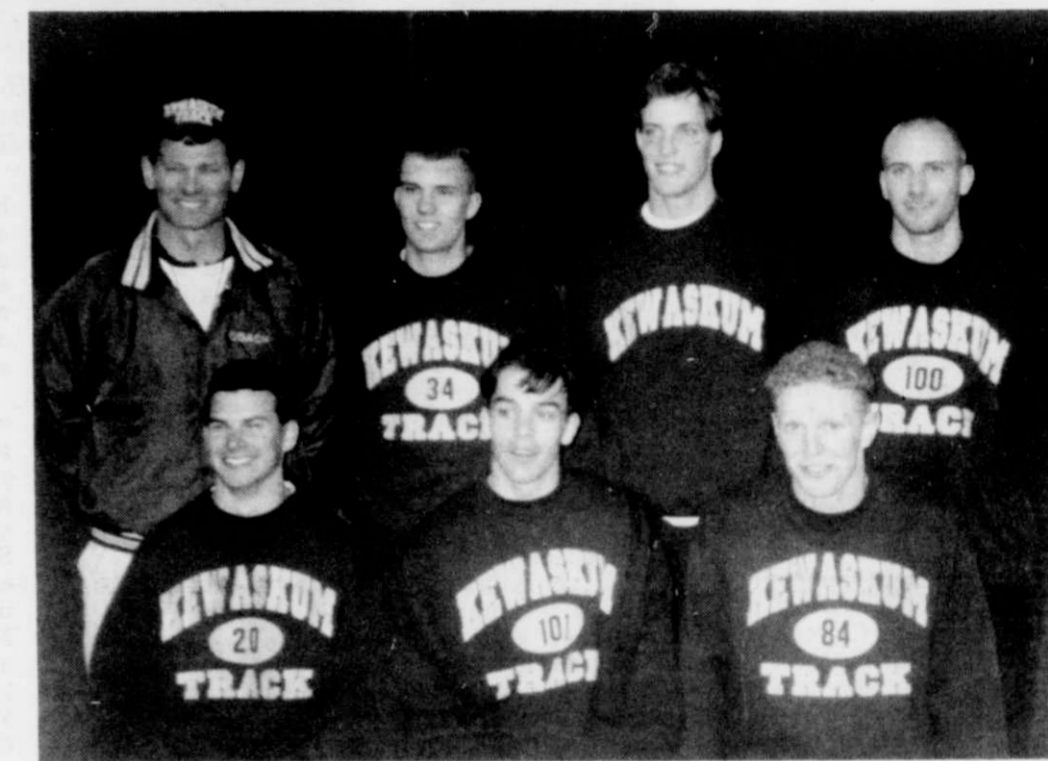

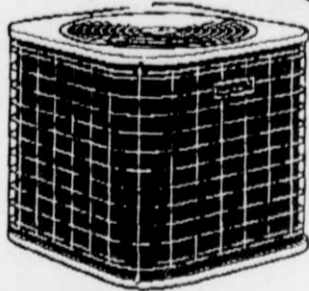

## Town of Wayne Passes Land Division Moratorium

At their May board meeting, officials from the Town of Wayne voted unanimously to establish an ordinance to create interim limitations on land divisions within the Town of Wayne effective June 1, 1996, for 18 months.

The moratorium will allow town officials to establish a land use plan. Board chairman Mark Strobel calls it a "cooling off period." As a result of the passage, town property owners will receive a questionnaire/survey requesting their input to the plan.

In recent months, the town has been inundated by requests to rezone agricultural land to residential and most have met with limited opposition from town residents. However, a recent rezoning request for land located on Sunset Drive has some neighbors and town residents up in arms.

The Town of Wayne Plan Commission considered a rezoning request from agricultural to residential on approximately 12 acres of land purchased by Kim and Mary Rodenkirch from the Frederick Baumgartner estate for the purpose of selling multiple lots. The request was back for consideration after a previous request to rezone approximately 80 acres was denied.

Several town residents spoke against the request at the April and May Plan Commission public hearing meetings citing increased traffic issues, driveway access, preservation of rural area and farmland, septic and water system concerns and cohabitation problems between a farmer's livelihood and those moving into a rural area to enjoy the serene setting.

A written protest with over 110 signatures against the rezoning of the parcel on Sunset Drive and other agricultural parcels in general was presented to Plan Commission members.

With the passage by the Plan Commission by a 5-2 vote, the rezoning request advanced to the town board for action. One resident cautioned the board if they followed the action of the Plan Commission and approved the request, that action would only open the floodgates for investors to come in and subdivide the Town of Wayne from one end to the

other. He asked the board to consider the long term effect of this decision.

Rodenkirch explained that two farmers are interested in purchasing the bulk of the good farmland. He hoped to work with the town on selling the land to develop the parcel in a matter that he could take residential zoning on some small residential lots in back of the parcel to provide nice homesites for people, their grandchildren and yet preserve green space for farmers.

Supervisor Mark Pamperin stated even considering all the issues that have been raised, he could not find this request any different from other requests he had voted for. Supervisor Leander Herriges was concerned with what the actual plans for the parcel are, citing several changes that had been made at recent meetings.

After further discussion, Pamperin moved that the rezoning request of the parcel from agricultural to residential be approved. With no second, the motion died. Herriges then moved that the request be denied. The motion was

seconded by Chairman Strobel. The vote was 2-1 with the request being denied.

In other business before the board, permission will be sought from the county to erect a sign in the medium clearly marking Commercial Lane to help eliminate motorists confusion between the ramp to Highway 41 and Commercial Lane.

Bids will be accepted on a 150 gallon gas tank the town no longer uses, necessary patching of roads and brushing are nearly complete and a bid was accepted for sealcoating and cold mix from Scott Construction of Lake Delton.

Citing past burglary problems at his store, approval was given to Dave Beyer of Uncle Sams Fireworks to move a temporary trailer to the property where the store is located with the board to review the request in one year. Beyer intends to eventually build a home on the property but explained there have been delays with building contractors preventing the start of construction.

The next Town of Wayne Plan Commission meeting will be Tuesday, June 18 at the town hall beginning at 7:30 p.m. with the monthly board meeting to follow on Wednesday, June 19, at 8 p.m.

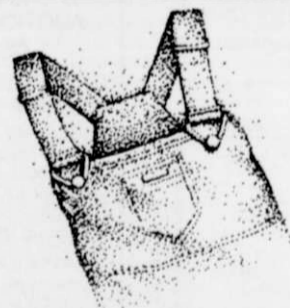

### Village Board Meeting Minutes

Regular Meeting  
April 29, 1996  
7:00 p.m.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Regular Session in the Council Room of the Municipal Building, 204 First Street.

President Robert Wagner presided. Trustee David Goeden arrived at 7:09 p.m. All other Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Harry Roecker, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote, the minutes of the April 15, 1996 meeting were approved as printed.

Chief of Police Richard L. Knoebel presented the March 1996 monthly report:

Criminal arrests 23, Criminal investigations 40; Traffic warnings 140, Traffic citations 27; Adult arrests 9, Juvenile arrests 15; Property stolen \$287, Property recovered \$508; Parking warnings 8, Parking tags 4.

Director of Public Works, Jerry Gilles reviewed a quote received on the straightening of the fence posts around the swimming pond. It was noted that approximately 24 posts needed to be replaced and fence tightened. The cost estimate was \$2,400 but since the company would be in the park for the ball field fencing they discounted the price to \$1,990. It was noted that if just a couple of additional posts were scattered in between they should also be done to help prolong the fence.

Director Gilles also explained to the Board that some valve work was needed in front of the Fire House because of leakage.

The proposals for the fine bubble aeration of the sewage treatment plant were reviewed as follows:

Energenics	\$35,500
Sanatair	\$31,100

It was noted this did not include the installation of the equipment. It was felt the WPC and DPW personnel could accomplish the work at substantial savings. The estimate for the installation was \$50,000 to \$60,000. It was also noted that if the fine bubble project did not proceed the standpipe portion would need to be replaced by itself, costing an estimated \$20,000. The equipment and installation cost should save enough energy to have a recovery of expense in around five years. The project has been budgeted for 1996 at an amount equal to \$85,522.

On a motion by Trustee Gary Gavin, seconded by Trustee Harry Roecker and unanimously carried by voice vote, the Board authorized the purchase of the fine bubble aeration equipment from the low bidder of Sanatair for \$31,100 with the WPC and DPW personnel doing the installation.

Administrator Daniel S. Schmidt reviewed the following with the Board:

1) Review of the Board of Review date and time, Monday, May 13, 1996 from 12:30 to

4:30 p.m.

2) Review of the budget control sheet for March 31, 1996.

3) Review of League and Taxpayer bulletins.

4) Review of Mid-Moraine Municipal meeting date and time.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee John Kenworthy and unanimously carried by voice vote, the Board approved the issuance of an Operator's License upon proper payment of fees and documentation for the following:

Piwoni, Thomas J. - Kewaskum, WI.

Note: The Police Department had no objections to any of the applications.

Chairman of the Park and Recreation Committee, Gary Gavin, announced a Committee meeting for the inspection of the parks on May 20, 1996 at 6:00 p.m.

Board Representative for the Plan Commission, Trustee David Goeden, reported that the Commission did meet on April 23, 1996 and that Mr. Rick Kania was present discussing and working on the Land Use Plan.

Administrator Daniel S. Schmidt informed the Board of the Railroad Commissioners meeting regarding the signals scheduled for May 9, 1996 at 1:00 p.m.

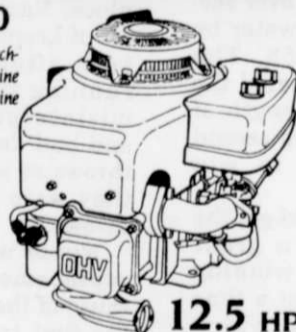

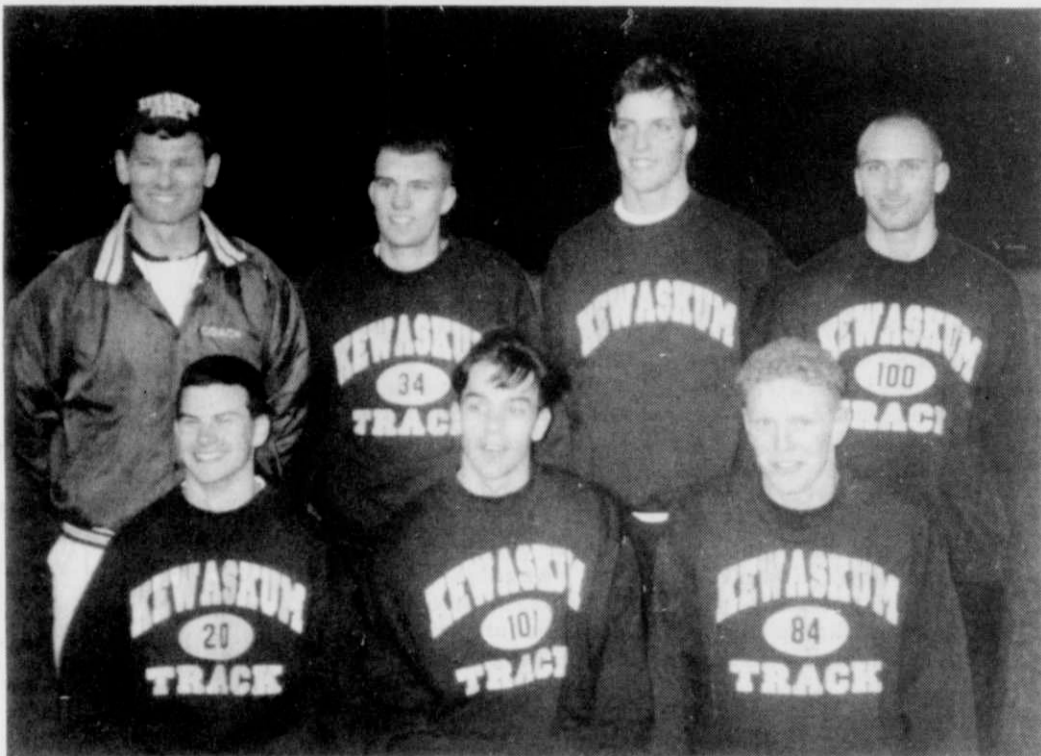

## Indian Girls Win Sectional Crown; Will Compete in Nine Events at State Track Meet

Eight individual entries and one relay! That's what the Kewaskum girls track team will be sending to the state track and field meet held this Friday and Saturday at UW LaCrosse.

The girls totally dominated the Sectional track meet in which 29 schools were competing. Going into the Sectional Track Meet with 12 individual entries and two relays, the team knew they would be the favorite to win the Sectional held at Waterford last Thursday. What they didn't expect was the huge margin of victory.

The girls won over second place Whitewater by a score of 96-58. The KHS girls dominated the meet on the strength of six firsts and two second place finishes to win going away.
