## Pastor James Bettin Announces Retirement

The official retirement for Pastor James Bettin of Peace United Church of Christ in Kewaskum began on August 1, just four days after the return of the Peace Church Habitat work crew, which he again coordinated in Michigan.

Rev. Bettin announced his plan to retire at the May, 1996 meeting of the Peace Church Consistory, and all members were informed of his plans by letter. He will continue to serve Peace Church as transition pastor for up to one year, dependent upon the securing of new pastoral leadership. At present, a church committee is preparing the church profile paper work to begin this search.

At the same time, the Barrier-Free Access Project is to be completed at the church in December of 1996, and Pastor Bettin is actively working with a very enthusiastic Centennial Committee for the 100th Anniversary of Peace Church in

James Bettin graduated from Oshkosh High School in 1947 and the University of Oshkosh (at that time, Oshkosh State Teachers College) in 1951. He received a Bachelor's Degree with a major in history and minors in English, Art, and Geology.

He developed a new art department at the Kewaunee Wisconsin High School and also taught Civics there from 1951 to 1954. In September of 1954, he entered Mission House Seminary near Sheboygan, as a seminary student of the Evangelical and Reformed Church.

His wife, Betty (Williams) Bettin, whom he married in December of 1952, taught English at Sheboygan North High School during those seminary years.

For one year he acted as youth director under Dr. Edmund Worthman at St. Peter's Church in Kiel, while in seminary. The Bettins also spent the final summer of his seminary training at St. Peter's Church in North Tonawanda, New York, where Bettin supplied the church as full-time pastor for three months. He tutored Hebrew at Mission House, with Greek and Hebrew being required subjects then.

He graduated with a Bachelor of Divinity degree in June of 1957 and was both ordained and installed as pastor of the dual charge of Bethany and New Elm Churches in Oshkosh, on June 9, 1957, where he served for four years.

Within a few weeks of his ordination, the merger of the Evangelical and Reformed with the Congregational Christian Churches took place. He

## Lions Chicken BBQ, **Kettle 20 Run Sunday**

If the recent Olympic games have inspired your competitive spirit, now is the time to test your athspeed endurance, by entering the annual Lion's Club Kettle 20 foot race, set for Sunday, August 11th.

The Kewaskum Lion's Club will be serving their famous chicken bar-b-q at River Hill Park while runners from across Wisconsin and neighboring states converge to vie for the coveted first place finish in the 20 kilometer (12.4 mile) event. Other runs include the 3.5 and 5 mile, and feature various men's and women's divisions.

The race is scheduled to begin at 8:30 a.m. in the park located along the Milwaukee River. Registration begins at 7:30 a.m. and runs through the time of the race. They can also be taken in advance.

Divisions for the Kettle 20 include six men's age groups: 1-17, 18-29, 30-39, 40-49, 50-59, and 60 and over. The five women's age groups include 1-17, 18-29, 30-39, 40 and over, and 50

Top male and female runners will receive a trophy, followed by medals for second and third place, with ribbons awarded for fourth and fifth. The two smaller races will also offer awards to the top place winners.

The entry fee for all racing events is \$9 with a T-Shirt, and \$7 without

the day of the race. Runners who register in advance will receive \$1 off the entry fee. This year's shirts were designed by Joan Squier, whose husband Dale, directs the event each year. The new design features a Kettle 20 banner with angels floating above.

Were expecting about 170 to 200 runners to register," states Dale, whose been in charge of the run for the past twenty years. "Right now I have forty runners registered, but we like to see 200, and it's usually close to that every year,' Squier said Tuesday.

Competitors enjoy coming back year after year to face the Kettle 20 challenge that takes runners through the rolling hills and scenic terrain of the Kettle Moraine State Forest.

All runners have the advantage of purchasing their chicken dinners for the special price of \$4.00 each, but must order their tickets before the race begins to take advantage of the opportu-

There will be six water stops along the route, located every two miles. Showers will be made available at Kewaskum Middle School.

The Lions Club will be serving their delicious dinners throughout the day beginning at 11 a.m. and running until 4 p.m. The cost is \$6.50 for 1/2 chicken, complete with mashed potatoes, vegeta-

## **KES Implementing New Student Pickup and Dropoff Procedures**

To better help insure the safety of the children who are students this year, the school district is implementing a new procedure for the beginning and ending of the school

The children can be dropped off at school in the front of the building or the north side after 8:30 a.m. The children are not to be on school property before that time unless it has been prearranged with school staff. Students are to report to the playground area in the back until they are brought into the building by school staff.

They are not to enter the building until 8:50 unless it has been prearranged with school staff.

There will be someone on duty to watch the children from 8:30 to 8:50. This is different than in the past and your help will be needed to make sure your children understand what they are to do. If there is bad weather, the children can report to the cafeteria using the back doors by the playground.

Dismissal is at 3:40, as in past years. The difference is that bus riders will report to the cafeteria and line up in bus

lines. Walkers will report to the gym. Students who are being picked up will report to the front of the school and will be picked up there.

Bus riders - will get their things together and report to the KES cafeteria. Here they can find younger/older siblings or friends which they ride with on the bus. It will also allow time for the children who are a little slow to get down stairs so they do not miss their bus. The children will then be dismissed for their bus at 3:45 from the

has since held his pastorate in the United Church of Christ, the denominational result of that merger.

From 1961 to 1966, he was called as pastor of St. Paul's United Church of Christ in Sheboygan. In 1966, he, Betty, and their two daughters, Ivy, seven years, and Amy, one, moved to Buffalo, New York, where Bettin served for six years as Administrator-Chaplain of the United Church Home for the Well-Aged, the only UCC home in Western New York State.

He trained for this position while still in Wisconsin at Cedar Lake Home of the UCC. At present, he serves as a volunteer on the Cedar Lake Campus Board of Directors near West Bend.

In 1972, the Bettins left Buffalo as Pastor Bettin returned to the parish ministry, serving until 1982 as senior pastor on a staff of three clergy-persons at Immanuel UCC at Lafayette, Indiana, a church of about 900 members.

From 1982 until 1986, he was senior pas-

Arlington Heights, Illinois. He has been at the Peace Church in Kewaskum for the ten years since 1986, having now completed over 39 years of active, ordained ministry. The transition period he now enters will involve a reduction of time and remuneration, but will include a complete ministerial service of preaching and involve-

The Bettins are building their retirement home in Oshkosh, where they were both born and raised. James was born on January 30, 1930. Their daughter and sonin-law, Amy and Stephen Funnell, live in Oshkosh with Bettins' grandchildren, Sonja, six years, and Eve, four.




cafeteria door and get on their bus, which will be parked on the north side of the building.

I had the privilege of talking to a state patrol officer and he said this was the first time the troopers had ever endorsed someone for sher-



## Peace Church Crew Participates in Annual Habitat for Humanity Work Project

The tenth anniversary work project week of the Habitat for Humanity crew of Peace United Church of Christ, Kewaskum, took place Saturday, July 20 to July 27, in the St. Ignace, Michigan area.

This marked a return to the 1995 Northern Straits Habitat work project site and involved completion labor on a Habitat house at Moran, Michigan, as well as the building of the newest house (the Northern Straits fifth one) in St. Ignace. The ten women and nine men working from Peace Church were able to see walls, roof, windows, and doors on this home by their depar-

As previously, the expense of the trip from Kewaskum was supported by the congregation of Peace Church, involving all transportation and food costs, plus a \$1,200 monetary gift to the Straits affiliate to purchase building supplies and materials.

All labor is voluntary; the Kewaskum supervisor was Howard Zemlicka, a seven year Peace Church Habitat worker, in cooperation with Clayton Stautz, with five years. It costs \$63.00 per crew member for the entire work week, with Marion Erdmann and Betty Bettin again acting as the crew cooks for the tenth year. The amount included all food and transportation.

Evangelical Free Church was once more the "home" in St. Ignace for the crew, with the volunteers sleeping on cots and air matresses and eating their meals in the fellowship hall.

Local Habitat affiliate volunteers supplied five noon lunches, delivered daily to the church -one day involving 20 eighteen inch filets of local fresh whitefish donated by the Mackinac Fish Market!

Both recipient families of the houses involving Peace Church labor were actively working with the actual construction, giving their part of the 500 hours of "sweat equity" required for an interest-free Habitat mortgage of ownership.

#### NATIONAL SCHOOL LUNCH PROGRAM Letter To All Households

#### Dear Parent/Guardian:

All schools in the Kewaskum School District serve meals each school day. Lunch ticket prices are \$5.50 per 5-day ticket for students in grades 1-5 and \$6.25 for students in grades 6-12. Daily tickets are also available. The cost is \$1.25 for students in grades 1-5 and \$1.40 for students in grades 9-12. Children also may get meals free or at a reduced price.

If you now get food stamps or AFDC for your children, your children can get free meals. If your total household income is the same or less than the amounts on the income Chart below, your children can get free meals or reduced price meals. A foster child may get free or reduced price meals regardless of your income. The reduced price is \$2.00 for a five-day ticket for all students.

TO GET FREE OR REDUCED PRICE MEALS FOR YOUR CHILDREN, YOU MUST COMPLETE AN APPLICATION AND RETURN IT TO THE SCHOOL. WE CANNOT APPROVE AN APPLICATION THAT IS NOT COMPLETE.

Yerification: Your eligibility may be checked at any time during the school year. School officials may ask you to send papers showing that your children should get free or reduced price meals.

Fair Hearing: You may talk to school officials if you do not agree with the school's decision on your application or the results of verification. You also may ask for a fair hearing. You may do this by calling or writing: Mrs. Jean Goeden, Board President, 2478 Hwy. 28 East, Kewaksum, WI 53040, Phone: 334-9549.

Reporting Changes: If your children get free or reduced price meals because of your income, you must tell the school if your household size decreases or your income increases by more than \$50 per month or \$600 per year. If your children get meals because they get food stamps or AFDC, you must tell the school when you are not getting AFDC or food stamps for them. You may then fill out another application giving income information.

## Kewaskum School District Official Notice Non-Discrimination Statement and Discrimination Complaint Procedure

The Kewaskum School District is committed and dedicated to the task of providing the best education possible for every child in the District for as long as the student can benefit from attendance and the student's conduct is compatible with the welfare of the entire student body.

The right of the student to be admitted to school and to participate fully in curricular, extracurricular, student services, recreational or other programs or activities shall not be abridged or impaired because of the student's sex, race, national origin, ancestry, creed, pregnancy, marital or parental status, sexual orientation or physical, mental, emotional or learning disability.

Complaints regarding the interpretation or application of this policy shall be referred to the District Administrator and processed in accordance with procedures established by the Discrimination Complaint Procedure.

#### Discrimination Complaint Procedure

Any complaint regarding the interpretation or application of Kewaskum School District's student non-discrimination policies shall be processed in accordance with the following grievance procedure:

1) Any student, parent or resident of the School District complaining of discrimination on the basis of sex, race, national origin, ancestry, creed, pregnancy, marital or parental status, sexual orientation or physical, mental, emotional or learning disability in school programs or activities shall report the complaint in writing to the District Administrator.

2) The District Administrator, upon receiving a written complaint, shall immediately undertake an investigation of the suspected infraction. The District Administrator will review with the building principal, or other appropriate persons, the facts comprising the alleged discrimination. Within 30 days after receiving the complaint, the District Administrator shall decide the merits of the case, determine the action to be taken, if any, and report in writing the findings and the resolution of the case to the grievant.

3) If the grievant is dissatisfied with the decision of the District Administrator, he/she may within 15 days, appeal the decision in writing to the School Board. The Board shall hear the appeal at its next regular meeting, or a special meeting may be called for the purpose of hearing the appeal. In either case, the Board must hear the appeal within 45 days of its receipt. The Board shall make its decision in writing within 15 days after the hearing. Copies of the written decision shall be mailed or delivered to the grievant and the District Administrator.

4) If the grievant is dissatisfied with the Board's decision, he/she may within 30 days appeal the decision in writing to the State Superintendent of Public Instruction.

5) Discrimination complaints relating to the identification, evaluation, educational placement or the provision of a free appropriate public education of a child with exceptional needs shall be processed in accordance with Wis. Stat. Ch. 115, Subch. V and Wis. Admin. Code Ch. PI 11.

6) Discrimination complaints relating to programs specifically governed by federal law or regulation shall be referred directly to the State Superintendent of Public Instruction.



The financial report of the Kewaskum School District was presented by Dr. Johnson.

There was no old business

Dr. Johnson gave his opening remarks which included a summation of District accomplishments during the 1995-96 school year and goals for the future.

George Allmann presented the 1996-97 budget. Don Nowak moved:

Be it resolved by the electors of the School District of Kewaskum that the annual salary of the School Board Members be set at \$1400 per year. Amy Pamperin seconded the motion. Secret ballot vote: 21 yes, 19 no, 1 abstention. Motion passed.

Frank Beesten moved:

Be it resolved by the electors of the School District of Kewaskum to authorize the payment of \$50.00 per day and \$50 per diem to school board members when traveling in the performance of duties that require them to be absent from regular employment. Augie Bilgo seconded the motion. After considerable discussion the motion and second were withdrawn.

Irene Heather moved:

Be it resolved by the electors of the School District of Kewaskum to authorize the payment of actual and necessary expenses of a school board member when traveling in the performance of duties and the reimbursement of a school board member for actual loss of earnings not to exceed \$50.00 per day when duties require the school board members to be absent from regular employment. Marilyn Terlinden seconded the motion. Secret ballot vote: 35 yes, 7 no. Motion passed.

Elmer Hallen moved: Be it resolved by the electors of the School District of Kewaskum that the School Board be authorized to sell or otherwise dispose of obsolete or unused furniture and equipment which is no longer needed for use by the district. Irene Heather seconded the motion. Motion passed by a voice vote.

Jean Goeden moved: Be it resolved by the electors of the Kewaskum School District that the School Board provide for a school lunch program and appropriate funds for that purpose. Lisa Maul seconded the motion. Motion passed on a voice vote.

Jon Downs moved:

Be it resolved by the electors of the Kewaskum School District that the School Board be authorized to furnish textbooks to students under conditions prescribed by the Board of Education. Frank Beesten seconded the motion. Motion passed on a voice vote.

Be it resolved by the electors of the School District that the School Board operate and maintain transportation vehicles and to purchase liability insurance for such vehicles, and to finance contracts for the use and services of such vehicles. Be it resolved by the electors of the School District of Kewaskum that the tax levy for the 1996-97 budget will include a \$1.00/\$1,000 equalized for the purpose of long-term debt reduction. Tom Timblin seconded the motion. Secr lot vote: 25 yes, 18 no. Motion passed.

Frank Beesten moved: Be it resolved by the electors of the School District of Kewaskum that a tax be levied on all taxable property of the district for operating expenses and capital outlay for the 1996-97 school year in the amount of \$4,464,798 and for debt retirement in the amount of \$1,194,659. Lisa Maul seconded the motion. Motion passed by a voice vote.

Chairperson Weare asked those in attendance if anyone cared to discuss any other matters provided by law relating to the management of the district. No other matters were

The School District of Kewaskum has nounced its policy for children unable to pay the full price of meals served under National School Lunch Program. Each school

Application forms were given to each family on registration day. To apply for free or reduced price meals households must fill out the application and return it to the school. Additional copies are available at the principals office in each school. The information provided on the application will be used for the purpose of determining eligibility and may be verified at any time during the school year by school or other program officials. Applications may be submitted at any

time during the year. To obtain free or reduced price meals for children for whom households receive Food Stamps or Aid to Families with Dependent Children (AFDC), an adult member needs only to list the names of the school children, give Food Stamp or AFDC case number for each child, sign his/her name and return the application to school the

Households must inform the school authorities when they no longer receive Food Stamps or

AFDC. For the school officials to determine eligibility for free or reduced price meals of households not receiving Food Stamps or AFDC, the household must provide the following information request ed on the application: names of all household members, and the social security number, of the adult household member who signs the application. In lieu of a social security number, the household may indicate that the signer does not possess a social security number. Also, the income received by each household member must be provided by amount and source (wages, welfare, child support, etc.). Households are required to report increases in income of over \$50 per

month or \$600 per year and decreases in house-

Under the provisions of the free and reduced price meal policy, the District Administrator will review applications and determine eligibility. If a parent or guardian is dissatisfied with the ruling of the officials, he/she may wish to discuss the decision with the determining official on an informal basis. If the parent/guardian wishes to make a formal appeal, he/she may make a request either, orally, or in writing to: Mrs. Jean Goeden, School Board President, 2478 Hwy. 28 East, Kewaskum, WI 53040, Phone 334-9549. If a hearing is needed to appeal the decision, the policy contains an outline of the hearing procedure.

If a household member becomes unemployed, or if the household size changes, the family should contact the school. Such changes may make the household eligible for reduced price meals or free meals if the household income falls at or below the level shown above, and they may reapply at that time.

In certain cases foster children are also eligible for these benefits. If a household has foster children living with them and wishes to apply for free or reduced price meals, the household should complete an application for a family of one or contact the school for more information.

The information provided by the household on the application is confidential and will be used only for purposes of determining eligibility and verifying data.

#### TYPE E NOTICE - VOTING BY ABSENTEE BALLOT

Any qualified elector unable to get to the polling place on election day may request to vote an absentee ballot. A qualified elector is any U.S. citizen, who will be 18 years of age or older on election day, who has resided in the ward or municipality where he or she wishes to vote for at least 10 days before the election. If voter registration is required, the elector must also be registered.

## Get Permission Before the Hunting Season Begins

It maybe hard to think about the hunting seasons beginning in September when the temperature is 90 degrees, but now is the time to make some contacts with private property owners.

One of the down sides of being a Conservation Warden is hearing all the stories from private property owners of hunters trespassing on their property without permission.

I hear stories of treestands being stolen, nails driven into trees, and trees cut down, and I have even heard of a trespasser attempting to kick a property owner off of his own property.

Being a hunter myself, it is embarrassing to hear stories like this, and easy to understand why some private property owners will not allow hunters on their property

Now is the time to get permission. It may seem early but the hunting seasons are just a little over a month away. With the early Canada Goose hunt beginning Tuesday, September 3, the hunting season is not far off.

Another considera-

tion is the increased opportunity to harvest deer this year, especially in the Zone T Units. I'm sure many hunters applied for a free tag but have no idea where they are going to hunt in Zone T

Property owners also like to be contacted before the season starts and with the number of reports I have received of crop damage so far this summer, I would think many of them would appreciate the thinning out of some wildlife.

Don't forget to make contact with property owners who have given you permission to hunt in the past. Just because you asked several years doesn't mean you have permission for the rest of your life. Things can change, like maybe the property owner that gave yor permission sold the property to someone else. It has happened.

As hunters, we cannot afford to upset private property owners. We need the opportunity to hunt on private property and must realize that it is a privilege. Not every landowner is going to allow hunting on their property, but it is up to us as responsible hunters to promote good hunter-landowner relations to keep the land open to hunting which is open now, and encourage other landowners to open their land to hunters in the future.
