Barn Destroyed, Man Injured in Explosion

On Tuesday, November 26, at approximately 3 p.m., an 84-year-old Town of Addison man was injured following a propane gas explosion and barn fire at 6816 CTH WW.

The man had finished repairs to a propane gas furnace located inside the barn and when he ignited the furnace, the explosion occurred.

The man, identified as Felix J. Heilmann of West Bend, suffered second degree burns to his face and third degree burns to his hands. He was transported to St. Joseph's Community Hospital, West Bend, for treatment of his injuries.

The barn, a two story wooden structure was completely destroyed by the fire. It is owned by Lloyd J.

Moritz of West Bend. Thirteen head of cattle were also lost, and farm machinery that was stored in the barn, was damaged extensively.

The Allenton Fire Department responded to the fire, assisted by departments from Kohlsville, Kewaskum, St. Lawrence, Slinger, West Bend, Theresa and Iron Ridge providing mutual aid.

Winter Parking Goes In Effect Dec. 1

Board Approves Budget

During another marathon three-hour session, the Kewaskum Village Board unanimously approved the \$1,657,289 budget for 1997 at Monday evening's budget hearing without a single taxpayer in attendance.

Village Administrator Daniel Schmidt gave a summary of the budget and the facts surrounding it, remarking, "To establish the budget we have to talk about the equalized value. Our equalized value has gone up \$5.3 million or 4.8%. The assessed value did not go up that much. It went up \$3,300,000 or 2.9%. I want to also point out that the State Assessed Property and Personal Property did see a decrease to the tune of \$2.5 million or 2.2%"

Trustee Gary Gavin asked, "Where's the major loss there?"

Schmidt explained the major loss is due to the state changes on how they assess electronic computer equipment. He added computer equipment changes so rapidly that by the third or fourth year, the equipment is obsolete. Schmidt cited examples of Kewaskum businesses that will see a substantial decrease in personal property due to this state change.

Trustee Gavin also asked, "Where does the state figure they're going to pick up the

difference on this loss of revenue?"

"Basically," Schmidt stated, "it's just that, lost revenue." He added the State was looking at other means of recouping that revenue.

Getting back to the budget, Schmidt further explained the general budget has actually decreased \$169,782 or 9.3%. However, the property tax levy to be collected will be reflecting an increase, caused from real growth within the Village, plus a slight increase.

Looking at the entire picture, Schmidt clarified the tax levy will reflect an increase of \$49,598 or 8.6%. The Village Property Tax Rate will also reflect an increase of 28.8 cents or 5.5% in comparison to that of 1995/1996.

The assessed gross tax rate has decreased from \$25.56 to \$22.10 this year, a decrease of \$3.46 or 13.5%. All taxing jurisdictions have followed in the Village's footsteps generally, stabilizing their budgets and with the help of additional state funds being sent to the school districts, decreases are being realized. The Village Board has no authority to approve or disapprove of these rates, but are mandated to collect those taxes.

The State Tax Credit for 1997 will be \$1.81 per

\$1,000 of assessed value, which reflects an increase of 59 cents or 48.4%. This means the net tax rate is \$20.29, which means a decrease of \$4.05 or 16.6%.

Schmidt also noted that the State of Wisconsin has kept the "Lottery Credit" on the tax bill, however due to litigation there will be no distribution of the "Lottery Credit" on the 1996 tax bill. It was estimated that the state average would have been \$100 per each claimed primary residence, down from that of last year.

The level of all basic services has remained at or near the same in previous years. There will be a modest amount of street maintenance work accomplished in 1997. However, with the State Legislature not increasing the Department of Transportation budget, it is likely the Village will need to hold back on the expansion of proposed street work.

It should also be noted that the Village has again had its share of State Shared Revenue of Expenditure Restraint monies cut. This year approximately \$22,700 will be lost.

In his annual Memo to Taxpayers, Schmidt concluded the 1997 Village Budget will allow them to continue to provide essential services and to continue to provide the quality of life the citizens desire.

Due to the length of the meeting, the bulk of other matters brought before the board will be addressed in next week's issue, however, it is important to note, according to Police Chief Richard Knoebel, winter parking restrictions will go into effect at midnight on December 1.

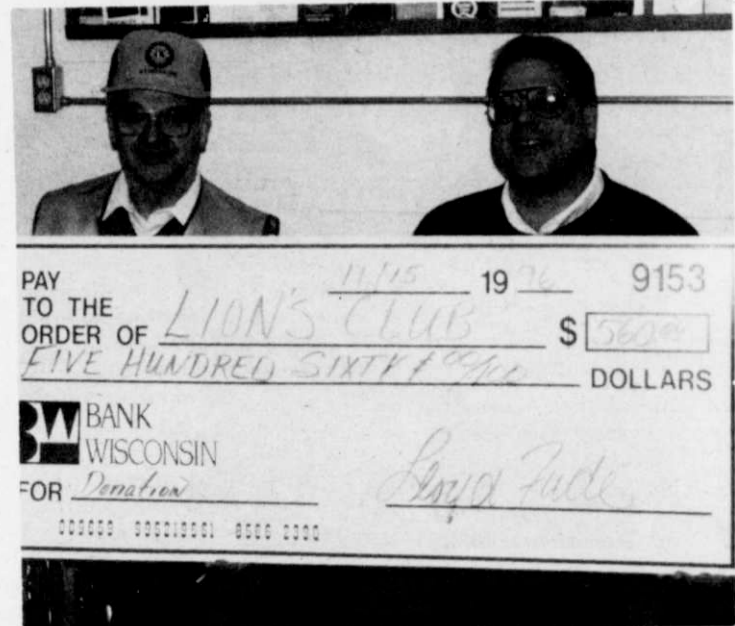
Rumors have also been surfacing that a few community organizations will

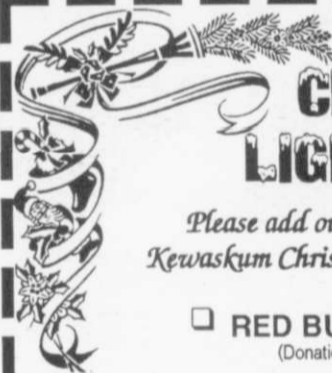

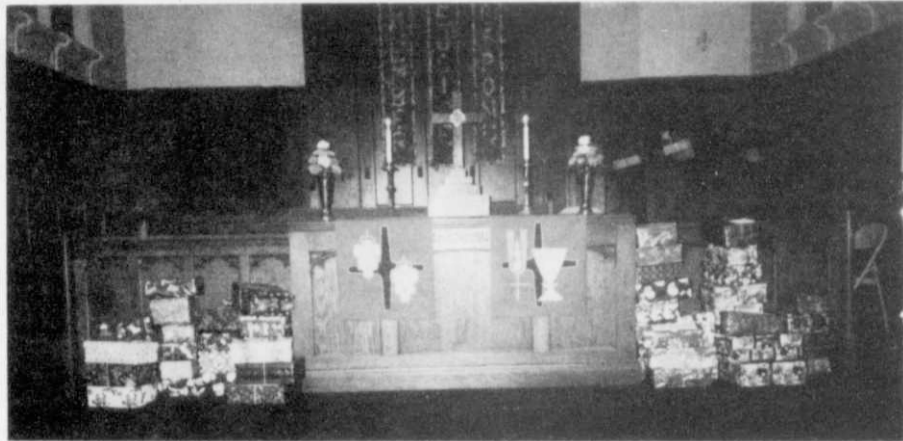

Operation Christmas Child At Peace UCC



"Operation Christmas Child" gifts dedicated at Peace UCC Church, Kewaskum, on Sunday, Dec. 10th.

"Operation Christmas Child," a mission outreach of Peace United Church of Christ, Kewaskum, was climaxed with the dedication of 62 gift boxes at the Sunday, Nov. 17, worship service. Sponsored by the local board of Christian Education, this Evangelical Program to fifteen countries with children in dire need of Christian help was targeted for the Sunday School of Peace Church, but open to all members wishing to give

a shoebox of small gifts - wrapped and ready for shipment and distribution. Racine, Wisconsin is the collection point for this state, with the national distribution being directed from North Carolina. An optional donation of \$5.00 to cover shipping could also be made, and all of the Peace Church gifts were so covered when delivered on November 19. Each box is designated for either a boy or girl in

one of four categories, ranging from infant through grade six. With the lids separately gift-wrapped and a rubber band closure, all the boxes are then given a special Christmas Bonus by Ruth Graham, wife of Evangelist Billy Graham, in North Carolina. A music box which plays "Jesus Loves Me," accompanied by the written words of the song in the appropriate language of the country of reception is a visible sign of the Christ focus of Christmas for the gift child.

This program was begun in 1993 with 28,000 boxes being sent out. 110,000 were sent in 1994, and 812,000 boxes show the growing success of the venture in 1995. In addition to the U.S., the United Kingdom, Canada, Australia, and the Netherlands are

also distributing countries now.

Children receiving the gift boxes this year are in fifteen countries: Bosnia, Rwanda, Russia, Jordan, Nicaragua, Croatia, Serbia, Kenya, Mexico, Romania, Slovenia, Hungary, the

Ukraine, Albania, and Belarus - plus certain Middle East areas. For most of the children, these boxes will be the only gift to be available due to poverty, war displacement and destruction, and family separations.

VILLAGE OF KEWASKUM NEWS NOTES

"Snow and Ice Removal"

The snow and ice season has arrived bringing along some problems. To alleviate the problem or to clarify a few items, let us refer to the Municipal Code, Chapter 8.09, which covers "Snow and Ice Removal."

I. SIDEWALKS TO BE KEPT CLEAR. The owner or occupant of any lot or parcel shall promptly each day, remove all snow and ice which may have fallen or accumulated upon the sidewalk in front of each lot or parcel; provided, when ice has so formed that it cannot be removed, the owner or occupant shall keep the same sprinkled with a material which will prevent the sidewalk from being dangerous to pedestrians. If the owner or occupant fails to comply with this subsection, the Director of Public Works shall cause the snow or ice to be removed or sprinkled as required in this section and the cost thereof assessed against the property as a special tax or charge against the property to be collected in the manner specified in sub. (3).

If the Village Director of Public Works orders such removal of snow and ice, a minimum charge of \$25 shall be affixed as the expense of such removal or treatment. If the cost of removal or treatment exceeds the \$25 minimum, the actual cost for such work, per occurrence, shall be charged plus a 10% handling charge.

II. SNOW NOT TO BE DEPOSITED IN STREET. No person shall cause to be deposited snow from his premises or sidewalk abutting thereon onto any street in the Village without a permit from the Director of Public Works who may require to be paid a fee sufficient to reimburse the Village for the cost of removal of such snow.

III. ASSESSMENT OF COST. If after the report of work is filed and billed the same is not paid within 30 days, it shall bear interest at the rate of 6% per annum from the date on which the work was completed. If not paid by October 1, the cost thereof will be assessed against the property as a special tax, etc.

As for this and all ordinances a penalty is also provided for in Chapter 25.04 of this Municipal Code.

Olde Cascade General Store

Remember the days when businesses gave their customers the "red carpet treatment," and idle conversation was a favorite pastime?

Nostalgia buffs will enjoy revisiting the 1880's at The Olde Cascade General Store and Delicatessen, located along Highway 28 in Cascade, where charm and old fashioned hospitality is dished up alongside a variety of deli cuisine.

Situated in the historic O'Hearn building, the store's interior has been painstakingly restored to reflect the original character of its era by business partners Donna Hahn and Lynn Beckford.

The building itself has been in use for over one hundred years, first built at the turn of the century by Edward H. O'Hearn as a furniture and undertaking parlor. In 1902 it became a saloon operated by Ulysses S. Swann, the first of a number of owners.

In 1922, it became a grocery and dry goods store, operated by August Torke, whose son, Carl, continued to run a tavern in the rear of the store. Mary Hollister Scharf purchased the business in 1928 and successfully operated the grocery store until it was purchased in the 1930's by Edwin F. Weinhold, of nearby Adell, assisted by his son Merlin.

Merlin and his wife Ethel purchased the business and continued to operate the store, where it remained in the same family for 39 years, serving the small community of Cascade.

In 1978, Donna and her husband, Chuck, purchased the store from the retiring Weinholds, and continued in the same business, offer-

ing a full line of groceries, along with a fresh meat department. In 1989, they started up Madison Avenue Liquor and Gifts, located across the street, and ran both businesses until 1991, when Chuck passed away.

Donna then decided to consolidate both stores into one building, which lasted until January of 1996, when she realized she could no longer do this all alone. "For financial and emotional reasons, I closed down the business," she relates. "Sales were dropping, and I didn't have any family nearby that could help. It was a situation where the town needed you badly, but not bad enough to keep you going."

Before she closed the doors, Donna ran a flyer in the Plymouth Review, making public her intentions, with a last plea to customers to help increase business to save the store. Nevertheless, "going out of business sales" commenced and she toyed with other ideas for the old building, finally deciding the best route would be to turn it into apartments. "I really didn't want to give up the store, and kept trying to come up with a better alternative," she remarks.

Lynn Beckford then entered the picture, a good customer for 17 years who lived outside of town. She started talking with her husband, Chip, about what she wanted to do for the rest of her life, now that the children were grown. "It started to evolve when Donna and I put our heads together," Lynn states, her enthusiasm sparked by a love for anything historical, a real antique hunter and frequent visitor of Paul's Auctions in Kewaskum.

Once the two women decided on the theme, "Old

Fashioned Country Store," there was no stopping them, and authenticity was top priority. After remodeling began, old wainscoting, wood ceilings, and original hardwood floors were revealed, and the restoration took on a purist's approach. "The entire front half of the store is original," Lynn boasts proudly.

"We wondered how big to make this place, and we first started out planning it as a carry-out type of deli, but it got bigger and bigger, and now it's almost a full line store."

What works so well, Lynn believes, is the combination of knowledge both owners bring into the business. Donna, with her years of experience in groceries and liquor, and Lynn's passion for antiques and restoration, have created a cozy atmosphere that makes customers want to "just sit and relax." "It's comfortable," Lynn plainly states.

The Olde Cascade General Store and Delicatessen offers a wide variety of custom made deli sandwiches, using fresh cut meats, veggies and all the fixings. Homemade soups simmer in big stainless steel pots, and their ice cream parlor serves up sundaes, malts, and hand dipped ice cream cones.

Customers include local clientele, truckers, employees on lunch break, and families out for a leisurely drive through the country. Orders are taken at the back counter and brought up front, where tables sit amidst an array of nostalgic furnishings and collectibles.

A checkerboard, deck of cards, and daily newspapers invite clientele to linger and relax for awhile, away from the daily grind. "We figure 2,500 cars pass by here daily, so it's a great location for this type of specialty business," Lynn maintains.

"Almost everything you see in the store is for sale," Lynn points out, including granite ware, reproduction canned goods with old time labels, gift baskets, framed copies of old magazine ads,

tables, frames, rug beaters, old bottles and glassware, homemade brooms and walking sticks, even the bathroom decor can be purchased.

"One woman came out of the bathroom and made her husband come back in to look at something she wanted to buy," laughs Lynn. Most everything is antique related, and reasonably priced, she adds.

Simple touches spoil the customers; coffee in glass cups with a doily placed underneath, big old fashioned malt glasses, fancy sugar cones. "It took us five months to come up with things that are different," Lynn explains. "We wanted to do things that no one else in town does."

Their menu also offers salads, cookies, tortes, pies, cheesecake, hot cocoa, apple cider and fresh popped pop-

corn.

Along with their line of groceries, the store carries fine wines, quality beer and liquor, party trays, deli meats and sausage, Wisconsin cheese, three to eight foot party subs, gift boxes and baskets, and Schwans ice cream favorites. "We do some catering now, cheese trays, hot beef, ham and pork, with plans to add more items in the future," Lynn states. "The stuff we have for sale here is the same stuff we use in our cafe."

The Olde Cascade General Store and Delicatessen is open daily, Monday through Saturday 10 a.m. to 7 p.m., and Sundays from 10 a.m. to 4 p.m., offering daily specials and a touch of charm that keeps customers coming back for more.

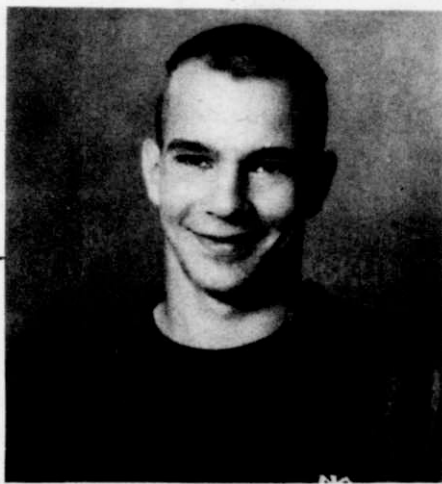

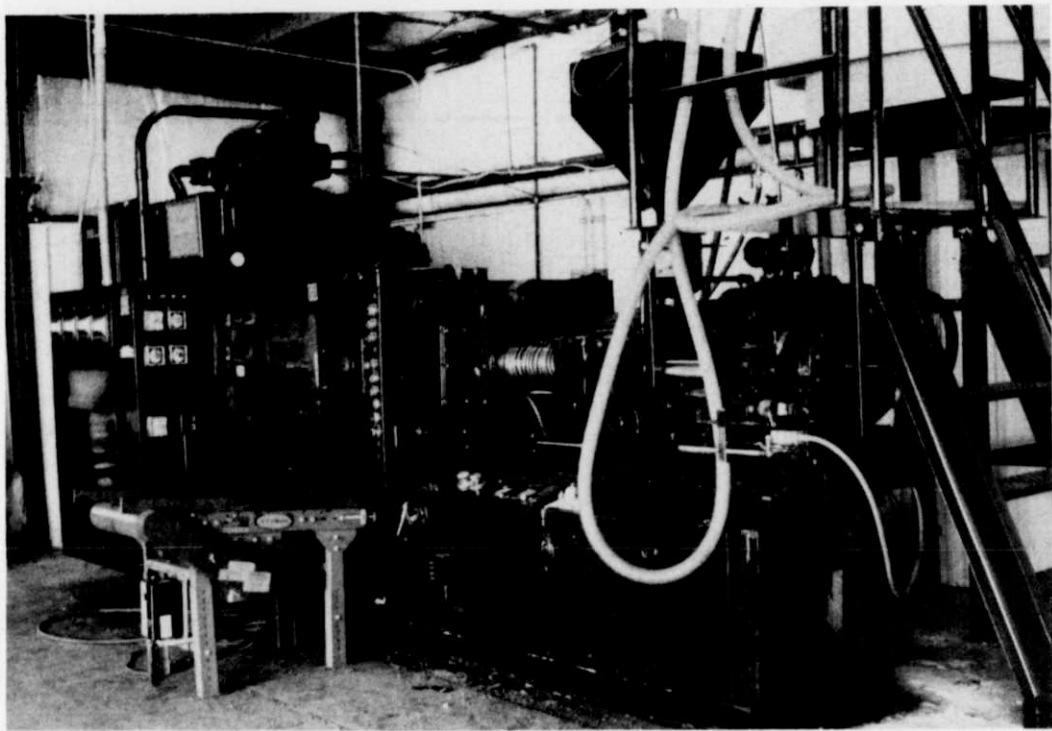

Two new businesses moved into the area rather quietly this past July, and although they may have gone unnoticed in a small town that usually knows everything, their story includes a new partnership, an innovative new product, and plans for future expansion.

Tech-Ni-Fab and Arc Industries, located along Highway 28 east (in the former Johann Plumbing building), recently announced the blending of their businesses into a new partnership, CDM Technologies.

Jan Chilson, founder of Arc Industries, commented that the partnership will allow for increased diversity between two distinct companies that work very well together.

Tom Benzschawel purchased Tech-Ni-Fab, a 20-year-old company originally from Menomonee Falls, in February of this year. Hired as General Manager in 1995 with intent to purchase, Tom decided to move the company back to the area where he grew up in after the sale was completed. Tech-Ni-Fab purchased the Johann building this past May, and two months later, set up shop building and selling specialty conveyor

systems.

"We build unique systems you can't normally buy from other sources," Benzschawel explains, with a list of customers that include J.C. Penney Distribution Center, Signa-Cast, and Bemis of Sheboygan Falls.

They also serve as an installer of Hytrol conveyors for the Babush Company of Menomonee Falls. Tech-Ni-Fab conveyor systems are built to fit specific dimensions, and accommodate custom lifts and turntables. "We also build some food grade systems, which require stainless steel," he points out, "but not a lot. We may have the capacity to do more in the future."

Their partner, Arc Industries, is a custom injection molding company, that manufactures a state of the art "fire starter" for the Meteor Lite Corp. We have developed a technologically advanced system, which means no one in the field has been able to do what we do," states Jan Chilson, who invented a new molding technique for the product after being told, "it couldn't be done."

Chilson, whose husband Leo is a Tool and Die maker, had no previous experience in the field. "I was a housewife up until June of this year," she

states, "but I had acquired a lot of knowledge about molding procedures from listening to my husband and other family members that were in the tool and die trade."

After talking with the owner of the Meteor Lite Corporation, a family friend who approached her about working for the corporation, she informed him that their product could be produced more efficiently and consistently by another means, although other nationally known companies said it was impossible. Within six weeks, she formed a new business and production began with incredible results.

The fire starter is a unique blend of wax and wood, molded into a circular shaped form with a hole in the center. "Up until now, fire starters have basically

been in liquid form (charcoal lighter fluid) or an extruded product," she explains, "and have been either difficult to light or contain some kind of petro fuel. Hopefully, our product will serve to eventually eliminate lighter fluid, which is already banned in California, effective in 1997."

"The Meteor Lite Fire Starter is environmentally friendly, and toxin free, leaving only a carbon ash residue. It truly leaves no taste on food cooked over an open fire, and burns for ten to fifteen minutes," Jan asserts. "You can light it, put your charcoal on the grill, walk away, come back 15 minutes later, and the grill is ready."

The product can also be used for starting camp fires, wood stoves, fireplaces, and is an asset for survival kits, whether hiking, hunting or backpacking.

Approximately 20 million fire starters will be manufactured in a year, and are presently being sold through Plow and Hearth catalog, in packages of two, six or 24. The product will also be sold on QVC, and introduced into the retail market by spring.

Wendy Baackes, who manages the offices of both companies, recently became a third partner in CDM Technologies, having worked with Tom at Tech-Ni-Fab's previous location in Menomonee Falls. June McDaniel, Jan's mother, is also a silent partner in the business.

With a total of ten employees, including the owners, both Tech-Ni-Fab and Arc Industries are growing and changing at a rapid pace. The companies are hiring two additional workers, and by next Friday, a full time staff will be manning three shifts to keep up with spring orders. A new CAD system and plotter has been ordered for designing blueprints, with plans to add a mechanical designer to their expanding staff in the near future.

At this time, Arc Industries is covering all phases of production of the fire starter for Meteor Lite, from processing of the mate-

rials to final packaging, and will eventually become involved in product sales and distribution. Two new injection molding machines will be in place on their production line by the end of January. "Tom also has a background in injection molding, and that's another reason our companies work so well together," Jan points out. "Our big focus will be getting this product out on the market."

Benzschawel has been hard at work developing his latest idea, and another state of the art camping related product, and CDM Technologies is looking forward to revealing this "new invention" to the public sometime in March. "My family and I enjoy camping, and I just came up with something I felt there was a definite need for," he relates.

"We want to be known as innovative, and let people know we're willing to help them with their ideas for products, to help get them out on the market," Chilson adds. "When we help each other, when we help out the little guys, we're helping ourselves."

Foreseeing the capability of rapid growth well into 1997, and expanding into the plastic injection molding after the first of the year, the businesses already senses the need for larger facilities, since they plan on remaining in the area a long time. "We will be planning on enlarging the building at some point," Tom mentions. "Of course, it's the goal and dream of any business." The building is now divided into a factory area, office, conference room, and recreation area.

During off hours, the three partners enjoy spending time with their families. Tom resides in Cascade, with his wife Debby, and three daughters, Becky, Katie, and Beth. Jan lives in Kewaskum with husband Leo and four children, Brian, Eric, Ashley and Alexander. Wendy and her husband Brad make their home in Oostburg with their two girls, Kendra and Allyson.

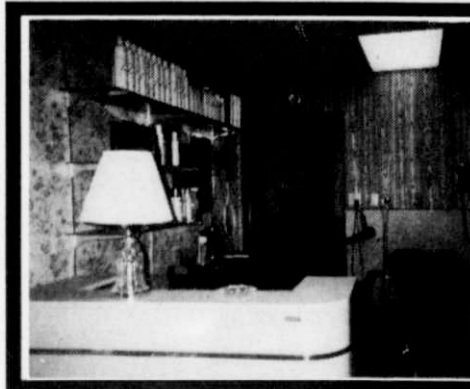

Kids can make a difference. In Wayne, Farmington, and Kewaskum Elementary Schools, they do... and the state is impressed with what they've been doing.

In fact, the Just Say No Clubs of the District elementary schools have been selected as one of only six organizations throughout the entire state to receive a prestigious "Exemplary Program" award from the State of Wisconsin for "outstanding contributions

made to the citizens of Wisconsin in the area of substance abuse prevention."

The State Council on Alcohol and Other Drug Abuse considered many factors in its selection process. High on its list was the involvement of the elementary students in promoting drug prevention throughout the District (such as red Ribbon

week for grades K-12), as well as contributions of over \$4000 (from sucker sales) to numerous community organizations and causes. The award is scheduled to be presented by the Governor in a Madison ceremony on December 13.

As an "Exemplary Program," the Kewaskum Just Say No Clubs will serve as a drug prevention model highlighted in state and local publications. They will also be showcased, along with other awardees, in a document to be distributed statewide.

The Clubs have been visible throughout the area in a number of other ways, too. This past summer, for instance, Club members participated in a balloon launch to send the Just Say No message beyond the borders of the District. Most recently, the clubs sponsored the November 21 "Great American Smoke-out" for the eighth straight year, providing stop-smoking survival kits to community members, as well as information about smoking prevention to schoolmates.

WINTER PARKING

The Winter Parking Restrictions and Snow Emergency Parking Restrictions go into effect at mid-night (12:00 a.m.) on December 1, 1996.

Municipal Code Section 7.04(3) Night Parking Restrictions, reads as follows: Signs have been erected at or reasonably near the corporate limits as provided in Section 349.13, Wisconsin Statutes, no person excepting physicians or licensed emergency vehicles on emergency calls, shall park or stop any vehicle on any public street or highway within the village between the hours of 2:00 A.M. and 6:00 A.M. from December 1, to April 1, of each year; provided that, notwithstanding such restrictions vehicles may be parked a period of time not longer than 3 minutes for actually loading or unloading of passengers, and provided further that no other regulation restricting parking as to place, time, or manner violated thereby.

The fine for violating the ordinance is:

\$5.00 if paid within three (3) days of the issuance of the parking citation.

\$10.00 if paid after ten (10) days but before 28 days.

After 28 days, the amount is \$25.00 and a notice will be sent to the Motor Vehicle Department to suspend your vehicle registrations and refuse renewals until the citation is satisfied.

An important fact is the owner of the vehicle is responsible for the payment of the citation whether or not he or she was the operator.

Municipal Code Section 7.04 (4) Removal of Illegally Parked Vehicles. This section covers the issuance of citations to and possible removal of such vehicles in violation of this ordinance. In addition to other penalties provided by Section 7.04(6) of this code, the owner or operator of a vehicle so removed shall pay the cost of the towing and storage.

More than 87,000 permits in 50 zones will be available this spring, according to Tom Howard, DNR turkey specialist in Dodgeville. Research projects on the turkey population in management zones 1 and 1A have been completed, Howard says, and the two zones have been rejoined as zone 1. Hunters who have been applying for permits in zone 1A should now request zone 1.

There are additional turkey hunting opportunities for hunters with disabilities in five state parks during the first three spring hunting periods. They are Natural Bridge, Nelson Dewey, Belmont Mound, New Glarus Woods, and Rocky Arbor state parks.

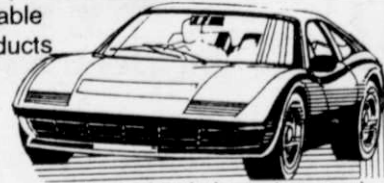

IRA President Steve Sinclair wrote, "Frank always had encouraging words for the drivers... and with his competitive spirit, childlike enthusiasm and sense of humor, Frank will be sadly missed."

Other familiar named drivers who were honored were former (EWSCA) Eastern Wisconsin Stock Car Association champion Terry Chesak of Newburg, who finished ninth with 2180 points; 58-year-old former Milwaukee Stock Car (MSC)/EWSCA driver, Bob Robel of Oconomowoc, who finished 16th with 1854 points; Scott Neitzel of Fox Lake (protege of former MSC/EWSCA driver, Rick Lamanski), who finished 17th with 1844 points and Jim Melis of Plymouth, who took his #51 M to 11th in the point standings.
