One Non-Incumbent Each Also File Nomination Papers for Village, School Board Seats

As of Tuesday's 5 p.m. deadline, all incumbents and prospective candidates for both Kewaskum village and school seats have signed and filed the required nomination papers declaring their candidacy in the upcoming spring elections, being held April 1st.

The two seats on the school board up for re-election are those of board president Jean Goeden and Neal Weare. Both are seeking another term, Goeden's third and Weare's fourth - although both have served on the school board on and off for years previous.

Lisa Maul, from the town of Wayne will be vying for one of their positions on the ballot. Maul ran in last

year's school board elections, but was defeated. Clara Trapp of Adell also took out nomination papers, but has not returned them.

The village board has three trustee seats up for re-election, as well as the village president's position. Current president Robert Wagner is seeking re-election, along with trustees Gary Gavin and Harry Roecker. The third board member, Dave Goeden, has decided not to seek another term.

The only non-incumbent to face village board elections will be Andy Pesch, a resident of the village, who turned in his papers late on Tuesday.

Chamber of Commerce Meeting Wednesday

At their November meeting, Kewaskum Area Chamber of Commerce members voted to cancel their December 18th meeting, due to its close proximity to the Christmas holiday.

A potluck supper preceded the regular November meeting which was attended by 12 of the 82 members of the Chamber. (Unless my knowledge of the new math is wrong, that subtracts into 70 members who did not attend. This also means only 7% of the members are making the decisions that affect the entire Kewaskum business community. Evidently that 7% must be making all the right decisions, or all other businesses must be content with the status quo.)

A discussion was held on the area's Tourism Assessment which was presented by Debbie Skinner of the Wisconsin Department of Tourism on November 7. It was agreed that the Tourism Assessment was an extremely positive presentation and there were several new faces in attendance.

The concept that the tourism industry is a bright outlook on the Northern Kettle Moraine horizon is a gross understatement. However, if businesses intend to capitalize on this endless source of tourism dollars, promotion of the area must be made by more than a handful of enthusiastic members.

A member of the Tourism Council Committee brought up the fact that the Council encompasses the ENTIRE Northern Kettle Moraine and more volunteers are needed to reach goals and objectives. Anyone is welcome to jump on the proverbial bandwagon at any time, and the sooner the better.

The main priority of the Tourism Council at this time is to compile and print a clear, concise map of the Northern Kettle Moraine area and have it easily accessible to all tourists.

For a nominal fee to help cover the monumental cost of printing and drawing up the map by professionals, area businesses will be able to purchase a

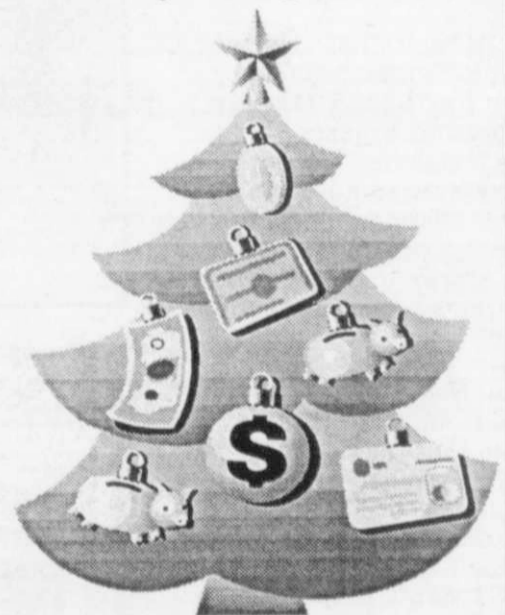

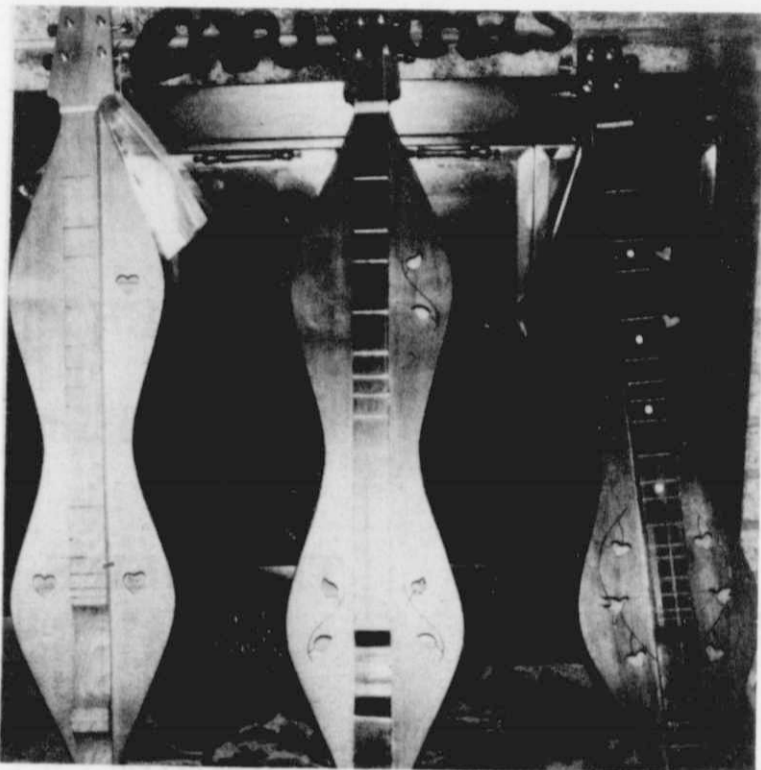

Retirement can be looked upon as that "golden age" when human beings finally find the time to pursue the dreams they've put aside while raising families and earning a living. Sometimes these dreams come as a surprise. Ask Al Stutzman of Auburn Lake, whose handmade dulcimers may be leading him into a whole new career.

A Campbellsport rural mail carrier for 27 1/2 years, Al and his wife Mary looked forward to his retirement at age 60. They met while their parents both owned cottages on Auburn Lake. Al, from Milwaukee, and Mary (nee Gruber) from Kewaskum, married and moved to their year-round lake home in 1955, where they led a quiet life raising five children.

With their neighbors, the Hartmans and Odekirks, they enjoyed "primitive camping" on weekends, traveling to Rendezvous, and they used to be members of the Smoky Hollow Muzzle Loaders Association.

In the fall of 1994, the couple, while traveling to Hot Springs, Arkansas, stopped in Branson to take in a few shows. It was there Mary noticed an ad in the paper offering dulcimers for sale at a local music store.

Always intrigued by the folk music played by other "primitive" enthusiasts at their weekend camping trips, they purchased a dulcimer, and later ordered a video tape on how to make the musical instrument from an old man well acquainted with "mountain music."

"I can't even read a note," Al points out, "but I knew I wanted to make one like that. The first one was for my wife, but the second one turned out so much better, I gave her that one instead, and took the first one back."

Since then, Al has hand made 28 dulcimers, working

Pennsylvania German zither, adapted by the mountain people of the Appalachians to make it more hour-glass shaped.

"Every dulcimer I make will sound different, and there are also many different ways to play it, so it's a very versatile instrument," Al explains, demonstrating the different sounds, using his fingers, then a noter, which slides for more of a "twining" melody, and picking the strings, which is an art in itself.

The wood used in making the sound board also changes the tone. "Hardwood lends a clearer tone, and soft spruce will give you a more mellow tone," he relates, adding that when he went to the Shawano Music Festival a woman taught him to use a heavier bronze base string, for richer sound.

The instrument is 26 inches long from bridge to saddle, and Al decorates each with individual cut out designs, in hearts, leaves, or hummingbirds. The wood stains he uses have become lighter over the past two years, to bring the natural wood grain.

For a man whose never been one for woodworking, Stutzman now has had his own official workshop in the basement, where if he works straight through, he can finish a dulcimer in about a week. "I usually work on two at one time, that way while the glue is setting on one, I can work on the other one."

A handmade jig is used to shape and form the sides, and hold the top and bottom on for gluing. The 1/8 inch thick pieces are first soaked in water, so they will bend to fit the form. "It's great to have my own equipment now," Al confirms. "When I first started out, I had to run to the neighbors to have

the pieces cut out."

Al takes his dulcimer wherever he goes, even when he goes up north deer hunting. "One night I was playing it in a bar and a man walked up to me and laid down the money for it while I was playing. Later I told him this was my dulcimer, but he wouldn't take no for an answer. He wanted that one, so I sold it to him."

"He's either sold, given away, or traded every one he's made so far," Mary joins in, who loves the instrument and it's music as much as her husband does.

This past summer Al took a one week course at the Rhinelander School of Arts, sponsored by the UW-Madison, to refine his playing techniques. The couple have been attending the school for several years, taking one week out of their summer to learn a variety of crafts like basket weaving, beadwork, and wood carving.

Although Al is shy when it comes to his musical abilities since he can't read music and learns everything by heart, he loves to play, and practices at home for two, three hours at a time.

Over the holidays, he entertained some friends at the Samaritan Home in West Bend, and a 99-year-old woman, confined to her bed, joined in to sing a Christmas Carol in German. "Dulcimer means 'sweet music,' and I agree with that," Al remarks.

All of the handmade original dulcimers are numbered, signed and dated. "I don't like to take orders or make them ahead," he maintains. "I love to make them, the tone is there, but I'd just make them my way, and if I have one available, people can come out and see

what I have."

His talents have been spreading by word of mouth, and by hearing him play, but his craft will have to be put on hold for a month, while he undergoes cataract surgery. "After that, the fine detail should be even better," he asserts.

The couple have five children, Mary Ellen, Andrew, Jennifer, Russell and Jerome, along with eleven grandchildren. The youngest, Jerome, and his wife have also taken up playing the unique instrument, and Al has the benefit of using Jerome's sawmill to cut his own wood, which saves on costly materials.

Mary retired from her job at the state Public Defenders Office in West Bend a year ago, so she is enjoying their newfound musical life, and recently purchased an antique auto harp, to specifically accompany the dulcimer. "I haven't tried it yet, but it plays harmony, and the instruments go well together."

The Stutzmans still attend Rendezvous, but only for the day. "It's good for me to go and play along with others who can play well," Al states.

basically with cherry wood and black walnut, although his latest model is an experiment using birds eye maple, which he says he'll keep using. "The black walnut is harder and more brittle to work with."

The dulcimer is a musical instrument in which wire strings run across a shallow body, or sound box, with no protruding arms or neck. An ancestor of the piano, it is thought to have originated in the Middle East, possibly as the Persian "santir."

The Hammered dulcimer is played using light spoon shaped beaters that produce a vibrant, metallic sound. The second type, the Appalachian Mountain dulcimer, is a three or four string, but sometimes up to seven string, fretted zither that was developed from the



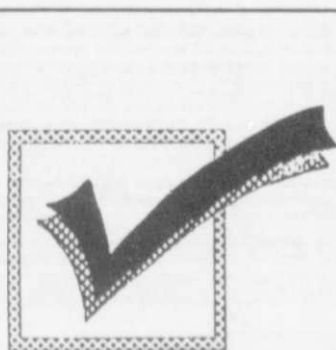

To Concerned Citizens in The Town of Wayne and Surrounding Areas:

Like many people we just lived our lives and weren't really concerned with the town issues until recently, when a large farm field near our house was purchased and proposed to be turned into a subdivision or divided into numerous lots, we still don't know exactly how many lots.

Many of the surrounding landowners and other concerned people signed petitions, written protests and voiced their opinions and concerns against this proposal at the town meetings. The main areas of concern are the road and driveway issues, high water table and runoff, destruction of prime farmland, preserving the environment and rural character. The surrounding areas are mostly large parcels of farmland or woods.

Do you know that if this goes through the town tax dollars will be spent to widen and rebuild the road that leads to some of the lots? The road, as it exists today is totally adequate for the one home and adjacent farmland it serves. Is it right that taxpayers should finance the rebuilding of roads so developers at the end can profit? Especially when there are many other roads in need of maintenance that have been put off for years. We wonder how much this will end up costing the taxpayers. The town approved this land division and rezoning contingent upon a developers agreement that is satisfactory to the town. They will probably be signing this at one of the next Town Board meetings.

It's really a shame that important decisions are sometimes made, not based on right or wrong, or public interest or concerns, but are made based on what has been done in the past, or what will or will not hold up when the lawyers get involved.

The other argument is that people who own the land should be able to do what they want with their land. This is a valid point but shouldn't the effects be considered? Hopefully the new Land Use Plan will take care of these issues. The Town of Wayne has a Moratorium (a freeze) on all land divisions that were not submitted before June 1, 1996. There were so many land divisions and rezoning

for development that the town spent most of its time on these, rather than other town issues. Housing units in the Town of Wayne has increased 22.4% in the last six years. Washington County is the fastest growing county in the state. The Southeastern Wisconsin Regional Planning Commission will be working with the town to develop a Land Use Plan.

There are seven members of the Planning Commission. The Town Board is made up of two supervisors and one chairperson. The board members are elected and serve a two year term. They are up for election this April. We urge everyone to research the candidates and vote in April. It's especially important now because these are people who will be making decisions on our Land Use Plan, which will have an impact on all of us in the future in one way or another.

We urge people who are concerned about their community, to get involved and find out what is really happening, now, and as the Land Use Plan is being developed. The next Planning Commission meeting will be Tuesday, January 14, at 7:30 p.m. and the Town Board Meeting is Wednesday, January 15, at 8 p.m. at the Wayne Town Hall. There will also be a meeting at the Wayne Elementary School on Thursday, January 23, at 7:30 to discuss the visioning meeting and survey results.

Documents of the Kewaskum school board have been brought to my attention indicating that during 1996 the Kewaskum school board has appropriated, or misappropriated, taxpayers money for the following:

A dinner for 38 (including spouses), administrators, building secretaries, board members and committee members of the Kewaskum school district was held at Hon-E-Kor in Kewaskum in August. Costs included 16 beef dinners, \$200, 22 chicken dinners, \$284, gratuities, \$72, centerpiece \$35, corsages, \$16, boutonniere, \$4 and a \$30 gift certificate for a speaker. Total cost, \$665. No business was held at this gathering.

A planning conference by Kewaskum school administrators was held at Fox Hills, a Mishicot spa, in August. Costs included rooms, meals, meeting rooms, travel and gratuities. Total cost, \$1,430.40. (Several mileage claims are still outstanding). This two

day meeting could have been held in Kewaskum for a fraction of the cost.

A voucher for Thanksgiving turkeys at a local market were issued to 220 members of the school districts staff, this included 40 vouchers for Johnson school bus drivers. Johnson is a private corporation and their drivers are not school employees. This was an order initiated by the school board. Total cost, \$2,300. This makes the entire sum total of \$4,395.40.

I do not believe the school board should have the authority for the above actions without the knowledge and consent of the entire school district. This cannot be done by holding board meetings at their convenience. It should and could be done by a mail poll or a referendum. It is the responsibility of homeowners to make sure that the school board is aware of this. It seems that the school board feels so secure in their positions that they can use our money for anything they desire. There is another election in April 1997.

Our Christmas Party followed. Bingo and other games were played with many prizes awarded. Refreshments, Christmas cookies and snacks were served.



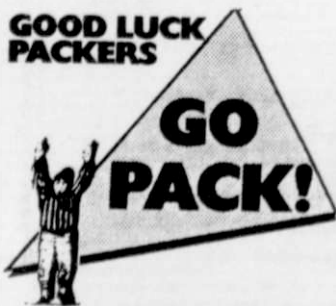

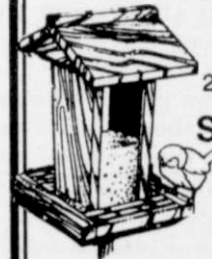
Kewaskum's top scorer

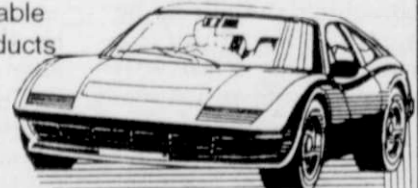

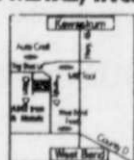
