School Board Handles Light Agenda; Discusses WASB Convention Issues

Kewaskum school board members had a light agenda this month, spending most of the time discussing the WASB (Wisconsin Association of School Boards) convention, and what they wanted their delegate, board member John Schulte, to support and not support.

The DPI (Department of Public Instruction) will be handing out their second draft of the new state academic standards at the convention for all local school boards to review.

Board member Neal Beard, who served on the state committee formed to develop standards and assessment policies, was concerned with two points

within an amendment drafted by the Waupaca school board that addresses this issue.

1) State standards and assessments should not be linked with national goals. Local school boards need to be encouraged to develop their own standards, to enhance more local control.

2) Staying away from the term, "higher order thinking skills." "This kind of connotation denotes there are lower order thinking skills," Weare pointed out.

The board also addressed another resolution that requests an exception for "technology development" within the revenue cap limits. The consensus agreed that it was risky to make all sorts of exceptions to revenue caps, and it could open

doors to continual tax hikes.

"It's like when Governor Thompson said all schools must be on the Internet," board member Jon Downs related. "Some school districts just couldn't afford it."

Board member Mary Andera agreed. "Homeowners don't have a well to dip into. Families have to budget all the time for unexpected costs, like sidewalks. They don't go on vacation that year. I'm totally against this."

School board members attending the convention this year are Schulte, Andera, Weare, Downs, and Super Goenden.

Superintendent Dr. Charles Johnson told the board he had completed the

Village Board Denies Class A License Request

The Kewaskum Village Board opened their January 6th meeting with a Public Hearing to discuss an application for a Class A Fermented Malt Beverage License by Thomas A. Schmidt, representing U.S. Oil Company for the Kewaskum Amoco at 890 Fond du Lac Avenue.

Village Administrator Daniel Schmidt briefly explained requests for this type of license have been made in the past by Rich's Foods, Shefond and others and these request had all been denied.

(Class A) "Fermented

Malt Beverage do not apply to the quota system. Class Bs are governed by quotas established in the state. Either communities issue one for every 500 in population or one license for every license that was in existence on August 27, 1939. It's by whichever number is larger."

Schmidt added that back in 1939 there were alot more taverns than there are today, therefore the quota is

a lot higher than the 500 residents per license.

He further explained the village could put quotas on the Class A licenses and have discussed that in the past, but had opted not to do so.

President Wagner asked why the previous requests for Class A licenses had been denied. Schmidt answered that board members at the time of the previous requests felt there were already two Class A licenses in existence in the village and their comments reinforced their opinion that two outlets were a sufficient amount.

In addition, any Class B establishments may also sell package goods until midnight.

Trustee David Goeden asked if Class A licenses only allowed packaged goods. Schmidt said, "Class A is to be consumed off premise."

Trustee Goeden also asked if there was a law governing what age a person must be in order to sell the package goods. Schmidt answered, "You have to be 21 to buy it and 18 to sell it."

All board members received a letter from Police Chief Richard Knoebel stating his opinions and recommendations on whether or not to issue the license.

Trustee Gary Gavin asked Chief Knoebel, "Other than what you have written here, are there any other comments you have?"

Chief Knoebel stated, "In the past we've always turned them down due to the fact of the easy access. In and out. A regular situation, a tavern or a liquor store, it's easier to keep an eye on people coming in and out that are underage and might have something. It's just not as easy to control."

Knoebel added, "It's just another outlet where possibly juveniles could get involved and it's a hard situation to control. You have underage people working there along with the people that are 18. Friends come in, it's hard to say no."

President Wagner stated the concerns Chief Knoebel listed in his letter of recom-

mendation were definitely points to consider.

Knoebel reiterated, "It just seems to me that it's an easier situation for people to get liquor. If someone would build a building situation where they had a separate room or a separate checkout area, it's a different situation, but this is all intermingled between the snacks, the food, and everything else."

Knoebel added, "There's a lot of cities that have granted them (the licenses) and wished they hadn't."

Trustee Gavin said he felt in the future, if an establishment had a separate area or a separate cash register and separate employee working at that cash register, it should be considered at that time.

Knoebel agreed, stating, "You have to take everything into consideration... the makeup of the building... if there is a way you can do this... have a separate spot. Where this would be checked out, everybody is checking out their soda and their snacks and paying for their gas."

Trustee Gavin reiterated, "Until that situation arises, that they do have a controlled situation, I don't think the board should consider it."

The rest of the board agreed and there being no further comments, a motion was made to close the public hearing.

Later in the meeting, under New Business, the board unanimously voted to deny the request for the Class A license.

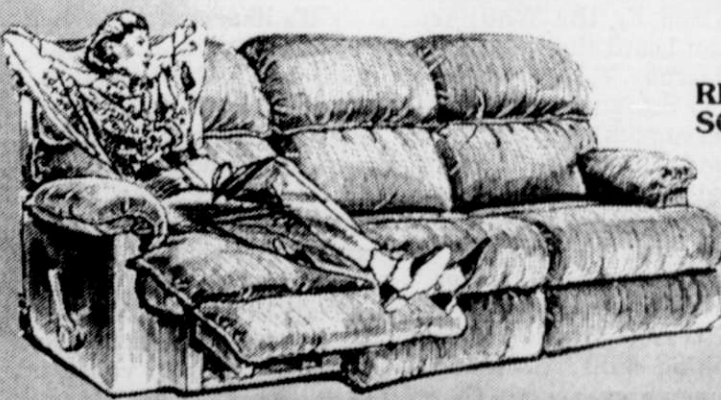

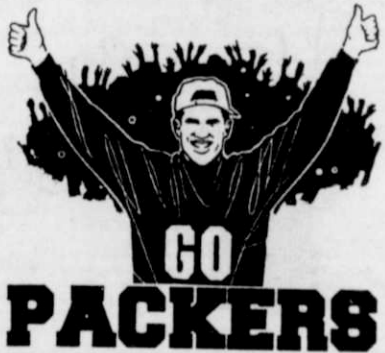

Two Three-Car Accidents Occur in Village on Saturday

Who said lightning can't strike twice in the same place? Two three-car accidents occurred in the same area in Kewaskum last Saturday, January 18, at the Fond du Lac Avenue (Hwy. 45) and Timblin Drive intersection on the south end of the village.

In the first accident, a 1988 Mazda, driven by Heather Spoerl was traveling north on Hwy. 45, towing a 1990 Mazda being driven by Robert Spoerl. Ms. Spoerl had to slow her vehicle considerably, causing the towed vehicle to pull hard to the right, past Ms. Spoerl, with the tow rope still attached.

The towed vehicle pulled Ms. Spoerl's car forward, causing it to veer into the southbound lane where it struck another southbound vehicle driven by a Kewaskum teenager, nearly head-on. The towed vehicle then continued approximately 200 feet past the accident

scene uphill.

Ms. Spoerl was transported to St. Joseph's Hospital in West Bend for treatment of her injuries by the Kewaskum Rescue Squad.

In the second accident a few hours later in the same area, another teenager from Kewaskum, driving a 1986 Pontiac Firebird northbound, slowed for the vehi-

cle in front of her.

Traveling behind her, also northbound, John Mueller of Port Washington also slowed his 1996 GMC Sierra pickup. The third vehicle, driven by Matthew Miller of West Bend, noticed the other stopping vehicles too late, and collided into the Mueller pickup, pushing him into the first vehicle.

Nursing Dreams Come True For Scholarship Winner

Lisa Reindl has one less class to pay for on her way to becoming a nurse.

That is a big plus for someone who pays for her education by working days, nights and weekends. She also attends classes three days a week, and studies whenever she has a free moment.

The Washington County Medical Society recently awarded Reindl, a lifelong West Bend resident, its

annual scholarship. The scholarship is open to a student from Washington County who is enrolled in the Moraine Park Technical College's Associate Degree Nursing Program in West Bend.

The \$280 scholarship is distributed to the winner in two semester installments. The medical society is expected to supplement Reindl's scholarship in January according to Wil-

liam Listwan, M.D., president of the Washington County Medical Society. The members of the physician's group began the scholarship in 1987, and have added to their original \$5,000 endowment fund. To date, the recipients of the award have come from West Bend, Hartford and Jackson.

Reindl says she has dreamed of pursuing a nursing career for a long time. She began her first semester in August and expects to graduate from MPTC in 1998. After graduation, she wants to work in a hospital, and pursue a bachelor of nursing degree. She describes her recent grant as "awesome," and expects to use the second half of the scholarship for either books or tuition.

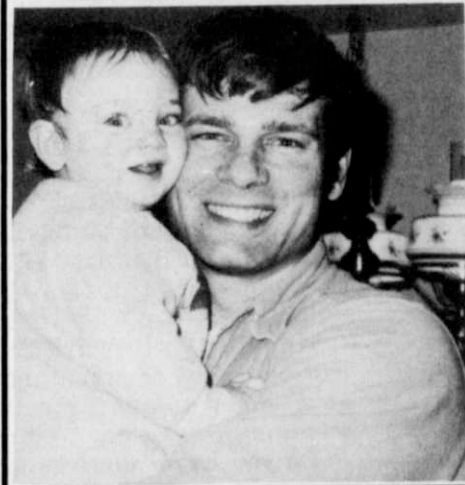
Kriewaldt Earns Degree

Grothman Proposes Martin Luther King Holiday Bill

West Bend Legislator Calls for Equality Between Public and Private Sector Employees; Would Keep State Buildings Open on MLK Day

MADISON -- State Representative Glenn Grothman (R-West Bend) announced on Monday, January 20, that he will introduce legislation to make the state's Martin Luther King Jr. Holiday a standard work day for state employees.

"I have spoken with a good number of people who think it's ridiculous that the state is paying its employees millions of dollars to stay home on Monday, while everyone in the private sector, public school systems, and local governments has to work," Grothman said.

The legislation will preserve the Martin Luther King Jr. Holiday, traditionally held on the third Monday in January. It does, however, require state office buildings to remain open on those days. Federal employees get a paid holiday for Martin Luther King Day,

Presidents' Day, Columbus Day, and Veterans Day. State employees, by contrast, are currently required to work on other days of recognition for famous Americans, such as Presidents' Day, Columbus Day, and Veterans' Day.

According to the state's non-partisan Legislative Fiscal Bureau, it costs almost \$10 million dollars each day to pay the salaries and fringe benefits of Wisconsin's employees. "There is no reason that taxpayers who have to deal with the Division of Motor Vehicles, the Department of Revenue or the University should be unable to do so today," Grothman noted.

Because MLK Day is treated as a vacation day, some state employees who must work receive overtime pay. "At a time when Money magazine says that Wisconsin has the second highest taxes in the country, such

unnecessary spending is not acceptable. To continue this policy makes it appear that the state government operates for the benefit of the employees, and not its citizens."

Grothman described a recent, random phone poll of dozens of Madison-based state agency employees which indicated that very few of the state's employees were planning to use their time off on January 20th to do anything related to Martin Luther King, Jr. "In fact, among the people we talked to, we couldn't find one who indicated that he or she was going to do anything even remotely related to Dr. King's birthday," Grothman commented.

"Martin Luther King, Jr. is recognized because he stood for equality. To continue a policy that so obviously divides state employees from private sector workers is an affront to the very ideal of equality."

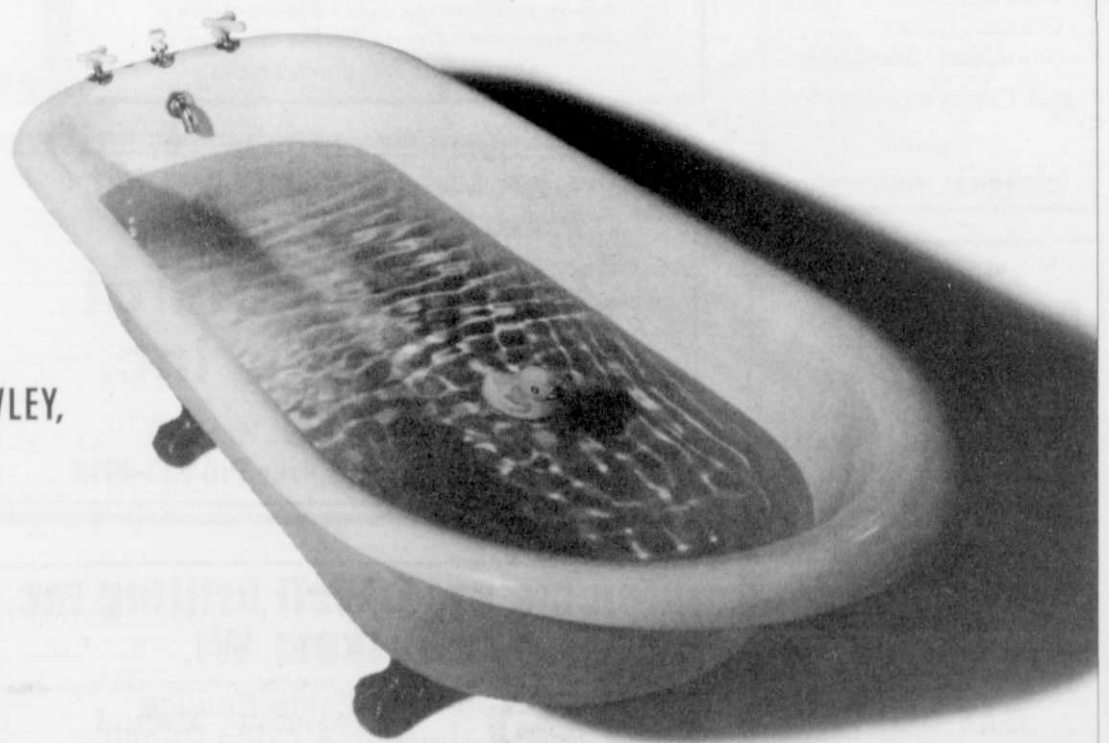

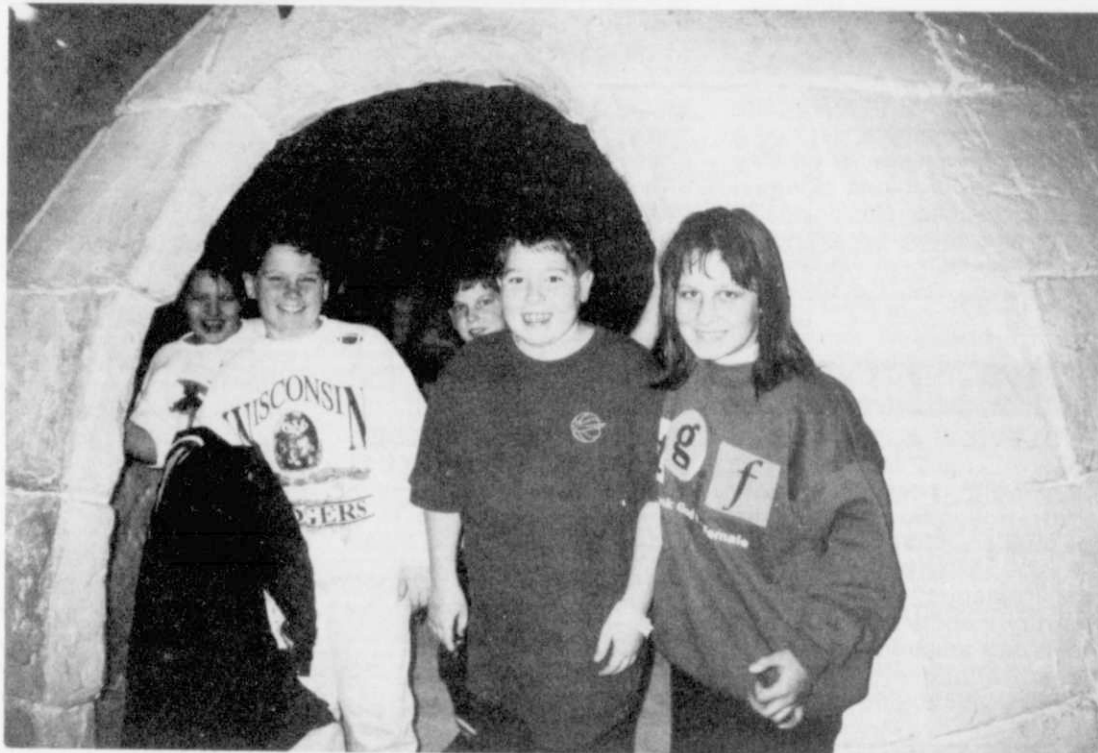
Over the past few weeks, students have previewed the concert in music class, listening to the scheduled pieces and learning a little about some of the com-

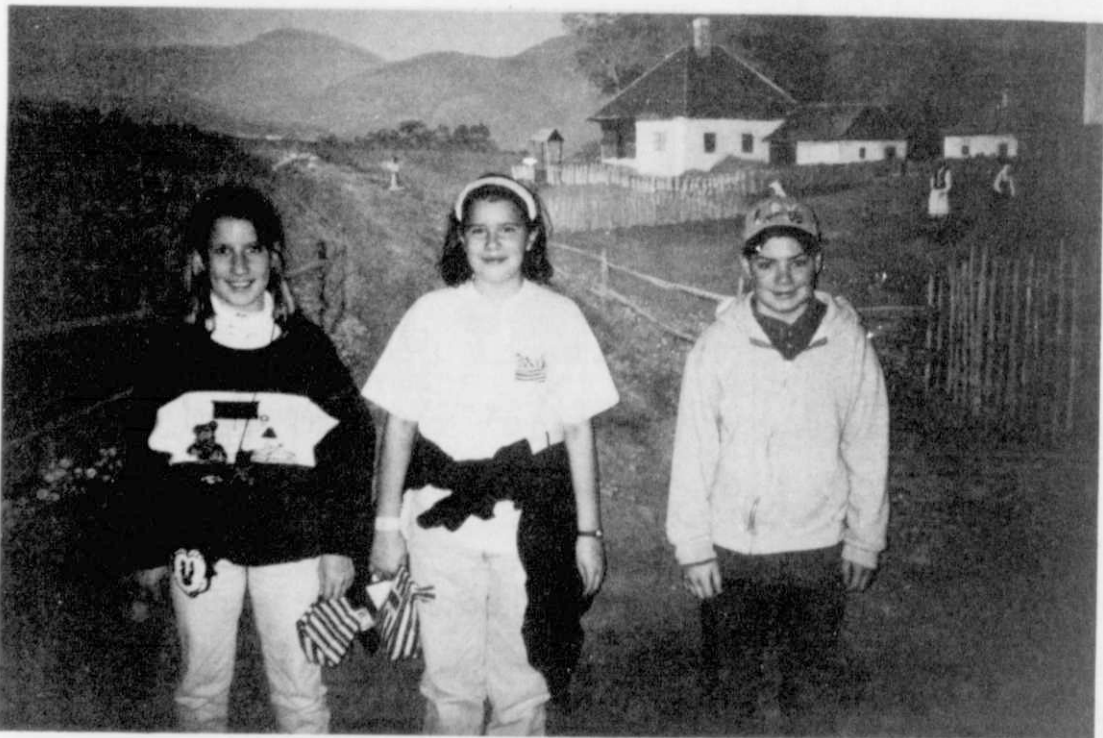
Student favorites ranged from the Streets of Old Milwaukee and the African animal dioramas, to sitting

and the Johnson Bus Company helped make it an educational -- and of course, FUN -- trip for all.



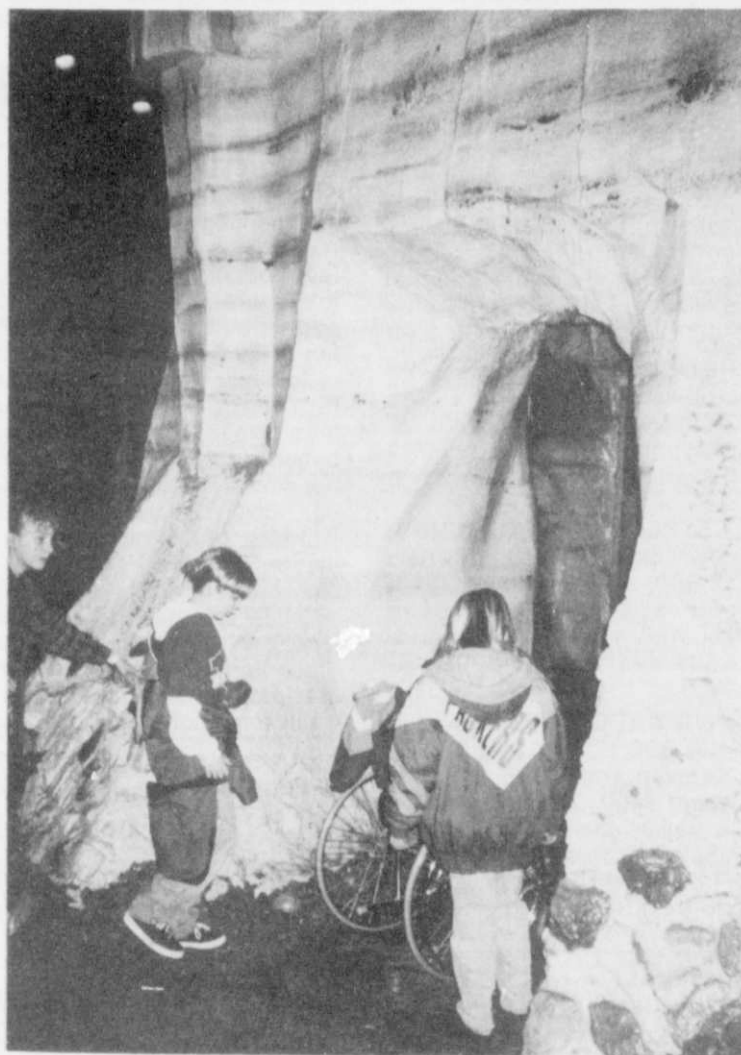



Preliminary Work OK'd for New West Bend Runway

A \$175,000 project to lay the groundwork for the possible construction of a new, longer runway at the West Bend Municipal Airport has been given the go-ahead by Governor Tommy Thompson.

"Before any work is done to realign the existing northeast-southwest runway at the West Bend Municipal Airport, we want the best information possible on which to make our decision," said Governor Thompson. "We want to know before any earth is turned what impacts there will be to the environment and what the airport's future needs will be so we make the right choices."

The Governor's action releases \$140,000 in state funds to prepare a Phase II Environmental Assessment to analyze the impacts of a realigned and lengthened runway and to update the airport layout plan. The City of West Bend will contribute another \$30,000 toward the project.

Governor Thompson said the project would help identify the alignment that would have the least impact on the airport's neighbors and the environment. If approved, the new runway would be rotated to a slightly more northerly alignment and State Highway 33 would be moved to allow for a new 100-foot wide, 5,500 foot-long runway, capable of handling corporate jets and

other aircraft. The current runway is 75 feet wide and 3,900 feet long.

Work on the environmental assessment and the airport layout plan is expected to be completed by November 1, 1997.

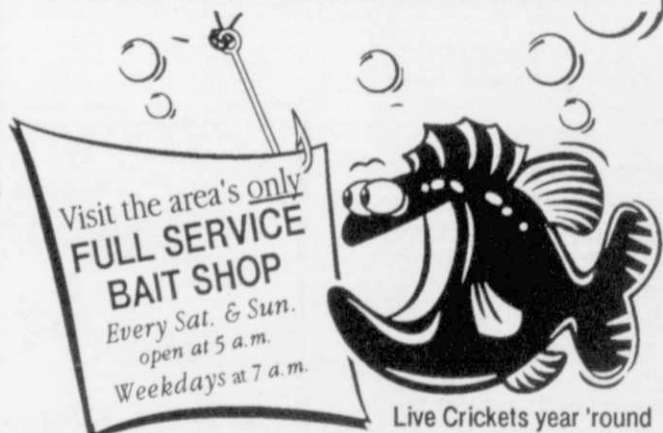
