School Administrators, Board Address Voters Concerns Regarding Proposed Land Purchase at Public Hearing

An accepted offer to purchase has been made on a 78 acre parcel of land that touches the east village boundaries by the Kewaskum School District, administrators told the community at Monday night's Public Hearing.

The deal includes voters approving the land purchase on an April 1st referendum, and many of them voiced their concerns throughout the meeting.

The land, owned by O & R Enterprise, extends along the south side of county Highway H to Kettleview Drive, on the west side of the Town of Kewaskum.

District Administrator Dr. Charles Johnson stated that out of the 78 acres, perhaps five acres are unusable.

"A certain portion of land is not suited to put a building on, but that doesn't mean it's not usable," Johnson told the audience, and affirmed there was adequate space on the acreage for anything the board might envision doing in the future.

Out of the total parcel, 68 acres are constructable and above the flood plain, with 60 of those presently suitable to build a structure upon. Business manager George Allmann explained that 20 acres surrounding the creek area, although not

suitable for a structure, could be utilized as playing fields. Total purchase price is \$545,000, which calculates to around \$7,000 per acre.

Allmann also indicated a lift station would be required to handle utilities, at a cost of \$30,000, based on architectural studies. "If you look at the village land use plan for the year 2010, this (land) is part of the village," Dr. Johnson related.

"It was important that any land selection be in concert with the land use plan for the village, and this one fit nicely into the village plan because of the quality of the piece of property." He stated that almost all the

available land considered by the board required a lift station. Most large parcels within the area suitable for use by the district had some wetlands. The cost factor also entered into their decision, with a set limit of \$600,000.

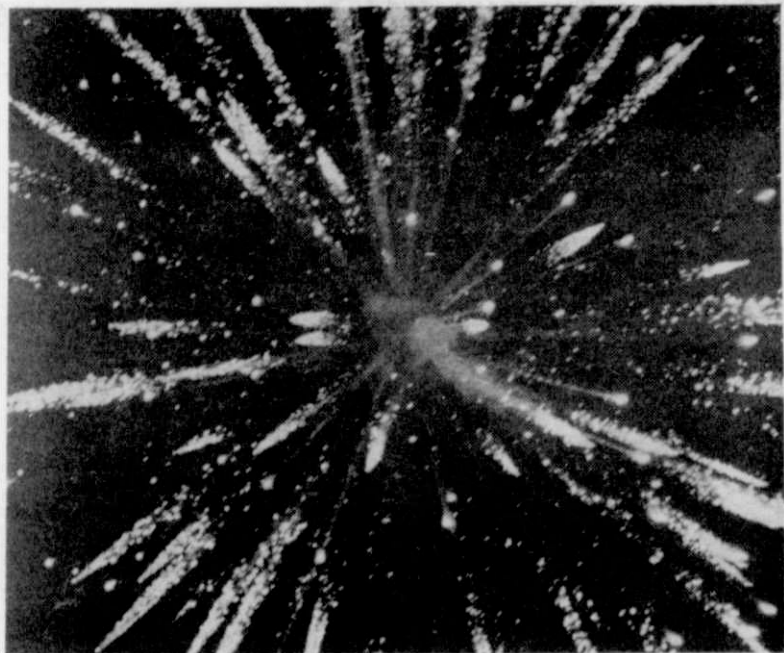
Other advantages of the purchase includes future roadway developments for bussing purposes, specifically the Jurisdictional Highway Plan for 2010 on a countywide basis, which proposes a two lane highway where Badger Road intersects with Highway 45, Kettleview Badger Road and Kettleview Drive around the village, connecting up with Highway 28.

Dan Truog, a resident who lives along Highway H, cautioned the school board about land containing flood plains and waterways. "We have land to the east of this building (high school) right now, that we can't use because it's so close to the (Milwaukee) river. Just so we don't fall into that classification again."

"I'd like to know the reason why they don't want to open Beechwood School, an open citizen, Wilmer Schmidt, asked the board. "Something has got to be done with that school this year, and I'm going to see that it is." He also asked

Nadalie Reindl went to Wisconsin Rapids determined to come home with a medal. She didn't just come home with any old medal, Nadalie went all the way and took the Division Two state title for her floor exercise. With a score of 9.33, Nadalie has also earned herself a school record.

"Nadalie was determined to win the floor exercise," said a very proud Coach Wendy Fideler. "She did a super job and earned every bit of it."

Before competing on the

floor, Nadalie did her beam routine. She received a score of 7.2 on the beam. This put her in 21st place.

"She fell off twice. I think Nadalie really had her mind on her floor exercise," Coach Fideler commented. "She wasn't nervous, but a gymnast can have her on days and her off days."

Two other Kewaskum gymnasts had the honor of competing at the state tournament. JoAnne Thull scored a 7.63 on her vault, which placed her 24th. This was JoAnne's first appearance at state and, being a junior, has gained the experience which will be benefi-

cial for next year. Kathy Deshotels competed on the uneven bars and received a 7.38 which earned her a 23rd place at state.

"Kathy did a really smooth routine, but it didn't have the difficulty that the other girls had," said Coach Fideler. First place winner received a 9.2. "The level of difficulty at state has to be pretty high."

Just making it to state is quite an honor for any high school athlete. This was Nadalie Reindl's fourth consecutive trip to the state competition. Kewaskum is quite proud of Nadalie, JoAnne and Kathy!

Area Red Cross Seeking Financial Assistance, Volunteers

The local area chapter of the Red Cross is requesting the community's help to meet its transportation needs.

"March is Red Cross Month" and the chapter is utilizing the month to request volunteer and financial assistance. In any given month, the Red Cross vehicles average 9,000 miles transporting area patients to vital medical treatments. In fact, in January, over 12,000 miles were logged. At this rate, the high mileage vehicles need replacement at a faster pace than anticipated.

Patients are from the areas served by the chapter: the villages of Jackson and Kewaskum and the towns of Barton, Farmington, Jackson, Kewaskum, Trenton, Wayne and West Bend. They are transported for such treatments as kidney dialysis, which requires patients to be on machines for several hours a day, three times

a week, in order to survive.

Forty-two volunteer drivers also make the medical trips possible. More volunteers are urgently needed to meet the needs. To donate financially or to become a needed volunteer, please contact the Red Cross office at 2410-B S. Main Street in West Bend, or call 334-5687.

Also during the month, on March 22, the chapter will hold a Disaster Preparedness Day at Pick 'N Save North in West Bend from 10 a.m. to 2 p.m. West Bend Mayor Mike Miller will kickoff the event, which will emphasize family safety.

As part of safety education, West Bend fire department personnel will demonstrate escape procedures using the department's smoke house. The community is encouraged to attend the event to learn more about family safety and the services of the local Red Cross.

Two Candidates Running for Town of Wayne Chairman Position

The Town of Wayne has experienced many changes in recent years as have many of our rural townships as Washington County has grown. After the April election, the town will experience a change in leadership as current chairman Mark Strobel will not seek another term.

Strobel has served as a member of the Town of Wayne board for 20 years, 17 1/2 as a supervisor and approximately the past 2 1/2 as town chairman. Time constraints are the major factor he has decided not to run for another term.

The two candidates for the chairman position are Leander Herriges and Jim Stoffel.

Herriges has been a town resident since 1949 and has been a lifetime dairy farmer in the township. He is completing his first terms as town board supervisor and plan commission member.

Herriges would like to pursue the possibility of a five member town board instead of the current three member. He feels five members would offer a variety of viewpoints on issues brought before the board.

Herriges states an important issue before the new board will be the continued work and completion of the Land Use Plan and coordinating zoning ordinances. Herriges further states the chairman position requires strong leadership and someone who is accessible, both of which he feels he can pro-

vide to town residents.

Leander, 61, and his wife, Mary have three children. He is a graduate of Kewaskum Schools, a member of St. Bridget's Catholic Church Parish Council and President of the Washington and Waukesha County Milk Marketing Organization.

Jim Stoffel states the completion of the Land Use Plan should be the number one priority of the new board and keeping town roads and roadside maintenance at the high level the town currently has.

Stoffel is a graduate of Kewaskum High School and received a certificate of attendance from the University of Wisconsin-Madison in the Farm and Industry short course.

Stoffel is presently the president of the Washington County Farm Bureau, is completing his second year as a town of Wayne Plan Commission member, is in his fifth year as co-chairman of the Breakfast on the Farm Committee, in 1991 was the host farm for the breakfast and has served as past president and past vice president of the Washington and Ozaukee Counties Dairy Herd Improvement Association.

Stoffel, 43, has been a lifetime dairy farmer and a Town of Wayne resident for approximately 32 years. Jim and his wife, Jean, have three children.

Town of Wayne residents can cast their ballot for town chairman at the town hall at 6030 County Trunk H on Tuesday, April

1, 1997 from 9 a.m. to 8 p.m.

Town of Kewaskum Schedules Public Hearing on Zoning Map

The Town of Kewaskum is entering the final stages of formalizing an updated Land Use Plan, Zoning Map and Zoning Ordinances. As part of this finalization, on Monday, March 24, 1997 a public hearing will be held at 7 p.m. in the town hall at which time any questions or concerns about the new zoning map may be presented.

The proposed zoning map will indicate various zoning districts by color. The map designates ten districts including, agricultural preservation (including 5,000 acres), agricultural open space (which would consist of lots of a minimum of three or five acres in size), residential single family, business, manufacturing, quarrying, landfill, institutional (churches, schools, public administration, etc.), park (state forest, skiing area, golf courses) and wet lands.

The town has been assisted by Southeastern Wisconsin Regional Planning Commission (SEWRPC) with the updating of the zoning map and ordinances. Camiros Limited from Madison was the Land Use Planner. The land division moratorium currently in effect will expire on April 1, 1997.

A copy of the proposed zoning map is available by appointment at the town hall for anyone interested in viewing the map prior to

the hearing. You may contact town clerk, Barbara

why it isn't possible to fill in the low areas on land already owned, as other developers in the village have done. Allmann answered that the DNR has restrictions on land use near the Milwaukee River, and the flood plain in that area goes all the way up to the soccer field.

Board member Larry Fechter stated that Beechwood would remain a separate issue that will stand by itself, as long as he was on the board. "The Beechwood issue does not relate to high school kids possibly, it does not relate to middle school kids possibly, as this land might very well relate to. I wish the people of this district would look at the merits of buying this land," he expressed. President Jean Goeden said the topic is on the proposed agenda for the May school board meeting.

Farmington resident Debbie Donath thought the purchase of land was a step forward for the future of the district, but asked for reinsurance that maintenance of existing schools would continue to be improved upon. "What's going to happen to our little schools out in the country?", she asked. Fechter said he hoped they would continue to maintain the buildings properly, and address individual needs, which continually change based on funds and priorities.

Board member Jon Downs told the crowd of about 50 residents that after looking at at least a half dozen parcels of land, the board had dealt with all the questions being asked that evening, such as adequate size, flood plains, enough buildable area, other uses for non-buildable land, and proximity to town.

"We're pretty much land-locked here in town," he added. Colleague Neal Weare said he hoped the board would continue to follow the process of requiring community input for all future endeavors. "Ultimately, whatever gets built on the land, is going to come to you folks, and you're the ones that are going to decide," he maintained.

Dr. Johnson told the voters that if they say yes to the land purchase, the tax impact on the taxpayer would be zero. Last year's \$1 per thousand of equalized value, taken from state tax relief (taxpayers received about \$3 per thousand in state aid), saved the school district over a quarter of a million dollars over a ten year period in interest payments on their long term debt, and paid off a part of the principal.

The district proposes to take that same dollar amount for this year, and apply it to the purchase of land. Johnson said that payment in full would be made on the closing date (written into the offer to purchase). This amount will be borrowed on a short term

loan, since the moneys collected from taxes will not be available until August, 1998.

"What the referendum calls for is it authorizes the school board to borrow up to \$600,000 for the land purchase," Allmann explained, trying to articulate some confusing financial aspects.

Community member Mr. Nowak told the board he felt that dollar amount would indicate an increase in the tax levy, because it decreases the tax relief granted to taxpayers by the state. "We waited 20 years for tax relief, and I'd like that dollar back," he commented.

Dr. Johnson explained that long term debts are a result of referendums, not short term borrowing, and the board's duty is to manage that debt. In reference to last year's annual meeting vote that allowed \$1 per thousand in tax relief to reduce the district's long term debt, Johnson again emphasized the fact the board had the authority to do this without voter approval, yet chose to take it to the annual meeting. "It's a debt that's already been approved by the public." The board also voted at the annual meeting to review the matter each year.

Resident Ron Will asked why this wasn't addressed two years ago, when the district remodeled the high school and middle school. Neal Weare, who was a member of the board at that time, stated that they were only asked to address the overcrowding at KMS and KHS. "We weren't given statistical figures that went out to the year 2005, for Wayne, Farmington, Beechwood, and the village. We could only concentrate on what we were given at that time."

"None of us are passing

the buck, and it's not our intention. That money that was spent is clearly going to be used. If we build another school, this school is not going to be abandoned, it's going to be used for generations and generations, so it's not like that money is wasted. We're reaping the benefits of that money every single day, and we will continue to do so," board member Tom Timblin added.

Robert Spoerl, a resident who owns land across the street from the proposed land purchase, asked the board why they didn't consider his property, and buy land on both sides of the road and eliminate acquiring an area located in a flood plain.

Timblin said the board was bound to the \$600,000 figure, and had to work within that price range. Mr. Allmann indicated the Spoerl property was one of several they had considered in their search for an appropriate site, but there was a need for a certain number of acres required for building, by the state.

"If I were a landowner, I would not sell off the good part, and keep the poor part, which I could not develop," he told Mr. Spoerl.

The offer to purchase is also contingent upon the results of soil borings and an environmental impact study. The school board has the option, to accept or reject the purchase, based upon the results obtained.

The land purchase referendum will continue to be discussed, on March 24th during WBKV's morning talk show from 8 to 9:30 a.m., and March 25th, with a Citizen's Information Night, to be held in the KHS Commons, from 6:30 to 9 p.m.

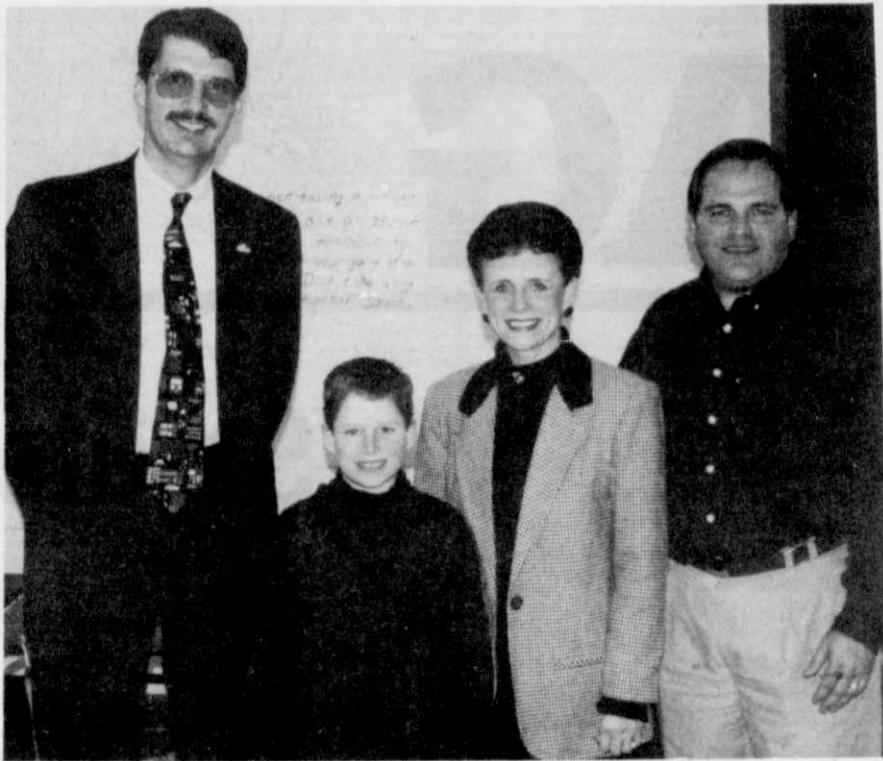

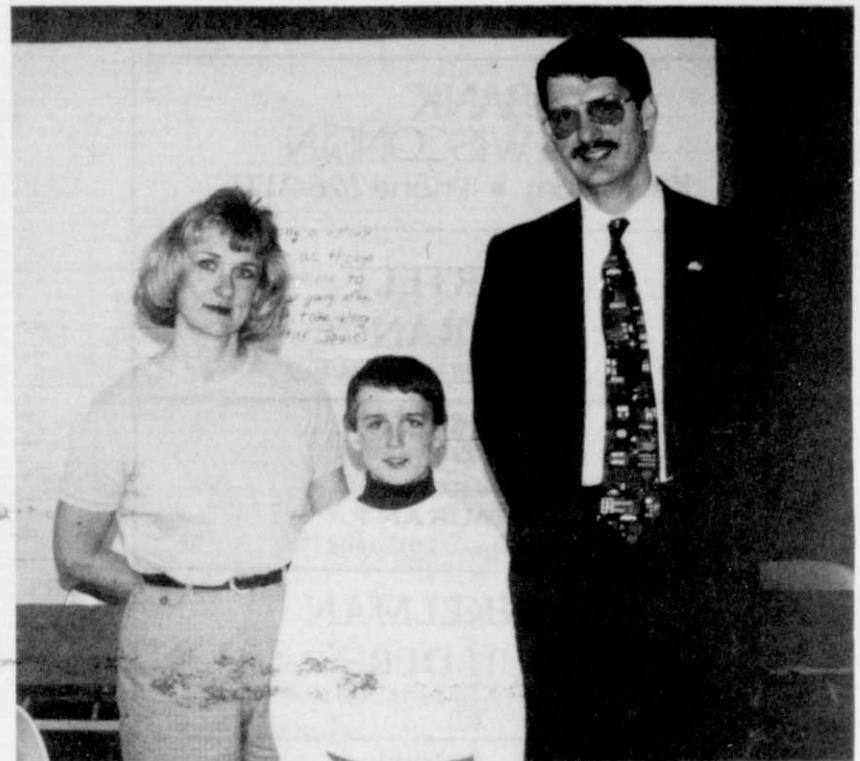

Inhalants and poisons have been called the cocaine of the '90s. They're addictive. They're deadly. They're readily available. And they're popular.

How popular? Nationwide, nearly one in four seventh graders has tried them. Locally, The Council on Alcohol and Other Drug Abuse of Washington County has seen an increase of use among adolescents who come in for drug and alcohol assessments.

What is the cocaine of the '90s? It's inhalant abuse, the sniffing or "huffing" (inhaling through the mouth) of hundreds of common, legal household sub-

stances. The National Institute of Drug Abuse statistics show inhalants to be the fourth most abused substance after alcohol, tobacco, and marijuana among 12-14 year old children.

Almost a half a million people use inhalants in any given month. Any time a person experiments with inhalants, it can be fatal.

The external effects of inhalants vary greatly and are usually short-term. Therefore, some or all of the following symptoms may be evident: red or runny eyes or nose, spots or sores around the mouth and nose, unusual breath odor, dazed or dizzy appearance, slurred

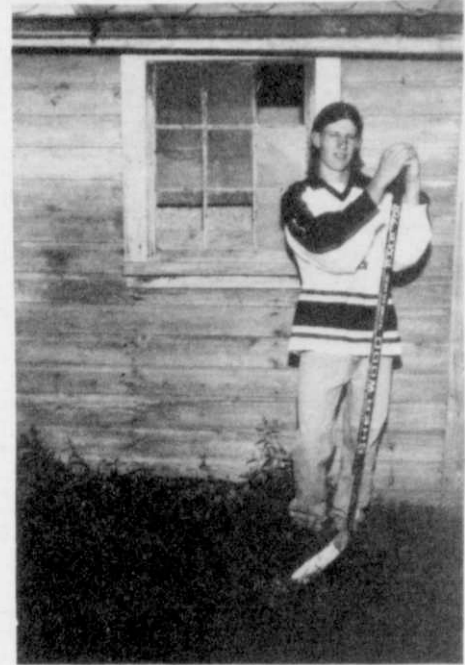
Washington County Ice Are State Champs!

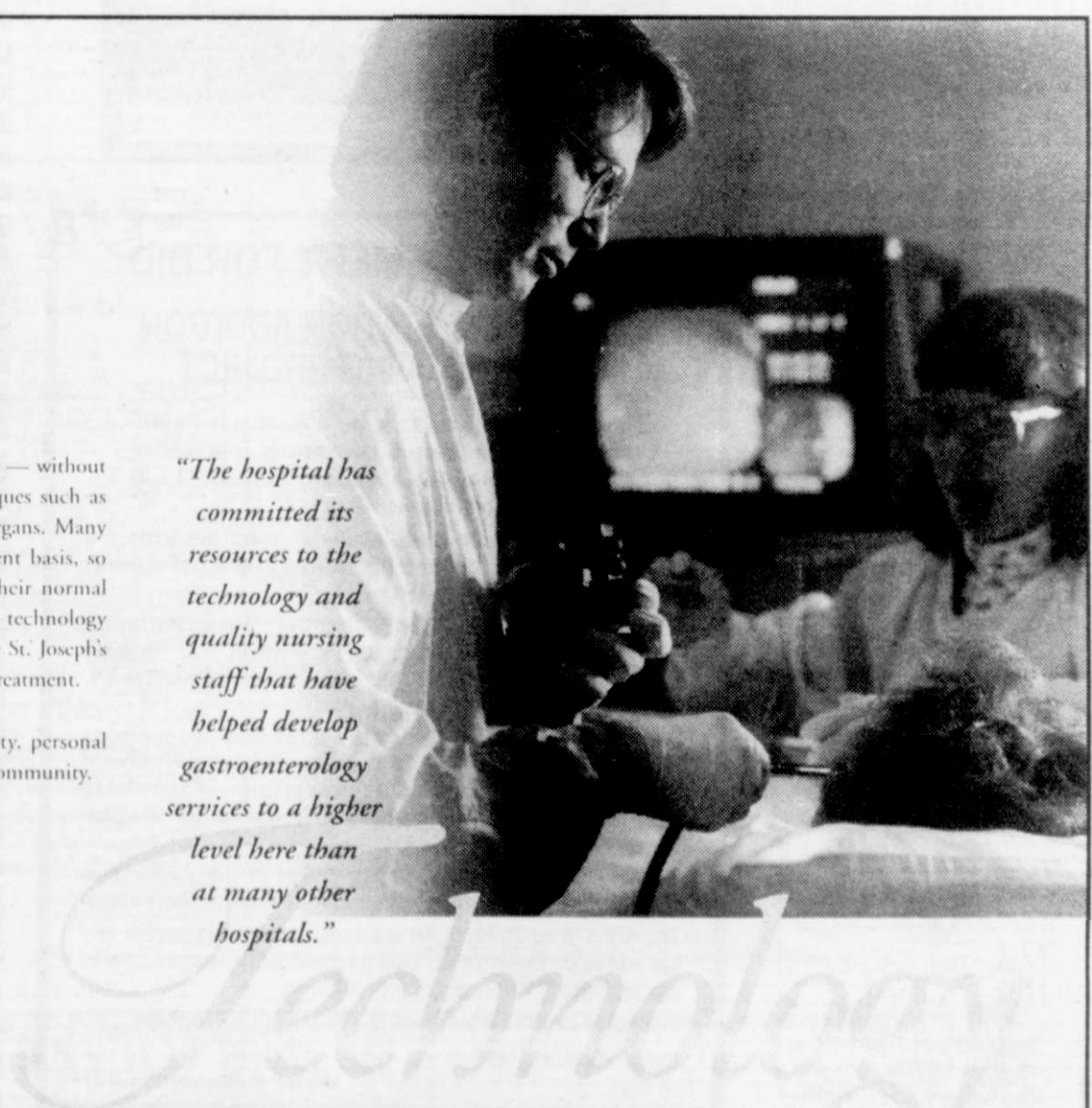

Dear Editor:

On Tuesday, April 1st, the voters of the Kewaskum School District will have the opportunity to vote on a referendum to purchase land for the future building needs of our growing school district.

Acquisition of land is an integral part of the long range planning needed for our school district. Presently land is available that is close to the village and of sufficient size to meet the district needs. With increasing population growth and the resulting development of subdivisions from farmlands, buying land later for the district's needs will result in land that is not as ideally located and will definitely be more expensive. Also in order to keep with the philosophy of having neighborhood schools, it is necessary to purchase this land before it is no longer available.

The obvious next question is, "How will this land be paid for?" Remember last year, the district residents saw a reduction in their tax bills of \$4 per \$1,000 due to additional state funding. The district kept \$1 back to pay off some of its long term debt and thus saved \$250,000 in interest payments. This year the school district would use the \$1 per thousand to pay off the land purchase. Taxpayers would thus see no increase in their tax bills and the land would be debt free.

Please take time to become informed during the next two weeks before the election. A reminder to voters who will be out of town the day of the election to request an absentee ballot from your clerk now. Please be informed and please vote.

Last year when the Kewaskum School Board found that the property taxpayer's were going to have a substantial reduction in property school taxes due to increased state aid, they decided to add a \$1.00 per thousand increase in our assessed property value, with the assurance that it

would be used solely for the reduction of old school debts in a one shot deal for one year.

They have the money so now they want to go in the real estate business and use it, approximately \$600,000.00, to buy undeveloped land, without any explanation of what they intend using it for. We, in the Kewaskum School District, are already paying in the area of \$6,000,000.00 to enlarge and remodel our high school so there should be no reason for it there. It seems to me that \$600,000.00 would buy an extreme amount of undeveloped land.

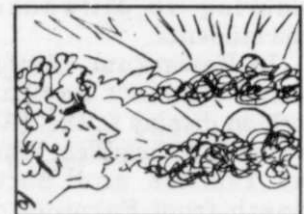
These issues will be decided by a referendum in the April election and before we decide the public should demand that we be told who owns this land to be bought, who would benefit the most from the sale, why they need the land and where they will get the money they promised to reduce the old school debts with. 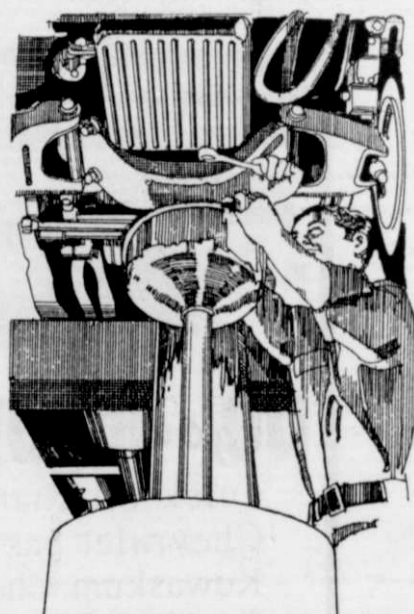

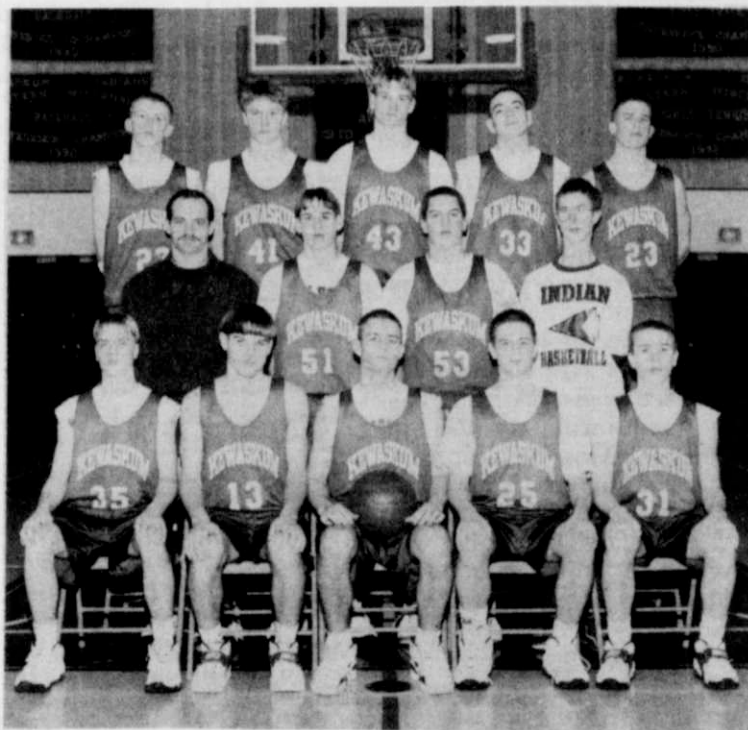

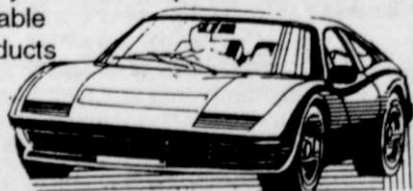
