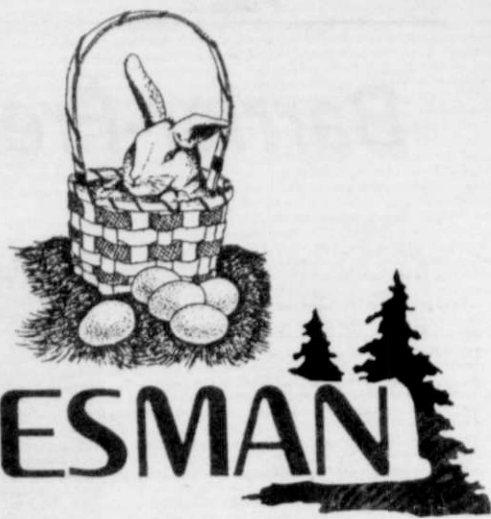

## Spring Election Tuesday

Voters of the Kewaskum School District will be asked to decide if the district should borrow (short-term) \$600,000 to purchase land for future building expansion on the April 1st ballot during the general election on Tuesday.

Taxpayers have been given this opportunity by the Kewaskum School Board, who voted to take the matter to the public. If the referendum passes, the money will not increase property taxes, but will be paid by taking \$600,000 from state tax relief.

Two incumbents on the Kewaskum School Board, Neal Weare, and Board President Jean Goeden, are being challenged by lone candidate Lisa Maul. Maul ran last year for a school board seat and was defeated. Goeden and Weare both ran unopposed in 1994. Both have been members of

the school board for several years, both having served as board president.

On the village scene, all incumbents have an uneventful race without opposition. With three seats open for village trustee, Harry Roecker and Gary Gavin will sit right down, along with newcomer Andy Pesch.

Is there a bit of apathy in the village these days or what? President Robert Wagner is seeking his third term as village president, also running unopposed, who began his term in office in April of 1993.

In the Town of Kewaskum, incumbents Chairman Dave Dorn, Clerk Barbara Wenzlaff and Treasurer Daniel W. Stoffel will be seeking re-election with no opposition. In the race for Town Supervisor, Michael Lettow is seeking his second term, opposed by newcomers Scott Sager and William

H. Butzlaff. One will be eliminated from the two seat position.

Some excitement can be found in the Town of Wayne with four candidates vying for two supervisor seats. Incumbent Mark Pamperin will receive some competition from Christian Kuehn, Don Kurer and Leonard Peter, who served on the board from 1983-1995. Leander Herriges and Jim Stoffel will face off for Town Chairman. Current Chairman Mark Strobel will not seek another term. Clerk Orville Kern and Treasurer Gerald Schulz will go unopposed in their re-election.

Farmington offers two contested races. Frank Mayer and Jim Dieringer are both seeking the position of chairperson. Incumbent Jack Theusch resigned from the position when he

## New Name, New Owner For 'Hair On Main'

Customers of Village Hair Stylists in Kewaskum are already acquainted with the business's recent makeover, but the community needs an introduction to the new Hair On Main, which combines three professionals under one roof.

Sandi Amerling has been running Village Hair Stylists since November of '88, when she purchased the business from Delores Marshke. She grew up with a background in the trade; her mother has been doing hair for over sixty years and owned a shop of her own. Five years ago, Wendi Dreher acquired the building from Marshke, and worked for Sandy, who leased the space and continued to run the business.

As of January 1, Dreher has taken over the shop, christening it with a new name, "Hair On Main." "In December, we held a contest to help rename the place,"

Wendi relates. "We had over 100 entries and our closest pick was Linda Enright's idea -- 'Just a Hair Off Main.' We changed it a bit, and would like to thank her and everyone else who offered their ideas." Linda won a backpack full of hair products for her efforts.

Wendi's new hair salon presents a "rent a chair concept," with two women renting their own space in the shop, working alongside Wendi, but self-employed. Sandi, who will be celebrating 27 years as a professional hair stylist this June, still serves her clients under the name of Village Hair Stylists, and says that her new freedom brings more flexibility to her work schedule, and the ability to

## Three Candidates Seek Town Of Kewaskum Supervisor Seats

Town of Kewaskum residents will elect two men to serve in a two-year town supervisor position at the April election. The three men running for the office are William Butzlaff, Sr., Michael Lettow and Scott Sager.

William Butzlaff, Sr., 52, is a lifelong town of Kewaskum resident and a graduate of Kewaskum High School. He has been a lifetime farmer in the township. William and his wife, Carol, have two children.

Butzlaff wants to preserve the rural, farming community setting of the town of Kewaskum, and regulate the growth of non-farming property.

Incumbent, Michael Lettow, 45, is seeking a second term as town supervisor. Some of Lettow's major accomplishments during his first term, have been the nearly complete updating of the town Land Use Plan, zoning ordinances and map.

Lettow sees future needs of the town to include the inspection of town

equipment and replacing equipment as necessary, and assessing road work that needs to be performed.

Lettow is a lifelong resident and has been a dairy farmer in the Town of Kewaskum since 1970. Michael and his wife, Debra, have four children.

He is a graduate of Kewaskum High School and is a past director of the Washington County Farm Bureau and a past director of the Washington County Dairy Herd Improvement Association.

Scott Sager, 34, was appointed town supervisor in September, 1996, and has served on the Town Planning Commission since May, 1996. He is a graduate of West Bend West High School and Valparaiso University with a Bachelor of Science Degree in Business Administration. A town resident since 1986, Scott and his wife, Karen, have two children. He is vice president of Sager's Mens Apparel Inc. in West Bend.

Sager has been a Wisconsin Department of Natural Resources Vol-

# Barrier-Free Project Dedicated at Peace Church

The new elevator addition was dedicated on Sunday, March 16, at the 9:30 a.m. service at Peace United Church of Christ, Kewaskum. Rev. James Bettin was accompanied in the worship service by Rev. Thomas Bentz, Southeast Association Minister in Wisconsin of the United Church of Christ and Rev. Bonnie Van Overbeke of the Wisconsin Conference Staff of the UCC.

The guest pastors offered special prayers and scriptures, and Pastor Bettin led the actual dedication service and preached "A Dream Come True." Other special guests included Contractor and Mrs. Richard Doede of West Bend and Architect Peter Schuyler of Milwaukee.

Church President William Stangl thanked the congregation, project workers, and guests for all the efforts and contributions involved in this addition, "which fits in just like it has always belonged." It now makes Peace Church Barrier-Free for all.

There are elevator stops on four levels in the 99 year-old building and its later addition. Handicap-accessible restrooms for men and women, the addition of a small lounge area with rocking chair for rest or baby care, plus the installation of a diaper-changing deck for infants, have made the church truly "open" to all.

Several members, unable to negotiate stairways anymore, were able to attend the Sunday service. Actually, the elevator itself has been operative since Christmas, 1996.

Special music by both chancel and men's gospel (The Churchmen) choirs added glory to the service. "Lift Me Up" was the particularly appropriate selection by The Churchmen! "Upon This Rock" was the Chancel Choir contribution. Larry Ammel directs both choirs, with Margaret McFadden and Sherry McElhatton as organists and accompanists. Youth of the church were represented by Emily Ogi, Katherine Van Ess and Jonathan Fenrick in a Lenten Symbol presentation, with Gretchen Van Ess as acolyte. "Work of the Hands" was the theme of Pastor Bettin's childrens' sermon.

Howard Zemlicka, chairman of the Barrier-Free Project, summarized the effort required from planning stage to June 23, 1996, ground breaking to the final dedication.

The total involvement of the entire congregation for ideas and help was praised as the key to success. He thanked his able committee and other specialists, named and unnamed, in various areas, who contributed: Dr. Stephen Van Ess, Kathleen Zahn, Dr. Gregory Ogi, Michael

Peterson -- all who offered time, talent, and specialized expertise in the work. Needful items were donated, and the Peace Women's Guild was cited for its help and encouragement, as were donors of much needed monies. "Excellent use of resources for stewardship" was the sum of the effort.

Lorena Wagner, church member and custodian, was praised for her months of "clean-up work," keeping

the church functional and attractive, even amid all the construction. Rev. Van Overbeke quoted a hymn, "Let us build a home where all are welcome in God's name." Peace Church has now become that for all members and visitors. A tribute was given by Charles Petrie for Donald Below, loyal Peace Church member who died on the eve of the dedication at Cedar Lake Health Care Center. He had planned to be present in his wheelchair on Sunday -- and now his Wednesday funeral would be the first to make use of the spacious new elevator.

A potluck banquet and fellowship period followed the sanctuary service for all celebrating the dedication in joy and thankfulness.

do some different things.

### CREOLE COD FILLETS

- 2 lb. cod fillets
- 2 Tbsp. flour
- 1 small onion, sliced
- 1 (1 lb.) can tomatoes
- 1 pimiento, chopped
- 1 bay leaf
- 1/4 tsp. monosodium glutamate
- 1 tsp. salt
- dash pepper
- 1/4 tsp. oregano

If fish is frozen, allow to thaw. Cut into serving pieces. Place in shallow 2-quart baking dish. Mix remaining ingredients; pour over fish. Bake in oven at 350° for about 1 hour. Makes 6 servings; 133 calories per serving.

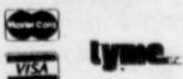

## Director Appointed for County Department of Social Services

County Social Services Board Chairman Jack German announced the appointment of Karen L. Bougneit to the position of Director of the Department of Social Services for Washington County.

Bougneit, a long time member of the staff and currently acting director, began her employment effective Thursday, March 6, 1997.

In this position, she will direct the activities of the department's seventy-one employees and its \$7.6 million annual budget.

ty August 1, 1969. She was appointed Deputy Director of the department in 1985.

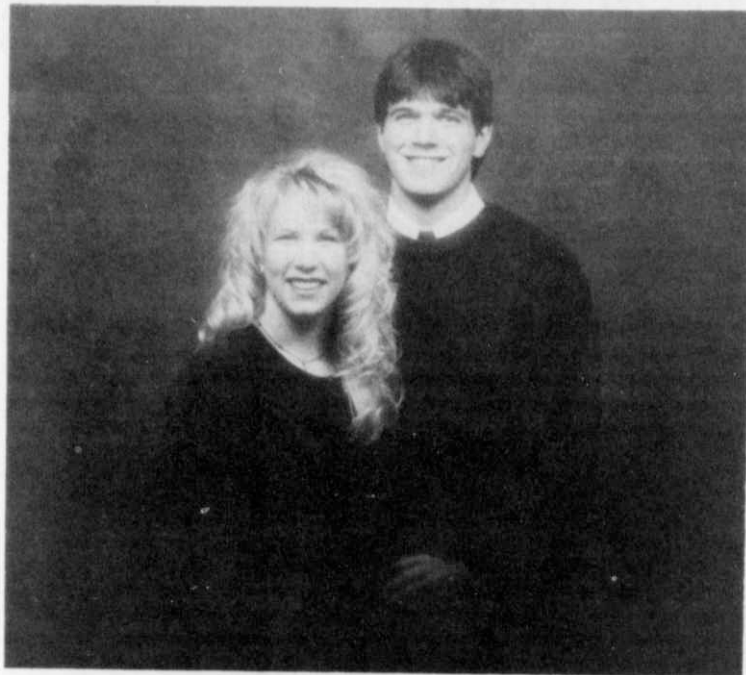

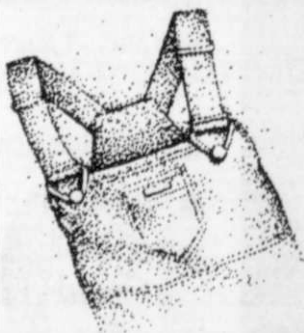

# Four Are Candidates for Town of Wayne Supervisor

Town of Wayne residents will elect two men to serve in a two-year term supervisor position at the April Election. The four candidates seeking the position include Christian Kuehn, Don Kurer, Mark Pamperin and Leonard Peter.

Christian Kuehn, 45, moved to the Town of Wayne from Sterling, Illinois 12 years ago. He states, "I wanted to find a place where I could own a few acres, raise a little beef, be close to a highway, and could look out the window and have a view, rather than looking at the house next door. It took 18 months to find our house."

Kuehn is running for supervisor at the encouragement of his neighbors, local dairy farmers and truckers and because he is committed to preserving the existing rural character and landscape of the town.

He views the completion of the Land Use Plan as a priority and agrees that town residents should be involved in the planning process and encourages their participation. Due to the recent resignation of the town's maintenance man, Kuehn feels the board will need to take action to find a cost effective way to assure the roads and equipment

continue to be properly maintained.

Kuehn is employed as an Assistant District Manager of the Social Security Administration and has 23 years of administrative experience. He is a graduate of Pemberton Township High School and Valparaiso University earning a bachelor degree in Political Science. He is a member of St. John's Lutheran Church in West Bend where he currently serves as chairman of the Stewardship and Evangelism Committee, has served on the church council for 12 years, and is the past chairman and past secretary of the Board of Elders. Christian and his wife, Cynthia, have two children.

As a town supervisor, Don Kurer would be committed to developing a sound land use plan, preserving the town's rural character and family farms, managing residential development and population growth, protecting woodland and wetland resources, developing steps to discourage and prevent rural crime and serving the citizens of the Town of Wayne with integrity.

Kurer received a Bachelor of Science degree from the University of Wisconsin-Madison in Soils and

Agronomy, has 30 years experience in farm and land use planning with the Department of Agriculture, has served as an advisor to Washington County's committee on farmland preservation, worked seven years mapping soils for South-eastern Wisconsin Regional Planning Commission (SEWRPC) Land Use reports, served as an advisor to Washington County's Land Use Department reviewing subdivision plats for environmental impacts and for many years has practiced conservation measures to control soil erosion on his own farm.

He is a member of Gideons International, has been a trustee on the Board of the West Bend Cemetery Association for 28 years, is a charter member and former Elder of Community Church of West Bend, and served his country in the U.S. Army Paratroopers in the South Pacific.

A retired District Conservationist with the U.S. Department of Agriculture serving Washington County, Kurer, 70, and his wife, Dorothy, have been farm owners in the town of Wayne for 28 years. They have four children and nine grandchildren.

Incumbent Mark Pamperin, 53, is completing his

first term as town board supervisor and Plan Commission chairman. He is a lifelong resident and dairy farmer in the Town of Wayne. Mark and his wife, Betty, have four children.

Pamperin is a graduate of Winnebago Lutheran Academy, completed a two year Agriculture short course at the University of Wisconsin-Madison and a six year study at Moraine Park Technical College in West Bend and Fond du Lac.

According to Pamperin, the most immediate issue before the town board is the completion of a sound Land Use Plan and updated Zoning Ordinances. Other areas of regard include town maintenance, brushing and town road maintenance.

Pamperin is a member of the Washington County Agricultural Extension and Education Committee. Falling under the jurisdiction of this committee, Pamperin is a member of the Site and Layout Committee and Chairman of the Advisory Committee. He is a member of the Washington County Dairy Promotion Committee and a member of Zion Lutheran Church where he has served as president and secretary, was a Sunday School teacher for 12 years and now assists as a substitute teacher, is a choir member and serves on the Stewardship and Evangelism Committee. Pamperin has served on the Board

of Directors for 15 years, is a past president and past secretary/treasurer of the Washington County Farm Bureau and is a past president and past board member of the Washington County Holstein Breeders Association.

The final candidate, Leonard Peter, brings 12 years experience having served as a supervisor on the Town of Wayne board from 1983-1995. He is a lifelong resident of the Town of Wayne where he farmed until 1983. He is currently employed part-time by Farmers Union of Madison.

Peter states he has the time to dedicate to serving the Town of Wayne people and will sincerely attempt to fairly represent them and their interests. He will try to hold taxes down as much as possible and wants to maintain the rural character of the township but is in favor of one to two acre lots that can be easily maintained by the landowner.

Peter is a member of St. Kilian Catholic Church where he served as treasurer for 23 years. A graduate of Kewaskum High School, Leonard, 71, and his wife, Beatrice, have four children.

The positions of town treasurer held by Donald Schulz and town clerk held by Orville Kern are uncontested.

The voting polls will be open from 9 a.m. until 8 p.m. on Tuesday, April 1, at the Town Hall.

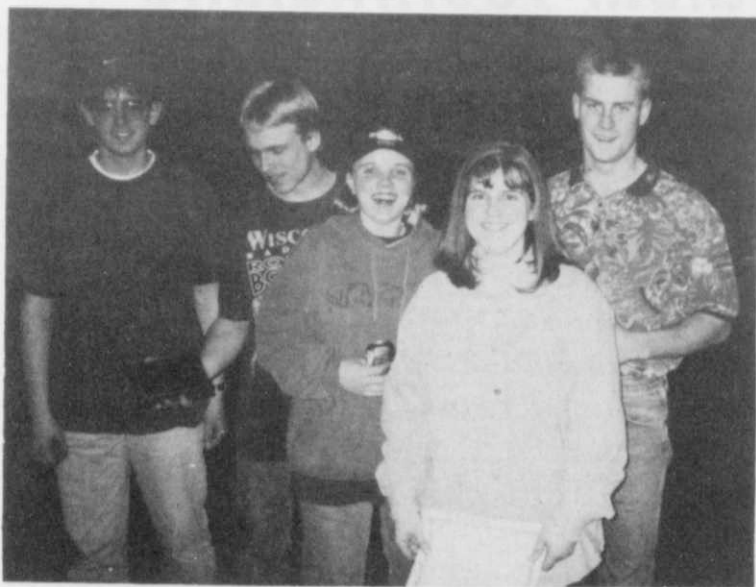

Jim Degnitz, Joe Enright and Dick Schneider are running for one seat on the Town Board, along with write-in candidate Richard Finch. Both Degnitz and Schneider have previous experience on the board. Town Clerk Joanne Oneska and Treasurer Eugene Fay are both running unopposed.

A hot race for Town of Auburn chairperson is taking place between incumbent Harry Knoelke and opposing candidate Walter Ferber. As for the two open supervisor seats, incumbent Kenneth Jandre will be facing newcomer to the political arena, John E. Reigle, and Samuel O. Gudex, who is running for his first full term, after completing the unexpired term of Dennis Fronck, who passed away.

## Local Need for Emergency Medical Technicians



Could you play a vital role as a member of the Kewaskum Fire Department Rescue Squad? Are you interested in being part of a high quality emergency service team? Contact the Kewaskum Fire Department soon.

Perhaps you have been fortunate and have never had to call "9-1-1". Or maybe you have found yourself or a family member in a health situation or fire situation where you required immediate assistance and did call "9-1-1". Have you ever given much thought about those individuals who respond to emergency needs 24 hours a day, seven days a week, other than you were so very grateful they came?

Kewaskum, like many communities throughout the state, is actively seeking men and women at least 18 years of age who are interested in serving Kewaskum and the surrounding area in emergency situations.

The most immediate need is in the area of Emer-

gency Medical Technicians (EMTs) who staff the Kewaskum Fire Department Rescue Squad. It is becoming increasingly difficult to find people who are available to respond to calls during weekdays and this has become a concern for fire department and Village of Kewaskum officials.

Several possible suggestions are being reviewed by both parties. The day shift runs from 5 a.m. to 6 p.m. and the night shift from 6 p.m. to 5 a.m. Respondents not available for an entire shift split time with another EMT or driver.

The department currently is staffed by 20 EMTs and nine drivers. Of those, eight EMTs and two drivers are available to respond during the day. It's not monetary compensation that attracts members but rather EMTs and firefighters are volunteers who enjoy community involvement, commitment and find

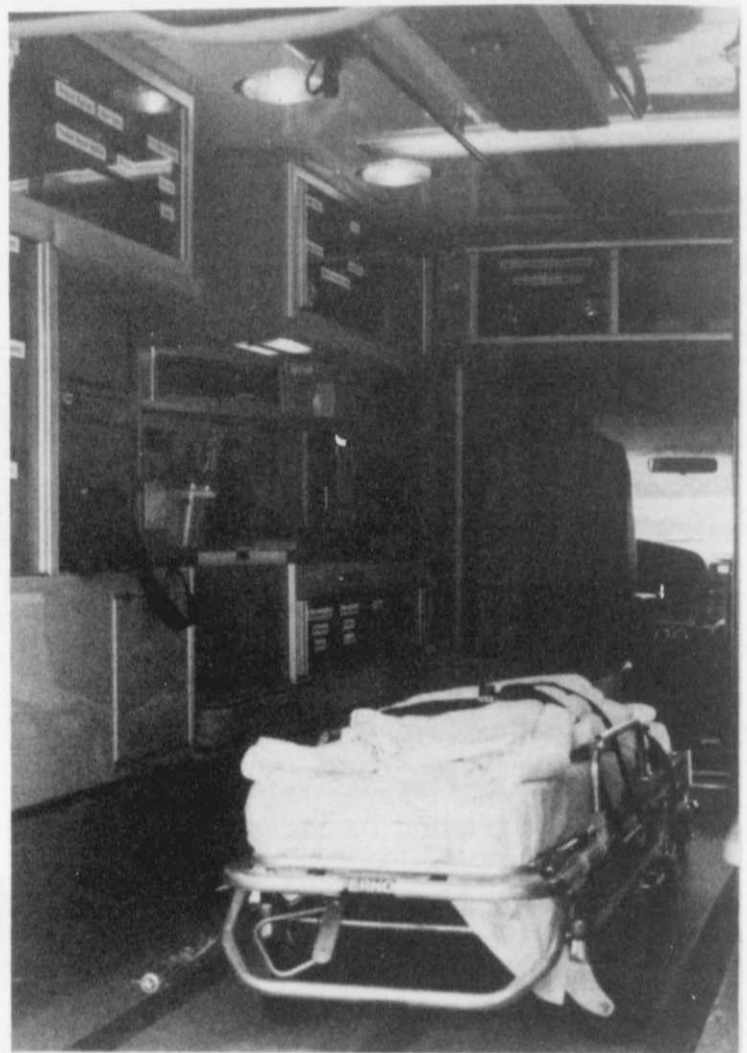
enormous satisfaction in helping someone.

The volunteers come from a variety of backgrounds, interests, ages and employment areas -- from self-employed, service industry, to blue collar or white collar jobs.

EMTs must take a 110-hour initial certification course plus an additional 32 hour course every two years for recertification. Night classes are available at Moraine Park Technical School in West Bend and day classes can be taken at Moraine Park Technical School in Fond du Lac.

In 1996, the Kewaskum Fire Department Rescue Squad responded to 215 calls while the fire department responded to 31 calls.

Any interested individual can contact Chief Mark Groeschel at the firehouse at 626-2411 or stop in at the firehouse after 7 p.m. on Thursday evenings.

## Direct Extension Listed for New Phone System in District

A new phone system that makes it easier and quicker to reach specific district personnel has recently been installed in the School District of Kewaskum (all schools and offices except Wayne and Farmington Elementary Schools can be accessed through any location called).

The phone numbers for all buildings have remained the same, but now calls can be specifically directed to the person or department the caller wishes to contact. If, for some reason, the person is unavailable, the caller can leave a spoken message for that person.

Although the new system is often called "Voice Mail," it is more than that, and simple to use. When a caller calls, three options are presented: dial the desired extension, press the star key for a directory, or press a single digit to reach the desired building. The

new system not only allows direct, easy access, it also allows the District to handle a greater number of calls more efficiently than before.

## 2 Injured in Hit and Run Accident Sunday

FARMINGTON- A motor vehicle accident occurred in the Town of Farmington this past Sunday, March 23, at 8:28 pm on STH 144 just south of STH 28.

Louis S. Ottmer Jr., of Allenton, was driving his 1967 Chevrolet pickup truck, he was traveling southbound on STH 144. The other driver, William L. Flunker of Cascade was driving his 1984 Mercury Stationwagon northbound on STH 144. Flunker was carrying two other passengers.

According to Flunker, Ottmer was traveling southbound in the northbound lane, so he (Flunker) swerved left in the southbound lane to avoid a head on collision (with Ottmer), as he did this Ottmer turned right striking Flunker on the passenger side. Ottmer spun clockwise coming to rest in the ditch area west of the road facing north. Flunker also spun clockwise, overturning, coming to rest on the drivers side of the stationwagon facing east on the west side of the road.

According to skid marks on the road Ottmer was indeed traveling southbound in the northbound lane for a period of time.

Flunker stated that Ottmer came over by them and asked "Are you O.K.?" Flunker stated that he was O.K. but he needed to get his friend out of the car. Flunker further stated that Ottmer helped his friend out of the stationwagon. Flunker then said Ottmer stated "I'll be right back, I have to turn my headlights off."

Kewaskum Fire Dept. personnel and Resuce personnel were called and immediately rushed to the scene with one ambulance and the Jaws of Life truck.

Flunker and his friend were transported to St. Joseph's Community Hospital by Kewaskum Rescue.

After talking with Flunker, the reporting Washington County officer, David Klopfenstein went to speak with Ottmer but was unable to locate him, he was then thought to have fled the accident scene by foot.

Officer Klopfenstein then did a registration check on the pickup and found it registered to Henry C. Laatsch of

Fox Lake. Dispatch attempted to call him and found the registered owner was deceased and the vehicle was sold to Ottmer. Officers on the scene were familiar with a Louis S. Ottmer Jr., so they attempted to locate him in Allenton but were unsuccessful. Ottmer's father was eventually located and he stated his son was "up north and out of the area." but told officers

his son had recently purchased a pickup truck matching the description of the suspect vehicle.

On Monday Ottmer contacted Dep. Rewerts regarding the incident. In questioning, Ottmer stated he was southbound on STH 144 when he saw a northbound vehicle (Flunker) "Crossover or lose control, and hit me head on." Ottmer said his

vehicle spun around and ended up in the ditch west of the road. He said he went over to the other car asked if they were O.K. and told them, he needed to shut his headlights off. The driver (Ottmer) said he left the scene walking in the westward direction, and walked as far as Lighthouse Lanes

and two guys brought him home. "I ran because I was scared and freaked out. I had nothing to drink, nor did I use any drugs before the accident."

A request for charges has been given to the District Attorney for Ottmer, regarding the felony charge of Hit and Run with Injury.

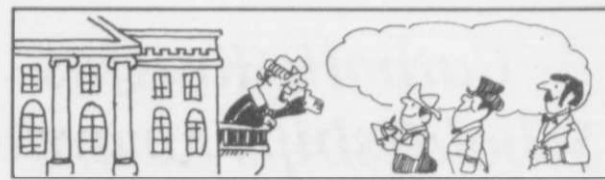

## An IRA Can Lower Tax Bill

For many people who work for companies without a pension plan, setting up an individual retirement arrangement (IRA) can give a double bonus. It can lower their taxes if they make deductible contributions to the IRA and provides for a more secure retirement.

Anyone who has taxable compensation, such as wages, tips, commissions and taxable alimony, and who will be under age 70 1/2 at the end of the year can set up an IRA. Money can be put into an IRA at any time during the year or by the due date of the tax return for that year, not including extensions.

Contributions must be in the form of money, such as cash, check or money order. Property doesn't count. The most that can be contributed for any year is \$2,000 or taxable compensation, whichever is smaller. For married couples who work, the maximum is \$2,000 each. A working spouse can set up a spousal IRA for a spouse who has little or no taxable compensation. The maximum combined contributions to the working spouse's IRA and the spousal IRA is \$2,250. Many people can deduct part or all of their contributions. IRA earnings generally are not taxed until they are withdrawn from the account.

Publication 590, *Individual Retirement Arrangements (IRAs)*, gives more information on IRAs, including how to compute and report deductible and nondeductible contributions, when to start withdrawing money and what actions will result in penalties. Order it by calling 1-800-829-3676.

Notice is hereby given of a spring election to be held in Washington County, on April 1, 1997, at which the officers named below shall be chosen. The names of the candidates for each office to be voted for, whose nominations have been certified to or filed in this office, are given under the title of the office, each in its proper column, together with the questions submitted to a vote, for a referendum, in the sample ballot below.

#### INFORMATION TO ELECTORS

Upon entering the polling place, an elector shall give his or her name and address before being permitted to vote. Where ballots are distributed to electors, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the elector shall retire alone to a voting booth and cast his or her ballot except that an elector who is a parent or guardian may be accompanied by the elector's minor child or minor ward. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

At the spring election, where lever machines are used, the elector shall depress the lever at the right of the name of the candidate for whom he or she intends to vote. To vote for a person whose name does not appear on the ballot, the elector shall write in the name of the candidate of his or her choice in the space provided for a write-in vote.

Where marksense voting is used, the elector shall darken the oval next to the name of the candidate of his or her choice for each office for whom he or she intends to vote. To vote for a person whose name does not appear on the ballot, the elector shall write in the name of the candidate of his or her choice in the space provided and darken the oval at the left of the write-in line. On the referendum question, the elector shall darken the oval next to "yes" if in favor of the question, or the elector shall darken the oval next to "no" if opposed to the question.

The vote should not be cast in any other manner. If the elector spoils a ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one elector. If the ballot has not been initialed by two inspectors or is defective in any other way, the elector shall return it to the election official, who shall issue a proper ballot in its place. Not more than five minutes' time shall be allowed inside a voting booth. Unofficial ballots or a memorandum to assist the elector in casting his or her vote may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official marksense ballot is marked, it shall be inserted in the ballot sleeve provided so the marks do not show. After casting his or her vote, the elector shall leave the booth, insert the ballot in the voting device, and shall leave the polling place promptly.

An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty reading, writing or understanding English or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the elector's employer or an agent of that employer or an officer or agent of a labor organization which represents the elector.

# Letters to the Editor

## To the Taxpayers of the Township of Auburn:

I, along with the other eight people, whose signatures appear below are first and foremost taxpayers of the Township of Auburn. We, the following, are also active members of the Campbellsport Volunteer Fire Department, who are very concerned with the price of fire protection, we as town taxpayers will pay after April 1, 1997.

As many of you may be aware, there has been a lengthy battle between the Township of Auburn and the Village of Campbellsport that has now gone to litigation regarding the proposed fire contract. This letter by no means is to defend one side or the other, but is to be informative regarding the associated cost of fire protection that the town board has elected to pay due to unresolved negotiations, come April 1, 1997.

On April 1, 1997, at 12:00 a.m., the current contract will expire, leaving the Township of Auburn with NO contract to provide fire protection service to its taxpayers, as required by state law. Therefore, the Campbellsport Fire Department has no legal obligation to provide fire protection services to the Township of Auburn. Please rest assured that the members of the Campbellsport Volunteer Fire Department will not leave you out in the cold. Fire protection services will be provided to you, the taxpayer, but at a price much greater than the fire contract amount.

As published in the *Campbellsport News* a couple of months ago, the township will be billed on a per call basis, with each truck and firefighter charging an

associated hourly rate. In 1996, the Town of Auburn, had eight fire calls in their jurisdiction, which resulted in 13 1/2 hours on the fireground and a total of 291 man hours. This would have resulted in a total bill submitted to the Township of Auburn for \$43,575.00. The fire contract for 1996 was \$16,000.00, and an additional \$10,000.00 to be placed in an equipment fund designed solely for truck purchases. This is a difference of \$17,575.00, which I do not believe would have been budgeted for fire suppression services. In a time when the township is already having to borrow money to pay its bills, I do not feel this situation is in the best interest of the township for its taxpayers.

The proposed fire contract to the Township of Auburn for 1997, is \$18,750.00, with an additional \$15,000 to be placed in the dedicated equipment fund. Also included in the fire contract amount, is service that is provided by the Campbellsport Ambulance. Since ambulance service will still be provided to the township, a \$5.00 per capita charge will be established for the Town of Auburn, as is currently done with the Town and Village of Eden for which ambulance, but no fire protection service is provided by the Campbellsport Fire Department under contract. This fee would result in approximately an additional \$10,000.00, paid by the township that is above and beyond any fees billed to the township for fire protection services.

In addition, since there is no established fire contract between the township and the fire department, there is then no mutual aid

contract with neighboring fire departments and the Campbellsport Fire Department for the Township of Auburn. This would then allow those mutual aid departments that we call upon for assistance to bill you the taxpayer DIRECTLY for their services rendered. This fee would again be above and beyond what is billed to the township for services rendered by the Campbellsport Fire Department. This situation, that appears to be inevitable, may also effect your insurance rates that you pay on your property. I strongly urge you to contact your insurance company and check into any problems that this may cause.

The reason for this impasse in contract negotiations, I cannot comment on, for I do not have all the facts. For this information, I strongly urge you to contact one of your town board members for answers to these questions. For any information regarding the fire department or services that they will provide, I am sure that any member of the department will be happy to answer any question that you may have.

In the township's best interest, I hope this matter is resolved soon so that fire

protection for the township can be provided at the contract amount. Remember, ultimately this comes out of all our pockets somewhere down the road.

I think that the Kewaskum School Board has been very wise in its pursuit of acquiring land for our schools. Just looking at the housing development, completed and planned, tells us that the district should expect tremendous growth in the near future.

Also, I think that the timing is fiscally prudent.

Appropriate and affordable land could be very difficult to find in the near future. As this area is recognized as a very desirable living area, prices on land for development is climbing dramatically each year. Land purchase is the right thing and now is the right time.

The Kewaskum School Board is continuing to promote the purchase of land with a flyer, a radio talk show and an information meeting on 3/25/97, probably all at our expense.

They claim in their flyer that there will be no impact on property taxes, but in reality they are already using one dollar a thousand of the assessed value of our home and are obviously intent on continuing to do so with this scheme so the impact was already made and will continue if this is passed.

They are planning on purchasing 78 acres of undeveloped land for an exorbitant cost of \$545,000.00 of which 20 acres is unfit for building and the rest has not been tested for it's fitness. Who will pay for the cost of this testing, the present land owner or us? District electors must vote at the times and places at which they cast their ballots at regularly scheduled elections.

### INFORMATION TO ELECTORS

(a) Upon entering the polling place, an elector shall give his or her name and address before being permitted to vote. Where ballots are distributed to electors, the initials of 2 inspectors must appear on the ballot. Upon being permitted to vote, the elector shall retire alone to a voting booth or machine and cast his or her vote, except that an elector who is a parent or guardian may be accompanied by the elector's minor child or minor ward. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

(b) (i) If paper ballots or lever machines are used, then on the special election question, the elector shall make a cross (X) in the square at the right of or depress the button or lever next to the answer which he or she intends to give.

(ii) If a punch card voting system is used, then on the special election question, the elector shall make a punch or a hole at the right of "yes" if in favor of the question, or the elector shall make a punch or a hole at the right of "no" if opposed to the question.

(iii) If a mark sense voting system is used, then on the special election question, the elector shall make a mark in the space at the right of "yes" if in favor of the question, or the elector shall make a mark in the space at the right of "no" if opposed to the question.

(c) The vote should not be cast in any other manner. If the elector spoils a ballot, he or she shall return it to an election official who shall issue another in its place, but not more than 3 ballots shall be issued to any one elector. If the ballot has not been initialed by 2 inspectors or is defective in any other way, the elector shall return it to the election official, who shall issue a proper ballot in its place. Not more than 5 minutes' time shall be allowed inside a voting booth or machine. Unofficial ballots or a memorandum to assist the elector in marking or punching his or her ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

(d) (i) After an official paper ballot is marked, it shall be folded so the inside marks do not show but so the printed endorsements and inspectors' initials on the outside do show. After casting his or her vote, the elector shall leave the voting machine or booth and, where paper ballots are distributed to the electors, deposit his or her folded ballot in the ballot box or deliver it to an inspector for deposit in the box, and shall leave the polling place promptly.

(ii) If a punch card voting system is used, then after an official ballot is punched, it shall be inserted in the envelope provided so the punches do not show. After casting his or her vote, the elector shall leave the booth, deposit the envelope containing his or her ballot in the ballot box, or deliver the envelope to an inspector for deposit, and shall leave the polling place promptly.

(iii) If a mark sense voting system is used, then after an official ballot is marked it shall be inserted in the envelope provided so the marks do not show. After casting his or her vote, the elector shall leave the booth, insert the ballot in the voting device, discard the envelope, and shall leave the polling place promptly.

(e) An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty in reading, writing or understanding English, or that due to disability is unable to cast his or her vote. The selected individual rendering assistance may not be the elector's employer or an agent of that employer or an officer or agent of a labor organization which represents the elector.

NOTE: Electors residing in municipalities which require voter registration must be registered to vote in this referendum. You can register by contacting your municipal clerk.

#### AN ORDINANCE TO AMEND THE TOWN ZONING MAP

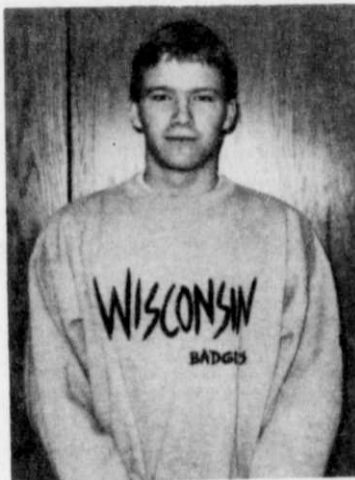

## ORDINANCE NO. 97-2 AN ORDINANCE TO AMEND CHAPTER 1 GENERAL GOVERNMENT

THE VILLAGE BOARD OF THE VILLAGE OF KEWASKUM DO ORDAIN AS FOLLOWS:

WHEREAS, the Village President and Village Board do recommend the amending of the Municipal Code in reference to the Citizen's Advisory Board to reflect a broader type Committee to help to improve and to promote economic development.

THE VILLAGE BOARD OF THE VILLAGE OF KEWASKUM, WISCONSIN WISH TO AMEND 1.36 AND RECREATE 1.36 AND ORDAIN AS FOLLOWS:

#### 1.36 ECONOMIC DEVELOPMENT/ADVISORY COMMITTEE.

(1) Purpose of chapter/section. The Economic Development/ Advisory committee, referred to in this chapter as ED/AC, shall be a citizens advisory committee whose purpose shall be to advise the Village Board on matters of economic development, implementing economic development activities that will assist in improving economic conditions in the village, developing and maintaining the village industrial and commercial base, and to assist on specific matters assigned to it by the Village Board.

#### (2) Composition.

The ED/AC shall consist of seven members and one ex-officio member as follows:

- The Village President;
- A member of the Village Plan Commission;
- Three citizens whose principle occupation shall be business owners or managers of business in the Village of Kewaskum with known interest in local economic development, of which two may be nonresidents;
- Two citizens having general knowledge of the affairs of the village and interest in local economic development;
- An ex-officio member who shall be the Village Administrator (or alternate Deputy Clerk) and shall serve as secretary;
- The chairperson shall be elected from the members and shall serve for a period of one year.

#### (3) Appointments; terms; vacancies.

- All appointments shall be made by the Village President and confirmed by the Village Board.
- Appointments of the five citizen members shall be for staggered three-year periods, except that those first appointed: one shall be for one year; two shall be for two years and two shall be for three years.
- The Plan Commission member shall serve a two-year term and will be appointed in May of odd-numbered election years. (1.36 (3)(a)).
- Vacancies will be filled in the same manner as the original appointment for the unexpired term of office thereof.

#### (4) Powers and duties.

The Economic Development/Advisory Committee shall be responsible for implementing the following economic developmental program goals:

- Guide and coordinate the efforts of local individuals and organizations concerned with the economic development of the village.
- Retain existing employment opportunities and encourage the expansion of existing business and industry in the village by helping to meet the needs of existing employers.
- Create new employment opportunities through the attraction of new employers.
- Assist in creating new employment opportunities by facilitating entrepreneurial opportunities in the village.
- Facilitate economic development in the village through the provision of community facilities and services that will assist in the expansion of employment opportunities.
- To assist the village in marketing coordinating and facilitating the development of the proposed Kewaskum Industrial Parks, Community Central Business District and Commercial Business District.
- The committee may act as liaison between the Village Board and private industrial development groups, such as the Chamber of Commerce and shall recommend to the Village Board such action of the Committee as determined as necessary.
- When necessary, the Committee may utilize the services of the Village's Engineers, the Village Attorney and other Village officials and employees, upon such basis as shall be mutually agreed to or as may be determined by the Village Board.
- The committee may develop and recommend feasible methods of financing and other measures of public input into the Economic Development process.
- The committee shall have the authority to make all necessary rules governing its own proceedings, but generally follow Roberts Rules of Order.
- The committee shall annually report to the Village Board or report on any type of achievements regarding the fulfillment of any of such programs.
- The committee shall work with the County and State as well as any other agency or governmental body that would best benefit the goals of said committee, in the promotion of economic development for the Village of Kewaskum.

(5) Meetings. One regular/annual meeting of the Economic Development/Advisory Commission shall be held in May of each year. Special meetings of the Committee may be called by the Chairperson or any two members upon reasonable notice to all other members. (The Village Board may request the Committee to also meet to address an issue of community importance.)

State Law Reference: This chapter is adopted in order to facilitate Village action in the promotion of industry and it is intended that the carrying out the intent of Sec. 66.52, Wis. State Stats., shall be the purpose of this Section and only the authority contained in this Section, in Sec. 66.52, Wis. State Stats., and such authority as is granted by the Village Board shall be carried out by the Economic Development/Advisory Committee.

This Ordinance shall take effect upon passage and publication as provided by law.



## KHS Students 'Speak Out' Against Drinking and Driving



Throughout Kewaskum High School, student volunteers in white faces and carrying gravestones, symbolized the teens that are killed every day as a result of drinking and driving.

Making a statement without saying a single word.

Dressed in dark clothes, forbidden to speak, faces painted in the white pallor of death, several Kewaskum High School students from Mr. Shaw's Health class assumed the role of the dead to symbolize the tragedy of drinking and driving, and how the combination often proves fatal.

Every half hour, according to Mr. Shaw, another person between the ages of 15-19 is killed as a result of drinking and driving. To illustrate the gravity of such information, student volunteers spent the entire day recently in the silence and dress which symbolized death, even traveling through the halls bearing gravestones reiterating the tragic news.

Reactions of student volunteers differed in their perceptions of the day, some found the experience "weird," some gratifying (in helping bring awareness to the problem), others felt isolated and alone. Students seemed to agree, however, on one thing: the importance of their message.

"Let's be aware of this epidemic problem, and (let's) make healthy decisions individually and collectively, as a school."

And certainly such messages are worth hearing, even if it takes some silent students to make them heard.

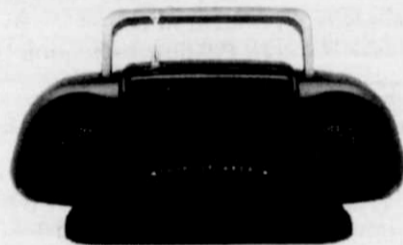

All mountain bike and bridle trails in the Kettle Moraine State Forest-Northern Unit are closed.

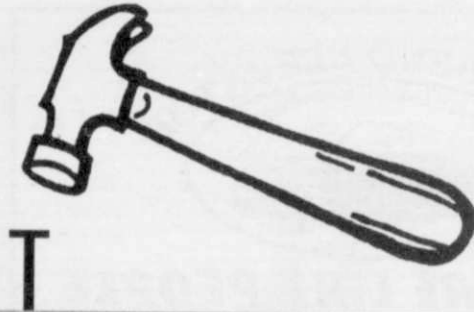
To protect the trails from damage during ice thaws and spring rains, the trails will be routinely inspected and will open when conditions on the trails improve.

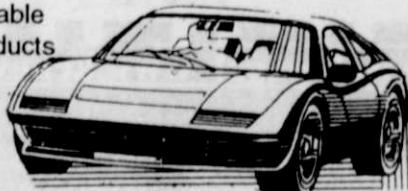

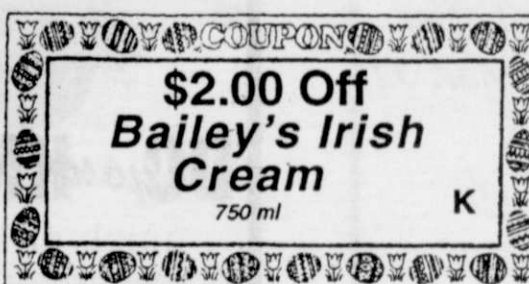
