Pearson is Named Permanent District Superintendent; Soerens Selected as KMS Principal

A unanimous vote Monday evening after adjourning from closed session, secured Clark Pearson's role as a school district superintendent, with Kewaskum school board members confident their choice for the permanent position will bring continuity and stability to the district.

The decision came just three months after Pearson was asked to serve as interim superintendent to fill the vacancy created by Dr.

Charles Johnson. Johnson surprised the community when he announced his sudden decision to take an executive position with a Washington D.C. based "think tank" foundation, leaving behind the last year of a two year contract with the school district.

Pearson, now in his 26th year with the school system, first served as high school principal (1972-1984), eventually switching to teach high school math. Last year, he took on a new role as Kewaskum Middle School principal, until stepping into the interim superintendent position on August 18.

"I believe that Kewaskum schools have been great schools, and I want to continue to uphold that quality, always working to improve upon it," Pearson stated Tuesday morning. A long time resident of the community, Pearson coached football for 12 years and various other sports during his career.

"I feel I have an understanding of what the com-

munity wants for their schools," he related.

Mr. Pearson received his bachelor's degree from the University of Wisconsin-Whitewater and a master's degree from the University of Northern Iowa. Before moving to Kewaskum, his previous teaching experience included the New Holstein, Kiel and Greendale school districts.

Board president Jean Goeden commended Mr. Pearson for his dedication to the school district, and said she was urged by an overwhelming majority of community members to hire Pearson permanently. "It was the people of this community that talked to me, that gave him their support, and I put a lot of credibility into that."

To bring his superintendent's license up to date, Pearson will be taking six credits at Marion College this semester. He was granted his license in 1978. His contract, effective through June 30, 1999, sets a salary of \$85,000.

Gross Tax Rate \$23.05 Per Thousand Board Approves '98 Budget

The Kewaskum Village Board unanimously approved a \$87,906 or 5.3% general budget increase at Monday evening's Public Hearing in front of one village taxpayer in attendance.

Village taxes, including debt retirement and interest are \$689,341.00 at the rate of \$5.78 per thousand. The total tax levy is \$2,748,699.70 at the rate of \$23.05 per thousand.

The property tax levy to be collected will be reflecting an increase, caused from real growth within the village, a drop in the ratio equalized value versus assessed value and a slight increase.

Looking at the entire picture, Village Administrator Dan Schmidt explained the tax levy will reflect an increase of \$60,323 or 9.59%.

The Village Property Tax Rate will also reflect an increase of 23.6c or 4.3% in comparison to that of 1996-97. The equalized value for 1997 has increased \$11,246,700 or 9.65% and the assessed value for 1997 increased \$5,802,100 or 5.1%.

The Village Tax Rate for 1996 was \$5.545 compared to the 1997 Tax Rate of \$5.781 per \$1,000 of assessed value.

Schmidt stated the assessed gross tax rate has increased from \$22.10 to \$23.05 this year, an increase of \$.95 or 4.3%, adding all taxing jurisdictions have tried to stabilize their budgets. With the help of state funds being sent to the school districts, this appears to have helped.

The administrator further explained, "The State Tax Credit, we have received and that comes in at \$1.81 per thousand." This means the net Tax Rate is \$21.24.

Schmidt also added, "We do have our final figures on the lottery credit now, and it comes out to \$71.81." Every tax bill will receive the lottery credit.

A breakdown of the 25.1% or (\$5.78) of the \$23.05 gross tax rate pays for approximately 71 municipal services summarized as follows:

These are provided under the direction and control of the Village Board and Administrator.

The remaining 74.9% (\$17.27) of your gross tax rate is collected by the village on behalf of the four other agencies that can't, by law, issue their own tax bills, and includes: Washington County - \$4.23; State of Wisconsin - .21; Kewaskum School District - \$11.32 and Moraine Park Technical College - \$1.51.

For the village, the level of all basic services has remained at or near the same as in previous years. The budget shows a modest amount of street maintenance work accomplished in 1998. The State Legislature did increase the Department of Transportation budget slightly, making it possible for the Village to maintain a similar level of proposed street work.

It should also be noted that the Village has again had its share of State Shared Revenue and Expenditure Restraint monies cut. This year, approximately \$21,547 will be lost.

According to the Village Administrator's Taxpayer Memo, the Village Board and Village Employees pride themselves in providing quality services at a reasonable cost to the taxpayers, as well as trying to reduce the cost of providing those services.

It should also be noted the State does provide grant money to operate an effective recycling program currently, but this program level of funding by the state has been reduced. A certain percent of recovered recyclable materials need to be met or the Municipality will be required to charge for garbage collection with the implementation of a volume base fee. The Village of Kewaskum meets this percentage by only two points, so everyone is asked to improve their participation in the recycling program.

In other business brought before the Board, Schmidt stated garbage collection for the holidays would remain on the usual pickup days, that being Wednesday, December 24, and Wednesday, December 31. He added the Municipal Build-

Kewaskum Frozen Foods Pledges \$25,000 Donation Fair Park Livestock Fundraising Is Something to 'Crow' About

Only hours after announcing a major donation of \$25,000 from Hansen's Piggly Wiggly Food Stores, another donor has pledged \$25,000 for naming rights to the Small Animal Barn (Poultry/Rabbits), according to Sandy Lang, Fair Park Liaison. Bob Beisbier, owner of Kewaskum Frozen Foods Inc., pledged his donation showing his support of the Washington County Fair Park Livestock Fundraising Campaign.

Kewaskum Frozen Foods Inc., which has been in business since 1941, provides custom slaughtering, processing, retail, wholesale, sausage and fresh meats to businesses throughout Washington County.

Bob has been a strong supporter of Washington County 4-H youth by being a part of the annual Meat Animal Sale and Carcass Show and also holding various education programs at

his business.

The newly named Kewaskum Frozen Foods, Inc. Small Animal Barn will be the only building in the complex that will accommodate year-round usage. The 4-H youth shooting sports (archery) is one group that plans to use the building off season.

The Washington County Ag & Extension Committee recently kicked off a public campaign to raise \$615,000 to help offset the cost of developing the livestock area. With this donation, a total of \$278,000 in pledges have been received. Contributors of \$25,000 or more earn the privilege of naming rights to one of the live-

stock buildings. The following pledges have been made: Farm Progress Days Show Pavilion; Roskopf Family Milking Parlor; Dairyland Seed Dairy Barn; Farmers Inc. Beef Barn, and Hansen's Piggly Wiggly Food Stores, Inc. Swine/ Sheep Barn.

Other sizable donations have been pledged from the State Bank of Newburg and Saukville Feed and Seed and various members of the Washington County Board of Supervisors.

A commendation will be presented to Kewaskum Frozen Foods Inc. at the next County Board meeting, scheduled for December 9, 1997.

Kenneth Soerens, long time high school social studies teacher, received thumbs up from the School Board Monday night, as they voted to change his interim middle school principal position to a permanent title.

Soerens took over the role of KMS interim principal in September, to replace Clark Pearson. His 24 year history with the district includes teaching social studies in various phases at the high school level. Last year, Soerens taught sophomore U.S. History, and A.P. History - a college level course he developed for the curriculum two years ago.

Hired for the 1973-74 teaching year, by then high school principal Clark Pearson, Soerens replaced Mike Williams, who went to serve as superintendent for another school district. He received his bachelors' degree from UW-Whitewater, and a master's from UW-Milwaukee.

His coaching achievements are well worth mentioning. Soerens coached football for eight years, and girls' basketball for 18 years, leading them to the state tournament in 1982.

"Although I'm principal of

the middle school, I still consider myself a teacher," Soerens stated after the meeting. "I am going to miss teaching and the contact with students in a classroom setting. I'm hoping my experience as a teacher will be valuable in helping other teachers become better educators. I am also very happy to be starting my second career in the Kewaskum school district."

A native of Cedar Grove, Ken resides there with his wife Donna, and daughters, Holly a sophomore in high school, and Jenny, a seventh grader.

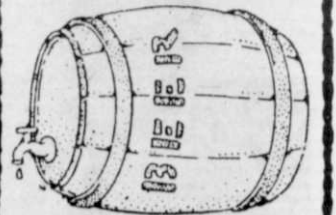
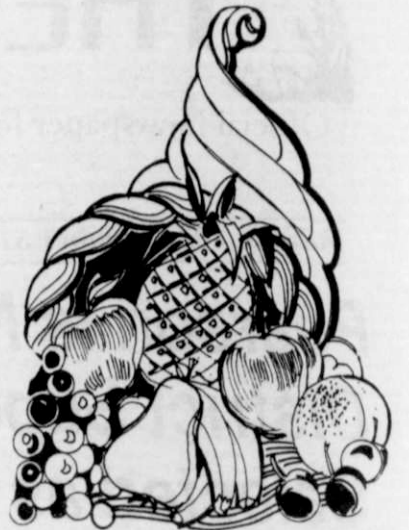

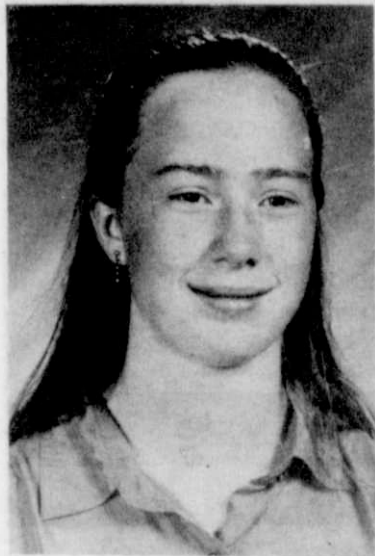

The Wild Adventures of Jill in the Netherlands

My mom said you would want to know what I have been doing, well, now I finally have the time to write you a letter. My name is Jill Pamperin and I should be a junior at Kewaskum High School. Well, right now I am in the Netherlands on a foreign exchange for a year with the Rotary. It is the greatest experience of my life!

I arrived in this country on July 31st and met my host parents who I have lived with for the first four months. Since I live in the northeast corner of the country, it was a long drive home. I then stayed there a week before going to a two week language camp. At the camp I learned a lot of Dutch so I could start to talk more to the people. Communication isn't such a problem - the Netherlands is such a small country that everyone speaks English and about half can speak French and German also.

That was four months ago, since then I began school, and we just finished the first grading period. The school here is leveled according to ability and I am in the middle level, the class before graduating year. I do my best in school and try the homework. The classes I am taking are the easiest -- U.S. geography, math, English, German, 2-D art, 3-D art/shop and two times

a day, Dutch. I also take the required classes of gym, religion and current events. My classes are taught in Dutch. My written Dutch isn't too good yet, so it is hard at test time. I managed to pass half of my classes and I did better than some of the Dutch students - that made me happy.

When school is done, I bike home. Everybody here owns a bike, the national average is 1.3 bikes per person. Because the country is flat, it isn't very hard to bike, but it is getting cold now. The wind always blows cold because I live one mile from the sea. I feel sorry for the kids that must bike one hour to school. When I get home it is tea time- you can never skip tea time- it is a ritual. We sit around and drink tea for half an hour. Then I try to do my homework.

Two nights a week I play in bands. One is an orchestra, the other a farmer band. The farmer band plays "folk music" and the uniform is the old farmer clothes. This means wooden shoes (klompen) so I had to buy some nice yellow ones. Also, one night a week I take ballroom dancing. It is a normal thing to do here. My brothers must get their diploma or my parents won't let them get a driver's license. There we learn to dance, now we are learning The Tango. I find it fun- but my brother who is my partner isn't so excited.

Here I live in a big family, my parents, my brothers Joost (17), Gijsbert (15) and my sister, Machteld (13). My dad is the mayor of the town- a profession here- you have to go to college for it and get hired by the Queen. (Yes, Holland has a royal family with a queen as a ruler.) Mom is a housewife and belongs to lots of societies. I live in a very old house, over 250 years old. It is one with 12 foot ceilings, 8 foot windows, servant's quarters and just overall huge!

I live in the corner of the country in the town of Delfzijl. It is slightly bigger than West Bend and I live a 15 minute

bike ride from the center. All the area around is farms- dairy and sheep farms. Some grow sugar beets and other crops, but mostly you see the black and white cows. The differences between this and the area around Kewaskum is that the farms are smaller here and there is a larger town every 10 miles and small villages every 2 miles. To show you how small the country is- going 100 kph (60 mph) it takes only four hours to cross the country in the longest direction.

The food here is good- they eat chocolate for breakfast. You spread butter on your bread and then put on chocolate sprinkles, spread or shavings. Other than that the food is normal- well, they eat tons of potatoes. We eat boiled potatoes every night! They do eat eel here, but I haven't had that yet.

For me the language isn't too difficult- I can talk pretty well after four months, my words are just in the wrong order. I always forget to put all the verbs at the end. The writing isn't so good though. If you can believe it, it is even more illogical than English. Letters disappear, reappear, and double by their own will all the time. So you can spell the same word many different ways. It is a good thing I don't have to write any term papers, but learning Dutch spelling makes my English spelling worse!

Soon I will be moving to another family. I have three families during my stay. I will be a bit sad, they have no kids at home, so it will be a bit lonely. But they do have a lot of pets and live far away from the school so it will be a long ride to school every day

this winter. I will stay at the same school, so I won't have to make new friends. The people- kids especially- are so friendly it isn't a problem. They always help me with my Dutch by correcting my many mistakes and they don't speak English to me so I learn the Dutch faster.

Already I have done some traveling in the country. I also went to Poland for a week on an exchange program with the school. It is a whole different place there- a bit dismal and gray. Everyone is so somber there- you have to go there and experience it for yourself to know what I mean. The girl I stayed with there will come back and stay with me for a week in spring. I have also been to Germany a few times, including to Berlin for a day. I haven't been to Amsterdam, but I am arranging a trip now.

The styles are a bit different here- everyone has skin tight clothes. The guys also wear turtleneck sweaters and scarves. Everyone outside- not only the girls but guys too. The most popular music is "house music" which means all you can hear is two beating bass drums. The rest is

drowned out. It was supposed to have originated from Chicago.

Some drugs are legal here- soft drugs, mostly. I am not sure all the drugs that includes, but marijuana is one. People here really don't use them, because they have tried and thought it was stupid. I haven't seen anyone stoned yet. (I don't really want to.)

That is about all for "The Adventures of Jill in Swamp Country" except for telling you it is always cold, rainy and windy! Murphy's Law in the Netherlands says that it always starts raining when you get on your bike and that the wind is always against you! Until next time!

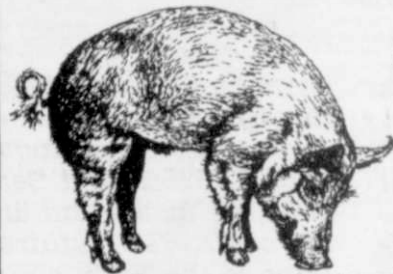

A Stroll Up Main Street



Moving west on this week's "Stroll Up Main Street" next to the Kewaskum Statesman at 203 Main Street is now the Hollywood Portrait Studio (shown in bottom photo). The building was previously owned and occupied for over 50

years by the Frank Felix family. Mr. Felix ran a Gamble Store and Radio and TV Sales and Service. The family had living quarters upstairs. Prior to the Felix occupancy, the building was owned by William and Lena Ziegler. Mr. Ziegler

operated a tavern and his wife Lena a boarding house. During prohibition, Mr. Ziegler did not sell any intoxicating liquor, only soft drinks and snacks. Children from Holy Trinity School would cross the street at recess and buy penny snacks. Before that the upper story was used as a dance hall. Kaspar Puppet Shows were also held there in the German language. When Mr. Felix passed away, his wife, Helen sold the building to Gary Gavin. He completely remodeled the building, inside and outside. In July of 1995, The Toning Shoppe moved in the building and ran a fitness center there for over two years.

Following in the Glaciers' Footsteps

Before the snow flew, fourth graders from Farmington Elementary took a field trip through the Northern Kettle Moraine State Forest to view and discuss glacial formations they had learned about in class.

The entire tour was approximately 50 miles, with walks up Dundee Mountain and Parnell Tower, providing great views of the surrounding ridges and kames. The groups made stops along the way, including the Ice Age Center, Long Lake, and Butler Lake Trail.

At the Ice Age Center, naturalist Roger Reif talked, then showed the classes a short film on glaciers.

Lunch was eaten at Long Lake after an invigorating climb up Dundee Mountain (which is really a kame). Along the way, however, students took some, umm, interesting detours before finding the right trail (which certainly added to the adventure...).

The students also enjoyed the Butler Lake Trail, which follows along the Parnell Esker. The ridge ranges from five to 35 feet in height and was deposited by a stream in an open

channel or tunnel beneath the Lake Michigan glacier.

With each different trail and formation, students learned a little bit more about the glaciers that covered Wisconsin so many years ago.

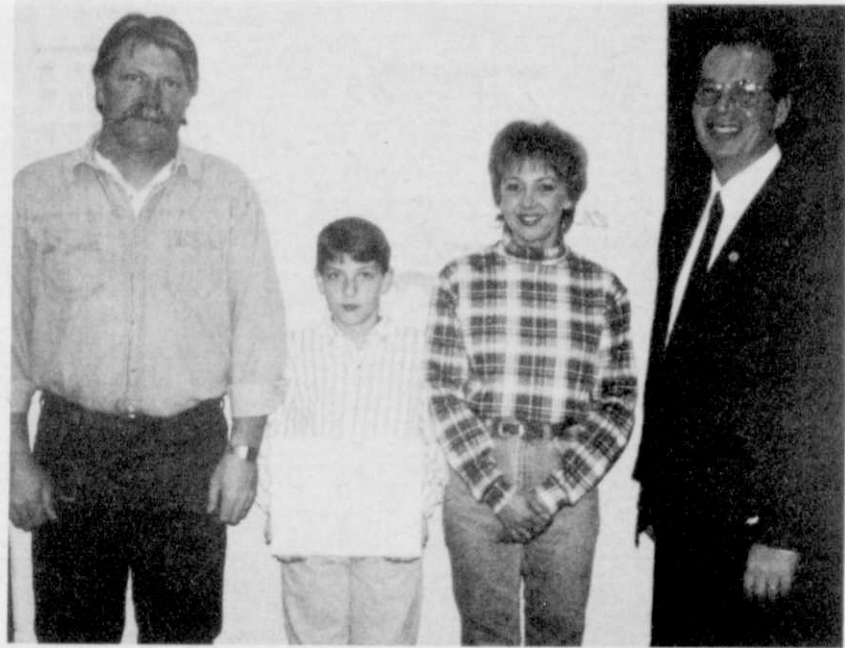

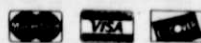

1 cup (2 sticks) butter, room temperature
 1/2 cup sugar
 1/2 teaspoon salt
 1 large egg yolk
 2 1/4 cups all-purpose flour
 Colored decorating sugar or other holiday toppings
 Cream butter, sugar, salt and egg yolk with an electric mixer until smooth. Gradually beat in flour. Wrap dough in plastic wrap; refrigerate 1 hour or up to 2 days. During this time, the flavors blend and develop, bringing out the buttery flavor of the dough.
 Preheat oven to 350 degrees. Roll out dough on lightly-floured surface to 1/8-inch thickness. Cut into desired shapes using holiday cookie cutters. Place on lightly-greased cookie sheets. Sprinkle with decorating sugar or other toppings. Bake for 12 to 15 minutes. Makes 3 1/2 dozen cookies.

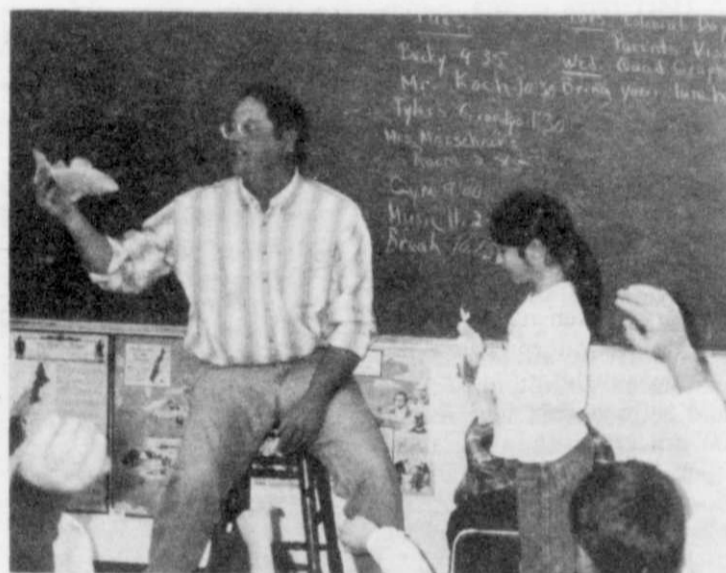

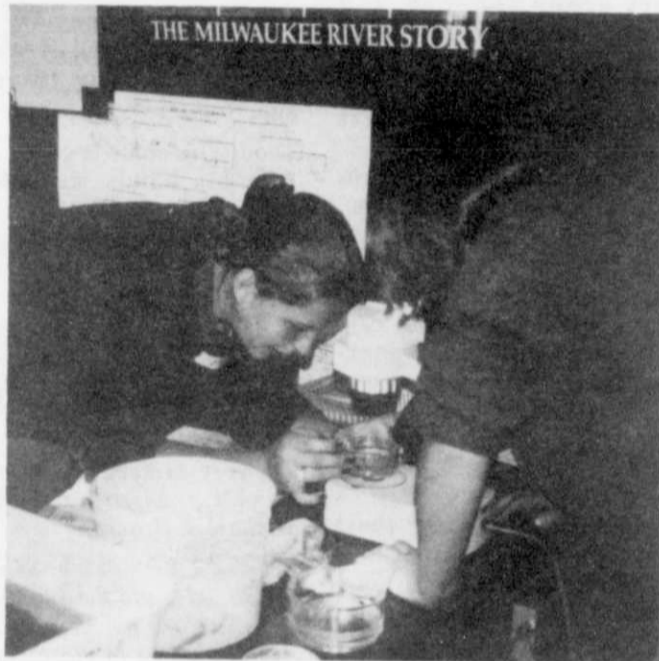

WINTER PARKING

The Winter Parking Restrictions and Snow Emergency Parking Restrictions go into effect at mid-night (12:00 a.m.) on December 1, 1997.

Municipal Code Section 7.04(3) Night Parking Restrictions, reads as follows: Signs have been erected at or reasonably near the corporate limits as provided in Section 349.13, Wisconsin Statutes, no person excepting physicians or licensed emergency vehicles on emergency calls, shall park or stop any vehicle on any public street or highway within the village between the hours of 2:00 A.M. and 6:00 A.M. from December 1, to April 1, of each year; provided that, notwithstanding such restrictions vehicles may be parked a period of time not longer than 3 minutes for actually loading or unloading of passengers, and provided further that no other regulation restricting parking as to place, time, or manner violated thereby.

The fine for violating the ordinance is:

\$5.00 if paid within three (3) days of the issuance of the parking citation.

\$10.00 if paid after ten (10) days but before 28 days.

After 28 days, the amount is \$25.00 and a notice will be sent to the Motor Vehicle Department to suspend your vehicle registrations and refuse renewals until the citation is satisfied.

An important fact is the owner of the vehicle is responsible for the payment of the citation whether or not he or she was the operator.

Municipal Code Section 7.04 (4) Removal of Illegally Parked Vehicles. This section covers the issuance of citations to and possible removal of such vehicles in violation of this ordinance. In addition to other penalties provided by Section 7.04(6) of this code, the owner or operator of a vehicle so removed shall pay the cost of the towing and storage.

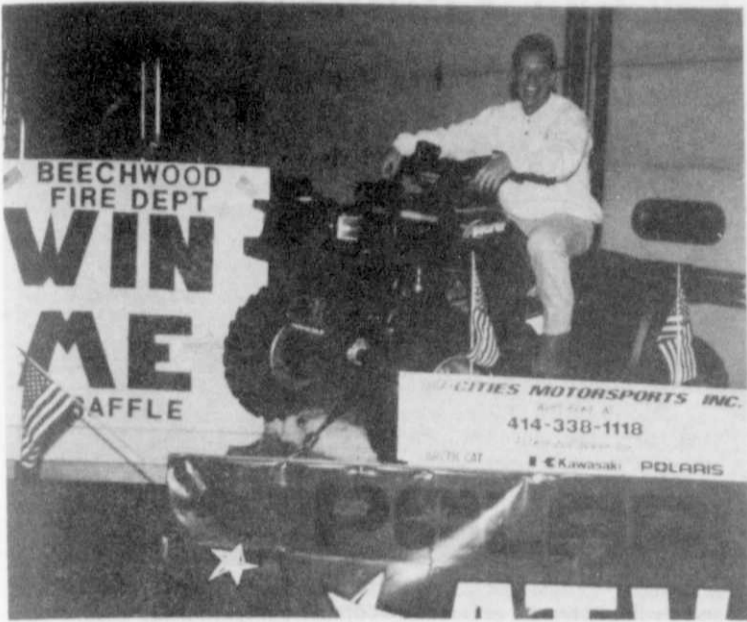

announced that the King and Queen from 30 years ago were both present and would they please join and dance with the 1993 King and Queen. I was totally taken by surprise and pleased beyond words! Then to open the *Statesman* a week or two later to see the picture you published added the finishing touch to a terrific weekend. The only part I didn't like was that the cheerleaders at the game (and spectators) were not active and really into it as we were back in the 60's. We used to have the field or gym really vibrating and rocking with enthusiasm. Especially when we did, "We're from Kewaskum and we couldn't be prouder. If ya can't hear us now, we'll yell a little louder!" And we did! I was really looking forward to singing our school song with the voices of current and past students. But I was almost the only one singing. I then felt it my responsibility to make sure it was sung, so I really belted it out -- and made my dad, always the good sport, sing with me! What happened to school spirit?! If some event ever needs an old cheerleader who still has it, let me know!!

When your stroll on Main Street gets to the site of your sister and brother-in-law's office (Henry Timblin Trucking), don't forget that the tavern/building was run by someone named Wink sometime in the 50's (or late 40's?). My grandparents always referred to it as Wink's Corner. And when you get to the former site of the depot, try to include a "jab" at whoever it was who decided to tear it down. I loved that building! As Postmaster, one of my grandpa's responsibilities was to go to the depot each day to collect a big pouch which had some of the day's mail in it. As one of the trains went through town

and slowed way down, someone on the train hooked the pouch on some device alongside the tracks. My grandpa would go to retrieve it. Also, I distinctly recall Fred Schlieff picking up mail pouches and parcels at the depot, loading them on this big old wagon with a long handle (like a great big flat coaster wagon), and pulling it down Main Street to the Post Office. The wagon had really big wheels, which had no rubber on them. One of Fred and Elsie Schlieff's daughters, Elaine, goes to my church here in Menomonee Falls and she and her husband remember it too. I think I have a picture of Fred and the wagon somewhere... but where? I have so many pictures to sort through and so little time to do it. The last train at night went through town at 10 p.m. heading north. With

my grandma's sister, Erna, living in Milwaukee then, my grandparents and I were on that train so frequently that they knew the conductors and they knew us by name. One conductor used to always buy me a Baby Ruth candy bar in the West Bend Depot when we went into Milwaukee on the early train. I can also remember the excitement when a "streamliner" went through town in the 50's. Mighty cool train! Orange and white, if I remember correctly.

Well, I certainly did ramble on here. But Kewaskum and "the good old days" are favorite subjects of mine. It's hard to stop once I get going!

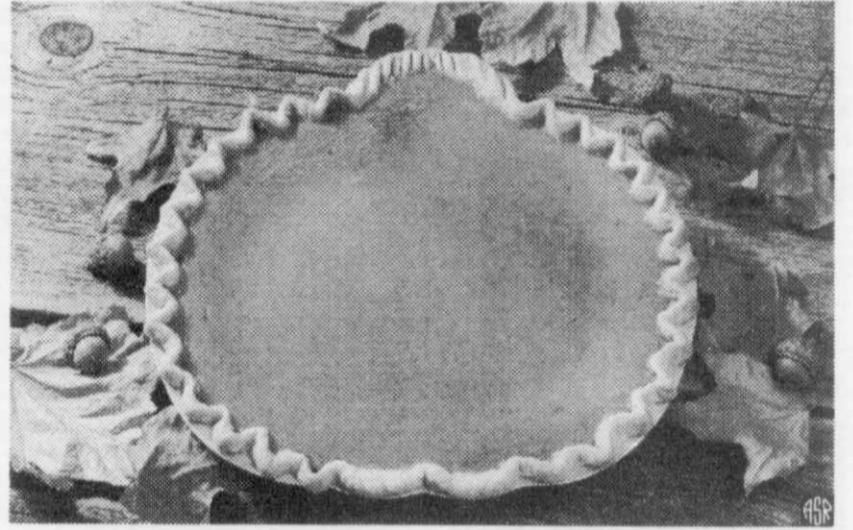

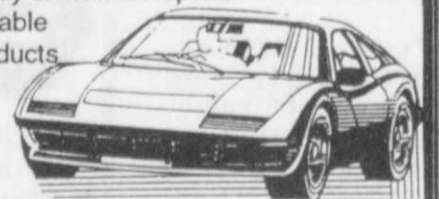

President Robert Wagner presided. All Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Andy Pesch, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote, the minutes of the October 20, 1997 meeting were approved as printed.

Assistant Fire Chief Mark Herriges was absent but, Administrator Daniel Schmidt reported that the repairs have been completed on #1864 - 1982 Ford Pumper. It was noted the estimated cost of said work is \$8,560.00. It was further noted the new tanker was in for warranty work; the paint job and the engine timing.

Chief of Police Richard L. Knoebel reported that the Value program will be using the State Bid for squad cars for 1998 and the Village would join them as usual. He also reported the School District approved the DARE Program for the Middle School and that Officer Thomas Bauer would be in charge of that.

Director of Public Works, Jerry Gilles informed the Board of the following:

1) The hydrant damaged by WEPCo has been fixed and the cost of repairs has been sent to the electric company.

2) It was noted several trees still have their leaves on them so a few more dates have been scheduled for leaf collection.

Administrator Daniel S. Schmidt reviewed the following with the Board:

1) Review of Mid-Moraine, League and Taxpayer bulletins.

2) Review of budget control sheet for the period ending September 30, 1997.

3) The new land use plan for the Village of Kewaskum was distributed to the Board Members for their review and future use.

4) The 1996 Annual Report was on file for SEWRPC for any one to review.

On a motion by Trustee Gary Gavin, seconded by Trustee Andy Pesch and unanimously carried by voice vote, the Board approved the payment of bills as recommended by the Administrative Committee. The total of all claims as recommended are as follows:

Chairman of the Administrative Committee, Trustee Robert Stoltzmann informed the Board that the committee is recommending for approval the revised smoking policy for the Municipal Building. On a motion by Harry Roecker, seconded by John Kenworthy and unanimously carried by voice vote the Board approved the "Smoking Policy" as printed. It was noted that an overall policy regarding all village buildings and vehicles be looked at.

Board Representative for the Plan Commission, Trustee Warren Dums informed the Board that the Commission has reviewed to date Sections 3 & 4 of the Zoning Ordinance and has only recommended points of clarification/language type changes. Sections 5 & 6 will be

reviewed at the next scheduled meeting of the Commission scheduled for Tuesday, December 9, 1997 at 7:00 p.m.

Board Representative on the Library Board Trustee John Kenworthy reported that the circulation for the Library has increased since summer and that we are now 700 over that of 1996.

Administrator Daniel Schmidt reviewed with the Board the CMAQ (the park & ride lot) project. The plan for said work was passed around for review and it was noted that bidding for the work will take place in February or March.

The Board reviewed two quotes to replace the existing boilers (furnaces) in the Municipal Building. The existing boilers have been creating an ongoing problem and we have having difficulty keeping them up and running. The quotes are as follows:

- 1) J.M. Brennan, Inc., Milwaukee, WI - \$14,454.00.
- 2) J.F. Ahern Co., Fond du Lac, WI - \$12,000.00.

On a motion by Trustee Gary Gavin, seconded by Trustee Warren Dums and unanimously carried by voice vote, the Board approved the low contract for boiler replacement to J.F. Ahern Co., at \$12,000.00.

On a motion by Trustee Gary Gavin, seconded by Trustee John Kenworthy and unanimously carried by voice vote the Board authorized the signing and delivery of the letter to the Department of Transportation regarding the postponement of the USH "45" project to 2003.

On a motion by Trustee Gary Gavin to sign and send a letter regarding cluster mailboxes to all parties and to prepare an ordinance to allow for the delivery of mail to individual rural type mail boxes died for lack of a second. Discussion then pursued with the focus being on the inequity or uniformity of the US Postal Service in handling cluster mailboxes. On a motion by Trustee John Kenworthy, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote the Board authorized the signing and sending of the letter regarding cluster mailboxes. On a motion by Trustee Gary Gavin and seconded by Trustee John Kenworthy and unanimously carried by voice vote, the Board directed that an ordinance be prepared to allow for the delivery of mail door to door and for the Village to promote such delivery.

On a motion by Trustee Gary Gavin, seconded by Trustee Harry Roecker and unanimously carried by voice vote the Board authorized the signing and sending of the letter of concern to the County in reference to the proposed ordinance, Chapter 17 Erosion Control and Stormwater Management for Washington County.

A brief review of the proposed Library Fund Budget for 1998 was accomplished. The Board did ask for a break down as to what a full time Library Director would cost versus maintaining the part time position.

Action was taken on Resolution No. 97-21 a resolution to Request Tax Exemption from the County-Wide Library System Tax Levy under provisions of Wisconsin Statutes 43.54(2) as attached hereto:

Preliminary budget overall review was held. It was indicated that the budget was balanced but

reflects an estimated 4.2% increase in the rate. Adjustments were reviewed both increase in revenue and decreases in expenditures. If the budget is approved as noticed for public hearing a 23c increase per \$1,000 of assessed value would be realized. (\$23.00 per a \$100,000 home).

Administrator Daniel S. Schmidt the Special Revenue Fund as proposed for 1998. There were no major fluctuations in comparison to this years.

The Water Pollution Control Department budget proposed for 1998 was reviewed with the results being an excess of revenue over expenditures. This reflects a good proposed budget, however with the anticipated relief sewer projects in 1998 additional funds will be required. Jim Fiocco of Ruekert & Mielke prepared an analysis which would indicate an estimated 6.8% increase on the sewer rates would be needed over those established in 1994. On a list of 37 utilities, Kewaskum has the 4th lowest in charges now and after the 6.8% increase we would be the 6th lowest. Follow up discussion regarding the topic will be placed on the agenda.

The Water Department budget as proposed reflects being balanced and showing a rate of return. It would not be anticipated that any rate adjustment would be needed in 1998.

Both of the utility budgets will also be heard at the general budget public hearing on November 24, 1997 at 7:00 p.m.

On a motion by Trustee Harry Roecker, seconded by Trustee Gary Gavin and unanimously carried by voice vote, the Board authorized the signing of the contract with Aquatic Biologist Inc. for the maintenance of the swim pond for 1998.

On a motion by Trustee Gary Gavin, seconded by Trustee Warren Dums and unanimously carried by voice vote, the Board authorized the signing of the contract with Bowmar Appraisal Inc. as Village Assessor for 1998 at a cost of \$4,600.

On a motion by Trustee Harry Roecker, seconded by Trustee John Kenworthy and unanimously carried by voice vote, the Board approved the snowmobile route for the 97/98 season.

On a motion by Trustee Harry Roecker, seconded by Trustee Gary Gavin and unanimously carried by voice vote, the Board adjusted the December meeting schedule to one meeting on December 8, 1997 at 8:00 p.m.

Administrator Daniel S. Schmidt informed the Board that the second ED/AC meeting is scheduled for November 18, 1997 at 4:00 p.m.

On a motion by Trustee Robert Stoltzmann seconded by Trustee Warren Dums and carried by the majority roll call vote, to adjourn. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent."

AN ORDINANCE TO AMEND THE MUNICIPAL CODE CHAPTER 8 PUBLIC WORKS

THE VILLAGE BOARD OF THE VILLAGE OF KEWASKUM DO ORDAIN AS FOLLOWS:

THE VILLAGE BOARD OF THE VILLAGE OF KEWASKUM, WISCONSIN WISH TO AMEND CHAPTER 8 - PUBLIC WORKS TO READ AND ORDAIN AS FOLLOWS:

8.13 MAILBOXES. No person shall install or erect a cluster mailbox in the Village without a permit issued by the Director of Public Works therefor. The Director of Public Works shall approve the location of such cluster mailbox before the permit shall be issued. The term "cluster mailbox" shall not be construed to mean "a cluster of mailboxes." If the permit is for other than a formal cluster mailbox unit(s) a detail drawing reflecting size, type of construction and location need to be submitted for Village Board approval, as well as any other information requested by the Village Board. No individual mailboxes shall be allowed in the Village. The existing individual mailboxes need to be maintained in a pleasing and safe manner adjacent to the specific address served by such mailbox. Only "cluster mailboxes" or approved alternatives shall be allowed in the Village.

(1) Cluster Mailbox Permit Fee. The fee for a permit for locating a cluster mailbox shall be \$10.00 payable in advance of permit being issued.

(2) An approved alternative to the aforementioned "cluster mailbox" shall be door to door delivery of mail by the US Postal Service. This delivery would be to the structure at which a residence and/or business resides.

This ordinance shall take effect upon passage and publication as provided by law.
