School District Board of Education, and three two-year trustee positions on Kewaskum's Village Board.

The upcoming Spring Election is scheduled for Tuesday, April 13, 1998.

The three-year terms of Mary Andera and John Schulte expire and both candidates have filed papers in their bid for re-election. This race will be joined by past school board member and board president Neal Weare of the Town of Auburn who has also taken out candidacy papers to vye for a seat back on the board.

We are lost the race for his fourth term this past

year to board newcomer Lisa Maul of the Town of Wayne.

In the village trustee race, incumbents Warren Dums, John Kenworthy and Robert Stoltzmann have all filed candidacy papers in their bids for re-election to the two-year terms. They will be joined by newcomer Robert Kilbourne who will also be seeking one of the three available seats on the board.

A Primary Election will not be needed locally, but it should prove interesting as each race has one more candidate than there are seats available.

Village Water, Sewer Rates Will Go Up 6.8% in 1998

Following a seemingly long holiday hiatus, the Kewaskum Village Board gathered Monday evening, January 5, for their first official 1998 meeting.

Assistant Fire Chief Mark Herriges and Police

Chief Richard Knoebel gave their reports, as did Director of Public Works Jerry Gilles. Gilles reported on the recent water main breaks at Riverview Drive and Main Street and North and Fond du Lac Avenues.

Gilles also asked for

authorization to bid for a snow plow truck to replace the 1985 model from the fleet, which has been budgeted for. He stated he was asking for authorization to bid the truck now because it's going to take us probably five to six months at least after we place the order before we get delivery."

He added, even if they would receive the chassis in June, the equipment, box and the plow would still have to be put on which would mean it could be August or September before the truck would actually be operational.

Trustee Andy Pesch asked Gilles, "Do we really need another one? That's an '85 truck. That's really not that old yet."

The Director of Public Works explained, "That truck really pushes its guts out to push the plow that's in it. It's holding up for the time being. I don't think we're going to continue to use that as a plow truck without some major expense in it. That truck works really hard to plow."

Gilles also explained to the board the possibility of installing a wing on an existing truck if they could realize a substantial savings. If the pricing comes back without saving money, the wing might as well be placed on the new truck with new warranty, etc.

He added, "As you know our plow routes have been becoming longer and I think a wing will help us keep up on our plow time and also is going to save us money in the fact that I feel that '85 is not going to stand it for a real long time."

The board unanimously

approved the authorization to bid the plow and also agreed to continue the Village Spring Cleanup Day, setting the date for Saturday, April 18, from 9 a.m. to 1 p.m.

Gilles concluded his report adding Christmas trees have been picked up and will continue to be picked up for the next two upcoming Mondays in January, as noticed in this issue of the Statesman.

During his report, Village Administrator Daniel Schmidt announced Congressman Jim Sensenbrenner will be holding office hours at the Village Municipal Building on Thursday, January 15, at 1:45 p.m., and the Village Economic Development Advisory Committee will be meeting Thursday, January 8 at 4 p.m. to review the survey they have been working on and plan to send out shortly.

Under Unfinished Business, following intense mail delivery discussion at previous meetings, Schmidt reported he had talked to current Postmaster Dennis Sullivan. Both the Village and the Post Office had been in contact with Senator Herb Kohl's office who reiterated door to door delivery that the village had requested has been discontinued since 1984 and would not be granted.

Schmidt added in reference to cluster boxes, the Post Office has stated the boxes are "being paid for by the developer."

Regarding maintenance on the cluster boxes the post office basically has agreed to take care of the keys and "as far as the maintenance they say there really isn't any maintenance to be done except painting which could be 15

years down the road as it has been in the past. Some postmasters say they automatically just take care of it, some people say the person that has the box in front of their house goes out and paints it. Another place they'll say the post office will do it and they will charge back. That's the prerogative of whoever is postmaster at the time."

Schmidt added the post office will not make a commitment or put anything more in writing at this time, but would recommend that, "seeing we do have it in the developer's agreement, that the developer put the cluster boxes in, and the current postmaster has said all we have to do is have the developer take the keys and they will take care of it."

According to Schmidt, the post office has stated, "The problem should not even exist." Schmidt added the post office recommends, "Have the boxes installed. The Village sort of withdraw from the issue and once the box is in, it's actually between the property owners and the post office. The village is outside of it the same as if it would be a rural box versus the post office. The township or the village would not be involved in the process."

The board agreed with that reasoning and passed a motion to that effect.

Under new business the board adopted a resolution to establish a 6.8% increase in sewer rate structuring to take effect for the first quarter of 1998. Schmidt explained, "the current charge is \$2.28 per thousand and the proposed is \$2.65 per thousand. On a 60,000 gallon average for the residential user, that would come out at \$11.98 per year, \$3 a quarter, or a

dollar a month. This proposal is to pay for the roughly \$550,000 two relief sewer projects that we have proposed for later this year in 1998." Schmidt stated the last adjustment was made in 1994.

In other New Business the board also passed Resolution No. 98-2 Declaring Intent to Exercise Special Assessment Police Powers in regards to installation of the street improvement

work for the old Fond du Lac Road area. Once bids are secured, a public hearing will be held on this issue in the future.

Under Miscellaneous Business, Director of Public Works brought up that Village employee Brad Rodenkirch had resigned his position with the village and Gilles asked for permission to advertise for his replacement which was given by the board.

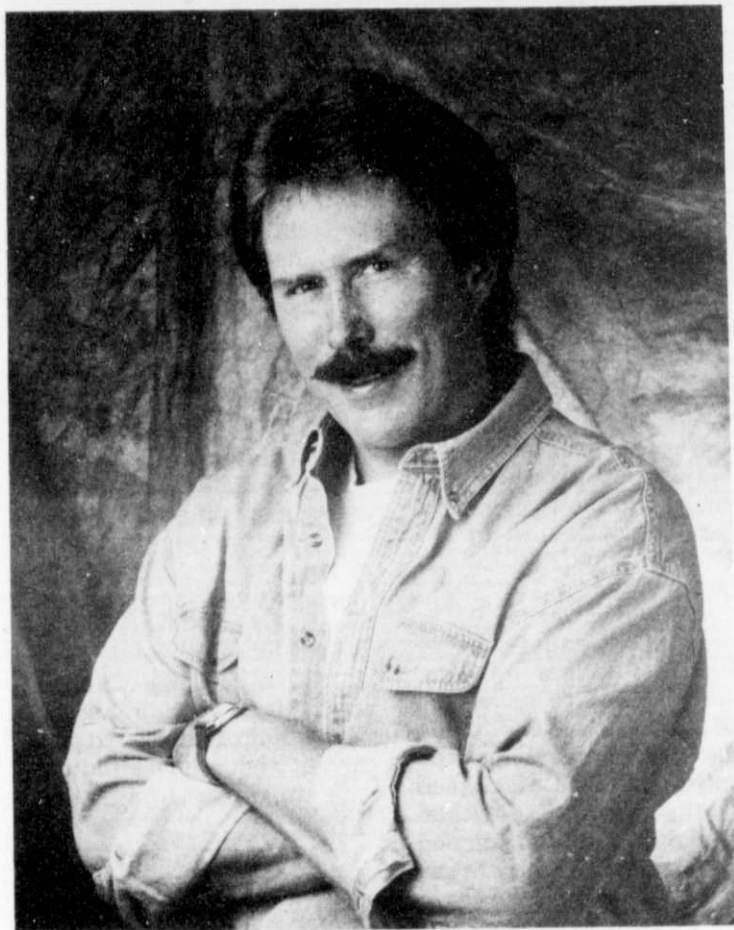

A Stroll Up Main Street



Returning to our weekly "Stroll Up Main Street" heading west, we have come to the business that now houses Jaeger Sewing Machine and Vacuum Center. The stalwart brick building that has undergone some remodeling and fresh coats of paint has a long history in the Kewaskum community. Peter Wunderle began a meat market on the premises in 1879 which was taken over by John W. Stellpflug, who operated the same from 1913 until his death in 1947. John G. Stellpflug took over on January 1, 1948 and he owned and operated the business until it was sold to Glen Remmel who also operated the business as a butcher shop. Remmel sold his operation to Byron Bunkelmann, who in turn changed the business to floor covering and operated the same until it was sold to Robert Puerling and Ken Leitheiser. Puerling and Leitheiser operated as a floor covering and carpeting business and erected the large storage building that now exists behind the original building. If anyone has historic information or a fond memory to contribute about the upcoming businesses on Railroad Street or the north side of Main Street, please send the information to the Kewaskum Statesman or call 626-2626. Please keep in mind, if any of the information is not 100% accurate, we use the information that is submitted to us, but other tidbits come from the mind of a person who does not have a whole lot of recall before the year 1957 (namely this writer) and who was paying attention to buildings at that time?? We made five phone calls trying to verify the above information, and received four answering machines and one clarification. So any assistance you can give this memory, growing more feeble every week, would be greatly appreciated. TO THE CITIZENS OF THE KEWASKUM SCHOOL DISTRICT:

The members of the Kewaskum School Board and Facilities Committee wish to invite EVERYONE from the District to the Public Open House at the Kewaskum Elementary School on Wednesday, January 14, from 6 p.m. to 9 p.m. We will run tours throughout the evening for your convenience. There will be members of the committee available to discuss the various options under consideration. Coffee and cookies will be served.

This is the perfect time to learn about the information the Board and committee have been working on for the last year and a half. Now is the time to have all your questions answered and your ideas explored by the committee members. We would like to have some input from you. This is your

chance to discuss some questions you may have about any of the plans.

Due to a miscommunication on my part with the Kewaskum Statesman, you will have two opportunities to give some input. The Kewaskum Statesman had the date for this open house on January 7, 1998. We had to change the date to Wednesday, January 14th because we needed to review and prepare the proper information for the evening. We also wanted to make sure the parents were informed about the meeting so they could learn more

about what is happening in the school district. So by the time you read this, we will have had one of the meetings (January 7th) and I hope we had a good turnout. Coffee and cookies are always good when having a discussion.

I would like to commend the committee members for the long and tedious hours they spent gathering information and trying to find a solution to the upcoming overcrowding and the updating of our schools. It was not an easy task.

I would especially like to thank Mr. Lloyd Koch.

He didn't just sit back, read the articles in the paper or listen to gossip. He joined the committee and learned the facts about the many options facing the Board. The Kewaskum School Board wishes there would be more Lloyd Kochs in our district; people who take the time to learn the facts. By giving us your input, you can have an effect on the process before any referendum is set.

Of course, we all think we have the answer, but when it comes to the cost or what is best for the District in the years to come, the answer isn't that simple.

Before I give an overview of the plans and ideas already considered by the Board or committee, I would just like to write a few notes on the Reigle/Ogi land. The option is dead and the Board no longer has any commitment to purchase the land. However, during one of our workshops, the land issue was discussed and the majority of the committee and Board agreed that the ideal situation would be to find land without any marshy lowland like the 12 acres on the Reigle and Ogi property. It was also agreed that because this is the Kettle Moraine, it would be difficult to find 40-80 acres of ALL high land. This is important for you to understand. The Board is taking into account all these considerations and will decide what is in the best interest of the District and make the best use of the monies.

I feel that the 12 acres would be the "largest classroom" in our school district. The shop classes could build the bridges and birdhouses, the Ag classes could learn about the various animals that live in that habitation, the science and biology classes could do some experiments right in our own backyard, and the elementary classes could take their annual hiking trip just outside of Kewaskum instead of traveling to West Bend or Newburg. The list of learning possibilities and useage of "low land" and the benefits for the school district could go on and on. So you see, I'm sure there are so many ideas out there that we haven't even heard.

Now is the time to express your opinion. Come and take a tour of the KES and look at the problems facing the District and the Board. Be a Lloyd Koch..... look at the facts.

Here is an overview of

the options the Board and committee have already considered.

1. Kindergarten through sixth grade:
- new KES on present land or new land
- add on to all the outlying schools to accommodate the sixth graders and future growth.

2. Kindergarten through fifth grade:
- new KES on present land/new land
- add on to all the outlying schools to accommodate the growth.

- add on to the middle school for the future growth.

3. Kindergarten through fourth grade:
- the outlying schools would be K-4

- minimal construction to outlying schools

- relocate grades five, six, seven and eight in current high school building.

- Administrative staff in current high school building
- build a new high school.

All the ideas above could add classrooms/gym/media center/auditorium between the Middle School and High School. All the options above could mean reopening Beechwood School through a recurring referendum. The committee strongly recommends an energy audit of all the buildings and update the facilities to accommodate that audit.

The following issues were considered by the committee:


- safety of KES students
- location of possible new KES - present site or outside of village

- if new KES is built, what would become of old KES.... use for special student classes, administrative offices, in-house day care. Other options and considerations were discussed.

Now we need your ideas. The Board is open to suggestions. We hope to take every idea under consideration before making a decision and preparing a referendum. We want to answer your questions now, and not have letters to the editors a week before the vote questioning our decision.

Second Free Clinic To Open in Hartford

What began as a dream of retired physician James Albrecht became a much needed reality in October of 1996, when Donated Health Care Services, Inc. opened its doors as the first free clinic in Washington County, through the dedication of numerous volunteers determined to build a foundation that would support growth.

Now, just one year later, the clinic is expanding its operations to include facilities at Hartford Memorial Hospital, slated to open sometime this year.

Donated Health Care Services Inc. offers low income people free medical care and referrals to doctors and dentists for free or reduced cost health care.

The clinic is open every Thursday evening from 6 to 9 p.m. in quality space provided by St. Joseph's Community Hospital. Two or three social workers are present each clinic evening to screen for financial eligibility and provide counseling. Usually one Physicians, or Nurse Practitioner, two or three nurses and two or three other helpers, all working "for free," are present to serve the people who register on a "first come first served basis" a half hour or more before volunteer professionals start at 6:00 p.m.

St. Joseph's Community Hospital, the clinics partner from the start of this venture of Faith, has provided without charge thousands of dollars worth of services. The services they provided as "Charity" have included 31 X-rays, 5 EKGs and 80 laboratory procedures. The Physician Specialists providing professional help in the Laboratory and X-Ray Departments also do their part free of charge.

While most patients live in West Bend, many come from other areas of the county, as well as from adjoining areas of Ozaukee and Dodge counties. Except for Thanksgiving, the day after Christmas, and the stormy night of Jan. 16th, 1997, the clinic has been open every week.

The variety of problems is amazing. Some have been present for months or years. Several patients have been referred to physicians who accept the vouchers with agreed upon reduced rates. Local Pharmacists have been cooperative in accepting the vouchers for medications at substantial discounts.

There were two vouchers from dentists to whom the clinic referred patients with serious dental problems marked "no charge" for services worth more than \$200.00 each. One dentist did \$425.00 worth of work and returned the referral voucher marked "no charge." Two patients referred for cancer workup received appropriate study and treatment by the hospital, surgeon and oncologist as a courtesy!

The physician volunteer on duty one night, when told that the patient he was seeing was close to the \$250.00 maximum they are currently forced to

limit each patient in a year, told that person who will require at least \$600.00 worth of care this year to come to his office at no charge: Another physician, working another night requested, the first patient to require an E.K.G. (to confirm an atrial fibrillation) to come to his office for follow up care at a reduced fee.

While volunteers work in the clinic without compensation, costs may total as much as \$200,000 each year.

Donated Health Care Services Inc. needs all the help they can get to continue to accomplish objectives of providing adequate care of the people they are called to serve without charge.

Dr. Albrecht praises supporters for their display of generosity. "We have been blessed in Washington County with many generous people with a sense of responsibility as well as the ability to help meet the needs of those less fortunate. The United Way exceeded their goal last fall despite the same people also providing over half of our goal for a year at the time of their drive.

Mindful of our position of substantial costs and no income, as well as the needs of the community, some companies, foundations, trusts, and individuals have spread their donations over three years. Thus far the high commitment by one company is \$7,500 yearly for three years. Another company has committed \$15,000 over three years. One Foundation has committed \$15,000 over three years and another Foundation \$15,000 over two years.

Churches have given as much as \$2,000. One church will give us a specified amount quarterly. Another church contributed \$500.00 of their Advent offering. Aid Association for Lutherans matched funds with proceeds from a Pizza sale sponsored by St. Luke Lutheran Church of Slinger for our benefit for a total of \$600.00.

Both Aid Association for Lutherans and Lutheran Brotherhood are expecting other churches to join them in arranging Fund Raising events for DONATED HEALTH CARE SERVICES, INC. Fraternal and other community organizations have been and are continuing to be supportive.

Individuals of all professions, occupations and economic means have supported us with prayer, well wishes and contributions sometimes beyond what one would expect. Contributions of sample medications provided to physicians by "Drug Reps", in turn given to us, reduce our charges by pharmacists.

In the past year children of two Parochial schools who have contributed over \$500.00 give us reason to have hopes for the future of benevolence in years to come.

Last, but not least, we must commend the people without whose contributions of talents

and time we would be unable to continue. We also are grateful to the many yet on our reserve list who have offered their services.

The 800 patients cared for since October 17, 1996 could not have been seen without the presence of the six clerical helpers who have volunteered. (Two or three each night), five Social Service workers, 14 Registered Nurses, Nurse Practitioners and one Physician's Assistant.

We are grateful to the ten physicians who have staffed the clinic, some as many as three or four times as well as to our Medical Director, Dr. Listwan. Without a Medical Director we could not operate.

While our needs are great, we are confident that with God nothing is impossible. We look forward with confidence that with His guidance we will achieve His purpose. We ask for your prayers and innovative support and thank you for anything you may be able to do."

The clinic is still in need of about 15 more doctors to free up the schedules of physicians already volunteering their time and talents, and to help open the second clinic in Hartford.

Sheriff Urges Safe Winter Driving Habits

On behalf of the Washington County Highway Department and Ken Pesch, Highway Commissioner, and the Washington County Sheriff's Department, we would like to remind drivers that with the winter driving conditions upon us, it is important to remember certain safe driving habits.

Slow down and be aware of constantly changing road conditions as you travel throughout the highway systems. Be aware of overpasses and shaded areas being slippery even though most roads are in good driving condition. Drive defensively and remember that a person on another road may not be able to stop due to road conditions. When you come upon an accident or other traffic concern, make sure you slow down and travel cautiously through the affected area.

Remember that when you see a snowplow, in order for them to clear the road, they have to stay to the center line of the road. If you are meeting them, stay to the right; if you are behind them, the safest is to follow them until you get to an area where you can safely pass or until you get to your destination. Snowplow drivers cannot see directly behind the vehicle and it is very important that when following a snowplow you stay at a safe distance behind, as the driver of that plow can be blinded by snow and also may have to stop or back up at intersections in order to clear the snow away.

Lastly, when winter driving, leave early so that you do not have to rush to your destination. Have a safe winter driving season.

Area Counties Receive Funds For Snowmobile Projects

MILWAUKEE -- Gov. Tommy G. Thompson has announced that 18 counties in the Department of Natural Resources Southeastern Region will receive grants from the snowmobile program totaling \$201,500.



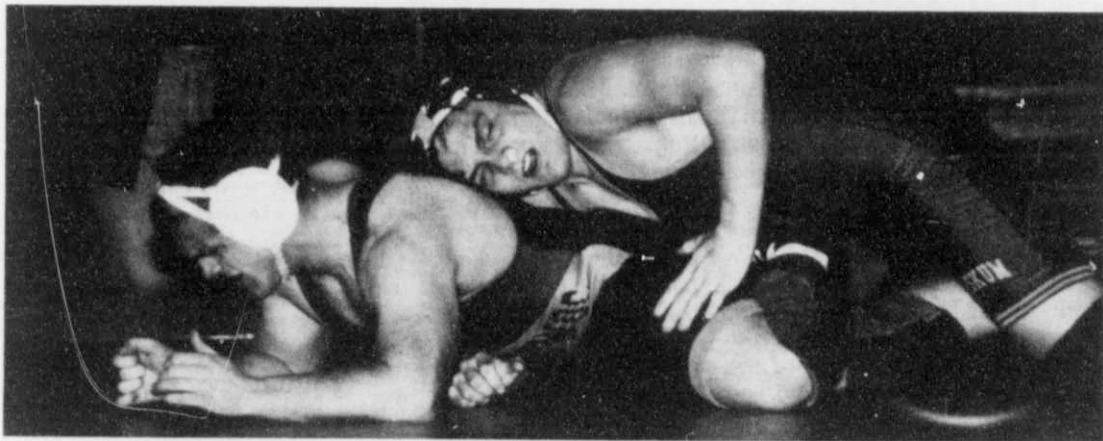

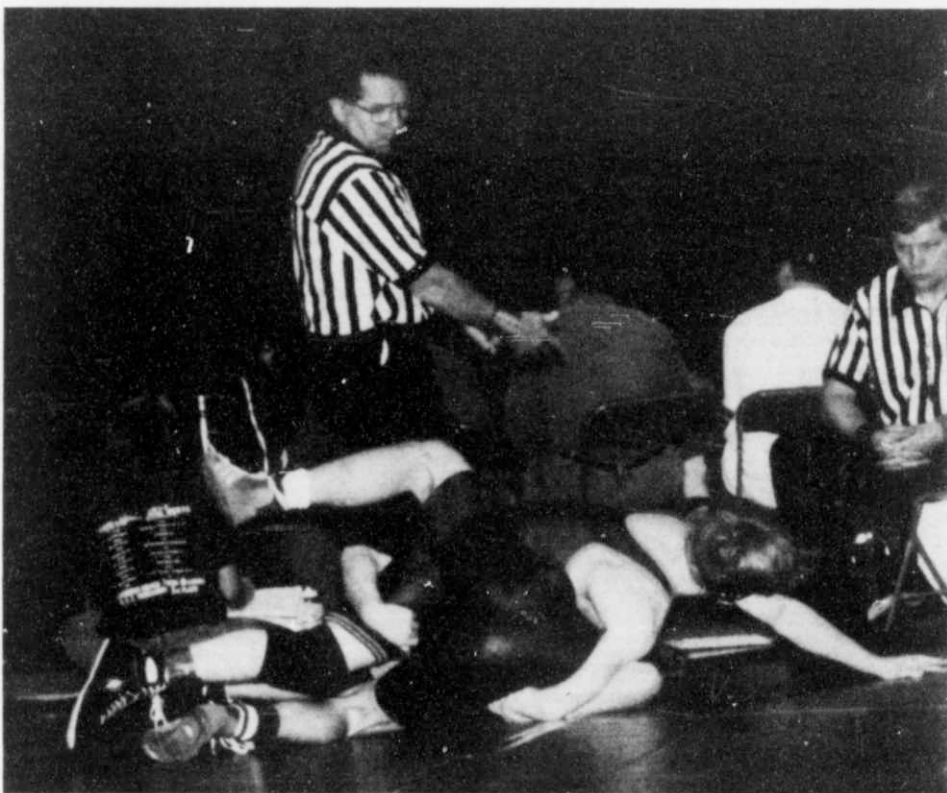
Coach says: Tourney "Went as expected"
