Beechwood School to Remain Closed

A packed KHS Commons listened silently as school board members voted against reopening Beechwood School, and in a second motion reaffirmed their position of not sending it to the voters on a referendum, with a definitive 4-3 vote.

Monday night's lengthy meeting gave community residents and board members a chance to speak out

on both sides of the emotional issue. "We're back to square one," board member Larry Fechter commented after the votes, referring to over two years of facility planning and recommendations from both administration and study committees to reopen Beechwood.

Holding firm to the opposite view, Mary Andera said that this would finally put the focus back onto Kewaskum Elementary

School. "The one thing everybody agreed on in every committee is that we needed a new KES," she related. "The timing isn't right for Beechwood."

Previous to the Beechwood discussion and action, the board voted 6-1 to approve building the new proposed Kewaskum Elementary School on the same site, despite objections from John Schulte.

"This was based on the

public not approving a land purchase," he pointed out, and cited increasing congestion around village schools as his main concern. "I don't want that responsibility. It could be disastrous to some child sooner or later."

Members of the audience were quiet, yet apprehensive as they awaited the next decision, that being the fate of Beechwood School. Only a handful of district residents spoke to the board, many having already said how they felt at earlier meetings, or through letters to the editor published in local newspapers.

"Several weeks ago you chose not to allow the taxpayers to make this important decision," Beechwood proponent Sharon Zolp told the board. "As you make your decision tonight let's do what's best for the education of our children, not your own personal agenda."

Two parents, already content with their children's education at Farmington Elementary said they had come to the meeting because of flyers they found in

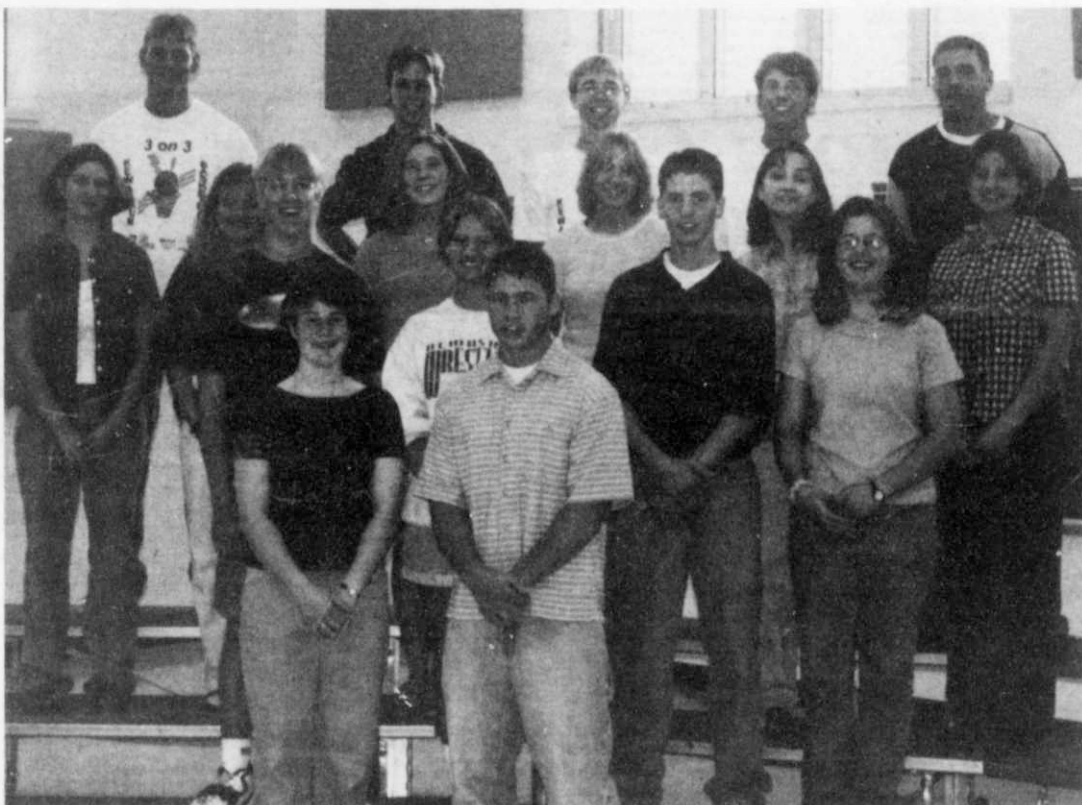
their mailboxes, addressing the Beechwood issue. "I don't feel the Kewaskum School District has funds to support the opening of another school or the need," Charity Becker stated. "My children could be flip-flopped between Beechwood and Farmington to fill class sizes."

Schulte, Downs, and Fechter all expressed their surprise at the sudden turn of events during last month's meeting when the vote to approve a referendum failed. A board consensus, taken at a previous work-session, had supported a referendum and its approval, set for the April agenda. At the Monday night meeting, the three members asked repeatedly for one of the four other board members to make a new motion that would allow another vote on the referendum question. Only the four who voted in the majority could make the motion calling for a revote.

In a 6-1 vote, with Schulte voting yes, the

Love of Gardening and Life Keeps Frank Sell Young

At age 94, Frank Sell has seen plenty of seedling trees grow to tall heights. He's seen countries taken over by other countries. He's stood in bread lines that stretched, from say, Bonnie Lane to the Village Hall in Kewaskum. He dug by hand the root cellar underneath the shed in the backyard. And every day throughout the summer, he tends to the flowers that mark his life like pages of history.

Tall and sure-footed, he walks through his terraced rock and flower garden, descending uneven stone steps as he points out tulips, daffodils, narcissus and creeping phlox. He built the rock wall to hold back the steep slope of ground in 1966. The year before, Frank planted all the pine and spruce in the lot behind his house, now a small forest of mature trees. "I've been busy ever since we moved out here," he asserts.

Born in Pomerania, Germany, located along the coast of the Baltic Sea which is now a part of Poland, Frank spent his boyhood exploring the forest and its vast array of plant life. "From little on, I love being in the woods, I couldn't stay away," he recalls.

On January 3, 1924, he first set foot on American soil. "There was no work in Europe after World War I. The bread lines were so long. I worked on a farm, but I couldn't see spending the rest of my life doing that." He first stayed with relatives in Kewaunee and

helped them out on their farm, but he had his dreams and "different ideas," and went to Wausau, where his first real wages in the states paid 29 1/2c an hour.

A turning point in his life occurred in 1925 when he and a friend took a trip to Milwaukee. He liked it, decided to stay, and landed a job at A.O. Smith where he worked for 39 years as a maintenance welder. Frank married his wife Else in September, 1928, on her birthday. They were married 63 years, until she passed away in 1991.

The Sells had originally planned to retire in Rhineland, but they moved to Kewaskum to be near their daughter, JoAnn Diewock. Her husband Erik was the first manager of Sunburst Ski Hill. "Then they moved to Colorado where there was more skiing. Erik managed a big resort there," Frank explains, adding that the couple later moved to Arkansas. His son Robert lives in Eagle River.

Together Erik and Frank built the brick ranch. Frank still lives in on Bonnie Lane. "Behind the house was all heavy brush, no trees except some Ironwood," Frank relates and tells of clearing, planting, and gardening -- all by hand, raising flower and vegetable plants from seed -- and the big hotbed he built to nurture young plants when the spring still felt a chill. Out behind the vegetable garden fresh compost was folded and tended and worked over until mature enough to use when it was

three years old.

Huge geraniums sit in pots on the patio, direct descendants of his first plant. "When my daughter was 15 years old, she gave her mother a pink Martha Washington geranium. I kept it growing, and one year it got as big as a bush with 62 flowers on it. Everyone admired it." Now producing red flowers, Frank explains that it reverts back from a hybrid to its natural state after a number of years.

His vegetable garden, which he still tills with a walk behind rototiller, boasts beets, peas, carrots, spinach, squash, zucchini, white and red cabbages, and potatoes. "I never bought fresh vegetables all winter except for lettuce," Frank insists, and says the potatoes don't sprout in his root cellar 'til mid May. "Carrots are good to June." There was never a weed in his vegetable garden, and there won't be any this

year. "People tell me they've never seen anything like it."

Else used to teach him about the garden. Sometimes she was even downright bothered by his obsession with work. In his prime, Frank used to go out after breakfast and not stop until it got dark, except for meal breaks.

"Why do you have to do this on Sunday?" Else would lament. "What I do on Sunday, I don't have to do on Monday," Frank would answer. Wood violets dot the lawn as a reminder of the single plant she brought home one day because she liked it. "Now they're everywhere," Frank complains, but his eyes smile with the memory.

Last year Frank still made current jams and put up dills, but he yearns for the peaches, cherries and pears he used to can by the dozens. "I miss that all now." He's also been known to make the most beautiful pound cakes, along with apple kuchen, rhubarb coffee cake, and stollen for Christmas. He still does the washing, cooking, and some baking, but not as much as he used to.

"This is going to be the

last garden this year," but, Frank says this as though he's said it before. The earth is warming, and the birds are flitting back and forth between bird feeders. The black gnats are out in full force, which bother Frank plenty and leave big welts if he doesn't take care. This afternoon he's going to finally cut the grass, after days of rain forced delay and meanwhile, everything grew lush.

At his age, Frank thinks that perhaps it's time to moderately slow down. He loves family visits from his children, seven grandchildren, and six great-grandchildren, speaks of them proudly and shows off their pictures. He still plays cards with his friends from town. He's like the stock from his geranium, growing stronger with time, spreading deep roots that produce more flowers every year.

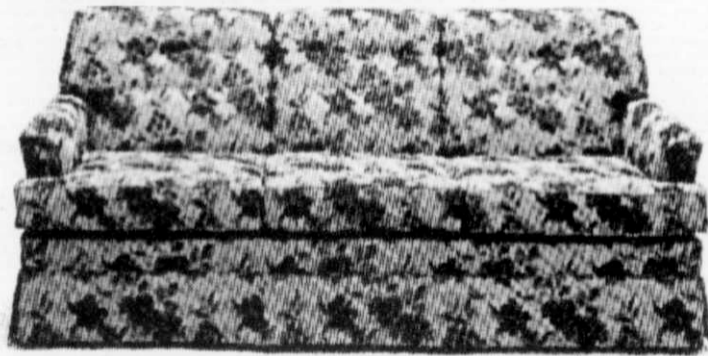

board first denied the reopening of Beechwood School for the 1999-2000 school year, with the operational budget to have been paid out of the general fund, not through a recurring referendum to exceed revenue caps.

"I'm going to say some things I wish I would've said last time," Jon Downs told his fellow members. "I feel very strongly about this - I believe the Beechwood issue should be decided by the public, not by us." He stated the issue would gain closure only through allowing the public a voice in the matter. "This is all about facilities planning. I don't see why Beechwood is the single issue the board has got to decide on (referring to future building referendums)." Downs then proposed voting again, urging to bring it back to the community.

Tom Timblin, the main recipient of the proddings to make a new motion, said he did not want to appear arrogant, but they (the board) were the elected officials. "We've been working on this thing for two years, and we

know so much more than the general public about all the finances and little nuances. We're more qualified than anybody. All seven of us have different opinions, but I believe everyone here is sincere as a heart attack," he concluded.

Concern over holding a recurring referendum was discussed by John Schulte, who said other members feared it would open up attempts by the state teacher's union to request referendums to raise salaries. "Whether they do that or not is not my concern. That shouldn't affect our decision." At this point Timblin rejected Schulte's request to revise the motion.

Trying to gather support for the re-motion, Fechter reiterated his opposition to a recurring referendum, but implored the board fulfill its obligation to allow people the right to vote. "I don't agree that we can't have a recurring referendum because people don't understand it."

Board President Jean Goeden explained that her decision was based on a

change in projected student growth, which started out with past administration estimating 4% growth per year, but has actually turned out to be 1 to 1 1/2%.

"Over a period of three years, we'll be down 90 students just at the kindergarten level. We're also losing ten to the school choice this year." She added that nowhere in the district goals does it ever support a small, or community school concept.

"Those are good points, they're valid," Fechter challenged, "but again, I'd like the board to address why you won't, as a majority, let the district vote on it. They deserve a crack at the bat. Why are we standing in the way?"

After the 6-1 vote against reopening the school, Schulte asked Timblin one last time for a new motion, and the request was granted. The new motion (to open Beechwood for the 1999-2000 school year, with the budget to be paid through a recurring referendum voted on by the public in a June 16, 1998 referendum, not to exceed \$600,000) failed once again, 4-3, with Goeden, Andera, Timblin and Lisa Maul voting no.

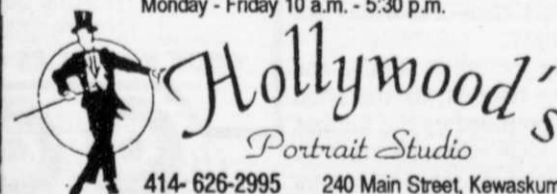

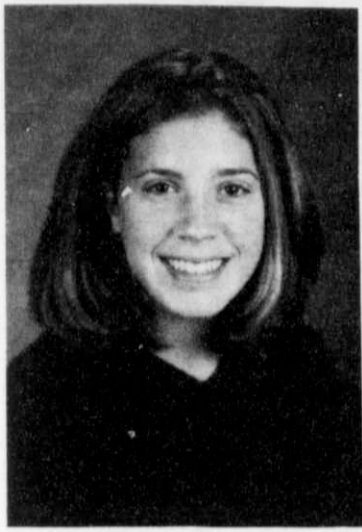

150th Anniversary of St. Kilian Parish to Be Observed

St. Kilian Parish, which was established in 1884 and is located in the southwest corner of Fond du Lac County, will be celebrating the 150th anniversary of its founding on Sunday, June 21, 1998.

The present church, which sits on a hill overlooking the beauty of the countryside, was built in 1896. The first church was a small log building which stood in the middle of a woods.

Today, a large cemetery cross marks the original site. Bavarian immigrants erected the first church and they named it after St. Kilian who had spread the message of salvation in Bavaria.

St. Kilian Church continues to be the center of Christian faith for approximately 65 families. For many of the families, parents, grandparents, and great-grandparents attended the small school which

began in 1867 and ended in 1972. The School Sisters of Notre Dame staffed the school for all those years. Also, many sons and daughters of the parish pursued religious lives becoming priests and sisters.

In observance of this special occasion, a Mass will be celebrated at 10 a.m. on June 21, at St. Kilian Church. Father Charles Bodden, a former son of the parish, will be the main celebrant.

School Board Approves Account to Decrease Debt

At the Monday night monthly school board meeting, action was taken by the board to unanimously approve a resolution to authorize the establishment of a defeasance escrow account, in the amount of \$517,000.00. These funds are being used to decrease the general debt obligation of the district.

Moneys for the escrow account were derived from

the 1997 levy of 87 cents per thousand dollars of equalized valuation.

The levy will be decreased by \$802,936.00 over the lifetime of the bonding issue. Yearly interest cost savings will be \$60,000 based on the defeasance approved in 1996 and 1997.

The current outstanding bond principal obligation for the district is currently \$4,080,000.00.

The Kewaskum High School boys track and field team placed sixth at the Vanderpan Co-Ed Invitational on Friday, May 8, at Sheboygan Falls.

Eastern Wisconsin Conference power New Holstein totaled 142 points for the team title. Plymouth edged Oostburg by a half of a point 130.5 to 130 points for the runner-up spot. Southern Door finished fourth with 96 points, host Sheboygan Falls finished fifth with 73 points, and Kewaskum finished a distant sixth with 39.5 points. Elkhart Lake finished seventh with 30 points and Howards Grove finished eighth with 19 points.

Matt Hammen captured the only first place for Kewaskum when he cleared 6'4" on his third attempt to edge the second place jumper by two inches. "Matt's jump of 6'4" tied his personal best for the third meet in a row this season. It wasn't an easy night to jump well with the cool and very windy conditions. This should be a confidence builder with him making 6'4" for the third time in as many meets," commented head coach Jerry Gosa.

Teammate Sean Cotter placed third in the high jump with a season best height of 5'8". "I'm happy for Sean," commented jumping coach Keith Amundson, "He has been working hard all season."

Brad Hermann provided the only other top three finishes when he placed third in the pole vault with a jump of 11'6".

The Kewaskum 3200m

relay team of Matt Belger, Dan Wall, Aaron Nelson, and Scott Mueller placed fifth with their best time of the season in 9:47.

Josh Rieder tied for sixth place in the long jump with a personal best jump of 18'4" and Scott Mueller placed sixth in the 800m run with a time of 2:17.7. Troy Staehler, Kewaskum's best 800m runner, had to miss the meet due to his confirmation on Friday evening. Staehler would probably have placed in the top three.

Matt Gundrum placed sixth in the discus with a throw of 123'9" and teammate Charlie Sparks finished seventh with a throw of 122'6".

The 1600m relay team of Josh Parrent, Josh Rieder, Steve Sarauer, and Chris Weninger finished seventh with a time of 4:01.5.

Matt Belger's 5:21 in the 1600m run and 12:01 in the 3200m run were personal bests, but did not place.

The next meet for the Kewaskum boys and girls track team is the Eastern Wisconsin Conference Championships on Thursday, May 14, at Chilton High School. Field events and the 3200m relay (girls, then boys) begins at 3:45 p.m. Trials will immediately follow the running of the boys 3200m relay. Following the completion of the preliminaries in the high hurdles, 100m dash, and 200m dash, there will be a 15 minute break. Final will begin after the 15 minute break.

Starting in 1993, businesses that rent personal watercraft to people are required to educate the renter on the spot, using DNR-developed materials. Those changes were important, Engfer said, because rental craft typically account for more than a quarter of the injury accidents.

"This educational program has helped to make our safety record for personal watercraft among the best in the country," Engfer said, adding that many other states have requested copies of the DNR's educational materials.

Engfer thinks the decline in recent years in personal watercraft accidents also reflects the fact that more older adults are buying the machines and that there is more pressure among enthusiasts to use the machine safely. "People seem to be using more common sense when operating them," Engfer says. "I think peer pressure is having an effect along with the increased education and enforcement efforts."

Personal Watercraft Accidents Drop

In a year when overall boating facilities soared and injuries increased moderately, boating safety experts are encouraged by figures that show people are more safely using personal watercraft, commonly known by such trade names as Jet-Skis.

One person died and 40 people were injured in 54 accidents involving personal watercraft. That compares to 1996, when one person died and 47 were injured in 62 accidents, and to 1995, when 52 people were injured in 69 accidents.

"The direction it's been going in recent years is very encouraging," says Bill Engfer, Department of Natural Resources boating safety administrator. "We've got more personal watercraft out on the water and fewer accidents and injuries. That shows us our education programs and personal watercraft laws are working well."

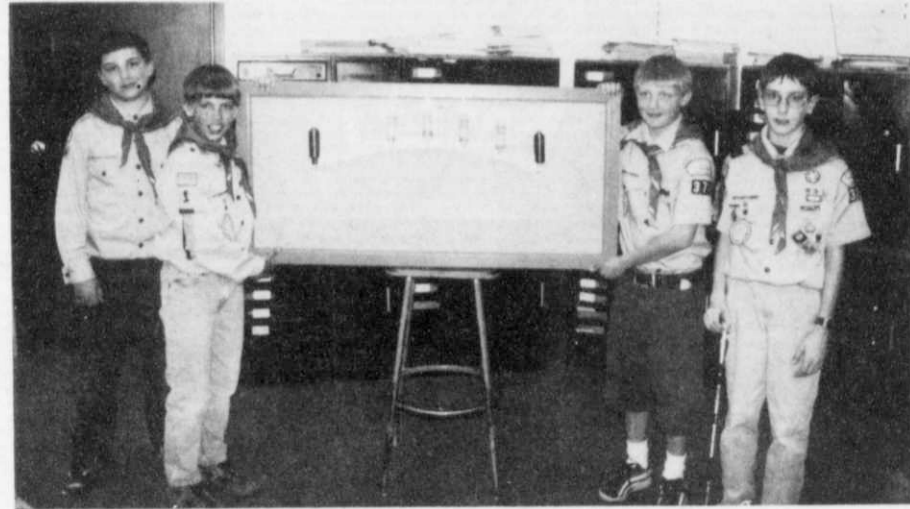

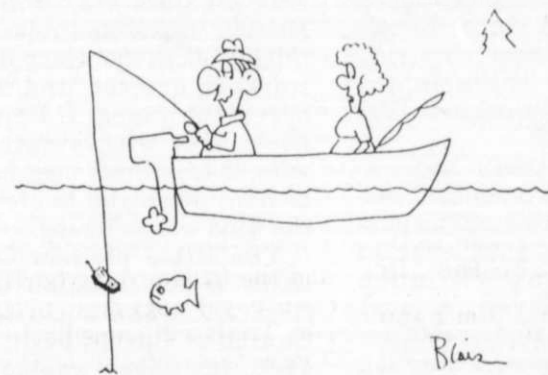

Church 'For All Peoples' Opens Doors in Wayne

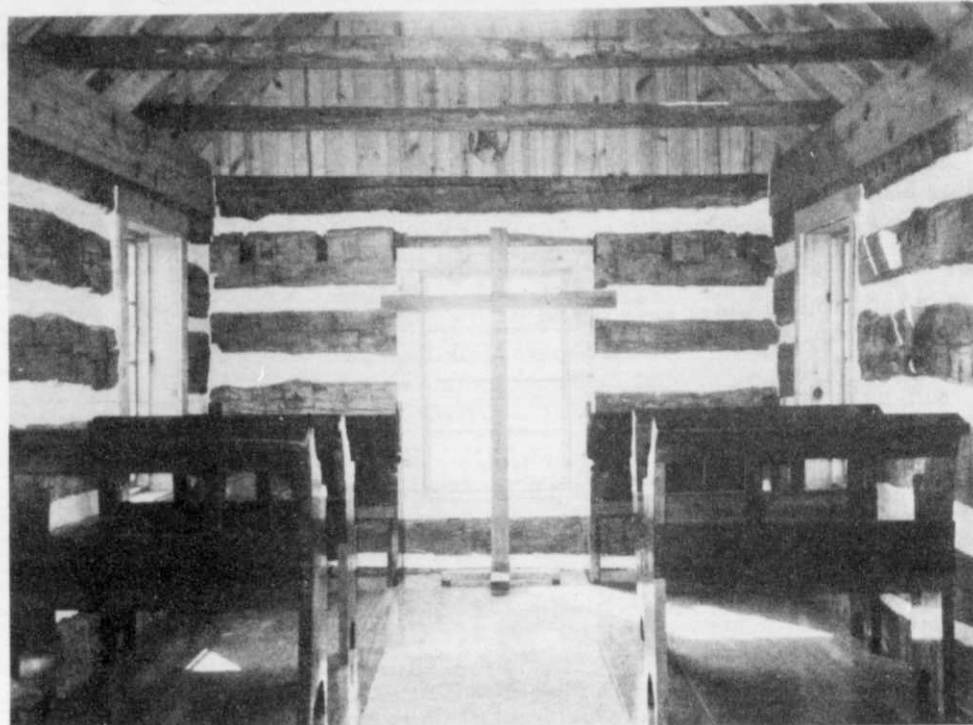
Overlooking 200 acres of wetlands, meadows and Wisconsin prairie, Faith Haven's new public chapels sit tucked into Kettle Moraine Esker, inviting seekers to share in the vision of a sanctuary, "For All Peoples."

The non-profit corporation has just completed construction of two unique public chapels just east of County Trunk WW in the Town of Wayne. Almost opposite in their relationship with time, a tiny log chapel graced with a wooden cross stand modestly beside a futuristic structure that supports three twenty

foot tall PVC sewer pipes rising up to heaven as an image of the Holy Trinity.

"A lot of people have invested in some pretty harrowing experiences to make this all possible," Faith Haven's spokesman relates, talking about the windy day workers erected and secured the pipes. Holding them taut with aviation wire, it took three men just to hold down the ladders, the wind was so strong.

The little pioneer log chapel is modeled after the first St. John's United Church of Christ, built in 1860. It's usage was once shared with Roman Catholic and Lutheran settlers in the area around the Town of Wayne, until each

built their own church. The replica stands as a reminder of a time when simplicity functioned best, and worship was approached with humbleness.

The two story futuristic "inspirational" sanctuary is stark white in comparison, welcoming in form with an unusual "flying roof" supported by two 6,000 pound laminated beams shipped in

from Oregon. Doors open to the sound of spiritual/classical background music programmed to automatically play for half an hour.

The interior celebrates art and the spirit, blended into an eclectic array of old and new that suggests a bold approach to God, yet offers it in subtle suggestions. "All the artwork in here is used to seduce peo-

ple to righteousness, not to evil," the caretaker purports. Light streams in from lots of windows in all shapes and sizes, some with wire sculptures sandwiched between glass, done by local artist Spiller.

The entryway is inlaid with tile from Czechoslovakia made from recycled automobile windshields. Walters Buildings in

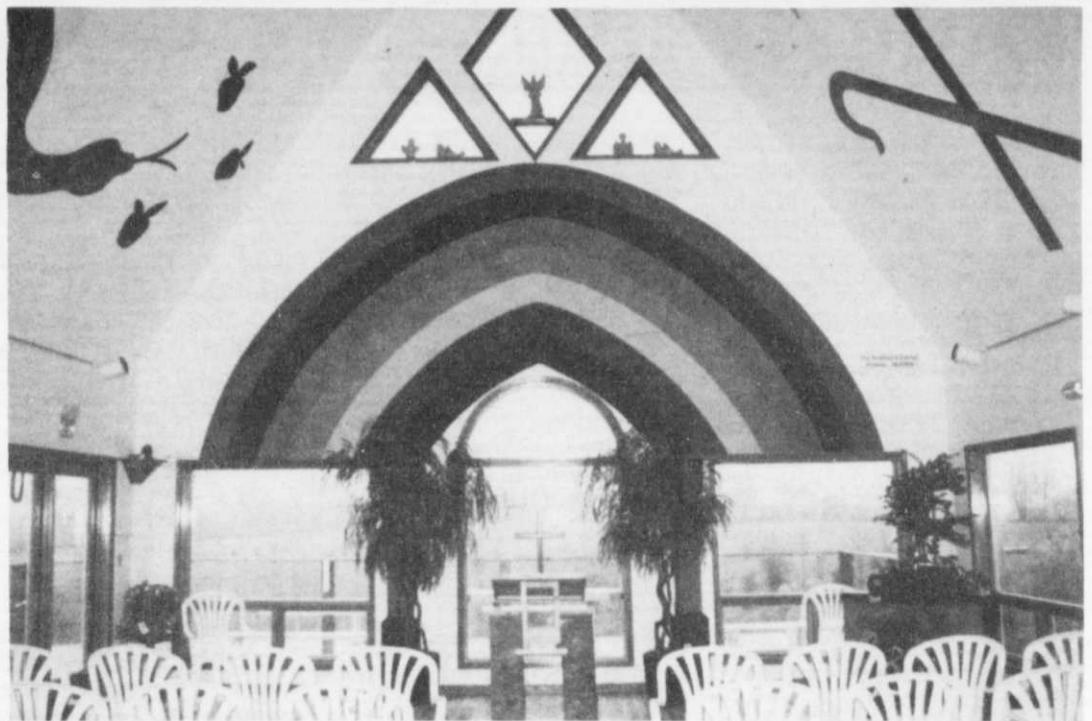

Allenton is now manufacturing tile using the same process. A spauld sugar maple floor sets off the beauty of the main worship area. "Spauld wood has started to disease, turning it darker in places. I love it because its flaws make it so interesting," the caretaker comments, pointing to a wall near the vaulted ceiling. Here carpet sculptures done by artist Chuck Gerhard of West Bend, depicts a huge serpent with a tempting apple, a shepherd's staff, a peace dove, and the star of wonder. The length of the ceiling, sparkling with glitter, is

enhanced by three immense wooden crosses that were almost as difficult to put up as the steeple pipes. Although the chapel is non-denominational, furnishings include hints of Catholic, Protestant, and universal images; an altar dedicated to Mary and Joseph, a tiny carpeted room focusing on an old picture of the Last Supper (labeled by a sign that says, "Talk With God Room"), an altar made from a real carpenter's bench, a Baptismal font, organ and altar all on wheels and statues of angels, saints, ladybugs and

lizards. One hundred hymnals were donated to Faith Haven Chapel by St. Germain's United Church of Christ.

The lower level has been fitted with a comfortable community room, equipped with a modern kitchen and elevator, and handicapped accessible restrooms. Set into the wall as a conversation piece is a massive marble altar once used in a church in Italy.

The east side of the chapel is wrapped in a deck that overlooks acres of formal and forested carriage trails, some girded with growing hardwoods that will one day form a canopy. Faith Haven hay rides, horse drawn wedding or Amish carriage rides offer a view of unique metal sculp-

tures dotting the landscape as well as the Apostle Garden, and over 273 species of Wisconsin prairie plants.

To the south of the two chapels, digging is underway to create a wildlife pond surrounded by a man made esker, set into 58 acres of pristine wetlands, a natural home for white egrets and blue herons to nest.

It took almost one year for the public use chapels to be completed. "We didn't put contractors on a deadline, we didn't want it hurried," the Faith Haven points out, so contractors worked in-between other jobs to finish the project. A private dedication will take place in June for contractors and members of St. John's, with an Open House

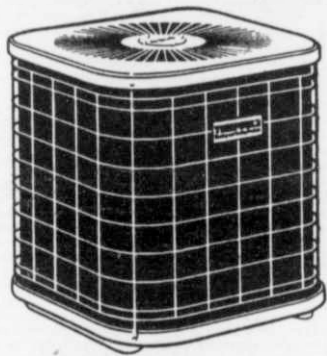
for residents of the Town of Wayne and the greater community scheduled for the month of August.

Meanwhile, the chapels are available for weddings, organizations, families or anyone wishing to pray, meditate, or just relax in its sacred beauty. "Adventure Away" tours offer a half day opportunity to view Faith Haven's natural bounty and enjoy a homemade lunch in the new community room.

Village Board Meeting Minutes

Mid-Monthly Meeting
April 20, 1998
8:00 p.m.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Mid-Monthly Session in the Council Room of the Municipal Building, 204 First Street.

President Robert Wagner presided. All other Trustees were present. A quorum was present. The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Harry Roecker, seconded by Trustee Warren Dums and unanimously carried by voice vote, the minutes of the April 6, 1998 meeting were approved as printed.

Representative Glenn Grothman asked to address the Board to give an update on what is happening in Madison. He reviewed several of the issues for upcoming discussion with the Board.

A public hearing was held on the special assessments for Municipal Improvements (installation of storm sewer, catch basins, sidewalk, curb/gutter, street/roadway, street base/surface and restoration/landscaping as well as other specifications contained in section 82 of the Municipal Code) for the area known as Old Fond du Lac Road and Fond du Lac Avenue Access Drive, (area annexed in 1991 north of the urbanized street section). Mr. Ken Ward and Mr. Curt Bolten of Ruckert and Mielke were present to explain the project and how the costs were established. It was noted the Village was being very generous in covering the cost of the storm sewer, and one half of the cost of the roadway. A fact sheet was provided to the Board regarding this project and how it related to others. Mrs. Karen Grahl, Mr. John Petermann, Mrs. Marion Erdmann and Mr. Harold Bonlender were present for the discussion. On a motion by Trustee Robert Stoltzmann, seconded by Trustee Andy Pesch and carried by the majority roll call vote, the Board closed the public hearing. On a motion by Andy Pesch, seconded by Trustee Warren Dums and carried by the majority roll call vote the Board suspended the rules to take up IX New Business A. Resolution No. 98-11 a Final Resolution regarding the Special Assessments as previously heard at public hearing and B, the Contract for the aforementioned project. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent."

Trustee Gary Gavin asked why sidewalk wasn't being placed on the east side of Old Fond du Lac Road. The explanation was given by the engineers and past practices were also noted.

Action was taken on Resolution No. 98-11 A Final Resolution Regarding Sidewalk Installation, Curb/Gutter, Storm Sewer, Catch Basins, Street/Roadway and Street Base/Surface and Restoration/Landscaping, as well as other Improvements and Levying Special Assessments Against Benefitted Property Under Sec. 66.60 7 66.65, WI Stats. as attached hereto:

The Engineers reviewed the bids received on the work for Old Fond du Lac Road and Fond du Lac Avenue access drive. The Engineers recommended awarding the contract for said work to the low bidder T.P. Concrete, Inc. for an amount equal to \$76,427.70. On a motion by Trustee Warren Dums, seconded by Trustee Andy Pesch and unanimously carried by voice vote the Board authorized awarding and signing said contract with T.P. Concrete, Inc. for the aforementioned project.

Assistant Fire Chief Mark Herriges presented the March 1998

monthly report:

Fire calls - 1, Year to date - 3; Jaws of Life - 5, Year to date - 12; Rescue calls - 28, Miles 649.

Chief of Police Richard Knoebel presented the February 1998 report:

Criminal arrests - 38, Criminal investigations - 42; Traffic warnings - 148, Traffic citations - 36; Adult arrests - 26, Juvenile arrests - 10; Property stolen - \$342, Property recovered - 0; Parking warnings - 11, Parking tags - 31.

Director of Public Works Jerry Gilles reviewed with the Board the following:

1) Reviewed a news note regarding the possibility of going to brush chipping on an every other week basis. This would be a cost effective move and be on the agenda for discussion on May 4, 1998.

2) Discussion will also be slated for the expansion of grass clipping compost material disposal hours on May 4, 1998.

WHEREAS, the Commission has transmitted certified copies of its resolution adopting that land use plan, together with the aforementioned Planning Report No. 45, to local governmental units of Southeastern Wisconsin Region; and

WHEREAS, The Kewaskum Village Board believes that the land use plan prepared by the Commission will be a valuable guide not only to the development of the Region but of Village of Kewaskum as well, and that the adoption of such plan by the Village of Kewaskum, Washington County, will assure a common understanding by the several governmental levels and agencies concerned and enable their staffs to program the necessary area wide and local plan implementation work;

NOW, THEREFORE BE IT HEREBY RESOLVED, that, pursuant to Section 66.945(12) of the Wisconsin Statutes, the Village Board on this 4th day of May, 1998, hereby adopts the regional land use plan for the year 2020, previously adopted by the Regional Planning Commission, as set forth in SEWRPC Planning Report No. 45, as an amendment and extension of the year 2010 regional land use plan and as a guide for the regional and community development.

A RESOLUTION OPPOSING "ASSEMBLY BILL 800"

WHEREAS, the Village of Kewaskum currently collecting a sewer connection fee and an open space fee and/or the consideration of the collection of impact fees would be restricted in our ability to collect and disburse said fees.

NOW, THEREFORE BE IT RESOLVED by the Village Board of the Village of Kewaskum is opposed to Assembly Bill 800.

BE IT FURTHER RESOLVED that the Village Administrator is hereby directed to send a copy of this resolution, upon adoption, to the League of Wisconsin Municipalities, Mid-Moraine Municipal Association, Washington County Clerk, and state legislators representing the Village.

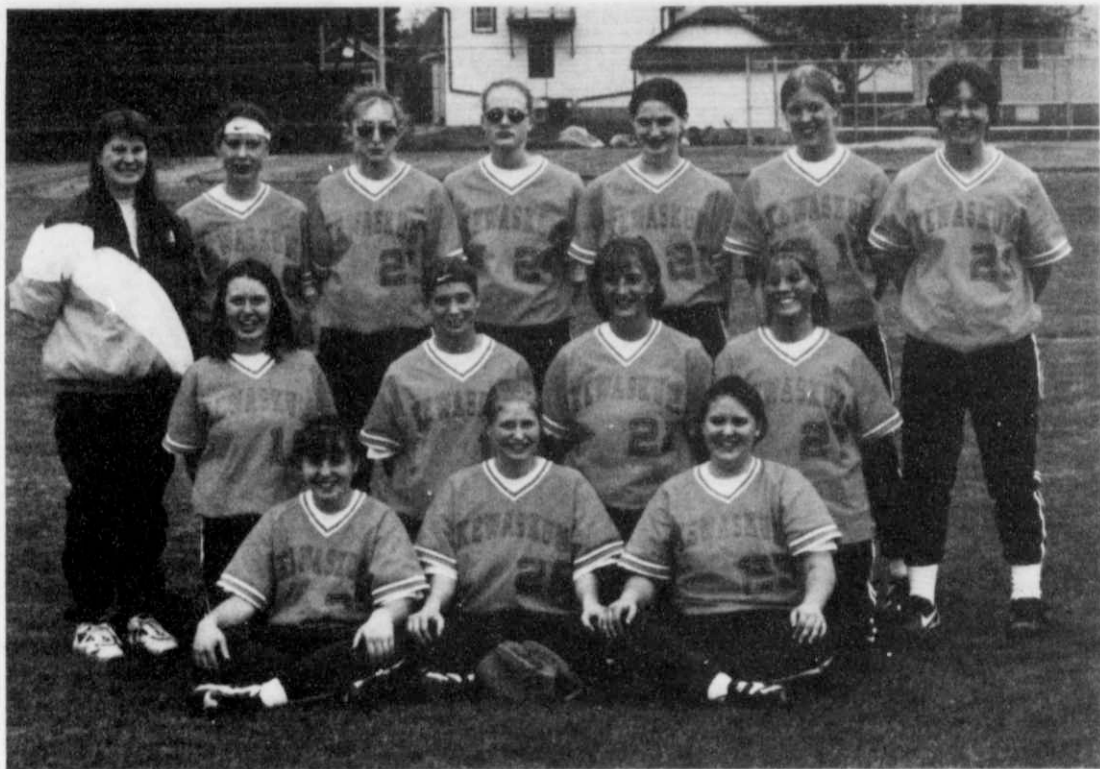

The Kewaskum High School boys' track team found out just how tough the Eastern Wisconsin Conference is in track again when it traveled to Plymouth to compete with Two Rivers in a triangular track meet on Tuesday, May 5.
