Military Road Sesquicentennial Wagon Train to Feature Authentic Wagon Built by Local Men

Outfitted to travel two weeks across the width of the state in a covered wagon, Bob Manthei and Augie Bilgo prepare to join the ranks of the Military Road Sesquicentennial Wagon Train on May 29, armed with the pioneer spirit of adventure, two Belgian horses and most likely, a couple tubes of Ben Gay.

In recognition of the 150th anniversary of Wisconsin's statehood, the wagon train will be retracing the route of the Old Military Road from Prairie du Chien to Green Bay, a 234 mile trek through 43 different communities. Sponsored by the Ashwaubenon Historical Society, the event will include numerous public appearances at places like Villa Louis, Fennimore, the Lodi fairgrounds, the Jamieson House in Poynette, Ft. Winnebago, Kingston, Markesan, Brandon, the Galloway House and Village, Stockton, Wrightstown and De Pere.

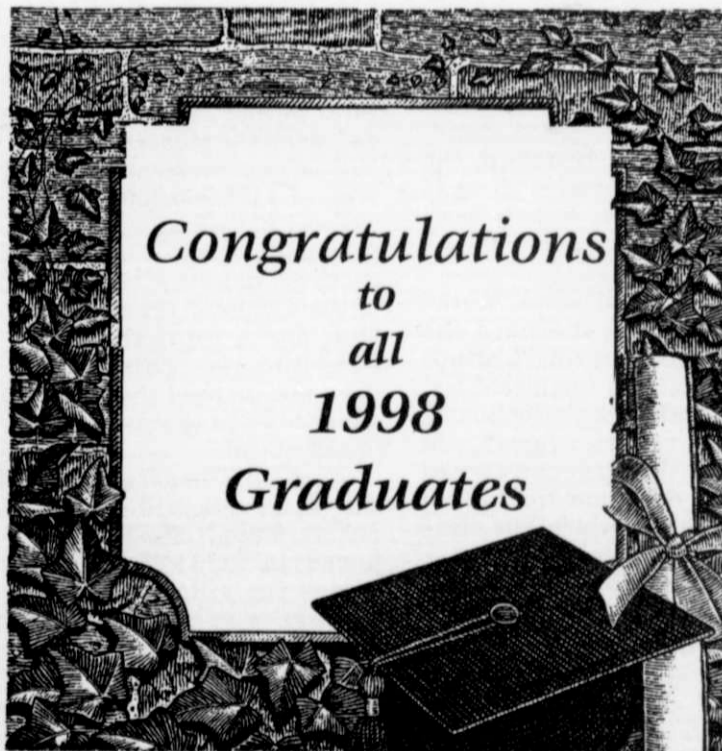

School Approves Salary Increases

Proposed administrative salary increases for the 1998-99 school year were approved by the Kewaskum School Board at their last meeting.

The total package reflects a 3.2% salary increase, contingent on new estimated insurance costs not to exceed a 6% increase. If they come in above or below the 6% mark, wages will be readjusted up or down accordingly. Total package increase cannot exceed 3.8%, which is set by a state imposed Qualified Economic Offer.

The following figures show base salaries for administrators, not including fringe benefits or longevity pay. The cost of health benefits for an administrator with family coverage is \$586.18 per month, plus \$67.74 dental.

95% is paid by the district, with full payment of dental coverage.

George Allmann, Business Manager/ Curriculum Coordinator, \$67,487; Larry Wilson, Kewaskum High School Principal, \$67,498; John Wolfenberg, Kewaskum High School Assistant Principal, \$54,273; Ken Soerens, Kewaskum Middle School Principal, \$62,370; Kieth Kriewaldt, Director of Elementary Education, \$65,621; Jim Botting, Farmington Elementary and Summer School Principal, \$56,760.

The proposed salaries for the upcoming school year will begin on July 1, 1998, and are based on a 260 work day year. The salary for the district administrator, Clark Pearson, will be approved at a later date.

Village Board Addresses Light Agenda

The Kewaskum Village Board breezed through a light agenda last Monday evening.

In the absence of Board President Robert Wagner who was recuperating from surgery, Village Administrator Daniel Schmidt asked the board to appoint senior board member Robert Stoltzmann as chairman pro-tem. Trustee Harry Roecker was also excused.

Police Chief Richard Knoebel opened with his report, also stating D.A.R.E. graduations were being held with the first one occurring last Tuesday.

In reference to the monthly report, Trustee Gary Gavin asked Chief Knoebel, "Why the big number on 57 parking tags?"

Knoebel informed him that the high school sends someone out to check license numbers on illegally parked vehicles and they then call the police department who in turn, write out parking citations. He went on to say at West Bend, Slinger and Hartford, the officers themselves go up to the schools on a daily basis to issue citations themselves.

Director of Public Works Jerry Gilles informed the board that spring hydrant flushing was completed last week, along with the Bonnie Lane repair project. He added the state has started crack filling on USH 45 in the village which has since been completed.

Because the village owns the parking lanes, the state was not obligated to pay for filling the cracks in those areas. "The county asked if we wanted to participate in the crack filling of parking lanes," Gilles stated, adding, "We did participate, so

all parking lanes with cracks were filled."

Trustee Gavin asked what the cost was and Gilles answered, "The crew costs \$3,000 a day to do the crack filling. The county has not gotten back to us with an actual figure." However, it was estimated to be around \$3,000. Gilles also informed the board that the village was not charged for crack filling by the stop and go lights or the turning lanes. It was picked up by the state.

In related business, Administrator Schmidt informed the board that money has been budgeted for next year to do the alley in back of Kuehl's Suds and Spirits and the Post Office.

Schmidt also added the Board of Review was held on Monday, May 11, and no one filed nor did anyone appeal. "We have realized a \$4,643,700 increase in assessed value. That's a 42% increase from last year. Primarily nineteen parcels were improved. The total of our land value is \$21,988,000 plus \$89,572,300 in improvements for a total of \$111,560,300. Then we also have \$2,594,800 in personal property. That will decrease however, because of the computer tax exemption, for a total then of \$114,155,100. This total does not include the state assessed property and improvement."

With this assessment, the village ratio will drop to an estimated .889% compared to .9331%, which means the village will go through a re-evaluation. Plans for this are in 2001 and 2002.

"We have been budgeting \$6,000 annually to pay for this," stated Schmidt.

For the month of April, there have been nine build-

ing permits for single family and one for a duplex. In closing, Schmidt indicated he had been receiving an excessive amount of phone calls from residents pertaining to grass clippings being blown on the road. Letters were mailed out to offenders and a notice was published in the May 14 edition of the Kewaskum Statesman.

The board then went on to discuss capital improvement projects for 1998. More discussion will follow after review by the Public Works Department at another meeting. The board however authorized advertising for bids for the Main Street Relief and Sewer project, as well as the Roseland Relief Sewer project.

Under new business, the board unanimously voted to approve Resolution No. 98-17, a Resolution for Local Adoption of the Year 2020 Regional Transportation System Plan for Southeastern Wisconsin. The plan calls for expanding Kettleview Road, CTH H and STH 28 and converting a portion of Badger Road and Kettleview Road to a county trunk highway status to be used as an alternate route around the village. The project at this time however, is at a low priority status.

The board then brought up the redundant issue of expanding STH 45 to four lanes. Schmidt told the board he sent another letter to the Wisconsin Department of Transportation. In this letter he asked consideration be given to the addition of automatic turn signals (arrows) at the USH 45 and STH 28 east intersection. Also requested was an addition of at least painted road turn arrows at the intersection of USH 45 and CTH H west.

Trustee Gavin expressed

disapproval of Ordinance 98-4 which deals with storage of junk, and regulation of discarded property. This was brought before the board because of an amendment, which stated Schmidt, "pertains to the depreciation of the neighbor's lot. Well you can't determine what depreciates the assessment of the neighbor's yard."

Gavin stated he was not aware there was such an ordinance. He added an ordinance such as this was hard to enforce, stating, "And what I have a problem with is if somebody has a woodpile on the side of their house, and they burn wood, why does that come under this thing (ordinance)."

Schmidt explained, "That's basically scrap lumber." Gavin interrupted, "Well that's not what it says, it says wood. Unsightly debris. What is unsightly debris? There's too many things that are vague here."

Schmidt reiterated with, "That's what the statute says." The Ordinance was approved with Trustee Gavin voting no.

For the last order of new business, the board discussed the possibility of purchasing and placing trees within the greenway on Fond du Lac Avenue, south of the Kewaskum Creek. The project is not to exceed \$2,000. The motion was introduced by Trustee Kenworthy and seconded by Trustee Gavin. The motion carried and was approved. A Tree Management Plan is also being considered.

Hallen Reflects on Memorial Day

Elmer Hallen stands in front of the new Veteran's Memorial he designed for the front lawn of the Robert G. Romaine American Legion Post #384 in Kewaskum. Decorative stone, some evergreen shrubs, and a bronze plaque mounted on a rock encircle the American Flag on its pole. The plaque reads, "In Memory of Robert George Romaine, and all those who served and gave their lives in World War I, II, Korea and Vietnam."

There are also brass insignias from each war, the kind they put on veteran's graves to hold flags on special days of remembrance. "People steal these from cemeteries, you know," Elmer states. "They melt them down for the worth of the metal."

A veteran himself, Hallen has several reasons for staying active in the Legion, but the most significant would be the large numbers of hospitalized or nursing home veterans. "So many of them are forgotten. A group of us go out to Cedar Lake, have parties for them, cheer them up a bit, try to give them a day of something to do," he relates, his voice emphasizing the word "forgotten." "I feel very bad for the guys in the hospital, and the ones who never got to be 20 years old. This time of year, I feel like going nuts, remembering. It's one of the reasons I keep going."

A life member of two American Legion Posts, the Order of the Purple Heart, the Veterans of Foreign Wars, and a national officer for the Izaak Walton

League, (an organization dedicated to the conservation of natural resources), Elmer doesn't brag about these things, it's just a fact. He's a patriot who loves his country, and hates war. He doesn't even like to talk about it and has to be coaxed.

Both his parents immigrated to the United States from Sweden, his mother at age 14, and his father at 18, whereupon he immediately joined the army to fight in World War I. Elmer became involved in the Sons of the American Legion before he himself even entered the service. "I guess we had a military background. My two brothers and I ended up serving in four different branches of the military."

Living in Northbrook, Illinois when World War II erupted, Elmer entered the Army in 1943. He became a part of the 658 Army Amphibious Tractor Battalion, commanding a unit of ten LVT's (Landing Vehicle Tracked) with 30 soldiers under him. "It's like a tank that floated," Elmer describes the vehicle. "We were always involved in the first three waves of any invasion in the Philippines.

We hauled the troops in; because of the coral reefs, the ships couldn't get close."

On December 9th and 10th, 1941, the Japanese invaded and took over the Philippines, and Elmer was one of the American soldiers who fought to reclaim the island. Most of the action he was involved in during the war took place there. "We also visited a lot of the lesser islands, checked them out and kept them safe."

He served his country for three years, then returned home to Northbrook, but it wasn't the same. "When I went into the army, the town was just like Kewaskum, but when I came back, it just kept growing, it got bigger and bigger." His sweetheart, Betty, waited for his return, and they married a month after Elmer got home. "She waited and I waited. It was a long, four year engagement," he proclaims.

The Hallens settled in Kewaskum in 1980, after visiting the area several times to snowmobile and golf. They purchased a lot, built their house, and finally made the permanent move up here three years later. Their three daughters, Peggy, Terry and Kitty, were Legion Auxiliary members since the day they were born, and Betty served as President of the Northbrook Auxiliary Unit, and also restarted the one in Kewaskum while Elmer served as commander of the Robert G. Romaine Post.

With a membership between 165 and 180 veterans, Kewaskum's American Legion Post serves the community through a variety of worthwhile endeavors. "Clayton Stautz and I visit schools and teach the kids about the flag and the Pledge of Allegiance," Elmer explains a program started three years ago. "We just did one in the little town of Armstrong. Children say the Pledge wrong. One Nation under God is one line, with no comma." The legion also sponsors youth at Badger State, runs a Farmer's Market on their grounds throughout the summer, sponsors an Easter Egg Hunt in River Hill Park and holds a Memorial Day coloring contest for children in the area.

"It's important we keep doing things for the veterans. We need to keep people aware that we are here," Elmer says of all veteran's

organizations and the work they do. "We keep looking for members -- we are a vanishing species, which is fine with me if there's never any veterans again. But I don't think that's going to happen." He encourages everyone to visit the Wisconsin Veteran's Museum, located near Madison. "It's an experience you won't forget."

After 52 years of marriage, Elmer is grateful for

his family, which includes six wonderful grandchildren, and a wife that still puts up with him. "That's worth a lot," he concludes. "I get involved in many things, and I try to follow through on all of them. For the future, I hope we stay away from wars, if we can. We have to do everything possible to avoid one. Still, if another war came, I would gladly go to serve my country again."

natives have been planning this trip for about three years, since the idea first originated from "Wagon Master" Dick Koltz of Greeleaf. Manthei started working on his authentic covered wagon in the summer of '97, using an early 1900's built Adams wagon base from Brantford, Ontario.

The old wooden wheels, axle and running gear were purchased at a horse auction in Waverly, Iowa. "I saw some models at the auction, I looked through books from the library, it's really just a standard wagon box with hoops put on and a cover," Bob modestly says of his covered wagon, adding that he's taken it apart a few different times to change something so it better fits the role it's designed to play.

The wagon itself is somewhat of a community venture, with various locals pitching in their expertise to get it right. "Mike Berger and Augie helped out a lot, helped me find the stuff we needed. The old iron and steel cam off "Buckshot" Backhaus's wagon, and Dick Laubach helped me put in the brakes," Manthei recites off the neighborly gestures of a small town. There's even a fold down table built into the back of the wagon, created by Bob and Augie in a moment of genius. "Look at how we fixed it up here in the back so we can eat," Augie boasts of their invention.

Pioneers, settlers, farmers depended on the versatility of the standard wagon box, of which the purpose changed to suit the need. Fitted with a cover, it hauled a family to a new home across the country; with the top off it hauled grain or carried a new plow from the mercantile to the farm; and fitted onto runners in winter it served as a horse drawn sleigh.

Manthei's wagon looks and feels authentic, from the wooden barrel lashed to the side to the canvas cover fashioned by Fond du Lac Tent and Awning Company. The wagon bows are Amish made, and the leather horse

harnesses were borrowed from Frank Stoffel.

"I bought new nylon harnesses for my team of Belgians. I can't use them on the trip," Bob points out. The horses are lent too, since one of Manthei's horses is a little lame right now. Bobby Schreffler's four year Belgian geldings, Blaze and Ben, will be making the "once in a lifetime" cross-state trip.

"The girls are meeting us at Lodi, to join us the last week," Augie says of his pioneer wife, Verla, and Joanie Manthei. "You should see how pretty she looks in the dress she made," Augie said, sending a look Verla's way. All clothing worn on the wagon train must look like authentic period dress made from natural fabrics; no snaps, zippers, no western looks, and at least one petticoat for the women. Alas, split riding skirts for women did not appear until after 1900.

Approximately 20 teams and wagons will be making the journey along parts of the Old Military Road, accompanied by outriders,

passengers, and walkers.

The group will be escorted by the 1st Alabama Calvary Unit. A 2,000 pound Super Bowl bell, created by the Richland Center Foundry, will be traveling with the group, to be raffled off in an evening ceremony in De Pere. Manthei was asked to haul the bell on his wagon, but he feared the load would be too heavy to carry the entire 234 mile trip. Raffle tickets for the green and gold "one of a kind" bell will be available all along the route.

With a daily 6 a.m. wake-up call, the wagon train plans to travel 15-20 miles per day, joining the festivities communities have planned along the route. Old fashioned hoe-downs, barn dances, chicken barbecues, historic and military demonstrations, raffles and auctions, chuck wagon dinners, Native American displays, songs and yarns spun into tall tales around the campfire, are just a taste of the many activities offered to honor the Military Road Sesqui-

centennial Wagon Train.

Before the construction of the Military Road, the waterways of the Wisconsin and Fox Rivers were the state's highways. Built to link three forts, Fort Crawford in Prairie du Chien, Fort Howard in Green Bay (both built in 1816), and Fort Winnebago in Portage (built in 1828), the Military Road was the first major road to be constructed in Wisconsin territory. Completed in 1838, it opened the way for families of settlers to reach the rich interior farmland of Wisconsin.

The wagon train has been planned to follow the original route as closely as possible, and although it no longer exists as a continuous entity, the Military Road still forms significant parts of some of Wisconsin's major highways and minor back roads. An 1848 map of Wisconsin lists 45 towns and villages, including the three forts, and this trip will take participants through ten of these locations. When the wagon in is following the original route, a special guidon

flag, white with the words, "U.S. Dragon" in red letters, will be flown to signify when they are traveling "historically correct." "Dragoons" was the term used for soldiers in 1848.

Ending on June 14 in Green Bay, the group will swing through Heritage Hill State Park, before it stops to place the Military Road Bell at road's end at the Holiday Inn downtown, the site of the beginning of the Military Road in Green Bay, directly across from the site of Fort Howard.

"This is a chance of a lifetime," Manthei expresses, who anticipates making new friends along the way and learning about life on the open trail. "We'll circle the wagons each evening, just like old times, and share stories around a campfire. I just hope these shoes hold out, I can feel every stone when I walk," he says of the fringed buckskin boots he wears with paper thin soles. No one said life back then was easy, Bob. On second thought, pack some Dr. Scholls with the Ben Gay. Wagons Ho!!

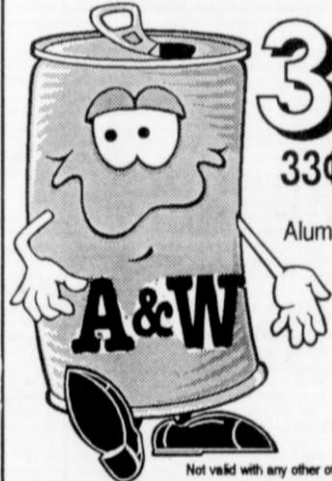

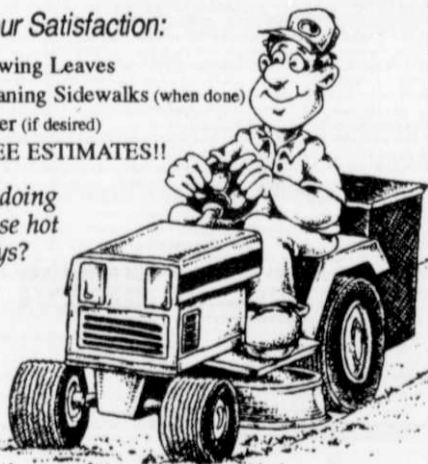

RECYCLING TIPS

** BATTERIES AND WASTE OIL **

TYPE OF OIL: Automotive and small engine oil only; **NO ANTI FREEZE.**

PREPARATION: Used crankcase oil should be free from water, rags or other foreign materials. Any cost incurred for handling and managing any contaminated oil will be charged to the person disposing of the oil. Place oil in a clear plastic container with a cover and take it to the disposal site. Roger and Dan's Auto Service at 891 Fond du Lac Avenue is the disposal site for village residents. Use a container that can be used again since disposal of containers becomes a problem. A "Waste Oil Permit Slip" must first be filled out prior to disposing of the waste oil. These slips are available at the Village Hall at 204 First Street.

TYPE OF BATTERIES: Automotive type batteries which are of the lead acid type. No flashlight or lantern type batteries are allowed.

PREPARATION: Automotive batteries should be placed adjacent to the recycling bin at the curb for pick up. Place the batteries curbside on the same day that your solid waste is to be collected. Pick up will be on Wednesday for both solid waste and recyclable items. Multi-family dwellings of six or more, remember, your recycling pick up will be the 1st and 3rd Wednesday of each month.

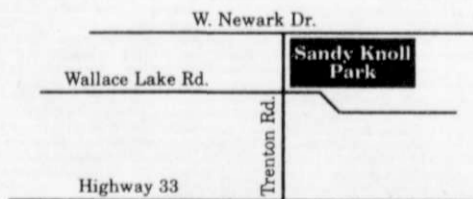

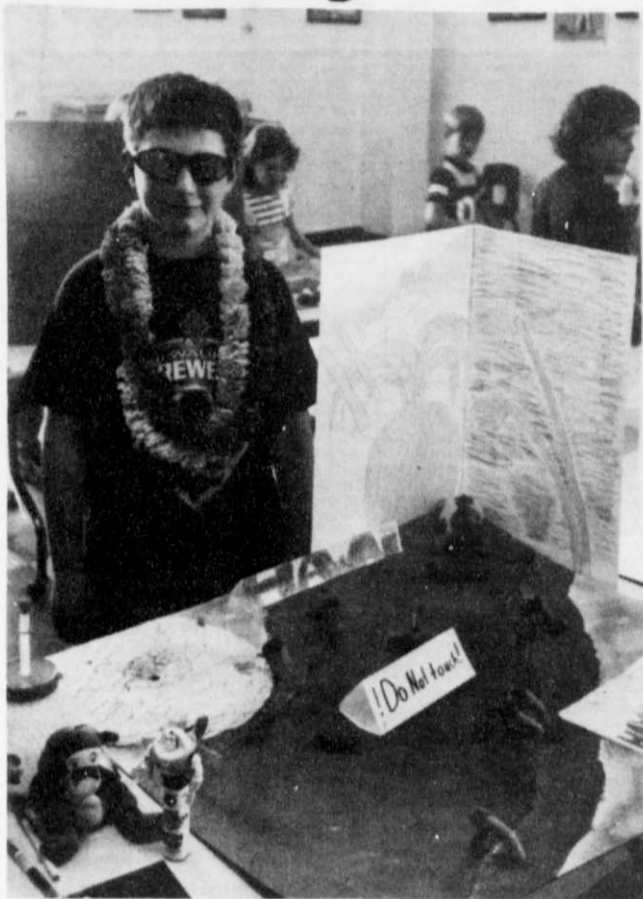

RESOLUTION NO. 98-17

A RESOLUTION FOR LOCAL ADOPTION OF THE YEAR 2020 REGIONAL TRANSPORTATION SYSTEM PLAN FOR SOUTHEASTERN WISCONSIN

WHEREAS, the Southeast Wisconsin Regional Planning Commission, which was duly created by the Governor of the State of Wisconsin in accordance with Section 66.945 of the Wisconsin Statutes on the 8th day of August, 1960, upon petition of the Counties of Kenosha, Milwaukee, Ozaukee, Racine, Walworth, Washington and Waukesha, has the function and the duty of making and adopting a master plan for the physical development of the Southeastern Wisconsin Region; and

WHEREAS, the Southeastern Wisconsin Regional Planning Commission has adopted on December 3, 1997, a transportation plan for the Region to the year 2020, which is intended to amend and extend the year 2010 regional transportation plan adopted by the Commission in 1994; and

WHEREAS, the year 2020 regional transportation plan and the supporting inventories, analysis, objectives, principles, standards, and forecasts are set forth in a published report entitled SEWRPC Planning Report No. 46, *A Regional Transportation System Plan for Southeastern Wisconsin 2020*; and

WHEREAS, the Commission has transmitted certified copies of its resolution adopting that land use plan, together with the aforementioned Planning Report No. 46, to local governmental units of Southeastern Wisconsin Region; and

WHEREAS, The Kewaskum, Village Board believes that the transportation plan prepared by the Commission will be a valuable guide not only to the development of the Region but of Village of Kewaskum as well, and that the adoption of such plan by the Village of Kewaskum, Washington County, will assure a common understanding by the several governmental levels and agencies concerned and enable their staffs to program the necessary area wide and local plan implementation work; and

WHEREAS, the Village of Kewaskum supports said plan, has a concern in reference to the proposed expansion of the Kettleview Road, CTH "H" to STH "28" with the ultimate conversion of a portion of Badger Road & Kettleview Road to County Trunk Highway status as an alternate route around the Village of Kewaskum, as to the low priority placed on said project on time frame expected for completion. It is noted the Village is supportive of the reconstruction of USH "45" double lane status as soon as possible, but acknowledge a need for an alternate route (bypass) in conjunction with this project;

NOW, THEREFORE BE IT HEREBY RESOLVED, that, pursuant to Section 66.945(12) of the Wisconsin Statutes, the Village Board on this 18th day of May, 1998, hereby adopts the regional transportation plan for the year 2020, previously adopted by the Regional Planning Commission, as set forth in SEWRPC Planning Report No. 46, as an amendment and extension of the year 2010 regional transportation plan and as a guide for the regional and community development.

BE IT FURTHER HEREBY RESOLVED that the Village transmit a certified copy of this resolution to Southeastern Regional Planning Commission, as well as copies to the Wisconsin Department of Transportation and Washington County Highway Committee.

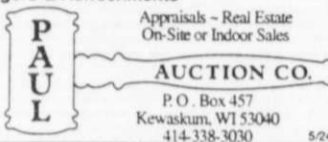

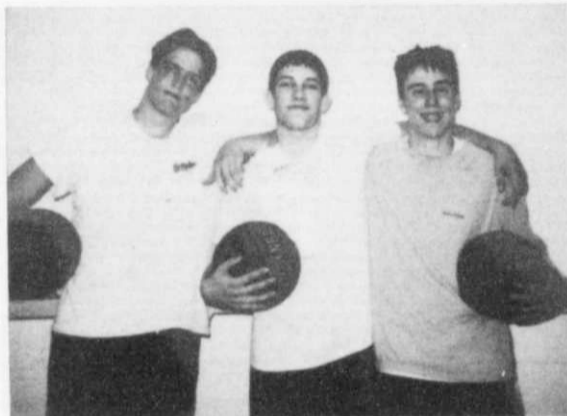

KHS Boys Track Seventh At Conference Relays

The Kewaskum High School boys' track and field team finished seventh at the Eastern Wisconsin Conference Relays on Thursday, May 21st, at Two Rivers with 42 points. Two Rivers won the relay meet with 111 points, followed by New Holstein's 103.3 and Plymouth's 85.3 points.

Highlights for Kewaskum included the first place finish of the high jump relay team of Matt Hammen, Sean Cotter, and Paul Mertz. Despite cool

and windy conditions, Hammen jumped 6'2" to lead the KHS trio to victory with a combined total height of 17'2", just two inches ahead of Two Rivers.

The discus relay team of Matt Gundrum and Charlie Sparks, who finished 1-2 at the conference meet the previous week, and Sean Cotter who doesn't normally throw; finished second with a combined total of 362'2". Powerful Plymouth finished first with a

total of 404'2".

The pole vault relay team of Brad Hermann, Troy Staehler, and Chris Koth finished a disappointing third with a combined height of 32'. Both New Holstein and Plymouth finished with a combined total of 32'6". Seniors Hermann and Staehler each cleared 10'6" and sophomore Chris Koth cleared 11'. "I thought that they could have broken the school record of 33'. We don't have opportunities like this every year and they missed their chance to put their names in the record book. In fairness to them I realize that Two Rivers isn't the easiest place to jump well," reported coach Jerry Gosa.

The shot put relay team of Matt Gundrum, Charlie Sparks, and Sean Cotter finished fifth with a combined total of 118'2". The 300m throwers relay of Gundrum, Sparks, and Cotter finished third with a time of 38.3 seconds.

The 800m relay team of Chris Koth, Chad Will, Paul Mertz, and Charlie Sparks finished fifth with a time of 1:42.8.

The 1600m medley relay team of Josh Rieder (400m), Chad Will (200m), Paul Mertz (200m), and Troy Staehler (800m) finished sixth in 4:12.4.

The triple jump relay team

of Josh Rieder, Scott Mueller, and Steve Sarauer finished seventh.

The 6400m (4x1600m) relay team of Matt Belger, Aaron Nelson, Chris Weninger, and Scott Mueller finished seventh with a time of 22:26.8. The same relay team also finished seventh in the 3200m relay with a time of 10:09.

"Without a lot of running depth it is difficult to compete with the powers of the Eastern Wisconsin Conference. We definitely need more athletes out for track. The team is also losing a good bunch of seniors that will be hard to replace," concluded coach Gosa.
