Jim LaMarche is Illustrator Of Books for Children

Wherever you go you take your hometown with you. Some wear it on their shirtsleeves; others tuck it away in a back pocket. Jim LaMarche weaves bits and pieces of it into fanciful illustrations that delight children and rekindle adult imaginations nationwide.

The Carousel, Grandmother's Pigeon, The Wallowing Window Blind, Mandy, Little Oh, and The Rainbabies, are children's books touched by the spirit and essence of LaMarche's talents as an illustrator, artist and designer. His work has been heralded as "exquisite," "masterful," "transcendent," "gleeful," and to a *New York Times* book reviewer, "extraordinarily beautiful."

Born and raised in Kewaskum, the path that led him from here to there seems as full as genuine wonder as the stories he paints in pictures. "It started off I was going into the sciences," Jim recalls his earlier ambition, inspired by his Kewaskum High School biology teacher, otherwise known as Dad.

Even though he was pretty good at art, it wasn't included in any career options, which through the years had changed from (in order of preference) "a magician, Davy Crockett, a doctor, a priest, and a downhill ski racer."

The mainstay of his boyhood summers was the Milwaukee River. "In the summer we rafted on it, swam in it. In winter we skated on it, sometimes

traveling miles upriver. In the spring and fall my dad took us on long canoe trips, silently sneaking up on deer, heron, and fields of a thousand Canada geese. And almost all year long we fished for bullheads and northerns from the dam."

During the middle of college at UW-Milwaukee, Jim switched his major from biology to art, still not sure where he was going with a degree in art. "I never considered illustration. Other students knew right away what they wanted to do. All I knew was art was one thing I liked to do."

After graduation, LaMarche spent a year in

VISTA (Volunteers in Service to America) working with the United Tribes of North Dakota in Bismarck. It was there he first dabbled in illustration while creating high school curriculum materials, which also involved learning about graphic design, writing and photography. A budding friendship with a teacher's aide named Toni eventually led to marriage and moving to Toni's native state of California.

After working all day as a carpenter's assistant, Jim came home and spent his evenings putting together a portfolio. "I slowly realized it might be possible for me to make a living at art, but I didn't know much of anything." The first person he presented it to told Jim it was the worst portfolio he'd ever seen. "Believe it or not, that first experience motivated me. I signed up for a class on illustration."

LaMarche's first big break came from an assignment with *Runner's Magazine*, but his first children's book was a much bigger thrill. Published by a company in Minneapolis, "My Daddy Don't Go To Work," netted Jim about \$500.

"It was so exciting to see it in print, everything worked out just right," he

Cemetery Cleanup Still an Issue in the Town of Wayne

The Town of Wayne Town Board met Wednesday and discussed monthly agenda items.

The board started off by approving a Certified Survey Map (CSM) for Jim Bartelt who is developing a small subdivision just west of Kohlsville.

The board went on to approve a salary increase for the town maintenance man. The raise reflected a \$1.00 increase per hour making the hourly rate \$10.00. Motion carried with all members in favor of the increase.

Town Chairman Leander Herriges informed the board the new town truck is in and asked to have the town emblem put on. The motion carried.

Jim Engelhardt of Bonestroll, Rosen, Enderlik and Associates made a presentation to the board. The firm is an engineering, architectural and surveying firm who recently opened an office in Mequon.

The board again reviewed the possibility of an anti-nudity ordinance. Town Clerk Orville Kern said he talked to the town's attorney and he advised to leave it alone for a while.

Town supervisor Donald Kurer expressed his view "I think we should nip it in the bud before anything starts. First thing you know something will start up and it will be too late."

Kurer continued asking if a sample copy of the ordinance could be obtained.

Herriges said he would check into what other towns are doing with it.

The board continued with follow-up discussion on the cemetery maintenance issue.

Kurer brought up the idea of a committee.

Herriges stated "I contacted Attorney Kiefer and he stated, you don't have a committee for this. It's strictly town, same as your town roads. It's the town board's job. That's the long and short of it."

Herriges went on to say, "After I got a few phone calls I started checking, I called down to the District Attorney's office. I learned one thing very fast. I don't think there's one person here who can talk to the District Attorney, you have to get your lawyer. So when we were told that they went and talked to the district attorney and had this stop work order, we were flat lied to. I asked, how do we go about doing something? He said, we would have to get a detective to do an investigation."

Herriges continued by saying he then contacted the sheriff's department, where he talked to a lieutenant in the detective department. A detective was assigned and Herriges stated he was questioned by the detective and the District Attorney's secretary.

Herriges asked him (the

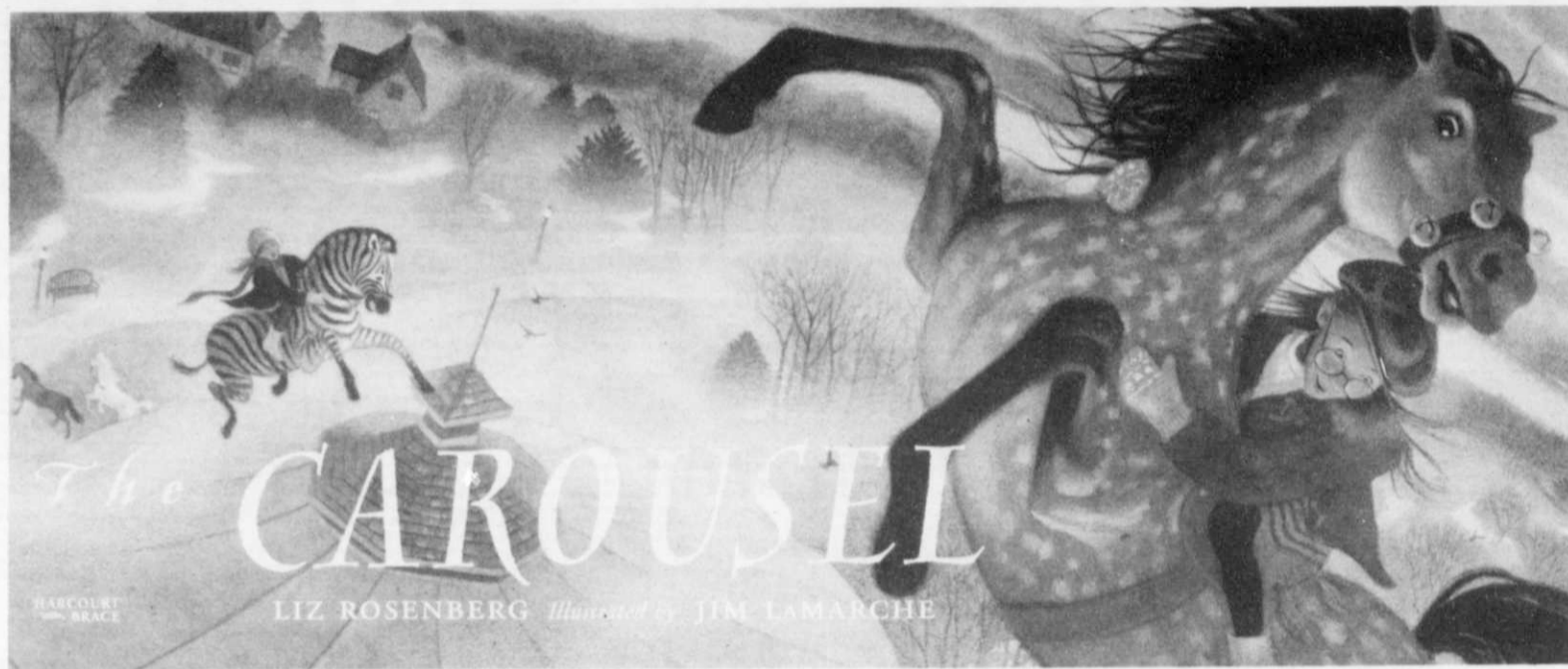

recalls. "I worked very hard on that book and tried to do my best. I still look at it and find things about it I really like."

Several books later, and a 1995 International Book Fair Award from the world famous Bologna, Italy Book Fair, Jim works specifically on one children's book a year, along with his freelance work. His publishers, Lothrop, Lee, and Shepard receive over 5,000 manuscripts a year, but they publish only about 30 of them, and Jim has his pick from what he gets sent.

Responsible for more than just the pictures, LaMarche creates the design, size, layout, and number of pages in each children's book. "This really sets the emotional tone of the book. The painting is the last thing I do." In the process, notebook after notebook fills with layouts, ideas and subject research. "I work closely with the graphics people at the publishing company, they're laying the type. The illustrator works to put together the bones of the book. The finished product should be a

collaboration between the publishing company and the illustrator."

Sometimes being an illustrator even means asking the author to change a piece of the story. That was the case in "Little Oh," an original fairy tale about an Origami girl who comes to life, by Laura Krauss Melmed. "To prepare myself, I researched and learned a lot about Japanese culture. The author had a stork in the story, and I knew it was supposed to be a crane. The symbol of the crane is everywhere in Japan." The bird did get changed, and Jim continues to base much of his work in thorough research, something he's always prided himself in.

His favorites -- *The Rainbabies* and *Walloping Willow Blind*. "There's an illustration in *Walloping I* snuck Kewaskum into," Jim points out. "It's a scene of a boy's room, the boy is in his bunk bed. The room is just a mess and filled with all kinds of junk, known as boy's treasures. Pasted up on the wall among all these treasures is a postcard from Kewaskum. It's a picture of snow and hills and pine trees."

In the award winning,

The Rainbabies, the whole flavor of the book was meant to be English, but Jim promptly changed it into a midwest experience. "My parents have a cottage in northern Wisconsin. If you really look into my work, it's everywhere. Children's books do that, they make you go back to your childhood. You go back to what you know."

Currently, Jim is excited to be working on his own story about a magic raft. "It's about a boy who goes off for a month to live with his grandmother, a no nonsense, tough, assertive woman who has lived on the river all her life. He's a modern boy with nothing to do, so she puts him to work. One night he discovers an ancient raft, and his grandmother shows him how to use it. The raft has all the animals of the river painted on it, and this seems to magically bring these animals to it. It's about an urban boy on the river, and coming closer to the simple things in life." The book will hopefully be out by the fall of 1999.

For Jim, one of the simple things in life is coming back to Kewaskum to visit, with Toni and their three boys, Mario, Jean-Paul and

Dominic. Although their home in Santa Cruz is only a few blocks from the ocean, it doesn't equal the same feelings the river provides as Jim walks the length of town in early morning. "Buildings and businesses have changed, yet others have remained exactly the same. It's a wonderful time for me."

Town of Kewaskum Meets with Village

The Town of Kewaskum started out their meeting with a presentation by Kewaskum Village Board President, Robert Wagner and Assistant Fire Chief, Mark Herriges.

The two came before the town board in hopes that the village and town board could work together in order to improve the appearance of a property on an "island" of the town within the village limits.

The property, 8898 STH 45 is owned by Carl Johnson of West Bend.

The building houses Genova Auto owned by John Genova.

Wagner presented the board first with photos showing the disarray of vehicles and vehicle parts. His main concern is the appearance of this particular property and the first impression it makes to newcomers into the village.

What prompted the recent urgency to solve the problem was a fire call the Kewaskum Fire Department responded to about three weeks ago.

Assistant Fire Chief Herriges addressed his concerns the fire his department responded to. He stated "by the time we were able to get to that car we had three cars burning." He continued, "there's probably 10 to 15 cars back there that belong in a junk yard. They're actually taking cars apart and salvaging parts. I believe you need a salvage license for that."

Town Chairman, Scott Sager introduced Zoning Administrator, Gordon Hoffmann who informed everyone that Genova and Johnson each received a notice of noncompliance and orders to correct. This informed each party of the codes that were being violated. Both parties are

required to take action by September 11, 1998 or they will be issued a Wisconsin Uniform Municipal Citation.

Hoffmann also informed the Wisconsin Department of Natural Resources Waste Management. They will in turn be making an inspection of the premises.

Hoffmann said he had received a fax from Johnson's attorney, William Hickmann, which stated that the lease on the building was for a used car lot, not a junk yard or waste recycling facility.

Wagner stated, "I think we have a good start."

The board then moved into a meeting of the Plan Commission.

The Plan Commission opened with an appearance by Byron Dei regarding a land division in section 14.

Mark Heinecke made an appearance regarding a land division in section 12.

There was discussion regarding the purchase of property in section 13 to construct a one-family dwelling by Richard and Sandy Schultz.

In town business, the board reviewed correspondence and discussed Census Committee 2000.

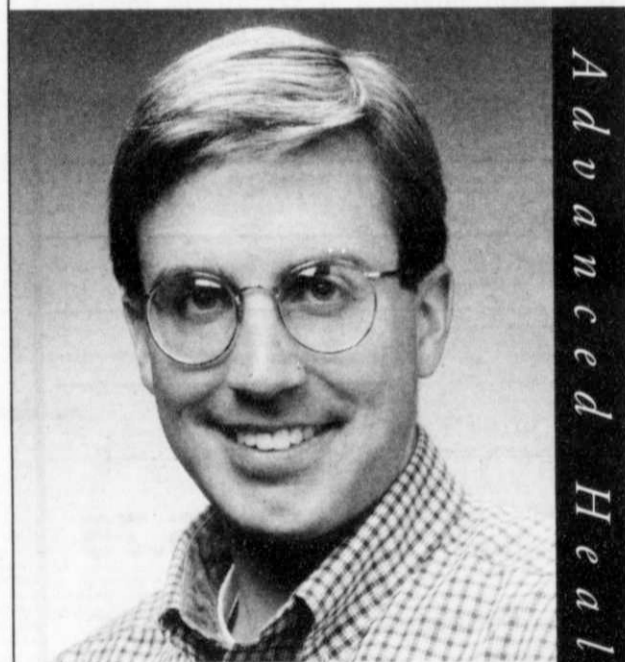

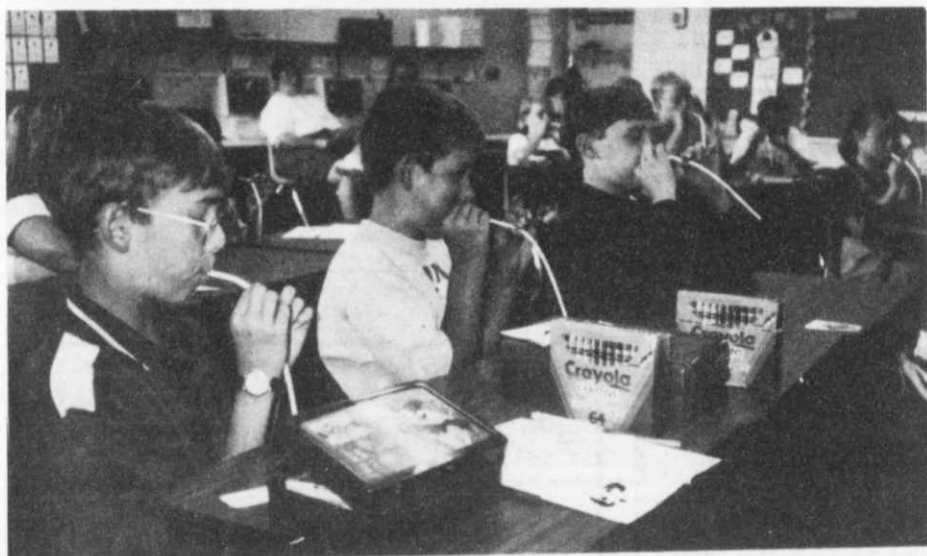

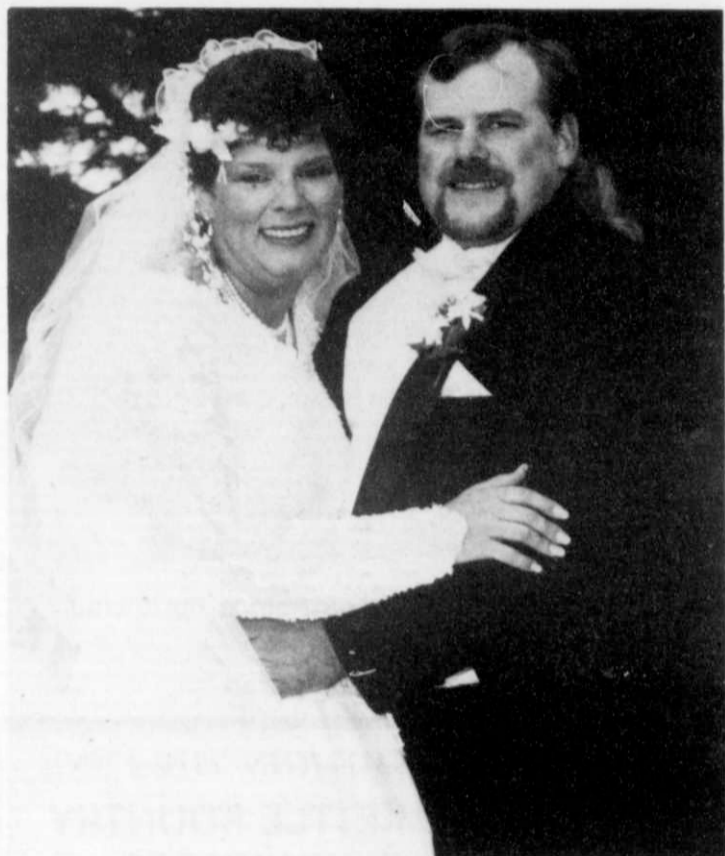

A representative of the Washington County Sheriff's Department stated the matter is considered a civil matter in which the town board is to be handling.

Kurer said, "There were a lot of concerned citizens about what happened."

After more discussion Kurer said, "The point is what are we going to do now? Are you going to ask for volunteers, the town board or are we going to hire somebody?"

Herriges stated "We'll hire somebody!"

Kurer asked, "Who are you going to hire?"

Herriges answered "We had two guys hired. I don't know if they'll come back the way they were cut down in the paper."

Kern raised a concern with liability with volunteers.

Supervisor, Leonard Peter added "What I can't figure out is why all these years no one said a word. As soon as Leander got guys to start in, all hell broke loose."

Kurer stated he thought they should stop arguing and just get the job done. He also said he thought maybe town resident Edgar Miske should supervise whatever work is done since he had experience with cleaning up cemeteries in the past.

Herriges said it was unnecessary. They discussed the item in length and it was decided to hire the town's maintenance men to finish the job.

Also it was decided to pay Kohlsville Carpet Cleaning to clean the carpet in the town hall.

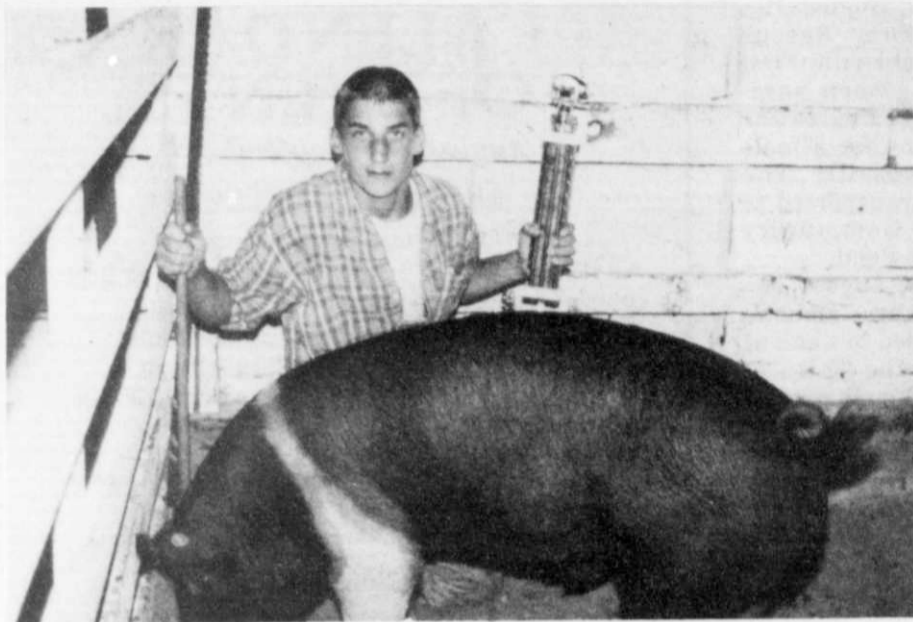

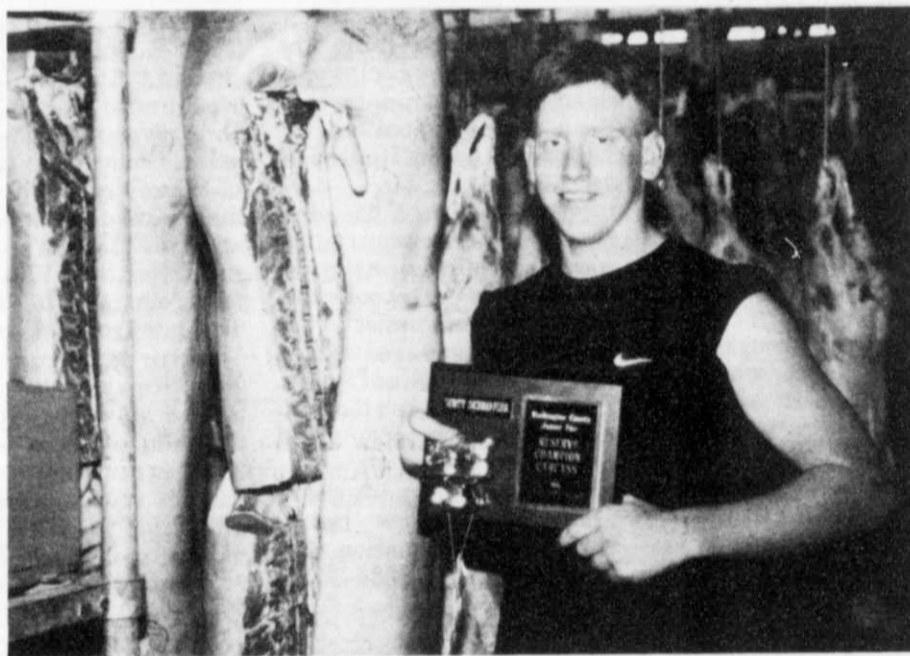

Mueller's magnificent machine features a massive 1480cc Sportster engine, mounted in a 1990 Suzuki RM250 frame. The Suzuki frame, of course, has been heavily modified to accept the big Harley powerplant and lengthened substantially as most all "real" hillclimbers are.

The suspension has also been heavily modified to handle the heavy Harley motor, and absorb the tremendous shock of landing from high-flying jumps. Kickstarting is totally out of the question, so starting the

big engine is accomplished with a remote starting unit powered by a car battery. The machine is an exceptional example of craftsmanship, machinery and mechanical expertise -- and beautiful to look at too! You don't buy one of these off the showroom floor!

Mueller has several sponsors to help him from this area, including Van Beek Cycle of West Bend, Mueller Welding of Kewaskum, and Herriges Machining of Kewaskum. Lloyd sends special thanks along to Horsepower-Louis Lauters, and, of course, is very thankful for the support of his family and friends.

His most memorable experience is, understandably, his 1997 national championship ride, and prefers to ride on the Minnesota hills because of the jumps and speed reached. He lists his hobby as "motor-riding."

Franchitti is Winner at Road America

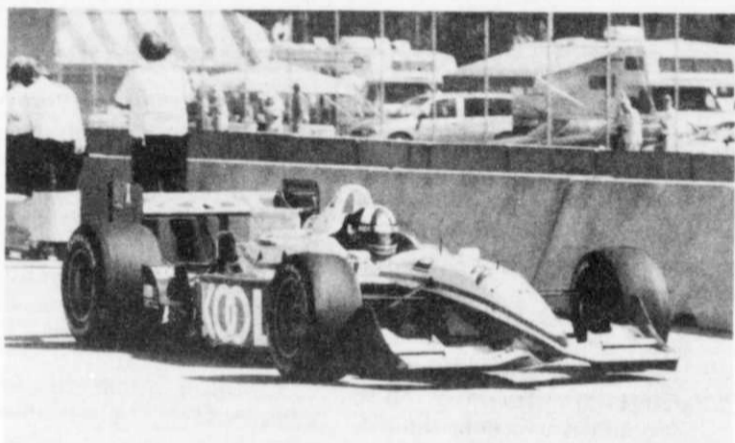
The weekend of August 14, 15 and 16 proved to be eventful for racing fans at Elkhart Lake's Road America. The FedEx Championship race is the 14th of a 19 round CART race schedule. The 4.048 mile road course is one of the most challenging, the longest and the fastest on the circuit. The scheduled race distance is 50 laps (202.4 miles).

Teams participating in the race prepared in advance with many of them testing tires on the track in July. Friday morning CART had practice runs followed by two groups of qualifying for the provisional pole in the afternoon. The temperature ranged from 84 to 85 degrees with a track temperature from 104 to 113 degrees.

Track position can be vital in winning this race, along with good tires. Goodyear and Firestone compete for the most wins. The course offers drivers places for passing along with challenging corners and fast straight-aways. Many factors from the weather conditions, how many pit stops, fuel consumption to the setup of the car can win or lose a race. It is a tactical race filled with strategy.

The practice session was filled with drivers leaving the track. Defending champion at Road America, Alex Zanardi, slid off the track and spun into a tire barrier at Turn 14. He exited the vehicle on his own and was returned to his pit area.

Greg Moore spun off the course at Turn 8, followed almost immediately by his teammate, Patrick Carpentier, in the same corner. Richie Hearn, driving the Budweiser car, spun in the same spot but managed to keep the car running, and continue to the pit area. Christian Fittipaldi and

Mark Blundell reported cut tires on their cars during examination in the pits. The practice session was temporarily stopped while track workers inspected and swept off the track.

The qualifying rounds had several drivers sliding off course and setting record speeds. At 2:39 p.m. the red flag waved as Andre Ribeiro, driving the #3 Marlboro car, made hard contact with the wall going into turn nine. He was transported to the medical trailer by ambulance and treated for a fractured left leg. Doctors determined there was no need for surgery or a cast. The remainder of the weekend racing was left undetermined at this time. He did manage to get in a qualifying lap.

Dario Franchitti ran off course, but managed to stay in control and continue. At 2:57 p.m. he clocked the fastest lap in group one and a new qualifying record.

At 2:58 p.m. Andretti logged the second-fastest lap and a minute later de Ferran recorded another qualifying record for Road America. In group two, Paul Tracy went off course in Turn 14, but managed to keep the car under control and make it back to the pits.

The Valvoline/Cummins driver, Gil de Ferran, won

the provisional pole with his speed of 145.055 mph (1:40.464), a new Road America qualifying lap record. "We had a great day today and I have to say it is largely due to Goodyear," said de Ferran. "Before we went to Mid-Ohio, I came here and had a very successful test. We were able to come up with a good recommendation for this race and thank God, our suspicions proved to be correct. This track requires that you run very little downforce to go fast, and there are some heavy breaking areas, so the car slides around a lot here. It is very, very easy to make a mistake."

Team KOOL Green driver Dario Franchitti finished top qualifier for Firestone and second on the provisional grid by virtue of his lap of 144.801 mph (1:40.640). Franchitti was attempting his third pole in the last four races and his fifth front row start. He is only in his second year in this circuit and his first with the KOOL team.

"On my quick lap, somebody went off in the carousel and kicked up a lot of dirt on the track," said Franchitti. "I took a big slide there and am still second fastest, so I'm happy. I think there's still more there for tomorrow and Sunday. We've won some poles and led some races.

The next step is to win a race and, from there, win a second time and a third time. It's difficult to drive here because you have to run with very little downforce and you have to setup for the fast and slow corners."

KMart/Texaco/Havoline racing legend, Michael Andretti, finished third fastest in the provisional pole. His qualifying lap was with a speed of 144.619 (1:40.767). Andretti holds the record of the most wins, 37, following round 13, the Miller Lite 200. Before going to the Mid-Ohio, Andretti was in Elkhart testing tires. "We tested here and hopefully the good results we are having will continue and help me with race finishes."

Andretti has had some bad luck lately including an unfortunate accident in Mid-Ohio. Alex Zanardi clipped the front wing of J.J. Lehto's car, which landed in the lap of P.J. Jones, who lost control of his car. Michael Andretti's car was launched over Jones' slowing machine and tumbled violently at about 180 mph into a gravel pit.

Andretti was still upset about the incident on his arrival at Elkhart Lake. "I could have been hurt very bad because of a bonehead move like that," he said. He was pretty sore that following Monday, but managed to start working out again on Tuesday in preparation for Road America.

He stated he actually never hit his head or hit anything hard with the car, and it probably looked worse than it actually was. Andretti talked about how,

from in the car, it seemed like he would flip right over the wall. Money well spent on safety equipment and design of these cars was given credit for Andretti's good fortune.

"It seems like all year long I've been in the wrong place at the wrong time," said Andretti. "We had a very quick lap going today, but unfortunately, Al Unser Jr. came out of the pits and he tried to get out of my way but by that time it was too late. I had lost about four-tenths (of a second) on my last lap, which was the difference of the pole. He tried to get out of my way, but I was just a victim of circumstance. It was very disappointing, but we're hoping for a little more tomorrow as the track gets better."

Zanardi was fined by CART, a record high of \$50,000, for the incident, in Mid-Ohio, and another pit row accident where he bumped rookie Helio CastroNeves into the concrete wall. He also was put on probation for the second time in two seasons and stripped of the one point he had earned for finishing in 12th place at Mid-Ohio. CART chief steward, Wally Dallenbach, has emphasized to the drivers the need to cut down on unnecessary risks and has used probation and fines as his favorite tools.

Saturday had drivers out in practice session again in the morning, including Andre Ribeiro. Marlboro Team crew members constructed a special shinguard and installed some

padding in his 98 Mercedes which made it more comfortable in the cockpit.

Under the direction of CART chief orthopedic consultant Dr. Terry Trammel, the crew used aluminum foil to properly shape a mold of Ribeiro's leg. They then used a wire screen, lightweight filler and four layers of carbon filter to protect the outside leg. A lighter, smaller shield was worn to protect the inside of the injured leg. Ribeiro used a special heel rest on the clutch pedal and the crew built him a shelf to keep his foot off the floor of the cockpit. Some left side padding was also installed inside the cockpit area.

"I am thankful to have such a resourceful team," said Ribeiro. "They have really made it possible for me to drive in the race on Sunday. Today, during practice, the leg felt pretty good considering the injury. It's still sore, of course, but with some rest and if I can keep the leg elevated, we should be ready tomorrow." Ribeiro decided to use his qualifying time from Friday for Sunday's race.

Qualifying rounds on Saturday set yet another track record with Michael Andretti, not only winning the pole position, but having the fastest lap yet of 145.323 mph (1:40.279). Andretti won the Marlboro Pole Award for Sunday's Texaco/Havoline 200 with his record lap. It was his first pole since Long Beach in 1995 and his 31st career pole. This moves him into sole possession of the most career poles in CART history, breaking the tie he has been in since 1995 with his father, Mario.

Team Rahal drivers Bryan Herta took second place in the grid position with a speed of 145.628 mph (1:40.069) and Bobby Rahal finished third with a 145.228 mph (1:40.344) lap.

"The Firestone tires were great," said Rahal. "We had excellent grip and cornering which is vital here at Road America."

On Saturday's events Michael Andretti said, "Until this afternoon, it seemed like every time we started to get something going this weekend, we'd

get a red flag, and I'd wonder, 'How am I going to ever catch a break?' But it was a perfect qualifying session. Every lap I had out there was clear and the car was great. This feels as good as a win to me personally because it's been so long. I'd like to thank Goodyear. They've really worked hard to get to this point."

Bryan Herta spun 2-1/2 times and showed up his boss, Bobby Rahal, on the final lap of qualifying. "It was a pretty good day throughout," said Herta. "I can't say enough about the Firestone tires. I hung it all out on the last lap and the tires responded. They were awesome. We made some significant gains yesterday in the car and today was just fine tuning. I knew it was going to be really, really close, so I just threw everything I had at it in that last corner and made it to the light and figured I'd sort it out after that."

During press conference Rahal was asked about how he felt being beat by Herta. "I was pleased I was second and then my teammate dropped me to third. I wasn't so pleased then," he joked. "He has to fix whatever he wrecks," Rahal added with a shrug.

When asked what happens if it is close again in the race, Rahal said, "Bryan is to move over and follow me basically. The policy is may the best man win. Just one thing: don't run into each other, that's the cardinal rule."

Race day on Sunday was blessed with beautiful weather and an estimated 75,000 fans. The total weekend attendance was estimated at 115,000, matching the track's record.

The track at Road America is a favorite of many drivers. Alex Zanardi, of the Target team, said, "Like Mid-Ohio, Elkhart Lake is a place I really enjoy each year. I feel most comfortable on these permanent road courses because of my background."

Bobby Rahal considers the track like home. "I've been going to Road America since I was four. I started going up there with my dad (Michael) when he was racing. We'd walk around the

entire track watching the 500 mile race. If there is one word to describe Road America, it's fabulous. It's four miles of the greatest track in North America... certainly one of the greatest in the world. I don't know anybody who dislikes this place. It just gives a racing driver everything he wants in a race track."

Al Unser Jr. has a star-crossed relationship with Road America. "I love Road America as a track. I love driving it. It demands a lot of respect. Road America has broken my leg; it's broken my heart. It's one of those places I look forward going to because I want to win there."

Michael Andretti also has a deep affection for the track. "Road America is one of the nicest tracks, not only in the country, but also in the world. The track is very challenging to drive. It has everything you could want in a track. There are fast corners, slow corners, a fast straight -- everything a driver could want." The fans at Road America are the most loyal fans I've seen," added Michael. "They have sat through every kind of weather you can imagine. They are there to support the race. They love it! They are true fans."

At 2:27 p.m. the National Anthem was sung by Barb Schmirer. At 2:29 p.m., the command, "Gentlemen, start your engines!" was given by honorary starter, Peter Bijur, Chairman of the Board and CEO of Texaco, Inc. The PPG Pace Car begins to roll the field of 28 cars in two for the first of two pace laps.

At 2:38 p.m., the green flag was waved to start Round 14 of the FedEx Championship series, the 50-lap Texaco/Havoline 200. Firestone engineers reported a temperature of 83 degrees and the track temperature was 114 degrees at the start of the race.

As the race cars made their way around turn two, 12th place Alex Zanardi made contact with the rear of Al Unser Jr., spinning Unser into the gravel pit at turn three. Carpenter also spun into the pit and made contact with Unser. Though both drivers were injured in

the incident, both were withdrawn from the race due to contact. Zanardi was able to continue and move up to seventh place in the event.

In lap two, Castro-Neves car pitted with an exhaust header problem. A brief fire broke out in the rear of the car and he subsequently withdrew from the race. On lap nine, Ribeiro stalled on turn 11 and withdrew with engine problems.

In lap 10, the running order had Herta leading by

.157 seconds over teammate Rahal. Rahal passed as they entered turn one. Herta, in second, made light contact with the rear of Rahal's car as they entered turn five and spun into the wall at the outside of turn five. Four seconds later, Barron made contact with the outside wall and slid into Herta, coming to rest on top of Herta's car. Crews removed Barron's car and fans cheered as Herta climbed out of his car. Both

drivers escaped serious injuries but were withdrawn from the race.

Lap 18 took Moore out of the race when he encountered a gear box problem and lap 20 had Pruett pulling off the course between turns one and two, with engine problems that eventually ended his race.

By the halfway point of the race, the running order had Andretti leading by .898 seconds over Franchitti, de Ferran, Fernandez and Zanardi. The lead continued to change as drivers headed to the pits. By lap 35 Franchitti had a 2.29 second lead followed by de Ferran, Andretti and Zanardi. On lap 37, de Ferran pitted and handing second place to Andretti. de Ferran returned to the race in ninth place.

By lap 40 Franchitti led by 11.858 seconds. On lap 42 Franchitti's crew pulled

off an unofficial 10.7 second pit stop and he retained the lead as he re-entered the race. Fernandez got the Black Flag for a pit road speed violation, and pitted for a drive-through penalty on the next lap, falling from the second to the eighth spot.

Lap 43 removed de Ferran from the race with engine problems. Franchitti held the lead followed by Andretti, Zanardi and Fittipaldi, until lap 49 when Andretti blew a left rear tire as he entered turn five. Andretti made hard contact with the wall, but he exited the car under his own power uninjured, which gave second place to Zanardi. The checkered flag was waved with Franchitti the winner of the Texaco/Havoline 200 by 7.102 seconds over second place Zanardi and third

place Fittipaldi.

On the win, Dario Franchitti, KOOL Reynard Honda, said, "It was very difficult to pass anybody on the track, so I just concentrated on good stops and quick 'out' laps. After the last stop, I saw 'plus-10' on the pit board, and that kind of worried me, because that's exactly what it said in Toronto before I went off. I was slowing it down and being cautious on the last couple of laps cruising it home."

Alex Zanardi's second place finish is his 11th podium in 14 events this season and his 12th consecutive finish that earns PPG Cup points. Christian Fittipaldi's third place finish is his best for the 1998 season.

CART Chief Wally Dallenbach announced following the race that no action would be taken against Zanardi, who is currently on probation and was involved in an opening-lap incident with Al Unser Jr. "After reviewing the tapes and interviewing several drivers, it was apparent that Alex took evasive action to avoid his incident, which was triggered by nose-to-tail contact between the nose of Gil de Ferran and tail of Scott Pruett cars in front of them," Dallenbach said. "Alex's wheels were locked up before the contact. It was deemed a racing accident."

Winner Dario Franchitti claimed his first victory after starting the race in sixth place on the grid, made three pit stops, had his best time in lap 40 at 142.225 mph and led the race 21 of the 50 laps.

Road America, once again, proved to be filled with the thrills of racing, the roaring of engines, excitement of action on the track and the agony of defeat.



The Village Board President Robert Wagner and the entire Board, as well as all in attendance, congratulated the Beautification Award Winners as well as the Woman's Club for leading the project.

David A. Schwengel was present to ask the Board to support the two railroad resolutions that have been placed on the agenda for consideration. Mr. Schwengel explained what was happening to rail service as far as cargo type delivery and passenger service. Several questions were asked by the Village Board and other people in attendance at the meeting. On a motion by Trustee John Kenworthy, seconded by Trustee Gary Gavin and carried by the majority roll call vote the Board suspended the rule to take up the two resolutions pertaining to the railroad under new business. Assistant Fire Chief Mark Herriges presented the June 1998 monthly report:

ORDINANCE NO. 98-5

AN ORDINANCE TO AMENDING CHAPTER 90 TRAFFIC AND VEHICLES

THE VILLAGE BOARD OF THE VILLAGE OF KEWASKUM DO ORDAIN AS FOLLOWS:

THE VILLAGE BOARD OF THE VILLAGE OF KEWASKUM, WISCONSIN WISH TO CREATE/AMEND CHAPTER 90 - TRAFFIC AND VEHICLES AND ORDAIN AS FOLLOWS:

90-220 Regulation of Play Vehicles and In-Line Skates.

- Definitions. (1) "In-line skates" has a meaning set forth in sec. 340.01 (24m), Wis. Stats.
- "Play vehicle" has the meaning set forth in sec 340.01 (43m), Wis. Stats., and does not include bicycles regulated under sec 90-166 of this Chapter.
- Pedestrian Right of Way. Every person riding in or upon a play vehicle or in-line skates on a sidewalk, pedestrian way or mall shall yield the right-of-way to any pedestrian and exercise due care when passing any pedestrian.
- Prohibited Areas for lay Vehicles and In-line Skates. No person shall ride in or upon a play vehicle or in-line skates in the following areas:
 - In addition to prohibited areas under sec. 346.78 and 346.94 (17), Wis. Stats., on the roadways of CTH "H", Third Street, Bilgo Lane, Main Street, Fond du Lac Avenue, Railroad Street, First Street, Second Street, Reigle Drive, Parkview Drive and Riverview Drive, except while crossing a roadway at a crosswalk.
 - On any parking lot owned by the village or on any private property posted by means of a sign or signs prohibiting the riding of play vehicles and in-line skates, unless with the express permission of the owner or occupant in charge of such area.

This Ordinance shall take effect upon passage and publication as provided by law.

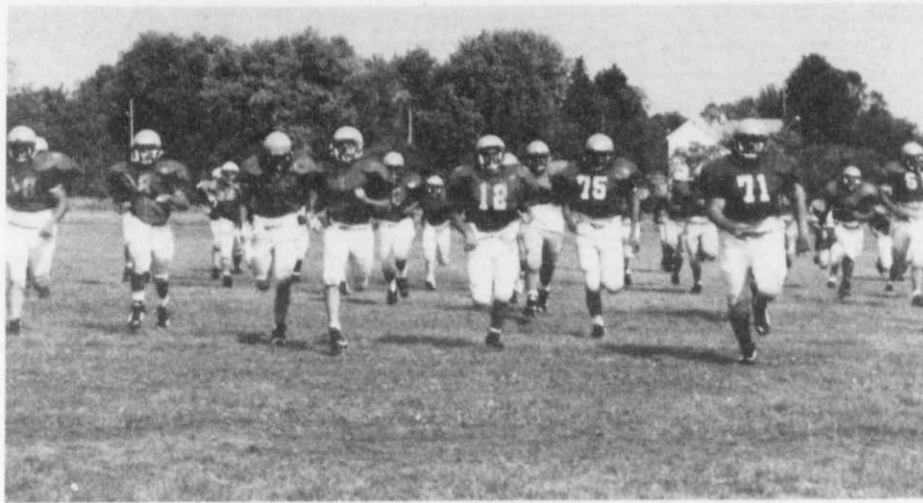

After a record fifty year of equestrian teaching, local horseman and instructor, the Rev. L.C. Riesch, spent this month bidding farewell to his many students of horsemanship.

At this time he glowingly commends a class of adult ladies who have become quite professional in the arts of driving horses hitched to the old fashioned "high wheel carts." As he puts in, "It is more difficult to drive a horse than it is to ride one. And these ladies do a fantastic job both in control of their animals and in their firm, but always gentle manner of handling even the most skittish members of the horse herd."

Riesch's happiest remark was when, with shining eyes he gave thanks to his many student instructor volunteers and the fact that in their fifty years of teaching, there was

never one accident. Again, as he put it, "Horsemanship is a dangerous but wonderful sport. Riders and drivers learn more than just "horsemanship." If willing, they learn a great deal about life, love and thoughtfulness.

A goodly number of his students have been with him for more than twenty years...and as some of them put it, Riesch is a tough instructor but always fair and ready to share his great knowledge of the horse and its ability to teach one how to mature in a most positive manner.

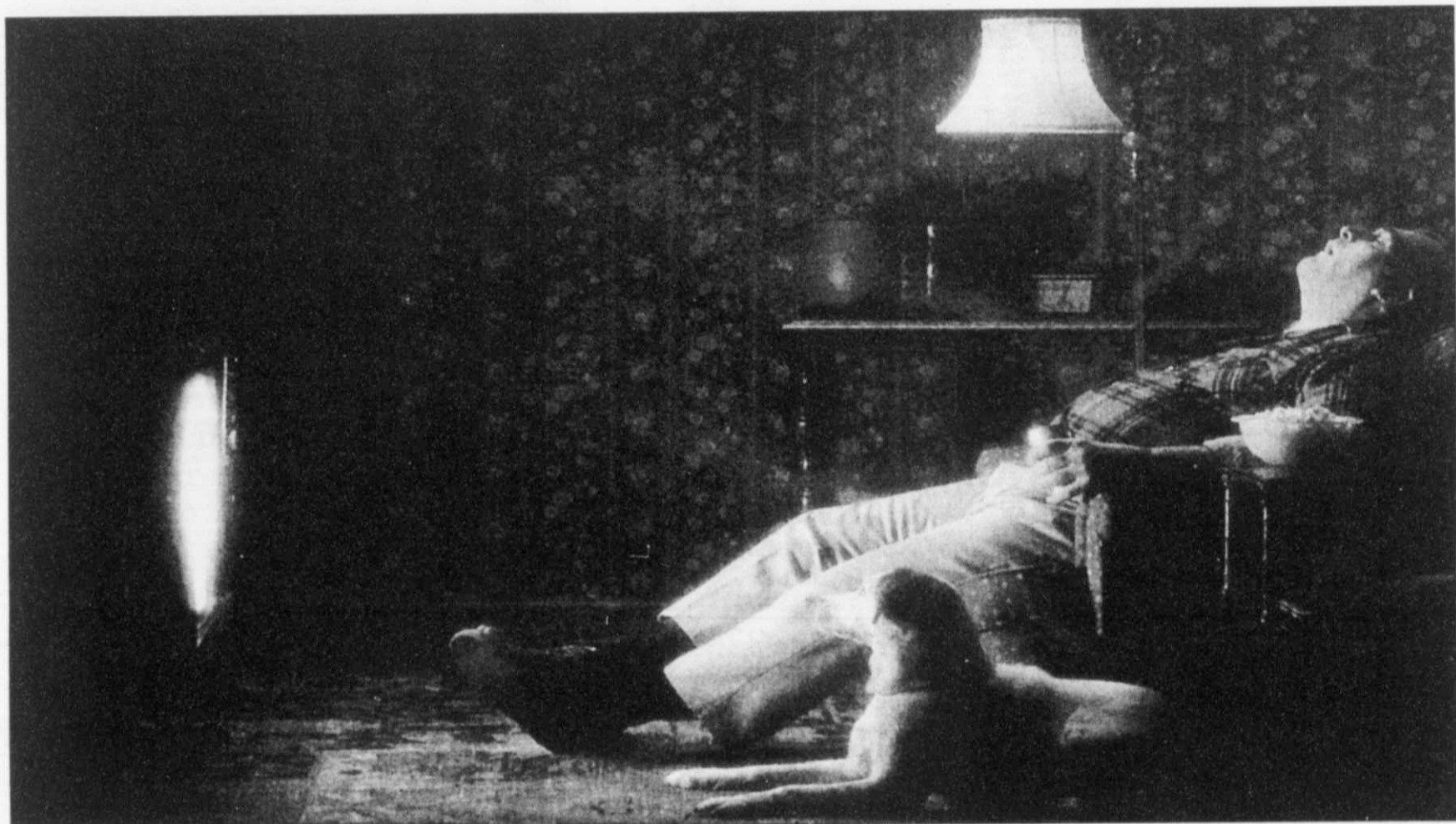
