## Taxpayers to Vote on \$12 Million Dollar Referendum Tuesday

Taxpayers of the Kewaskum School District will be voting on a \$12 million dollar referendum to build, enlarge and update schools on September 8th.

The school board approved the resolution at Monday night's school board meeting with a 6-1 vote. Board member John Schulte opposed the referendum.

The total package includes the proposed construction and remodeling of Wayne and Farmington Elementary Schools and Kewaskum High School, along with the construction of a new elementary school and administrative building within the village of Kewaskum.

The proposed \$7.5 million two-story elementary school building will house approximately 28 rooms and 24,850 square feet for educating pre-school through fifth grade students, 5,250 square feet for special education needs, 27,350 square feet for music, art and an IMC gymnasium, 2,250 square feet for administrative and student services, and 9,550 square feet for auxiliary areas. A flexible, two stage gym would allow space for a cafeteria, media center, and

community usage.

The building would be situated east of the current KES on the district's seven acre parcel, with the front entrance facing Bilgo Lane. Demolition of the old elementary school will cost an additional \$300,000. Plans are also being discussed to reroute bus traffic that is presently causing a congestion problem, with a possible bus lane also located along Bilgo Lane in front of the new school.

Wayne Elementary School would receive a 4,700 square foot addition constructed to also include the two stage gym/media center/cafeteria, improved heating, ventilation, and air conditioning, replacement of existing windows, additional conference and work areas. Cost for the proposed improvements - \$800,000.

Approximately 20,000 square feet would enlarge Farmington Elementary School with a two stage gym, offices, classrooms, storage and guidance areas, and rest rooms. The plan also includes remodeling the existing classrooms, corridor and cafeteria, replacing existing windows, and updating the HVAC. Total cost - \$2 million.

The referendum also

asks for approval of \$1 million worth of renovations of the original structure at Kewaskum High School, replacing corridor ceiling, lighting and floor tile, lockers, and HVAC for areas not air conditioned. Remodeling could also include the Tech-Ed and Agriculture Departments, and a stage addition to the main gym.

New district offices are designed to fit on or near the current KES site after it is demolished. The 4,000 square foot building would accommodate administrative needs. Total cost - \$250,000.

### Badger Road Closed to Thru-Traffic

Construction started on Monday of this week on Badger road in the Town of Kewaskum.

The road will be closed to thru-traffic due until the project is completed.

The completion date is set for the middle of October.

Advance sale tickets will cost \$3 and may be purchased by mailing your check, payable to Kiwanis Club of Kewaskum, P.O. Box 68, Kewaskum, WI 53040. (Advance sale tickets will be honored at two events for children 12 and under). Tickets will cost \$3.50 the day of the Shoot.

Proceeds will benefit area youth activities.

## Washington County Is Awarded DNR Park Grant

The Wisconsin Department of Natural Resources has announced the award of \$450,000 in reimbursement for Washington County's purchase of the Ackerman's Grove park site on 1,550 feet of Little Cedar Lake shoreline in the Town of Polk.

The County Board unanimously approved the purchase earlier this year at a cost of \$1,600,000. Closing on the purchase is expected later this fall. Plans for future development and opening as a public park are still undergoing plans and committee approvals in the County budget process for 1999.

Washington County expresses its appreciation to all those who worked in support of the process including those who responded to surveys and spoke in favor of additional lake access opportunities during public hearings for the County Park and Open Space Plan last year. Appreciation is also extended to the Little Cedar Lake Protection and Rehabilitation District and to the Taxpayers United for Lake Access organization which formally supported the project.

Fall leaves and native flowers fill baskets with vibrant bursts of crimson, orange and gold. Outdoors the walkway is festive with hay bales and woodcarvings of turkeys, geese and grinning Jack-O-Lanterns.

Located in rural Campbellsport along Auburn Ashford Drive, Calico Cabin is situated on the property of Janie and Terry Lang. It's origin is a mystery; the Longs think the historic hand-hewn log building may have moved some time ago to its current location. Once used as a tack room, it now serves as home to Janie's thriving country craft business, filled with a variety of items lovingly handmade by Janie and her mother, Betty Miklavzina.

Open every weekend since Easter, visitors may be greeted by a pet turkey who thinks he's a person, or

Clem the goose, or a happy cocker spaniel. "We have all kinds of critters here, almost as many as crafts," Janie laughs. The Langs purchased the property 2-1/2 years ago, and Janie took advantage of the opportunity to display her growing craft collection in a permanent place.

"My mom and I have always done craft shows on the average of four a year. We always had to fight the rain and weather. At one show it was so bad, we had to throw out some ruined items. It was a lot of work."

It's apparent they enjoy working together. The mother-daughter team was inspired by Betty's first creations, Raggedy Ann dolls that Janie still owns and cherishes. From there it grew to crafts made from patterns, to spin offs of patterns, to one of a kind collectibles. Dear Editor,

Despite the recommendations of three District Administrators and several community committees (two of which I served on), the Beechwood School will remain closed, at a time when we are asked to authorize a \$12 million dol-

lar referendum. The reopening of the school would go a long way to help ease the overcrowding at Farmington. I feel that all the elementary schools are at or near capacity. We currently have about 1900 students district wide. By the year 2007 (nine years from right now) the student population is expected to be at 2400 students. Looking at this \$12 million dollar proposal, I fail to see how it addresses the future needs of the district.

The only part of this plan that makes any sense, is a new KES which is needed. By voting **NO** at this time, however, doesn't mean that a new KES will never be built. It will force the Board to bring back a plan that addresses the needs of the entire district and its students now and in the future.

Questions have to be asked. In the beginning Farmington Elementary was to have a 20,000 square foot addition at a cost of \$1.8 million dollars. Now the architectural firm says "oops" we made a mistake. FES will only get 16,472 square feet of additions at a cost of \$2.25 million dollars. I wonder what else may be cut out of the plans in order to bring this proposal in at the \$12 million dollar cost?

So as we look at this

proposal, it is plain to see, it is a plan with no real vision to the future. **NO** additional classrooms at WES. A net of two rooms at FES and one of those is for storage. A new KES built on the same site with the same safety concerns for all KES students. At the high school where we were told we need more gym space, we are going to lose the very thing we have heard that we need.

Also remember that at the middle school, we are getting close to capacity. You could ease the overcrowding at KMS if we went back to a K-6 system. However, under the current proposal there wouldn't be any room for that. So if you want 27-30 students per class, then vote for this referendum.

The other alternative is to come back to the taxpayers in the near future for more money to expand all of the elementary schools. Turn the high school into the middle school and then fund a new high school at a cost of at least \$23 million dollars plus the cost of land.

To quote some board members, "This is the only plan we feel that we can sell to the residents and that we think the residents will buy." I feel that we can do much better than to nickel and dime the residents of the district every few years.

There is no denying that the school board, the administration, and other devoted parties have worked diligently on the upcoming referendum. There is no denying that there is a dire need for a new elementary school in Kewaskum, updating at Wayne Elementary, Farmington Elementary and Kewaskum High School. New facilities are also needed for administration. There is no denying that the financing for such an endeavor is nominal -- \$32.00 per \$100,000 of assessed property value.

Dear Editor and Kewaskum School District Residents:

After countless hours of discussion by the school board, committees, administration, and district residents, we will be voting on September 8th for an overall building referendum for the Kewaskum schools. Sincere thanks to everyone for their time invested.

There is one strong reason for you to vote yes on September 8th and that would be to address the need for a new KES building.

But because this is an all or nothing package, there are many possible reasons that residents may want to vote no. Some of the reasons to vote no might include:

1. Some taxpayers are wondering why they should spend money to add classrooms at Farmington when there are six empty classrooms in Beechwood. Tax-conscious residents would prefer to utilize the space we already have. Of course, there will always be some who will vote no to any tax increase, regardless of the details.

2. Some people may question the decision to build the new KES on the existing site. There are safety and traffic issues to consider which have only partially been addressed. There are also logistical problems, such as where sports teams

will practice during the construction. I feel the board misinterpreted the results of the failed land referendum and incorrectly concluded that the taxpayers would never let them buy land. If they had presented a plan where taxpayers knew which school building would be built on the land and perhaps selected a more suitable parcel, the outcome could have been dramatically different. I feel we have shortchanged ourselves by deciding to build the new KES on the existing site.

3. Some people, myself included, don't want a larger Farmington school. Educationally, we feel that two smaller schools (BES and FES), with more reasonable class sizes, would enhance children's educational development. The referendum total dollars would not increase, and operating expenses could be absorbed within the current operating budget (from the budget surplus we've had every year). This would create an environment similar to that at the Wayne school. Some people label those of us with this philosophy part of a "special interest group." If truly caring about class sizes, community schools, and improved education is considered a special interest group, then I wish there were more of us.

4. Some people can't figure out how the Wayne school improvements have grown from \$550K in March to \$1,050K now, on a student base of approximately 130 students. Wayne

already has more space per student than the other outlying schools in our district. Wayne currently has 20,000 sq. ft. for about 130 students vs. Farmington's 27,000 sq. ft. for about twice that many students. Is the space there being utilized efficiently?

5. Many people feel there is a need for some type of auditorium within our district. This idea has been kicked around during the last several referendums and again slashed to keep the overall referendum dollars down. Many feel that this district does not support the fine arts to the extent that it supports sports, for example.

6. There is question as to how far into the future this referendum will take us as a district. For instance, although the middle school could technically hold a few more children, it is at capacity from a sound educational standpoint. By virtue of people moving into the district, KMS has the fastest-growing segment of our district. The board will have to be back soon with another referendum to address this along with other issues, like the fact that the Wayne improvements are not adding any additional student capacity.

Attention school board: If the September 8th referendum does not pass, I respectfully suggest that our next referendum isolates the new KES as a separate referendum question (just as Beechwood should have been). Although it is ideal to have one overall

plan, perhaps we may need to prioritize if we feel the need is greater at KES. Then instead of no building taking place in the district, we could possibly get a referendum passed to address one recognized need.

In you do not believe in all aspects of this referendum, then you should vote no on September 8th. Don't hit the panic button and vote yes because you think it's the last chance. This is a decision that is going to affect our children and our grandchildren. The board has been spinning their wheels on this facility planning issue for several years. They have spent much of this time unproductively by going back to their own drawing board instead of utilizing the inputs and conclusions of the two facility planning committees. More unproductive energy was spent making sure that Beechwood School was excluded from the referendum (an item initiated by our school board, not any "special interest group"). If this referendum fails, the board can feasibly rework the building referendum in time for a November referendum. As a matter of fact, the board already has architects' drawings for any of the possibilities mentioned above, and you, as a taxpayer, have already paid for them through architects' fees.

If you are not completely sure that this building package is what you want, then vote accordingly on

September 8th.

"It doesn't take the place of discipline or appropriate consequences for misbehavior," she points out. "Instead, it can empower children to solve their own problems creatively and peacefully."

Along with Ms. Taylor, other KES representatives were Principal Kieth Kriewaldt, LD teacher Ray Martens, and fifth grade teacher Mrs. Bonnie Schultz.

KES applied to participate via a written proposal, and was selected over schools from dozens of other districts. Because KES was

### INFORMATION TO ELECTORS

Upon entering the polling place, an elector shall give his or her name and address before being permitted to vote. Where ballots are distributed to electors, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the elector shall retire alone to a voting booth and cast his or her ballot except that an elector who is a parent or guardian may be accompanied by the elector's minor child or minor ward. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

At the partisan primary the elector may select the party of his or her choice or the ballot containing the names of independent candidates for state and legislative office.

Where paper ballots are used, choose the ballot of the party of your choice and then make a cross (X) in the square next to the candidate's name.

Where lever machines are used, depress the lever of the party of your choice, and then depress the lever next to the candidate's name.

Where a marksense system is used, darken the oval next to the party of your choice, and then darken the oval next to the candidate's name under the party of your choice.

To vote for a person whose name does not appear on the ballot, write in the name of the person of your choice in the space provided for a write-in vote. Where lever machines are used, raise the slide above the office concerned and write in the name of the person and party of your choice on the paper exposed. Where a marksense system is used, write the name of the person of your choice in the space provided for a write-in vote. To write in a name for an office that does not appear on the ballot under the party of your choice, fill in the oval in the write-in section on the ballot, and write in the name of the person. Write-in votes are not permitted on the Independent ballot, or for the office of party committeeman or committeewoman.

In order to qualify for participation in the Wisconsin Election Campaign Fund, a candidate for state office must receive at least 6% of all votes cast on all ballots for the office for which he or she is a candidate, in addition to other requirements.

On referenda questions, where a marksense system is used, fill in the oval next to "yes" if in favor of the question, or next to "no" if opposed to the question.

If an elector spoils a ballot, he or she shall return it to an election inspector who shall issue another ballot in its place, but not more than three ballots shall be issued to any one elector. If the ballot has not been initialed by two inspectors or is defective in any other way, the elector shall return it to the election inspector who shall issue a proper ballot in its place. Not more than five minutes' time shall be allowed inside a voting booth. Unofficial ballots or a memorandum to assist the elector in marking his or her vote may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After casting his or her vote, the elector shall leave the voting booth, properly deposit the ballot, and promptly leave the polling place.

After an official marksense ballot is marked, it shall be inserted in the ballot sleeve provided so the marks do not show. After casting his or her vote, the elector shall leave the booth, insert the ballot in the voting device, and shall leave the polling place promptly.

An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty reading, writing, or understanding English, or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the elector's employer or an agent of that employer or an officer or agent of a labor organization which represents the elector.

Notice is hereby given that a Referendum Election will be held in the School District of Kewaskum, on the 8th day of September, 1998, at which the referendum question set forth in the sample ballot below shall be determined.

**INFORMATION TO ELECTORS**

Upon entering the polling place, an elector shall give his or her name and address before being permitted to vote. Where ballots are distributed to electors, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the elector shall retire alone to a voting machine and cast his or her ballot except that an elector who is a parent or guardian may be accompanied by the elector's minor child or minor ward. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

On the referendum question, where paper ballots or lever machines are used, the elector shall make a cross (X) in the square or depress the lever or button at the right of or depress the lever or button at the right of or depress the button or lever next to "yes" if in favor the question, or the elector shall make a cross (X) in the square or depress the lever or button at the right of or next to "no" if opposed to the question.

On the referendum question, when punch card voting is used, the elector shall make a punch or a hole in the space designated "yes" if in favor the question, or make a punch or a hole in the space designated "no" if opposed to the question.

On the referendum question, where marksense voting is used, the elector shall connect the arrow or fill in the oval next to "yes" if in favor the question, or connect the arrow or filling the oval next to "no" if opposed to the question.

If the elector spoils a ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one elector. If the ballot has not been initialed by two inspectors or is defective in any other way, the elector shall return it to the election official, who shall issue a proper ballot in its place. Not more than five minutes' time shall be allowed inside a voting booth. Unofficial ballots or a memorandum to assist the elector in marking his or her ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official paper ballot is marked, it shall be folded so the inside marks do not show, but so the printed endorsements and inspectors' initials on the outside do show. The elector shall leave the booth, deposit his or her folded ballots in the ballot boxes, or deliver the ballots to an inspector for deposit, and shall leave the polling place promptly.

After an official punch card ballot is marked, it shall be inserted in the envelope provided so the holes or punches do not show. The elector shall leave the booth, deposit the envelope containing his or her ballot in the proper ballot box, or deliver the envelope to an inspector for deposit, and shall leave the polling place promptly.

After marksense ballot is marked, it shall be inserted in the envelope provided so that the marks do not show. The elector shall leave the booth, insert the ballot in the voting device and discard the envelope, and shall leave the polling place.

An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty reading, writing or understanding English or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the elector's employer or an agent of that employer or an officer or agent of a labor organization which represents the elector.

The vote should not be cast in any other manner.

## Minutes of Village Plan Commission

The Plan Commission of the Village of Kewaskum, Washington County, Wisconsin met in the Council Room of the Municipal Building, 204 First Street.

President Robert H. Wagner called the meeting to order. Members present were Frank Beesten, Richard Schmidt, Michael Kimble, Warren Dums, Charles Waala, and Administrator Daniel Schmidt. A quorum was present. Theodore Meilahn asked to be excused and was absent.

The meeting was opened with a Moment of Silence and the Pledge of Allegiance.

On a motion by Richard Schmidt, seconded by Michael Kimble and unanimously carried by voice vote, the Commission approved the minutes as printed for April 28, 1998.

Administrator Daniel S. Schmidt reviewed Section 13, 14, 15 & 16 of the Zoning Ordinance. Several points were brought up for discussion and some of those points need clarification from SEWRPC.

Several points were noted for discussion with SEWRPC:

1. In 13.3 (Changes and Amendments) Petitions, it was suggested that the mailing requirement to those parties living within 200

feet be notified of a public hearing.

2. In the balance of 13 it is noted to have Rick Kania review the flood plain and shoreland requirements of the ordinance.

3. In reference to all fees and permits SEWRPC is to recommend the appropriate adjustments.

4. In Section 15 the definitions as defined in the Land Use Plan should appear in the Zoning Ordinance.

5. Some needed definitions would be for the words, land use, CBRF, PUD, building height, bed & breakfast, and etc.

6. Under the definition of Environmental Control Services, the Commission did not understand.

7. Under Essential Services - fiber optics, cable television, satellite dishes and the like should be included.

8. Elimination of Mobile Home from code but not from definitions so as not to allow for the placement of one.

9. Machine Shop - check noise as how it may apply to computerized equipment.

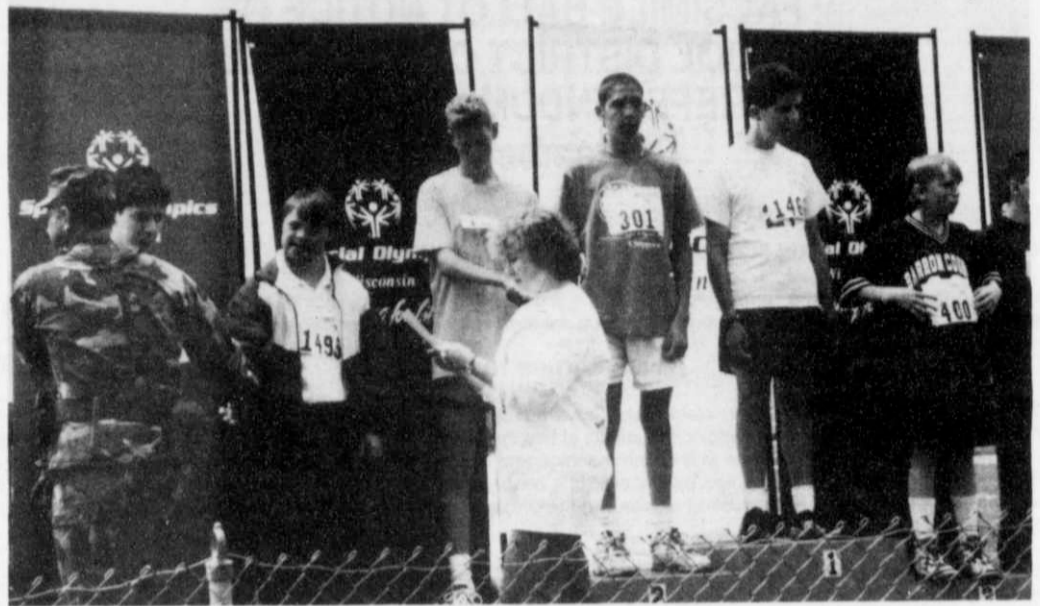
10. Under Signs include event type signs, etc.

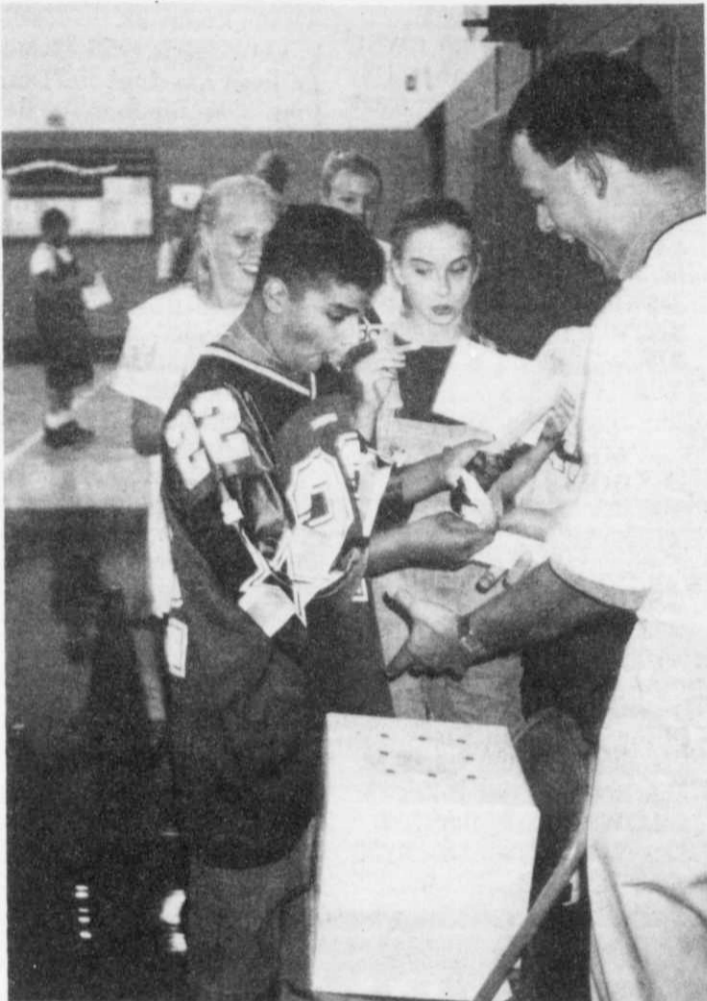

(PLYMOUTH, WI) Tim Melis of Plymouth rolled to his third 30 lap Winged Super Modified victory of the season during the Eastern Wisconsin Stock Car racing program at Sheboygan County Fair Park Saturday night.

Melis, who started on the outside of the front row, out-powered polesitter Dennis Klumb of Grafton to take the top spot in turn two of the opening lap. The first caution flag flew on lap 2 when Cascade's Barry Maas stopped in turn two.

When the race returned to green flag action, Melis darted out to a large half-straight away cushion over fourth starter Brad Dahmer of Sheboygan on the lightning fast one-third mile clay oval track. On lap 15, the second yellow flag appeared when Paul Pokorski of West Bend and Greg Otte of Sheboygan Falls made contact along the frontstretch sending Otte on a series of slow rolls.

After the restart, current

point leader Billy Kruetz of Kiel came in from the third starting slot to power his way past Dahmer into second place on lap 17. The high riding Kruetz then began to slowly reel in Melis over the next eight laps before the third yellow was displayed for the stalled car of Kiel's Dave Enders in turn two lap 25.

Melis bolted out to a solid lead in the final five laps as Kruetz began to slow slightly along the high groove. The 15th year driver stayed glued to the ultra tacky inside lane during the closing laps en route to his 11th career EWSC Winged Super Modified feature victory.

Kruetz solidified his claim to his first ever EWSC Winged Super Modified track championship with a strong second place showing, Dahmer was third, Klumb placed a season best fourth and Plymouth's Tim McMullen rounded out the top five.

Kruetz's closest competitor in the points race, three-time and defending track champion Pete Ostrowski of Milwaukee,

saw his title hopes slip farther away when he dropped out of the feature event on lap 16 with a broken rear end.

The Kiel driver now holds a 69 point lead (1015-946) over Tim Melis going into the End-of-Season championship night of racing on Saturday, September 12. Ostrowski's mechanical problems in the feature event dropped him to third place in the point standings with 945 points.

Chad Kistner of Kiel picked up his first career feature triumph in the 25 lap Limited Late Model main event.

Brian Gilles of Plymouth racked up his first 20 lap feature victory of the season on the way to an extremely rare clean sweep in the Super Stock division.

In other action, Pete Ostrowski won the 15 lap Winged Super Modified semi-feature. Dennis Konitzer of Sheboygan was victorious in the 15 lap Limited Late Model semi-feature. Sheboygan's Matt Jackson captured the 15 lap Super Stock semi-feature and Dan Holm of Waldo won the 6 lap super Stock consol-

ation race. John Scharenbroch and Shelby Hellmer each posted victories in the special Limited Late Model Mechanic's heat races.

There will be no EWSC races over the Labor Day weekend. All three track champions will be crowned when the 1998 EWSC season comes to a close on Saturday, September 12 with the annual End-of-Season Championships. Spectator gates open at 5 p.m. with time trials at 6 p.m. and racing at 7 p.m.

## Indians Lose 'Badger Classic' to Cougars

It turned out to be a great day to be in Madison for the Badger Classic football game but the outcome of the game was not what Coach Perry Koth had been hoping for.

With a very strong showing in last week's scrimmage against West Bend East and West, the Indians were hoping for a strong running game combined with a strong defense. They got the strong defensive game they expected but the running game was nowhere to be found as the Campbell-sport Cougars squeaked out a 9-6 victory.

The Cougars opened the scoring with a 20 yard field goal by Matt Millionig that barely made it over the crossbar with 1:22 left in the first quarter for a 3-0 lead. The Cougars had 95 of their 106 yards rushing in the first quarter before the Indian defense shut down the running attack for the remainder of the game.

Sophomore linebacker Bob Ogi led the defense with 18 tackles, the next closest player was Aaron Seiser with eight tackles. "Bob was all over the field," stated Coach Koth, adding, "He had an outstanding game for us."

The Indians got on the board midway through the second quarter on a 21 yard field goal by Junior Chris Koth to tie the score at 3-3. He then followed with an impressive kickoff as he booted the ball 65 yards into the endzone for a touchback. Koth added a 27 yard fieldgoal with 23 seconds left in the half to give the Indians a 6-3 halftime lead.

Because the running game was struggling (minus four yards in the first half), Koth went quickly to the passing game which produced a number of big gains for the Indians.

Quarterback Josh Gaffke connected with junior Jason Strobel on passes of 22, 37 and 27 yards in the first

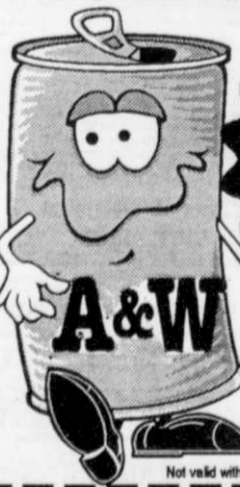
