First Visioning Workshop Develops Many Innovative Goals for Community

Thirty-five enthusiastic area residents gathered Saturday, November 7 in the firehouse meeting room for Kewaskum's first visioning workshop.

Vern Jung, a member of the Economic Development Advisory Committee welcomed participants to the workshop hosted by the Village of Kewaskum.

He was followed by facilitator Dan Wilson of the University of Wisconsin-Washington County Extension. Wilson proceeded to give a brief summary of the recent village survey and explained the process of what the day's visioning workshop would entail.

Wilson was assisted by Randy Tetzlaff, Ozaukee County UW Extension Agent.

Attendees then broke down into small groups of seven and eight and were then facilitated by Vern Jung, Mike Kimble, Jim Reigle, Joyce Kral and Lana Kuehl, members of the Economic Development Advisory Committee. The committee is chaired by Jeff

Butler and also includes Village President Robert Wagner, and Village Administrator Dan Schmidt, who advises.

The individual groups then identified pertinent issues to the community by briefly responding to the statement: "It is the year 2010. In short specific phrases, describe what the Village of Kewaskum/area will be recognized for, why you will want to live here, what you value about the community, and what is happening to make it an even better place."

Following the 45 minute brainstorming session, participants re-gathered into one large group to decide on which issues that they came up with should take priority.

The group determined the following issues should be addressed as the community approaches the 21st century:

1) Careful planning and zoning of growth; a balance of organized residential, industrial and community development; encourage controlled growth.

2) More diverse retail business.

3) Improve schools and school buildings; improve educational standards and facilities.

4) Improve transportation and access to the community.

5) Encourage year-round recreational facilities; provide more and better recreational opportunities for residents; support a place for young and old to "hang out."

6) Strengthen business by encouraging independent business owners; establish guidelines for business-industrial areas; style/design review.

7) Represent a forest community; expand motto "Gateway to the Kettle Moraine."

8) Improve entrance to village.

Following the lunch break, the visioning volunteers formed smaller groups again to create a goal statement and action planning on the top priority issues. The plan included identifying community assets already possibly addressing the issue. The groups also determined objectives, steps, resources needed,

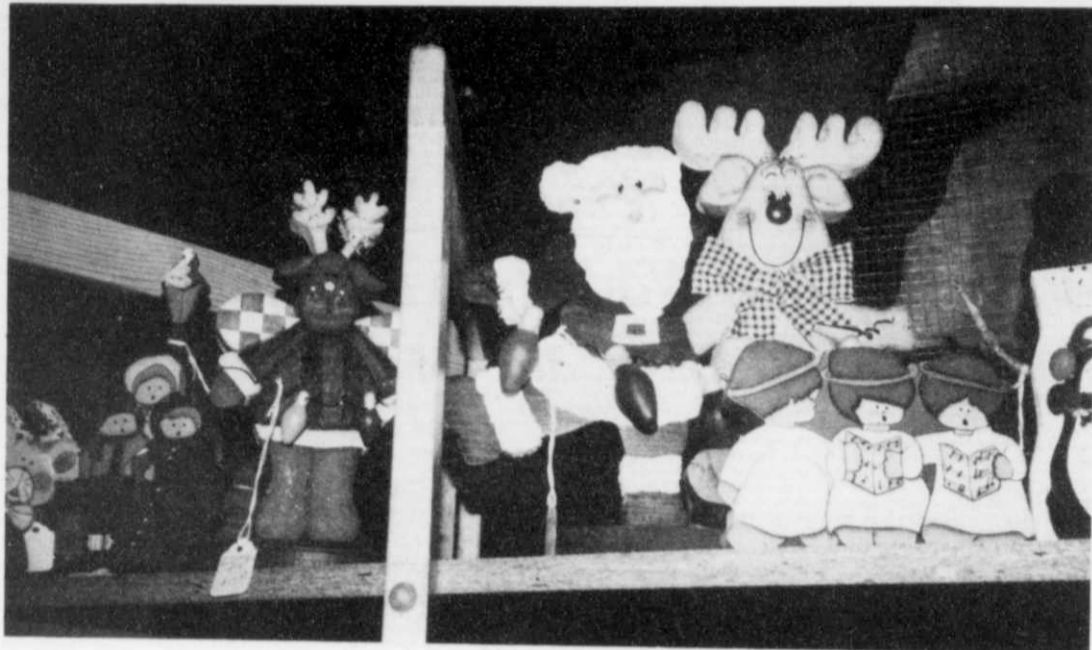

\$2 Million Fund Drive Underway for Cancer Care Center at St. Joseph's Hospital

A fund drive to raise \$2 million in donations for the new Cancer Care Center at St. Joseph's Community Hospital is drawing support. Launched in mid-October, the drive has received more than \$300,000 in donations to date, and organizers hope to reach the \$2 million goal by the end of the year.

The goal amount mirrors a \$2 million gift from an anonymous donor received by the hospital in July for the Cancer Care Center. The hospital's board of directors has invited the public to match that generous contribution.

"We're very pleased that many contributors feel the Cancer Care Center is truly an important addition to health care services in our area. Some have shared their own experiences with cancer and how it has affected the lives of their families or friends," said Greg Burns, executive director of St. Joseph's Community Hospital.

Co-chairing the Cancer Care Center Fund Drive are Tom Bast, chairman of the board and CEO of M&I First National Bank; John Dedrick, president of West Bend Mutual Insurance Company; Atty. Elaine Shanebrook, of Shanebrook Law Office; and Sharon Ziegler, past president of the hospital's volunteer organization, Partners, who is active in numerous civic and arts organizations.

"We hope that everyone

who is contacted, or who learns about development of the Cancer Care Center, will choose to contribute and help us to reach our goal. The funds are important because they help to build the facility. But they also symbolize a gift of hope from the people who give, to the people who ultimately will be served by the Cancer Care Center," said Burns.

The Cancer Care Center will be an estimated 20,000 square foot facility connected to the hospital, with its own parking and covered entrance. It will be built on the southeast portion of the hospital campus, at the corner of Oak Street and Ridge Road.

The center will make it possible for cancer patients requiring radiation therapy to receive that therapy in the familiar surroundings of their own community hospital, instead of traveling outside the area. Radiation therapy will be provided by a linear accelerator that delivers high-energy radiation to tumors to destroy the cancer cells. The linear accelerator itself represents approximately \$1.2 million of the center's approximately \$4 million cost.

In addition, the center will be linked to hospital support services like nutrition counseling and social services, and will enable medical oncologists and radiation oncologists to work together to plan combined modality treatment for their patients.

There will also be office space in the same building for medical oncologists and oncology nurses.

The fund drive is being conducted through special mailings and personal solicitation by a core of volunteers, as well as general information to the public. 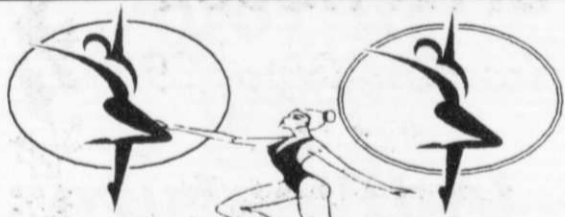

History was made Monday evening when only three village trustees were present at the bi-monthly meeting.

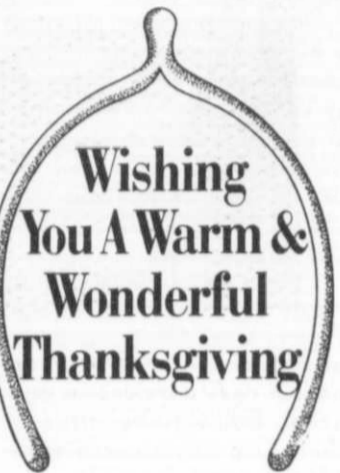
The board was to address a public hearing regarding a zoning change from LB Entrepreneurs LLC. The change would be from B-2 general business district to R-1 single-family residence district. This change would have resulted in a 94 home subdivision on the former Spoerl property on CTH H west.

Administrator Daniel Schmidt presided and apologized to an audience of over 10 residents that the board could not take action on any agenda items because a quorum was not present.

He further explained that President Robert Wagner was excused due to complications

following surgery; Trustee John Kenworthy was out of state for a funeral; Trustee Harry Roecker was out of state on business and Trustee Andy Pesch was also absent.

The public hearing has now been rescheduled for December 7th at 8:00 p.m.

who would be responsible and a time frame.

An hour later, the participants reconvened into the larger group and one respondent from each group reported on their individual action plans.

The goal of one group studying transportation issues was to improve transportation to and within the community. Their objectives included determining locations and times of the problem traffic flow and the reasons for the problem, or possible high traffic time change. They also explored the safety issue, alternative transportation for commuters, additional traffic route through or around the village, the parking issue, more and better signage and the addition of bike and walking trails. It is hoped their research will be ongoing.

Steps of action for this group included a joint meeting of school, village, police, business, and chamber of commerce officials and to have police direct traffic at heavy traffic times.

A second group addressed the goal to improve schools and school facilities. Their objectives were to have more community involvement in improving the schools; educate the public about the needs of the schools; locate, plan and

maintain new facilities; improve existing facilities and improve recreational opportunities through community/school cooperation.

One of their steps of action was to match a student organization to a community organization and to develop interest between adults and students. They would like to see action by the spring of 1999 with additional action being taken in the fall of 1999.

The goal of another group was to expand, promote, and strengthen new and existing retail business. Their objectives included the development of an industrial park; the support and retention of existing businesses, and develop new business opportunities. It was felt that with the addition of a small industrial park, many new retail businesses would follow.

Their plan of action included finding an appropriate site for the industrial park and the study of funding for the purchase of land, and land improvements for the same. Research on financial incentives was advised as well as a feasibility study. They would like to see their goal accomplished by the years 2000/2001.

A group addressed the goal of creating a plan for controlled and balanced growth. Their objectives were to complete a zoning plan, to decide what type of growth is wanted and needed, develop a marketing

plan and to monitor this plan.

Their steps of action included a review of the village land use plan; coordinate a zoning plan with the above stated objectives and the consideration of the hiring of a consultant.

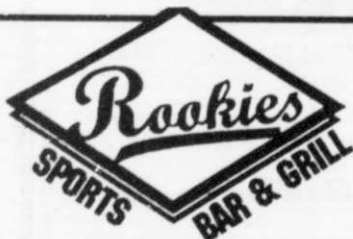
A group converged to establish Kewaskum as the Gateway to the Kettle Moraine. The objectives of this goal was to inventory existing resources; develop a marketing plan; establish and improve the physical linkage between the village and its surroundings; and to develop plans to have Kewaskum blend more closely into the Kettle Moraine.

This group came up with many plans to establish their goals quickly. Their thought process included partnering; promoting the benefits of the community environment, and quality of life; Internet site development; completing the Ice Age Trail and bringing it into the village; establish a good working relationship with private landowners; preserve open space; and develop an urban forestry program, among many other innovative ideas.

Another goal addressed was to establish guidelines for residential, business and industrial areas in regards to style and review. Their plans featured focusing on lot sizes; establishing architectural signature; imple-

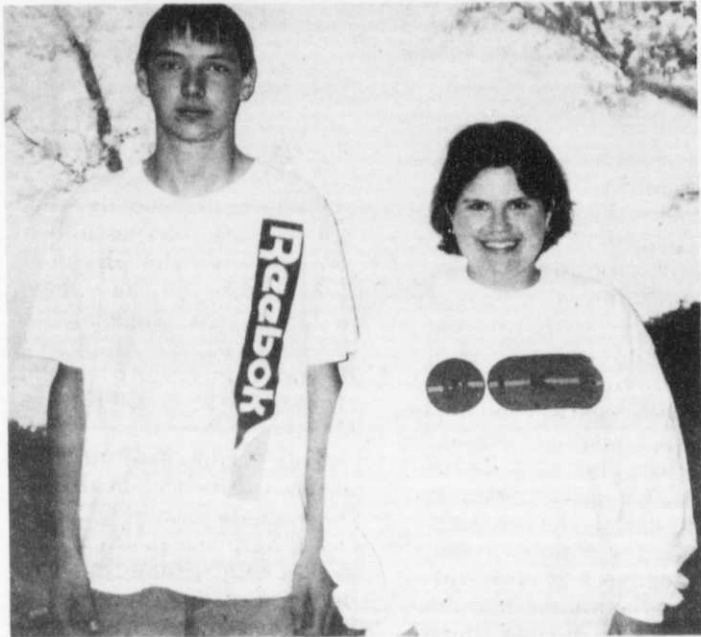

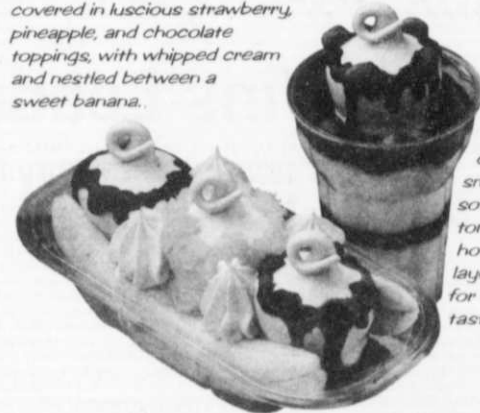

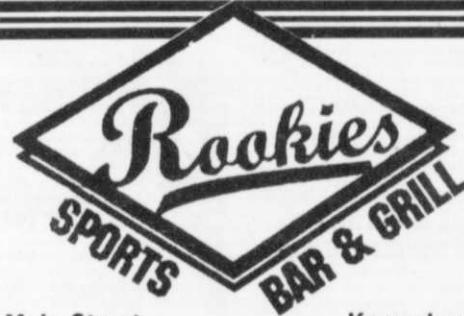

Grothman Wins Leadership Post

**A Washington County First:
Area Legislator to Serve as Majority Vice Chairman**

MADISON -- State Representative Glenn Grothman (R-West Bend) won election this week to the leadership team of the 1999-2000 Wisconsin State Assembly. Republicans hold a 55-44 advantage in the State Assembly.

Grothman was elected caucus vice-chairman, defeating Representative David Ward (R-Fort Atkinson) and Rep. Joe Handrick (R-Eagle River) for the post.

The caucus vice chair will be in charge of orientation for the ten new Republican legislators, assisting in chairing party caucuses, and will allow him to participate in leadership determining the legislative agenda.

"I am truly honored that my colleagues elected me to this post, particularly over two such well-qualified and hard-working candidates," Grothman said. "I am looking forward to influencing the legislative agenda before bills get to the floor."

Grothman was nominated by Rep. Carol Owens (R-Oshkosh) and Rep. Scott Gunderson (R-Waterford) who commented on Groth-

man's independent streak and described him as the leader of the conservatives.

Upon researching past leadership elections, the Legislative Reference Bureau was unable to find any other Washington County legislators who had been elected to Leadership since 1940 before which records were incomplete.

Representative Bonnie

Ladwig (R-Caledonia), the Assembly's Assistant Majority Leader stated, "Glenn worked very hard for the Republican team. That and his outspokenness were the reasons he won. He will be a tremendous asset to our leadership team."

Grothman recently won re-election to the Legislature for the two year term starting in January of 1999.

WINTER PARKING

The Winter Parking Restrictions and Snow Emergency Parking Restrictions go into effect at mid-night (12:00 a.m.) on December 1, 1998.

Municipal Code Section 7.04(3) Night Parking Restrictions, reads as follows: Signs have been erected at or reasonably near the corporate limits as provided in Section 349.13, Wisconsin Statutes, no person excepting physicians or licensed emergency vehicles on emergency calls, shall park or stop any vehicle on any public street or highway within the village between the hours of 2:00 A.M. and 6:00 A.M. from December 1, to April 1, of each year; provided that, notwithstanding such restrictions vehicles may be parked a period of time not longer than 3 minutes for actually loading or unloading of passengers, and provided further that no other regulation restricting parking as to place, time, or manner violated thereby.

The fine for violating the ordinance is:

\$5.00 if paid within three (3) days of the issuance of the parking citation.

\$10.00 if paid after ten (10) days but before 28 days.

After 28 days, the amount is \$25.00 and a notice will be sent to the Motor Vehicle Department to suspend any and all vehicle registrations held by the owner and refuse renewals of the same until the citation is satisfied.

An important fact is the owner of the vehicle is responsible for the payment of the citation whether or not he or she was the operator.

Municipal Code Section 7.04 (4) Removal of Illegally Parked Vehicles. This section covers the issuance of citations to and possible removal of such vehicles in violation of this ordinance. In addition to other penalties provided by Section 7.04(6) of this code, the owner or operator of a vehicle so removed shall pay the cost of the towing and storage.

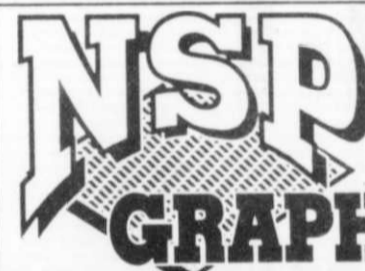

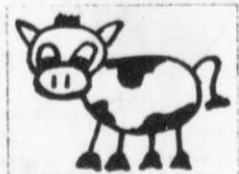

menting an urban landscape plan; establishing a design/review board; signage, and the enforcement of existing ordinances.

They felt to reach their goals they had to establish diverse lot sizes within subdivisions and define what they felt the community should look like, among other steps. They also set a time line of most goals being met by the year 2000/2001.

A very important goal undertaken by one group seemed to be prevalent among all who attended, that being to improve the entrances to Kewaskum. Everyone was in agreement that the first impression visitors get when they approach the village is lasting and of utmost importance.

The objectives of this group were to improve visual appearance; improve the welcome signs at village entrances; landscape and design all entrances; focus on east entrance, and check into lighting on entrance signs.

Their plan of action was to meet with town and village officials to coordinate ideas and to identify the direction to take to improve the appearance and to contact civic organizations for donations and ideas. Maintenance and future planning could be handled by a group of volunteers.

Last but not least, another group handled the development of recreational facilities as their goal. To achieve their goal, they decided a community/recreation center would be a welcome addition to the community. The center would be a multi-purpose facility with meeting rooms and a teen/senior citizen center with the possible inclusion of an aquatic center/sports complex.

To accomplish this objective, the group would like to form a plan committee to research fund raising ideas, find a site location and develop media awareness. As part of this objective, they would like to form the Kewaskum Recreation Department to oversee the undertaking of this and additional recreational opportunities.

This group would also like to see the development of more outdoor trails and the possibility of a recreational river walk along the Milwaukee River into the Kettle Moraine. Their plans of action on this objective include securing maps of existing trails and contacting Kettle Moraine Forest personnel, the DNR and the Milwaukee River Watershed Program on the development of the river walk. They also supported the idea of bridge construction across the river on the north end of town.

Many good ideas were formulated by these industrious, enthusiastic participants. One thing they all

had in common was their love of this area. Collectively they all want this to be the very best community it can possibly be. All seemed genuinely interested in following through with the goals that were set and expressed a desire to meet annually to address achievements and set new goals.

'Buck Fever' Can Be Dangerous to Heart

Deer hunters, beware. The excitement of "buck fever" combined with strenuous hunting activities and heart disease risk factors can put a hunter in less than prime condition at risk for heart attack.

Studies show that just sighting a deer can send a hunter's heart rate soaring. And the common practice of dragging a dead deer, often for long distances, can be exceptionally stressful on the heart, according to the American Heart Association.

Suddenly becoming very active when you have been fairly sedentary can be dangerous to your heart, partic-

ularly if you have coronary artery disease -- deposits of cholesterol in vessels leading to the heart.

Sudden activity is a danger similar to that faced by people who suddenly begin shoveling snow when they haven't exercised in some time. A Michigan-based study in 1996 found that hunters dragging a deer increased their heart rates as much as 116% of their maximum heart rates.

Besides the excitement and demanding physical activity associated with deer hunting, other stresses are involved. These include environmental factors such as cold weather and hilly terrain and such social factors as smoking, heavy drinking and overindulgence in a high-fat diet.

The American Heart Association offers the following recommendations for prospective hunters:

* Weeks before you hunt,

raise your fitness level through regular brisk walking or other aerobic exercise.

* If you have high blood pressure, high cholesterol or other risk factors such as smoking, check with your doctor before hunting.

* Don't eat a heavy meal before hunting. Don't drink the day before hunting. If you smoke -- which the American Heart Association strongly opposes -- don't do it the day before hunting.

* Never drag a deer if you have coronary artery disease.

* If you experience any warning signs of a heart attack -- dizziness, chest pain or pressure -- stop what you're doing and get immediate medical help.

Gessners, Klumbs Honored As Quality Milk Producers

BARABOO -- Area dairy farmers were among 1,420 being honored by Foremost Farms USA for producing quality milk during calendar year 1997.

The cooperative presented two different levels of awards to local producer-owners throughout Illinois, Indiana, Iowa, Michigan, Minnesota and Wisconsin. The award levels were based on the average somatic cell count (SCC) of the milk marketed by producers from January 1 - December 31, 1997.

The SCC level in milk is one measure of its freshness and wholesomeness. It also indicates the sound herd management decisions made by producers in their operations. Milk with a lower SCC yields more cheese when processed and it has a longer shelf life when packaged for fluid use by consumers.

When milk meets specific criteria, Foremost Farms USA members earn extra money in quality premiums

paid in their milk checks.

"Superior Quality" awards were presented to 86 producers whose milk averaged below 100,000 SCC. "Excellent Quality" awards were presented to 1,334 producers whose milk averaged between 101,000 and 250,000 SCC.

Byron and Sharon Gessner of Kewaskum and Edward and Harvey Klumb of West Bend, were honored by Foremost Farms USA with an "Excellent Quality" award for the production of quality milk during the cooperative's annual district meetings.

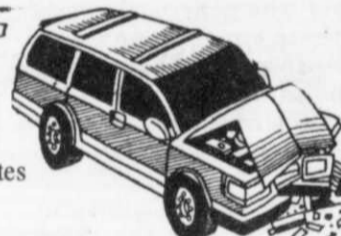
