Jim Schlitt, his wife Mary and his son, Jeremy, opened Starfire Motors on February 1 in Kewaskum. The business is located in the historical Honeck Chevrolet building on Highway 45.

The building has been home to car dealers for years in the history of Kewaskum. Kilian A. Honeck, Sr., originally started Honeck Chevrolet about 1922. Honeck was a diverse businessman also working as a cattle dealer, homebuilder, farmer and trucker.

The dealership prospered so much that in 1933 it was changed from an associate dealership to a direct dealership. They did so well that in 1936 record sales were reached with 125 new automobiles being sold to a total population of less than 800. The business was moved to the present building location at that same time.

Steady growth was maintained until 1942, when General Motors halted shipments of new cars due to wartime conversion. Honeck Chevrolet did not feel the crunch during the war because of the many other jobs of Kilian Honeck and the conversion of the dealership into a repair shop.

On April 15, 1946 Kilian Honeck, Jr. took over the business with one employee. The dealership continued to grow. By 1975 they had 20 full time and two part time employees with nearly 600 cars sold.

Kilian Honeck raised his family in Kewaskum with some of them working in the business as they were growing up. Lynn, one of the daughters, worked as a mechanic doing oil changes and pumped gas. Jane worked in the office. The daughters did their share of running for parts and helping out where they could. In July of 1989 Kilian Honeck passed away.

"My dad worked hard in the business," Jane said. "He was involved with many areas of the community. The high school was provided with a car for their drivers education program, we had floats in the parade for the annual picnic

# Lynn Ranked #1 in Nation! Former KHS Ace Breaks Yet Another Record As She Sets 1,000 Meter Indoor Track Mark for Carroll College

Marni Lynn, former Kewaskum High School track and cross country standout, won the 1,000m run at the University of Wisconsin-Oshkosh on Saturday, February 27, and in the process smashed the Carroll College school record.

Lynn, a sophomore competing in her second indoor collegiate season, broke the existing school record by over ten seconds. She posted an excellent time of 2:56.10 (two minutes, 56.10 seconds).

When interviewed by phone, Lynn commented, "I led from start to finish," and that, "it was fun to run back at the University of Wisconsin-Oshkosh." Lynn set her Kewaskum High School indoor school records in the 1600m, 800m and 3200m races on the same track earlier in her career.

The Carroll College track team travels to Knox College in Illinois for their Conference Indoor Track and Field Championships on March 5 and 6. Lynn is tentatively scheduled to run four races over the two days. Race strategy for two or three of the races will be to run to win or place high, but not run her fastest time possible, since she has qualified for Nationals the following week and four races over two days will be taxing enough.

Lynn's automatic qualifying time of 4:36.26 in the 1500m run last week at the University of Wisconsin-Stevens Point moved her to the number one ranking nationally in the indoor 1500m event for Division III female athletes. Lynn will run at the NCAA Division III Track and Field Championships on March 12 and 13 at Ohio Northern University in Ada, Ohio. Good luck, Marni! 
According to a report issued by the Washington County Sheriff's Department, the driver of the 1998 Dodge Neon was Kristen M. Becker, 17. She was transporting family members, Dustin Becker, 18, Lindsay Becker, 12, Jenny Becker, 15, and Brenda Rothenhoefer, 16 and Melissa Rothenhoefer, 17. Jodi L. Schuppel, 17 was also in the vehicle. The group was known as a very close group of family and friends.

Becker was apparently eastbound on Sherman Road, crossing the Wisconsin Central train struck the passenger side of the car about two feet from the rear of the vehicle. Upon impact, the car spun around coming to rest between the two sets of tracks.

All of the occupants were injuried and transported.

Kristen and her brother Dustin were treated and released from St. Joseph's Community Hospital. The Rothenhoefer sisters, Melissa and Brenda, who were seated in the back seat of the car, were airlifted from the crash scene by Flight for Life helicopters from Milwaukee and McHenry IL. to Froedtert Memorial Hospital in Wauwatosa. and Honeck Chevrolet sponsored bowling, baseball and basketball teams."

Honeck Chevrolet was a major business for Kewaskum. The decision to sell the business was a difficult one. Jane actually considered taking over about 15 years ago but wasn't sure Kewaskum was ready for a woman running the business.

"When dad passed away my sisters and I had our picture taken with the Honeck Chevrolet sign," Jane said. "It was emotional. Kewaskum holds a lot of memories with friendly people. It is a nice town."

Jane took four pieces of important memorabilia back to Maine, where she now lives, with her. She runs her own accounting firm. police chief and a street scene of all of the cars sold by my grandfather that year," said Jane. "It is a piece of family history that we treasure."

When Honeck Chevrolet quit business the dealership passed through a couple more owners selling cars until last November. General Motors decided to close the small Chevrolet dealers as part of their Year 2000 plan. The Honeck family still owns the property and the Schlitt family is leasing it.

Jim Schlitt started out looking for a part time job, not a career, in the car industry 22 years ago. He applied at Ted Lauck Chevrolet just to do Jim and Mary Schlitt started the business in February. of 1996 in West Bend. Jeremy joined them in April 1997. They made the decision to move the business to Kewaskum.

"Kewaskum is a friendly community," said Mary. "It is nice being where people come in, browse and visit. In West Bend we were located at the end of car alley. No one walked by or just stopped in to visit."

"It is a growing community and there are always people around," Jeremy said. "We have found the people to be friendly and hope that they give us a chance to show them that we are up front and honest with selling cars."

Starfire Motors has a mission statement that they live by. It says that they will pro quality, affordable vehicles, priced below retail market value in a comfortable, friendly, no pressure atmosphere. "It is important to us, at Starfire Motors, to give back to the community," Mary said. "We have always stressed providing a no pressure establishment where people are welcome to browse the lot. We also encourage them to shop around because we have confidence in the vehicles we sell and don't need to use high pressure tactics or add on costs to do business. Cars are acquired from anywhere there is a good quality car that someone might be interested in. The Schlitt family buys them from private owners, auctions and wherever there is a good car. "We inspect cars thoroughly before purchasing them," said Jim. " "Normally I purchase cars that have good eye appeal, something that is a good quality car. I am pretty fussy about what I buy. We check out cars to make sure there is no frame damage and other problems. Sometimes things come up that we find later and if that happens we sell it wholesale. We have a good turnover of vehicles because of our reasonable prices. The key to help people buy a car is honesty. Big dealerships have executives, salespeople, cleaning staff and extras that the customer pays for in the end."

Starfire Motors fights against the prototype of the used car salesman. They are in the business of being honest people who want to help you find a good car at an affordable price. The staff will print out the Bluebook price, work with the customer on determining loan and retail value and make it easy to buy a car. Friday 9-5:30 and Saturday 9-4. They encourage anyone interested in a vehicle to come and browse the lot. Plans are underway to add a mechanic to assist customers on maintenance and repairs, a full service department. They are also looking at adding a detail shop where cars are cleaned up inside and out. Ken Wagner, who at one time had his own dealership, retired and works part time for the Schlitt family.

"Ken has had a lot of experience in the car business," Mary said. "He has been with us since we first opened. We do an honest business that brings back repeat customers and word of mouth advertising from a happy customer brings in new ones."

It is that honest attitude that makes Starfire Motors a perfect fit for a community like Kewaskum, a place where people live generation after generation and can do much of their business locally. Starfire Motors plans on becoming a part of that history.

"I have the last Bluebook, and office guide to car value, from my father's desk," Jane said. "I have an award my grandfather had won in 1927 for selling his quota of cars. A paperweight sits on my desk with a gold coin inside that says '1971 Kewaskum acceptance, momentum and prosperity' on one side. The other side reminds me of my dad. It says 'The speed of the boss is the speed of the gang.""

Kilian Honeck was a good employer. He respected his employees and treated them well. After 25 years of service they would receive a new car. Jane can remember at least five or six of them being given away.

"My sister has a photograph from about 1927 with the some car clean-ups at night.

"The sales manager at the time pulled me aside and said he thought I'd make a good salesman," Jim said. "The following Monday I started selling cars and have been doing it ever since."

Jim gained a lot of experience over the years. He learned the business of selling cars, working with people and the things that were important to him about being an honest salesman.

"I worked at Schwartzburg Chevrolet Oldsmobile for about eight years. In the seventies, I was with Ted Lauck Chevrolet," said Jim. "I also worked for Suds Volkswagen when they were in West Bend and was the sales manager at Lochen Ford in Newburg for ten years."

Starfire Motors was the result of all of that experience.

Jodi Schuppel who was transported to Hartford Memorial Hospital and later flown to Froedtert. She is reported in satisfactory condition suffering from multiple fractures.

The fourth passenger in the back seat was Jenny Becker who was treated and released from Hartford Memorial Hospital.

Lindsey Becker was seated in the front of the vehicle with siblings, Kristen and Dustin. She was admitted to Hartford Memorial Hospital and is reported in fair condition as of Monday.

Three of the passengers were ejected from the vehicle upon impacting the train. Those being Dustin and Lindsey in the front seat and Jenny who was seated behind Kristen the driver.

The roof of the car had to be removed in order to extricate the victims in the back seat.

The transports, in addition to the Flight for Life helicopters, were made by Dick's Ambulance Service of Slinger, two units from Hartford Emergency Squad, one unit from Richfield Rescue, and one unit from Jackson Rescue. Also assisting at the scene was the Slinger Fire Department.

It has been confirmed that the railroad warning signals were in operation.

The Wisconsin Central train was being operated by Engineer Daniel A. Longley, Occonomowoc and Scott E. Renchin of Fond du Lac.

It is believed the train was

traveling at a speed of 40 MPH or less, the speed limit for the intersection is 50 MPH.

Counselors were on hand at Slinger High School to help friends of the victims cope with the tragedy.

The crash remains under investigation by the Washington County Sheriff's Department.






All Jackson and Slinger churches will meet at 1 p.m. at St. John's United Church of Christ on Kettle Moraine Drive, Slinger.



The Kewaskum Village Board met Monday with Village Attorney, Gerald A. Kiefer in attendance among twelve other village residents.

Fire Chief Mark Groeschel was present and gave his report. He indicated that a new ambulance has been ordered from Foster Coach where the last one was purchased. # Buying a Hunting or Fishing License To Be Easier Under Automated System

MADISON -- Buying a Wisconsin fishing or hunting license at a sales outlet using the state's new automated license sales system will be easier and more convenient than in the past. The automated license issuance system (ALIS) will be used by more than 1,100 license sales outlets when the 1999 license sales season begins March 10, said Marilyn Davis, director of the Bureau of Customer Service and Licensing at the State Department of Natural Resources in Madison.

"Each customer will be treated as a 'new' buyer the first time they purchase a license at a sales outlet using the automated system," Davis said. "After the first purchase, automation will make subsequent license purchases at any sales outlet or over the phone even easier."

Whether you buy a license in person or over the telephone, here's a step-bystep guide to buying a license under the DNR's automated system.

#### BUYING YOUR LICENSE IN PERSON

1. Pick the sales outlet that's most convenient for you. More than 1,100 DNR-authorized agents will offer licenses at sporting goods stores, bait shops, hardware stores, resorts and marinas. You may also buy your licenses at DNR Service Centers, which also offer information about fishing and hunting seasons, regulations and state park and forest maps.

"You don't have to use the same location each time you buy a license; once you're part of the automated system, you'll be assigned a unique DNR customer number that, when entered into the automated system, will prompt the system to print your name, address, and other information on your license documents from any authorized agent location," Davis said.

Each sales outlet in the automated system will offer a complete selection of DNR licenses including hunting, fishing and trapping licenses, patron's licenses and duplicate licenses. Because licenses will be printed on demand, no licensing station will run out of inventory and several licenses can be printed on the same form at the same time. 2. Provide a form of personal identification and your Social Security number the first time you buy a license under the automated system. The first time you buy a license under the new system, you're considered a "new" customer. The license agent will ask for identification. If you have a new Wisconsin driver's license or Wisconsin ID card, the system can read this information from the encoded magnetic strip. Older driver's licenses feature a special number that the agent can enter to accomplish the same task.

As always, Wisconsin residents without a Wisconsin driver's license or Wisconsin ID will need to provide proof of residency and identification, Davis said. Those customers, along with non-resident customers, will be asked to complete a short New Buyer's Form the first time a purchase is made on the automated system.

A Social Security number will be requested the first time ALL customers buy a license, Davis said.

"Providing a Social Security number is RE-QUIRED by a state law the Legislature passed in 1998 to aid collection of childsupport payments," she said. "The DNR's automated license sales system has been designed to keep customer Social Security numbers confidential.

"You'll only need to provide your Social Security number once. After that, the unique DNR customer number the automated system assigns you will automatically link to name and address information about you when you buy a license in the future. This feature will also eliminate the need to provide a Social Security number each time you buy a license."

Customers may also buy licenses for other people who have filled out and signed a DNR application form specifically designed for this purpose. Parents who want to buy licenses for their children will need to complete this form with their offspring ahead of time. Applications are available at DNR Service Centers and will soon be accessible from the DNR's website at <www.dnr.state. wi.us>.

Once the sales agent has entered basic data about you into ALIS, the system assigns your permanent DNR customer number, which will be printed on all licenses and receipts. Transactions for recreationmore easily and accurately processed, Davis said.

3. Sign your receipt, pay your fee and receive your license. Licenses will be printed immediately on durable, water-proof stock (a different license color will be used each year). When your purchase is complete, a two-ply receipt will list the types and prices of each license, the total fee you owe and your DNR customer ID number. You will be asked to sign the receipt following a statement on the receipt declaring your residency. The sales agent will give you one copy of the receipt.

Each licensing agent will have a supply of outdoor regulations for each license or permit privilege purchased. A button on the ALIS machine will allow agents to order a supply of regulations quickly as supplies start to dwindle, Davis said. "This feature of the automated system will improve the distribution of information about fishing and hunting regulations to customers," she said.

#### **BUYING A LICENSE** OVER THE PHONE

1. Call a toll-free phone number, 1-877-945-4236 (corresponds to 1-877-WILICEN[SE]; number will be activated March 10) to purchase a license over the phone 24 hours a day, seven days a week. Customers will be charged a \$3 handling fee for this service to cover the costs of compiling and mailing license regulations and other documents to each phone customer. Both residents and nonresidents may order licenses over the phone.

2. Tell the operator which licenses you wish to purchase; also provide the same personal information just as if you were buying your license in person: name, address, Social Security number or DNR customer number.

3. Provide your MasterCard or Visa charge card number (other cards not accepted) and expiration date. The operator will tally your charges, including the \$3 handling fee.

4. Write down the authorization number the operator will give you and keep it handy if you plan to fish, for example, before you receive your license in the mail. Licenses, permits and regulations will be mailed shortly thereafter. The authorization number will allow you to enjoy instant privileges except for licenses that require a carcass tag. For short-term licenses,

such as fishing licenses covering periods of two to 15 days, the date the shortterm license becomes effective will determine whether you'll even receive a license in the mail. If you order a two-day license the day before you intend to use the license, for example, your authorization number will suffice; you won't be mailed a license because your twoday license period will be over before your short-term license arrives in the mail.
