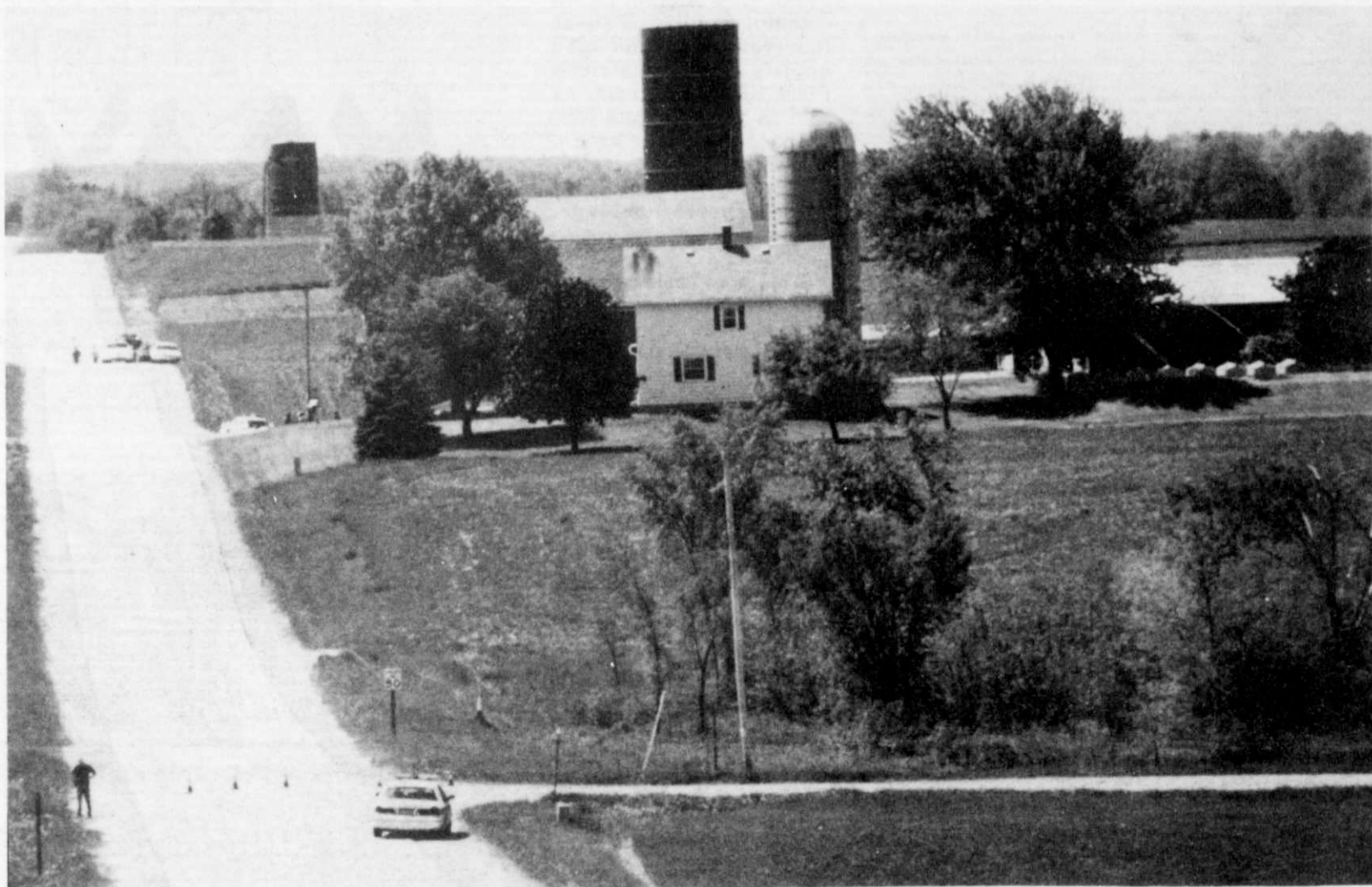

SWAT Teams Called to Town of Kewaskum Farmhouse



The above photo shows the farmhouse where a shooting suspect held himself hostage and kept Washington Deputies at bay for hours on Wednesday. The farmhouse is located on CTH B, just north of Badger road in the Town of of Kewaskum. Unconfirmed reports say the melee began when the suspect fired a shot at a Washington County Deputy early this morning after the deputy was called to the scene. The deputy was shot in the arm and it is reported he is in good condition at this time. Members of the Washington County Sheriff's Department and West Bend City Swat Teams were called in around 9 am. The Kewaskum Rescue Squad was dispatched to be on hand in case their assistance was needed. Also on the scene were members of the F.B.I., West Bend K-9 unit and Snipers to assist. The suspect's mother was brought onto the scene in hopes of coaxing the suspect out of the house, but it was unsuccessful. At 11:02 tear gas was fired into the house. Thirty minutes later, one shot was fired, injuring no one. At approximately 12:30, more shots were fired, allegedly injuring a member of the SWAT team. District Attorney David Resheske was called in for consultation by Sheriff Jack Theusch. The Germantown Swat Team was also called in at around 1 pm. Further information was unable to be obtained at this writing, due to printing deadlines.

Larry Ammel Named County High School Teacher of the Year



WEST BEND -- Larry Ammel will receive the Washington County High School Teacher of the Year Award at the 1999 Commencement Ceremony at the University of Wisconsin Washington County.

He has a distinguished record as a teacher and band director in the Kewaskum School District. He earned his Bachelor's from UW Stevens Point in 1968 and began his career as a teacher in the Kickapoo School District near Viola.

After five years, he moved to Kewaskum and the rest, as they say, is history. Along the way, he received a Masters from St. Louis University.

At Kewaskum he created

a music program which is the envy of schools many times the size of his. The Jazz Band which he founded, has traveled extensively and has both served as an ambassador for the school and as a vehicle to introduce this uniquely American idiom to the people of the region.

Trips have taken his groups to Toronto, Myrtle Beach, Orlando and Williamsburg. His students not only got to play their music, but they got to learn about other places, other times and other people.

Larry's influence on his school goes beyond his official job. He was one of the founders of Kewaskum's Honors Award Ceremony,

which has become that community's vehicle to recognize academic achievement.

For the past several years, Larry has also served as advisor to KHS's Student Council. Under his guidance the Council has become a powerful force not only for the betterment of the school, but of the community as well. His guidance has led to a unique partnership between students and senior citizens.

Musician, teacher, mentor and guide, Larry Ammel's true legacies are the students he has taught. He is Washington County's Outstanding High School Teacher for 1999.

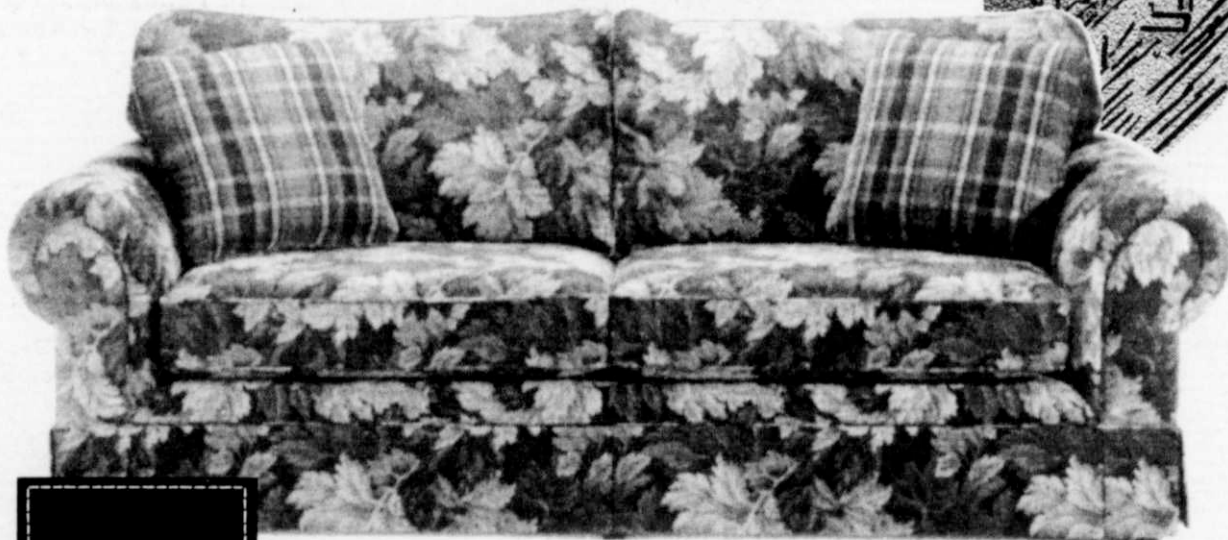
Areas of screening include speech/language, vision, hearing and readiness skills.

Lucas Martin Honored at Kohl Foundation Banquet

Lucas Martin of Kewaskum, a graduate of St. Lawrence Seminary in Mt. Calvary, was one of the student scholarship winners that was honored at a banquet held to acknowledge the achievements of northeastern Wisconsin students and teachers Saturday, May 15, at Appleton North High School in Appleton, it was announced by the Herb Kohl Educational Foundation. Lucas is the son of Larry and Louise Martin of Kewaskum.

On April 9, the Wisconsin Newspaper Association and the Herb Kohl Educational Foundation announced the recipients of the \$1,000 Initiative Awards, Scholarships and Fellowships. The banquet recognized and honored the accomplishments of the area's outstanding students and educators.

Kim Markgraf, spokesperson for the Herb Kohl Foundation, said that U.S. Senator Herb Kohl, representatives of co-sponsoring organizations (Wisconsin Department of Public Instruction, Wisconsin Association of Nonpublic Schools, Wisconsin Cooperative Educational Service Agencies and the Wisconsin Newspaper Association) and the families and friends of northeastern Wisconsin award recipients were part of this program.

"The Herb Kohl Educational Foundation believes that it is important to publicly acknowledge and applaud the efforts of Wisconsin's leading teachers and students. We are very pleased to have Senator Kohl join us for this special recognition of excellence in education," Marggraf said.

The Herb Kohl Foundation Scholarship was established in January 1990 by Herb Kohl to provide scholarships to graduating Wisconsin high school students who have demonstrated academic excellence, outstanding leadership, citizenship, community service, integrity and other special talents; and to help them pursue postsecondary studies.

The Herb Kohl Foundation Fellowship rewards teachers who have demonstrated superior ability to inspire love of learning in their students, have motivated others and have provided meritorious service both inside and outside the classroom.

The initiative program was established in October 1997 to recognize students who have demonstrated a high level of motivation to achieve, have shown strong promise for success in college and beyond, and may have overcome significant personal obstacles or adversity, but are unlikely to receive other academic

based scholarships. One hundred different high schools throughout Wisconsin are designated annually to select an Initiative grant recipient.

"Senator Kohl made formal award presentations to the winners at the banquet," Marggraf stated.

The Herb Kohl Foundation will issue the \$1,000 Scholarship and Initiative grants to the postsecondary

institutions the students will attend. Each teacher will receive a \$1,000 Fellowship and an additional \$1,000 grant will be awarded to the teachers' school for use in innovative educational projects. To date, the Herb Kohl Educational Foundation has provided \$2.8 million to Wisconsin educators, students and schools.

Recruiter Steeber to Present Memorial Day Address

Navy Recruiter Mark J. Steeber, SK1(SW), USN, of West Bend will present the Memorial Day Address.

Mark was born in Manitowoc on December 24, 1965. He was a member of the graduating class of 1984 from Roncalli High School in Manitowoc.

Petty Officer Steeber entered the U.S. Navy Reserves through the delayed entry program in June, 1996. In October 1986 he reported to the Recruit Training Command in Orlando, Florida for basic training.

Upon completion of basic training, he reported to the Naval Technical Training Center in Meridian, Mississippi for Logistics Management school, graduating in February 1987, fourth in a class of 19. He then reported to the Naval Reserve Center in Sheboygan for nine months of Reserve Duty. In December 1987 Mark was released from drilling reserve status to

enlist in the active duty Navy and returned to the Recruit Training Command in Orlando, Florida for Navy Veteran indoctrination into the active duty Navy.

His initial tours were at sea onboard the Minesweepers USS Fortify (MSO 446) followed by the USS Adroit (MSO 509) at the Little Creek Naval Amphibious Base in Norfolk, Virginia. While serving in USS Adroit, Mark earned the distinction as an Enlisted Surface Warfare Specialist.

He was then assigned duty as financial manager onboard USS Portland (LSD 37) from July 1989 to December 1991. While onboard USS Portland he completed a six month deployment to the Mediterranean Sea and also deployed for nine months in support of Operation DESERT SHIELD and DESERT STORM.

After reenlisting in December 1991, Mark accepted orders to the Atlantic Intelligence Command (AIC) by way of the Fleet Training Center, Norfolk, VA where he attended Independent Duty Logistics Management School. While

In March 1995 Mark reenlisted for orders to Commander, Cruiser Destroyer Group Two (CCDG-2). He reported for duty in June 1995 to serve as the Assistant Staff Logistics Management Officer where he oversaw Logistics for a 12 ship Battle Group. While at CCDG-2, he deployed twice to the Mediterranean Sea/Arabian Gulf.

Healthy Pancakes

- 1 Cup Mrs. Butterworth's Original Pancake Mix

Pour ¼ cup batter for each pancake onto hot griddle (apply non-stick spray if necessary). Turn pancakes when tops are covered with bubbles and edges look dry

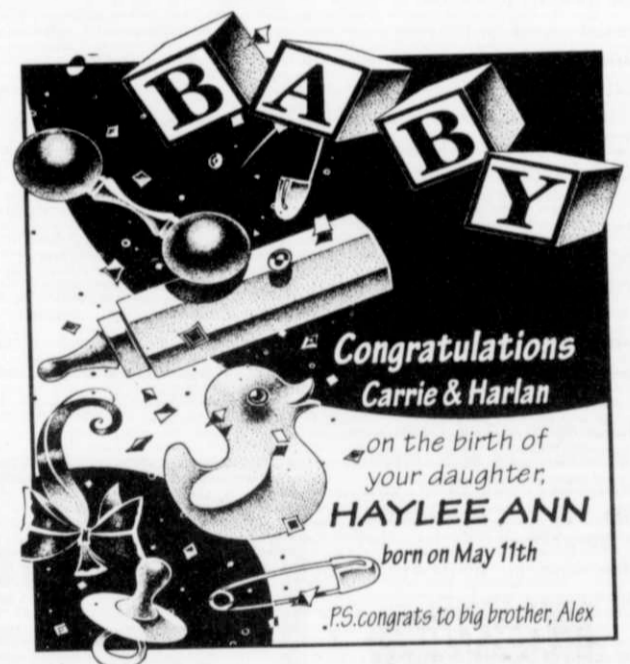
(about 2 minutes). Turn only once and cook an additional 2 minutes. Makes 5-6 pancakes.

Serve with the following healthy topping and Mrs. Butterworth's syrup.

This sculpture piece is on permanent display in the State of Wisconsin Capitol Building in Madison. Helen Mears died at the age of 44 years.

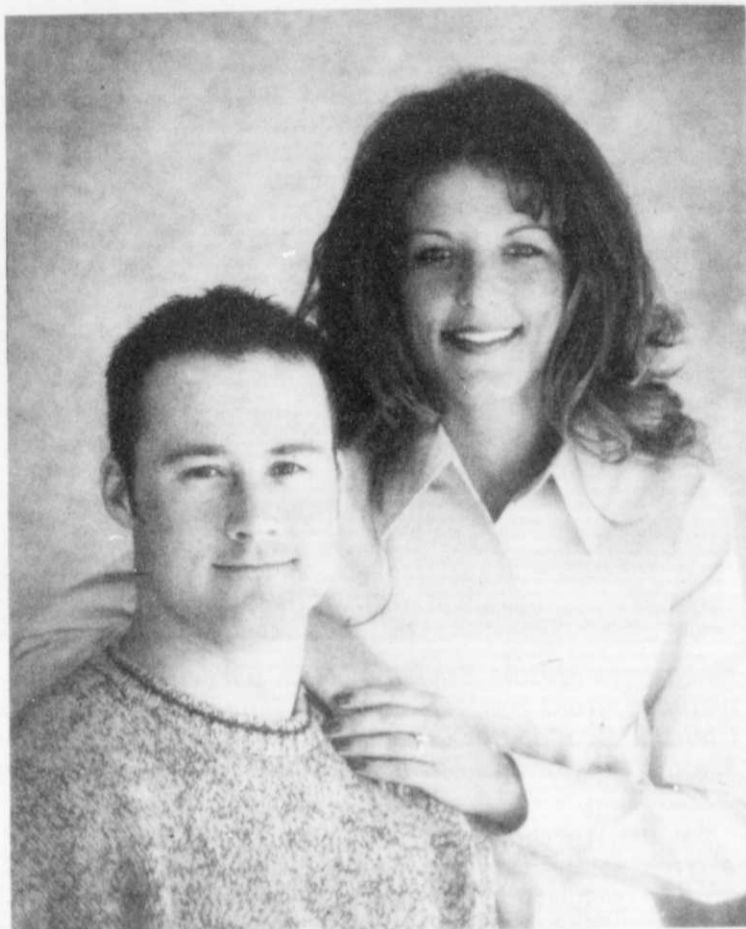

Town of Scott Board Makes Changes in Normal Procedures

"Change" appeared to be the password for what is happening in the Town of Scott. Routine tasks and procedures which have been normal procedures for many years are now experiencing changes.

This became evident at the recent meeting of the Town Board.

The first of these changes was a new format of the evening's agenda. Many items which usually were taken care of at the end of the meeting have now been moved to the beginning, such as approval of the minutes and building inspector reports.

Lengthy meetings which have lasted as long as four or more hours are being shortened by holding two meetings per month. These regular board meetings are being scheduled for the second and fourth Monday of the month at 7 p.m.

Approval of certified surveys which in the past, had been a part of the clerk's announcements, will now become a specific agenda item. Anyone needing approval of a certified survey will need to contact the Chairman or clerk several days in advance so it can be placed on the agenda.

"Payment of Bills" has been moved to the end of the meeting giving board members time to review invoices before approving payment. Along with this change, and following procedures spelled out in Chapter 66.44(2) of the State Statutes, Ordinance 1999-1 was adopted. This ordinance provides for payment of routine and customary monthly claims (bills) against the town to be paid without waiting for board approval at the next regular meeting.

Before paying the bill, the clerk/treasurer must make sure that funds are available in the town budget, that the service stated on the bill has been authorized, and that this service has been provided to the town and completed as was authorized, and that it is a valid claim against the town.

A list of the claims paid in this manner will be given to the board on a monthly basis giving detail of date paid, name of claimant, purpose and amount.

Chairman Larry Martin has implemented another change. Martin has taken steps to move away from the committee assignments which have been historical in the past, to a method by which each individual board member will have individual areas of responsibilities. He has labeled these as Liaison Assignments.

Supervisor Ivan Kumrow was assigned to Roads and Recycling, Robert Gluck

to Parks and Recreation (this includes the Hilltop), Mark Ringwell to the Fire Commission, Ira Weber to Insurance and Ordinance enforcement. Martin will be the Liaison handling Personnel and Planning Commission.

Any liaison which finds an issue which needs attention will have it resolved by a committee of the whole at regular board meetings during his "Committee Report." Martin believes that this will allow the board to be more effective in managing the affairs of the town while minimizing the number of individual meetings which have been held in the past.

Clerk/Treasurer Laura Wagner has been appointed as the responsible official to submit application for the annual DNR Recycling Grant.

After careful consideration and inspection of the current lawn mower being used at the Hilltop and ball diamond in Batavia, a decision was made to repair the old instead of purchasing a new one. Estimated costs of repairs which would be done by the town's highway maintenance foreman, Mark Muench came to \$650. He reported that the

mower deck appears to be in sound condition, the motor does not use oil and with overhaul should last for many years.

If the hydrostatic elements of the mower needed update, this would add an additional \$750, and would need to be "farmed out." Earlier this year purchase of a new mower was considered to be \$15,000.

Action was taken to hire Simonsmeier, Weber & Corson Accounting Firm to conduct an audit of the 1998-999 books. Cost of the audit was not known.

During a public hearing held prior to the meeting, comments were heard regarding a request of Wisconsin Pallet Sales, Inc., now owned by Dave Van Wormer, for a conditional use permit to allow wood recycling and the manufacturing and repair of pallets and wood products on his M-1 zoned property in Section 13.

VanWormer recently purchased the business from "Bucky" Backhaus and needs a conditional use transfer. Comments disclosed that a number of items in the original use permit were not complied with by the former owner

and were being transferred to VanWormer.

Backhaus's permit allowed a house trailer to be used as an office. He did so for a time and after building a permanent office, he pulled the house trailer aside and it remains on the property in violation of the permit. It appeared that this was one of the violations of the original permit which needed to be corrected.

Residents speaking on VanWormer's behalf felt that he should not be punished for the actions of the former owner. Although

VanWormer has agreed to clean up the premises, he claimed that he needs time to get the job done if he is to continue the business and the cleanup at the same time. He said, "It cannot be done overnight." Residents agreed that a five year buildup could not be cleaned up in six months.

The planning commission recommended that the use permit be limited to six months. Normal permits are for two years.

The board approved a new two year permit, with cleanup to be reviewed

County Humane Society Joins National Dog Bite Prevention Effort

The Washington County Humane Association is joining the Humane Society of the United States (HSUS) in recognizing National Dog Bite Prevention Week, May 16-22, 1999.

Letter carriers with dogs attached to their ankles have been the subject of jokes and cartoons for years. But there is nothing funny about dog bite injuries to the more than 4.7 million victims who are bitten each year, most of whom are children.

The HSUS and The Washington County Humane Society agree that, in most cases, dog bites are not caused by "bad dogs" but by irresponsible dog owners. Dogs who have not been properly socialized to other persons, who are not supervised or safely confined, who are not sterilized or who receive little attention and handling are those who often bite humans.

Although particular breeds of dogs are often accused of being most likely to bite, other characteristics are better predictors of canine biting behavior. Dogs who have not been spayed or neutered are three times more likely to bite. Marnie Brown, WCHS Executive Director suggests that "the first step you take to prevent your dog from biting is to have him/her spayed or neutered."

Proper socialization, supervision, humane training and safe confinement are also important components of responsible dog ownership and bite prevention.

Most dog bite incidents can be prevented through public education and responsible dog ownership. National Dog Bite Prevention Week is an opportunity for animal care agencies, humane societies, post offices, public service agencies, veterinarians, dog trainers, educators, physicians and many others to work together to address this significant -- and large-

ly preventable -- public health problem.

"It is also important that we teach everyone in our community -- especially our children -- how to avoid being bitten by dogs," says Brown. For more informa-

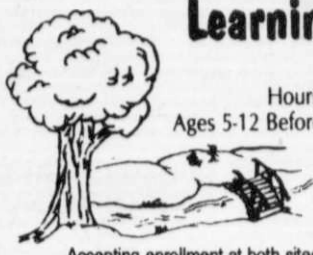

Members of the New Fane Sportsman Club have made a generous offer to help people in an emergency situation and have proposed a challenge to other organizations or individuals.

If any other organization, individual or business will donate the funds to purchase a new Physio Control Life Pack 12 Defibrillator for use in the Kewaskum Fire Department ambulance, the New Fane Sportsman Club will donate the funds to purchase a second unit to be used in the second ambulance.

A defibrillator is a portable battery-powered device that is used to record cardiac rhythm and to generate and deliver an electrical charge to patients with ventricular fibrillation.

The leading cause of death in this country is heart-related disease. More than 350,000 people die suddenly of cardiac arrest each year. More than three-quarters of them die outside of the hospital. Many die unexpectedly in their homes.

Research in pre-hospital treatment for sudden death had identified several factors commonly associated with successful resuscitation and subsequent survival. Equipping the EMT with a defibrillator for early defibrillation is one of those factors that improves the chances that a patient will survive a cardiac arrest.

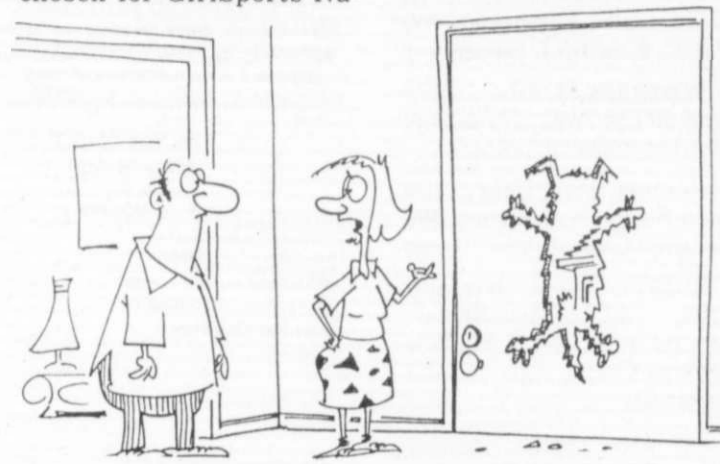
The current defibrillators in the Kewaskum Fire Department ambulances are being replaced because the electronic parts are no longer manufactured. Area hospitals are not able to efficiently download the computer chip information

from the current unit because of updated hospital systems.

Defibrillation is a special skill level over and above the basic EMT training. Its legal requirements are very state specific. A continuing education program that includes regular review of theory and practical defibrillation skills is required. As with any health care equipment, the unit is costly.

The cost of each defibrillator is approximately \$9,000. But who can place a price on a patient who has survived a cardiac arrest because of defibrillation?

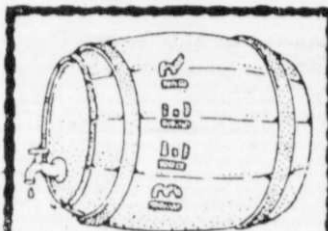

Sparks Wins Discus Boys Track Fifth at Conference

KEWASKUM -- The host New Holstein boys track team might not have but a bow on it, but they nevertheless wrapped up another conference title in a long list of titles for Grant Turner, their retiring head boys coach.

Turner has coached boys track at New Holstein for 18 years. When asked how many championships his teams have won over the years, he responded, "eight, nine, ten, I really don't know. I never really keep track of things like that."

New Holstein won seven events, finished second in three events and third in seven events to total an astounding 197 points to easily win the Eastern Wisconsin Conference title. Division One Plymouth finished a distant second with 116.5 points, just 3.5 points ahead of Two Rivers.

Chilton finished fourth with 89 points, followed by Kewaskum with 51.5 points. Sheboygan Falls finished sixth with 43 points and Kiel and Roncalli tied for seventh place with 26 points each.

Sophomore Charlie Sparks, just got better and better in the discus, as he worked his way through the trials into the finals of the discus. Sparks had the third best throw of the eighth discus throwers going into the finals. Throwing in reverse order, with the thrower with the best distance throwing last, each finalist received three additional throws.

Sparks, who had a throw of 142' to build off of, threw 153' on his last throw with two other throwers still each having one throw remaining. Neither Ty Mueller of Plymouth or Josh Engels of New Holstein bettered their throws of 149'7" and 149'1" respectively, and therefore, finished second and third to Sparks.

Sparks had been seeded third in the discus at the meet, so his conference championship in the discus was quite a surprise. When asked about Sparks, KHS throwing coach Dave Rizzardi responded, "Charlie Sparks is athletic determination. To become conference champ, he had to overcome a slow start tonight. His last throw beat two very good discus throwers; one from Plymouth and the other from New Holstein. Charlie has put himself into elite company, and he is only a sophomore." Sparks scored 14 team points for Kewaskum.

Freshman Chris Canter also won a conference medal with his third place finish in the long jump. Canter's jump of 18'5-3/4", while not very close to his personal best of 19'10-3/4", enabled him to score six points for

Kewaskum. All the distances for the long jump were shorter as the jumpers seemed to have trouble with New Holstein's pit. The winning jump by Wes Fannin of New Holstein was only 19' 3/4".

Seniors Andy Christophersen and Josh Rieder finished fifth and eighth with jumps of 18'1" and 17'5" respectively to give Kewaskum an additional six team points. Rieder also placed eighth in the triple jump with a career best jump of 36'7".

Junior Chris Koth placed third in the pole vault with a season equaling best jump of 11'6". "Chris needs to go 12' or 12'6" at a meet soon. There is only the Conference Relays next Thursday, May 20, and then the following Monday is the WIAA Regional.

The 4x100m relay team of Chris Canter, Jim Thelen, Jason Strobel and Charlie Sparks ran out of track and just couldn't catch New Holstein this time, as the Kewaskum quartet had to settle for third place with a time of 46.5 seconds -- just a couple of tenths of a second behind New Holstein.

Their goal was to win the event, but Chilton has a very good relay team and New Holstein proved to be tough to beat at home. "I was pleased, however, that they did finish third and won a conference medal," commented head boys coach Jerry Gosa.

One surprise for Kewaskum and definitely for the athlete was Jim Thelen's fifth place finish in the 100m dash in 12.3 seconds. Thelen had not realized that he was entered in the 100m dash as Kewaskum's third entry along with teammates Jason Strobel and Chris Canter. (The Conference meet uses the regional format so there can be three entries in some events).

"I was down at the start of the 100m dash to hold the blocks for Strobel, when they called off my name for the race," recounted Thelen. Thelen ran well and finished second in his heat of the preliminaries and advanced to the finals based on time, where he placed second with his career best time. Kewaskum hasn't placed anyone that high in the 100m dash in seven or eight years. The 100m dash is a real competitive event in the Eastern Wisconsin Conference. Eric Deklen of New Holstein won the event with a time of 11.5 seconds.

Sophomore Brian Wall continued to perform well in the pole vault as he cleared 11' for the third meet in a row. Wall's 11' jump placed him fifth. Teammate Joel Herrmann had an off night as he only cleared 10' for eighth place.

The 4x800m relay team of underclassmen Josh Repovsch, Troy Kedroske and Justin Weninger and Bryan Kraft finished sixth

with a time of 10:00.7. Plymouth won the relay with a time of 8:32.6.

Sparks also picked up a pair of sixth places with his 43'8-1/4" in the shot put and 24.6 seconds in the 200m dash. Ty Mueller of Plymouth, who took second in the discus, won the shot put with a throw of 50'3" and Eric Dekleyn of New Holstein also won the 200m dash in 23.1 seconds.

The 4x400m relay team of Darrell Woebeking, Tom Ogi, Chad Will, and Josh Rieder finished eighth for Kewaskum in 3:59.6. Ogi and Rieder filled in for Paul Mertz and Luke Kehres, who did not run due to injuries; a sprained ankle and a pulled muscle respectively.

Mertz did manage to high jump earlier in the meet, however, but did not place with his 5'8" jump. Chad Will filled in for Kehres in the 400m dash and ran a personal best time of 57.0 seconds but did

not place. Matt Belger came within a second of breaking five minutes in the 1600m dash, but also did not place.

On Thursday, May 20, Kewaskum hosts the Eastern Wisconsin Conference Relays. Field events start at 3:30 p.m. Boys throw the discus first and girls throw the shot put first, then switch. Girls high jump first to completion, then boys follow. Triple jump and long jump will use an open pit from 3:30 to 6:30 p.m. Running events start at 4 p.m. Hope to see you there.

Girls Track Seventh at Conference

NEW HOLSTEIN - In their last Eastern Wisconsin Conference Championships, the Chilton girls captured the conference title by outscoring Sheboygan Falls 132-114.

Chilton won four events and placed second in six events. Two Rivers finished third with 102 points, followed by Roncalli with 87 points. New Holstein finished fifth six points back with 81 points and Plymouth finished sixth with 55 points. Kewaskum finished with 48 points and Kiel finished eighth with 42 points.

This is Chilton's last year in the Eastern Wisconsin Conference. Next year Campbellsport will switch out of the Flyway Conference and enter the Eastern Wisconsin Conference.

Sophomore Colleen Gosa had a busy night going back and forth from the track and the discus throwing area. Gosa started her busy night by placing fifth in the 1600m run with a career best time of five minutes and 45.4 seconds (5:45.4).

Then she went on to the discus throwing area and threw a career best 109'11" in the discus to get into the finals. Before throwing in the finals, however, Gosa returned to the track to run the 800m run. Again she was placed in heat one (the slow heat) of the 800m race which runs first. Gosa ran a season best time of 2:37.9 and won her heat of the 800m run.

After the completion of heat two (the fast heat), the times from heat one and heat two were merged and Gosa finished fourth overall. Gosa returned to the discus for her final three throws. Her throw of 109'11" in the trials placed third and earned her a conference medal. Gosa scored a total of 15 team points for Kewaskum.

After the meet, throwing coach Dave Rizzardi commented on Gosa's success in the discus. "Colleen was very consistent this evening in her rotation, release point, and follow through. She also had more power and a very nice release angle today. With only two

weeks left in the season it is important to have this kind of consistency. It is good for Colleen to be able to compete with this kind of competition as a sophomore. She was beaten by two girls from Chilton; one of them Stef Pingel, is a senior who was a state competitor last year. Pingel won the discus with a throw of 131' tonight and her teammate Wendy Woelfel placed second with a throw of 114'5".

Senior distance ace Carol Neumann, hampered by shin splints and a tight hamstring, finished seventh in the 1600m run with a time of 5:52.6 and later scratched from the 800m run because of these injuries. "I felt bad for Carol. This was her last conference meet and she didn't have the opportunity to run the way we know that she is capable of running," commented distance coach Jerry Gosa.

Senior Jackie Michaels, defending conference champion in the 300m low hurdles, finished second with a time of 51.1 seconds. Michaels, who led the first 200 meters of the race was passed by two hurdlers down the stretch. One of the hurdlers ahead of Michaels tripped on the last hurdle and fell, allowing Michaels to finish second.

Michaels was not at 100% strength due to illness. Teammate Emmy Foerster finished eighth in the 300m low hurdles with a time of 54.6 seconds. Steph Renk of Plymouth won the 300m low hurdles with a time of 49.1 seconds.

Michaels also finished sixth in the 100m high hurdles with a time of 18.4 seconds and seventh in the long jump with a distance of 13' 10-3/4". The 100m high hurdles were won by Kristel Ehrhardt of New Holstein in 16.6 seconds and Bridget Bero of Two Rivers won the long jump with a leap of 15'1". Many of the distances for the long jumpers seemed shorter than normal. Bero's season's best in the long jump was 16'8".

Sophomore Jody Wichtoski was a surprise third place finisher in the high jump with a season best jump of 4'10". First, second and third place heights

were all 4'10". First, second and third place heights were all 4'10", with placing determined by number of misses.

Nevertheless, Wichtoski earned her first conference medal. Wichtoski also placed eighth in the triple jump with a distance of 29' 2-3/4".

The 4x800m relay team of Emily Rinzel, Elizabeth Rammer, Kelly Darmody, and Lauren Steinhardt finished fifth with a time of 11:11.7. The 4x100m relay team of Jenny Fettig, Lynn Wiesner, Kristen Schiller, and Tina Lindgren also finished fifth with a time of 56.9 seconds. Sheboygan Falls won the event with a blistering time of 53.8 seconds.

The 4x200m relay team of Fettig, Wiesner, Schiller and Lindgren finished seventh with a time of 2:01.2. In a very exciting race, Roncalli and Sheboygan Falls each recorded times of 1:52.8, but Roncalli won the relay as it nipped Sheboygan Falls at the wire.

Kewaskum was shut out of the 100m dash, 200m dash, 400m run, 3200m run, 4x400m relay and the shot put. Kewaskum did not run the 4x400m run due to injuries. Likewise, sophomore 3200m specialist Emily Rinzel did not run due to shin splints.

Head girls coach Joe Kinney offered these comments after the meet. "We finished seventh at the conference meet. We have known that the Eastern Wisconsin Conference is a tough conference, but this meet really made the point.

I felt we had a chance at third or fourth, however, some of the events didn't come together. We didn't get any first places. You cannot win, or even do well in this meet if you don't get some firsts."

"Again, our team is young. It will take us awhile to put things together. The individual performances are still coming along. Jackie Michaels did well in the 300m low hurdles, as did Colleen Gosa in the discus. The 3200m relay team of Emily Rinzel, Kelly Darmody, Elizabeth Rammer and Lauren Steinhardt are all doing well. At this point we are getting a little beat up. This is a tough part of the season, as injuries are being more of an issue," concluded Coach Kinney.

On Thursday, May 20, Kewaskum hosts the Eastern Wisconsin Conference Relays. Field events start at 3:30 p.m. and running events start at 4 p.m.

On Wednesday, May 12, the Kewaskum High School boys golf teams traveled to Quit-Quit-Oc Country Club to challenge the Kiel High School Raiders on their home golf course.

This Eastern Wisconsin Conference Dual Meet would prove to be pivotal in positioning these teams leading up to the Conference Championship Match on Thursday, May 20. The Kewaskum Indians entered into the contest with a 3-1 league ledger, trailing only the undefeated Panthers of Plymouth. Whereas the host Raiders at 2-3 were trying to improve their chances and status within the conference at the expense of the visiting Indians.

Kewaskum has been working on establishing more consistency from match to match, regardless

of the course or conditions. The coaches were attempting to solidify the KHS varsity and junior varsity line-ups heading into the upcoming tournament series.

These seemingly positive team goals may actually have had a detrimental overall effect on this particular match. The Indians were able to accomplish these goals and yet manage to lose the match.

The local linksters posted four scores of 43 and recorded two rounds of 44 between the varsity and junior varsity competitors, resulting in a team total of 173. The Raiders varsity upset the visitors with scores of 39, 40, 46 and 47 totalling 172. Thereby, evening the Raiders record at 3-3 and dropping the inconsolable Indians to 3-2, two full matches behind the defending champs, the Plymouth Panthers.

Both league losses this season happened at Quit-Quit-Oc Golf Course on cool, wet and windy days. Kewaskum's 175 team total outdistanced Manitowoc Roncalli's 184 and Chilton's 185 to complete their conference dual match season in a successful manner. Leading the Indian Varsity was Shaun Timblin with a 39, and Curt Koth with a 42.

Chase Parson's 41 was Chilton's best with Jon Pazdera's 40 leading the Roncalli Jets. The junior varsity won both as well led by Kevin Miller's 41 and Josh Stangl's 42.
