## First Annual John Schmitt Memorial Ride to Benefit C.O.P.S.

As the late John "Spike" Schmitt of Kewaskum looks down on the community he gave his life to serve he will be smiling. Especially on his wife, Carla as she rides along with over 800 others in the first annual John "Spike" Schmitt Memorial Ride this Saturday.

The participants will depart Bob's Harley Davidson in Fond du Lac at noon.

The ride will benefit C.O.P.S. (Concerns of Police Survivors).

Carla says she is quite eager to partake in the ride. She has recently received her bike license. She recalled last summer when her and John rode together in the ride celebrating Harley's 95th anniversary.

Registration will start at 7:30 am and close at 11:30 am. The ride will take place rain or shine.

The ride consists of a 100 mile Poker Run with five stops and will depart from Bob's Harley-Davidson, N6584 Rolling Meadows Dr.

After leaving Bob's Harley they will go straight to Hickory street and turn right, and follow that until CTH Y where they will turn right and follow CTH AY and turn left where they will proceed to Brownsville and turn left on STH 49. They will travel on STH 49 until turning right on STH 175. STH 175 will take them into Theresa to CTH P where they will turn right and ride until they arrive at STH 33 stopping at Hillcrest Tavern.

After their first stop, they will continue south on CTH P through Rubicon to STH 60 where they will turn left and travel through the City of Hartford. Upon arrival at STH 175 in the Village of Slinger they will stop at Raceway Tavern.

Following that stop they will then take STH 175 North through Slinger to St. Lawrence making their third stop at Guerdnt's Tavern.

After that stop they will continue northbound on STH 175 to Theresa and then turn right on STH 28 to the Village of Kewaskum, stopping at Grand Larsony.

They then will proceed to their last stop, taking STH 28 east out of the village to STH 144, turning right and going into Barton and turning left on Schmidt Road past the Sheriff's Department to STH

## New District Administrator To Start Here July 1

Kewaskum's new administrator will officially assume his post in Kewaskum on Thursday, July 1.

Wayne P. Graczyk of Fond du Lac comes to Kewaskum after leaving his position at the Hustisford School District where he was employed as the District Administrator since 1996.

Graczyk left Hustisford who has two schools, Pk-6 and 7-12 with 456 students, three administrators, 32 certified staff members, six CESA Certified Staff members and 20 support staff members. Their annual budget was \$3.9 million.

Kewaskum has five schools, three being K-5; one, 6-8 and one, 9-12. The total combined number of students is 1,925. Kewaskum has 12 administrators, 147 certified staff members and 78 support staff members. The annual budget was \$15 million.

From 1992 to 1996 he was principal at Shiocton Elementary/Middle School in Shiocton, WI. A Pk-8, early childhood, pre-school, LD, ED, Speech, CDB/CDS and migrant program. The school enrollment was 540 students. It employed 45 certified staff members and 15 support staff members.

From 1988 to 1992 he was Principal at St. Mary and Joseph School in Fond du Lac, WI., a K-8, two buildings, 395

Several area communities came together to mourn the death of Joshua John "Bud" Panko on Sunday, June 6, 1999.

Bud, age 9, of W181 County Trunk C, St. Cloud, was killed June 3, while walking with his mother, Brenda (Ketter) Panko, to help his father, Dave Panko, at their restaurant,

The Idlewile Inn in St. Cloud.

He dropped his ever-present basketball on the road and went to retrieve it, and was hit by a milk truck. The truck driver had slowed down and moved over, and his mother had warned him the truck was coming. It was an unavoidable tragedy

## Farm Accident Kills St. Cloud Teen

TOWN OF KEWASKUM- An 18 year old St. Cloud teen tragically lost his life as a result of a farm accident Tuesday afternoon, on the Arthur J. Buss Farm just north of the village on STH 45.

Ben J. Knuth, St. Cloud, was raking hay in a field on the Buss farm. He encountered a slope in the field and lost con-

trol of the tractor, the tractor overturned and threw him to the top of the cab where he received a fatal blow to the head.

Fond du Lac County Sheriff's Department responded along with Kewaskum and Campbellsport Rescue Squad.

Knuth was pronounced dead at the scene by the Fond du Lac County Medical Examiner

The accident is under investigation by the Fond du Lac County Sheriff's Department.

## Heated Discussion Held On Village Noise Levels; Garage Hours Extended on Saturday

Kewaskum village board members opened their first June meeting by presenting retiring Kewaskum High School teacher Larry Ammel with a Proclamation of Appreciation.

The Proclamation to Larry Ammel read, "in grateful recognition of your many years of faithful, efficient and dedicated public service rendered to the School District of Kewaskum and Village of Kewaskum." June 7, 1999 was proclaimed LARRY AMMEL DAY within the village.

Former board member Gary Gavin was also presented with a Certificate of Appreciation from the Mid Moraine Municipal Association for his service on the Village Board over the years.

Under reports by Department Heads, Fire Chief Mark Groeschel reported that the new ambulance had arrived. Groeschel stated, that was the good news. The bad news he had to report concerned the 1982 pumper had developed another hole on the passenger side was dripping constantly. He stated the equipment committee would be meeting very soon to decide what the options would be on the pumper and would report back to

the board.

Groeschel, along with Village Administrator Daniel Schmidt, also reported on the July 3rd (rain date July 4) fireworks display. They stated the final order would be placed within a few days. Thus far, Chief Groeschel reported, as far as aerials were concerned, there has been as many fireworks purchased as last year, however, the ground displays were down a little. However, Groeschel stated, "All in all, it should be a pretty good show."

Prior to Police Chief Richard Knoebel's report, President Wagner opened comments and discussion on the review of the village noise ordinance. Wagner was referring primarily to the noise levels generated by "altered" motorcycles and also loud stereo systems.

Wagner had done his homework by contacting Harley Davidson headquarters in Milwaukee, the Environmental Protection Agency and law enforcement agencies in Washington. His issue came with the quality of life he desired for the village. He was informed that the larger street bikes come out of the factory reach only 80 decibels, actually the same noise level as a vacuum cleaner.

He further explained that law enforcement agencies informed him that modified exhaust systems were in violation. It was not necessary to carry noise meters, you simply had to adopt an anti-tampering ordinance.

In regards to car stereos, Wagner added, there is a state statute that says if you can hear a car stereo 75 feet away, you write them a ticket.

Police Chief Knoebel and Wagner disagreed on the issue of how to enforce the statute and how to determine these issues.

Wagner stated, "It's just common sense. Basically, I'm not out to harass bikers in this community. I'm out to stop those that come through the community shaking the roofs off the house."

As voice levels rose, Trustee Jon Kenworthy interjected and called for a "time out" during the heated discussion, to cool off and allow other board members to ask questions.

A member of the audience, Gary Gavin, added he thought the village might be opening a whole different can of worms, stating who determines what noise levels are irritating to fellow citizens, whether it be a bike, a stereo or a chain saw.

"We're a law enforcement

agency, let's enforce the law," Wagner concluded.

The issue was not resolved but rather seemed to be tabled until more information on the statutes could be gathered.

Trustee Andrew Kuehl, Chairman of the Public Services Committee, reported his committee approved extended hours for lawn and yard waste drop off. The board unanimously approved the extended hours at the village garage. For the summer months, extended hours will be held every Saturday from 9 to 11 a.m.

Trustee Andrew Pesch stated the Plan Commission had met on May 25, and reviewed the final plat for Old Glory Heights subdivision. With a few minor changes, the Commission sent a favorable recommendation back to the full village board.

Trustee John Kenworthy, representative to the library board, reported that librarian Kitty Hlavaty has resigned following 17 years and he expressed the board's regrets upon hearing of the resignation and appreciation for Kitty's dedicated service and commitment to the library in this community.

Under New Business, the board passed resolutions regarding a county-wide clean sweep program, the July meeting schedule, the Intent to Apply for an Urban Forestry Grant Program and their support of the Rails to Trails Program.

## Local Dairy Queen Attempting National DQ Drive-Thru Record

Dairy Queen of Kewaskum will be attempting to set the National Dairy Queen Drive-thru record for most number of cars served in one hour.

The current official DQ drive-thru record is 120 cars in one hour held by Louisville, Kentucky. The "unofficial" record was set last week by the Dairy Queen in Bellingham, Washington at 145 cars in one hour. "We're not going to make it official until the register tapes have been verified," said Tara Follmuth at International Dairy Queen.

Kevin Scheunemann, owner/operator of DQ Kewaskum, was presented with the "Fastest Drive in the Market" Award for 1998 in April. "We have a great crew. They understand the urgency of having a fast,

efficient, and accurate drive-thru," says Scheunemann. He continued, "I'm confident that we will not only break the record, but shatter it by a wide margin. I wouldn't be surprised if we're able to get 200 cars through in one hour."

A 200 car hour would bring the National DQ drive-thru trophy home to Kewaskum Dairy Queen.

There will be two attempts at the National Title. One will be from 6 to 8 p.m. on Sunday, June 27, and another on Saturday, July 3, also from 6 to 8 p.m. "The June 27th attempt will be a warm-up," says Scheunemann. "We hope to at least break the Wisconsin DQ drive record that day, and then the National record on July 3."

For participating vehicles, Kewaskum Dairy Queen will be offering its signature product, the 12 ounce BLIZZARD treat, for only 99 cents in drive thru. Each vehicle is limited to one BLIZZARD at the 50% off price per trip. "However, there is no limit to the amount of trips a customer can make around the drive-thru," says Scheunemann. "I know one customer already who is going to

make six trips around the drive thru in order to get six 99 cent blizzards," he added.

Cash prizes will be awarded for the top two poker hands.

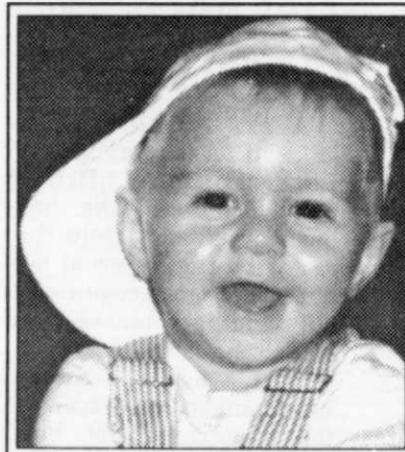
Registration fee is \$20 per person, which includes food, music by "Bar Fliez" and door prizes. \$10 at the gate for those not participating in the ride.

The participants are scheduled to arrive in the Village of Kewaskum at 3 pm. They will be parking on Railroad Street which will be closed until the bikers leave.



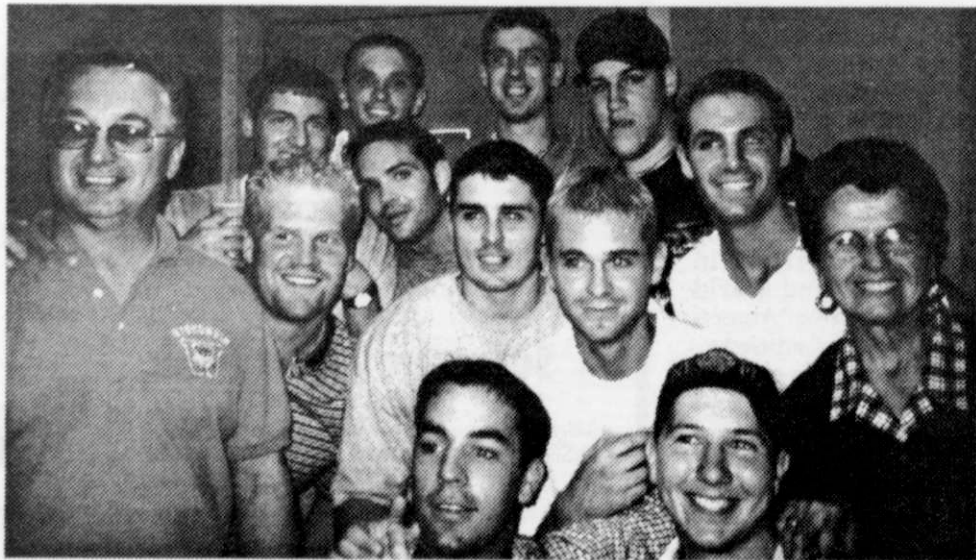

This last school year, Bud attended St. Paul's Lutheran school in the Town of Forest, East of Fond du Lac. This is a small school where values are emphasized and practiced. In that nine months, Bud changed dramatically. His belief and trust in God influenced his family and his classmates tremendously. He was not afraid to show his love of God or his love for his parents. When asked to write a story about his favorite idol, he chose his mother.

Visitation for Bud was held from 11:15 a.m. until 3:15 at St. Paul's Lutheran Church, where Bud attended school. Approximately 700 people attended to express their condolences to the family.

Funeral services were officiated by Reverend Mark Barez, followed at 3:30 at Faith Lutheran Church in Fond du Lac.

The previous week, Bud sang a "goodbye" song with his schoolmates to the eighth grade graduates. On this day, at his funeral, his schoolmates sang the same song for Bud.

The 91st Psalm was also read because Bud had marked it as his favorite in his hymnal. Bud influenced his family, friends and classmates with the light of his faith during the past year. The theme of the service, "Cherish the Gift" was uplifting and positive in spite of the tragic occasion.

As the funeral procession

proceeded to Union Cemetery in Campbellsport, a storm broke out. Cars proceeded through falling trees, hail and blinding rain. Bud's mother remarked that she wished there would be a rainbow because Bud loved rainbows.

Later, family and friends gathered at the Town of Auburn Town Hall on Highway 45 to offer each other support and share a meal. As the family left the hall, a full double rainbow appeared in the sky.

Bud loved basketball and carried one with him most of the time. He loved all kinds of sports, but basketball was his favorite. Bud's biggest dream was to have a gym in his school. Family members and friends feel that something good must come from this tragic accident.

Had Bud's life not been cut so short, he may have continued to spread his light of faith to many. But that was not meant to be. What better way to continue the spirit of his life, than to help make Bud's dream of a gymnasium in his school a reality?

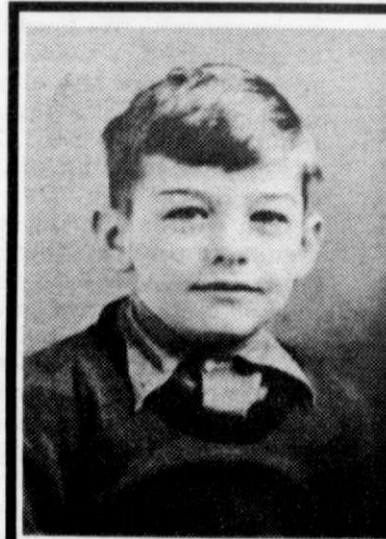

## New Individualized Anesthesia For Surgery Patients at St. Joseph's

A new noninvasive technology that directly measures the effects of anesthesia on the brain during surgery is "customizing" anesthesia for patients at St. Joseph's Community Hospital of West Bend.

The hospital recently installed the Bispectral Index or BIS (pronounced "biz") made by Aspect Medical Systems of Natick, Mass. It offers the first direct method of measuring the effects of anesthetic and sedative agents on the brain, using an enhanced EEG (electroencephalogram) monitor.

Patients are often concerned that they will not be fully "asleep" during surgery or will remember the procedure because they received too little anesthetic. Too much anesthetic, which is more likely to occur, can mean a longer recovery and side effects such as nausea. The BIS technology reduces the chances that a patient will get too little or too much of the drugs.

Patients wake up faster after surgery, are more alert and can go home sooner. Ultimately, the reduced hospital time and appropriate drug amounts are cost-effective for both hospital and patient.

"Patients care about this. It addresses patients' concerns about whether they will wake up before their surgery is over or be aware of what's going on. Each person's need for drugs during surgery is different. The new technology gives us 'real time' information about the patient during surgery," said Jim White, manager of anesthesia services. "It's used throughout the anesthesia process, from the time the patient goes to sleep until he or she is awake."

Eric Breckenridge, D.O., medical director of anesthesiology, said anesthesia providers have always relied on the use of standard dosages, along with a patient's vital signs -- heart rate, blood pressure, pulse -- and their own professional experience and knowledge to determine the amount of anesthetic drugs a patient needs. Now those techniques are integrated with BIS technology that directly measures the patient's level of consciousness.

"You know the patient is

effectively asleep throughout the operation," he said.

The new equipment includes a three-electrode sensor that is placed on the patient's forehead and temple to continuously monitor brain waves.

St. Joseph's is one of the first hospitals in the state to add the new BIS monitoring system to all four of its surgical suites. It is being used for all patients requiring general anesthesia. The new technology is also in use at several large medical facilities in the region, including St. Luke's and St. Joseph's in Milwaukee.

As of May 1999, more than 400,000 patients have been monitored with BIS technology, which is in use

at hundreds of healthcare facilities nationwide. Clinical studies, as well as routine use at these facilities, have demonstrated that the BIS monitor improves quality of care by:

- \* Reducing the average amount of anesthetic drug administered. Less drugs leads to faster, more predictable patient wake-up times after surgery and smoother recovery, as well as reduced costs.

- \* Helping to assess the risk of intraoperative awareness, which is the unintentional regaining of consciousness during surgery. Though a rare phenomenon, an estimated two percent of surgical patients experience awareness.

### Public Invited To Join Friends Of Saxonia House

The general public is invited to join Friends of Saxonia House, Inc., a non-profit organization for Clean-Up Day at the Saxonia House in Fillmore on Sunday, June 27, from 8 a.m. to 5 p.m.

The house is located 1/8 mile east of the intersection of Highways M and H, southeast of Kewaskum. Participants should bring rakes, shovels, axes, saws, and other clean-up tools and supplies and should wear gloves and sturdy

shoes. Bring your own sandwich and beverage for lunch if you plan to help the whole day.

The Saxonia House is believed to be the largest standing half-timber-construction house in the United States. Friends of the Saxonia House, Inc., plan to restore the house, barn, other buildings, and beer-storage cave and reconstruct the former Farmington Brewery on the property as the Saxonia House Living History Museum.

## Driver's License Extension Card Replaces Sticker

Those drivers selected for a four-year extension of their driver's license will receive an extension card rather than a sticker beginning in July, the Wisconsin Department of Transportation announced recently. Wisconsin's safest drivers currently receive a silver four-year extension sticker to place on their driver's license when the license expires.

Beginning with July extensions, a card with green and black print, a green state seal and a drawing of farmland will be issued to safe drivers with

soon-to-be-expired licenses. Once the extension fee is paid, drivers issued the extension card need to write their driver's license number on the card, sign it and carry it with the driver's license at all times. Although the license shows an expired date, the extension card makes it good for another four years.

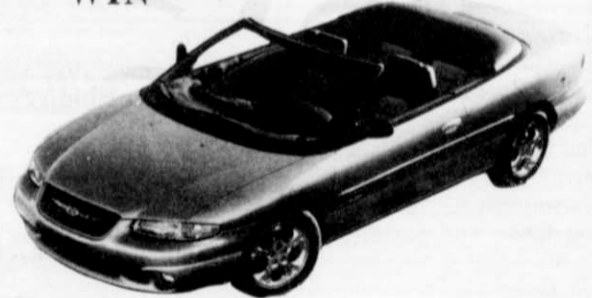
The driver's license extension process is being used to phase in the new eight-year license, which went into effect February 1, 1998. The four-year automobile Class D extension is \$12; the eight-year automobile Class D renewal license is \$24. Drivers who do not receive an extension notice need to go to a WisDOT DMV customer service center to renew and receive an eight-year license.

## Boating Safety

Warm weather and holiday weekends mean increased boat traffic on area lakes. Because of this, now is a good time to re-emphasize the importance of safe boat operation.

Each year several people lose their lives and many more are seriously injured in boating accidents that could have been avoided. One of the easiest ways to practice safety while boating is to wear a P.F.D. (Personal Flotation Device), commonly known as a life jacket.

Life jackets have become lighter and more comfortable to wear over the years and are a relatively inexpensive way to ensure your safety while on the water. The law does not require you to wear a P.F.D. while boating, but it is strongly encouraged. The law does require that one wearable type P.F.D. be on board for every person in the boat, and that they are readily accessible.

Every person that operates a boat is responsible

for the safety of their passengers, and for obeying the boating laws. It is important to remember that there are many different activities that take place on our waters, such as swimming, boating, water skiing, fishing and skin diving. Boats must stay at least 100 feet away from any skin divers flag, as well as 100 feet away from swimmers.

Boats must operate at a speed of slow-no-wake when within 100 feet of any dock, raft, pier, or buoyed restricted area. In addition to these speed restrictions Personal Watercraft (also known as the trade name Jet-Ski) must also operate at a speed of slow-no-wake when within 100 feet of any boat or another Personal Watercraft.

By exercising good common sense, extending courtesy to your fellow boaters and lake users, limiting alcohol consumption while boating, and obeying these boating laws, your chances of having a fun and safe summer are very good.

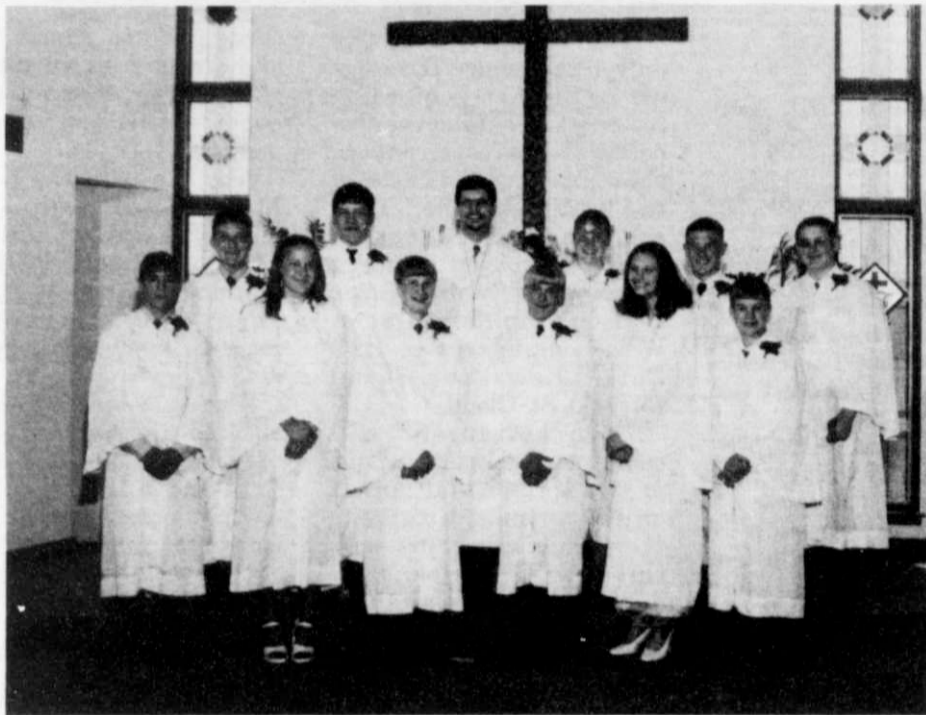

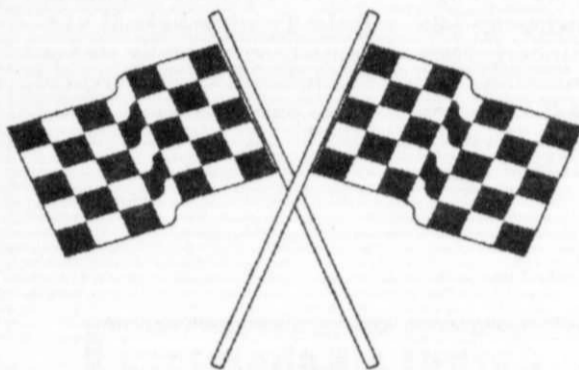

The Village Board of Kewaskum, Washington County, Wisconsin, met in Regular Session in the Council Room of the Municipal Building, 204 First Street.

President Robert Wagner presided. All other Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

A public hearing was conducted on the applications for Combination Class "B" Fermented Malt Beverage and Intoxicating Liquor License renewals. There were no objections from the floor to any of the applications as publicly noticed and read. The Police Department had no objections to the applications. On a motion by Trustee Harry Roecker, seconded by Trustee Andy Pesch and carried by the majority roll call vote, the Board closed the public hearing. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent".

A public hearing was conducted on the application for Combination Class "A" Fermented Malt Beverage and Intoxicating Liquor License renewals. There were no objections from the floor to any of the applications as publicly noticed and read. The Police Department had no objections to the applications. On a motion by Trustee Warren Dums, seconded by Trustee Robert Stoltzmann and carried by the majority roll call vote, the Board closed the public hearing. Roll call vote was 6 "Aye" 0 "Nay" 0 "Absent" 1 "Abstention" (Trustee Andrew Kuehl)

President Robert H. Wagner presented Gary Gavin with a Certificate of Appreciation from the Mid-Moraine Municipal Association for his number of years service to the Village of Kewaskum as a Trustee. Mr. Gavin received a round of applause.

Fire Chief Mark Groeschel presented the May 1999 monthly report: Fire calls- 3, Year to date- 15; Jaws- 2, Year to date- 11; Rescue calls- 17, Miles- 344

Some general discussion took place regarding the delivery of the new ambulance and the 1982 pumper again having a leak in the tank.

It was noted that the Village Fireworks display will be an estimated \$6,500, similar to that of 1998.

Chief of Police Richard Knoebel was present and responded to President Robert Wagner's review of the enforcement of the noise ordinance as it would apply to motorcycle and vehicle stereo noise.

President Wagner began by reading the definition of noise and sharing information received from the EPA on motorcycle exhaust systems. It was noted the Village's ordinance is more complicated than it needs to be making it very hard to enforce. This has been acknowledged by Village Attorney Gerald Kiefer and further comparisons to other municipal jurisdictions within the County and elsewhere. The Village Board and people in attendance did not support the specific

random enforcement on motorcycles, etc. but more on an individual complaint basis. President Robert Wagner promoted the enforcement of the EPA rules regarding tampering and suggested the Village adopt a federal anti-tampering ordinance. After an extensive and often times intense discussion, it was left that the Police Chief is to check further into the matter and report back to the Village Board in the near future.

Director of Public Works, Jerry Gilles informed the Board of the following:

1) Reported a water service leak on Moraine Court that required repairs.

2) The Village of Kewaskum was given the anticipated schedule for asphalt repair and replacement work.

3) Informed the Board of the misinformation some residents have regarding the Village working on some of the storm water problems on private property. It should be noted the Village will try and assist with the correction of such a problem but that the corrective action is then billed back to the property owners.

4) Reviewed the price quote received for the railing wings and a one section addition to the railing adjacent to the creek on Wildlife Drive. (Estimate \$13,94.75) The Board will review the railing and it is to be placed on the next meeting agenda.

## Peterson and Morgan Split Late Model Feature at Slinger Super Speedway!

(Slinger, WI) Cindy Peterson (Butler) and Conrad Morgan (Waukesha) each won 50 lap late model features as Slinger Speedway hosted both the Bob Fish Pontiac, Buick, GMC Alan Kulwicki Memorial and Round One of the Mobil and Coca Cola Triple Crown Classic.
