All Set for Last Kettle Kountry of the Century

It began as a dream. Ideas started to develop. Soon it magnified, deepened and snowballed. Preliminary plans were made. Events were scheduled. Finally, following many meetings and hours of preparation in the fall of 1989, the first Kewaskum Kettle Kountry Kolors was born and the dream became a reality!

Kettle Kountry Kolors celebrates its tenth annual appearance on Saturday and Sunday, October 9 and 10 at River Hill Park and along the banks of the serene Milwaukee River in Kewaskum. Coincidentally, it is also the last Kettle Kountry of the 20th century.

Although committee members have changed over the years, some have come and some have gracefully retired, the emphasize for this event has remained constant over the years... family fun at little or no cost to festival goers.

The Kewaskum Area Chamber of Commerce members have been diligently working to provide another outstanding weekend here in the beautiful Kettle Moraine. It is the Chamber's intention to share our own little corner of God's country to all who care to appreciate its fall brilliance.

Many people have enjoyed Kewaskum Kettle Kountry Kolors over the years with an estimated attendance of over 10,000 in 1998. This year's festival has many popular returning attractions, plus a host of new activities, again, at little or no charge!

Making a return along the banks of the lazy Milwaukee River, amid the rich hues of autumn, will be the camps and lodges occupied by the ever-popular Buckskinners. At this

teaching encampment, members will gladly explain to you the "tricks of the trade" during the Buckskinner era. Watch a blacksmith create a masterpiece, cheer at the "hawk (tomahawk) throwing contest," marvel at the expert whip demonstration, and enjoy the sights and sounds of a time that seems forgotten.

Children will find lots of fun things to see and do. A special children's activity tent will feature Animal Encounters, juggling, Dancercise Kids, puppets and music. Bingo the Clown will fascinate many with shows scheduled at 10:30 a.m. on both days of the festival. Pumpkin carving, a basketball shootout, make-it-and-take-it crafts, a BB gun shoot and a hole-in-one golf contest are activities sure to delight young and old alike.

Be sure to check out the State Patrol safety equipment display and you won't want to miss the Reserve National Guard helicopter landing and exhibit on Saturday. Also featured on Saturday, back by popular demand, will be the professional wrestlers, a current trend in spectator sports, featuring The Sodbuster, "Kenny J," who will perform on Saturday during matches at 1 and 4 p.m.

For your listening pleasure, enjoy the sounds of the Kewaskum High School Jazz Band, Twin Hill String Band, Blues Blisters from Fond du Lac, Joey Minz and the soothing, peaceful sounds of InterRaymi, a favorite of last year, playing native music of the Andes.

Sunday will feature the annual 5K Kewaskum Youth Scholarship, Inc. (KEYS) walk/run beginning at 11 a.m. The event is open to everyone. The course winds through the village of Kewaskum and can be completed as quickly or leisurely as one would like to take

it. It would take the average person approximately one hour to walk.

Sunday begins with a tasty pancake breakfast, sponsored by the Kewaskum Sno Chief, served from 8 to 11 a.m. Peace United

Church of Christ of Kewaskum will sponsor the annual church service at 9 a.m. again this year in the Children's Activity Tent.

Whatever you are in search of, there's a good chance you'll find that spe-

cial gift item (and one for yourself!) in the popular craft tents. Each year the tents and outdoor displays expand, allowing new vendors and familiar vendors to show and sell their crafts-

Conference Football Rivalry Resumes At Kettle Moraine Bowl Here On Friday

Former Scenic Moraine foes, the Kewaskum Indians and the Campbellsport Cougars will face each other again in conference action for the first time in 20 years this Friday on the Kewaskum High School football field.

The intense rivalry felt years ago will take on a whole new meaning Friday night in the first newly-developed Kettle Moraine Bowl, which will be held annually when the two teams square off during the football season.

The competition between the neighboring football teams began many years ago when Kewaskum and Campbellsport were both members of the Scenic Moraine Conference. In 1979 the WIAA re-aligned the conferences with Camp-

bellsport going to the Flyway Conference and Kewaskum was placed in the Eastern Wisconsin Conference. The Indians played for the first time in the tough EW conference in 1980.

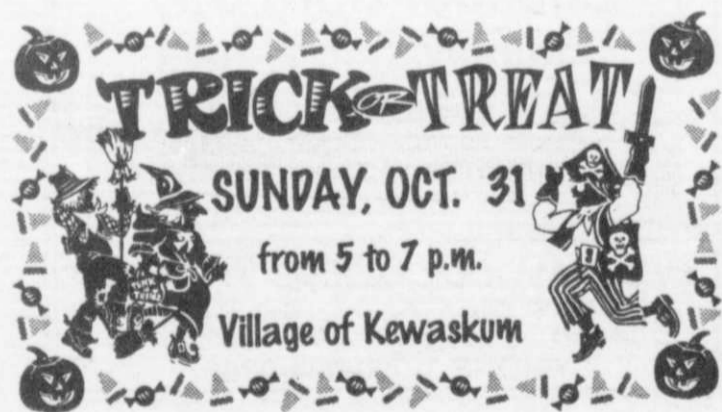
In a recent conference move, Campbellsport, too, was transferred to the Eastern Wisconsin, which meant the two teams will again be meeting each other every year in conference action, where all games count!

On Friday evening, the two teams will again be going head-to-head as conference rivals for the first time in 20 years. In honor of this auspicious event, the schools have come up with the idea of making it an annual Bowl, calling it the Annual Kettle Moraine

Bowl.

The winner of the prestigious football game on Friday will take home the traveling trophy, until the two teams meet again the following year. The trophy will be awarded this year by KHS Principal Robert Ganka. The trophy will then "travel" to the winner of the Kettle Moraine Bowl annually.

Don't miss this new twist to a traditional rivalry with our neighbor to the north. Who will win the first annual Kettle Moraine Bowl? Attend the football game this Friday at 7 p.m. between Kewaskum and Campbellsport to find out where the trophy will be displayed for the upcoming year.



EDUCATION... It's Everyone's Business

Last week I spoke about taking stands on issues. For those that weren't able to read the article I stated that **Stands are different, that they don't allow much wiggle room. They cost, and they usually bring a fair amount of pain somewhere along the way. They can be divisive, too, and get people hollering at each other, and slip in under your skin like a sliver that begins to fester round about everything else that needs doing. But I also said that stands can unite as well. They can galvanize around a cause or around a dream or sometimes even around a love. Stands can do good things. Opinions just itch, mostly like mosquito bites.**

Yes, education is everyone's business. In this week's article I want to reaffirm my belief in the democratic process. A referendum is an opportunity for a governmental agency to seek approval from the community and for the community to voice their opinion. It is also an opportunity for both to make a stand.

I think that we all agree that people should be informed before casting any vote, to take the time to ask questions, to seek out information. For example, I wonder how many people know that the proposed elementary school referendum here in Kewaskum, if approved, will **not raise** the school tax rate (mill rate) over the duration of the twenty-year loan? And I wonder how many know that with the state aid formula currently in place, about 50-55% of the entire \$11,700,000 will be paid for by the state?

When the referendum was adopted for a district elementary school program, I requested that the school board allow me to coordinate the process of getting the information to the public, and they agreed.

My approach was to form a volunteer Grass Roots Referendum Information Committee (R.I.C.). It was formed with a single purpose: to inform the public about the content, and impact of, the proposed referendum, but do it with community members talking to community members.

The R.I.C. consists of community people and is chaired by Ann Wicklund (Wayne), Ruth Reis and Colleen Herbst (Farmington) and Connie Zemlicka and Gordie Dickman (Village). A flyer has already been mailed and should have been delivered to your home explaining what is in the referendum, why it was proposed, how the question on the referendum was decided, and the cost implication to the taxpayer.

If it has not arrived, please call one of the chairpersons and a copy will be sent to you. A Speaker's Bureau has also been formed and every club and organization we could identify is being contacted. A member, or members, of the speaker's committee will make a short presentation to the club membership in October and would be available to answer questions. If for some reason your club or organization was not contacted, or if you have a small group that you would like to invite us to, please call me at the district office (626-8427).

Yes, making a stand doesn't always give much wiggle room, but it can unite. With an informed electorate, my hope is that the stand made on the November 2 referendum will unite the community by doing what's right for the elementary age, pre-school age children, and for the community. You might call it Kewaskum Pride!

I mentioned earlier in this article that the school tax rate would not increase for the twenty-year duration of the loan. I also said the state will help pay for Kewaskum's referendum. This is what I mean by being an informed voter. For the past three years the mill rate (school tax rate) has been kept constant at \$10.56 per thousand dollars of equalized value.

School district residents need to know that the school tax rate will not rise as a result of the referendum. It will remain the same as the past three

years. I'm sure you've read about large referendums passed by other districts around the state. Did you know that **you** are helping pay for them through your tax dollars?

The fact remains that, through the state aid formula as it's currently written, the state will be helping Kewaskum residents pay for the \$11,700,000 referendum for the elementary program. The state will pay, through their state aid formula, approximately 50-55% of our referendum. What does this mean to the taxpayer of the Kewaskum School District?

It means that approximately \$6,000,000 of the referendum will be paid by the state with the remaining amount paid with local tax dollars. I am not sure how others see this, but I believe this is a tremendous benefit to the community, as well as the children. For years now, whether you knew it or not, you have been helping to pay for other school district referendums. Wouldn't it be nice to know they will now help pay for ours?

Over the next four weeks I will be utilizing **Education... It's Everyone's Business** to provide information and respond to the most frequently asked questions. The Referendum Information Committee also has a date to appear on WBKV radio to review the referendum and respond to any questions or comments from callers. That date and time are tentatively scheduled for Tuesday, October 19, 1999, from 6 to 7 p.m.

Stay tuned and check your radio listing when it becomes available.

I am open to phone calls or personal visits if you have specific or general questions. I personally would prefer a call to schedule an appointment, but am open to an unannounced visit. However, with an

unannounced visit there is always the chance that I will be engaged in some activity or meeting and unable to meet with you. I would rather be able to meet with you, especially since you took the time to stop in. Please feel free to call one of the chairpersons of the R.I.C.

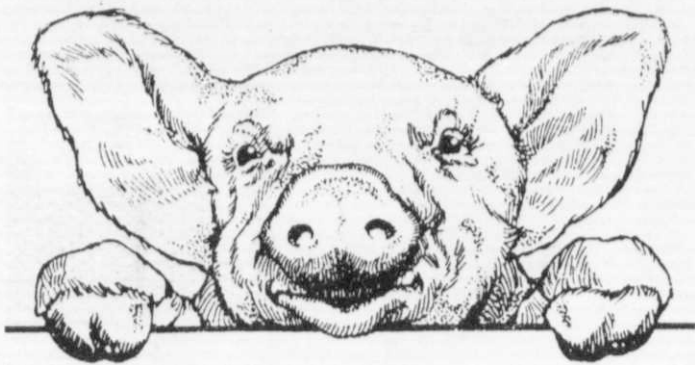

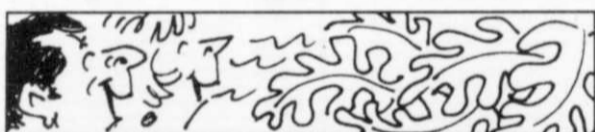

NOTICE TO ELECTORS OF THE SCHOOL DISTRICT OF KEWASKUM RELATING TO ABSENTEE VOTING PROCEDURES FOR A SPECIAL REFERENDUM ELECTION

TAKE NOTICE that a special election shall be held on November 2, 1999, in the School District of Kewaskum. The absentee voting procedures for the special election are set forth below.

VOTING BY ABSENTEE BALLOT

Any qualified elector, unable to get to the polling place on election day for any reason, may ask to vote by absentee ballot. A qualified elector is a person who is a U.S. citizen, who will be 18 years of age or older on election day, who has resided in the ward or municipality where the person wishes to vote at least 10 days before the election. If the voter resides in a municipality which requires voter registration, then registration is also required for the voter to receive an absentee ballot.

To obtain an absentee ballot, the voter should contact the clerk of the village or town in which the voter resides. A written request must be made by the voter for the absentee ballot. If the voter contacts the clerk by telephone the clerk will send the application form to the voter. If the voter requests an absentee ballot by mail, the written request, signed by the voter, which indicates that the voter resides within the municipality, will be honored. Written requests may be made beginning six months before the election. The deadline for receipt of the written request by mail is 5:00 p.m. on the Friday before the election. If the voter goes to the clerk's office to complete a written request, the request must be made no later than 5:00 p.m. on the day before the election.

If the absentee voter resides in a nursing home, the absentee ballot will be delivered to the nursing home by two special voting deputies appointed by the municipal clerk. The special voting deputies will present the absentee ballot to the voter and provide assistance in marking or punching the ballot if necessary. At the request of an absentee voter a relative may provide the assistance. After voting at the nursing home is completed, the special voting deputies will return the absentee ballot to the municipal clerk.

With two exceptions, the voter who wants to cast an absentee ballot, must make a separate written request before each election. If a voter is indefinitely confined to his or her home or a care facility because of illness, age, or disability, or if the voter is in the military, the voter need not make a request before each election. There is a special statement on the application form which is provided by the municipal clerk which can be completed asking that an absentee ballot be automatically mailed to the indefinitely confined or military voter before each election. If the voter fails to vote and return the ballot sent to the voter, a separate written request for the next election must be made before the voter can obtain a ballot.

A voter who is hospitalized on election day may obtain an absentee ballot by designating another person as the agent for the voter. There is a statement on the application form for this purpose. An application by agent for a hospitalized elector may be made in person at the municipal clerk's office no earlier than 7 days before the election and no later than 5:00 p.m. on the day of the election.

If a voter requests an absentee ballot stating the reason that he or she is a sequestered juror, the application can be made no earlier than 7 days before the election, and no later than 5:00 p.m. on the day of the election. If the application from a sequestered juror is received by the municipal clerk after 5:00 p.m. on the Friday immediately preceding the election, the municipal clerk or the clerk's agent will deliver the absentee ballot to the court and the judge will call a recess to allow the voter to cast his or her vote.

The municipal clerk will send the absentee ballot to the voter once the request is received and the ballots are prepared. Absentee ballots are available twenty-one (21) days before the election. The municipal clerk keeps a public record of all individuals requesting an absentee ballot indicating when the ballot is requested, sent, and returned to the municipal clerk.

An absentee ballot can be voted at home any time after it is received in the mail. An absentee ballot can also be voted in the clerk's office if the voter appears in person and fills out the written request. The voter should make sure that the certificate-affidavit is properly completed and witnessed by two persons or a person authorized to administer oaths. The voter and the witnesses must sign the certificate on the absentee ballot carrier envelope. If the absentee elector receives assistance in marking the ballot, the person providing the assistance must sign the statement on the back of the ballot which provides that the person giving the assistance marked the ballot as directed by the absentee voter. The municipal clerk will make sure that the certificate-affidavit is properly completed by the voter when the absentee ballot is voted in the clerk's office.

The completed absentee ballot must be in the possession of the issuing municipal clerk in time for the clerk to deliver the ballot before the polls close on election day. Voted absentee ballots may be delivered in person to the municipal clerk. Any absentee ballot received after the polls close or any absentee ballot where the certificate-affidavit is not properly completed cannot be counted.

To obtain an absentee ballot send a written request to: the municipal clerk of the town or village in which the voter resides.

SHARE Volunteer Service Fund Announced

SHARE volunteers throughout Wisconsin have something to celebrate! The first round of grants from the SHARE Volunteer Service Fund was announced at Volunteer Appreciation Celebrations held throughout the state. Checks totaling more than \$18,000 will be distributed to SHARE host sites in September, for use in local volunteer initiatives.

The Volunteer Service Fund was established as part of the SHARE Select program, which is the latest enhancement to SHARE's self-help food distribution system. On a monthly basis, SHARE distributes food at bargain prices through a network of more than 250 community organizations called "host sites." Volunteers, who work diligently to make the program available in their community, staff the sites. These volunteers, combined with a system of volume purchasing, make the food savings possible.

Everyone is welcome to be part of SHARE; there are no income or eligibility

requirements for participation. Participants are asked to commit two hours of volunteer service to their community each month. This provides the volunteer energy needed to operate the program, plus generates thousands of volunteer hours for local activities. The Volunteer Service Fund was created to add financial resources to expand the activities of SHARE volunteers. Returning 10% of the sale of SHARE Select foods to the host site generates the fund.

"The purpose of SHARE is to build and strengthen the community," said Paulette Hardin, SHARE's Executive Director. "We do that by bringing folks together around a common interest in affordable food and also by encouraging and promoting volunteer service."

Host sites have selected a variety of projects to support with their portion of the Fund. In West Allis they are donating to the Alzheimer's Association. The volunteers in Whitewater are buying needed supplies to help local children start the school year. In Dunn County the volunteers are planning to buy a defibrillator for use by the county emergency medical team. Some sites are banking their money to use for outreach during the holiday season.

"We are so excited about the vision and imagination of our host site leaders," said Hardin. "They have big hearts and even bigger plans. It doesn't take a lot of money to make a big difference. But it does take a lot of commitment. We are so pleased to be a part of their work to build better communities."



WHEREAS, the Village of Kewaskum, Washington County, Wisconsin (hereinafter called the "Village"), is presently in need of funds aggregating Three Hundred Sixty-Seven Thousand Dollars and Zero Cents (\$367,000.00) for public purposes including:

Purchase a new Fire Department Truck Pumper, and Rehabilitate the 1982 Fire Department Truck Pumper.

WHEREAS, this Board deems it necessary and in the best interests of the Village that, pursuant to the provisions of Section 67.12(12), Wisconsin Statutes, the sum of Three Hundred Sixty-Seven Thousand Dollars and Zero Cents (\$367,000.00) be borrowed for such purposes upon the terms and conditions hereinafter set forth:

NOW, THEREFORE, BE IT RESOLVED, that for the purposes herein above set forth the Village, by its President and Village Clerk, pursuant to Section 67.12(12), Wisconsin Statutes, borrow from West Bend Savings Bank (hereinafter called the "Lender"), the sum of Three Hundred Sixty-Seven Thousand Dollars and Zero Cents (\$367,000.00), and, to evidence such indebtedness, said President and Village Clerk shall make, execute and deliver to the Lender for and on behalf of the Village the promissory note of the Village to be dated October 1, 1999, in said principal amount with interest at the rate of Five Point Two Five per cent (5.25%) per annum and payable as follows:

BE IT FURTHER RESOLVED, that there be, and there hereby is, levied on all the taxable property of the Village, a direct annual irrevocable tax sufficient in amount to pay the principal and interest on said note as the same becomes due and payable, said tax to be in the following minimum amounts:

If at any time there shall be on hand insufficient funds from the aforesaid tax levy to meet principal and/or interest payments on said note when due, the requisite amount shall be paid from other funds of the Village then available, which sums shall be replaced upon the collection of the taxes herein levied.

In the event that the Village exercises its prepayment privilege, if any, then no such direct annual tax shall be included on the tax rolls for the prepayment so made and the amount of direct annual tax herein above levied shall be reduced accordingly for the year or years with respect to which said note was prepaid.

In each of said levy years, the direct annual tax so levied shall be carried into the tax rolls each year and shall be collected in the same manner and at the same time as other taxes of the Village for such years are collected; provided, that the amount of tax carried into the tax roll may be reduced in any year by the amount of any surplus in the debt service account for the note. So long as any part of the principal of, or interest on, said note remains unpaid, the proceeds of said tax shall be segregated in a special fund used solely for the payment of the principal of, and interest on, said note.

BE IT FURTHER RESOLVED, that there be and there hereby is established in the treasury of the Village, if one has not already been established, a debt service fund, separate and distinct from every other fund, which shall be maintained in accordance with generally accepted accounting principles. Sinking funds established for obligations previously issued by the Village may be considered as separate and distinct accounts within the debt service fund. Within the debt service fund, there be and there hereby is established a separate and distinct account designated as the "Debt Service Accounts for Promissory Note dated October 1, 1999", which fund shall be used solely for the purpose of paying principal of and interest on said note. There shall be deposited in said fund any accrued interest paid on said note at the time it is delivered to the Lender, all money raised by the taxation or appropriated pursuant hereto, and such other sums as may be necessary to pay principal and interest on said note when the same shall become due.

BE IT FURTHER RESOLVED, that the "proceeds" of said note shall be used solely for the purposes for which it is issued, but may be temporarily invested until needed in legal investments, provided that no such investment shall be in such a manner as would cause said note to be an "arbitrage bond" within the meaning of Section 148 of the Internal Revenue Code of 1986, as amended, or the Regulations of the Commissioner of Internal Revenue thereunder; and an officer of the Village, charged with the responsibility for issuing the note, shall certify by use of an arbitrage certificate that, on the basis of the facts, estimates and circumstances in existence on the date of the delivery of the note, it is not expected that the proceeds will be used in a manner that would cause said note to be an "arbitrage bond".

BE IT FURTHER RESOLVED, that the projects financed by the note and their ownership, management and use will not cause the note to be a "private activity bond" within the meaning of Section 141 of the Internal Revenue Code of 1986, as amended, and that the Village shall comply with the provisions of the Code to the extent necessary to maintain the tax-exempt status of the interest on the note.

BE IT FURTHER RESOLVED, that the Village Clerk shall keep records for the registration and for the transfer of the note. The person in whose name the note shall be registered shall be deemed and regarded as the absolute owner thereof for all purposes and payment of either principal or interest on the note shall be made only to the registered owner thereof. All such payments shall be valid and effectual to satisfy and discharge the liability upon such note to the extent of the sum or sums so paid. The note may be transferred by the registered owner thereof by presentation of the note at the Office of the Village Clerk, duly endorsed for the transfer or accompanied by an assignment duly executed by the registered owner or his legal representative duly authorized in writing. Upon such presentation the note shall be transferred by appropriate entry in the registration records and a similar notation, including date of registration.

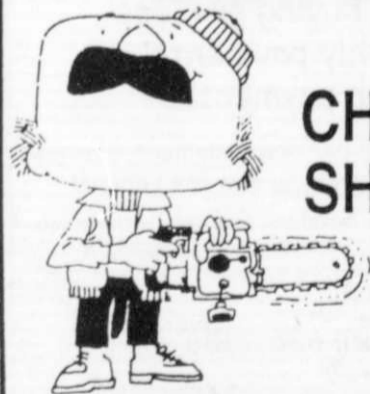

tration, name of new registered owner and signature of the Village Clerk, shall be made on such note.

BE IT FURTHER RESOLVED, that the note is hereby designated as a "qualified tax-exempt obligation" for purposes of Section 265 of the Internal Revenue Code of 1986, as amended, relating to the ability of financial institutions to deduct from income for federal income tax purposes, interest expense that is allocable to carrying and acquiring tax-exempt obligations.

Village of Kewaskum Regular Meeting August 16, 1999 8:00 p.m.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Regular Session in the Council Room of the Municipal Building, 204 First Street.

President Robert Wagner presided. All other Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Harry Roecker, seconded by Trustee Andrew Kuehl and unanimously carried by voice vote, the minutes of the August 2, 1999 meeting were approved as printed.

It was noted the request of the Peace United Church has been tabled until further notice at their request.

Fire Chief Mark Groeschel reviewed the proposal received for the refurbishing of the 1982 fire truck that has a leaking tank and several other major problems. One proposal was received for J & B Fire Equipment at a price of \$54,995.00. No action was taken at this time but will be discussed under new business.

Fire Chief Groeschel reported that the building repairs regarding the siding of the Fire House have been scheduled for completion this fall.

Chief of Police Richard Knoebel presented the July 1999 report:

Criminal arrests 49, Criminal investigations 61, Traffic warnings 142, Traffic citations 55, Adult arrests 27 Juvenile arrests 10, Property stolen \$1,960 Property recovered -0, Parking warnings 16, Parking tags 14

Chief of Police Richard Knoebel reported that the speed sign trailer has been delivered and that it turned out very nice. If all goes as planned, it may be equipped that it can be placed into service later this week.

Director of Public Works Jerry Gilles reviewed the following:

1) The completion of the asphalt work in conjunction with the relief sewer project of 1998.

2) Reported the electrical line around the Municipal Building has been transferred to two new poles and the old poles removed.

3) GTE will be completing the transfer as well and removing an extra pole.

Administrator Daniel S. Schmidt reviewed the following with the Board:

1) Review of League and Taxpayer bulletins.

2) Review of the budget control sheet for period ending July 31, 1999.

3) Review of Mid-Moraine Municipal Association Meeting for August 25, 1999.

4) Review building permit report for month of July 1999.

5) Review of correspondence.

Chairman of the Administrative Committee, Trustee Robert Stoltzmann announced that the next meeting of the Committee was scheduled for September 20, 1999 at 6:45 p.m.

Chairman of the Public Services Committee, Trustee Andrew Kuehl announced that a meeting has been scheduled for September 20, 1999 at 7:15 p.m. to review budget items for 2000 as well as the recycling grant application for 2000.

Chairman of the Public Works Committee, Trustee Warren Dums reported that Mr. Frank Krueger was present to discuss with the Board the need for a catch basin within Prospect Street. On a motion by Trustee Robert Stoltzmann, seconded by Trustee Andy Pesch and unanimously carried by voice vote, the Board authorized the placement of a catch basin and connection line in Prospect Street at an estimated cost

of \$1,200 to \$1,500.

Chairman of the Park and Recreation Committee, Trustee John Kenworthy reported that a meeting was held and a variety of budgetary items were reviewed. It was noted the committee recommended that work proceed on budgeting for the in-line skate path/park within River Hill Park and that the suggestions made by the EDAC be considered.

Plan Commission, Board Representative, Trustee Andy Pesch informed the Board that a Commission meeting is scheduled for August 24, 1999 at 7:00 p.m.

Library Board Representative, Trustee John Kenworthy reported that a meeting is scheduled for August 18, 1999 at 6:45 p.m.

Administrator Daniel Schmidt reported that the downtown parking lot may get paved later this week and that the other aspects of the lot are falling into place.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee Harry Roecker and carried by majority roll call vote, the Board approved the application for the Kewaskum Chamber of Commerce for Kettle Country Kolors, Beverage Special Picnic/Gathering License and Temporary Special Class "B" License, for October 9 & 10, 1999 at River Hill Park. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent".

On a motion by Trustee Warren Dums, seconded by Trustee Harry Roecker and unanimously carried by voice vote the Board approved Linda Theisen as the agent for the aforementioned.

Administrator Daniel Schmidt reviewed the Department of Administration's preliminary population count for the Village of Kewaskum as of 1-1-99. The population is 3,418, an increase of 246 persons. The number of residents per unit dropped slightly.

Action was taken on Resolution No. 99-29 A Resolution to Place Upon The Present 1999 Tax Roll for

Collection, all Accounts Delinquent as of October 1, 1999 as attached hereto:

On a motion by Trustee Andy Pesch, seconded by Trustee Andrew Kuehl and unanimously carried by voice vote, the Board approved the use of Tony Trolia as a broker to sell the 1972 street sweeper at a 10% commission.

Discussion was held on having an environmental assessment completed on the property located at 1308 Fond du Lac Avenue. It was noted the testing of material in the building would cost an estimated \$780.00 and the final dollar amount for the test holes, etc. was not finalized but projected at \$1,200. On a motion by Trustee John Kenworthy, seconded by Trustee Andrew Kuehl and unanimously carried by voice vote the Board authorized proceeding with said study at a cost not to exceed \$2,000.00. (SIGMA is the company to dig and test the underground and Schauer & Associates the building materials.)

Administrator Daniel S. Schmidt reported that financing proposals for the new fire truck and the refurbishing of the 1982 fire truck were received from four sources and are as follows:

- 1) St. Frances Bank, (M&I), Kewaskum, WI 5.50% to 6%
- 2) State Trust Fund, Madison, WI 5.25%
- 3) West Bend Savings Bank, Kewaskum, WI 5.25%
- 4) Pierce Lease Purchase 5.66%

The amount to be borrowed is \$367,000 at a repayment schedule of 10 years.

On a motion by Trustee John Kenworthy, seconded by Trustee Warren Dums and unanimously carried by vice vote, the Board directed the Administrator to proceed with borrowing the \$367,000 from West Bend Saving Bank at a rate of 5.28%.

On a motion by Trustee Warren Dums, seconded Trustee John Kenworthy and unanimously carried by voice vote the Board authorized the contract for refurbishing the 1982 Ford Pumper to J&B Fire Equipment at a cost of \$54,995.00.

On a motion by Trustee Harry Roecker, seconded Trustee Andy Pesch and unanimously carried by voice vote the Board authorized the contract for the purchase of a new fire truck to Reliant Fire Apparatus/Pierce Manufacturing, Appleton, WI at a cost of \$311,952.00.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee Andrew Kuehl and carried by the majority roll call vote, to adjourn to closed session under Chapter 19.85 (1)(c) of the Statutes to discuss employee performance data and evaluation for Village employees over which the governmental body has jurisdiction. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent".

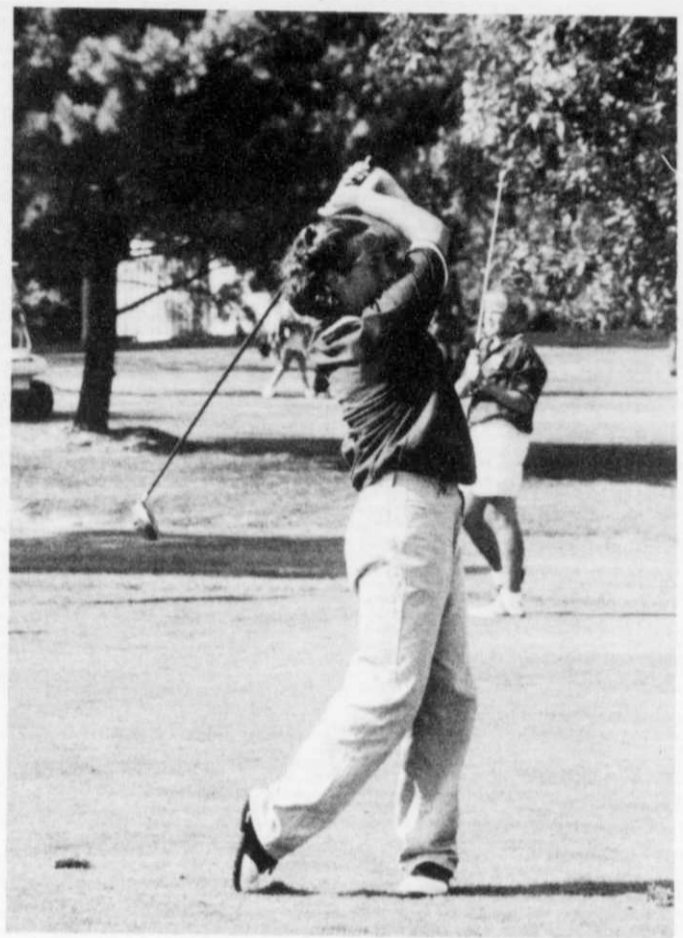

Indians Lose First Game to Sheboygan Falls, 26-14

Kewaskum's undefeated season ended Friday night at the hands of the Sheboygan Falls Falcons.

The Falcons who are rated #2 in middle sized schools in southeastern Wisconsin by the Journal Sentinel football polls, dominated the line of scrimmage enroute to a 26-14 victory. It looked like it could be another big blowout for the Falcons who outscored their first four opponents by a score of 188-14 including a drubbing of conference favorite Manitowoc Roncalli two weeks ago by a score of 47-14.

The Falcons took the opening drive and marched right down the field and scored on Pat Melger's nine yard run with 8:33 left in the quarter. After the Indians were forced to punt on their first possession, the Falcons came back with another touchdown drive capped off with a Matt Kimmeler 14 yard run for a 14-0 lead with 4:18 left in the quarter.

The Indians found themselves pinned deep in their own territory for much of the first half as three times Falcon punts were not caught by Indian returners and three times the ball rolled inside the five yard line. With the Falcons great defense and their offense controlling the clock with a powerful running game it didn't look good for the Indians.

But the offense came alive in the second quarter. Jason Strobel took a pitch around the left end and after making the linebacker miss, he took it up the sideline for an 18 yard touchdown run. Chris Koth's kick made it 14-7 with 10:39 left in the half.

The Indians stopped the Falcons and made them punt it away. Unfortunately for the Indians, no one fielded the ball and it was downed inside the Indian five yard line. After two runs netted no yardage Coach Perry Koth decided to quick kick the ball on third down, hoping to get the ball back onto the Falcons side of the field. The strategy failed however as the kick was blocked and the Falcons recovered the ball in the endzone for a touchdown. The extra point kick was wide right so with 6:26 left in the half, Falls had a 20-7 lead which is what it remained through the half.

In the third quarter the Indians defense made a goal line stand as they stopped the Falcons on fourth and goal from the two yard line. The entire left side of the Indian defense stuffed Pat Melger for no gain as Mike Farchione, Dave Lettow, Adam Beck, Aaron Seiser, Curt Koth and Bob Ogi simply denied the Falcons a score that would have put the game away for Sheboygan Falls.

The Indians starting on

their own two yard line methodically moved the ball down the field until they were stopped on the Falcon 20 yard line. Facing a fourth down and seven yards to go, Coach Koth decided to take the three points to close the gap.

Chris Koth kicked the ball through the uprights for a successful 37 yard field goal. A late flag on the play however found one of the Falcon players had roughed the kicker which meant an automatic first down if the Indians accepted the penalty, however taking the penalty would also negate the three points from the field goal.

The Indians decided to take the penalty which turned out to be a good decision as on the very next play, Koth hit senior tight end Adam Beck on a screen pass and Beck took it seven yards for the score. Koth's kick made it 20-14 with 6:02 left in the third quarter and suddenly the Falcons found themselves in the toughest game of their season. Koth has now kicked 24 consecutive extra points

without a miss.

The momentum seemed to have swung and after a short drive, the Falcons were forced to punt. On the punt however, the Indians had 12 men on the field giving the Falcons a first down. Several plays later Matt Kimmeler scored his second touchdown of the game to finish the scoring for the evening. The Falcons two point conversion pass was incomplete, accounting for the final score of 26-14.

Quarterback Chris Koth threw two interceptions in the second half under a fierce pass rush and with time running out. The task doesn't get any easier this week as the Indians host nearby Campbellsport. This game truly will be a battle as both teams are 2-1 in conference and 3-1 overall.

The game also has playoff significance because the Cougars finish the season against Kiel, Plymouth and then Sheboygan Falls. The Indians finish against Roncalli, Two Rivers and Plymouth. The loser of this week's game will have to win two of their final three

games to make the playoffs. Game time is 7 p.m. at Kewaskum. In another key game this week Plymouth (3-0) is at Roncalli (2-1).

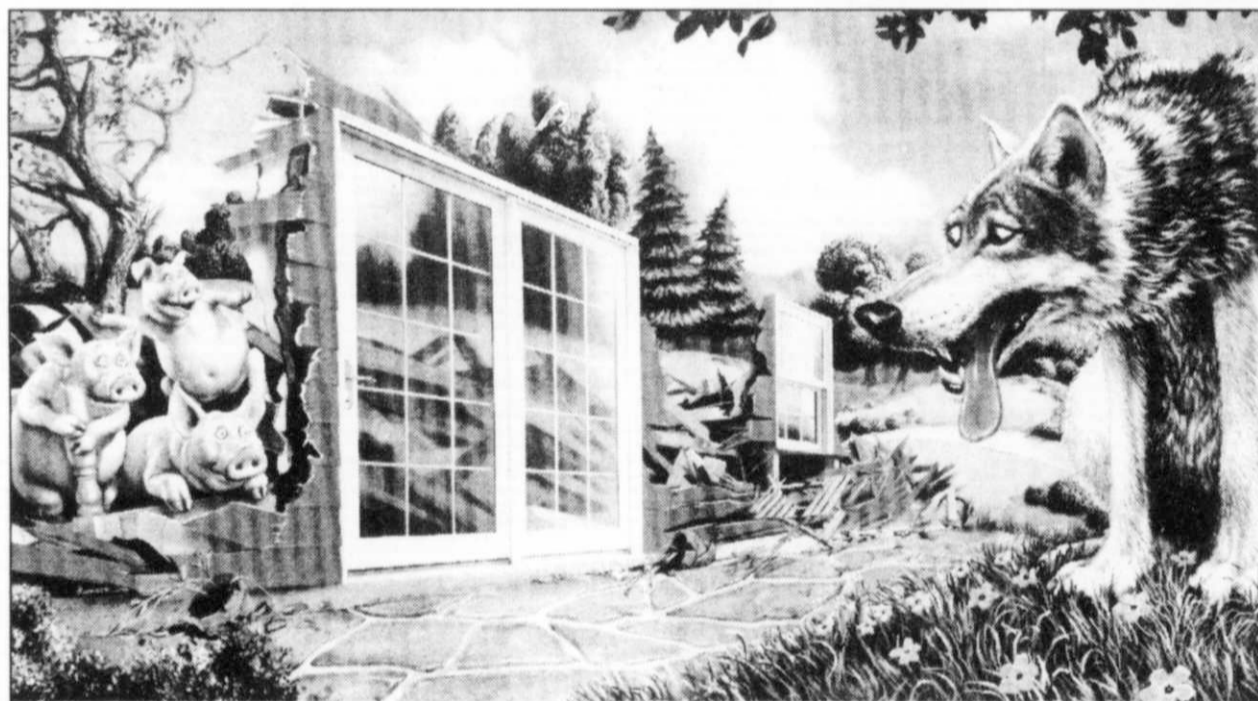
