Democracy... Or Not?

Kewaskum Village President Robert Wagner has taken it upon himself to bring ethics charges against newly-elected village trustee Andrew Kuehl, regarding his lone vote against the liquor license recently granted to Geidel's Piggly Wiggly.

The first point to be brought out is there were a number of options available at the meeting. According to a reliable source, immediately prior to taking the vote, President Wagner, being the president of the board for many years, should have informed the inexperienced trustee that he felt there was a conflict of interest and told Kuehl he should abstain from the vote. Or following Roberts Rules of Order, could have called a point of order. He chose at the time to do neither one.

Instead the board president and fellow board members all chose to say nothing and take matters "down and dirty" later on. Just who is violating a code of ethics? The inexperienced trustee who voted no because he felt his question had not been sufficiently addressed or the fellow experienced board members who have now decided to "hang the new trustee out to dry" and "make an example out of him?"

This trustee happens to be my son. Another conflict of interest? Perhaps so, but I have **ALWAYS** tried to report **ALL** village board proceedings, before and after Andrew's election, as objectively and unbiased as possible. The Geidel story was one of the most difficult stories I have ever had to write. My husband owns a liquor store, my son is a trustee, but I feel I still tried to remain objective with the story. I felt I did. Perhaps not. I guess you would have had to attend the meeting and judge for yourself, or ask the Geidels.

The second point I would like to make is, how will **YOU** explain to **YOUR** children that standing up for what they believe in is wrong. I have spent the past 19 years trying to teach this young man, Trustee Andrew Kuehl, how important it is to volunteer, become involved in the community you love and to do the best you can to make your spot in the world a better place for your fellow man. In a few short weeks, local municipal government and the media have completely destroyed the ideals I have tried to instill in this young man, my son.

Impetuous vote? Perhaps it was, perhaps not. As far as I know, this new board member had fully intended on abstaining from the vote... until he had the "audacity" to ask a simple question and in his mind, realized he did not receive a legitimate answer.

My third point, violating ethics or not, that questions remains to be seen, I guess, but is this still not a democracy we live in? Perhaps this "new concept" should really be studied further. In this country, are we **ALL** not guaranteed the right to vote the way we so choose? Call me stupid, but that's what I was taught at Kewaskum High School. (Go ahead, Mike Nichols, have a field day with that statement!)

We elected Andrew Kuehl... possibly even because we thought an inexperienced young person might bring some vibrance and fresh ideas to the board. It is still our decision on whether we choose to re-elect him, that is if he would be sadistic enough to run. I mean, after this, how can we honestly encourage people, young or otherwise, to set themselves up to be ridiculed? I'm sorry, but I don't think I could do it. Guess my shoulders just aren't broad enough or my skin thick enough.

The media has made this young man, yes, my son, out to be some kind of evil, sinister, self-serving ego-maniac, plotting to overthrow local government. After nearly 20 years, I no longer wear blinders where my children are concerned, but I am telling you, **THE MEDIA IS WRONG** on this one! Now I truly realize why the media is so intensely disliked and I am ashamed to realize I may be grouped with "the media." Maybe it is time for all Kewaskum residents to attend a village board meeting and see for themselves just how terrible this Kuehl kid is. But don't take my word for it... that's probably a "conflict of interest" there somewhere. In my opinion, that is the beauty and charm of Kewaskum and why people are clamoring to move here. Because we are **ALL** intertwined and care for one another. Is this a bad thing? I don't think so. That's why I chose to stay here and raise my family here.

Lastly, I would like to publicly thank all the people that have stopped in my office or called to offer words of encouragement and support. This alone has carried my family through this debacle that has wreaked havoc on our holiday season.

Open Letter To the Voters

In surrounding communities, we see the big conglomerates gobbling up the little man who is trying his hardest to get by. Where is our individuality if we have just one store that has everything? When I ran for this position I promised all of you that I am in favor of seeing small businesses succeed in this community, whether it be my family or yours.

In the private email to Mr. Wagner I stated that I felt if the license was granted it was a distinct possibility that Kewaskum might lose three small businesses. This was not an attempt to hold the board hostage like Mr. Wagner stated. I was merely stating the facts as I saw them.

It was discussed that if the board was not concerned about small business in this community it was pointless for the three (Kuehl's, Video Post and The Statesman) businesses to remain in Kewaskum.

The board except for myself, did not seem to hear the point Mr. Kuehl was trying to make and moved swiftly to get the public hearing closed.

Finally, according to the Journal/Sentinel's Mike Nichols "nobody's trustee but his own" (myself) spoke up. I asked my fellow trustees if it would not be a good idea to postpone a motion on the issue until we researched why almost half of the communities surveyed **DO NOT** grant the combination license to grocery stores. I felt another

I have been to many public meetings where a president or chairperson has stopped voting by a member of a board because of a conflict of interest. If Mr. Wagner, as chairperson, is so hard-bent on "following the rules" why didn't he stop me if he thought I was out of order.

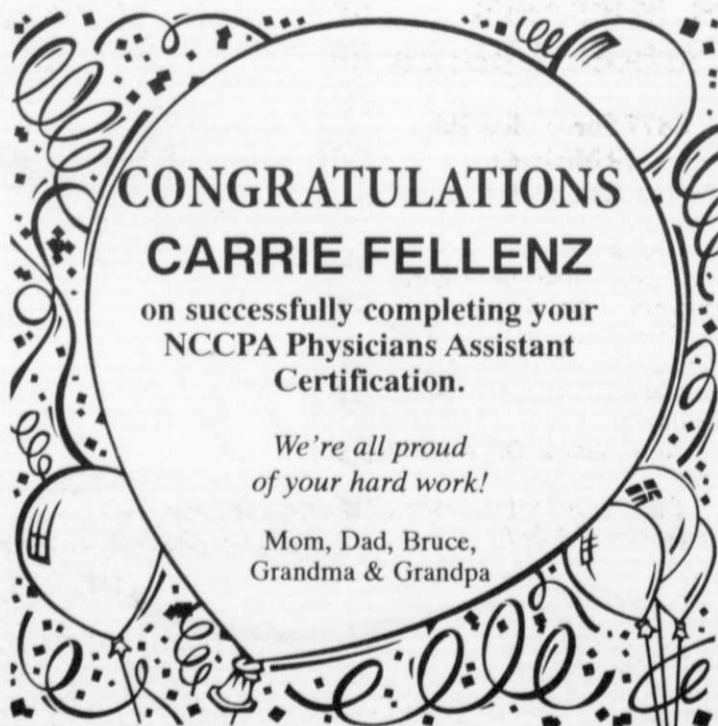

It was Christmas Eve and the owner of a small business sent his workers home informing them he would lock up. He was unmarried and this meant he didn't have to rush to families or homes bustling with holiday activities and planning.

One of the last responsibilities was to lock cash and important papers in the safe before he left. As he walked into the safe, somehow the door closed behind him and he discovered that he was locked inside. He pounded on the door and walls but knew deep inside no one would be there to hear it.

The safe wasn't very large, perhaps 5'x7'x8', and his first fear was that he would suffocate before morning. He panicked with that thought until he felt a light touch of fresh air touch his face and traced it to a small outside cooling vent. Knowing at least that he wouldn't suffocate, he pondered his predicament. He came to the rather logical conclusion that his best hope was to wait until morning for the company clerk to arrive and open the safe. He then realized that tomorrow was Christmas Day and nobody would be coming in. He sat down tired and dejected.

However, as he sat on the floor of the cold and dark safe, he had a surge of hope. Surely someone would miss him! His optimistic outlook was dampened when he recalled how just a week earlier his only brother had invited him to help trim the tree and have Christmas dinner with the family at his brother's home. The owner now sadly recalled how he had declined the invitation.

Sitting on that cold floor, he remembered why he said no to his brother. The previous year he had helped his brother trim his tree but found his children to be loud and obnoxious. Wanting to avoid it this year, he simply declined the invitation. Dejectedly, he realized that his family wouldn't miss him at all.

His thoughts wandered

to his church choir. He had been asked to sing at the Christmas Eve services. Feeling even sadder now, he remembered how he just didn't want to do it so he said he had other plans.

He was also called to volunteer at the nursing home on Christmas Day, but once again he was too busy, declining this opportunity so he could spend time alone at home. It was with a high degree of remorse that he realized that he wouldn't be missed by anyone on Christmas Eve or Christmas Day, so he resigned himself to his fate of spending both locked in a safe.

The day after Christmas, the clerk did open the safe upon coming to work. However, he never looked inside, going directly to his desk and started his daily chores. When the owner came out he saw the other employees working at their desks. He was struck by the fact that no one even noticed his ruffled appearance. It was then that the thought hit him.

During his absence, no one had missed him. His very absence was not noticed. He left the office, went home, cleaned and changed clothes, and returned to work. Yet he couldn't shake the uncomfortable feeling that he was not missed, that his absence was not noticed. He slowly came to the realization that if a person did nothing for other people, they would not be noticed, nor would they be missed. He vowed that the next year would be different. He would spend time with his brother's family; he'd volunteer and get more involved. He wanted to be noticed.

The question for all of us is if we were missing, would our absence be noticed? One way to be noticed is to volunteer and serve your community. There are many ways to do this, and running for the school board is just one of them. Y2K News

The Power is Off: Is Food Still Safe?

SEVENTH IN A SERIES OF EIGHT ARTICLES

No one knows for sure what effect the Y2K bug might have on electrical power systems, but some experts think there might be at least short-term interruptions.

"If the power does go off, you will need to consider the safety of refrigerated and frozen food in your home," says Barbara Ingham, University of Wisconsin-Madison/Extension Food Science specialist. "Generally, refrigerated foods are safe as long as the power is out for no more than a few hours. Food will remain chilled for four to six hours if the refrigerator door is not opened."

Foods that can be safely stored a few days at room temperature, above 40 degrees Fahrenheit, are:

- * Butter and margarine
- * Hard cheese
- * Fresh fruits and vegetables
- * Fruit juices
- * Dried fruits and nuts
- * Fresh herbs and spices
- * Opened jars of salad dressing, peanut butter, jelly, relish, taco sauce, barbecue sauce
- * Mustard, ketchup and olives
- * Fruit pies
- * Bread, rolls, cakes and muffins

"Other refrigerated foods stored above 40 degrees Fahrenheit for more than two hours should be discarded. Throw away moldy items or food with unusual odor or appearance," adds Ingham.

Discard the following items:

- * Raw or cooked meat, poultry and seafood
- * Meat-topped pizza and lunch meat
- * Casseroles, stews or soup
- * Milk/cream, yogurt, soft cheese
- * Mayonnaise, tartar sauce or creamy dressing
- * Cooked pasta, potatoes, rice and salads prepared from these foods
- * Refrigerator and cookie

dough

* Fresh eggs and egg substitutes

* Custard, chiffon or cheese pies and cream-filled pastries

* Gravies

Food in a freezer will stay frozen for about two days, a half-full freezer for one day. "Foods may be safely refrozen if they still contain ice crystals," says Ingham.

"When trying to save as much food as possible, first use perishable food and foods from the refrigerator. Then use foods from the freezer."

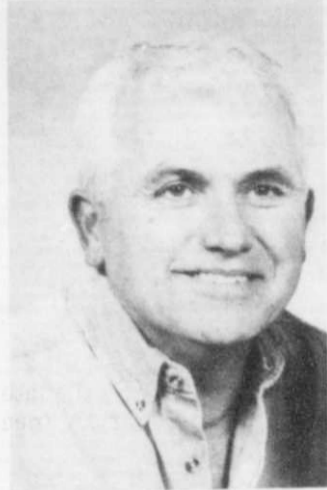
