Town of Scott Residents Experience Slight Increase on 1999 Tax Bills

Town of Scott residents expected to see a slight increase in their tax bills. The 1999 tax rate is 65 cents higher per thousand dollars of assessed valuation than the figure for 1998. Total rate will be \$3.53 as compared with \$3.26 last year. Part of the reason for this is a decrease in anticipated receipts coupled with a 15% increase in the expense column.

The Public Works Department has increased by \$9,067, due mainly to the increased cost of the recycling and garbage program. Operator expenses and withholding are up by \$6,350, site maintenance is up \$505, pest control \$115, and hauling and disposal costs \$2,097. Debt Retirement is a plus \$15,023 which, for the most part, is due to the purchase of a tanker truck. There is also an increase of \$17,588 for Culture and Recreation. This category includes the library, parks, and operation of the Hilltop.

A \$4,784 cut in State Shared Revenues, offset by \$4,600 increase of highway aids softened the 2% decrease in anticipated revenues.

A new category has been added under general government. It is that of

mentor/clerk. The \$1,000 allocated for this category has been provided to assist the new clerk/treasurer giving her time to become familiar with the job until tax collection season is over. The board has also established a \$15,000 salary for the clerk/treasurer for the year 2000.

Remaining tax collection dates planned for the Town Hall are Friday, December 31 between the hours of 9 a.m. and 7 p.m.; Saturdays, January 15 and 22, from 9 a.m. to 1 p.m.; Saturday, January 29 and Monday, January 31, from 9 a.m. to 5 p.m.

Clerk/Treasurer Billie Jo Richter advises that in order to avoid standing in line, payments can be sent to the Town of Scott, N1306 Boltonville Road, Adell, WI 53001. A business size envelope, stamped and self-addressed, is required to receive a receipt.

A resolution adopted in January of 1999 which allowed for the clerk/treasurer to issue payroll checks and to pay utility and other bills for monthly services has been repealed and a new resolution adopted at the December meeting will allow payment of all bills, including payroll only after approval of the full town board.

A one year contract has

been negotiated with Superior Services for garbage collection. The cost includes a \$50 per month for dumpster rental along with \$144.48 per "pull" to remove the garbage filled dumpster. Added to this will be the "tipping" fee which currently is \$28.76. The tipping fee is expected to increase thirty cents in January due to the Consumer Price Index.

Both a five and three year contract were considered, but not accepted due to the fact that a newly organized committee is looking into the costs and possibility of changing to a curbside system. If that system should become a reality, the one year contract at this time seemed adequate.

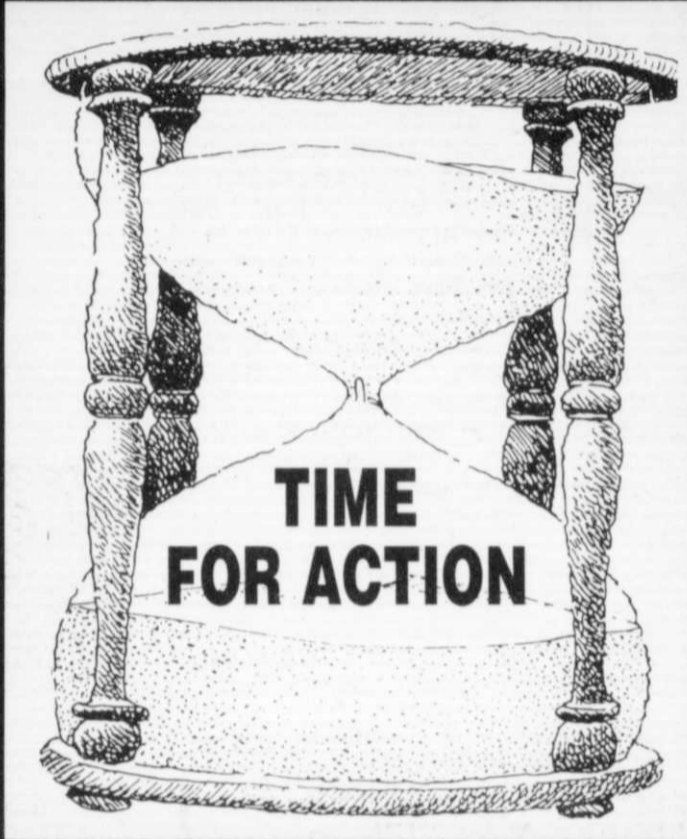
Winter hours for garbage and recycling announced recently have undergone yet another change. After reviewing the holiday hours, (these will remain the same), a decision was made to be open on alternating Saturdays and to have earlier hours. The site will be open on January 15 and 29, February 12 and 21 and March 11 and 25 from 8 a.m. to 2 p.m. The remaining holiday time will be Tuesday, January 4.

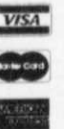

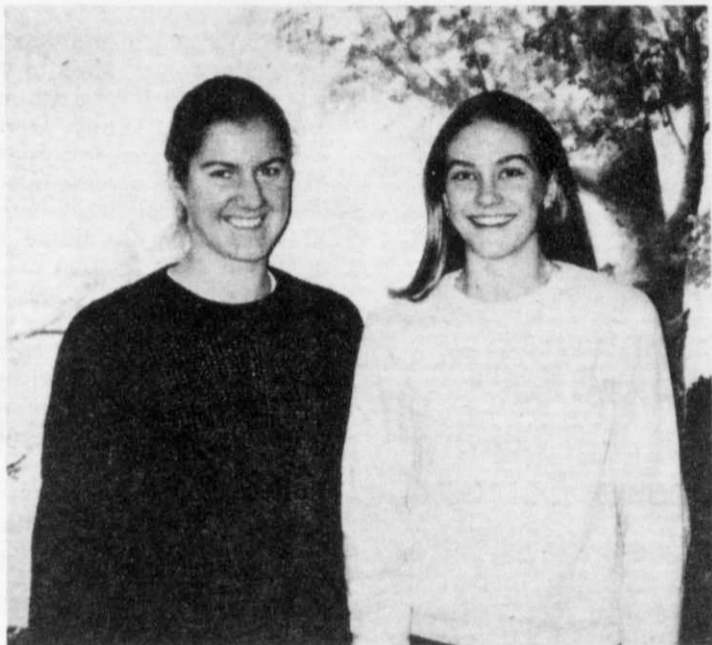

EDUCATION... It's Everyone's Business

Today's article is entitled, "Lessons of the Geese." While I am sure that many have heard a variation of this, I felt it appropriate to use it here in my final effort to get individuals from the community to run for a school board position this spring.

Fact #1: As each goose flaps its wings, it creates uplift for the bird following. Thus, by flying in a V formation, the whole flock increases the flying range 71% over one bird flying alone. Lesson: Those who share a common direction and a sense of community get going more easily and quickly with help from each other's thrust.

Fact #2: Whenever a goose falls out of formation, it suddenly feels increased drag and resistance, and quickly gets back in formation. Lesson: By staying in formation means accepting help from those ahead of us and helping those behind.

Fact #3: Geese in forma-

tion honk from behind to encourage those up front to keep up their speed. Lesson: Make sure your honking is for encouragement.

As you consider filing your own Declaration of Candidacy for a school board position, be assured that the seven-member board is called to share a common direction with a sense of community. Be working together the board reduces feelings of "drag and resistance." And finally, as I "honk" from behind the scenes to encourage individuals to run for a school board position, I do so in the most positive manner possible. A school district should have as many community members running for office because it shows service, it shows support, and it shows a real commitment to the district.

I repeat my earlier comments that the School District of Kewaskum is one the community should be proud of, and if you're proud of your schools, what better way to show it than to make a stand and run for office? Being elected to the school board is an opportunity for citizens to put their best foot forward. Won't you at least consider it? If not you, encourage a friend to do so.

I sometimes think there is a misperception that if you serve on the school board you'll do nothing but attend meeting after meeting. This is not necessarily the case. Each board member is committed to attend the monthly school board meeting, held on the second Monday of each month, and to serve on at least one committee that meets once a

month. There may be other special meetings but generally only after checking with all board members' calendars and schedules. Your talents and treasures are needed. The community needs you. Keep in mind that the seven-member school board is called to work together, to share a common direction and a sense of community. Isn't that what serving is all about?

December 24 was the deadline for incumbents to file papers declaring that they were **not** running for re-election. As I write this to meet the publishing deadline (December 27), we have had one incumbent file papers for Non-Candidacy (Jean Goeden); one incumbent filing candidacy papers (Lisa Maul) and one new individual filing their Declaration of Candidacy (Gordie Dickman).

If you've read my previous two articles there are two openings for positions on the board. The deadline for filing your Declaration of Candidacy is January 4, 2000. Papers may be picked up at the District office from 8 a.m. until 4 p.m. The office will remain open until 5 p.m. on January 4. Won't you please consider sharing your time and talents as a member of the Kewaskum School Board? I am confident you'll be glad you did. of Wisconsin losing political representation to the House of Representatives and the State Legislature. Additional information will be directed to town citizens as the Census time approaches.

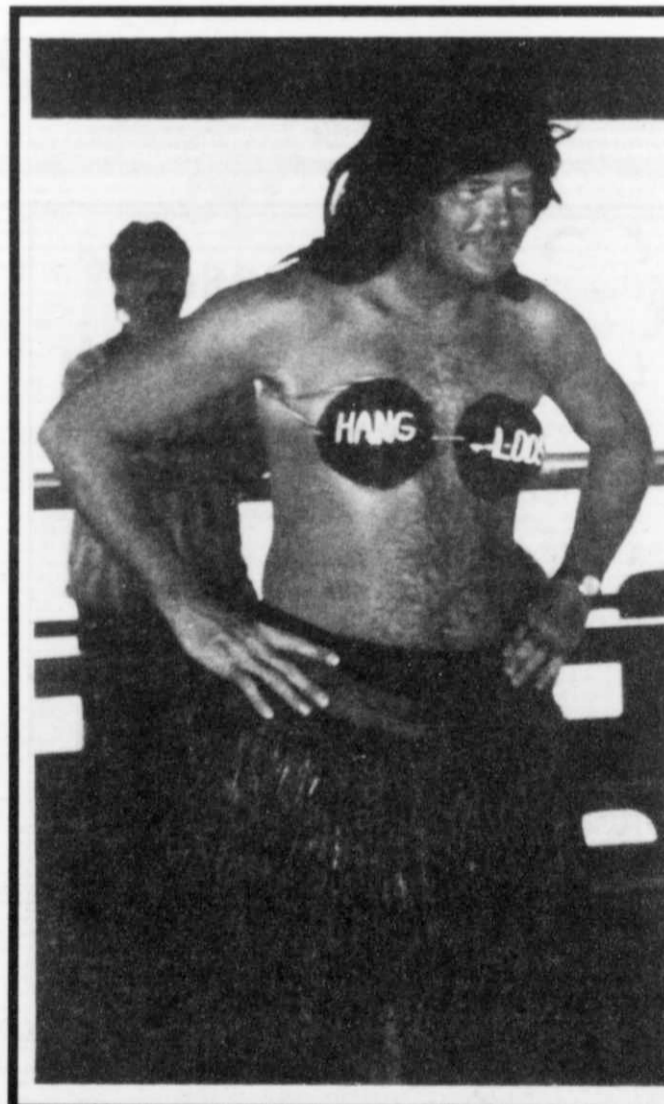

St. Joseph's Hospital Halts Construction of North Addition

St. Joseph's Community Hospital of West Bend has decided to halt construction of an addition to the north of the hospital, citing recent lower-than-expected patient volumes, financial concerns, and changes in the health care environment.

The hospital's board of directors, meeting last Monday, voted to not go forward with the approximately \$30 million portion of the project targeted for the north addition. The project was to include new inpatient and outpatient surgical suites, redevelopment of the emergency department, a new radiology department, expanded rehabilitation services space, a new intensive care unit, and other facilities.

The decision will have no impact on the construction of the \$7 million Cancer Care Center at St. Joseph's Community Hospital, which is nearly complete and is scheduled to open on March 15, 2000.

"After weighing the issues, and considering the significant costs involved in the project, the board of directors made a difficult but fiscally prudent decision to not proceed with the addition. The board's decision was based on its feeling that the hospital should preserve its financial reserves as much as possible, especially in light of other health care initiatives and services by the hospital that will require financial

support," said Executive Director Gregory T. Burns.

"The health care environment is changing at a rapid pace. This step was carefully taken with the expectation that the board will be reevaluating the hospital's strategies. The hospital is currently in a strong financial position. The board wishes to devote the hospital's financial resources to the most effective uses, to better patient care in this ever-changing environment," said President and Board Chair Atty. Elaine A. Shanebrook.

Hospital officials explained that the reasons for the decision included lower

inpatient and outpatient volumes in recent months, poor financial results this fiscal year (since July 1, 1999), a less than favorable bond market, and potential changes involving other local health care providers that could affect hospital volumes and financial procedures.

Burns said disappointment that the project is not financially feasible at this time is shared by all of those involved with the project. However, by not going forward with the project, the hospital will be better positioned to pursue additional clinical equipment and initiatives.

"Like the private sector, many local governments have been checking systems for 911 emergency reporting and dispatching; building security and environmental controls; personnel, budgeting and taxation; street lighting and traffic control; and sanitation and water."

Local governments also have been working with vendors and business partners to ensure that purchased goods and services will be operating on and after January 1, 2000.

Local governments have been maintaining records on the outcome of this work so that people can be assured that an organized approach to Y2K issues will protect their communities from serious problems.

"Evaluating the outcomes of Y2K activities and reassessing priorities is important because the problems are interdependent and may shift depending on the results of work," adds Lederer.

As a result of these efforts consumers should remember that the best possible attempts have been made to correct any problems, yet Y2K may cause unexpected delays, outages, etc., that may inconvenience us. Most importantly consumers should be patient and not panic if minor disruptions occur.

Philosophically, let's take a moment to think about what the changing of the Millennium means. This is not an ordinary New Year's event. Decades may come and go. But this year, we not only see the passing of a century, we also see the passing of a Millennium. This is a once in a lifetime event that millions of people will never experience. It should be special to every one of us in some way. Define "special" in your own way and celebrate it with your family and friends.

While Y2K has caused a lot of extra work and expense for government and

business, it is also a timely reminder of how interdependent we are and how important it is to solve problems by communicating and cooperating.

The underlying nature of the Year 2000 challenge has forced even the largest organizations to look outside themselves to promote readiness by business partners and customers. Across the state, community, religions, business and other groups are working together to ensure that January 1, 2000 is a day of family and community celebration throughout Wisconsin.

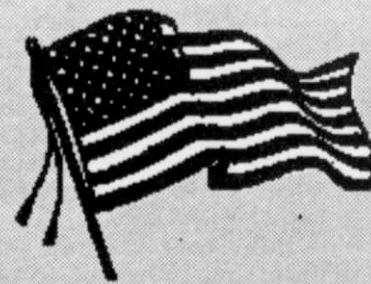
Leonard was a member of the VFW and was grand marshal in the 1989 Memorial Day parade in Bellingham, Mass.

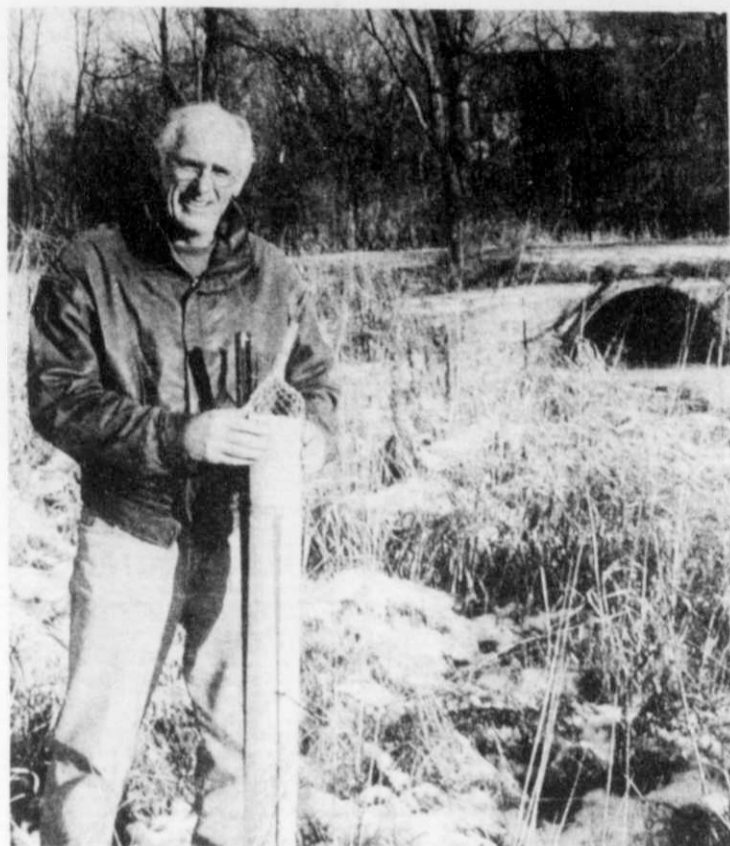

Sign Up for Conservation Reserve Program Set Up



John Yarmark of the Town of Trenton, is shown putting a bird guard, which is a sleeve of netting, over a tree tube on his CRP land. John has 52 acres enrolled in the CRP, established to warm-season grasses, wetlands, and trees.

The next sign-up for the Conservation Reserve Program (CRP) has been set for January 18 until February 11, 2000. The CRP is a cropland set-aside program in which landowners receive annual, per acre payments for planting wildlife covergrass, trees, etc., not commodity crops, on the enrolled land.

The actual CRP contracts will not begin until 2001, so the wildlife cover will not have to be established until the spring of 2001. Commodity crops can be planted this spring, and harvested in the fall, on land accepted during the sign-up in January and February.

The CRP has been in existence since 1986. This will be the 20th CRP sign-up. There are about 3,055 acres of CRP land in Washington County, established to a variety of cover types. Land enrolled into CRP can provide many benefits including excellent wildlife habitat, reduced soil erosion and water runoff, enhanced water quality, scenic beauty and many recreational opportunities. Public access to CRP land is NOT required.

The last CRP sign-up was held from October to December of 1998. During that time 500 acres were entered into the program in Washington County. Cover establishment on that land is scheduled to be completed in the spring of 2000, except for some of the tree planting contracts, which can go for three years.

Enrolling land into the CRP is a competitive process. Two factors will determine if land is accepted.

One factor is the bid, made by the landowner, which is the amount of money per acre, per year the landowner will accept for taking the land out of production and putting it in the program. Before submitting a bid, the landowner is told what the bid cap for the particular field is.

The productivity of the soil, the slope of the land being offered, and the prevailing rental rates in the county determine the bid cap. The bid cap is the maximum amount the per-acre bid can be for the field. If a landowner bids over the bid cap, the bid is automatically rejected. If the bid is at, or under, the bid cap, it may or may not be accepted, depending on this other factor.

The other factor used to determine which offers are accepted is the Environmental Benefits Index (EBI). The EBI, as the name indicates, evaluates the environmental benefits of each particular parcel of land, established to the planned cover, and ranks it against other offers. The EBI takes into account the types of cover planned, the overall wildlife habitat value of the land, the proximity of the land offered to water bodies and to protected areas, such as refuges and state parks, and the soil erosion control and water quality benefits achieved.

Landowners will be notified in March of 2000 whether their offer has been accepted or rejected.

National Trust Lends Support To Friends of Saxonia House

FILLMORE -- Friends of the Saxonia House, Inc. has been awarded a grant from the Jeffris Preservation Services Fund/Wisconsin of the National Trust for Historic Preservation.

The matching fund grant provides seed money to assist in developing an engineering and architectural analysis, as well as a timetable for the restoration of the Saxonia House site located near Fillmore in Washington County.

Funding for this project was made possible through the newly created Jeffris Preservation Services Fund/Wisconsin. This endowed fund for Wisconsin was established through a generous grant to the National Trust from the Jeffris Family Foundation of Janesville.

The Foundation has a long and illustrious record of supporting significant preservation efforts in the state, and has filled with this gift an important gap in preservation funding in Wisconsin by providing funding to advance preservation opportunities at their earliest, formative stages through the National Trust's Preservation Services Fund. The Jeffris fund has a priority for small communities in rural areas, especially those under threat from sprawl. Grants range from \$500 to \$5,000. They are awarded to non-profit groups and public agencies, and must be matched at least dollar for dollar with public or private funds.

Friends of the Saxonia House, Inc. is a non-profit organization formed by Janesville residents Paul and Mary Williams in 1997 to purchase, restore and operate the Saxonia House property at The Saxonia House Living History Museum. The house was built in 1854 by an ancestor of Mary Williams and is believed to be the largest half-timber construction house in the United States.

The National Trust for Historic Preservation is a 50-year-old nonprofit membership organization chartered by Congress to encourage public participation in all aspects of historic preservation. The National Trust's programs are funded from a variety of sources,

including foundation support and private contributions.
