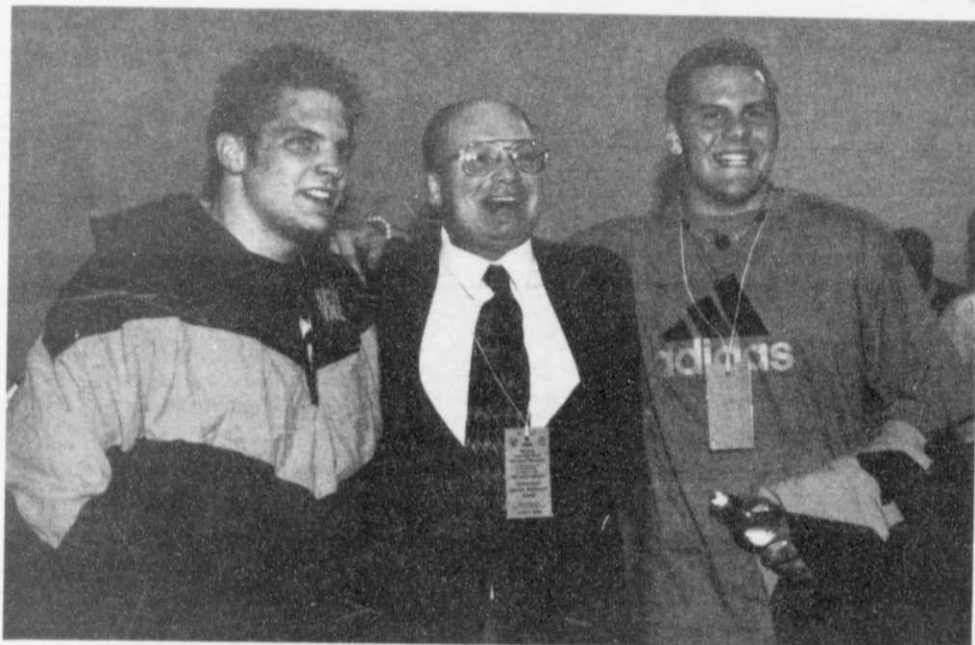

## Kewaskum's Farchione Brothers Leave Their Mark in Madison

### Mike is Division II State Champ; Jason Takes Fourth

Kewaskum High School senior wrestling star, Mike Farchione, and his competitive brother, Jason, traveled to Madison this past weekend to participate in the State Division II Wrestling championships and left their mark in the record books.

It was the first time in KHS history that brothers traveled to the champi-

onships in Madison and to put icing on the cake, it was only the second time a Kewaskum wrestler has brought home the title, courtesy this time of Mike Farchione at 189 pounds. Josh Kurtz was Kewaskum's other state champion.

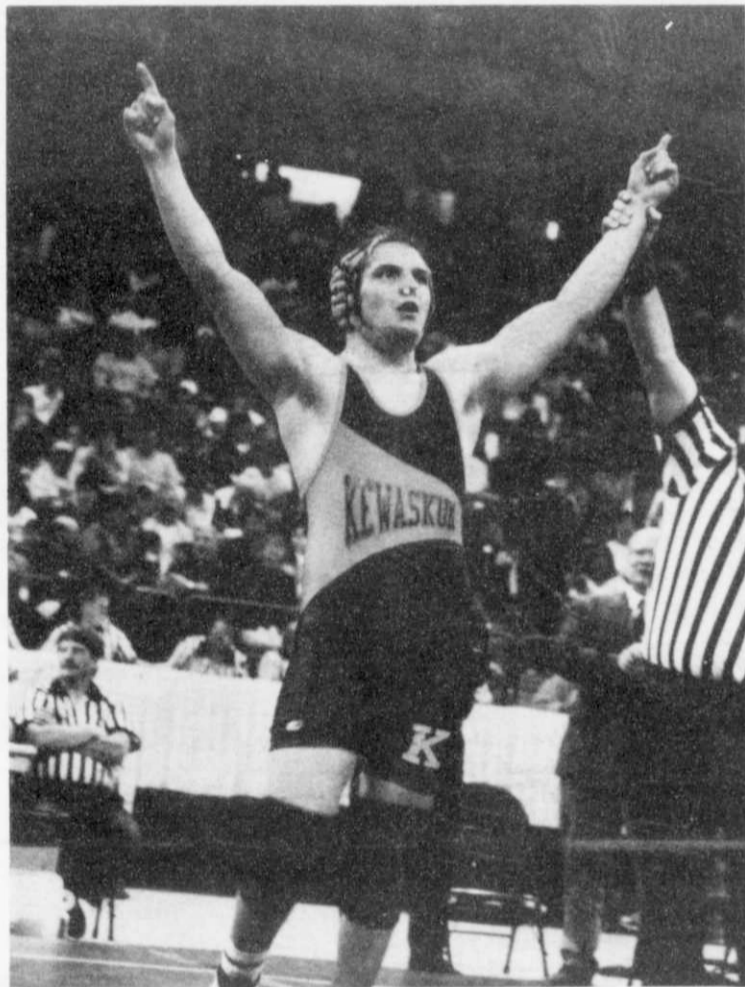
To make the pot even sweeter, KHS wrestling coach John Nell, who has indicated he will be retiring from coaching after this season, adds his second

state championship to his credits.

During the first round in the quarter-finals, Mike beat #1 ranked Zac Elliot (26-5) of Richland Center, 6-3. In the second round, he decisioned Justin Moore (32-4) of Durand/Pepin, 8-5.

In the finals, Mike faced Derek Toshner of Campbellsport, who previously beat Mike one week ago in the sectionals, 1-0.

Toshner earned his berth

Nancy and Jerry Mehring of West Bend have announced that after 45 years, the two Dairy Queen stores in West Bend, are changing ownership.

The new owner will be Kevin Scheunemann, who also owns the Dairy Queen in Kewaskum and Belgium. Kevin worked for the Mehrings for nine years before he purchased the Kewaskum store in May, 1998.

According to the Mehrings, "It is going to be a little hard to leave something that has been our whole life. However, we are happy that the new owner, Kevin, will continue the tradition of Dairy Queen in West Bend, and he is planning to retain all of the current employees. Our customers should

notice no change, as the current smiling faces will continue to serve them."

Jerry said they have met a lot of great customers, employed a lot of fine people and made some wonderful friends during the past 45 years. Jerry started his Dairy Queen career at the former Barton Hill Dairy Queen in 1956.

Nancy joined him in the business in 1960 and they were married in 1962. They have operated the stores together ever since then. At one time, they operated nine stores in Washington, Waukesha and Milwaukee counties.

They sold the Hartford Dairy Queen in March, 1999 and the Jackson store in May, 1999. This final transfer of ownership brings

to an end 45 years of operating Dairy Queen stores for Nancy and Jerry.

Nancy and Jerry will continue to be active in Dairy Queen, as they are the Territory Operators of the four county Metro Milwaukee area. In this capacity they work with 30 Dairy Queen stores in this area, and continue to develop new stores in the Milwaukee area.

They will also continue to work with their three sons who have Dairy Queen/Orange Julius stores in Hawaii. "We probably will never completely retire as Dairy Queen is in our blood and it is pretty hard to totally leave something that has been our entire life."

## 262 Area Code Required On Calls Beginning March 4

All calls to the new 262 area code must soon be dialed using 262. Beginning March 4, callers who use 414 for calls to phone numbers in the new 262 code will reach a recording that reminds them of the change.

262 was added to meet exploding consumer demands for advanced communications services. Without a new area code, GTE and other telecommunications companies would have run out of phone numbers by year-end.

The new area code does not change rates, local calling area or seven-digit phone numbers.

To make a local call, customers should dial the seven digit telephone number. To place an Extended Community Calling (ECC) call, customers need to dial "1 + the area code + seven digits" when the area code is different from their own. A description of local and ECC calling areas is included in all GTE telephone directories.



## Body of Dead Woman Found in Washington County

An investigation continues in a case where a Washington County Highway worker found the partially clothed and partially decomposed body of a white female, approximately 5'5", 128 pounds, brown hair with reddish tint and blonde highlights. She had no visible scars, marks or tattoos.

The woman was found Monday at around 8:42 a.m., lying face up along state highway 45 north of where highway 45 meets 41 in the Town of Richfield.

The Washington County Sheriff's Department removed the body to have an autopsy performed by the Milwaukee County Medical Examiner. No further information was learned through the examination as to when and how the woman died.

Toxicology tests will be performed but results may take weeks, or months.

The sheriff's dept. has received calls from other law enforcement agencies but as of yet they have found no connections.

## KMS Students Gather For Enrichment Day

One hundred and thirty-five gifted and talented sixth, seventh, and eighth graders from nine Dodge, Fond du Lac and Washington County schools participated in the fifth annual Enrichment and Exploration Day that featured a variety of activities at the University of Wisconsin-Fond du Lac on Tuesday, February 8.

The Mayville Steel Drum Band, the Pan-Jammers, the only eighth grade steel drum band in Wisconsin, got the day's schedule off to a to-tapping start as the students gathered in the Student Center. Interspersed with the playing of musical selections, Director Ben Reehl told the students that steel drums are an alternative-type music.

Reehl pointed out that although the majority of people believe the instruments came from Jamaica, they are actually from the small island of Trinidad, and are the only acoustical instruments invented in the last century.

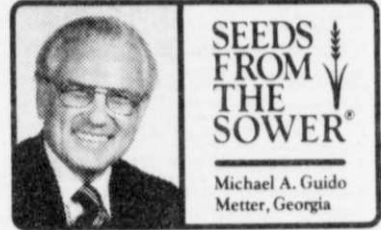

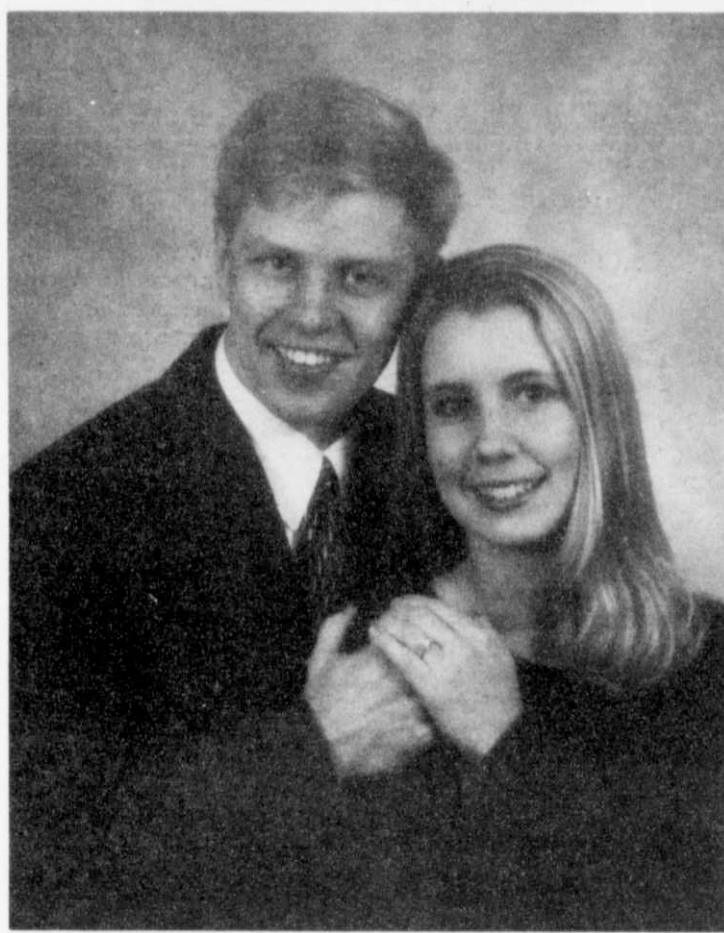

# Kids Must Learn Math Without Calculators

By Rep. Glenn Grothman

We have all experienced the difficulty some young children have in making change or dealing with numbers that their grandparent would have no problem with. The root cause of is the same liberal philosophy of education that has caused the changing in the way SAT scores are reported, grade inflation which gives honor roll status to performances which would have earned their parents; or grandparents' C's and inventive spelling which allows spelling errors uncorrected so children's egos are not bruised.

Today I will discuss the disturbing trend of having children use calculators in school as early as first or second grade. Common sense should tell one that it is important one learn to use numbers either with paper and pencil or in one's head. Unlike many things taught in school -- which can be forgotten after the test -- we must use mathematical skills our entire lives. Some modern teachers argue that children must use calculators since they are part of everyday life. This is true, but let's be honest -- it only takes five minutes to learn to use a calculator. Understanding of multiplication, division and fractions necessitates years of memory and practice. I have talked to college professors who attribute the poor math preparation of recent college students to premature use of calculators.

Sadly, the United States Department of Education has endorsed ten math programs derisively referred to as "Math Lite" or "Rainforest Math." They discourage memorization, encourage calculators, and try to blend environmental

studies and group projects with traditional math.

Fortunately 200 prominent math mathematicians and scientists have called on the U.S. Department of Education and its fuzzy-headed bureaucrats to rescind its endorsement of this anything-goes-math because it omits instruction in basic mathematical skills.

"It would be a joke except for the damaging effect it has on children," said Professor David Klein, who crafted the letter. Perhaps, this liberal approach to math is why American students score so badly compared to other countries on the international test. (19th out of 21 industrial countries -- almost all non-industrial Asian countries score ahead as well.) Due to the sad state of American schools, Silicon Valley businesses have had to ask for permission to import workers for high-paying high tech jobs which poorly trained American students are unable to handle.

Sadly, even here in Wisconsin, the Wisconsin students assessment administered by our Department of Public Instruction allow calculators for fourth, eighth and tenth grade tests. All districts I have contacted except parochial schools allow the kids to use calculators. Having taken several eighth grade tests myself, I can assure my readers that they are

incredibly easy and contain nothing that was not taught 30 years ago. The fact that the standardized test allow kids to use calculators confirms my worst suspicion about statewide tests administered by liberals in Madison (or Washington). They are more likely to lower standards at the local level than to raise them.

I am introducing legislation in Madison to ban the use of calculators on standardized fourth and eighth grade tests. In school year 1988, we spent \$4,649 per child. Last year we spent \$8,264 per child. Inflation only would have increased the amount to \$6,508. We can throw as much money as we want at our schools, but unless some common sense is used in educating children it will all be wasted.

## Census Day

What is: (a) completely confidential; (b) extremely important to Wisconsin's financial and political interests; and (c) only happens once every ten years?

If your answer is the U.S. Census, you're absolutely correct and on March 1, 2000, Wisconsin households were scheduled to receive the first of three letters from the U.S. Census Bureau that will get the census process started across the state.

The first letter was to feature messages written in several languages, including Spanish, Hmong and Korean, that offered simple instructions on how to obtain census questionnaires in these and other languages. The goal is to ensure that every household

in the state, including those where English is a second language, is counted.

The other two mailings include the census questionnaire itself, which will be mailed around March 15, and a reminder/thank you card that will be distributed sometime around March 20.

"This is an opportunity for every Wisconsin family to directly contribute to the long-term interests of their community and state. An accurate census will help ensure that we receive both fair political representation in the nation's capitol and that we qualify for a full share of federal payment programs," State Department of Administration Secretary George Lightbourn explained.

Lightbourn emphasized that the census data collected from households is confidential.

# Phosphorous Free Fertilizer Available

The Big Cedar Lake Protection and Rehabilitation District recently initiated a program to help reduce the impact of phosphorous on lakes and streams. The District is taking orders and coordinating distribution of Safe Green, a lawn fertilizer that doesn't contain phosphorous.

When phosphorous gets into lakes and streams it promotes unsightly algae blooms and abundant aquatic weed growth. Improper selection and application of lawn fertilizers is just one of the many contributors of phosphorous to surface waters. The amount of phosphorous entering waters from lawn fertilization varies, but limiting all inputs of phosphorous is a goal of many organizations and agencies.

Residents may think that it is important for only those living adjacent to a lake or stream to use a phosphorous free fertilizer. The concern is much more wide spread. Nutrient loaded stormwater runoff from urban areas passes untreated through storm sewers directly into streams and lakes. Runoff from suburban or rural residential areas moves over land to water bodies.

Lawn fertilizers combine nitrogen, phosphorous, and potassium as the three major elements needed for

plant growth. However, most tests show that soils in Washington county have high to excessive levels of phosphorous and potassium. Thus, nitrogen is typically the only supplement needed for the majority of lawns.

Safe Green's 25-0-0 (nitrogen, phosphorous, potassium) formula promotes healthy turf and leaves out unneeded nutrients. Also, the fertilizer combines both slow and quick release forms of nitrogen to provide a uniform growth for eight weeks or more.

Lawn fertilizer should be applied at the end of May and in late October at full application rates. It can also be applied at the beginning of July and again in early August at half application rates if there is adequate rainfall to keep the grass growing. The full application rate for Safe Green is 4 pounds of fertilizer for each 1000 feet of lawn. This means a 50-pound bag of Safe Green will cover 12,500 square feet per full application.

The exact cost of the fertilizer has not been determined yet. However, it is expected to be somewhere between \$5.50 and \$6.25 per 50-pound bag. Call the Big Cedar Lake Protection and Rehabilitation District at 262-629-9322 for more information or to place your order.

Homeowners may also be able to obtain phosphorous free fertilizers from local businesses handling lawn care products or through mail order catalogs.

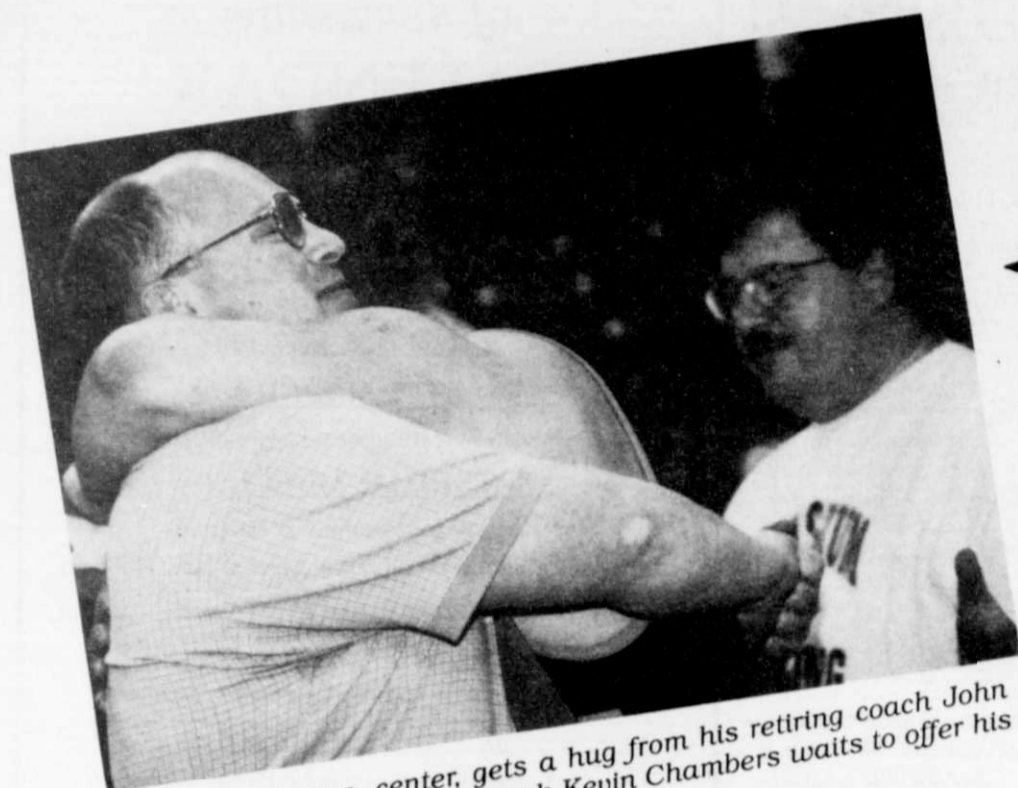

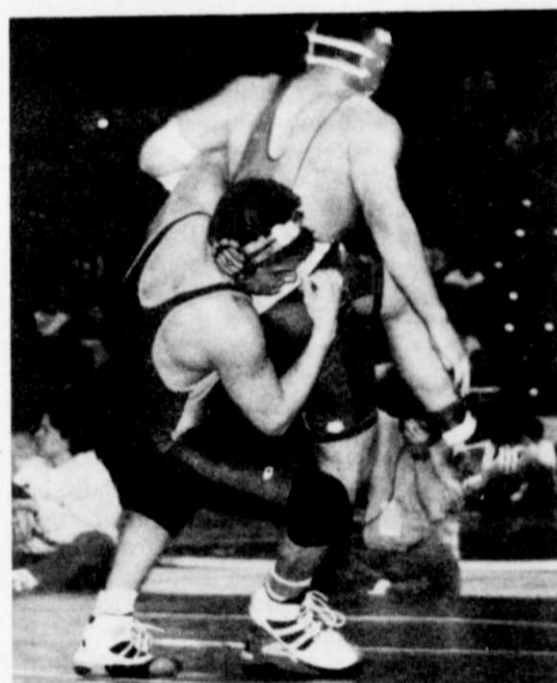

# Dorn Brothers Recognized for Dedication to Environment

LANCASTER, WI -- The Wisconsin Pork Producers Association (WPPA) recently recognized producers and industry members for their dedicated service at the 2000 Winter Ag Expo, held Feb. 17-19 at the Marriott Madison West in Middleton.

Beginning in 1995, the Wisconsin Pork Producers has honored producers within the state who have implemented exemplary environmental practices in protecting the state's abundant land and water resources. The 1999 recipient of the WPPA Environmental Stewardship award is Dorn Brothers, Dave & Don Dorn, Kewaskum.

The original 80 acres of the 200 farm that Dorn

Brothers own has been in the family for 100 years. Dave and Don purchased the home farm in 1980. In the following 10 years they built finishing, gestation, nursery/grower and farrowing buildings. All of the hog buildings are either attached to each other or connected by enclosed waterways.

Their manure management system consists of two-7000 gallon reception pits, one 12000-gallon reception pit and a 192,000-gallon Harvestone Slurry Store. Recognizing the need to have no runoff to the Kewaskum Creek, which is located 150 feet from the farrowing house, Dorn Brothers participated in the Milwaukee River Priority Watershed Project, which cost shared the 12,000-gallon pit and the slurry store. Odors are controlled by incorporating the liquid manure as soon as possible, usually within 24 hours.

A comprehensive nutrient and pest management plan has been developed with the help of Scott Petges from the Washington County Land Conservation Department. Every spring and fall after the slurry is emptied a manure analysis is taken. Soil tests are taken every three years. The farm saves \$4000 annually by incorporating the manure analysis into their fertilizer application plans.

A positive visual image is evident to anyone driving past the hog operation. This image is positive enough for the Washington County Land Conservation Department to conduct farm

tours and explain management practices to area students and citizens.

In addition, wildlife management is very important. Grass areas along the creek provide extremely good deer, pheasant and turkey cover. Dorn Brothers plans to incorporate the On Farm Odor environmental program in 2000.

Section 1: EA Agricultural Preservation District, Section 3.03(A)(14), Permitted Uses, is amended to read: "(14) One (1) single-family farm dwelling with a garage."

Section 2: A-1 Agricultural/Open Space District, Section 3.03(A), Permitted Uses, is amended by repealing subsection 15 which states as follows: "Single family dwellings in existence prior to the adoption of this ordinance on April 14, 1997."

Section 3: A-1 Agricultural/Open Space District, Section 3.04(B)(1) is amended to read: "(1) Garages and carports and accessory uses or structures as that term is defined in 15.02 and as regulated in 6.03 of the Code."

Section 4: R-1 Single-Family Residential District, Section 3.05(B)(1) is amended as follows: "(1) Garages and carports and accessory uses or structures as that term is defined in 15.02 and as regulated in 6.03 of the Code."

Section 5: Accessory Use Regulations, Section 6.03(A)(1) is repealed and recreated as follows: (1) Accessory building, such as garages, garden or utility sheds, playhouses, or gazebos, upon the issuance of a building permit. Accessory buildings shall be located at least 10 feet from the principal structure; shall be placed on a pad of gravel, concrete, asphalt, wood or metal; shall be located not closer than 10 feet to a lot line; and shall not exceed 15 feet in height. Any accessory building for motor vehicles shall be placed on a floor or pad of asphalt, concrete or gravel. Accessory structures in the A-1 Agricultural/Open Space District and in any Residential District on parcels five (5) acres or less in size shall not exceed a total of 864 square feet in area. Accessory structures in the A-1 District and in any Residential District on parcels greater than five (5) acres shall not exceed a total of 1,500 square feet in area or 20 feet in height. Accessory structures 120 square feet or less in area may be permitted up to five (5) feet from a side or rear property line.

Section 6: Vacant Nonconforming Lots, Section 7.05, is amended to read as follows: "The Zoning Administrator may issue a building permit for development of a lot which does not contain sufficient area to conform to the dimensional requirements of this Ordinance may be used as a building site provided that the use is permitted in the zoning district in which it is located, provided that the lot is of record in the County Register of Deeds Office prior to the effective date of this Ordinance. Nonconforming lots served by public sanitary sewer shall be at least 50 feet wide and 7,200 square feet in area. Nonconforming lots served by onsite sewage disposal systems shall be at least 100 feet wide and 30,000 square feet in area. Lots with smaller dimensions shall not be developed unless a variance is granted by the Zoning Board of Appeals. Vacant nonconforming lots granted permits under this Section shall be required to meet the setback and other yard requirements of this Ordinance."

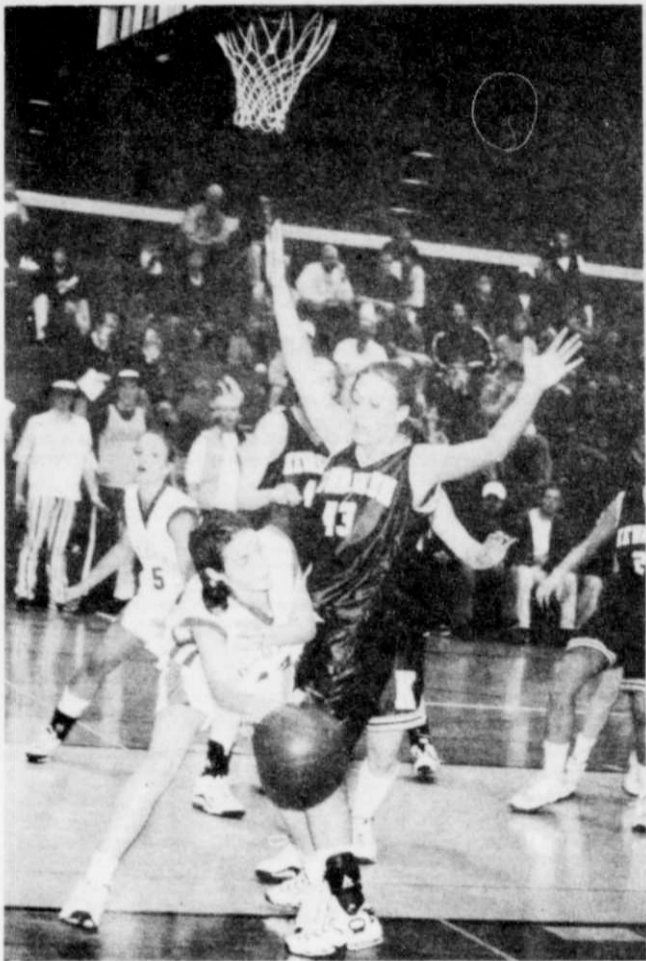

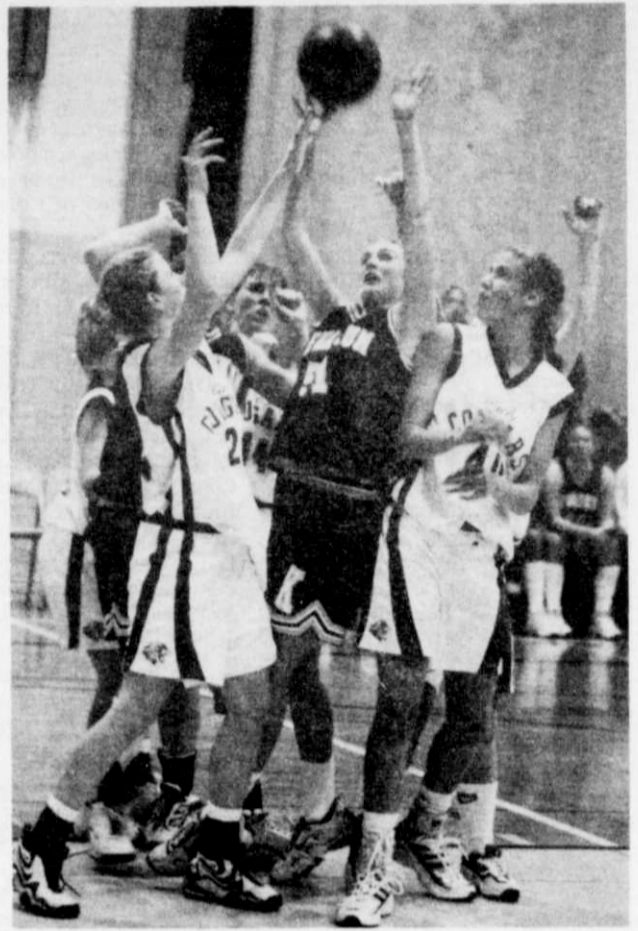

Brother Jason Farchione also did an excellent job during his competition, placing fourth at 275 pounds.

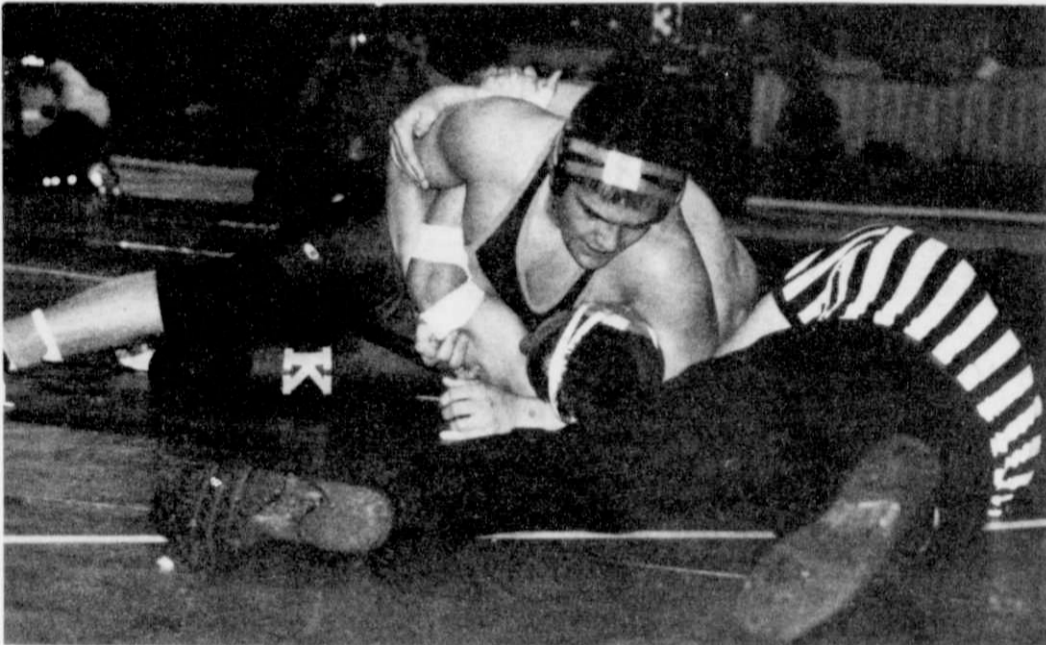
During the first round, Jason pinned Richard Ellmann (34-3) of Oconto in 1:12. In the semi's, Jason

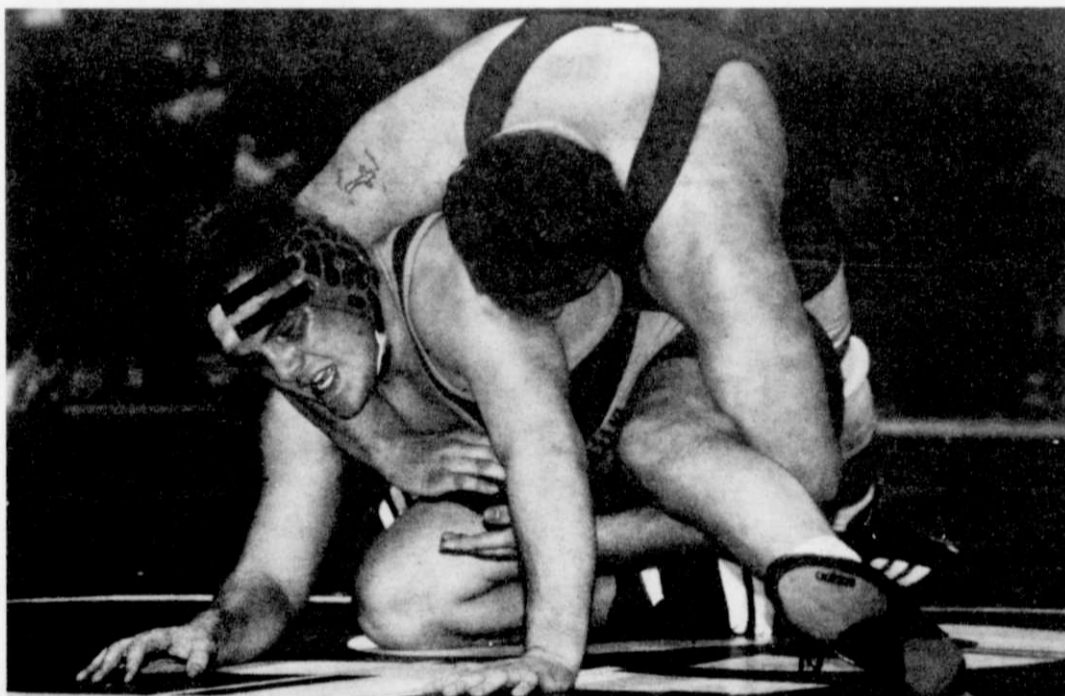

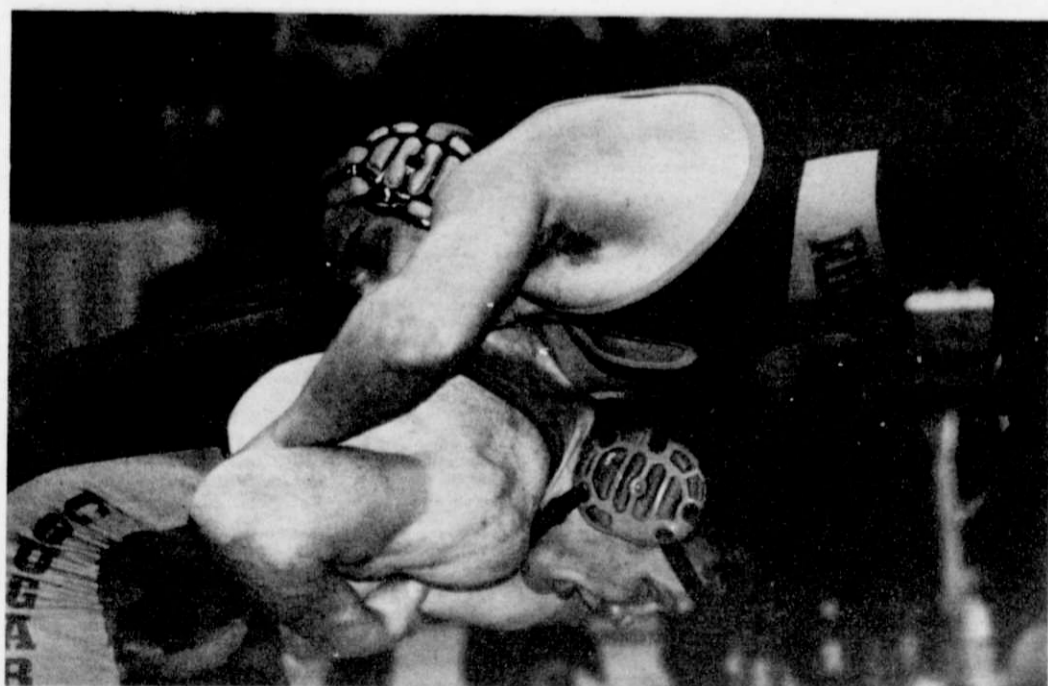

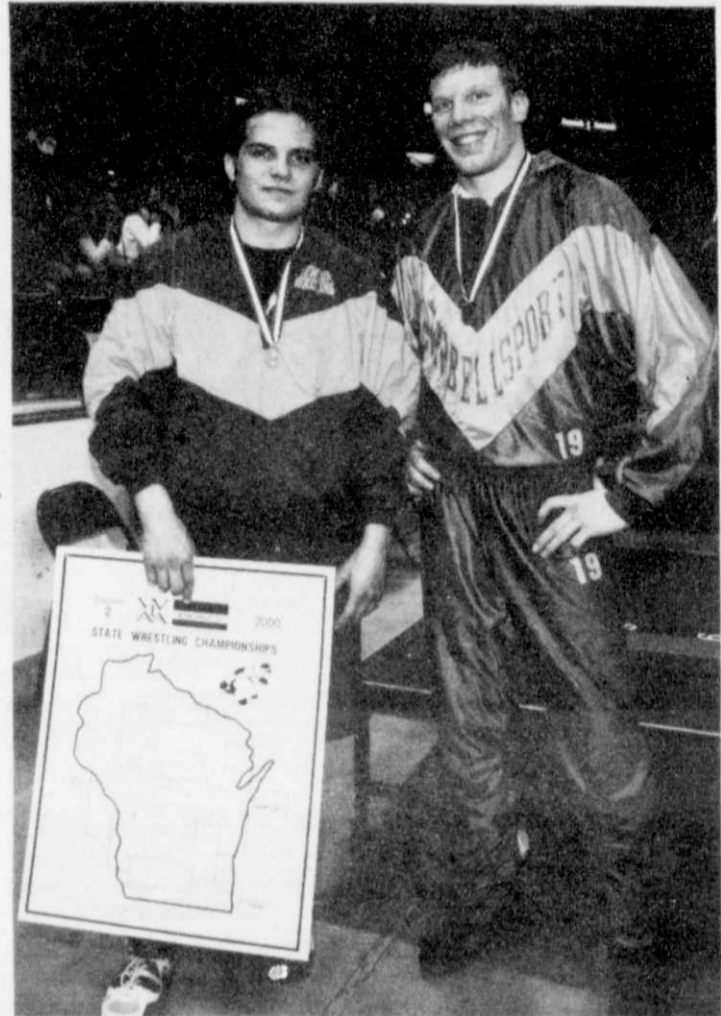

## Evening With Nature Series Continues

The Evening with Nature Series at the Northern Kettle Moraine State Forest continues with "An American Naturalist in Russia." The program will be held on Thursday, March 9, from 7:00 p.m. to 8:30 p.m. at the Henry S. Reuss Ice Age Visitor Center. The Ice Age Visitor Center is located off of Hwy. 67 1/2 mile west of Dundee. The program is free, but donations are always gratefully accepted.

During the summer of 1999, a team of 11 people from Wisconsin headed to Muraviovka Park located along the Amur River in far eastern Russia. This team formed by the International Crane Foundation spent three weeks in Russia working side-by-side with Russian educators to lead environmental education camps for the local children. Teaching children about nature is harder in a land where poverty is so rampant, but after ten environmental camps conducted since 1994, 460 children have been awakened to the idea of appreciating their beautiful environment.

Muraviovka Park for Sustainable Land Use is the first privately protected territory in Russia since 1917. The park protects important habitats for Red-crowned, Hooded and White-napped Cranes, Oriental White Storks, and many other migratory birds.

Join Howard Aprill, naturalist from Wehr Nature Center in Milwaukee, as he described the challenges and joys of teaching environmental education in the Russian far east. Through stories and slides learn how the political, economic, and social changes are affecting the environment, and how a class of Wisconsin fourth graders connected with Russian students.
