Students in Mrs. Ammel's second grade class received an important package recently, photographs and a personalized letter from the President of the United States.

The President wrote to thank the class members for a copy of the book they created and sent him, "Dear Mr. President." The book was a bound collection of letters from Mrs. Ammel's students, voicing their opinions on a wide range of subjects from schools to gun control to the environment.

Letters also touched on

less complicated subjects. Todd Scheid asked, "Do you play ball with your dog?" while Josh Boettcher wrote, "I am wondering when will there be a new President?"

The signed response from President Clinton came on White House stationery and read:

"Dear Students:
 Thank you for writing to me. I'm impressed by your hard work and enthusiasm for our nation.

I am extremely honored to be your President. Even when I was a little boy growing up in Arkansas, I

hoped that someday I would be able to serve the people of my country.

My job as President can be very difficult, but it is also exciting. The best part is knowing that I have an opportunity to make America better for young people like you.

 Bill Clinton"

In addition to the letter, the class also received pictures of the President, Vice-President Gore, and even the first family's pets, Buddy the dog and Socks the cat.

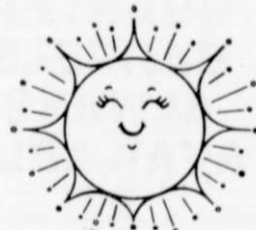
A very special "thank you" is extended to Nancy Heckel, Jim Schaub and the Kewaskum Police for their help when our home was broken into while we were on vacation.

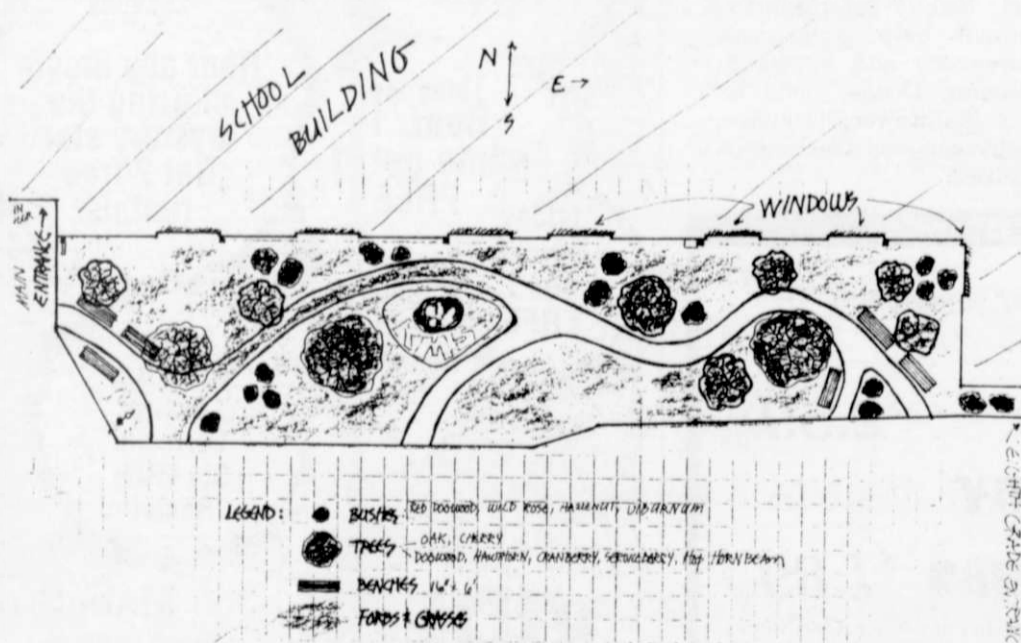

Kewaskum Middle School Awarded \$500 Grant

Middle School has been awarded a \$500 grant by the "Wild Ones Natural

Landscapers." Their Seeds for Education Program was "estab-

lished in 1995, to support schools, nature centers, and other places of learning for children-involved projects such as creating natural landscapes and outdoor classrooms using native plants." Only seven of these grants are awarded annually to applicants from around the country.

The award-winning KMS landscape plan was designed by the eighth grade drawing and painting class. Students have envisioned a curving path, benches, trees and bushes to cool the building and provide shade in the summer, and places for native flowers and grasses.

A service group of sixth, seventh and eighth grade students has recently been formed by art teacher, Lynn Molenda, to begin work on

the plan. She and tech. ed. teacher, David Drexler, will build the path with the help of Dave Rizzardi's high school FFA students.

When this is completed, some trees, bushes and flowers will be planted. This is but the first phase. The entire project, which will rely entirely on student, teacher, parent and community involvement, will take several years to complete.

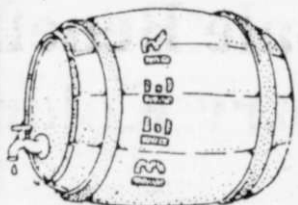

Kelsey Guth Donates Her Hair to Locks of Love Program

Kelsey Guth, a third grader at Kewaskum Elementary School, recently decided to have her long hair cut. Not unique, you say? It is when you realize Kelsey decided to have 11-1/2 inches of her hair cut so that she could donate it to a program called Locks of Love.

Locks of Love is a non-profit organization located in Palm Springs, Florida, that provides custom, vacuum-cap hairpieces to financially disadvantaged children with long-term medical hair loss.

Locks of Love provides an unusual need for children throughout the United States by using the donated hair to create the highest quality hair prostheses.

Most of the children helped have lost their hair due to a medical condition called Alopecia Areata, which has no known cause or cure. The prostheses are provided to help restore self-esteem and confidence, enabling children to face the world and their peers.

Donors provide the hair, volunteers staff the office and the manufacturer hand-assembles each piece, which requires approximately four months. Locks of Love provided over 50 hairpieces during their first year of operation.

Thousands of donated ponytails pour in from around the country every month. Most donors mail a note and a photo along with their bundle of hair.

Children comprise about 75% of the donors, making this a charity where children have the opportunity of helping other children.

Kelsey, the daughter of Mark and Tammy Guth, 703 Memorial Drive, Kewaskum, heard about the program from her cousin, Sarah Parker of Belgium. Sarah, age three, was having her first haircut and learned about the Locks of Love program. Before her first haircut, she needed to grow her hair to the required 10" so the hair could be donated.

Ironically, Kelsey's aunt, Connie Parker of Oshkosh, has also recently decided to have her hair cut to donate to the program. Three members of the Parker-Guth family are now sporting new shorter hair, and a few

children who didn't have a hairdo before this generosity are extremely grateful for their donation.

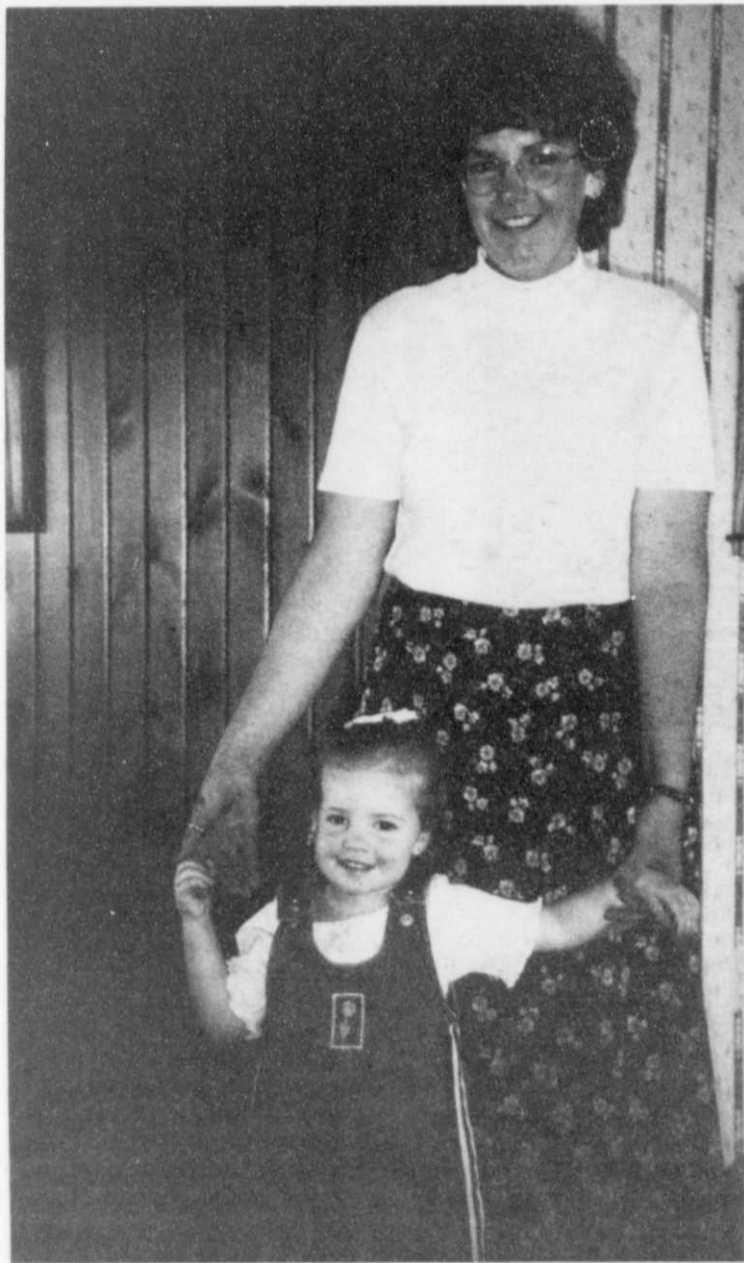

Frozen Fruit Slush

Serves 6

- ½ cup water
- ¼ cup frozen limeade concentrate
- ½ 16-ounce bag unsweetened frozen mixed-fruit, slightly thawed
- 1 tablespoon plus 1 teaspoon sugar
- 12 ice cubes (about 2 cups)

Put half of each ingredient in a blender and process until smooth. Pour into three ½-cup molds. Repeat with remaining ingredients.

Freeze until firm, about 4 hours.

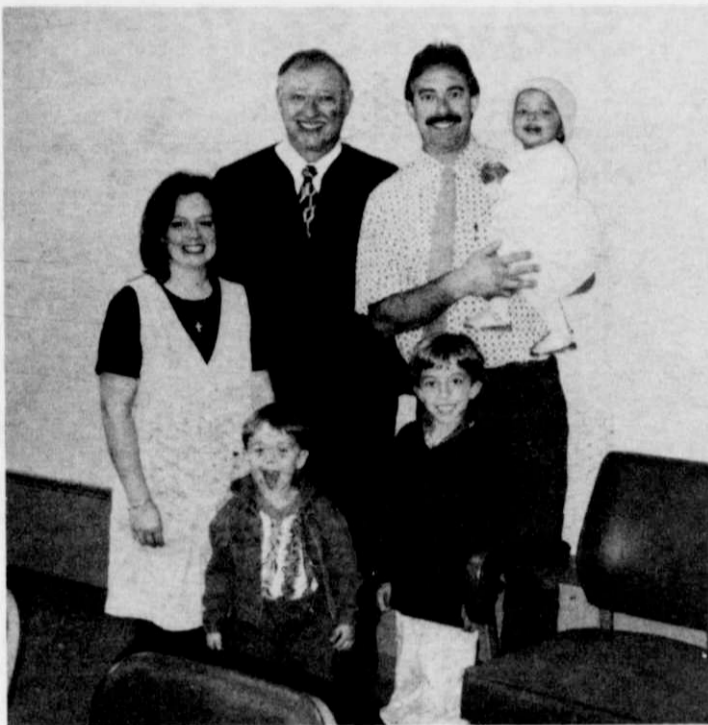

The Legislature Isn't Broken, It's Working Too Well

By Rep. Glenn Grothman

The Legislature is currently preparing for its May floor period. The statewide press in general and the Milwaukee Journal Sentinel in particular, have taken this interlude to claim the Legislature is broken and has failed to do enough the past two years. These comments betray the big government left-wing bias of the press. Let's look at the facts.

Already this session a 1500 page budget was signed into law increasing state general purpose spending by over twice the rate of inflation to over \$11 billion a year for the first time. The university system was given its most favorable budget in memory. In a major policy change, the Regents were given the authority to spend money raised through tuition hikes not approved through the Legislature.

The teachers' unions felt it was their most favorable budget in a long time as money flowed for smaller class sizes, more special education, more summer school and more all-day

kindergarten.

Laws changing teachers' salaries were changed forcing school districts next year to give minimum average increases of over 4%. A new \$20 million a year anti-smoking program was instituted (Ads currently on television are not part of the state program which will be added to the current ads).

BadgerCare was funded for the first time, and it's the most generous government program in the country for otherwise uninsured families. Money was allocated to increase the prison population from 18,000 to 24,000 in two years. (It now appears we'll be closer to 22,000). Counties were forced to do additional planning through a Smart-Growth program that will be an employment boom for government planners.

Major utility reform provides a new \$30 million a year low income program to be paid from your utility bill. State, county and school employees will receive a generous pension increase. The state debt load increased overwhelmingly, as new parkland will be purchased at twice the

rate in the next ten years as it was in the last ten years.

Bonding was approved for a new Department of Revenue building to pay for all of the above. In addition, many other provisions and 150 other bills were passed adding laws from regulating athletic trainers to providing protections for liquor wholesalers. The Milwaukee bus system was given a generous increase in funding.

Only someone like a Journal Sentinel editorial page writer could claim that all of the above spending was not enough. Does the Journal Sentinel expect Wisconsin to be turned into a socialist state in only two years?

You will notice that absent from the above work was passage of laws reining in the Department of Natural Resources, family planning services for minors, protecting gun manufacturers from government-filed lawsuits or substantial tax relief.

It seems as though both parties can work together to expand government but shy away from the type of change I hear people want. As one can tell from the above comments, I felt the Legislature worked too well and we could have used a little more gridlock in Madison. Unfortunately, these newspapers editorials do have an effect in that

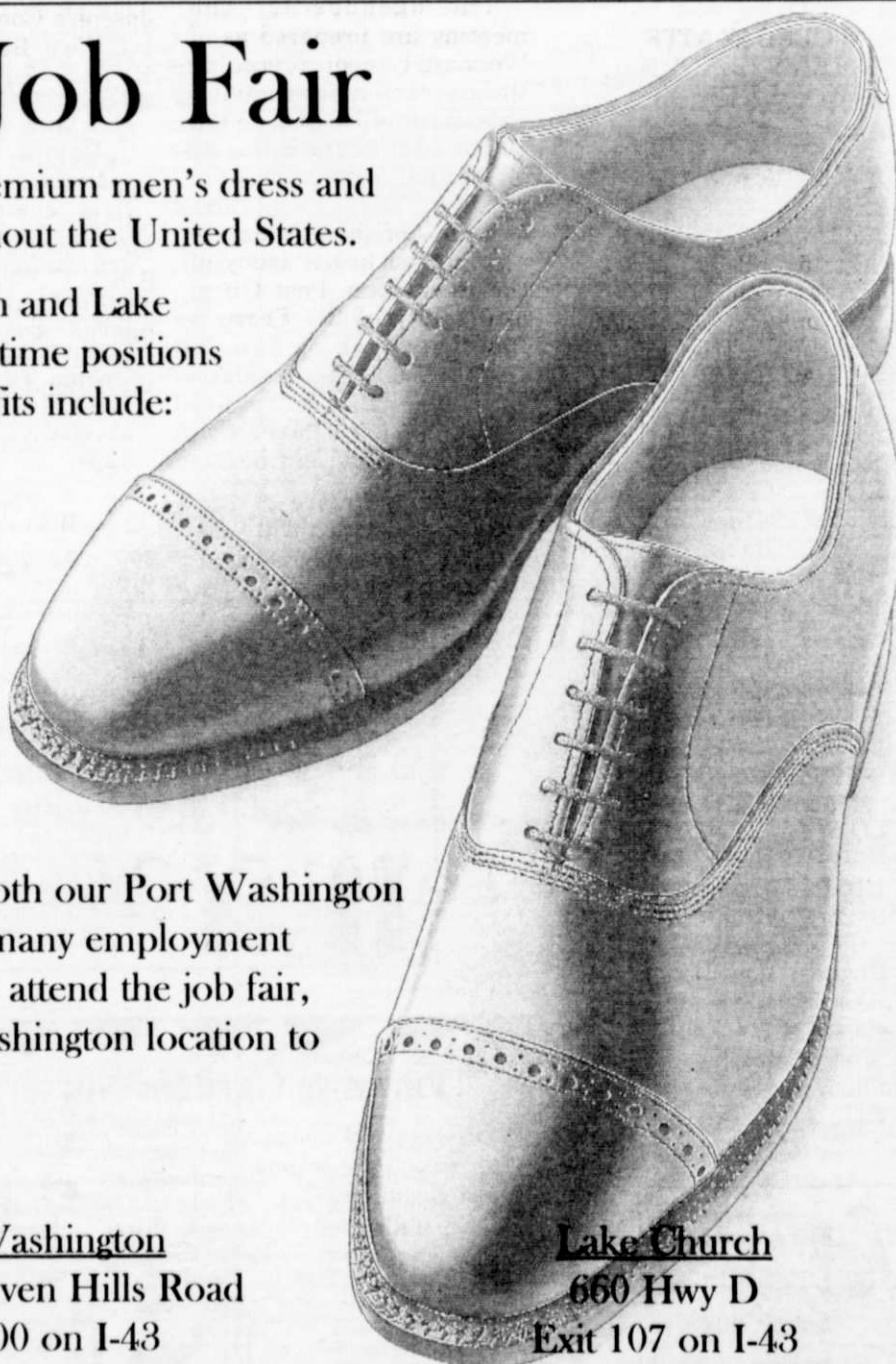

Turkey Hunters Off to a Fast Start

MADISON - Wisconsin turkey hunters were off to a fast start during the April 12-16 first period of the six-period spring turkey season.

One of the most important factors, the weather, was near perfect for the first three to four days of the period, according to Keith Warnke, Department of Natural Resources upland wildlife specialist. The last day of the period, April 16, was cold and in some areas wet or icy, which kept birds and hunters quiet. Hunters reported seeing many toms; some even had a choice of targets.

Most gobbling was heard from birds still on roosts in the early morning. Mating is in full swing and once birds were on the ground, gobbling seemed to slow down, Warnke said.

Mike Foy, a DNR wildlife biologist, said he saw toms displaying "on every other hill, the whole way," on a trip from Yellowstone Lake to Fitchburg on Thursday evening. Even the registration stations in his area that in past years have had low numbers, were registering birds at a steady pace.

Hunters were bringing in

some large birds with at least one 25-pound-plus tom recorded and many in the 22-and 23-pound class.

The success of Wisconsin's turkey program has been phenomenal, Warnke said. The birds disappeared from the state in 1881 due to hunting pressure and habitat loss. An early effort to reintroduce them failed but a second attempt in 1976 was successful.

The modern day turkey season was initiated in 1983, and a fall season was added in 1989. With an estimated population of 250,000 birds in the state, hunters were able to safely harvest 33,168 birds in the 1999 spring season. More than 130,000 permits were issued for the 2000 spring season.

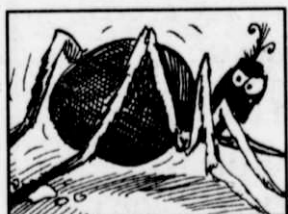

Indians Fail to Defend Their County Tournament Title

In April of 1999 the Kewaskum High School varsity boys golf team won the Inaugural Washington County Invitational 18-Hole Tournament at the Washington County Golf Course near Hartford.

The Indians proved to have greater depth on their varsity team than their counterparts from the six other high school teams from within the county. The KHS linksters earned rights to the FIRST PLACE traveling trophy for the past year.

On Saturday, April 22, Hartford Union High School hosted all the varsity boys golf teams in Washington County in the Second Annual Invite conducted at the Washington County Golf Course. The 18-hole stroke play event was held on a glorious spring day with warm, sunny and dry conditions. The Indians were ready and eager to defend their first county championship.

The tournament began at approximately 11 a.m. with all participants starting on the back nine first. Plus all teams consisted of eight team members each, with the top seven scores counting toward the team total. The last foursome finished around 5:30 p.m. with the awards presentation at 6 p.m.

Upon the completion of the first round, the Indians totalled 292 to lead their next closest competitors by eight strokes as Germantown, Kettle Moraine Lutheran and Slinger tallied 300. Kewaskum was led by Curt Koth's 39, Kevin Miller's 39, Jon Boedeker's 40, Bill Koch's 42, along with Dustin Melzark's 43,

Josh Stangl's 44 and Noah Koch's 45.

Unfortunately the local linksters were unable to duplicate their performance on the second (front) nine as the Indians dropped to third place overall. Hartford improved upon their first round total by 11 strokes resulting in a winning total of 597.

Kettle Moraine Lutheran was able to reproduce the same score on the second round to finish in second place with a 600 total. Kewaskum added 20 more strokes to their first nine subtotal to finish with 604.

Hartford and Kettle Moraine Lutheran proved to have better depth this year as the varsity Indians did not maintain their steady scoring throughout the day. Kewaskum has been tremendous in nine hole competitions by scoring totals of 168, 167 and 160 in three of their last four rounds.

However, the Indians are averaging a 177 per nine during 18 hole tournaments. Thus the Indians need to make a noticeable step up in their mental preparation for 18-hole competitions.

By comparison, Kewaskum actually shot 28 strokes better in this year's county tournament, but the competition had obviously improved as well since the 1999 invitational. The victorious Orioles of Hartford bettered their 1999 total by 47 swings whereas KML did so by 45 strokes.

The level of play throughout the whole tournament had improved significantly. In fact, KHS's winning total in the first-ever county meet would have finished last this year.

Last year's medalist Jon Boedeker of Kewaskum improved his personal score by four strokes to finish fifth best this year at (40-39) - 79. Both senior Curt Koth (39-44) and junior Bill Koch (42-41) shot 83, followed by junior Kevin Miller's (39-46) 85 and junior Josh Stangl's (44-45) 89. Sophomore Noah Koch put together a pair of con-

sistent 45's for a 90 total.

The 2000 Washington County Invite Team totals and places were:

First - Hartford Orioles, 304-293 - 597; Second - Kettle Moraine Lutheran, 300-300 - 600; Third - Kewaskum Indians, 292-312 - 604; Fourth - Germantown Warhawks, 300-307 - 607; Fifth - Slinger Owls, 300-320 - 620; Sixth - West Bend East Suns, 306-317 - 623; Sixth - West Bend West Spartans, 305-318 - 623.

Despite dropping off during the second round, Kewaskum continues to develop more varsity level competitors as indicated by Kevin Miller's 39, Bill Koch's 42 and 41 and Dustin Melzark's 43. The competition for varsity positions should result in much better scoring as the season progresses. Especially when senior Todd Wright returns from a week-long Florida vacation during this week's Spring (Easter) Break.

The Indians will compete in the 24-team Oak/Lion Invite at the Country Club at Camelot on Wednesday, April 26, then start their Eastern Wisconsin Conference Matches on April 27 against Plymouth at Hon-E-Kor Country Club and on April 28 at New Holstein at the Badger Creek Golf Club.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Regular Session in the Council Room of the Municipal Building, 204 First Street.

Administrator Daniel Schmidt called the meeting to order due the absence of President Robert Wagner who asked to be excused. All other Trustee members were present. A quorum was present.

On a motion by Trustee Larry Ammel, seconded by Trustee John Kenworthy and unanimously carried by voice vote the Board elected Trustee Robert Stoltzmann as President Pro-tem.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Larry Ammel, seconded by Trustee Harry Roecker and unanimously carried by voice vote, the minutes of the March 20, 2000 were approved as printed.

A public hearing was held on the application of the Kewaskum Athletic Club, Inc., Kiwanis Park, Kewaskum, WI for a Class "B" Fermented Malt Beverage License for a period commencing April 15, 2000 and ending October 15, 2000. On a motion by Trustee Harry Roecker, seconded by Trustee Andy Pesch and carried by the majority roll call vote, the Board closed the public hearing. Roll call vote was 6 "Aye" 0 "Nay" 1 "Absent".

Fire Chief Mark Groeschel presented the March 2000 report:

Fire calls- 5, Year to date- 10.
Jaws calls- 0, Year to date- 1.
Rescue calls- 22, Miles- 420.

Fire Chief Mark Groeschel informed the Board that the 1864 was returned last Wednesday, March 29, 2000 and that the new pumper was placed into service on Thursday, March 30, 2000. The Fire Chief also invited everyone to attend the wet-down of the new pumper scheduled for Thursday, April 27, 2000 at 7:00 p.m. at the Kewaskum Kiwanis Community Park. This wet-down is similar in nature to a launching of a ship and will be followed with a reception at the Fire House.

Chief of Police Richard L. Knoebel presented the following:

1) Announced the receipt of COPS Grant in the amount of \$150,000 over a 3 year period for the hiring of 2 new police officers. It was noted that if the Board was interested in accepting the grants, one officer would be added in May or June and the other in September or October. The paperwork has not been received regarding the grants, but if the Village wants to proceed by May interviews etc. need to proceed prior to the next meeting when the Board would take some official action on the acceptance of the grant(s). Please be advised of the following requirements to appear before the Board of Review and procedural requirements if appearing before the Board:

No person shall be allowed to appear before the Board of Review, to testify to the Board by telephone or to contest the amount of any assessment of real or personal property if the person has refused a reasonable written request by certified mail of the Assessor to view such property.

After the first meeting of the Board of Review and before the Board's final adjournment, no person who is scheduled to appear before the Board of Review may contact, or provide information to, a member of the Board about the person's objection except at a session of the Board.

No person may appear before the Board of Review, testify to the Board by telephone or contest the amount of assessment unless, at least 48 hours before the first meeting of the Board or at least 48 hours before the objection is heard if the objection is allowed because the person has been granted a waiver of the 48 hour notice of an intent to file a written objection by appearing before the Board during the first two hours of the meeting and showing good cause for failure to meet the 48 hour notice requirement and files a written objection, that the person provides to the Clerk of the Board of Review notice as to whether the person will ask for removal of any Board members and, if so, which member will be removed and the person's reasonable estimate of the length of time that the hearing will take.

When appearing before the Board, the person shall specify, in writing, the person's estimate of the value of the land and of the improvements that are the subject of the person's objection and specify the information that the person used to arrive at that estimate.

No person may appear before the Board of Review, testify to the Board by telephone or subject or object to a valuation; if that valuation was made by the Assessor or the Objector using income method; unless the person supplies the Assessor all of the information about income and expenses, as specified in the manual under Sec. 73.03(2a), that the Assessor requests. Statutes.

The KHS weightman's shuttle (3x100m) team of David Cibulka, Josh Peterson and Dan Willkomm, also finished second

with a time of 42.8.

The 400m relay team of Andy Breese, Mike Zingsheim, Matt Hartmann and Luke Kehres finished third with a time of 51.8 seconds. The KHS sprint medley relay (400m-200m-200m-800m) team of Andy Lickel, Mike McKee, Mike Zingsheim, and Travis Tiedt finished third with a time of 4:20.5.

The discus relay team of Troy Koefler, David Cibulka and Josh Peterson placed fourth with a combined distance of 251'1" with Cibulka's 93' throw the best of the three Kewaskum throwers.

The shot put relay team of Koefler, Peterson, and Willkomm placed fifth with a combined distance of 92'8-1/2" with Koefler's 35'7" throw the best of the three Kewaskum throwers.

The 3200m relay team of Travis Tiedt, Kurtis Cochran, Joe Rinzel, and Keith Boegel finished fifth with a time of 10:15.3. The high jump relay team of Tiedt and Boegel also finished fifth. Likewise, the 1600m relay team of Paul Mertz, Josh Peterson, Bill Thelen and David Cibulka finished fifth with a time of 4:10.4 with Mertz running the fastest 400m split.

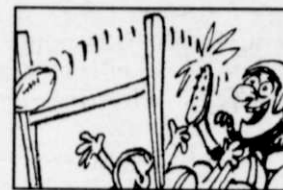
Upon completion of their

Ordinance No. 2000-01

AN ORDINANCE RELATING TO THE CONFIDENTIALITY OF INFORMATION ABOUT INCOME AND EXPENSES REQUESTED BY THE ASSESSOR IN PROPERTY ASSESSMENT MATTERS IN THE VILLAGE OF KEWASKUM

WHEREAS, as part of the Budget Adjustment Act, 1997 Wisconsin Act 237, a number of significant changes regarding property tax assessment appeals and Board of Review procedures were enacted; and

WHEREAS, at Section 279(K) of 1997 Wisconsin Act 237, Section 70.40(7)(af) of the Wisconsin Statutes was created; and

WHEREAS, Section 70.47(7)(af), Wis. Stats., requires that the municipality provide by ordinance for the confidentiality of information about income and expenses that is provided to the Assessor under Section 70.47(7)(af), Wis. Stats. and shall provide exceptions for persons using the information in the discharge of duties imposed by law or of the duties of their office or by order of the court,

NOW, THEREFORE, the Village Board of the Village of Kewaskum, Washington County, Wisconsin, DO ORDAIN AS FOLLOWS:

The Village Board of the Village of Kewaskum, Wisconsin creates Section 2.262 etc., of the Municipal Code which reads as follows: 2.262 ASSESSOR CONFIDENTIALITY

SECTION 1: Whenever the Assessor, in the performance of the Assessor's duties, requests or obtains income and expense information pursuant to Section 70.47(7)(af), Wis. Stats., or any successor statute thereto, then, such income and expense information that is provided to the Assessor shall be held by the Assessor on a confidential basis, except, however, that said information may be revealed to and used by persons: in the discharging of duties imposed by law; in the discharge of duties imposed by office (including, but not limited to, use by the Assessor in performance of official duties of the Assessor's office and use by the Board of Review in performance of its official duties); or pursuant to order of a court. Income and expense information provided to the Assessor under Section 70.47(7)(af), unless a court determines that it is inaccurate, is, per Section 70.47(7)(af), not subject to the right of inspection and copying under Section 19.35(1), Wis. Stats.

SECTION 2: SEVERABILITY

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

SECTION 3: EFFECTIVE DATE.

This ordinance shall take effect immediately upon passage and posting or publication as provided by law.

Sparks Breaks Discus Record Again; 400m Relay Ties Record Boys Track Fifth at Slinger Relays

SLINGER -- The Kewaskum High School track and field team competed in the annual Slinger Relays on Tuesday, April 18, against some tough Division I schools. Green Bay Prebble won the relay meet by winning 10 of the 15 events with a score of 124 points, 18 points ahead of Hartland Arrowhead, who finished with 106 points.

Wisconsin Lutheran finished third with 78 points, Slinger finished fourth with 66 points, and Kewaskum finished fifth with 50 points. Waupun finished sixth with 16 points.

Kewaskum finished second in five events with their sprinters responsible for three of the five second place finishes. The second event of the afternoon had the Kewaskum 400m (4 x 100m) relay team of Jim Thelen, Chris Canter, Tony Fitts and Charlie Sparks wearing their spikes on the all-weather track and running their fastest time of the season by 2.2 seconds.

They finished second and in the process tied the school record with a time of 45.2 seconds. "They definitely came ready to run," Coach Gosa commented about the Kewaskum sprinters. Green Bay Prebble won the 400m relay with a time of 44.5 seconds.

The Kewaskum Sprint Medley (400m-200m-200m - 800m) relay team also finished second with Green Bay Prebble again taking the win in 3:46.4 (three minutes and 46.4 seconds) compared to Kewaskum's 3:48.1.

Chris Canter ran the opening 400m leg with a split time of 54.3 seconds and then handed off to Tony Fitts. Fitts ran 200m and then handed off to Jim Thelen who also ran 200m. Thelen then gave the baton to Jesse Boegel for the final leg of 800m. Boegel ran very

hard and had a time of 2:05 for his split. "They all ran well. First Chris ran exceptionally well in the opening 400m leg to put us in good position. He dropped over two seconds off his previous best time in the open 400m dash. Then Fitts and Thelen really did a good job with their 200m legs. Both ran their fastest 200m splits of the season. Also, Jesse Boegel really pushed hard in the 800m leg and ran his fastest 800m of the season. He ran great," reported Coach Gosa.

Moments after the Sprint Medley relay, Thelen, Canter, and Fitts were back on the track competing with teammate Charlie Sparks in the 800m relay. The Kewaskum unit again finished second, this time to Wisconsin Lutheran in a very close race. Wisconsin Lutheran finished first with a time of 1:36.2 while Kewaskum finished second with their best time of the season by almost two seconds with a time of 1:36.5. "They gave it their best. They ran very well against some tough competition," reported Coach Gosa.

The Kewaskum pole vault relay team of Josh Parrent, Brian Wall and Joel Hermann also placed second with a combined height of 34'6", which also established a new school record. The old record of 34' was held by Brad Hermann, Chris Koth, and Dan Wall, set in 1998 at the Confer-

ence Relays. Parrent, vaulting late into the dark evening, cleared 12'6", Wall 11'6", and Hermann 10'6". Prebble won with a combined height of 36'6".

Charlie Sparks again broke the school record in the discus with a throw of 155'11". Sparks had the best throw of the competition. Sparks teamed with Nathan Fechter and Dan Willkomm to finish a distant fourth with a combined distance of 326' in the six team competition. Green Bay Prebble won with an impressive combined distance of 406'3", compared to 356'10" for Arrowhead and 355'8" for Slinger.

The KHS weightman's shuttle saw Nathan Fechter, Troy Koerferl and Charlie Sparks placed second with a time of 38.0 seconds, just behind Prebble's 37.8 seconds winning time.

The Kewaskum long jump relay team of Chris Canter, Justin Weninger and Paul Mertz placed fifth with a combined distance of 50'9-1/2". Tony Fitts competing for the first time in the long jump, jumped on the JV team and ended up having the best jump of any Kewaskum long jumper with a distance of 18'9". Had Fitts jumped for the varsity he could have propelled the Kewaskum varsity to a third place finish.

The KHS high jump team of Paul Mertz, Tom Ogi and Mike McKee placed fifth with a combined height of

16'. Prebble won the event with a combined height of 17'8". The triple jump team of Justin Weninger, Kurtis Cochran, and Troy Kedroske likewise also placed fifth with a combined distance of 92'5-1/4". Prebble again won this event with a combined distance of 113'11".

The Kewaskum 3200m (4x800m) relay team of Darrell Woebbeking, Troy Kedroske, Chris Baker and Jesse Boegel also finished fifth with their fastest time of the season in 9:24.2. Arrowhead won the event with an impressive time of 8:32.2.

"We knew going into the meet that there were four events that we should be very competitive in. The good thing is that we did very well in those four events against some very tough competition. We ended up placing second in three running relays, the 400m, sprint medley, and 800m relays, along with the pole vault relay. We were very happy with their efforts and the results," concluded Coach Gosa.

Grafton High School hosted their annual Black Hawk Golf Invite at the Country Club of Wisconsin.

The eight team tournament featured six WIAA Division One schools and two WIAA Division Two teams in the 2000 field. The No. One rated team in the state, the Brookfield Central Lancers, had won the Lake Country Invite on the 15th and finished second at the Sheboygan North's Invitational at Blackwolf Run on Monday, April 17, was favored to defend their 1999 Grafton Golf Title. However, the host Grafton Black Hawks, who finished second last year at the Division Two

Then the temperature actually improved as the sun came out during the play of the middle holes. The nine-hole event concluded as the cool winds came off the lake

and the skies becoming overcast as expected.

As the players came in off the 7,049 yard links layout, coaches started to record and post individual scores as well as team totals. It became apparent that the traditional division one powers struggled at their two through four varsity spots, whereas the Indians were recording solid scoring throughout their linkster lineup.

When the coaches finished tallying, totalling and tabulating, the Kewaskum Indians were excitedly surprised to realize that they had captured the 2000 Grafton Black Hawk Tournament Team Title by one stroke over Hartford and by two strokes over Menomonee Falls and Sheboygan North. Both Grafton and Brookfield Central finished well back to the dismay of most in attendance except the exhilarated Indians of Kewaskum High School.

varsity of KHS was senior Curt Koth and junior Jon Boedeker, who toured the front side in 40. Needless to say, this tournament championship should have done wonders for the team's confidence going into Saturday's (4-22) Second Annual Washington

County Invitational scheduled at the Washington County Golf Course near Hartford, especially since it too is a Links style trac.

The Indians, who won the inaugural tournament last year were looking to defend their 1999 County Championship. However the greatest benefit was to see the sheer joy experienced by the KHS varsity boys golf team members at the conclusion of those invites.

During the Easter Break, the Indians will compete in the 24 team Oak/Lion Invite at the Country Club at Camelot on Wednesday, April 26. Then KHS will begin its Eastern Wisconsin Conference schedule by hosting perennial power, the Plymouth Panthers, on April 27 at Hon-E-Kor Golf and Country Club.

The Indians will conclude their break at Badger Creek Golf Course versus the New Holstein Huskies on Friday, April 28.

Boys Golf Team Measures Up Against The Best in 38-Team Invitational

As a means of determining their early season status, the Kewaskum High School varsity boys golf team competed in the Lake Country Invitational at the Olde Highlander Golf Club at Olympia Village in Oconomowoc.

This boys' team tournament was hosted by Hartland Arrowhead High School on Saturday, April 15, starting at 9 a.m. and concluded at 3 p.m. Thirty-eight area high school teams comprised of four members each played 18 holes against many of the state's top ranked teams in division one and two from WIAA as well as WISAA.

Traditionally, this tournament features many of last year's state tournament teams. This year's field included six of the top eight division one teams and two of the top three in division two. Therefore this invitational serves as a great indicator of your team's position at the start of the spring golf season.

The competition and the weather conditions proved to be challenging as the winds shifted around from the north as a cold front moved through the area around 12 noon. The temperature dropped at least 15 to 20 degrees.

The Indians proved to be up to the challenges early in the tournament with all four local linksters recording solid scores between 40 and 45 for a first round team total of 168.

Unfortunately as the weather changed so did the individuals scores and team totals. The second nine got

long and resulted in rounds ranging from 42 to 50 for a 187 team total. Thus, the Kewaskum Indians finished tied for 20th out of the 38 teams with a team total of 355.

Individually, senior Curt Koth started out with a 40 on his first nine, but experienced some trouble off the tee, leading to a 50 on his second nine and a tally of 90. Fellow senior Todd Wright tied Curt by hitting rounds of 43 and 47. Junior Jon Boedeker led the team with scores of 42-40 for an 82 total. Rounding out the Indian roster was junior Josh Stangl who put together scores of 48 and 45 for an

individual total of 93.

Last year the KHS varsity team started out their season by winning two of the first three tournaments that they participated in. Yet the Indians were unable to maintain that level of success as the season progressed.

Therefore, the varsity team members have used the early season team tournaments as a starting point rather than as the high point of their season.

With the fourth place finish at the Horicon Marshland Invitational on April 13 and their 20th place at the Lake Country Tournament on April 15 in Oconomoc along with their next Invite that was scheduled for April 18 at the Country Club of Wisconsin, the Indians should begin to have a firm grasp on where they stand in respect to area, regional and state scholastic golf teams.

Now that they have com-

peted with the area's best teams, the KHS varsity team members need to gradually improve their level of play, such that, at season's end, they are capable of challenging those quality opponents throughout the tournament series, in conference play, regionals and sectionals.

This annual tournament at Olde Highlander gave the team a chance to be measured against some of the best teams so that they can gradually develop into a very solid tournament team later.

Although the Kewaskum Indians were in the top third of teams at the turn, KHS gradually fell back into the 20th position overall at the conclusion of this annual gathering of many of the state's finest golf teams. However, the local linksters will not have to face any tougher competition throughout the remainder of the season.
