Geidel is Fifth Generation to Own and Operate Grocery Store in Kewaskum

Geidel's Piggly Wiggly Now Open

Kewaskum is home to a brand new Piggly Wiggly store located at 940 Fond du Lac Avenue. Ribbon cutting ceremonies were held on June 22. Long-time resident Mike and Jesslyn Geidel have started a new corporation called Geidel's Foods, Inc.

"Our family brings a long history in the food business," said Mike. "I make the fifth generation to carry on the family tradition of serving the Kewaskum community."

In the late 1800's Nic Marx opened a business that included a simple grocery store and saloon at the age of 25. It was located just west of the railroad tracks on the south side of Main Street.

By the year 1901, Marx was selling groceries, flour, feed, oysters, along with cigars, wine and liquor in the saloon. Being located near the tracks was convenient to attract passengers for a quick snack. Soft and hard coal were also stored and sold out of the bins located next door behind the Citizens Bank. In the year 1911 his son, John, took over the business.

John Marx continued to operate the store at the same location until 1926. He then moved the business next door, in the building where the bank was, and joined the newly formed Independent Grocers Alliance (IGA). The new store was called 'John Marx IGA.'

John, along with his son Harold, sold a full line of boxed, jarred and canned goods. Later they added fresh produce, a limited selection of refrigerated and frozen items and a variety of IGA brand products.

Harold was nicknamed 'Mixie.' He acquired the name as a young man that would mix the hard candies at the store. Mixie left the store for a time when he was in Lake Wales, Florida for Major League Baseball tryouts. In 1936 he returned to Kewaskum to work full-time at the store stocking shelves and delivering groceries.

Harold married Eleanor Hron in 1939 and started a family. Their daughter Judy soon accompanied him on the Thursday trips to the Godfrey Company warehouse for fruits and vegetables to sell at the store for the weekend. Weekly trips were also made to State Street to candle the eggs brought from local farmers.

The coal bins behind the store were converted to storage units and rented for \$5 a

month. Friday was movie night, in Kewaskum. Local residents would go from store to store signing up for prize drawings. Those nights were so busy that an employee would run the only register in the store and Eleanor ran an extra till out of a cigar box.

On Jan. 1, 1956 Harold and Eleanor purchased the business from John, starting the third generation of Marx IGA. They ran the store with their children Judy, Jim, Sue, Mary and employees Frances Van Blarcom, Meta Heimermann and Norb Rohlinger.

"Our family brings a long history in the food business,"

In the fall of 1961 Harold and Eleanor purchased the existing seven buildings across the street that were owned by the H.J. Lay Lumber Company. The site was cleared and the new structure was built marking the start of Marx IGA Foodliner. The family worked around the clock cleaning coolers and shelves. Mixie's cooling team members even came in helping stock the store up until the night before it opened for business.

On Harold's birthday, Jan. 24, in 1962 Marx's IGA Foodliner became the newest and largest grocery store in the community. With a growing business the store was remodeled in 1965 and became Marx's Sentry Foods. The familiar Crestwood Bakery and the Sentry name was an asset to the Marx business.

The fourth generation of Marx ownership took place in 1976 when Harold's daughter, Judy, and her husband Bill Geidel purchased the business. They continued to operate the store at the same location until October of 1982 when they acquired the lease on the existing Shop Rite in the Kewaskum Mall.

After some remodeling, the business again grew to its fourth building and opened for business on Nov. 17, 1982. This move marked the first time the business operated off of Main Street since its beginning 106 years ago. The full service grocery store included a full deli department and soon Sentry became the only grocery store in Kewaskum.

"I have been in the grocery store business since I was 14," said Mike. "I graduated from Kewaskum High School in 1981 and received an associate degree in food marketing from Waukesha Technical School." Jesslyn is from Cedarburg and has schooling in landscape and horticulture. They have three children, Sarah (14), Kayla (11) and Ethan (9). Bill and Judy Geidel are semi-retired, but are helping out in the new store.

"We love the Kewaskum

community," said Mike. "It is a great place to live and raise a family. Those were things we considered when we decided to start our new business."

The new store is 26,300 square feet. It will be a full service supermarket. There will be an in-store bakery and deli offering ready to eat hot and cold sandwiches. The produce will carry a variety of items including a section for ready made salads and cut fruits. The meat department will have two grades of meat including certified Angus beef.

"Our new store will offer new products like vitamin enriched juices and pastas in the dairy department," Mike said. "The frozen foods and ice cream department includes 95 freezer doors to accommodate a variety of choices. We also have a liquor and floral department."

The store will include a wide variety of selections offered at bigger stores, but will be convenient for shopping. Jesslyn will run the floral department and have outdoor plants in the parking lot in the spring. Sarah will be helping out in the deli.

"Carrying on family tradition is important to us," said Mike. "My sister, Angie Tennes, will help run the store giving the good customer service she is known for. My cousin Aaron Laatsch will manage the store and his brother Anthony will work

here."

The new store will have familiar faces for Kewaskum residents. Geri Bodden and Virginia Lettow together bring with them a combination of over 25 years of deli and bakery experience. Jim Giese has over 25 years in produce; Brian Justman 12 years in the meat department, Ron Wagner over 7 years in dairy and Karen Grahl 20 years in customer service.

"Our new store has a website at www.geidelsfoods.com," said Mike. "It will list job openings and an online application for convenience. We will use the website to promote events in and outside the store. There will be deals for Piggly Wiggly card holders to get special coupons for saving on products."

Future plans for the website include the ability to order items like fruit baskets and deli trays online, some auctions for gift certificates and other items that non profit groups might want to use for fund-raisers.

The new Piggly Wiggly carries on family tradition in the Marx family, offering Kewaskum area residents quality products in a full-line supermarket. New products and the website are just some of the many conveniences that will be available for customers. The new store offers a fresh start and opportunities for the people of Kewaskum.

Have a Safe Fourth of July

If you are going to use fireworks at a family or neighborhood celebration, the Wisconsin Department of Agriculture, Trade and Consumer Protection recommends that you follow these guidelines. Have fun, but:

- * Never allow young children to play with fireworks - including sparklers.
- * Read and follow all warnings and instructions.
- * Never try to re-light fireworks that have not fully functioned.
- * Keep a bucket of water handy in case of a malfunction or fire.
- * Only light fireworks on a smooth, flat surface, always away from houses, dry leaves and other flammable materials.

"Each year, hospitals across the country treat over 11,000 fireworks-related injuries - most of which involve children under the age of 15," says Bill Oemichen, administrator of Trade and Consumer Protection. "Fireworks also cause more than 1,000 residential fires each year which cost millions of dollars in property damage."


Keep in mind that the sale of fireworks in Wisconsin is controlled by local ordinances that are different in every community. State law allows the sale of

fireworks more powerful than caps, sparklers and snakes only to out-of-state buyers or in-state organizations that hold a permit issued under a local ordinance. But many local ordinances are more restrictive. For example, Milwaukee and Kenosha ban fireworks altogether.

What about so-called "membership" in a private organization which allegedly gives the consumers a "permit" to buy and use fireworks which are otherwise banned under state law or local ordinances? The Wisconsin Court of Appeals has recently ruled that such "associate memberships" purchased by people at the time they buy fireworks are invalid.

What about buying banned fireworks in another state or through catalogs published by our-of-state companies? Wisconsin law still requires you to have a permit before you can use them in Wisconsin. Be sure to check with local officials before you spend money for fireworks that may be illegal to use in your area.

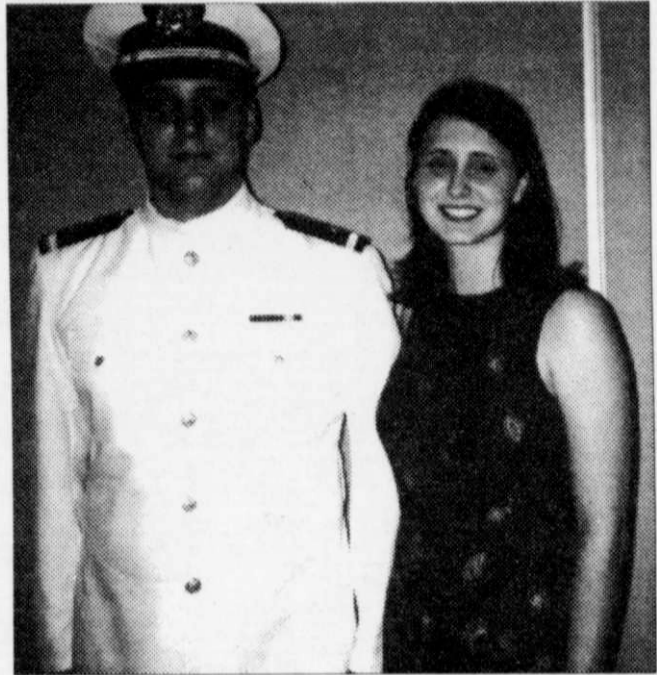

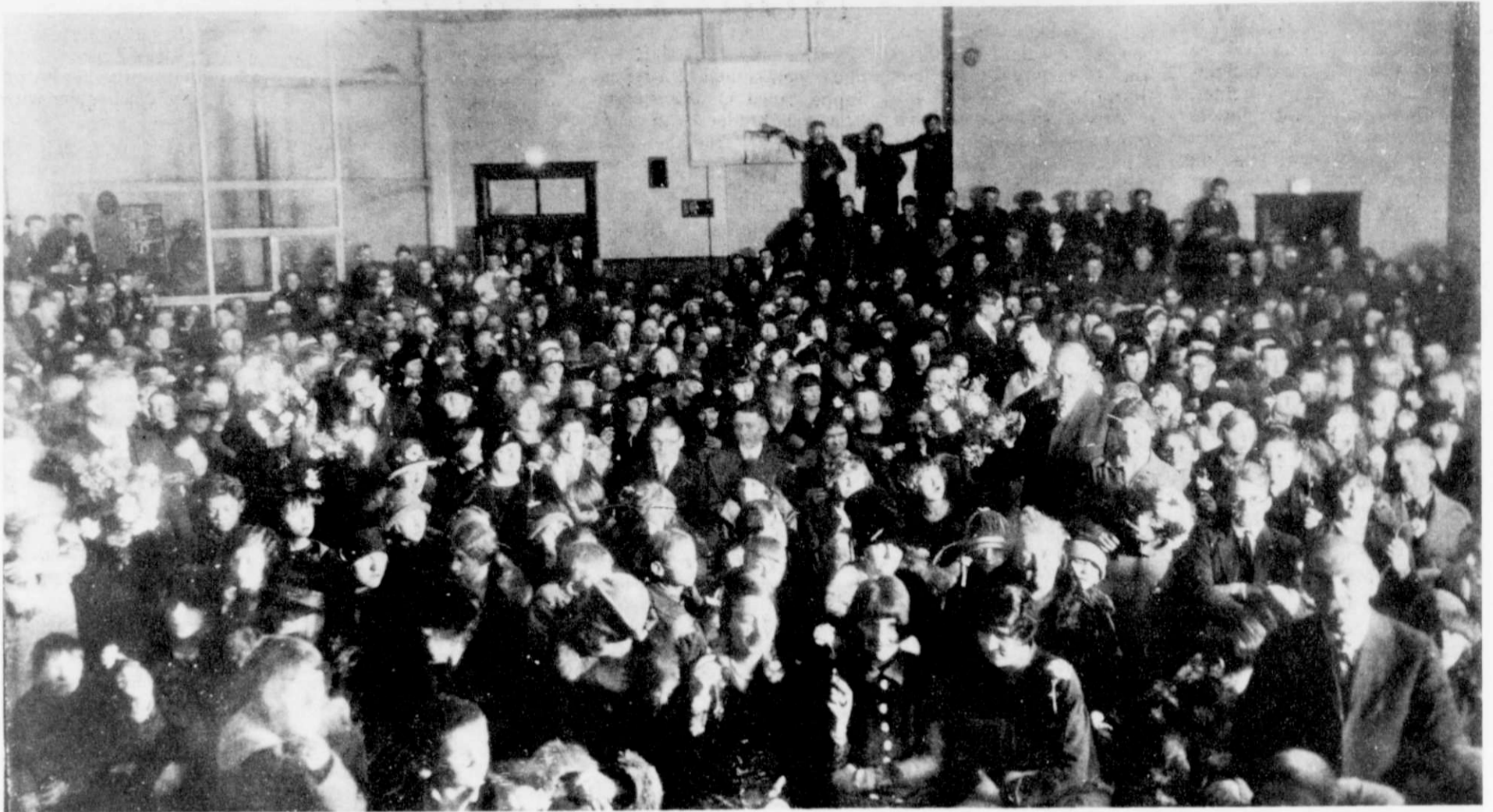

New Top Grant Provides \$1,000 To Students

Students who plan to attend a Wisconsin technical college this fall can tap into money provided by a new state initiative called the TOP (Technical and Occupational) Grant. The TOP Grant is a first-of-its-kind funding program spearheaded by Governor Tommy G. Thompson and the Wisconsin Legislature.

Beginning the fall, recent high school graduates and High School Equivalency Diploma (HSED) recipients who attend Moraine Park Technical College or another Wisconsin technical college can receive \$250 toward their tuition for four semesters, for a total of \$1,000.

While there are five basic eligibility criteria, obtaining the TOP Grant is very easy. Unlike other grants, it is not based in financial need or academic performance. Those who meet the criteria and take five minutes to complete an application will

receive the funds.

To be eligible for a TOP Grant, students must:

- * apply to a Wisconsin technical college within three years after graduation from a Wisconsin High School
- * enroll in an associate degree or technical diploma program
- * enroll as a first year student (First year students include new high school graduates or any student graduating after July 1, 1997, who have not earned more than 18 college credits after high school graduation.)
- * enroll full time (12-plus credits)
- * maintain a 2.0 GPA (grade point average) while attending a technical college.

Interested applicants can apply to the School District of Kewaskum. They would need to attend and complete a two-day workshop in Oshkosh (on Tuesday, August 22, and Wednesday, August 23, 2000). After course completion, the necessary paperwork (including certified school transcripts) would be completed and submitted to the Wisconsin Department of Public Instruction with a \$100 fee for the licensing.

After the State of Wisconsin has completed a background check, the individual would be able to substitute teach. Although we would prefer to see trained teachers in the classroom, there is an ongoing need for additional individuals to substitute teach. The Kewaskum School District is not immune to this problem. We continue to have difficulties finding adequate numbers of daily, short and long-term substitute teachers.

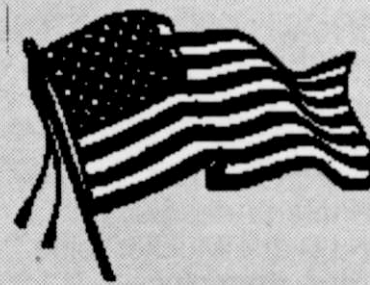

News From The Capitol

There is No Pollution Problem

Once again the issue of reformulated gas is the major topic of conversation in the six county non-attainment area in South-eastern Wisconsin.

The Wisconsin State Assembly Republicans are filing a lawsuit against the Environmental Protection Agency in an attempt to get a waiver from this requirement.

In discussing the matter, I have found two misconceptions with regard to the issue. First, some people are under the impression that Milwaukee has an ozone problem. In fact, not only do we have no ozone problem in Ozaukee and Washington Counties, but test sites on Appleton Avenue, well into the city of Milwaukee reveal less ozone exceedances than at the Harrington Beach site located on Lake Michigan.

The Department of Natural Resources operates approximately 25 sites in the state of Wisconsin. The only sites with ozone exceedances are those located right on Lake Michigan and, in fact, in recent years high ozone readings have been recorded in such isolated areas as Harrington Beach and Kewaunee County. Areas with high automobile usage do not cause this "ozone problem." It is caused by the interaction of the sun with the water. The "ozone problem" disappears when the sun

goes down.

The second fallacy is that reformulated gas is causing matters to improve. Ozone exceedances in 1993 and 1994 before reformulated gas were slightly less than since reformulated gas. Ozone was much more prevalent in the 70s and 80s, however.

The reason for the difference recently is cleaner burning engines. As a side-light, I can not remember anybody during the 1970s feeling it was difficult to breathe in this area. Now that the problem is a fraction of what it was then, we are not only requiring different gas, but driving industry from this area due to more onerous regulation as well.

The most frustrating factor in fighting this matter is the lack of support we have received from the Department of Natural Resources, which should be looking out for the State of Wisconsin. Their credibility with their fellow bureaucrats in the Environmental Protection Agency gives them influence elected officials do not have.

Unfortunately, the bureaucrats in Madison (who are not in the non-attainment area and are not affected by this) agree with the Environmental Protection Agency that there is a problem, which must be solved and are in favor of

reformulated gas.

The combination of the influence of environmental extremism and big businesses (in particular Archer-Daniels-Midland) who make money from the reformulated gas has caused the EPA not to listen to our plight. We have had to go to the court system. The Environmental Protection Agency recently lost a major suit brought by utilities for exceeding their regulatory mandate in that area -- let's hope we can keep their losing streak in tact.

Governor Ok's Pavement Seal-Coating Project at WB Municipal Airport

Governor Thompson has approved a \$110,000 project to seal-coat and help extend pavement life at the West Bend Municipal Airport.

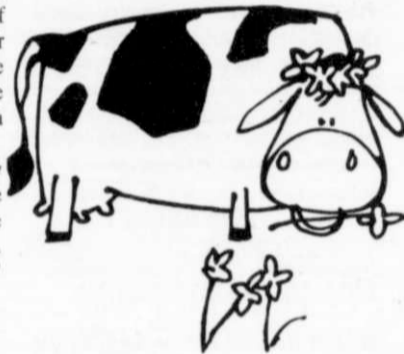
The Governor's actions releases \$88,000 in state funds to seal-coat, crack-seal and re-mark the airfield pavements. The City of West Bend is contributing another \$22,000 towards the project.

"Wisconsin's airports play an increasingly important role in our economy and overall quality of life," Governor Thompson said. "The seal-coating work is a wise and relatively modest investment compared to the much higher cost associated with re-constructing airport pavements."

The airport is expected to

be closed for a few days at a time during the various construction phases. It's hoped work on the project will be completed by September, 2000.

"Along with extending the life of the pavement, the dark-colored seal-coating and newly-painted runway marking makes the runways safer to use and very visible from the air," said Michael Gabor, Airport Engineering Specialist with the Wisconsin Department of Transportation.

Antlerless Deer Hunting Permit Deadlines July 20

MADISON - The deadline for hunters to apply for Hunter's Choice and bonus antlerless deer permits for the 2000 deer hunting seasons is July 20. Hunters should not apply for hunter's choice or bonus permits in this season's 97 Zone T deer management units, except in State Park units where hunter access is limited by this drawing process (please see the 2000 Wisconsin Antlerless Deer Permit Information sheet available at all license vendors).

Additional information on the 2000 deer season is available at Department of Natural Resources service centers and under the "outdoor activities" button on the DNR Website at <http://www.dnr.state.wi.us>.

Wisconsin deer hunters will face expanded Zone T seasons in 2000. In all, 97 deer management units

have been designated as Zone T. Some deer herd-control measures included in Zone T hunt are additional archery and gun hunting opportunities and free antlerless deer permits. The Zone T was created to help reduce the deer herd in overpopulated deer management units. This effort is intended to reduce the social and ecological problems associated with high deer densities.

Because of the extensive Zone T opportunities, hunters should carefully read the 2000 Wisconsin Antlerless Deer Permit Information sheet to determine if they should apply for a hunter's choice or bonus permits in the unit in which they hunt.

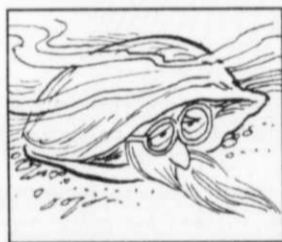

Anglers Need To Know Regulations

MADISON - With the fishing season now in full swing (the northern zone bass harvest season opened June 17) local Department of Natural Resources wardens are reminding anglers to make sure they know the regulations before hitting their favorite fishing hole.

"One of the problems we're seeing this year is people "sorting" fish," says Gary Homuth, DNR natural resources policy officer. "Any fish you take into your possession that you don't release immediately is part of your daily bag limit, even if you release it later. You cannot release a fish to keep another fish that you feel is more desirable. And the daily bag limit applies whether you're fishing on the water or from shore."

Homuth also says to make sure any fish you keep are the required minimum length. To do so, measure the fish in a straight line from the tip of the snout with the mouth closed to the end of the compressed tail. The best way to do this is to lay your tape measure on the ground and set your fish on top of it with the tail "pinched."

"A lot of anglers do not measure their fish properly," Homuth says, "they try to conform the tape measure to the fish and measure along the outside of the body. This of course will increase the measurement."

But Homuth is also happy to see more anglers practicing catch and release. "This is great for the overall health of any gamefish population, and it's a trend we hope to see continue."

For example, nearly 200,000 muskies were caught last year according to DNR statistics, but only about 4,300 - about 2 percent - were harvested. Muskies, once known as the fish of 10,000 casts, now require on the average only about 3,000 casts for an angler to land one. Bass and trout populations have also rebounded nicely in some areas thanks in part to catch and release.

Homuth offers these

catch and release tips:

* Play the fish as little as possible. Although it is fun to hook a "fighter," playing them to exhaustion decreases the survival rate.

* Be careful when handling fish. Your hands should be wet, and should touch the fish as little as possible. Get the fish back into the water as soon as possible.

* If a fish is deeply hooked, simply cut the line as close to the mouth as possible. The hook will not harm the fish and will eventually disintegrate.

Homuth offers these tips for anglers luck enough to catch "the big one":

* Don't clean or freeze the fish, and keep the fish cool - preferably on ice.

* Get the fish weighed as soon as possible on a certified scale (witnessed by an observer).

* Contact the nearest DNR office to get the species positively identified and to find out whether it's a record.

Also notify a DNR office if you catch a tagged fish. The fish are tagged for research purposes. Please be ready to state where and when the fish was caught, and its length and weight. PWC Users Suffer Accidents at a Higher Rate Than Other Boaters

MADISON - People who operate the increasingly popular personal watercraft (PWC) on Wisconsin waters need to know the special rules that govern their sport and drive defensively and courteously, boating safety experts say.

"Respecting others' rights and boating responsibly will help you have a safe, enjoyable day boating and it reflects favorably on the sport," says Doug Bilgo, Department of Natural Resources Conservation Warden.

That's particularly important because personal watercraft - often referred to by the trade name "Jet Skis" - suffer a proportionally high number of boating accidents. The sport is under fire from some lake property owners and other users who complain about PWCs making too much noise, coming too close to other boaters, and harming shoreline fish habitats.

The number of PWCs registered in Wisconsin has climbed from 5,425 machines in 1990 to 33,300 machines at the end of 1999, more than a 600 percent jump. Yet, while the machines still comprise only about six percent of Wisconsin's fleet of 565,000

registered motorized boats and sailboats, PWCs accounted for about one-quarter (47 of 164) boating accidents in 1999.

"The accident rates for PWC users are higher because most accidents involve people who have borrowed the PWC from the owner and have little or no experience operating boats," Bilgo says.

The most important measures PWC operators - particularly novices - can take to protect themselves are to read over their operator's manual and practice turns in an area free of other boaters, Bilgo says. That's because when an operator lets off the throttle of a PWC, he or she has no steering ability, so he or she needs to practice turning before getting out among other boats.

Operators also need to be aware of all boats around them and know the laws. They must obey both the boating regulations governing all motorboats and some additional restrictions. Among the additional restrictions are:

- * Everybody on board a PWC must wear U.S. Coast-Guard approved life jackets.
- * Operators may not operate a PWC that is towing people within 100 feet of a swimming area, a public boat landing, another boat towing a skier, the tow rope of a skier, or a person involved in

skiing or a similar activity.

- * Operators may not operate a PWC within 100 feet of another boat or PWC unless the PWC is traveling at a slow-no-wake speed and neither craft is involved in any type of water skiing or similar activity.

- * Operators may not use a PWC from sunset to sunrise.
- * Operators must go at a slow-no-wake speed within 200 feet of the shoreline of any lake.

Other tips for safe, responsible PWC operation include:

- * Respect the rights of others and be conscious of the noise your craft makes. Running a PWC in a small area for a long time can be irritating to others, as can jumping waves and making hair pin turns, which are the leading cause of excess noise as the exhaust system comes out of the water in such maneuvers.

- * Do not operate a PWC if you have been drinking.

- * Remember that no person under 12 may operate a PWC and that children older than 12 but younger than 16 may operate a machine only if they have passed a DNR prescribed boating safety course and possess a safety certificate issued by the DNR or another state.

- * Take a boating safety course from the DNR, the U.S. Power Squadron or the U.S. Coast Guard Auxiliary.

Gosa, Sparks Named MVPs at KHS Track Awards Ceremony

On Wednesday, June 7, the Kewaskum boys' and girls' track teams jointly held their annual potluck supper and awards ceremony in the cafeteria at Kewaskum High School.

Each specialty coach presented varsity letters and JV certificates to the athletes they coached during the season. Collectively, the coaches presented varsity letters to 13 athletes from the boys' team and 20 athletes from the girls' team.

Letters were awarded based on the number of varsity points scored by each athlete during the season. Coaches also presented JV certificates to a total of 19 boys and 10 girls.

team that also placed second at the conference meet. Emmy placed fourth in the finals of the 100m high hurdles at the sectionals with a career best time of 16.6 seconds.

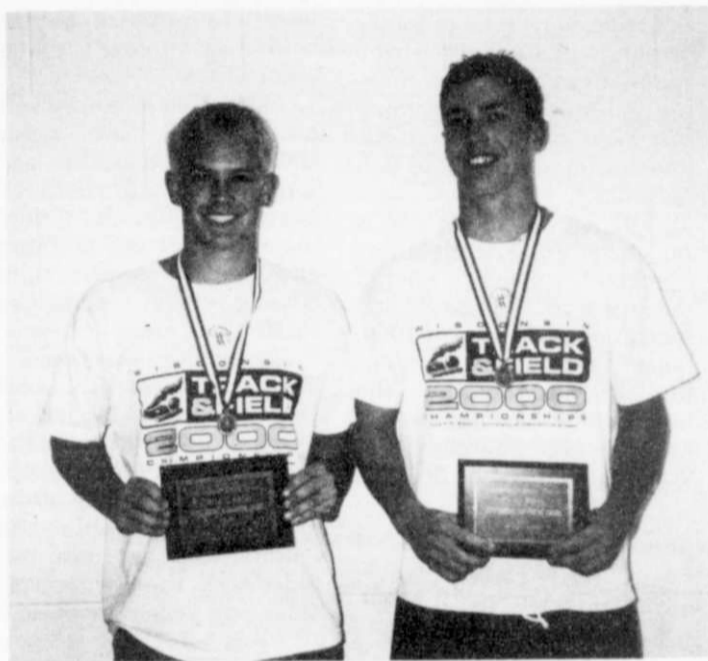

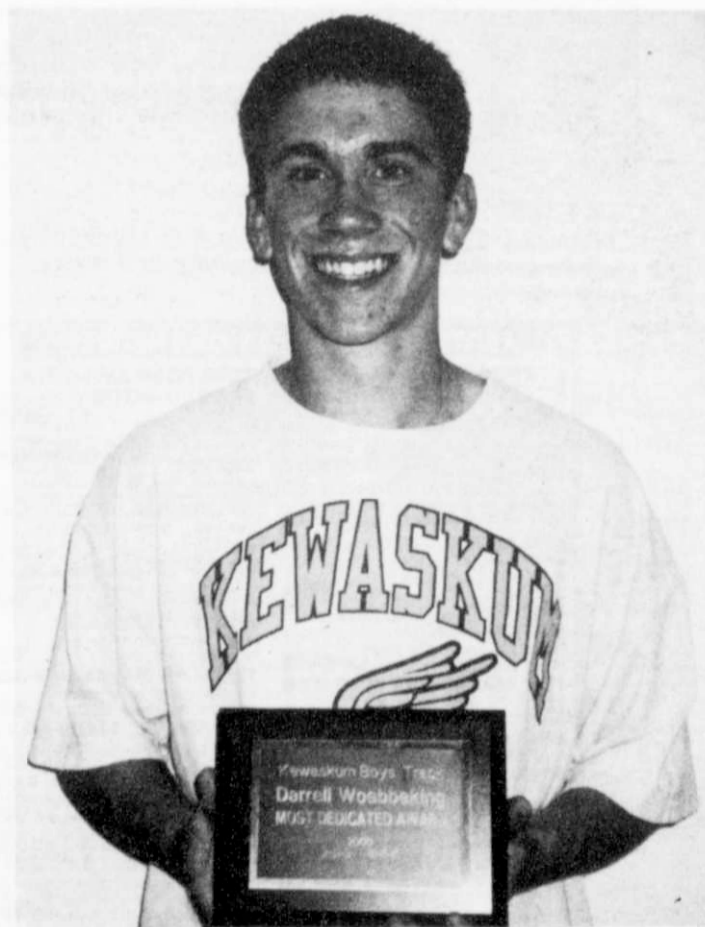

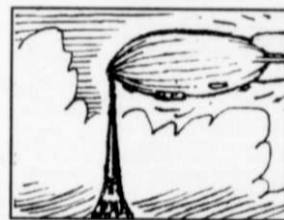
