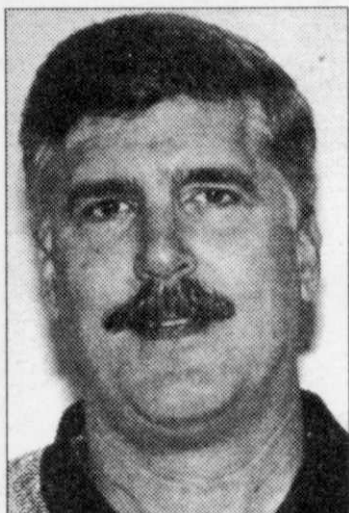

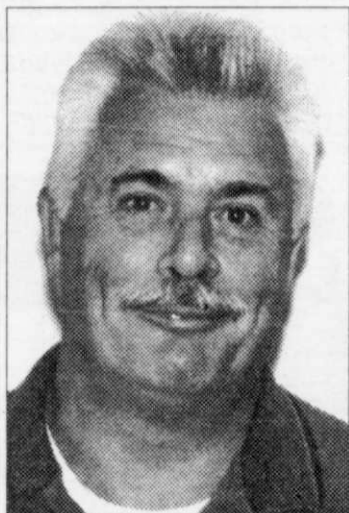

School Board to Choose From Three to Fill Vacancy

The Kewaskum School Board reviewed two letters of intent at Monday night's meeting. A third letter was found Tuesday after being misplaced through mail sortation.

Board president Jon Downs told the board that letters were received from Mark Steinhardt and former board president Neal Weare.

Superintendent Wayne Graczyk informed this newspaper Tuesday that school officials found a third letter from Steve Schmitt that was misplaced during mail sortation at the district office.

The board will personally interview the three at an open meeting Wednesday, Oct. 4 at 6 p.m. in the district administrative building. The public is welcome to attend.

The vacant seat was left by former board president, Larry Fechter who has moved out of

the district to accept a building and grounds supervisor position with the Iola-Scandinavia School District.

The selected board member will serve until the April election when the position will be up for election.

Mark Steinhardt of rural Kewaskum submitted his letter of intent. Steinhardt is married and has a son in the school district, and a daughter who graduated last year. "The reason for my interest in this position is a combination of two simple factors. I desire to be of service to the community in which I live, and I recognize the importance of providing a quality education for our youth, in an atmosphere that encourages them to do their best," he said in a letter of intent.

A business owner, Steinhardt graduated from KHS and holds an Associate Degree in Mechanical Design and a Bachelor of Science in Mechanical Engineering. He is

involved in his church board and a member of the Washington County Campus Foundation, an organization that raises and manages scholarship funds for UWWC.

Past board president Neal Weare feels he would be an asset to the board due to his 12 years of experience on the board and being a past board president for six years of those years.

Weare who lives in Campbellsport is married and has a daughter and two grandchildren attending school in the district.

In his letter he states, "My desire to see the Kewaskum School District continue to reach new goals, continues as strong as ever."

Steve Schmitt of Allenton, whose letter was the one found after the board's meeting, is married and has four children in district schools.

He is a journeyman tool & die maker, employed by Tools

Inc., of Sussex as a production plant manager with eight years of managerial experience.

"I believe the school board will benefit from my supervisory skills, work ethic and professionalism. Serving the public and having a more active role in local government is a goal of mine. I am a team player and a good listener," said Schmitt in his letter to the school board.

Gonnering Wins County Election By a Landslide

Only 130 of the Village of Kewaskum voters turned out for Tuesday's Primary Election to determine a Wisconsin U.S. Senate and Washington County Register of Deeds race.

Current Register of Deeds Dorothy "Tina" Gonnering received 53 votes in the village, 2,224 throughout Washington County. Karen Breit received 31 in

Kewaskum, 712 county-wide. Jodi Valind received 12 in Kewaskum, 560 throughout the county.

Gonnering will be running unopposed in the November election.

Local favorite, (r) John Gillespie took 55 Kewaskum votes and 123,371 throughout the state. Bill Lorge (r) received 6 in Kewaskum and 36,068 statewide. Marc Gumz (r) received 5 in the village and 20,330 statewide.

Incumbent Herb Kohl (d)

received 24 in Kewaskum and was the state favorite with 170,976 votes. Jim Sigl (d) received 3 in Kewaskum and 18,899 Wisconsin votes.

John Gillespie will challenge Herb Kohl in the November race.

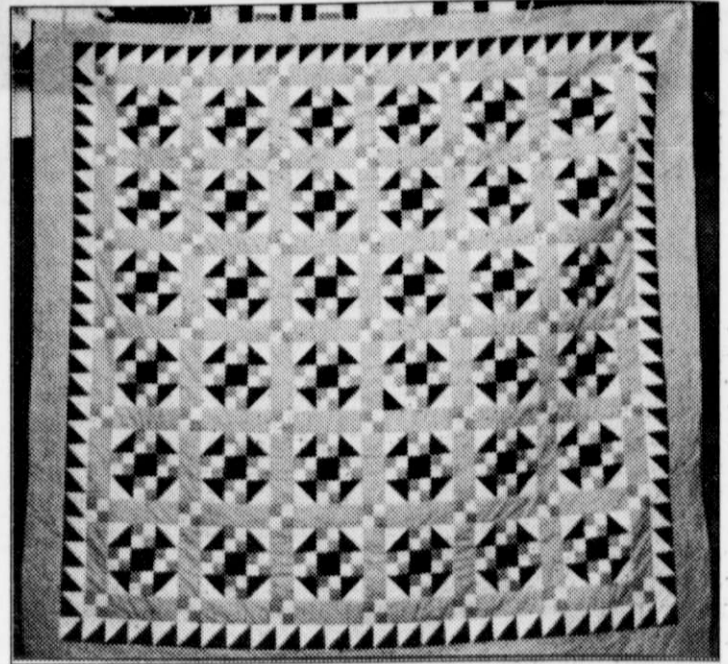

We've cherished in many ways.

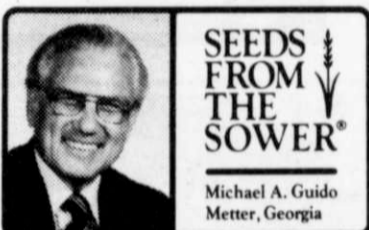
Some have graduated from High School this year, Another was recently wed One goes back to Alaska For me, I just scratch my head!

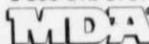

\$1,100,000 United Way Campaign Underway

Two key events have ushered in the start of the annual United Way of Washington County Campaign: the Business Leaders Breakfast at the Washington County Fair Park held on August 30, and the Campaign kickoff held on September 6.

The Keynote speaker for the Business Leaders Breakfast was Dan Finley, County Executive for Waukesha County. Mr. Finley's topic, "Working Together is the Only Way to Get Things Done," emphasized the importance of government, nonprofits, business and residents contributing and working jointly to address community concerns - and the collaboration necessary to ensure the continued quality of life. A former United Way chairman for Waukesha County, he shared his personal belief in the value of United Way and the services that member agencies provide. Approximately 70 business leaders and campaign volunteers attended this event.

On September 6, community volunteers and agency representatives officially began the 2000 Campaign at the Cedar Theatre on the Cedar Campuses.

The fun theme for volunteers this year is "Mysteries, Puzzles and Other Oddities," and the theatre provided the perfect setting for this event, which featured "Mission Possible: The Search for Donors" fun video.

The "Give Help, Give Hope" campaign video, highlighting local agencies was also shown. Those in attendance heard the campaign message of Help and Hope from the 2000 Campaign Co-Chairs, Charlie and Gaytha Hillman. United Way Board President James Hodges and Executive Director Barbara Hurula also spoke of the importance of the United Way effort here in Washington County.

More than twenty area businesses and organizations were Pacesetters for the 2000 campaign. United Way Pacesetters started their campaign on August 25. They ran early campaigns and "set the pace" for their divisions. Results for Pacesetters were announced on September 6. To date, \$123,375 has been raised in gifts and pledges, which is 11.2 percent of the overall goal.

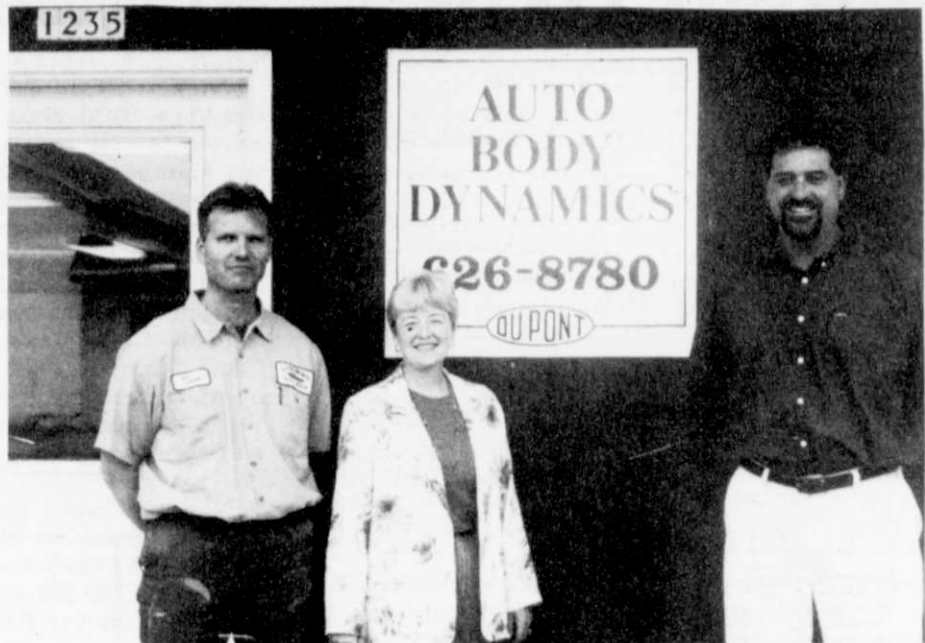

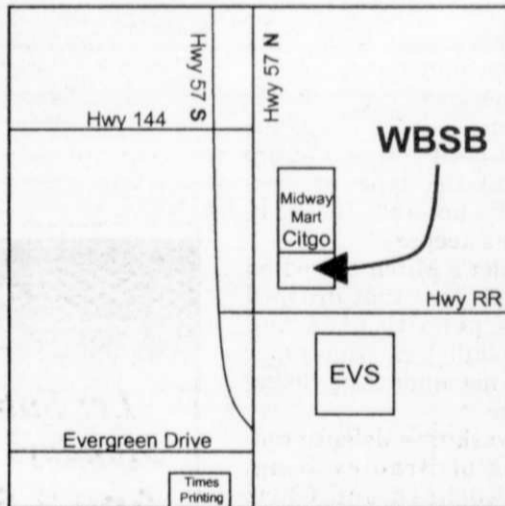



Archery Deer Hunting Season Opens Sept. 16

MADISON - Wisconsin's archery deer hunting season opens Saturday, September 16, and state wildlife officials say bow hunters should be able to look forward to another good season.

This year's bow season in many areas of Wisconsin will have a different look due to Zone T seasons that will be held in three-quarters of the state. Non-Zone T units will have the typical early and late bow seasons separated by the November firearm season. The early season begins September 16 and ends November 12, the Monday before the gun season. The late season begins on December 2 and continues until the end of the calendar year.

Archers hunting in Zone T units in 2000 will be able to hunt the regular early and late archery seasons, and will also be able to hunt Monday, November 13 through Thursday, November 16. During the periods of October 26 - 29 and December 7 - 10, archers will be restricted to

harvesting only antlerless deer in Zone T units, due to the antlerless-only Zone T firearm hunts being held at these times. Archers are required to follow the blaze orange clothing requirement whenever their season overlaps with firearm deer hunting.

The statewide white-tailed deer population is currently about 1.7 million, according to Bill Mytton, deer and bear ecologist for the Department of Natural Resources. "The mild winters of the last three years have helped push our deer population far beyond the desired goal," Mytton said.

Even some northern forest units that suffered severe winters during the mid to late 90s have fully recovered and are well over management goals. As a result archers should find ample numbers of deer statewide.

Two free Zone T antlerless permits will continue to be issued with the purchase of deer-related licenses. In addition, additional

antlerless permits for Zone T units may be purchased at all ALIS license agents which began Monday, September 11. Leftover bonus antlerless permits that were not issued during the mail-in drawing process in non-Zone T units will also go on sale at this time. Bonus permits cost \$12 for residents and \$20 for non-residents.

Over 250,000 people purchased archery licenses in Wisconsin in 1999. Archers set an all-time state record bow harvest last fall of over 92,000 deer.

"If the weather is agreeable this fall, we expect to break the state record archery harvest for the third straight year. I would like to remind all hunters, that it is the antlerless harvest that determines future Zone T units. We need much more hunter cooperation in the harvesting of additional antlerless deer. It's time for all hunters to 'walk the talk' in regard to managing the states deer herd resource," Mytton said.

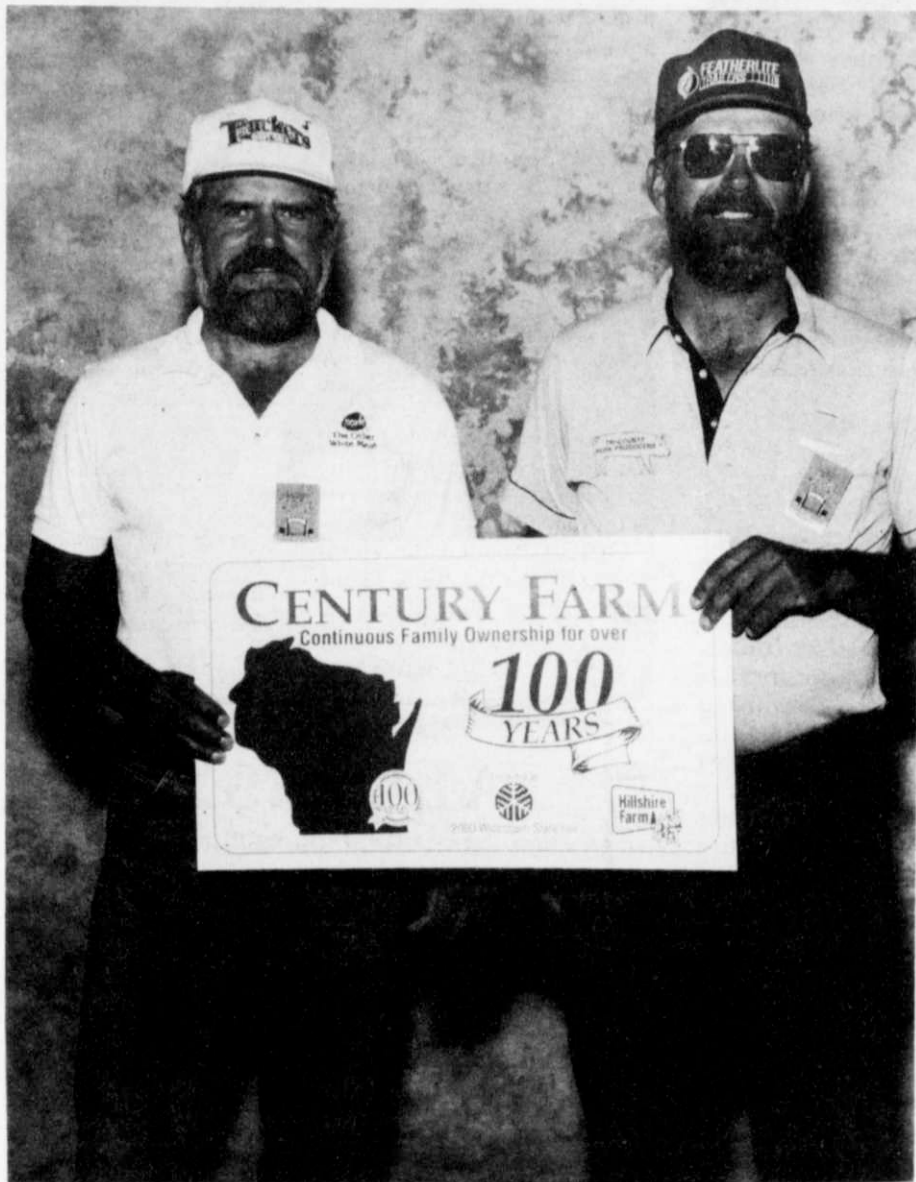

Dear Editor:

In spring 2000, Healthy Washington County Tobacco Free Coalition, in coordination with the Washington County Health Department, received a grant to conduct surveillance activities in Washington County, to determine if tobacco license holders were selling tobacco illegally to underage youth. The coalition partnered with local government including every city, village and 12 of 13 townships. Seventy-two purchase attempts were made throughout the county, resulting in 14 illegal sales. This was a 19% sales rate to underage youth, compared to the state average of approximately 20%. Some municipalities did an excellent job, such as Kewaskum and Jackson, where no tobacco was sold illegally.

A surveillance activity only shows tobacco sales on one day with one particular set of clerks asking or not asking for ID's prior to sales. It is very encouraging that 81% of tobacco licensees in Washington County were conscientious in observing the law. The surveillance results are available at the Washington County Health Department. We are looking forward to a time when all municipalities can report zero illegal sales of tobacco to underage youth.

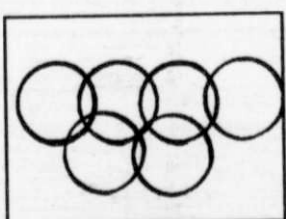

One argument for the bill took note of the balance between rising world populations and decreasing availability of farmland due to catastrophic urban sprawl.

Against the bill, a few delegates pointed out that higher prices to developers

often provide immediate financial assistance to a small farmer during bad seasons. Most members, however, recognized that such action leads to a downward spiral of trouble, leaving the farmer without enough land to break even on production value versus cost.

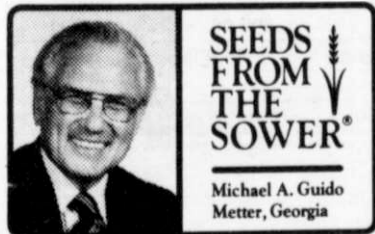

The Village Board of Kewaskum, Washington County, Wisconsin, met in Regular Session in the Council Room of the Municipal Building, 204 First Street.

Administrator Daniel S. Schmidt called the meeting to order due to the resignation of President Robert Wagner. All other Trustee Members were present. A quorum was present.

Senior Sarah Williams led the Indians by scoring a total of nine points.

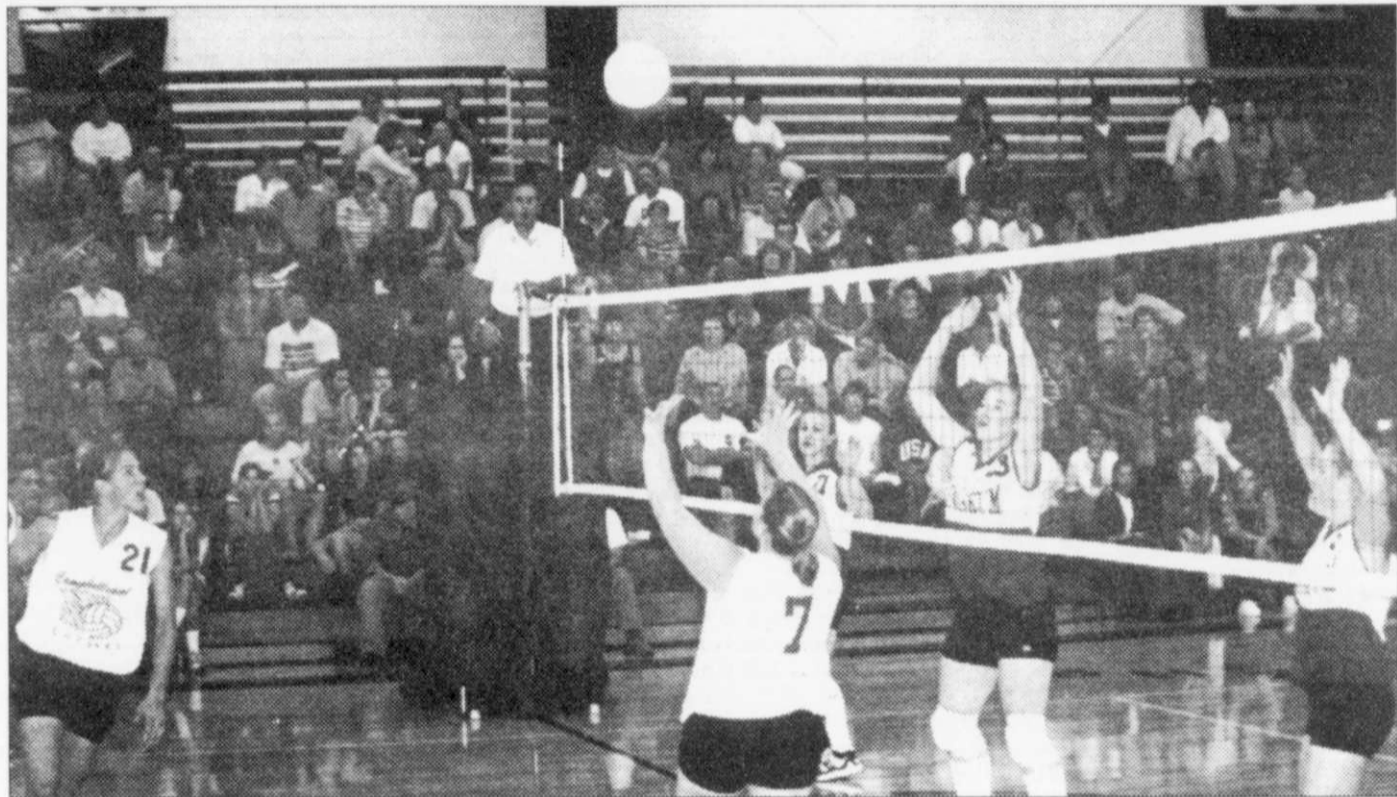
Williams and fellow senior Kathryn Schneider helped the victories with seven assists each.

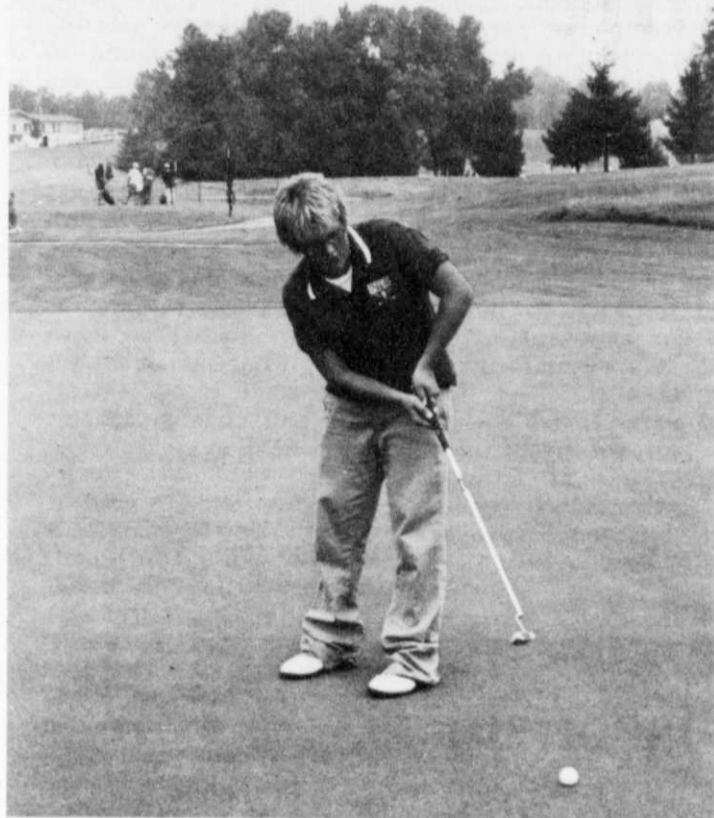

KHS C.C. Team Competes In KM Lutheran Invite

The Kewaskum Cross Country team competed in the Kettle Moraine Lutheran Invitational at Kettle Moraine Lutheran High School on Friday, August 25. Kewaskum girl's cross country team has seven members, including five returning letterwinners. The boy's team has 11 members with four returning letter winners.

Cross Country scoring is quite different from other sports. The team with the lowest score wins, instead of the team with the highest.

Each varsity team is allowed seven runners. Five of the seven runners are called "counters," the five fastest, those are the runners whose places are used in the team score.

The other two runners are called the "pushers." Their purpose is to push the counters so they don't slow down or get caught by the pushers. The pushers are also there to put more space between their teams' counters and the other teams. Every counter a pusher beats from another team adds one more point to the other team's score.

If a counter would get beat by their own pusher, the counter's place would still be used in the team

score. The score is found by simply adding up the five counter's places. So if team A's counters finished (1,3,5,7,9) = 25 points, and team B's counters finished (2,4,6,8,10) = 30 points, team A would win. The boy's team and girl's team are never combined because of the difference in the race distances.

The Pewaukee boy's team won the meet with a score of 72 points. Sheboygan Lutheran finished second with 82 points. Manitowoc Lutheran finished third with 128 points. Overall the Kewaskum boy's team finished eighth out of 15 teams with a score of 214.

Sophomore Alex Reinhart of the University School of Milwaukee won the boy's five kilometer race in 18:04.1. Junior Joe Miller of Slinger finished second in 18:06.4. Nick Martiny, a senior at Campbellsport, finished third in 18:26.1. Gabriel Siehr, a junior at Manitowoc Roncalli finished fourth in 18:50.6. Junior Ryan Carlson from Pewaukee finished fifth in 18:55.9.

Kewaskum's team was led by a group of four juniors. Veteran Bryan Kraft led the team by finishing 15th in 19:38. Next was

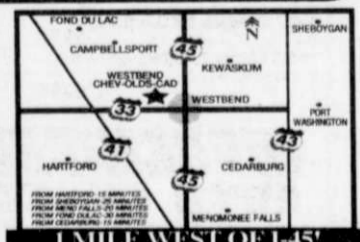

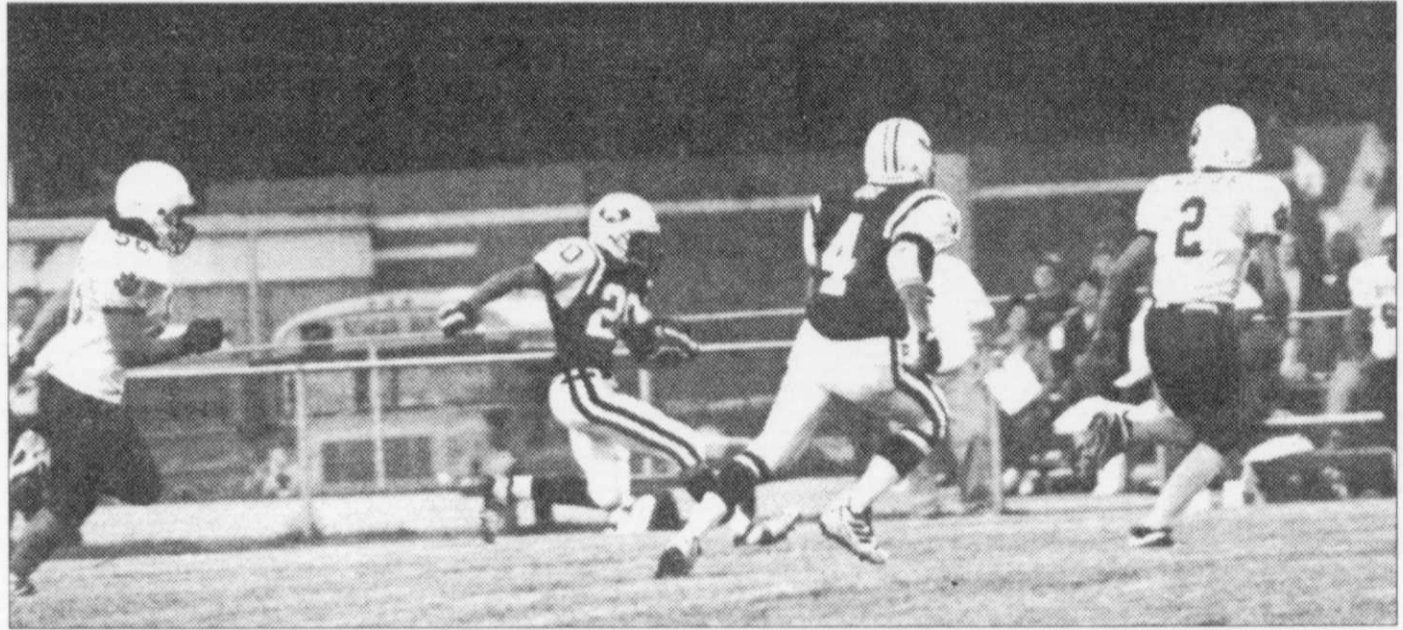
