A variety of fun-filled family outdoor winter activities are currently being discussed for the upcoming Winterfest Weekend being held in conjunction with this year's Kewaskum Christmas Parade being held on Sunday, December 3.

Besides the parade, which will begin at 5 p.m. at Kewaskum High School, definite plans include "Santa's Workshop" which will be set up inside the former Hair on Main building at 230 Main Street (north side of Main Street).

Many exciting activities for young and old alike, have been planned for "Santa's Workshop." Inside will be a special Make-It-and-Take-It section where youngsters will be able to paint ceramics and make special crafts and gifts for their parents, grandparents and friends.

There will also be an opportunity to design and make their own wrapping paper and wrap their special handmade gifts. There

will be hourly door prizes and a special Christmas tree where you will be able to draw a number to choose your own door prize. Mrs. Santa and Frosty the Snowman will be on hand to entertain the kids and for photo sessions. Other activities are also in the making for "Santa's Workshop" on Saturday and Sunday and will be announced when they are finalized.

Please be aware the Kewaskum High School FHA Club is sponsoring their annual Breakfast With Santa on Saturday, December 2, in the commons area of the high school at 9 a.m.

## Four Vehicle Crash Leaves Two Injured

**Town of Barton-** Two people were transported to an area hospital after being injured Wednesday in a four-vehicle crash south of the village limits.

Authorities say the crash took place as Christopher G. Kleinhans, 30 of West Bend was driving southbound, alone, on Highway 45, south of

Highway H, east when he allegedly crossed the centerline striking a semi tractor/trailer driven by Ben J. Proeber, 20 of West Bend driving northbound head-on. Kleinhans' vehicle then spun around striking northbound Karen D. Nichols, 48, of Campbellsport. Nichols' vehicle landed in the ditch on the west side of the northbound lane. She was also driving alone.

The fourth vehicle, driving behind Kleinhans luckily avoided the accident except for the flying debris. That vehicle was driven alone by a Kewaskum girl who was uninjured.

Both Kleinhans and Nichols were transported to St. Joseph's Community Hospital in West Bend.

The sheriff's department is still investigating the accident.

## EDUCATION... It's Everyone's Business

In my previous article, I said that state mandated test scores would be addressed in this column. As I write today, I need to clarify a few points first. You must first understand that I do not oppose testing. I believe tests are necessary and important for the students, in the assessment of the district's teaching methodologies, and for constructively altering our curriculum whenever needed.

Today, however, I am writing to explain to our readers that we can't make the mistake of seeing test scores as some stand-alone, sacred sign of accomplishment or achievement, or lack of either. I see tests as one measurement of a student, and of a school. Let me explain.

In my opinion, I could say that the people who love and trust polls, probably also love and trust tests. I reflect back on our most recent presidential polling data and think that it makes my argument for me. One day Bush is up 10%, the next day Gore is up 11%. A 21 point swing, in one day? Valid information? The pollsters sure wanted you to think so. I am of the mindset that test scores could be seen the same way.

Tests in our district, as measured by the mandatory state testing, range from at times excellent in some areas, and needing attention in others. I believe that tests taken are but a "snapshot" in time, a single picture of a student at one time in the day, or month, or the school year.

Tests are one indicator of a child's achievement. Imagine this. You have a picture taken of yourself right after some strenuous workout, or after a most hectic and stressful day, or

following some devastating news. Or you have a picture taken at a peak moment of your day, when everything's perfect, everything's falling into place. It's one of those days that nothing can go wrong. Which picture would you carry in your wallet, or display on a mantle piece as an indicator of who you really are? Which picture would depict you favorably or unfavorably in the eyes of the beholder? Tests are the same in my mind.

While the purpose of tests are to measure what a student knows and has learned, and conversely what the school has taught, it also captures and measures what the student is experiencing at that time in their life, that single "snapshot" mentioned earlier.

What if the student wakes up feeling great, and everyone in the house is cheery and encouraging?

That student arrives at school focused and in a positive frame of mind. If testing were done on that day, at that time, what influence do you think it would have on their test score?

But what if the student wakes up and gets into a fight with their parents or siblings, or just found out their parents are going to separate, or their best friend doesn't like them "anymore," or they just broke up with their boyfriend or girlfriend? If testing were done that day, would their test taking abilities be altered or affected?

As I mentioned, testing has a very important function in our schools. They have a purpose and rightful place in our schools, which will be covered in my next article. However, it is critical that we also see tests for what they are. They should, in my opinion, be seen as a

"snapshot" in a student's life, not seen as an absolute value of what they are, and all that they know. Tests should be seen as one indicator of what and who a child is, not a final indictment.

Tests should be used much as roadmaps are used in a journey across the

country in your car. Tests should be guides for parents, for teachers, and for our school district to ensure that we are on the right road, and if we're not, they should help guide us back to the right road, or find a better road to enable us to reach our destination.

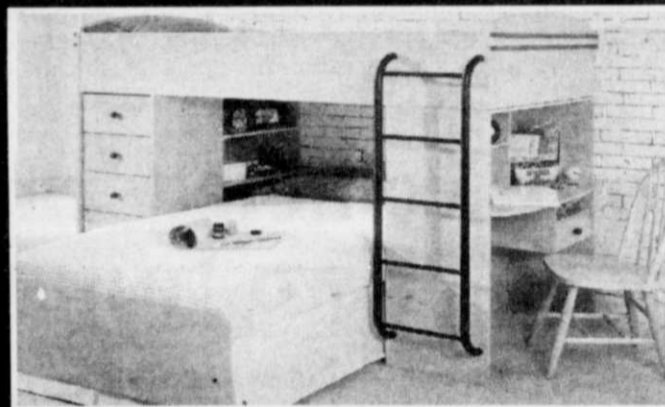

# Letter to the Editor

Letter to  
The Editor:

The Kewaskum Auxiliary Personnel (KAP) consists of the custodial staff, food service, teachers' aides and secretaries.

Early in the morning, at 6 a.m. the custodial staff arrives and begins to open the school building doors. The duties of the custodial, janitorial and maintenance staff entail many. They take care of the grounds daily picking up debris, cutting lawn, snow and ice removal. Maintenance is forever busy with plumbing needs, electrical, repairs and construction jobs. The janitorial staff keeps the buildings clean, they deliver the mail and food to all the buildings in the district, post notices. Physical Education equipment must be moved to the floors for classes, equipment is moved for practice sessions and games, fields are prepared for events, rooms and gymnasiums must be prepared for meetings and assemblies. The custodial staff are in the buildings and on the grounds early in the morning with the evening shift ending at midnight.

The food service arrives early to begin preparing meals for the schools. The high school and middle school prepare all the elementary school meals. They work quickly because lunch begins at 11 a.m. in some of the schools. The lines must move through at great speed to accommodate the full staff. After the meal serving is complete, there is the cleanup and preparation for the next day. Nutrition, cleanliness and efficiency is very necessary

for the students' welfare and state mandates.

Before the secretaries begin their shift, the telephones are already ringing and a steady flow of students and staff wander in and out of the offices. The telephones ring all day and the needs of the students are continuous. There are conflicts, illnesses, injuries, handling of money for various events, along with the paper work involved with attendance, reports and correspondence. Students want guidance on their schedules; inquire about grades, college, careers. Secretarial duties include scheduling building use for sports events, workers for games and handling the food service needs. The payroll secretary is ever busy preparing payrolls, insurance papers, new employee meetings, retirement benefits, state and federal reports, Workman's Compensation and a multitude of other duties.

The teacher's aides assist the students and teachers in the classroom. They keep libraries open, discipline students in the classroom and in the high school study halls, and help with the flow of students to and from the busses. The needs of the students are many. They include academic needs which are done on a one to one basis. They also entail various physical and medical needs for many students. Some students are in wheelchairs, have handicap needs, and require many medical needs and procedures. The aides' tasks are important for both the student and families of our district because without the

teachers' aides many of the students would not be able to attend classes.

The negotiation committee has been working hard for two years gathering information and presenting proposals to the Board. To propose an updated and fair contract they gathered many comparables from area school districts for language changes and wage scales. To date, there has been no settlement of the contract which expired June 30, 1999.

Many may not feel the support staff in the school district is as important as the administration and teachers who have received substantial raises, but you can see that "Without the support staff the doors would not open."

Please give the School Board members a call and encourage them to give us a fair settlement soon.

## Clinical Trial Announced Using Elk Velvet Antler for Rheumatoid Arthritis

The effect of Elk Velvet Antler (EVA) on rheumatoid arthritis (RA) sufferers will be studied during a clinical trial conducted by research teams from the University of Alberta and University of Calgary in Canada.

More than 220 patients are being recruited from rheumatology practices in Canada for the triple-blind, placebo-controlled, randomized clinical test. 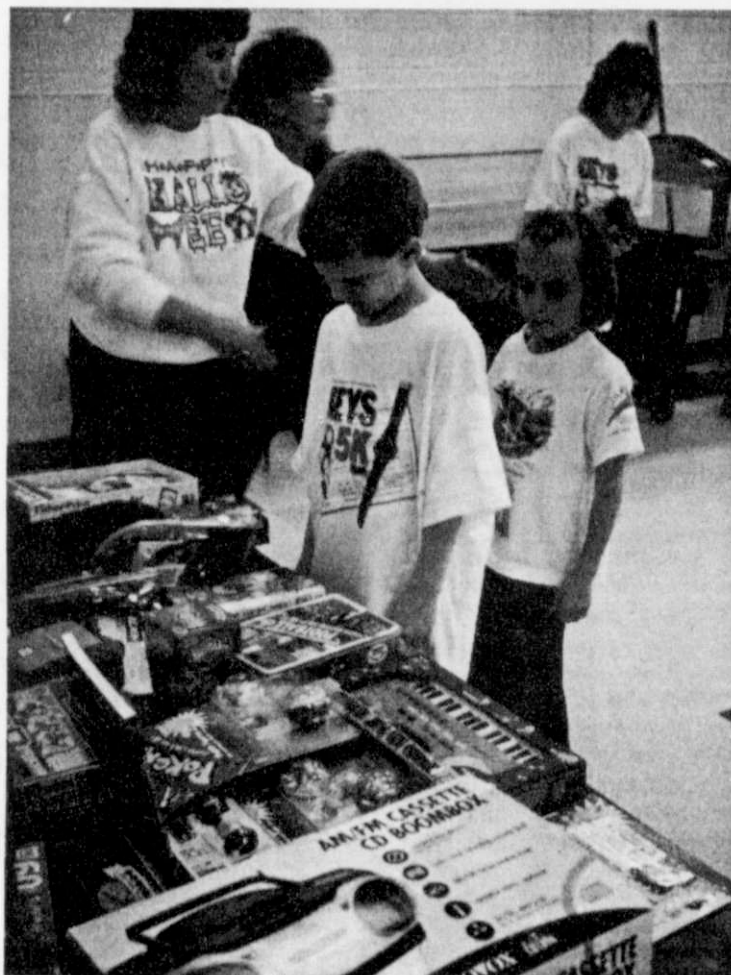

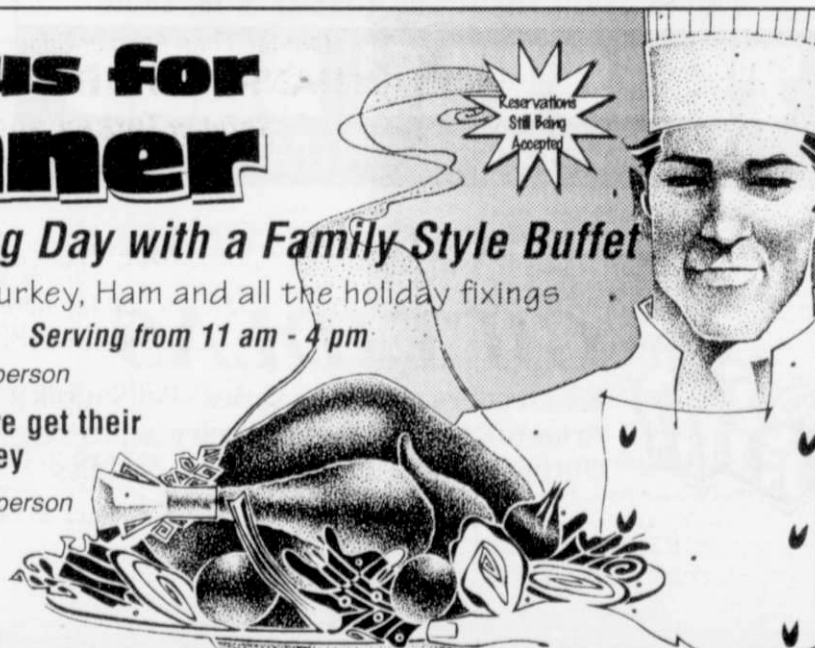

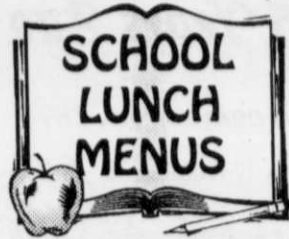

# Airlift to Transport Bridge Construction Materials



CAMPBELLSPORT - How do you replace an aging snowmobile bridge that is accessible only during the frozen winter months? Ask for a little help from your friends.

An exciting partnership has formed at the Northern Unit Kettle Moraine State Forest to replace a deteriorating snowmobile access trail bridge. The 832nd Medical Company of the Army National Guard out of West Bend has volunteered the use of a Blackhawk helicopter to airlift construction materials to the isolated bridge site. General contractors CD Smith Construction, from Fond du Lac, supplied the use of a large bucket to bring gravel, by air, to the site.

"We are thrilled to have the assistance of the Army National Guard and CD Smith Construction. Both have gone out of their way to make this project possible. We are fortunate to have partnerships like this," said Forest Superintendent Jerry Leitermann.

The Army National Guard will use the experience as a training opportunity for its pilots. Northern Kettle Moraine State Forest staff will be responsible for site preparation and overseeing the project. Wisconsin Conservation Corps employees will remove the old bridge and construct the new bridge once the materials are

on site.

The site is not accessible by truck or tractor. Without the help of the Army National Guard and CD Smith, state forest and WCC employees would need to hand carry the materials down a steep, undeveloped hillside through a wet area. This unique partnership will save time and effort for staff, as well as provide real-life experience for the helicopter crews.

The airlift went smoothly on Wednesday, November 8th. The Blackhawk spent the morning at Mauthe Lake Recreation Area moving bridge materials and then provided flights to the Conservation Warden and other game managers.

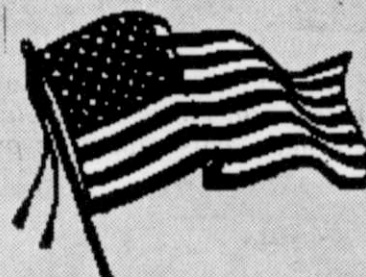

## Kirst Attends Seminar

Robert A. Kirst of Kirst Builders attended a one day seminar on foundations. This seminar was sponsored by Wisconsin ENERGY STAR Homes. Brent Anderson, P.E. was the presenter. Topics covered included, types of soils and how they have an impact on concrete, proper excavating, footing placement and curing time and how to get a dry basement after a home is complete.

Proper grade drainage is the beginning of a dry basement. Waterproofing such as tar or water proofing membrane doesn't compare to good quality solid drainage around the foundation. Stone placement under the footings, over the footings and under the house slab is critical. Water will free flow through stone to the sump pit or to daylight on a hill site lot.

Foundation insulation can best be accomplished by placing foam on the exterior of the concrete wall to the very top. The most critical area is between the house wall and the grade. Many builders are leaving this area exposed to the elements causing extensive heat loss. The foam must extend from the footings up to and over the rim joists for adequate weatherization. Any foam insulation must be protected from the sunlight or it will break down and lose its insulating value.

Exterior concrete slabs such as walk's and drive-ways can be placed with little surface problems during the winter. Fogging the concrete pour every hour during daylight is very important as it dries and cures in the summer time. A product such as "Seal and Cure" will slow the curing rate and leave a better surface.

Precast foundation walls were discussed. This type of foundation walls require no footings. They are cranes lifted into place on a bed of

stone. Precast walls cannot be back filled until the house deck is nailed in place and the concrete floor is poured. Vertical strength of the wall is good although it lacks rotational and torsional strength.

The Plan Commission of the Village of Kewaskum, Washington County, Wisconsin met in the Council Room of the Municipal Building, 204 First Street.

President John D. Kenworthy called the meeting to order. Member Leeann Butschlick asked to be excused and was absent. Members present were Theodore Meilahn, Andy Pesch, Richard Schmidt and Frank Beesten. A quorum was present.

The Plan Commission reviewed the request of Herriges Oil, Inc. for a conditional use permit to allow for the installation of a bulk oil distribution facility in conjunction with the existing garage/filling station at 1245 Fond du Lac Avenue. The request would be for the issuance of a Conditional Use Permit as provided for in Section 5.7 of the Village of Kewaskum Zoning Ordinance. As a condition of the CUP the area where the four (4) tanks are to be buried and the other area to the rear of the building will be paved with either concrete or asphalt and will be drained easterly. The Zoning Administrator had no objections with the CUP. On a motion by Andy Pesch, seconded by Frank Beesten and carried by voice vote the Commission sent the request to the Village Board for Public Hearing with a favorable recommendation regarding the conditional use permit, with the noted point. Theodore Meilahn abstained.

The Plan Commission reviewed the request of TeleCorp Realty, L.L.C. for a conditional use permit to allow for the installation of a cellular communications tower and antenna. Mr. Rick Kania reviewed points of concern in reference to locating a tower etc. The Zoning Administrator Gordon Hoffmann had several points of interest regarding such a facility. The location would be adjacent to Water Tower # 2 at 1004 Fond du Lac Avenue and the CUP would be for the installation/construction of a cellular communications tower and permission to mount Personal Communications Service (PCS) antenna on said tower. Mr. Jim Ryan was present and asked a few questions. He was asked if they would extend the

height of the tower, allow co-locating of others and install a monopole versus a lattice type. The answers were all yes, with the note that the company would give the ownership of the structure (monopole) to the Village of Kewaskum. The Village Board of Kewaskum, Washington County, Wisconsin, met in Regular Session in the Council Room of the Municipal Building, 204 First Street.

President John Kenworthy presided. All other Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Larry Ammel, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote, the minutes of the October 2, 2000 meeting were approved as printed.

The public hearing was held on the request of Herriges Oil, Inc. for a Conditional Use Permit for the property located at 1254 Fond du Lac Avenue which is zoned B-3 Central Community Retail and Service District; Tax Key No. V4-0130. The Conditional Use Permit is to allow for the installation/construction of a bulk oil distribution facility in conjunction with the existing garage/filling station. Mr. Raynor Herriges explained the project and work to be completed. It was noted four underground tanks would be buried, all with monitoring devices, a fenced pumping port and the area to the north and south would be paved with asphalt or concrete to direct the storm water run off. It was further noted that a storm sewer connection would be installed going to the southeast within an easement. This would hopefully correct some of the water problems to the west of the property. It was indicated that the state and approving agencies have approved the work to be completed for this location. The two existing overhead storage facilities will be closed and removed early in 2001. Six area residents were present to ask questions about possible contamination, decreased property values, increased insurance, and to verify steps will be taken to help with the water problem. 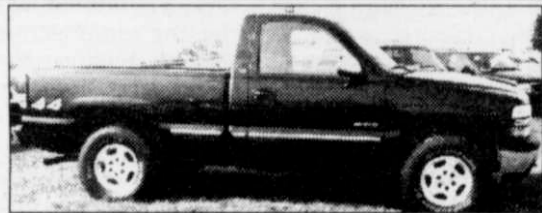

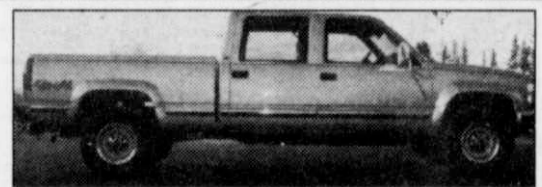

# Firearm Deer Hunting Season Opens Nov. 18

MADISON - More than 650,000 hunters are expected to head out to the woods and fields of Wisconsin for the nine-day firearm season that opens half an hour before sunrise on Saturday, November 18.

Department of Natural Resources wildlife officials are hoping that many hunters will use permits that allow them to shoot antlerless deer to help control a statewide deer herd that is estimated to be 1.7 million, the highest on record. Two free Zone T antlerless permits were issued with the purchase of every license, and hunters can purchase additional bonus permits for most of the state's non-Zone T deer management units (DMUs).

"We ask that hunters take on the role of deer managers by using their antlerless permits to focus more of our statewide harvest on antlerless deer," said Bill Mytton, DNR Deer, Bear and Elk Specialist. "Hunting is our main tool for managing deer populations and a significant antlerless harvest is needed in many areas of the state to reduce populations."

Hunters were able to use the two free Zone T antlerless permits that were issued with the purchase of each deer-related license during the October 26 - 29 antlerless hunt held in Zone T units. They may now use any unfilled Zone T antlerless tags during the nine-day, muzzleloader and archery seasons while hunting in Zone T units. Eighty-six regular DMUs are included in Zone T in 2000, along with 11 state park DMUs. Most non-Zone T DMUs, and all regular Zone T DMUs, have remaining bonus antlerless permits available for sale at all license vendors, or by phone order at (877) WI-LICENSE. Bonus permits cost \$12 each for residents and \$20 for nonresidents, and hunters may purchase up to two per day. All revenue generated through the sale of bonus permits goes to the state's Wildlife Damage Abatement and Claims program.

"As always, weather will

be a primary factor in how successful hunters are, but following three mild back to back winters, the state's deer herd is again well above population goals.

*Hunters need to have green registration stubs at registration station*

All hunters are required to fill out and submit a deer registration stub when they register their deer at registration stations. In previous years, the stub was printed on the back tag. Under the new ALIS system, license vendors were asked to provide license buyers with one green registration stub at the time of purchase of each deer-related kill tag. Many hunters like to have the stubs with them to fill out before they reach the registration station to save time. However, if a hunter does not have a stub, they may pick one up and fill it out when they register their deer.

*Wildlife health officials monitoring deer herd at select registration sites*

Wildlife health officials and volunteers will be collecting samples from deer at select registration stations across the state during opening weekend to test for a variety of deer diseases.

"We're doing this as part of an overall program to monitor the health of Wisconsin's deer," says Kerry Beheler, DNR Wildlife Health Specialist.

Similar sampling projects in previous years have not turned up any signs of disease in deer. The samples will be tested for a number of different deer diseases, including Chronic Wasting Disease (CWD), Bovine Tuberculosis, Epizootic Hemorrhagic Disease, Bluetongue Virus and distribution of the Ixodes deer tick.

"Samples will only be taken from hunters who voluntarily participate, and if a hunter provides a buck head with antlers, the antlers can be returned to the hunter at a later date," Beheler says.

Collectors will include personnel from the DNR, UW-Stevens Point School of Natural Resources, UW-Madison School of

Veterinary Medicine, Department of Agriculture, Trade and Consumer Protection, U.S. Department of Agriculture and the National Wildlife Health Center, among others.

*Other General guidelines for 2000 gun deer season:*

◆ The season opens on November 18 and ends November 26.

◆ Licenses to be used during the November nine-day firearm season or the muzzleloader season must be purchased by the close of business on Friday, November 17. The muzzleloader season immediately follows the regular season, opening November 27 and running through December 3. Hunters who are only interested in hunting the second Zone T antlerless-only hunt December 7 - 10 may purchase their gun deer license at any time before November 18 or between December 4 and 10.

◆ In previous years' muzzleloader seasons, hunters were required to have a hunter's choice permit to hunt bucks in the muzzleloader season. This is no longer a requirement. Hunters may now harvest a buck with an unfilled regular gun deer season.

◆ Bonus permits can be purchased at any time, including during the gun and muzzleloader hunts. Bonus permits are available for purchase for most non-Zone T DMUs and all Zone T DMUs.

◆ All deer taken during the nine-day firearm season must be registered no later than 5 p.m. on November 27. All deer taken during the muzzleloader season must be registered no later than 5 p.m. on December 4. All deer taken during the December 7 - 20 Zone T antlerless hunt must be registered no later than 5 p.m. on December 11.

◆ It is illegal to possess any firearm on November 17 unless the firearm is unloaded and enclosed with-

in a carrying case, except for: waterfowl hunting; sighting in of guns at established shooting ranges; or hunting at licensed game farms and shooting preserves.

◆ Coyote hunting is closed north of Highway 29 during times open to firearm deer hunting.

◆ Blaze-orange clothing is required for deer and upland game hunters during the gun deer season, the muzzleloader season and the Dec. 7-10 Zone T antlerless deer hunt.

◆ Many DNR offices across the state will operate on extended hours during opening weekend November 18 and 19. Some will also maintain extended hours on the second weekend of the season November 25 and 26. Hours vary, so customers are being urged to call ahead.

◆ All state parks are closed to firearm hunting during the December 7 - 10 Zone T antlerless hunt.

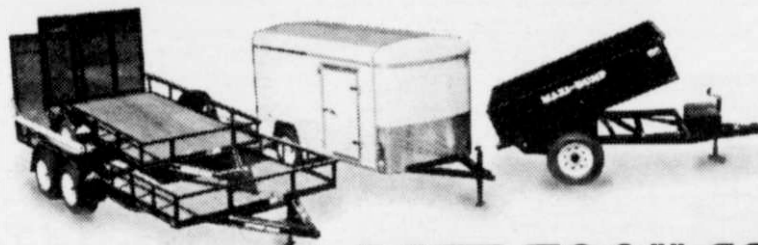
## In the Service
