## SPRING ELECTION TUESDAY, PRESIDENT RUNS UN-OPPOSED

### Heated Campaign For Four Village Board Seats

Four seats are open on the Kewaskum Village Board for this Tuesday's Spring Election.

One of the three seats is a one year term left by John Kenworthy who was voted to fill the open Village President position left by Robert Wagner who resigned his position last year.

Kenworthy has decided to keep the Village President position and is running unopposed.

## Two to Compete for State Superintendent of Schools

Two strongly opinionated women are running for John Benson's superintendent of Wisconsin schools. The two won in February's primary election are Elizabeth "Libby" Burmaster and Linda Cross.

Burmaster believes in strengthening reading skills. "Reading is the fundamental skill that separates children who succeed from those who struggle. Every available technique must be applied to insure that children become strong readers at an early age. In addition, programs must be developed and implemented for the middle and high school level to address teenage illiteracy," says

Burmaster

She further states "Families and schools must work together. Parents and families have the right and responsibility to participate in their children's education. As State Superintendent, I will work to build the partnerships needed for public schools to be community centers for learning."

Standards and assessment: "Our children deserve a well-balanced curriculum based on high standards that will prepare them for the global information age. We must prepare children to perform well as critical thinkers, problem solvers, and information seekers. Standardized testing is only one measure of our children's educational progress. Ongoing, authentic assessment everyday in the class-

room will prepare our children to be productive citizens.

Safe schools: We must maintain small class sizes and create safe learning environments where our children and parents feel connected to their school.

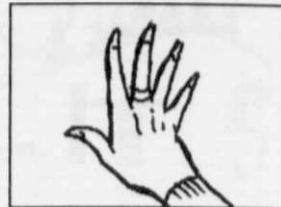
Bend in 1991; ran in an unsuccessful county supervisor race in 1994; ran in an unsuccessful state senate race in 1996 under the libertarian party.

## Fillmore Fireman Mark VanNatta Named Runnerup Wisconsin Firefighter of the Year

Fillmore Volunteer Fireman Mark VanNatta, 9025 Camp Awana Road, Fredonia, has been named runnerup Wisconsin Firefighter of the Year at the annual conference held March 16-18, 2001. There are over 10,000 members of this association.

VanNatta, age 40, is married with three children. A volunteer member of the Fillmore Fire Department for 15 years, he was captain of the rescue squad for eight years, lieutenant for the fire department for five years and was first assistant chief for two years.

He has taken courses in firefighting and received certification in First Responder, CPR and Defibrillator. He was also responsible for initiating the First Responder Squad in the Fillmore area community.

In nominating VanNatta, Fillmore Fire Chief Calvin Steinert gave the following background information on him.

Mark joined the Fillmore Fire Department in 1984 and has been a great example to his fellow firefighters and to the community. He has put in many hours over and above the call of duty. He is well-liked and respected by all members of the Fillmore Fire Department, and they are proud to have him as Assistant Chief.

In 1982 Mark was working part-time as a maintenance man at Camp Awana. That year the camp replaced some gas water heaters with oil water heaters. While making his rounds, Mark discovered one cabin did not have hot water. He went to the back room and pushed the reset button on the new oil water heater and was immediately blown out of the building through a window.

When the gas water

heater was replaced, the gas inlet pipe was not capped, and the spark of the reset button caused the violent explosion. Mark survived, but suffered first, second and third degree burns over 85% of his body.

He was taken to St. Mary's Burn Center in Milwaukee where he spent six months recovering. There were many months of

physical therapy, but Mark made a full recovery and went on to become the full-time caretaker at Camp Awana.

Mark was extremely grateful to the members of the fire department for helping him and he wanted to give something back to the community that he had grown to love. He joined the department a short time later.

In 1991 Mark saw a need in the community for expanded Emergency Medical Services. He put together a plan for a First Responder Squad and presented it to Chief Steinert.

Chief Steinert told Mark if he could recruit 25 people to take the first responder course, he would support the program. VanNatta upheld his part of the agreement, and on June 1, 1992 the Fillmore First Responders went into service with Mark VanNatta serving as captain.

Mark spent countless hours scheduling refresher courses and planning rescue practices. One of his greatest assets, according to Chief Steinert, was his ability to lead and teach other members, so all of the First Responders felt appreciated

and were capable of handling any situation, even the most difficult, they were thrust into.

During Mark's tenure as captain the Fillmore First Responder Squad has grown to 31 members. He was instrumental in acquiring a new rescue squad, and in getting the Fillmore First Responders certified to use a defibrillator. The Fillmore squad is the first First Responder Squad in Washington County to put a defibrillator into service.

In December 1999, Mark was nominated for First Assistant Chief of the department and he was elected unanimously. At that time, he stepped down as First Responder Captain

so he could focus more energy on the duties of the assistant chief. He does remain an officer on the First Responders.

Mark VanNatta vowed to repay the Fillmore area community for the help they gave him after his accident, and he has done that a hundred times over. He is very deserving of the honor of being named runnerup of the Wisconsin State Firefighter of the Year award. He is a man who has dedicated his life to helping and caring for others through his work at the Fillmore Fire Department.

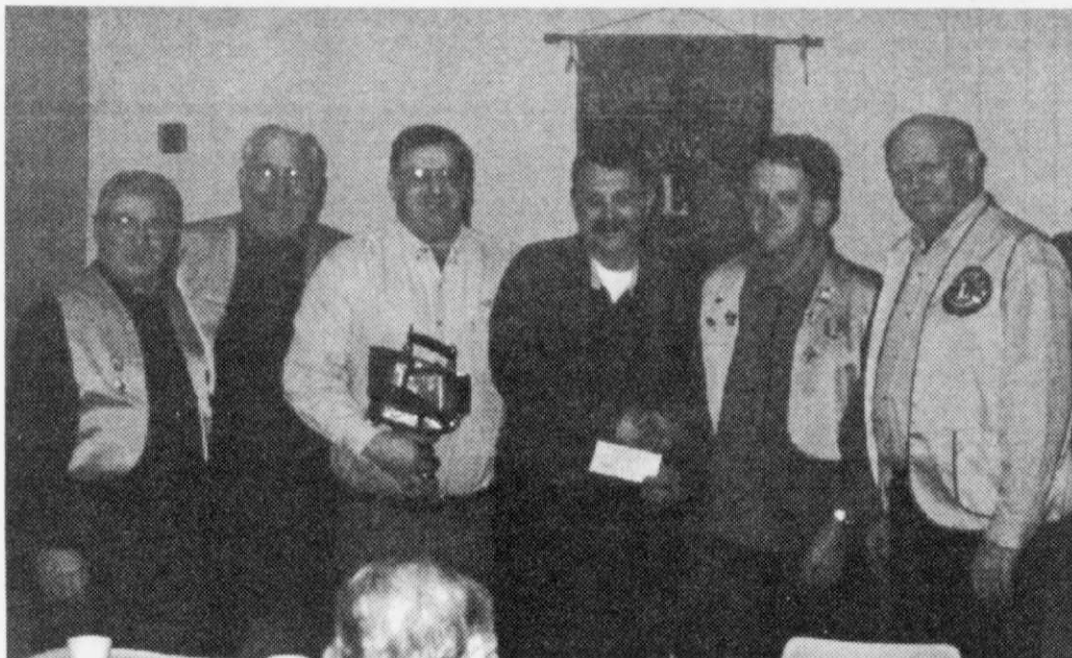



intendent, you will have a person devoted to building academic excellence by partnering with parents and teachers.

"It is this team approach that will provide the greatest foundation for our students' futures. Clearly, there is a need for change. With a stronger focus on parental involvement, school safety and higher academic standards, I believe we can improve the quality of education in our state," said Cross on her website.

She further states that "parents should play an integral role in supporting students and the educational system as a whole. The best way to help parents is to give them the right to choose a school that is the right fit for their children. Different students have different needs. By allowing parents the freedom to guide their children in the right direction, we not only strengthen academic ties, but family ties as well."

Cross' priorities are to Make schools a secure place of learning for students and teachers. Raise the academic standards required of each student. Partner with parents and teachers to take a proactive approach to teaching. Transform the Department of Public Instruction (DPI) into a user-friendly agency. Advocate reform, rather than hinder it. 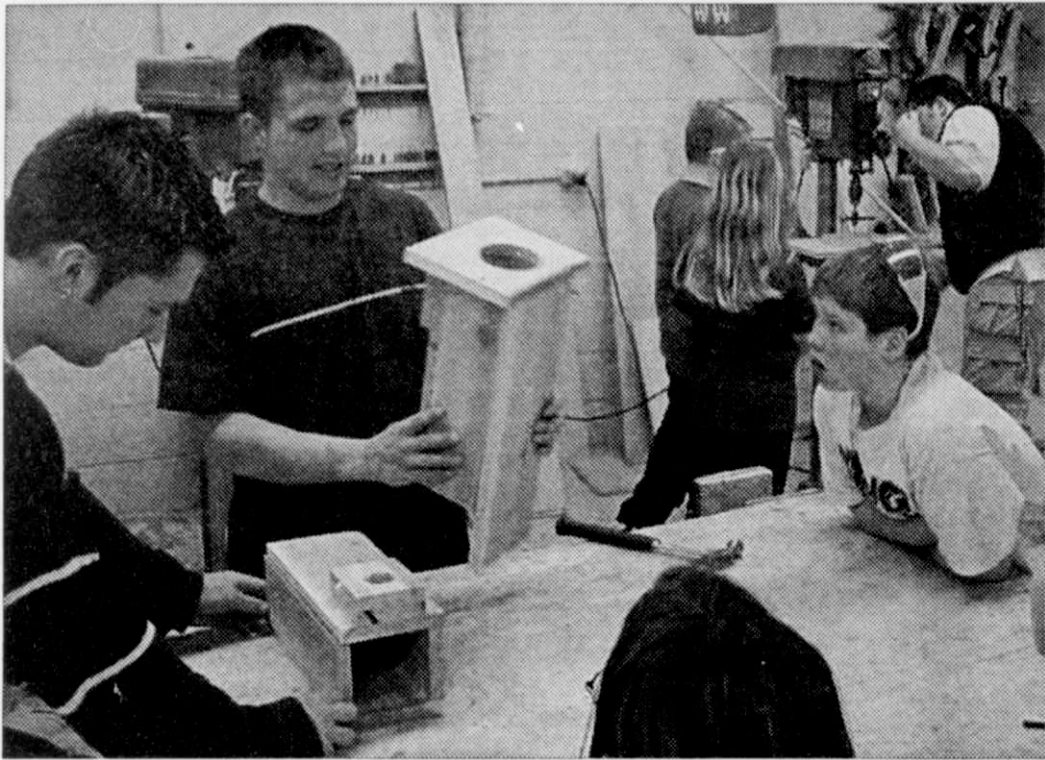

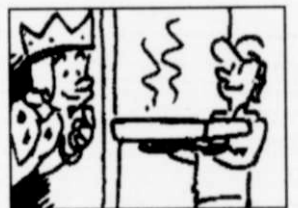

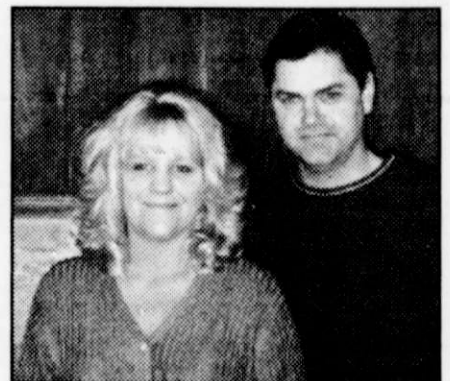

## Controlled Burns Proposed For Sheboygan County And Kettle Moraine

MILWAUKEE - The Department of Natural Resources is proposing to conduct controlled burns this spring on several wildlife areas in Sheboygan County and within the Northern Unit of the Kettle Moraine State Forest. The Department is proposing to burn up to 671 acres within the Northern Unit of the forest, 196 acres on non-state land and 158 acres on other wildlife areas in Sheboygan County.

Controlled burns are used to increase plant diversity and stem density on grasslands, for site preparation for seeding warm season grasses, and to set back undesirable woody vegetation. The goal is to improve nesting habitat for many species of grassland nesting

birds such as the mallard, blue-winged teal, pheasant, bobolink and the grasshopper sparrow.

This type of project does not have the potential to cause significant adverse environmental impacts; therefore, the Department has made a preliminary determination that an environmental assessment will not be required for this project.

The proposals may be reviewed at the DNR Plymouth Office, W5750 Woodchuck Lane. For more information contact Bob Hanson, Wildlife Technician at (920) 892-8756. Public comments on the proposed projects are welcomed and should be received no later than 4:30 p.m. on Wednesday, April 3, 2001.

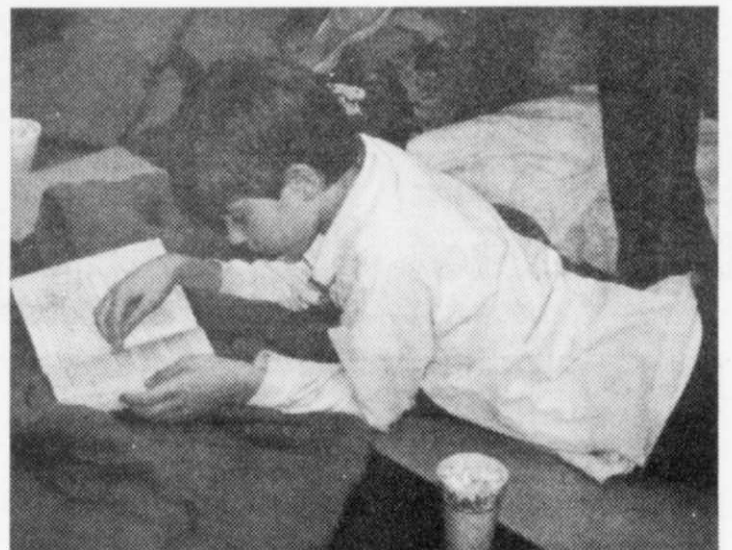

Preceding him in death were his wife; a son, Phillip; and two brothers, James and Raymond.

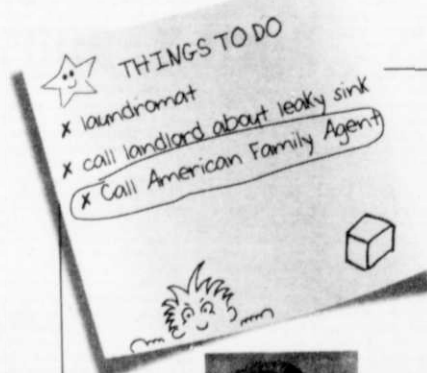

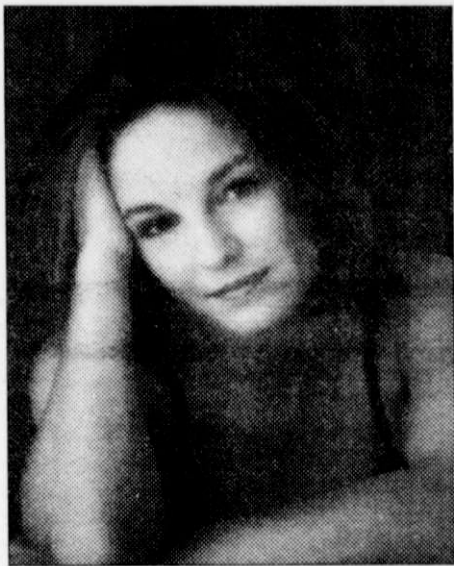

Upon being permitted to vote, the elector shall retire alone to a voting booth and cast his or her ballot except that an elector who is a parent or guardian may be accompanied by the elector's minor child or minor ward. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

At the spring election, where paper ballots or lever machines are used, the elector shall make a cross (X) in the square or depress the lever at the right of the name of the candidate for whom he or she intends to vote. To vote for a person whose name does not appear on the ballot, the elector shall write in the name of the person of his or her choice in the space provided for a write-in vote. On referendum questions, the elector shall make a cross (X) in the square or depress the lever at the right of \*yes\* if in favor of the question, or the elector shall make a cross (X) in the square or depress the lever at the right of \*no\* if opposed to the question.

Where marksense voting is used, the elector shall darken the arrow next to the name of the candidate of his or her choice for each office for whom he or she intends to vote. To vote for a person whose name does not appear on the ballot, the elector shall write in the name of the person of his or her choice in the space provided and darken the arrow at the right of the write-in line provided. On referendum questions, the elector shall darken the arrow next to \*yes\* if in favor of the question, or the elector shall darken the arrow next to \*no\* if opposed to the question.

The vote should not be cast in any other manner. If the elector spoils a ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one elector. If the ballot has not been initialed by two inspectors or is defective in any other way, the elector shall return it to the election official, who shall issue a proper ballot in its place. Not more than five minutes' time shall be allowed inside a voting booth. Unofficial ballots or a memorandum to assist the elector in casting his or her vote may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official marksense ballot is marked, it shall be inserted in the ballot sleeve provided so the marks do not show. After casting his or her vote, the elector shall leave the booth, insert the ballot in the voting device, and shall leave the polling place promptly.

An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty reading, writing or understanding English or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the elector's employer or an agent of that employer or an officer or agent of a labor organization which represents the elector.

# Anderson Convicted for High School Vandalism

A jury only took 30 minutes Monday to convict a Kewaskum teen who was accused of breaking into Kewaskum High School through an open gym door. Eric Anderson was found guilty on both counts of bur-

glary and damaging property. He will be sentenced May 11 for his involvement in the vandalism at the high school. He faces up to 25 years in prison and up to a \$20,000 fine.

Damages to the school are estimated at \$9,800 according to school officials.

A Kewaskum High

School custodian, Kewaskum Police, school superintendent Wayne Graczyk and several students testified.

According to Graczyk, the jury heard from Anderson himself who said he was in the building, that he did kick in the kitchen door, and knocked over a few chairs in the teacher's lounge. But he denied doing anything else. Several student witnesses stepped forward to inform the jury that he admitted to being in the building and doing more

than he said he did.

"I believe justice was served and I am glad this is behind us. Hopefully this will send a clear message to others inclined to do similar vandalism," said Graczyk.

## DNR Outdoor Report

March 20, 2001

Spring arrived on the calendar and in the air over much of Wisconsin this past week. A strong low pressure system last week triggered a major bird migration with almost all areas of the state reporting significant increases in the number of birds being seen.

Large numbers of Canada geese have been migrating through the state on their way north, and increased numbers of sandhill cranes, ducks, robins, horned larks and red-winged blackbirds, have all been reported.

American mergansers, canvasback, scaup, buffleheads, and goldeneye were seen on the Mississippi River.

Only a few counties in northern Wisconsin are still reporting that their snowmobile and cross-country ski trails remain open. Those that remain open generally will officially close at midnight March 31.

Groomers are continuing to groom snowmobile trails in the Hayward area. Snowmobile trails were icy but in fair condition at the Flambeau River State Forest near Park Falls.

Despite about two feet of snow remaining in the Oneida and Vilas county areas, snowmobile trails were only in fair condition in the woods and were very poor in and around towns and at crossings due to open patches where the sun has exposed the ground. However, cross-country ski trails in the Northern Highland-American Legion State Forest remain in good condition for late season skiing.

Most of the rest of the state is reporting that snowcover is diminishing rapidly with the recent warm weather. Rivers and even some lakes are starting to open up, with stretches of the Wisconsin River now open, as far north as Nekoosa.

The Rock, Crawfish, Bark and other major rivers of southern Wisconsin are all open. And even the Bois Brule River in Douglas County has open stretches, with the first whitewater canoeists and kayakers of the year paddling its waters last weekend.

Conservation wardens across the state are reporting incidents of people falling through the ice on lakes and rivers and are encouraging people to stay off the ice unless they are certain it remains solid.

Although up to 18 inches of ice remains on many southern lakes and two feet or more remain on northern lakes, areas near springs and near inlets and outlets

are opening up. Warm weather and rain forecast may greatly accelerate the ice melt. The top layer of ice is getting rotten and honeycombed in many areas and this ice may no longer support the weight of a person.

In the north, last week's snowstorm that dropped six or more inches of snow in some parts made access to lakes very difficult. In general, those anglers who are still ice fishing reported action as very slow, with only a few crappies and bluegills being caught.

Open water fishing has begun on some of the major river systems that remain open to game fishing. Anglers were catching a lot of walleyes on the Wisconsin River in central Wisconsin but most were under the size limit, and some success catching legal walleye on the Lower Wisconsin River.

Fishing has improved at various locations on the Mississippi River. Ice is out of the main channel near the Trempealeau dam area with some walleye and sauger being caught. The river below the Dresbach dam is beginning to open up, but ice flows were making access difficult. Walleye and sauger were becoming active since ice out below the Genoa dam.

Along Lake Michigan, some catches of browns and steelhead were starting to pick up on tributaries. The lower Oconto is open and some silver-looking steelhead were reported. A few steelhead have been seen below the Mishicot and Shoto dams on the Twin Rivers. Most of the Sheboygan and Milwaukee rivers are open, but there have been no reports of steelhead. The lower Root and Pike rivers are open but only a few browns and steelhead have been reported.

Cardinals have begun their annual courtship rituals. Brilliant colored males can be seen singing in the treetops. Barred and great horned owls are nesting. Tom turkeys are now regularly being heard gobbling from their roosts in the morning and seen strutting to catch the attention of the females during the day.

Maple sap has just started running. And while weather conditions are very favorable with cold nights and warm days, so far the sap has been slow to run. More days in the 40s with nights below freezing should help.

Finally, bears are beginning to emerge from their dens and will be looking for a free lunch. So now is the time to being taking bird feeders down at night and making sure garbage containers and are secure.

## Knowing How to Apply Increases Chances of Receiving Turkey Permits

MADISON - As the April 11 opening of Wisconsin's spring turkey season approaches, some hunters have questioned why they didn't receive a single harvest permit when a friend may have received two.

"It comes down to the time period and hunting zone the hunter requests on their permit application," says Keith Warnke, upland game biologist for the Department of Natural Resources.

"Anyone, can play the system to ensure they receive a permit every year. The applicant has to realize that there are more permits available than applicants and a hunter who is flexible can get a permit every year."

To ensure a spring permit, Warnke recommends that hunters should "always list all time periods as options on their applications." Though applicants should aim for their preferred zones, having less popular zones as second and third choices may be necessary to secure a permit.

Permit distribution is regulated by an automated license issuing system

(ALIS), which begins the selection process by grouping all of the applications into four categories:

- \* Landowners with and without preference points.
- \* Residents with and without preference points.
- \* Nonresident landowners with and without preference points.
- \* Nonresidents with and without preference points.

Preference points are earned when a hunter applies for a turkey permit and is not selected to receive one. Preference points that are earned this spring are used for the next year's spring turkey season.

To begin the lottery, category one is sorted by preference points. An application from those with preference points is randomly selected and the first choice is evaluated. If the first choice is available, a permit is issued and the application is put into the second permit drawing. If the first choice is not available, because all the permits for that zone and season have already been issued, the applicant's second and third choices will be considered using the same process. If no other choices were made, then no

permit will be issued to the applicant this year.

When an applicant receives a first permit, the application is then put into the second permit drawing. The same system of preference points is used to evaluate the applications for second permits. Hunters who select under-subscribed zones and later time periods will have the best chance to receive a second permit.

After all the applications in the first category are assessed, the applications in the other three categories will be evaluated in numeric order by the same process.

Last season, 126,677 first permits and 23,726 second permits were given. There were 12,871 applicants who did not receive a permit. Approximately 30% of permits per zone were given to landowners.

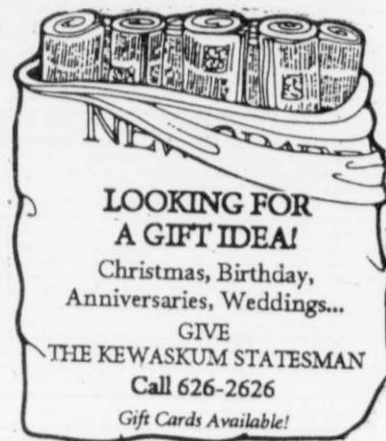

## TOWN OF SCOTT CITIZENS - ALERT:

I, a full-time, Town of Scott highway maintenance and recycling worker was seriously injured while cutting brush on the north ditch of Brazelton Drive, just east of Immanuel Lutheran Church on November 27, 2000. My left foot slipped on the steep bank of frozen grass while my right foot became entangled in an undergrowth of grape vines, causing me to break my right femur three inches above my knee. To date I am totally disabled, which my doctor said would be temporary for as much as six months or thereabout. Recovery has been good so far.

At the February 12th Town Board Meeting, I appealed to the Town Board to pay my portion of my family health insurance until I returned to work. At that time I would begin to repay the Town Treasurer over several months. My portion is approximately \$334.00 per month. I presently receive 66% of my wages from Workmen's Comp, but I am also out \$1000 per month that I earn on my part-time job. By now everyone knows what it cost them for home heating this winter, not to mention other household expenses.

On a motion not to help me which was made by Ira Weber and seconded by Irene Gnacinski, the motion passed on a 3 to 2 roll call vote. Voting not to help were Irene Gnacinski, Ira Weber and Clarence Janz. This would not have cost taxpayers even a penny because I would have paid it back upon returning to work.

I'm asking the Town of Scott citizens to question where the compassion and humanitarianism of these elected officials is. These people feel it is their town, their board and not OURS and OUR representatives. Tuesday, April 3rd is Election Day. Please vote your conscience. I feel like the poor man left along the road half dead, passed by two prominent people, only to be helped by a lowly poor man in the Parable of the

Good Samaritan in Luke 10:30-36.

I want to personally thank the members of the Batavia Fire Department who collectively offered to help me out until I was back on my feet and could repay them. I respect them very much for their compassion, having been at the meeting and seeing what had happened to me. 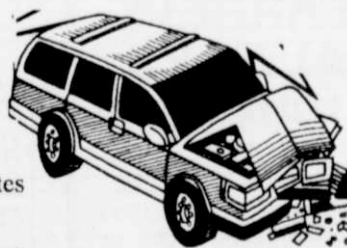

## Hunting, Fishing Licenses May Be Renewed Now

MADISON - Current Wisconsin hunting and fishing licenses, including conservation patron and sports licenses, expire March 31. Licenses valid for the new license year starting April 1 are available for purchase now.

Licenses may be purchased from any of 1,500 bait shops, sporting goods stores and DNR service centers in Wisconsin and several sites in Illinois and Minnesota. Licenses may also be purchased over the telephone toll-free at 1-877-WI-LICEN(SE) (1-877-945-4236) for the cost of the license plus a \$3 handling fee. The toll-free number may be called 24 hours a day, seven days a week.

Callers may charge license fees to their Visa or MasterCard. Customers will be issued an authorization number over the telephone, which allow license buyers to immediately enjoy most outdoor recreational privileges (exceptions include activities requiring a back tag or carcass tag) before

receiving their license in the mail.

Customers buying a license for the first time this year will need to provide the sales agent with some form of identification along with their Social Security number (required by law). The sales agent's computer terminal assigns the customer a unique DNR identification number, which the customer can use in the future any time he or she wishes to purchase a new license, without again providing a Social Security number.

The customer ID number you are assigned is your permanent number that you can use year to year for license transactions, says Marilyn Davis, director of the DNR Bureau of Customer Service and Licensing in Madison. Customer ID numbers were printed on any Wisconsin DNR license purchased in 1999 or 2000.

"Just offer your customer ID number and some other form of identification to a license sales agent each

time you need a license transaction, such as a new license or a duplicate," Davis says. "The agent will be able to quickly find your customer record without you having to provide your name, address and other information each time."

Conservation patrons received their patron license renewal options in the February issue of the *Wisconsin Natural Resources* magazine. To meet deadlines for special application periods such as hunter's choice, patrons are encouraged to renew their patron license earlier in the license year so they receive their fall hunting packet when it is sent in June.

Licenses valid for 2001 will be printed on red weatherproof paper stock (licenses for 2000 were orange) and sized to fit in the wallet. Printed receipts instead of 2001 red licenses will be issued for short-term licenses, such as two-day fishing as well as turkey licenses and turkey stamps.

Customers may refer to the on-line service center on the DNR's web site or call any DNR service center for more information about license sales.

In 2000, the department sold more than 3.6 million licenses, which produced over \$59 million in revenue the department uses to protect and manage fish and wildlife habitat on public and private land, enforce conservation laws and acquire conservation properties and boating access sites for public use.

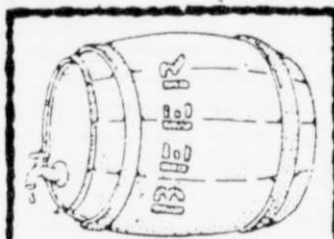

Notice is hereby given of a spring election to be held in Washington County, on the third day of April, 2001, at which the officers named below shall be chosen. The names of the candidates for each office to be voted for, whose nominations have been certified to, are given under the title of the office, each in its proper column, together with the question submitted to a vote for referendum, in the sample ballots below.

**INFORMATION TO ELECTORS**

Upon entering the polling place, an elector shall give his or her name and address before being permitted to vote. Where ballots are distributed to electors, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the elector shall retire alone to a voting booth and cast his or her ballot except that an elector who is a parent or guardian may be accompanied by the elector's minor child or minor ward. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

At the spring election, where lever machines are used, the elector shall depress the lever at the right of the name of the candidate for whom he or she intends to vote. To vote for a person whose name does not appear on the ballot, the elector shall write in the name of the person of his or her choice in the space provided for a write-in vote.

Where marksense voting is used, the elector shall fill in the oval next to the name of the candidate of his or her choice for whom he or she intends to vote. To vote for a

person whose name does not appear on the ballot, the elector shall write in the name of the person of his or her choice in the space provided and fill in the oval on the write-in line. On referendum questions, the elector shall fill in the oval in the space next to "yes" if in favor of the question, or the elector shall fill in the oval next to the space designated "no" if opposed to the question.

The vote should not be cast in any other manner. If the elector spoils a ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one elector. If the ballot has not been initialed by two inspectors or is defective in any other way, the elector shall return it to the election official, who shall issue a proper ballot in its place. Not more than five minutes' time shall be allowed inside a voting booth. Unofficial ballots or a memorandum to assist the elector in casting his or her vote may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official marksense ballot is marked, it shall be inserted in the security sleeve (if one is provided) so the marks do not show. After casting his or her vote, the elector shall leave the booth, insert the ballot in the voting device and discard the sleeve. The elector shall leave the polling place promptly.

An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty reading, writing, or understanding English, or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the elector's employer or an agent of that employer or an officer or agent of a labor organization which represents the elector.
