Chamber Okays 2001 Kettle Kountry Kolors; Teen Dance Set for June 8

The future of the annual Kettle Kountry Kolors festival was the main topic of discussion at the April meeting of the Kewaskum Area Chamber of Commerce.

Present at the meeting were Judy Berger of Main Street Crafts; Sharron Miller of Miller's Furniture; Karen Heberer of Heberer Brothers Home Improvement; Andrew Kuehl of the Kewaskum Statesman and representing the Kewaskum Kiwanis; Lana Kuehl of the Kewaskum Statesman; Audrey Krueger of Kewaskum Pharmacy; Jeanne Goeden of Goeden's Auto Body and representing the Kewaskum Woman's Club; Mike and Jesslyn Geidel of Geidel's Piggly Wiggly; Jim Wright of Wright Insurance Agency; Jackie Burtard and Linda Theisen of St. Francis Bank; Tim Miller of West Bend Savings Bank; Mr. and Mrs. Tom Hron, Rich Amerling, Bev Rohlinger and Bill Lehmann Jr., representing the Kewaskum Sno Chiefs; Jerry Kiefer of Kiefer Law Office; Wendi Dreher of Hair on Main; Lee Kempf of LK Heating; Joyce Kral of Lasting Impressions Engraving; Bob Kirst of Kirst Builders and also representing the Sno Chiefs, and Gwen Dreher of the former Doctors Inn Bed and Breakfast.

Newly-elected Chamber President Linda Theisen called the meeting to order and opened comments stating, "Our main concern tonight will be Kettle Kountry Kolors. It's time we start dealing with it."

Chamber Secretary Jackie Burtard shared the results of the survey about the festival sent to all members. One member wrote, "bigger is not always better," with the main consensus being to keep the event going but perhaps ask for help planning the event and financial assistance from the other non-profit organizations in the community.

Jeanne Goeden, speaking for the Kewaskum Woman's Club stated their organization was concerned because the festival was their major fund-raising event of the year. She said, "We do donate some of our profits back into Kettle Kountry Kolors."

Former Chairman of the festival Lana Kuehl asked members not to push the panic button just because last year's festival was a

financial fiasco, saying, "95% of last year's problem evolved from the bad weather." She added that you can't make a judgement on the entire operation of a festival just because you encountered unfavorable weather one year.

Low attendance was a major problem last year primarily due to the cold, wet weather. When dealing with an outdoor festival, Kuehl stated, you are at the mercy of the weather and occasionally you are bound to hit a weekend where bad weather is a factor and has to be dealt with the best you can.

Tom Hron of the Sno Chiefs stated, "It's our biggest event of the year," further explaining their entire membership gets involved in the event and realizes everything is based on the weather.

More discussion included being scheduled the same weekend as Mayville's Audubon Days. It was explained last year's scheduling was a bit of a fluke, due to the fact that Saturday fell on the last day of September and Sunday fell on the first day of October. Mayville's festival is always scheduled on the first full weekend in October. Hence, Kewaskum's festival will be set for the second full weekend in October.

Joyce Kral interjected that a fall festival has also been added to Fond du Lac's entertainment lineup. She stated, "As time goes on, you're going to have more competition."

Jean Goeden added, "I would hate to have it (Kettle Kountry Kolors) stop. Once you give up that weekend, it's hard to get back into the swing of it."

Following more discussion on the approximately \$4,000 lost on last year's event, Tim Miller made a motion to hold the Kewaskum Kettle Kountry Kolors 2001 festival on the condition that the monies lost last year get paid back to the general fund and the event is held without the Chamber entirely having to subsidize the event monetarily themselves. The motion was seconded and passed.

Decisions were then made on fund-raising for paying back the general fund and underwriting this year's festival. The Sno Chiefs agreed to run the

entire operation of the Beer Garden, paying for any entertainment of their choice for that area. The Lions and Kiwanis Clubs of Kewaskum have also confirmed they would help out.

It was also agreed to ask local businesses to help sponsor entertainment for the children's tent and the gazebo. Signage will be made accordingly thanking the sponsors.

Upcoming fund raisers will include a special annual teen dance already scheduled for Friday, June 8, from 8 to 11:30 p.m. at Kewaskum High School's Rose Hall featuring the bands, "Guilt Trip" and "Cold Fusion." Tickets will be \$3 in advance and \$5 at the door, and food and refreshments will be available. Tickets may be secured at St. Francis Bank and West Bend Savings Bank. More information on the dance will be printed in the Statesman soon.

Other fund-raisers include the annual Chamber golf outing, which is scheduled for Saturday, June 23, at Hon-E-Kor Country Club, and brat frys at Geidel's Piggly Wiggly on July 28 and September 8.

Volunteer help from all Chamber members will be needed to undertake these fund-raising events. They are not asking you to volunteer for all the fund-raisers (though your help certainly would not be refused). If every member volunteers to help for at least one, it would make things so much easier for everyone involved.

Members also touched on the fact and agreed, that all monies realized from the fund-raisers should not entirely go to underwrite the cost of Kettle Kountry Kolors. Therefore a portion of the raised funds will go to other activities or be donated back into the community. Further discussion will be held on this at a later date, to decide where to distribute monies made.

In other business transacted, it was decided to change the time of the monthly meetings to 6 p.m. rather than the previous 7 p.m. All members are encouraged to attend the next meeting scheduled for Wednesday, May 15, at 6 p.m. downstairs in the St. Francis Bank meeting room. Please try to attend.

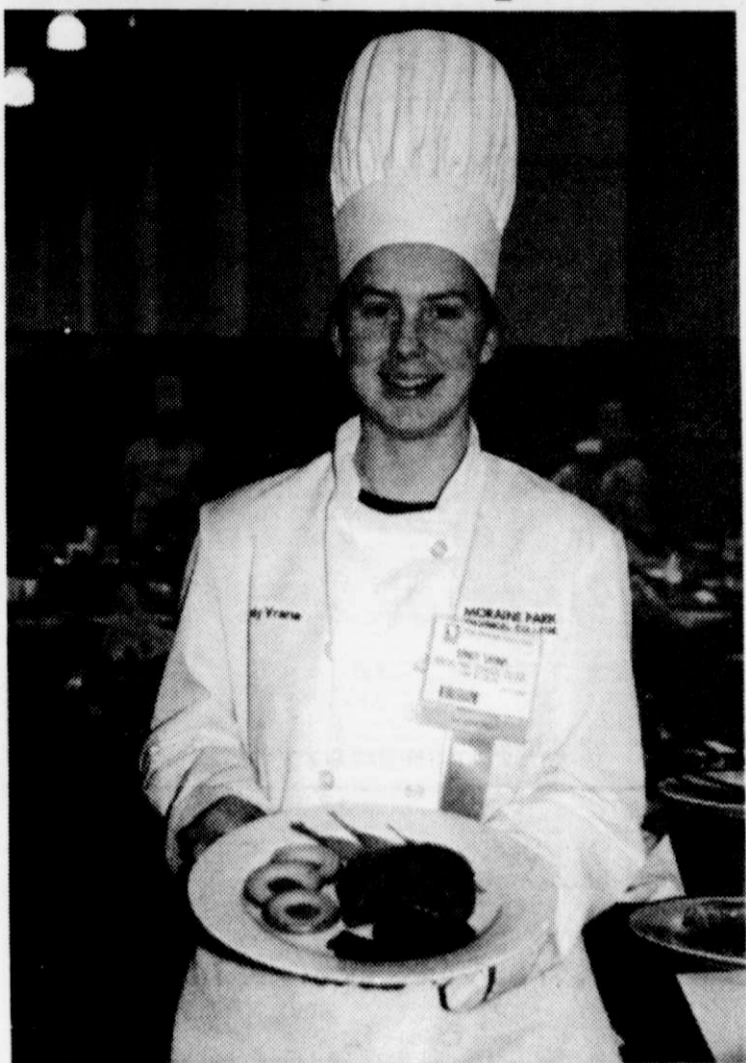

RECYCLING TIPS

CORRUGATED CARDBOARD

TYPE OF CORRUGATED CARDBOARD:

The cardboard that peels apart with two outside layers is corrugated. The middle section not exposed is wavy or corrugated.

COLORS: Some waxed and pressed cardboard may also be recycled.

PREPARATION: Flatten boxes and cut into 2'x2' pieces. Tie in bundles with twine or strong string. Bundles should be limited to 8" in height.

Place bundles at the curb next to the dark green recycling bin or blue recycling bag. Place the bin or bag, at the curb on the same day that your solid waste is to be collected. Pick up will be Wednesdays for both solid waste and recyclables. Multi-family dwellings of six or more, remember, your recycling pick up will be the 1st and 3rd Wednesday of each month.

NOTE: If raining on collection day, please hold cardboard until the following week.

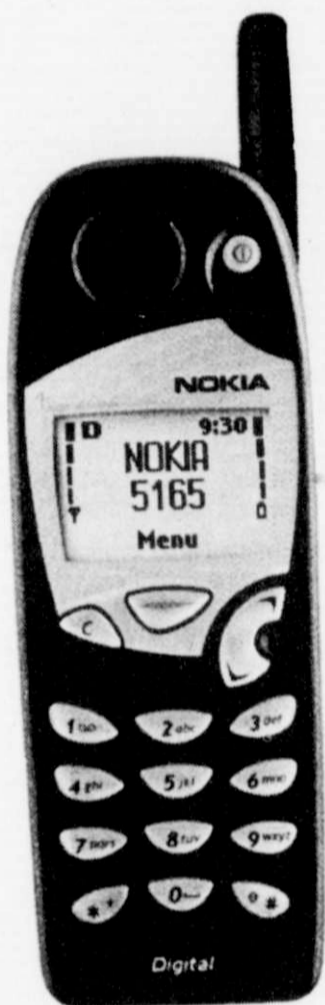

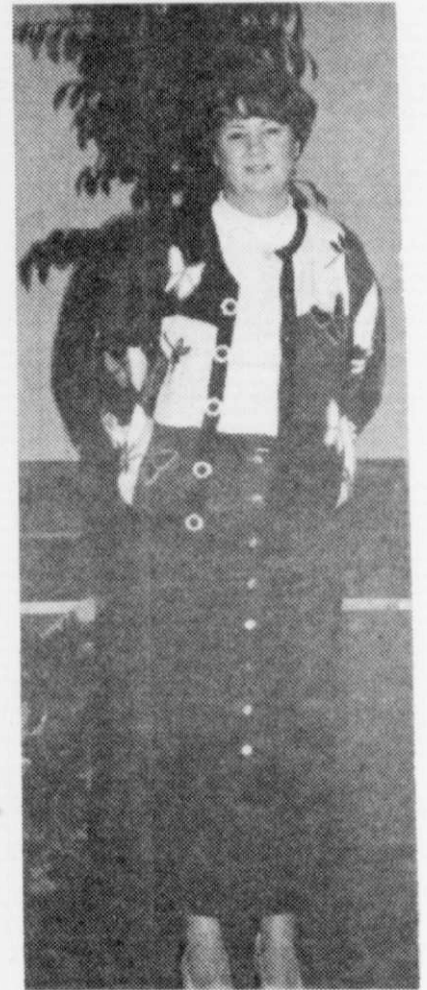

Preceding him in death was his father-in-law, John Hrdi.

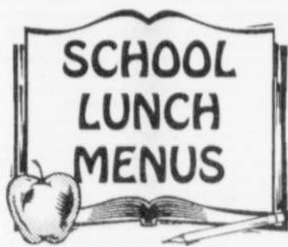

Now I know what is important to this District, BIG buildings. You want state of the art buildings for millions of dollars, but you can't spend thousands to educate a deaf child. Well, we can all see what is important to you. Do the rest of the people of the Kewaskum School District think the same?

How dare you make this family suffer so much pain to fight for something their child is entitled to. It's hard enough to cope with a deaf child, and now to have to fight for her rights.

And I know of what I speak. My grandson, Jake, was born deaf and I know what an education can mean. He started intervention at Juneau, from two to three. Then he started school at Mayville in the special needs class.

It was not easy but their School District worked with them to give him the education he will need for a better life. The teachers there didn't know sign language, but they learned with Jake. He also got his speech therapy and anything else he needed. He was in Mayville from three to five.

When he started kindergarten, they sent him to Hustisford to learn to work with his signer in a classroom setting. It's only a 10 minute ride for him. He will be going back to Mayville Schools to be educated with the rest of his class. You cannot believe what this has done for him. He is ahead of all expectations.

I cannot see how a school district, who's number one agenda is to educate children, can do this to a family. It's a disgrace to this District. I have to say for

the first time in my life, I'm ashamed to say I live in the Kewaskum School District.

I urge this District and the School Board to stop denying this child her right to an education both by law and morally. You are not going to win and it's going to cost alot more money than if you would have started to educate her right away.

I'm telling the Menzel family to keep fighting because they are right. You take this matter as far through the courts as you have to for your child. She is the most important one in all of this. You have my permission, as a taxpayer, to make the School District pay for all the money it is costing you to fight for something that should have never gone this far. Your cost of raising a deaf child is high enough. My prayers are with you and you keep fighting. I'm behind you.

I thank God every day that Jake lives in the Mayville School District. They know what is RIGHT!

Sometimes father doesn't know best. After disabled and elderly citizens, and their care workers, filled the Capital to protest the poor funding of Medicaid services, our governor shrugged it off, saying that it was his job to balance the "family" checkbook and to set spending priorities. What he didn't seem to

understand is that the "family" is trying to tell him that his priorities are wrong.

The governor's budget says that paying the driveway is more important than health care for grandma and grandpa. His budget says that buying new computers for businesses is more important than the help needed by our brothers and sisters in wheel chairs. The governor's budget spends millions on hundreds of things that may or may not be good, but are clearly less important than the health and dignity of our disabled and frail elderly citizens (things like renovating the state fair park, buying an unused prison and bumping up Midwest Express airline's profits).

Our elderly and disabled family members have recently lost a great deal of access to home, hospice and personal care, but the governor's budget offers no meaningful help. Nor does the budget spend even one dollar to help the 11,000 Wisconsin residents now on waiting lists for community care, one dollar to make the Community Options Program available to one more person, or one dollar to help senior citizens with their prescription drug costs.

The budget says that we, as a family, have many priorities, many moral obligations, higher than that of properly caring for our disabled and elderly. That's just wrong.

You and I know that Wisconsin has a higher sense of morality than making money matter more than people, and we've been saying so around the state. The "family" of Wisconsin knows that we are our brother's keeper. And our sister's. And our parent's,

children's and neighbor's keeper. The only mysteries are how our governor's priorities got so painfully twisted, and why our governor cannot hear his "family's" plea to put our house in order. This time, it's "father" who doesn't know best.

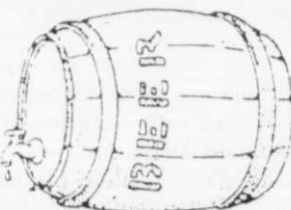





Team Wins Five Events, Sets Three Meet Records Boys Track Fifth at Vanderpan Invite

SHEBOYGAN FALLS - The Kewaskum High School boys track team won more than their share of first places at the 31st annual Vanderpan Coed Track Meet on Friday, May 4th. The problem for the Kewaskum boys was that they didn't pick up any second places and that they were completely shut out of five events. Sheboygan Falls won the meet title by scoring a total of 137 points that included one - two finishes in both the 1600m run and the 3200m run that accounted for 36 points.

New Holstein finished second with 116 points, followed by 111 points by Plymouth. Howards Grove squeaked by Kewaskum for fourth place with 102 points and Kewaskum totaled 98 points for fifth. Southern Door scored 58 points, Oostburg 56 points and Elkhart Lake finished with 16 points in the eight team invitational.

Kewaskum picked up its first win and record of the meet when the 4x200m relay team of Chris Canter, Tony Fitts, Tom Ogi and Charlie Sparks won with a time of 1:34.3. The old record was set by Kewaskum was 1:35.6 set in 2000. Plymouth finished second in 1:36.2 and New

Holstein finished third in 1:37.7

The Kewaskum 4x100m relay team of Canter, Fitts, Kevin Miller and Sparks duplicated the 4x200m relay effort by also winning and setting a meet record with a time of 45.0 seconds. The old record was set by Southern Door was 45.3 seconds set in 1999.

The third meet record was set by Sparks as he won the discus with a throw of 166' 4". The old record was held by Mueller of Plymouth at 162' 7". David Cibulka finished seventh for Kewaskum at 120' 0".

Canter won the long jump with a distance of 19' 5 1/4" into a stiff cold win. Fitts placed third with a jump of 19' 0". "It was nice to have Fitts back in the relays and long jumping," commented Coach Jerry Gosa.

Instead of the 4x400m relay being the last event of the night, the pole vault continued after the final running event into the darkness. With just Josh Parrent left in the pole vault at 12' 6" the event had to be called because of darkness. Sheboygan Falls is the site of the Eastern Wisconsin Conference Meet on Thursday, May 10th and concerns were raised about the safety of the pole vault without sufficient lighting. Parrent won the pole vault

at 12' 6" and Kewaskum's Mike McKee placed third at a career best of 12'.

Troy Koefel's third place in the shot put with a throw of 46' 1/2" was Kewaskum's last top three finish.

Canter and Fitts finished fourth and seventh in the 100m dash with time of 11.5 seconds and 11.7 seconds. Tom Ogi and Paul Mertz placed fourth and sixth in the high jump at 5' 8" based on misses.

Chris Baker finished fifth in the 1600m run with a career best time of 4:56.9 and Tom Ramthun finished seventh at 5:02.8.

Matt Hartmann found both the competition and wind stiff as he finished seventh in the 110m high hurdles in 17.5 and eighth in the 300m intermediate hurdles with a time of 45.0 seconds.

The 4x400m relay team of Mertz, David Wicklund, Hartmann and Luke Kehres finished sixth with a time of 3:45.6.

The 4x800m relay team was in for a long race as the baton was knocked out of the hand of one of Kewaskum's runner and he had to go back and retrieve it. The foursome of Troy Kedroske, Bryan Kraft, Darrell Woebeking and Josh Repovsch finished eighth.

"We had a lot of good efforts. I told the team that the effort was most important. They scored 98 points. That is the most points the guys have scored in 10 years. (The last time the boys won the Vanderpan was back in 1985.) This is the kind of competition that they have to be ready for next Thursday. They definitely had a much better meet Friday than last Tuesday. The relays looked good. I saw a lot better focus and determination," concluded coach Gosa.

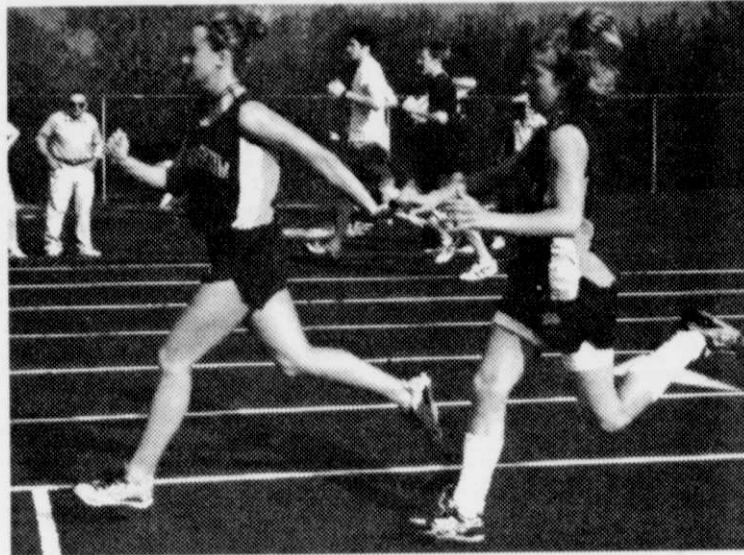

SHEBOYGAN FALLS - The Kewaskum High School girls track team held off a very determined Sheboygan Falls team and won their third invitational track title Friday night, May 4th, by a score of 117 to 112 points.

The Sheboygan Falls Falcons had won the Vanderpan Invitational the last three years in a row. The Indians won three events, placed second in four other events and placed two individuals in six events on a cool and windy night to win the title.

After 17 events Kewaskum and Sheboygan Falls were tied at 109 points each. The Kewaskum 4x400m relay team just needed to finish ahead of Sheboygan Falls in the final event to win the invitational.

The good news for Kewaskum fans was that Kewaskum has a very good 4x400m relay team this year. The team of Jessi Graham, Breyan Donath, Jenna Roecker and Becky Herriges, not only finished ahead of Falls, but almost won the event when they finished second to Elkhorn with a time of 4:24.4. Falls finished sixth with a time of 4:42.8. "Our relay team got together and decided that they would switch their running order. They told me that they had everything figured out. They went out and ran a very good race,"

reported coach Jerry Gosa. Winning the meet would not have been possible without many fine performances and efforts by all of the athletes on the Kewaskum girls team in the 17 other events.

Jacki Krueger won the pole vault with a meet record jump of 8' 6" and Emmy Foerster won the 100m high hurdles with a season best time of 16.1 seconds. Foerster also placed fourth in the pole vault at 7'. In the 100m high hurdles Foerster held off Kissinger of Elkhorn who placed in last years state meet.

The Kewaskum 4x200m relay team of Herriges, Foerster, Donath and Tina Lindgren ran well and won with a time of 1:55.5.

The Kewaskum 4x100m relay team of Herriges, Kristin Schiller, Stacy Muckerheide and Lindgren finished second to Elkhorn at 53.4 seconds to 55.3 seconds.

Jenna Roecker came on strong at the end of the 300m hurdles to place second with a good time of 51.3 seconds. Roecker also placed fifth in the 100m high hurdles with a time of 17.2 seconds.

Colleen Gosa placed second in the discus with a throw of 100' 7" and then came back on a night when she was sick, to pick up five big team points for Kewaskum by finishing fourth in the 1600m run with a time of 6:05.4.

Teammate Emily Rinzel finished sixth with a season best time of 6:07.2. to pick up an additional three points. Gosa picked up points by placing sixth in the shot put with a throw of 29' 6 1/4".

Nicole "Coco" Herrmann placed third in the shot put with a throw of 33' 1 1/4" and Muckerheide also placed third in the long

jump at 13' 8". Muckerheide also finished eighth in the 100m dash with a time of 13.9 seconds.

Jessi Graham finished third in the 400m dash with a time of 65.2 seconds and Donath finished fifth with a time of 66.0 seconds. Jolene Clark placed fifth in the high jump at 4' 10".

Heather Hackbarth finished fifth in the 3200m run with a career best time of 13:27.8. The 4x800m relay team of Kelly Darmody, Katie Schneider, Lauren Schultz and Hackbarth also finished sixth with a season best time of 11:16 just two seconds out of fourth place.

Becky Herriges also placed eighth in the long jump with a jump of 13' 0".


"A lot of great efforts. The five point margin of the win should remind our team just how important each and every place is to the team. The extra effort as they approach the finish line is extremely important - you've got to have that burning desire to do your best. It was a difficult decision as to whether or not Colleen should run the 1600m run. We went back and forth and she decided that she would run the 1600m and probably scratch the 800m run," concluded Coach Jerry Gosa. Each and every point was indeed needed.

The KHS track teams travel back to Sheboygan Falls on Thursday, May 10th for the Eastern Wisconsin Conference Championships.
