Village to Remodel Kitchen and Bathroom at Riverhill Park

The Kewaskum Park and Recreation Committee met last Monday evening to approve requests to use village park facilities. The committee members also approved village administrator Dan Schmidt's request to begin planning and design work for the modernizing of the kitchen and a bathroom facility in Riverhill Park.

The current kitchen structure was built during W.P.A. days where the government provided jobs during the depression era. It was finished in the 1930's upon the park's construction and erecting of the dam on the Milwaukee River. It has had no major updates since that time.

The bathrooms were constructed in the 1940's and have also had no major renovation projects.

The park is home to

Kewaskum's Independence Day fireworks display and Kewaskum's famous Kettle Kountry Colors Festival. It is also used by village residents for various activities.

Schmidt's plan for the project include re-locating the kitchen to where the current restrooms are located on Riverview Drive.

"We plan on a two level facility where the kitchen will be located on the bottom, built into the hill and restrooms on top," said Schmidt.

Once plans are completed they will be brought before the park and recreation committee.

Schmidt also added that the village is accepting donations from civic organizations, residents and businesses for the project. Donations can be dropped off at the municipal building. Donors will be recognized in the Statesman once the project is completed.

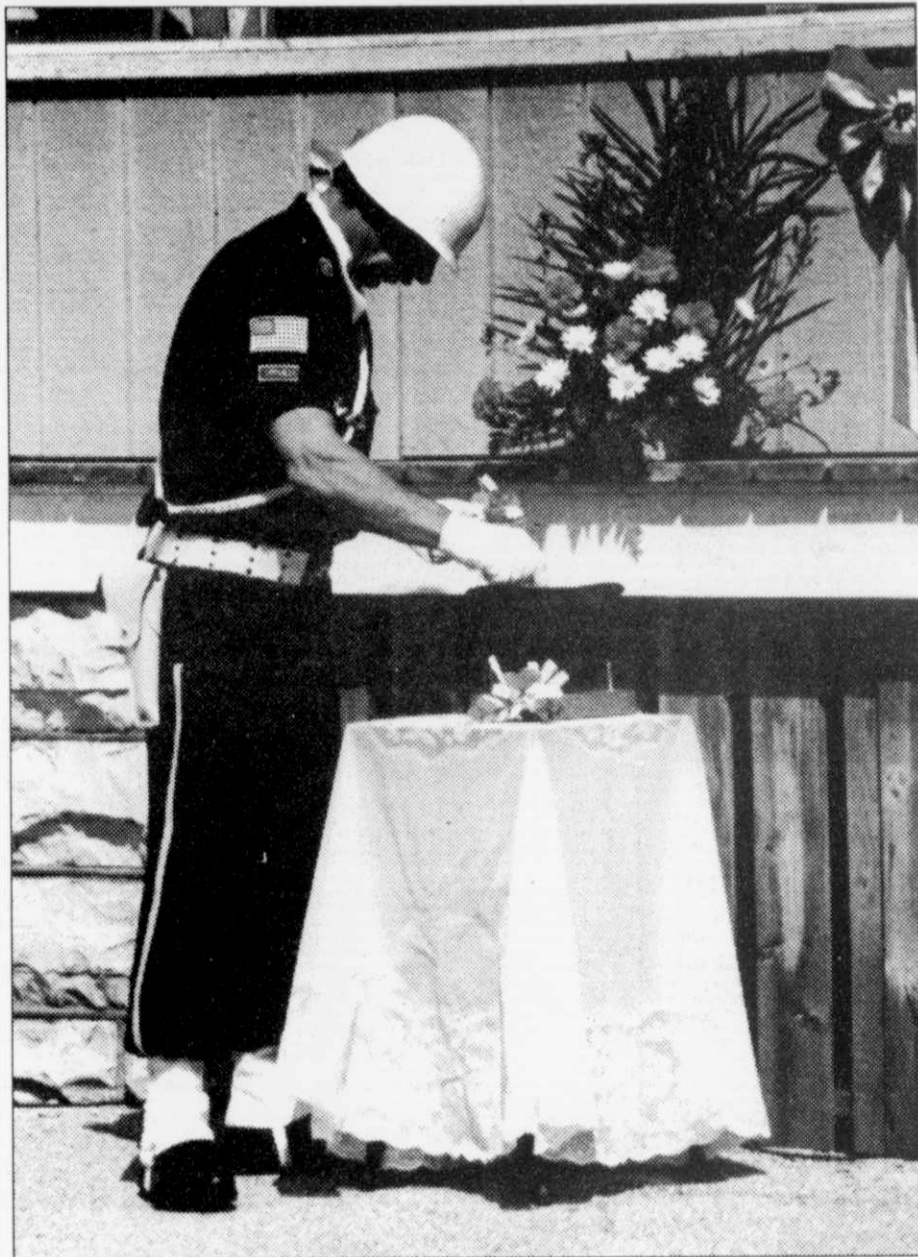

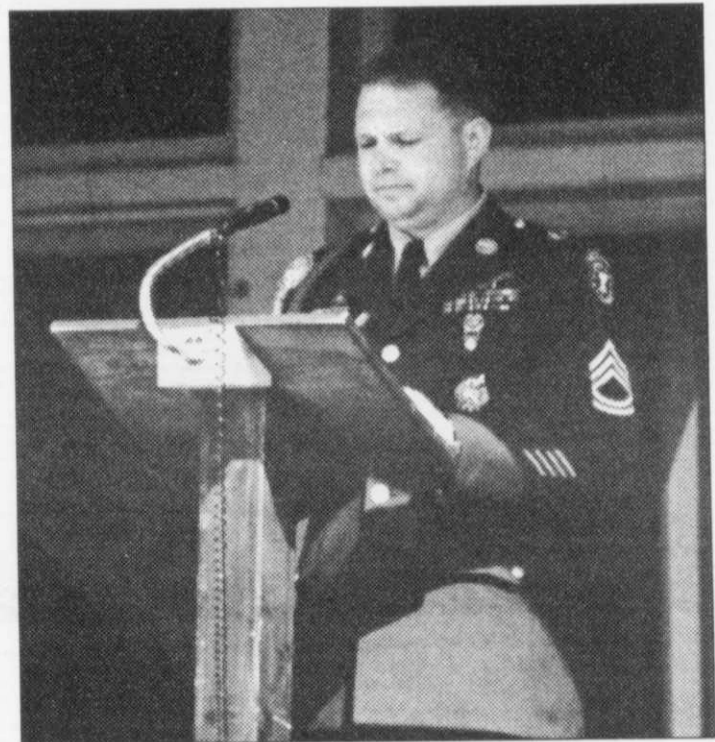

The cost is \$130 per credit plus a \$50 non-refundable course registration fee. Classes run from June 11 through August 3, and the deadline for online registration is June 1.

Students have one-on-one contact with professors and classmates through email and chat rooms. Lecture notes and reference materials can be accessed at any time, and from anywhere one can get an Internet hookup. Courses are taught by professors from UW Colleges, the freshman-sophomore institution of the UW System.

Who benefits from online courses? It's a great option for stay-at-home parents, full-time employees and students who don't have brick and mortar educational facilities nearby. 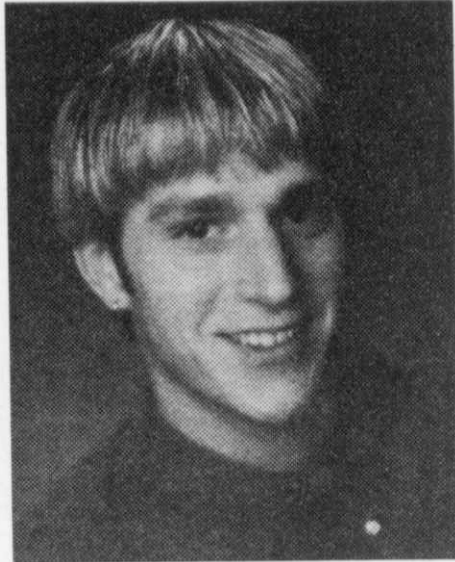

DIRT CAKE

Ingredients / Equipment / Garnish

- 1 20-ounce package cream-filled chocolate sandwich cookies
- 1 8-ounce package Cream cheese, softened
- 4 Tbsp. butter, softened
- 1 cup powdered sugar
- 2 3.4-ounce packages instant vanilla pudding mix
- 3 1/2 cups cold milk
- 1 cup whipping cream
- 2 Tbsp. granulated sugar
- 1 (8-inch) new terra-cotta flower pot; gummy worms; silk or plastic flowers

Method - Crush cookies until

fine. Set aside. Beat Cream cheese, butter and sugar until smooth. In separate bowl, mix pudding and milk until well-blended. Fold pudding into Cream cheese mixture. Whip cream to soft peaks; add granulated sugar; beat to stiff peaks; gently fold into Cream cheese mixture. Wash and dry terra-cotta pot; cover hole in bottom with foil square. Place one cup crushed cookies in bottom of pot. Top with 1/3 of the pudding mixture. Continue layering until pot is full, ending with crumbs on top. Chill several hours or overnight. Prior to serving, decorate top with gummy worms and silk or plastic flowers. *Makes 12 servings.*

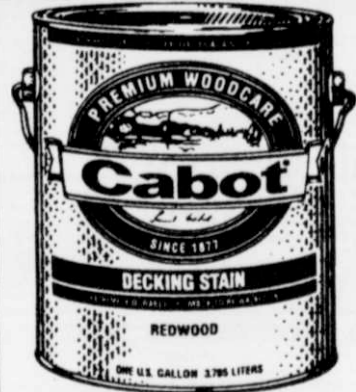

JUNE BUG COOKIES

Ingredients

- 3 1/2 cups all-purpose flour
- 2/3 cups unsweetened cocoa powder
- 1 tsp. baking powder
- 1 tsp. salt
- 2 cups butter, softened
- 2 cups granulated sugar
- 1 cup packed light brown sugar
- 2 large eggs
- 2 tsp. vanilla
- Cream Cheese Frosting*
- Red food coloring; small tube black frosting; licorice strings; mini chocolate chips; M&Ms

Method - Heat oven to 350°F. In a medium bowl, combine flour, cocoa, baking powder and salt. In large bowl, beat butter with both sugars until light and fluffy. Beat in eggs and vanilla. Gradually beat in flour mixture on low speed until well blended.

For each cookie, scoop up heaping tablespoon of dough; roll into 1 1/2 inch ball. Place on ungreased cookie sheets three inches apart. DO NOT flatten dough. Bake 14 to 15 minutes or until set. Cool two minutes on cookie sheets; carefully transfer to wire cooling racks; cool completely.

To decorate June Bug cookies: Prepare the Cream cheese frosting recipe. Transfer 1/4 of the frosting to a small bowl to use for the June Bug "face." Add enough red food coloring to the remaining frosting to create a bright color. Decoratively frost cookies to resemble a ladybug using the white (round face), red (wings/body) and black (dividing lines) frostings. Use mini chocolate chips to create the ladybug "dots" on the wings and mini M&Ms for "eyes." Cut, bend and place licorice strings in face frosting to form antennae. Store cookies loosely covered at room temperature for up to three days. Makes about three dozen (3-inch) cookies.

*Cream Cheese Frosting

- 1 package (8 ounces) Cream cheese or light Cream cheese (do not use fat free)
 - 1/4 cup butter, softened
 - 1 tsp. vanilla
 - 2 cups powdered sugar
- Cut Cream cheese and butter into chunks and place in bowl of food processor fitted with the steel blade. Add vanilla and powdered sugar. Use on/off pulses to process ingredients until well blended. (Can also be made with mixer.)
 Store cookies in air-tight container in refrigerator or cooler.

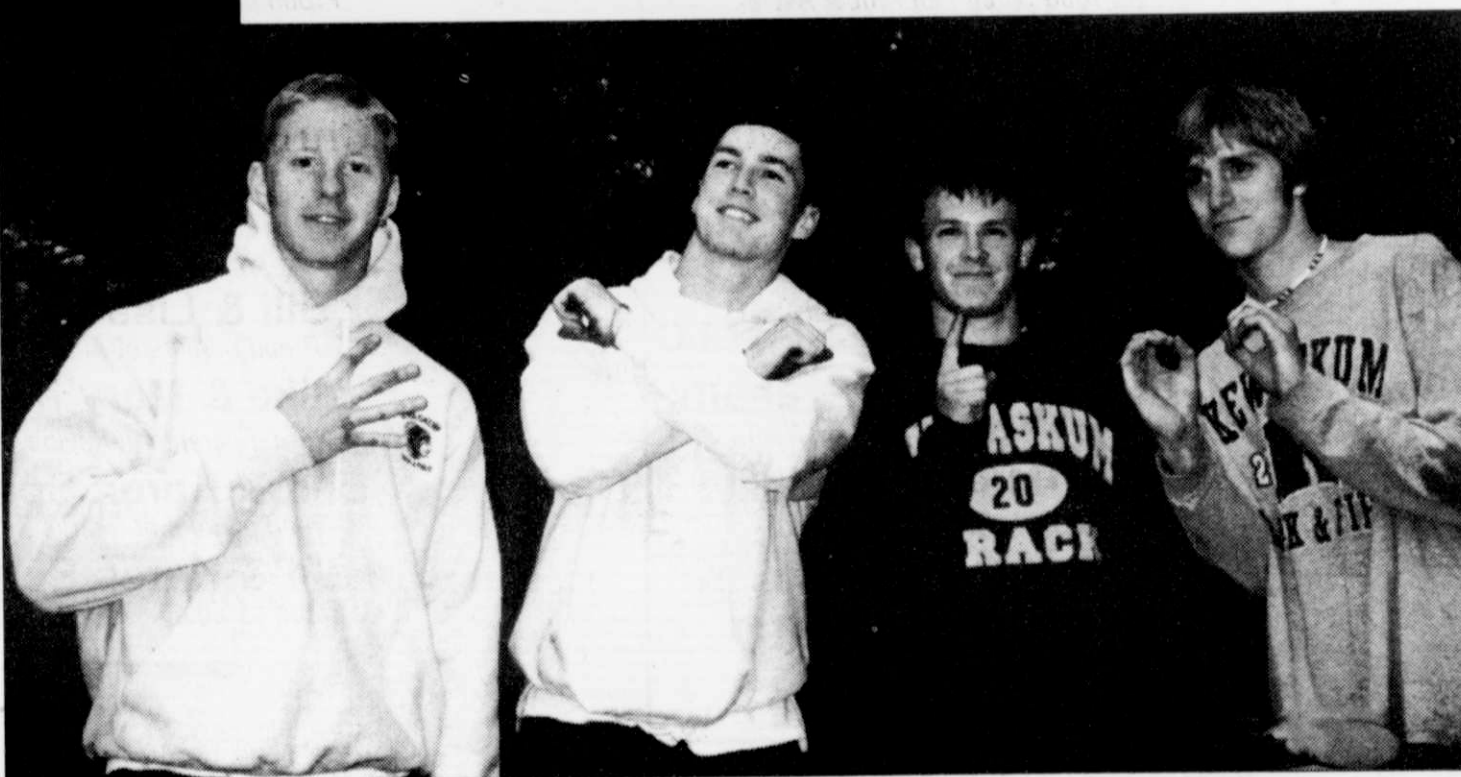
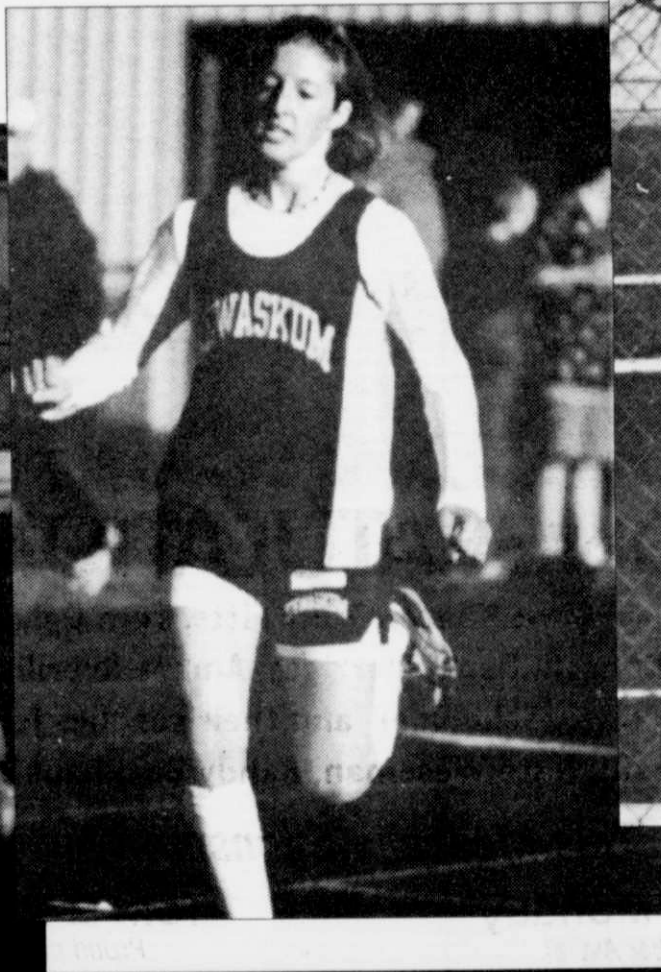

The Village Board of Kewaskum, Washington County, Wisconsin, met in Regular Session in the Council Room of the Municipal Building, 204 First Street.

President John D. Kenworthy presided. Trustee Mathew Heiser asked to be excused and was absent. All other Trustee members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Larry Ammel, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote, the minutes of the April 2, and 16, 2001 meetings were approved as printed.

A public hearing was held on the Sanitary Sewer Service Area Amendment for the Village of Kewaskum. The public hearing is being sponsored by the Village of Kewaskum and Southeastern Wisconsin Regional Planning Commission (SEWRPC). A draft staff memorandum describing the proposed sanitary sewer service area amendment, including a map of the area, was on file at the office of the Village of Kewaskum and SEWRPC. President John D. Kenworthy introduced William Stauber, Chief Land Use Planner with SEWRPC.

Mr. Stauber briefed the Village Board and the public on what the report stated and how any amendments would affect the Village and Village sewer utility. Only two modest changes are proposed, the first being 41 acres located west of CTH "S" and South of East Moraine Drive. Within this area only 25 acres would be developable, with the balance in conservancy. The area is 12 acres and is bounded on the east by USH 45 and on the north by Badger Road. This area is being considered for commercial type development. It was noted there would be less than 0.05 mgd of flow expected at the existing treatment facility, which has current capacity.

The Administrator Daniel S. Schmidt informed those present the request was made by the Plan Commission and supported in June of 2000 by the Village Board. The 41 acres was considered in 1988, but asked to be excluded by the property owner who now has requested the change. The area was included in the Land Use Plan and would provide for a traffic connection vital to the growth of the community in the future. The 12 acres proposed was to clear up a matter supported by the Town, Village and County as it relates to the USH "45" improvements and a cross intersection promoted and agreed to by all. Trustee Andy Pesch informed the Board the Plan Commission reviewed the amendment and sent it forward with a favorable recommendation. No one spoke in opposition to the amendment. On a motion by Trustee Andy Pesch, seconded by Trustee Thomas Piwoni and carried by the majority roll call vote, the Board closed the public hearing. Roll call vote was 6 "Aye" 0 "Nay" 1 "Absent".

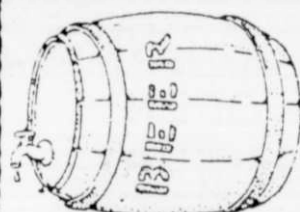

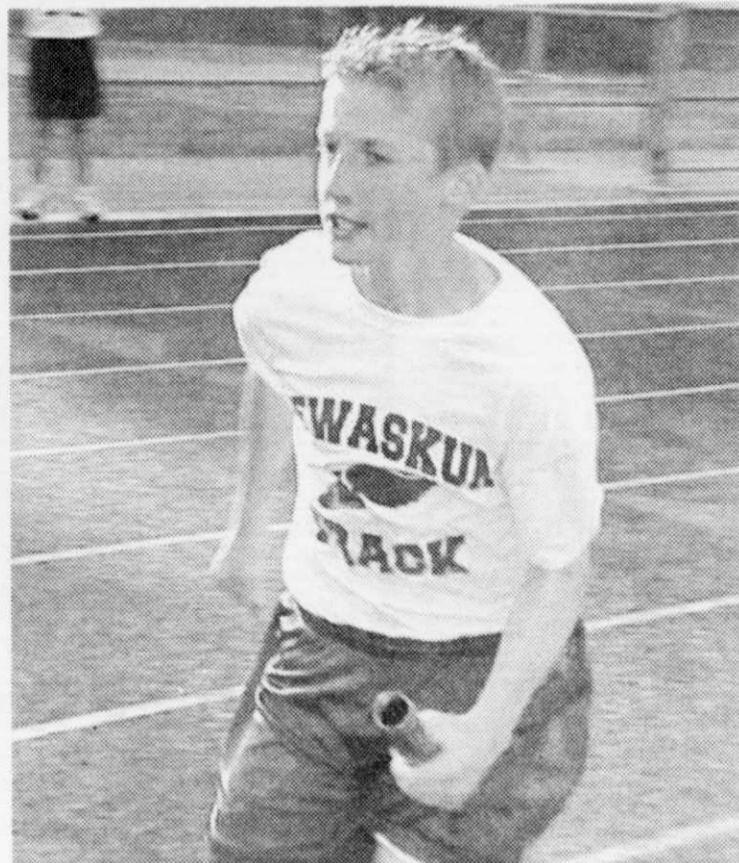

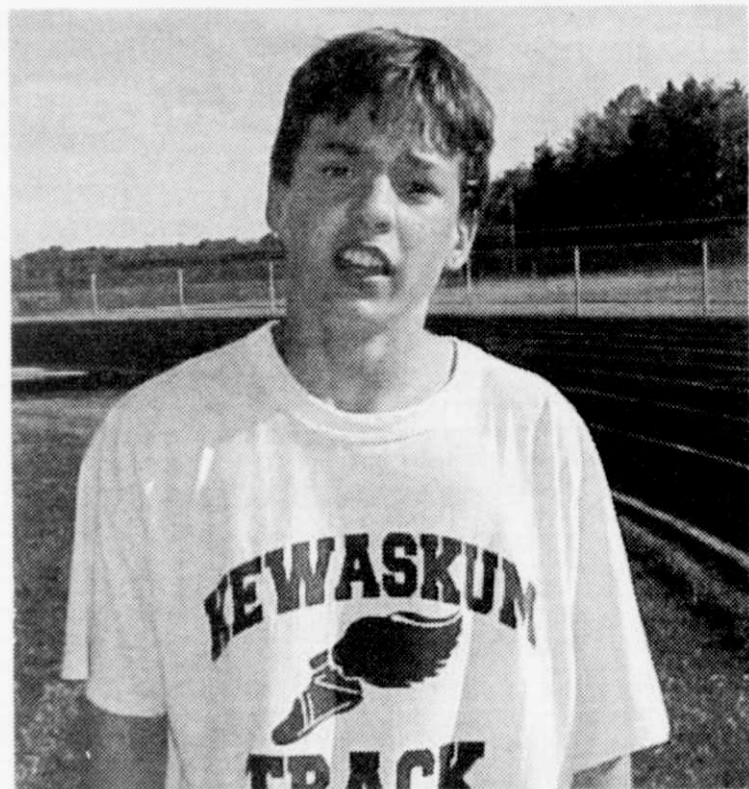

Jason Jahnke, right, and Scott Rhoads, left, finish first and third, respectively, in the 110m hurdles.

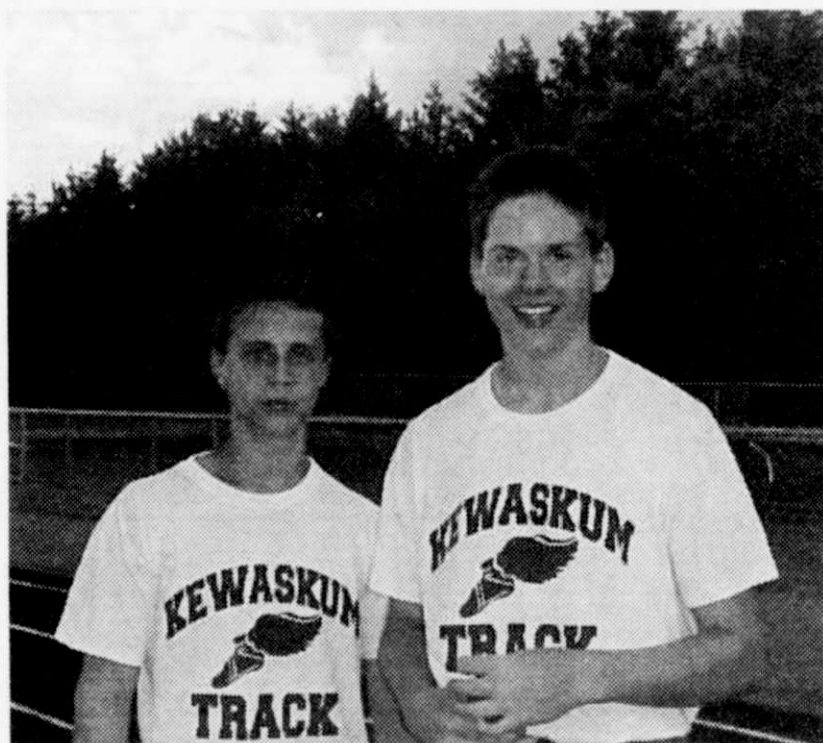


Garrett Donath races to a first place finish in the 1600m relay.

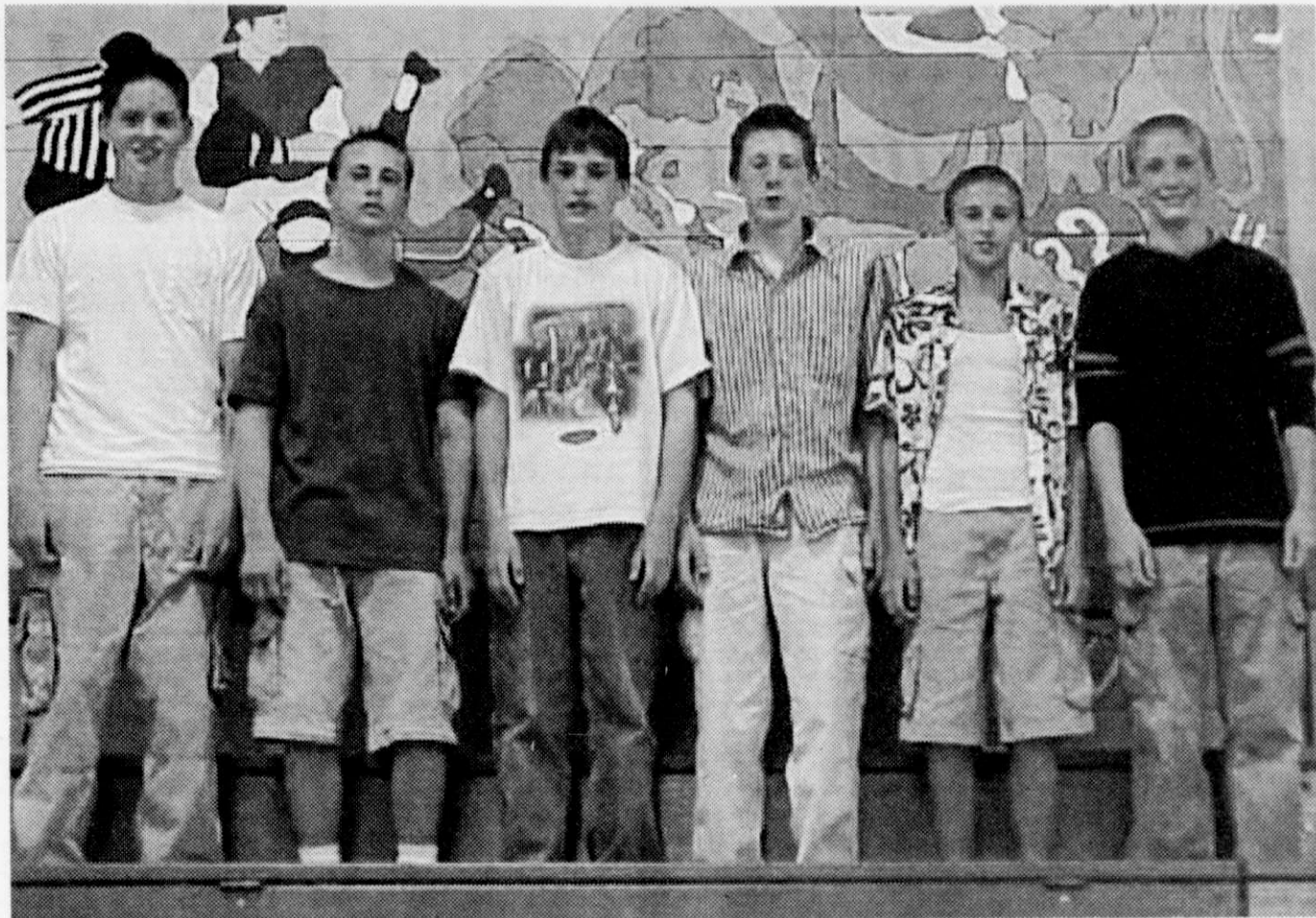

Three KHS Relay Teams; Athletes in Seven Individual Events Qualify for State

PEWAUKEE - Both the Kewaskum High School girls and boys track teams finished second at the WIAA Sectional Track Meet Thursday, May 24, at Pewaukee.

The Kewaskum Indians advanced in a combined 10 events to the state meet. The boys team qualified two relay teams and individuals in four events. The KHS girls team qualified one relay team and individuals in two events. The top three finishers at the sectional track meet qualified for the state meet Friday and Saturday, June 1-2, at University of Wisconsin - La Crosse.

The Kewaskum boys team finished second to Eastern Wisconsin Conference (EWC) opponent New Holstein 86-63. New Holstein won five events and Kewaskum boys won four events.

Charlie Sparks, the defending Division Two state champion, won the discus again at the sectional with a throw of 167' 9". Josh Parrent won the pole vault competition with a vault of 14'. Sparks has the second best throw going into the state meet and Parrent is the number one seed in the pole vault.

Both the Kewaskum boys 4x200m and 4x100m relay teams won. The 4x200m relay team of Chris Canter, Tony Fitts and Sparks won with a time of 1:31.0. EWC foe, Sheboygan Falls, who nipped Kewaskum at the conference meet, finished second with a time of 1:31.4. The 4x200m relay event is a new event this year at the state meet.

"The Kewaskum sprinters were real excited when the WIAA voted to include the girls pole vault as a state event. That meant that the 4x200m relay also would become a state event for the boys. This would give both the girls and boys the same number of events. Plus the EWC had already been running the 4x200m relay at the conference meet and last year we had won both the 4x100m and 4x200m relays," recounted coach Jerry Gosa.

The Kewaskum boys 4x100m relay team of Canter, Fitts, Kevin Miller, and Sparks won with a school equaling record time of 43.7 seconds they established a week earlier at the EWC relays. Howards Grove finished second with a time of 44.1 seconds. Canter, Fitts and Sparks return to the state meet in the 4x100m where last year along with Jim Thelen, who now runs for St. Norberts, finished fourth with a time of 43.79 seconds. Both the

Kewaskum 4x200m relay team and the 4x100m relay team have the best time in Division two going into the state meet on Friday.

Fitts and Canter both also qualified for the state meet in the long jump by placing second and third respectively with jumps of 20' 9". Each athlete's second jump was used to determine their placing.

The Kewaskum girls track team finished second to an old EWC opponent, Chilton, 62-58. Jessi Graham placed second in the 400m dash with a career best time of 62.5 seconds. Graham dropped a second off her previous best time. "Jessi ran one heck of a race," exclaimed coach Randy Backhaus.

The girls 4x400m relay team of Becky Herriges, Breyan Donath, Jenna Roecker and Graham ran an inspirational season best time of 4:12.7. The sophomore ladies dropped six seconds off their previous best time.

"Before the race we huddled together and talked. I told them that for three of them (Becky, Breyan and Jenna) it would be their third time out on the track and their last chance to qualify for state. I told them that the race came down to the relay team who had the biggest heart and that I knew that they could do it because they had the heart to do it - the burning desire to make it to state. I told them that they could run a time of 4:12 - 63 seconds splits apiece," reported a happy coach Gosa.

Colleen Gosa qualified for state for the second year in a row with her third place throw of 111' 3" in the discus. Gosa placed sixth at the state meet last year. Emmy Foerster also qualified for the state track meet in the 100m high hurdles by placing third with a time of 16.5 seconds. Foerster just edged teammate, Roecker, who fin-

ished fourth. Roecker later finished fifth in the 300m hurdles with a career best time of 49.7 seconds before running in the second place 4x400m relay.

"The coaches are obviously very happy for the athletes that qualified for the state meet, but also feel sad for those athletes whose seasons ended when they didn't place in the top three. It definitely wasn't for a lack of effort or determination that they didn't make it. They knew that they would face extremely tough competition and rightfully so. The coaches are very proud of the efforts made by all the athletes," stated coach Jerry Gosa.

Troy Koefler, who on Monday won the regional competition with a career best throw of 48' 1", placed fourth with a throw of 46' 7 1/2". Likewise, Nicole "Coco" Herrmann, who won the shot put at the regional with a career best 35' 10 1/2", also placed fourth with a throw of 35' 10" and just missed third place and a chance to go to state by only 1 1/2". The only consolation is that they are both underclassman and will have a chance to hopefully make it next year.

Jacki Krueger also just missed qualifying for state when she placed fourth in the pole vault at 8' 0".

The 4x100m relay team of Herriges, Kristin Schiller, Stacy Muckerheide and Tina Lindgren finished fifth with a season best time of 53.1 seconds and the 4x200m relay team of Herriges, Donath, Foerster and Lindgren finished sixth with a season best time of 1:51.8.

Donath also finished seventh in the 400m dash with a time of 1:04.9. Jolene Clark also finished seventh in the high jump with a jump of 4' 10".

Mike McKee placed sixth in the pole vault with a season best height of 12' and

David Cibulka placed eighth in the discus with a season best throw of 134' 3".

KHS Girls' Track Team Wins WIAA Regional

The Kewaskum High School girls track and field team continued with their tremendous season when they won the WIAA Regional title by scoring 153 points on Monday, May 21.

Sheboygan Falls finished second with 123 points, Pewaukee was third with 105.5 points and Grafton finished fourth with 97 points. Other team scores were Campbellsport 54 points, Kettle Moraine Lutheran 50.5 points, Random Lake 43 points, Brown Deer 42 points, and Dominican Whitefish Bay 29 points. A total of nine girls teams competed with the top four finishers qualifying for the sectional competition at Pewaukee on Thursday, May 24.

The start of the meet was delayed approximately 35 minutes because of the heavy rains. The rain delay proved to be a smart decision by the WIAA officials as the storm stopped and the sun actually shined on the regional track meet.

Kewaskum girls took first in four events including a pair of first-third finishes in the shot put and the discus. Nicole "Coco" Herrmann won the shot put with a career best of 35' 10 1/2" and teammate Colleen Gosa placed third with a season best 31' 6". Reversing their order, Gosa won the discus competition with a throw of 109' 1" and Herrmann placed third with a throw of 86' 1". Gosa also qualified in the 1600m run with her fourth place finish with a time of 5:58.

The top four finishers from each event qualified for the WIAA Sectional Track Meet on Thursday, May 24, at Pewaukee.

The Kewaskum High School boys sprint relay teams continued their impressive season-long success with the 4x200m relay team of Chris Canter, Tony Fitts, Tom Ogi and Charlie Sparks winning in 1:31.7. Sheboygan Falls finished second with a time of 44.4 seconds.

Sparks, the defending Division Two state discus champion, also won the discus Monday with a throw of 161' 4".

Canter won the long jump with an impressive leap of 21' 8 1/2", which also broke the school record of 21' 3" held by Mike Pettit set back in 1980. Canter now holds both the indoor school record of 21' 4 1/2" set earlier this year and the outdoor record. "Chris has had a great year. He had a monster jump at regionals. 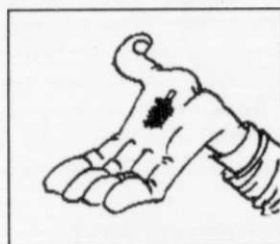
