25 Years ago April 9, 1976

More than 5,000 people, many of them from Kewaskum, crowded into the West Bend High School's field house Friday night to see and hear the President of the United States, Gerald Ford, who spoke in West Bend, while on a weekend swing through the state. President Ford spent the night at the West Bend Holiday Inn where he met with campaign workers and community leaders at a closed reception. It was the first presidential appearance in West Bend since Franklin D. Roosevelt came in the 1930's. Early Saturday morning President Ford visited Senland Farms at Route 1, Campbellsport, where he walked through a dairy farm, learned of dairy farm problems and ate a hearty dairy farm breakfast. The Peter Senn family greeted Ford at 7:35 a.m. as he brought his presidential campaign to Fond du Lac County. The presidential



"Next, the company will prepare assessments of each site and make comparisons of the alternative site scenarios. In Phase Two, Health Care Futures will prepare financial projections based on conclusions reached in Phase One. Ultimately these projections will be part of the hospital's bond offering," he added. "The decision on where to locate a new hospital has long-range implications that go well beyond the work span of most of the people who are currently involved. We are confident Health Care Futures will provide the objective analysis and guidance we need to make the best decisions for the hospital and the community."

David A. Anderson, a long-time consultant and lecturer on regional health systems and strategic planning as well as founding partner for Health Care Futures, said that a critical decision such as this should be based on the most accurate and objective information available.

"It is important to emphasize that our company is approaching this project with no biases other than our extensive experience in preparing objective assessments in other markets. We will work with the hospital's board to complete a rigorous study of the facts and recommend what we believe is the right course of action," Anderson stated.

Anderson chose early retirement as a partner from KPMG Peat Marwick in June 1996, in order to establish Health Care Futures LP. The firm consults for health systems, academic medical centers, physician group practices and health care associations.



FFA Tractor Operator's Contest

This year's Tractor Driving Contest was held in Arlington, Wisconsin, at the University of Wisconsin Madison's research farm, Saturday, June 2. The tractor-driving contest was offered to FFA members from sections four, five, and ten. Representing section ten for Kewaskum FFA was Lee Schacht and Tom Ramthun. Lee and Tom competed against seven others from section ten, with the three sections combined there were about 30 FFA members competing.

The purpose of the contest was to promote and encourage safe and skillful farm tractor operation, and to provide FFA members an opportunity to demonstrate their knowledge of tractor maintenance.

The contest consisted of a written test, with questions on safety and routine tractor maintenance, and a practical inspection of a tractor, where contestants were to find multiple things unsafe about the tractor.

The driving portion of the contest consisted of a two and four wheel driven course. The participants were given a short time to practice on the tractors.

For the two-wheel course a small Ford tractor and two-wheeled flat rack was to be backed through an alley and driven through a serpentine before being backed into a shed made up of golf balls on pipes about four feet tall.


The four-wheel course was also a small Ford tractor and a flat rack wagon, which was to be pulled out of a shed and backed into the finishing shed right next to the first.

During both of the courses the drivers were given points for things like dislodging a golf ball, crossing the boundaries, or grinding gears on the tractor as well as being given points for the time it took to complete the course. Through out the day contestants were being judged on safety, they would get points for things like failure to engage a clutch gently, turning too short, or jumping from the tractor.
