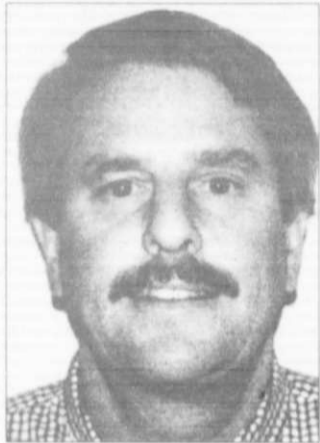

## Four Running for Three Seats In School Board Election

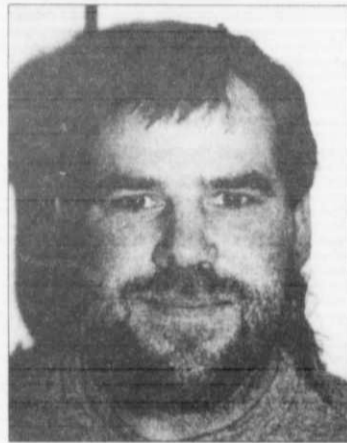

Four people, two incumbents, one past board president and one newcomer are stepping up to the plate in hopes of either retaining or receiving three year terms on the Kewaskum Board of Education in the upcoming April 2 election. A write-in candidate may still come forward.

Past board president Jon Downs filed for non-candidacy. Downs would have been seeking his third term on the board. Downs cites an increase in responsibilities at his place of employment as his reason for not running again.

"I like the direction the board is taking, I hope it continues," said Downs.

The final day for filing nomination papers was Wednesday, January 2.

Current clerk, Mary Meisser has been serving on the board for seven years. She unseated Ray

Kevin Scheunemann won his seat in last year's election after John Kenworthy moved up to village president. Kenworthy would have been up for election this year so Scheunemann must again run.

The trustees receive an annual salary of \$600 per year plus a per diem pay per meeting of \$30 per village board meeting and \$15 per committee meeting.

## Castro Still in Critical Condition at Froedtert Memorial Hospital

Former Kewaskum resident and doctor, Florizel F. Castro, 62 was involved in a motor vehicle accident Monday evening on Highway 45 in West Bend after his vehicle is said to have stalled.

The accident is still under investigation according to the Washington County Sheriff's Department. Castro's car that allegedly stalled on the highway was hit by a van.

Castro was trapped inside his vehicle and was extricated by the West Bend Fire Department. He was

then taken to St. Joseph's Community Hospital in West Bend and was later taken to Froedtert Memorial Hospital in Milwaukee via Flight for Life helicopter.

As of press time early Wednesday morning Castro was listed in critical condition by a Froedtert Hospital spokesperson.

## 25 Years Ago

Dr. R. G. Edwards of Kewaskum will retire from medical practice on January 1, 1977. Dr. Edwards, who practiced full-time from an office in his home, came to Kewaskum February 8, 1932 after completing his internship at Minnesota General Hospital. He celebrates his 71st birthday on September 1. On September 7, 1975, over 600 grateful people of Kewaskum and the surrounding area paid special tribute to Dr. Edwards at a Recognition Convocation, held in the new local high school gymnasium, honoring him for his many contributions to the community and surrounding area. At that time he had delivered over 3,400 babies, over 1,000 more than the present population of the village. At the ceremonies a special scholarship fund was established to serve as a living testament to the many years of faithful and outstanding service provided by Dr. Edwards. During Dr. Edwards long career, his wife, Alma, has assisted him in his office as a graduate nurse.

## EDUCATION... IT'S EVERYONE'S BUSINESS

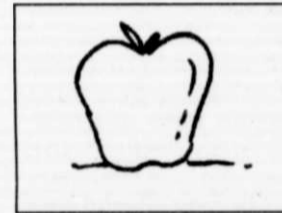

## Who is Rich, and Who is Poor?

There were two jewelry cases at the St. Vincent de Paul thrift store: one case marked "All Jewelry - As Is - \$1.99," the other, marked exactly the same except for the price being, instead, 99 cents. It was here, in front of the second case, the less expensive of the two, that the young family - a father, a mother, and their child - stood looking beyond the information taped on the glass door and into the case itself where earrings and bracelets and necklaces and other such items were displayed on that Christmas Eve afternoon.

"Look, purple!" said the woman to her husband, much taller than she, who now leaned over his wife's shoulder to see what had caught her eye. "My favorite color."

Together they agreed that the tarnished silver chain with its three purple stones hanging from the center was beautiful, and so he asked a clerk nearby if she would please remove it from the case because he would very much like to buy it for his wife for Christmas. Ninety-nine cents, plus tax, is the amount that he, this beholder, exchanged for the graying necklace.

Now there was a time in this particular clerk's life where she would have looked upon such a sight with pity, thinking it among the saddest she could imagine, possibly even pathetic, but she was no longer the same person she had been. Things had changed - specifically, her lifestyle. Gone were the expensive cars and the expensive clothes and the expensive house. Gone, gone, gone. The reason why is not as important as the fact that they were. Yes, things had changed, but most importantly, she had. And this, unbelievable as it may seem at the present moment, would be for the better. She would surely tell you this herself, if you were to ask, because it was here, in the valley of her life, that she would learn great lessons; lessons that all the money in the world would never have taught her.

And so we find her over at the St. Vincent de Paul, as I mentioned previously, checking out customers during the store's Christmas rush. She could never have imagined what kind of rush took place in a store that sold what other people discarded as unneeded, unwanted, and even as junk, because she had never set

foot in a place like this during the entire of her life. She hadn't needed to. Until now. But others had needed to, and always would, and now she would meet them, The Poor; those like this young woman who, when Christmas dawned in the morn, would wear a purple necklace, and those like her husband who would unwrap a wooden plaque, four inches by four inches, with painted letters reading "Home Sweet Home," bought by his wife the day before last for 49 cents. Plus tax.

These gifts, purchased with love alone - and a few coins - would not soon be forgotten by the clerk who now concerned herself with those who had little, and less than little.

There was another Who concerned Himself with these same, the very One honored this Day, the Messiah from the manger. Here, in a manner lower than the poorest of the poor, the King of Kings came. Not to a palace as one would have supposed, but to the last place anyone expected to find Him; without even a bed for His head. It is a picture of poverty, not of power or prestige. And it would be with the poor that He would continue to identify Himself throughout His life. By choice. Thus was Heaven's orchestration of the Message that began in the manger - a message that would, in no uncertain terms, direct our focus onto our fellows and off of our for-

tunes. In riddle-like teachings, the Christ would have us wondering who is really rich and who is really poor. To His disciples He'd take the time to point out a gift offered by a poor widow, a gift worth merely a fraction of a penny, and then tell them that this gift was greater than all the others that had been brought by the wealthy. This same Christ would let a young rich man know that although he had accumulated much, it was nothing; nothing, that is, of the sort of riches that lie within the soul, the riches that can neither be bought nor counted, the only riches that matter in the end.

It is not wealth itself that is condemned by God, but our attitude toward it, our use of it, our obsession with its multiplication, and the mask it becomes over empty lives and empty hearts.

And so, it was those of poverty and struggle, not the rich and famous nor the Who's Who of Jerusalem, that stood most often in the shadow of the One Who admitted to having "no place to lay His head." So said the Christ, the King of Kings, the Lord of Lords, the Homeless Man.

The thought is a bit uncomfortable, is it not? Uncomfortable, like the question the old preacher asked from his pulpit, "Why do you worship one Homeless Man on Sunday and ignore another on Monday?" It got kinda quiet in that church after the word "Monday." Pin drop quiet. And I, for one, have not forgotten what that

silence sounded like.

Jesus Christ came, and one day will return. This He told us, and it is true. And when He does, there will be a dividing that takes place in His presence. It is a dividing recorded there in The Book. To the right will step those who fed the hungry, clothed the naked, took in strangers, cared for the sick, and visited those in prison. To the left will step those who didn't, and just for the record, you will not want to be found standing on the left side when this dividing is over this too is recorded.

To those on the right, Christ will say this: "Come, you who are blessed by my Father; take your inheritance, the kingdom prepared for you since the creation of the world. For I was hungry and you gave Me something to eat, I was thirsty and you gave Me something to drink, I was a stranger and you invited Me in, I needed clothes and you clothed Me, I was sick and you looked after Me, I was in prison and you came to visit Me. I tell you the truth, whatever you did for one of the least of these brothers of Mine, you did for Me."

And here is the whole of the message: What we do unto those who lack, we do unto the Lord. Let us remember this, and we will meet one another on the right.

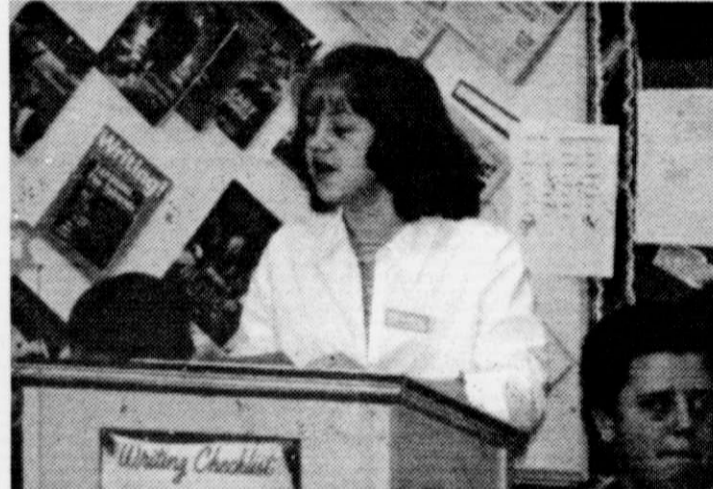

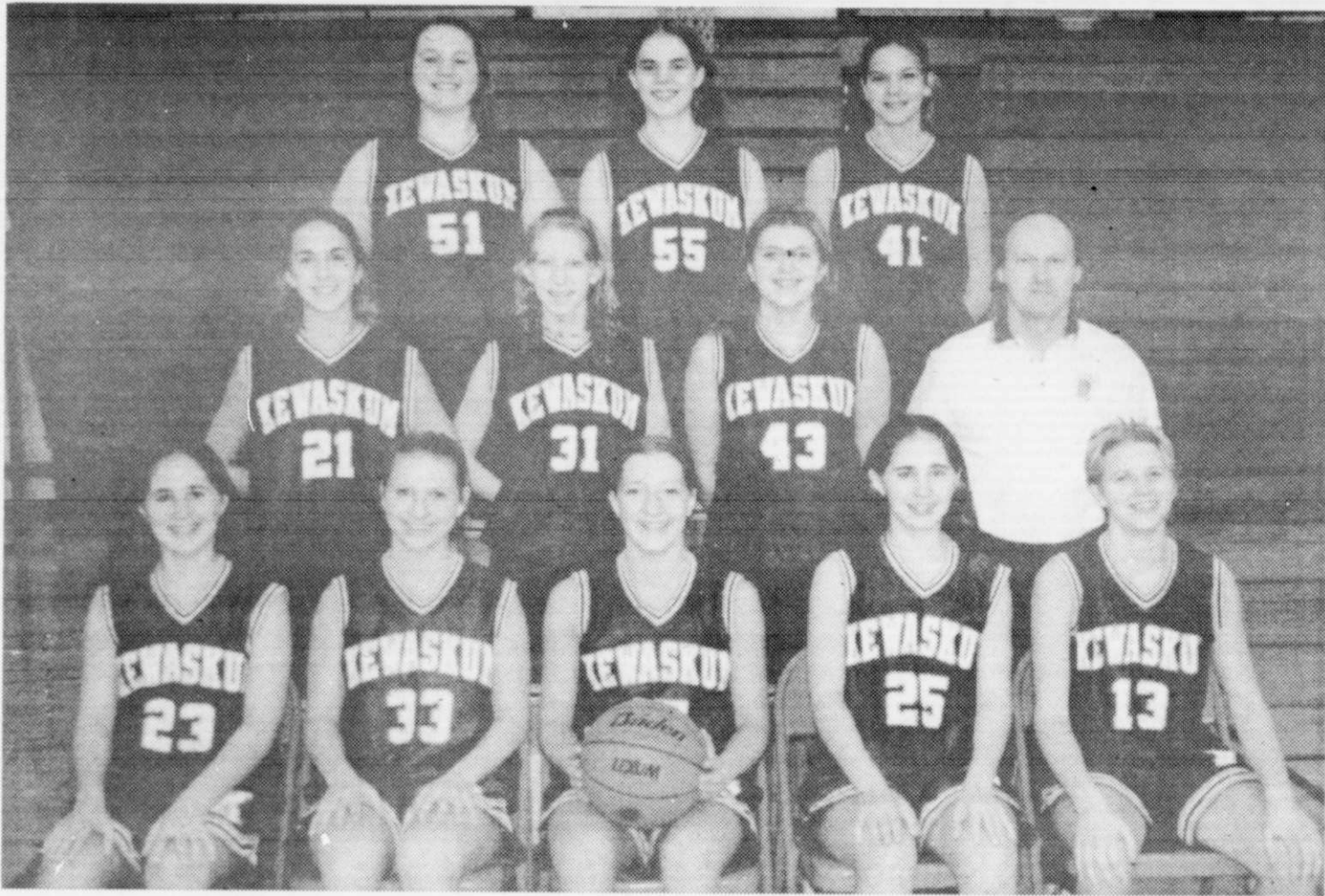
