Former Kewaskum School District Employee Steals \$25,000

Kewaskum High School has new money handling policies in place following allegations that a former employee embezzled \$25,000.

This week Nancy A. Reinert, 41, was charged with one count of theft for allegedly stealing from three cash funds at the school. Reinert, who worked at the high school for 18 months, has been accused of taking money from a soda machine fund, milk and lunch fund, and a pool of money called "the sunshine fund", which consisted of donations from teachers and students.

Kewaskum Police Chief Dick Knoebel said the case initially came to light in November 2000 when then high school Principal Robert Ganka told police he thought somebody was taking money from the school safe. "We had something to go on because somebody had given us a tip that maybe she was doing this," said Knoebel. "We actually set up a videotape and saw her taking money out of a cash box." Police also put identifying marks on several bills. The criminal complaint says some of that money later showed up in Reinert's personal bank account and on the days money was missing, Reinert was the only one seen working with the school's cash box.

On December 13, Knoebel said he confronted Reinert about the missing funds. The criminal complaint says Reinert denied several times taking the money and said a co-worker

gave her permission to make change. In late December, police again sat down with Reinert. The criminal complaint said she told police she didn't take anything and after that, she quit at the school. "If she had admitted to it, it would have been easier," said Knoebel. "But after that, it just meant we had to go and prove everything."

Knoebel said, they continued to work with the bank and the school on the case for the next two years, gathering evidence to support their accusation. "It took a long time because we had to go through bank records and everything else and that's not an easy thing," said Knoebel who also spoke with a former roommate of Reinert's. That man said in a criminal complaint that Reinert had admitted to him, she had taken the money and used it for car and house payments.

In March 2000, Kewaskum police filed a complaint with the Washington County District Attorney's office and this week charges were finally issued against Reinert.

"I've been Police Chief since 1988 and this is the first theft of this magnitude that I've seen," said Knoebel.

Many parents and neighbors in Kewaskum were shocked when they heard about the amount Reinert was accused of taking, saying it is hard to fathom somebody socked away that much money selling scooter pies and sodas. "But that wasn't the only thing she was taking," said Knoebel. "We had one person say she

sent a \$100 bill over to the school and she (Reinert) only credited \$50 on the account. It was stuff like that and I don't think the school is ever going to know exactly what she took, just because the way the theft occurred."

In light of the missing funds and the case pending in court, administrators at Kewaskum High School have taken steps to improve checks and balances within their system. "When I came on board at the school I just noticed the monies here are incredibly secure," said Donn Woolweber who took over for Ganka this year as High School Principal. "I'm wondering if any banks are as secure as what we're doing here at the high school." Woolweber said the administration has a number of new safeguards in place and he finds the system prudent and professional. "There's never less than two people counting or working with the money and balances are always checked and rechecked. A big part of the scenario is what can happen when one person is alone with money. Missing funds can apparently happen, but not anymore at this school."

Nancy Reinert is scheduled to make an initial court appear April 1st, before Washington County Circuit Judge Andrew Gonring. If convicted she could face up to 10 years in prison.

CAMPBELLSPORT- A 15 year old Campbellsport boy was involved in a one snowmobile accident shortly before 6:30 p.m. Sunday evening.

The teen was returning home after dropping off two friends in Eden and flipped his sled on a private trail 1/4 mile west of Highway W in a field south of Meadow Road near Eden.

He was taken to St. Agnes Hospital in Fond du Lac by Campbellsport

Rescue Squad and then later moved to Children's Hospital in Milwaukee. The family was not releasing his condition to the media as of press time Tuesday evening.

The teen told a Fond du Lac County Sheriff's deputy he did not remember exactly what happened.

It was noted that there was no stop sign at the place where the teen was thrown from his sled. A short time later the president of the club that maintains the trail replaced the signs.

Kewaskum Woman Killed in Milwaukee Bus Crash

MILWAUKEE- A 60-year-old Kewaskum woman was pronounced dead at the scene of an accident on Milwaukee's northwest side shortly after noon on Sunday when she collided into a Lamer's school bus.

The crash occurred on West Brown Deer Road in

the city of Milwaukee.

According to various reports the crash occurred when Kathleen Schachtschneider for some unknown reason crashed into the rear of a school bus stopped at a traffic light.

There were six passengers, employees of Lamers Bus Company on their way to pick up a replacement bus to take back to Slinger after another bus broke

down.

Investigators are trying to pinpoint the woman's speed and are almost sure the crash is not weather related.

Schachtschneider was driving alone at the time of the crash.

Town of Scott Discusses Fire Protection Referendum Questions

The Town of Scott Board has authorized two advisory referendum questions regarding the future of fire protection.

The questions will appear on the ballot on April 2.

They are:

1. Shall the Town of Scott, Sheboygan County, Wisconsin, continue to contract with two fire departments, one in Batavia and one in Beechwood?

and...

2. Shall the Town of Scott, Sheboygan County, Wisconsin contract with one fire department?

Voters will be able to answer "yes" or "no" to both questions.

The town board held a rare Saturday evening special meeting to approve the referendum questions.

Supervisor Ira Weber supported the questions and emphasized that they are advisory. They should give the board some direction in case there needs to be major cuts in the budget.

Board members said they are reacting to the proposed cuts in state revenue sharing proposed by the governor to stem a projected \$1.1 billion shortfall in state revenue. The Town of Scott Board believes its revenue sharing from the state could be dropping from \$87,276 to \$15,866.

Neighboring Town of Sherman had budgeted \$56,966 in state aids, but they expect to get nothing if the governor's budget proposal is approved.

Many Batavia Fire Department and Beechwood Fire Department members attended Saturday's special meeting, but they were not allowed to speak. The agenda did not include time for "public comments."

Town Chairman Steve Jung explained that observers at a town board meeting may only speak when asked to speak, or during a public input session. Public input was not part of Saturday's agenda.

However, now and then unsolicited remarks could be heard and sometimes a board member answered.

"Why start with the fire department?" somebody asked. "Why not other items?"

Weber replied, "Because that was the biggest expenditure in the town budget." He said that \$159,381.15 was spent on fire protection in 2001. The 2002 fire department budget is \$110,306.39, compared with \$60,024.75 for 2001.

There also was mention of the possible combining of the two fire departments.

"As far as combining fire departments," Weber said, "they are a private organization. I don't think we can force them to combine."

"We must find out what the people want even though it may not be our personal opinion," said Supervisor Gluck.

Near the end of the meeting, Batavia fireman James Sprosty passed out a two-page document to the town board. It was signed by 14 town residents, mostly fire department members and their spouses.

The document contained a mixture of 12 statements and questions, which included:

- We, the fire departments, are not here to work against the town, but rather work with the town, to provide the residents of the Town of Scott the best possible fire fighting and EMS service at a reasonable cost to the town taxpayer, while still protecting the long heritage of both fire departments.

- How many residents are asking for this referendum, or is it a small amount, and a board member?

- Is this maybe an issue that the fire commission should be working on instead of the town trying to force it on the fire department?

- If there is a real need for a referendum, the fire commission should be the one working on the question, and then presenting it to the board for the November ballot.

- Does the town have any dollar figures on how much savings there actually will be by having one fire department and a substation?

- Where are these stations to be located and who is paying for them?

- Is there a substantial savings, or are we talking pennies?

- Where else in the town

budget have we looked at to cut costs, or are the fire departments the single chopping block?

- Are there any concessions from the town board members to save taxpayer monies? Board members have received a 3% raise this year, and there is another 3% raise in store for next year.

- Why is it that when a concerned citizen brings something to the attention of a board member outside of a board meeting, no names are mentioned, and those concerned citizens are never at the meeting that addresses their concerns?

Young Miss Haley Guell, a seventh grader at the Shepherd of the Hills parochial elementary school in rural Armstrong, sent out a few letters last week. I received one of those in my mailbox on Saturday afternoon. The envelope it arrived in was addressed to Mrs. Rochelle Pennington and was penned in a child's handwriting with large, carefully written letters.

"Hmmm," I wondered. "What's this?" I was curious.

Opening the envelope, I found an urgent plea inside. Written in purple, orange and green magic markers was the following message:

"PLEASE HELP! Kayden Vassekuil. Baby with rare heart condition. Send special fund for this baby in need! THANK YOU! P.S. And spread the word!"

Haley was seeking help for a seven-month-old baby she neither knew nor had ever even met. A newspaper article had caught her attention and also the attention of others at her church. The

article was about a little fellow born in Waupun, Wisconsin with a heart condition so rare that only three children in the entire world are afflicted with it each year. Corrective surgery was beyond what his family was able to pay. What to do?

Command those who are rich in this present world not to be arrogant nor to put their hope in wealth, which is so uncertain...command them to do good, to be rich in good deeds, and to be generous and willing to share...so that they may take hold of the life that is truly life.

Others would answer that question for Kayden's young family. Others, like Haley Guell who was not only participating in her church's fundraiser - a Sunday morning brunch on March 10 with all proceeds going to the family - but who felt compelled to do something more, something of her very own. So she did.

Her teacher didn't know what Haley had decided to do, and neither did her folks. The first inkling her mother had that her daughter was up to something was when the phone rang this past Sunday morning. Haley's grandmother was calling to ask who she should make her check out to.

"What check?" asked Haley's mom.

"The check for the sick baby Haley is collecting money for."

Grandma went on to read the letter she received and tell about the self-addressed envelope that had been included for returning donations. (This girl is

organized!!)

Haley would later explain in a voice of sweet and genuine concern why she did what she did. "It's because I felt really good about it. I felt like I was doing something to help others and not only thinking of myself. It felt really good. Really good." So said the seventh grader.

Haley never heard President Bush's message about the responsibility we have toward one another and about the responsibility we have for making the world a better place. I know this because I asked her this. She didn't need to hear it. She was already living it, changing the world by changing the life of someone in her own world.

Zesty Turkey Wrap

2 cups finely chopped Butterball Turkey
 ¼ cup sliced green onions
 ¼ cup finely chopped sundried tomatoes
 ½ cup prepared ranch salad dressing
 Lettuce leaves
 6 (7-inch diameter) flour tortillas or 4 pita pockets

Combine turkey, onions, tomatoes and dressing in medium bowl. Place lettuce leaves towards one edge of each tortilla. Divide turkey salad among tortillas, place on lettuce. Roll to wrap. If using pita pockets, cut pockets in half, line with lettuce and add turkey salad. Makes 6 wrap sandwiches.

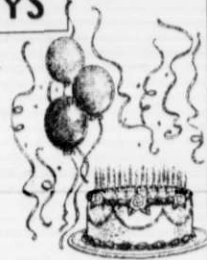

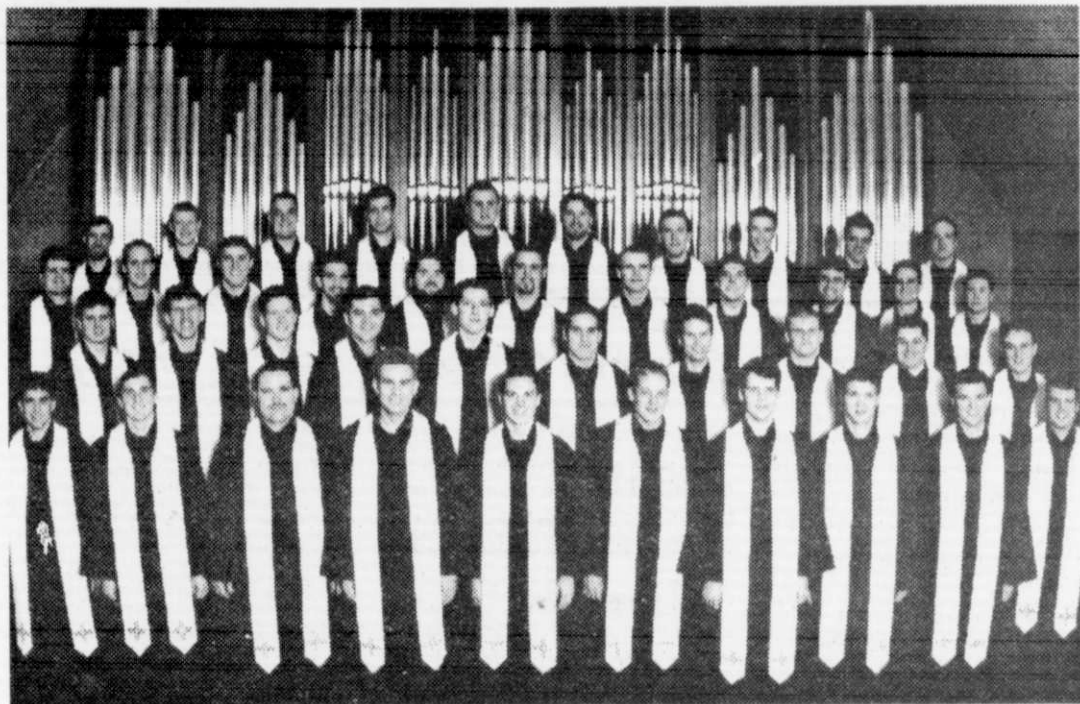

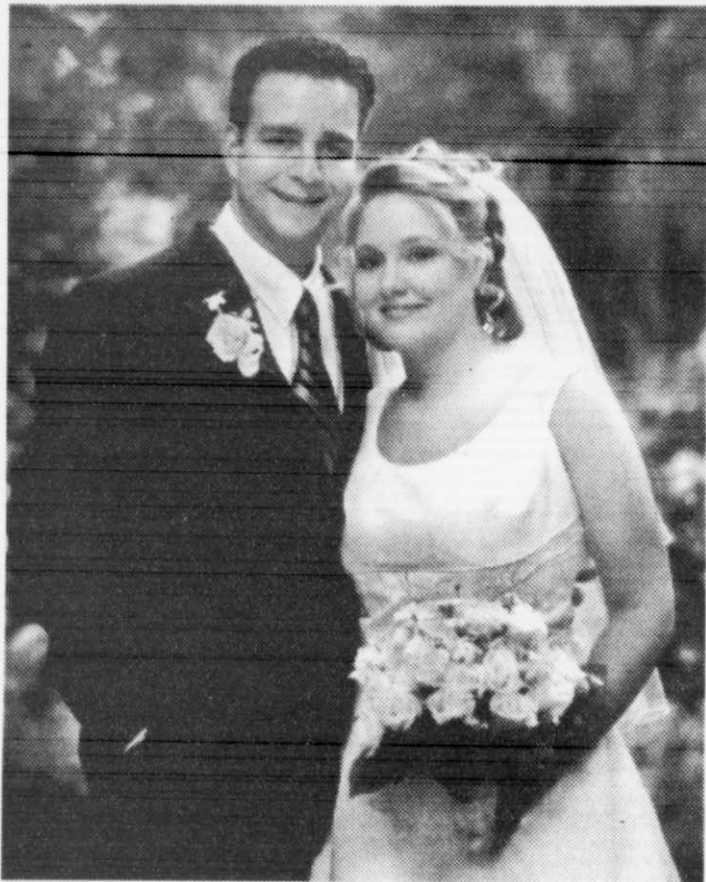

GIRL SCOUT COOKIE RECIPE

SUPER SAMOA SURPRISE FIRST PLACE

Junior Girl Scout Troop 362

Ingredients:

- 1 box of Girl Scout Samoas
- 2 boxes of coconut cream pudding; Instant or cooked
- 3/4 cup flaked, sweetened coconut
- 1 oz. bittersweet chocolate
- 1 tsp. butter
- 1 tsp. cream
- 3 1/2 cups milk

To make the crust:

Break up the Girl Scout Samoas (14 cookies) into a food processor. Process until the cookies are evenly crumbed. Press into a 10-inch pie plate. Refrigerate for an hour or more.

To make the filling:

Make the pudding using the directions for pie filling on the box. If it is cooked pudding, let cool until warm instead of hot, stirring every five or 10 minutes to avoid leaving a "skin" on the pudding. When it has cooled sufficiently, pour it into

the chilled pie crust. If it is instant pudding, you may pour it directly into the chilled pie after mixing.

To make the topping:

Heat the oven to 325°. Spread the coconut flakes on a cookie sheet and place in the oven. Stir the coconut every couple minutes until it is evenly browned. This should take about 10 minutes or less. Sprinkle the toasted coconut on top of the filling in the crust and refrigerate while you make the chocolate drizzle.

To make the chocolate drizzle:

Place the chocolate in a microwave proof dish. Microwave at half power for one minute. Add the butter and microwave, again, at half power for another 30 to 60 seconds, stirring to mix the melted chocolate. Continue microwaving and stirring until the chocolate is completely melted and mixed with the butter. Add the cream and mix well. Drizzle over the toasted coconut or put in a decorating bag and pipe on in any design you wish. Refrigerate for three hours or overnight.

Allenton Requests Approval Improvements Proposed for Wastewater Treatment Plant

MILWAUKEE -- The Allenton Sanitary District has requested approval to upgrade its wastewater treatment plant to remove phosphorus. All treatment plant construction will take place at the existing plant site.

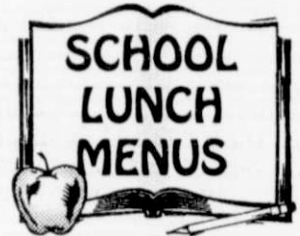
The sanitary district is required to provide phosphorus removal as a condition of its discharge permit issued by the Wisconsin Department of Natural Resources.

The sanitary district anticipates financing the project with a state Clean Water Fund low-interest loan. The estimated capital cost of the improvements is \$101,000. User charges to a typical residential customer are not expected to increase because of this project.

While this type of action normally does not involve significant environmental effects, the Department is

soliciting public comments regarding the impacts of the proposal.

During the tragic events that enveloped the nation following the World Trade Center disaster in New York on September 11, 2001, area residents were shocked to find out that a 1994 graduate of Kewaskum High School, Andrea Haberman, was listed as one of the missing victims.

An outpouring of sympathy was extended to Andrea's family and following a memorial service, a scholarship fund was established in her name.

Through donations and fund-raisers, the Andrea Haberman Scholarship Fund soon became a reality, an entity of the High School's KEYS Kewaskum Youth Scholarships, Inc.

The following is a letter to KEYS coordinator Gerald Gosa from the Haberman family:

Dear Mr. Gosa:

Enclosed please find a check payable to the Keys Scholarship organization at Kewaskum High School, tendered in the name of our daughter Andrea. This check represents donations made by so many kind people and our family to the memorial fund established in Andrea's name after the tragic events of September 11, 2001. The events took her life. The fund will honor her memory. My wife Kathy, daughter Julie, Andrea's fiancée Allen Kolodzik, and I have been amazed at the outpouring of support from so many kind people being done in her name. As parents, Kathy and I tried to instill in our daughters to study hard and do the best they were capable. We taught our children it is with knowledge that you gain the confidence to face the world. We are very proud of Andrea's educational achievements. She was an honor student throughout her school years. While always Kathys' and my bright light, it was touching to see many of her teachers, from grade, middle, high school and college, show their concern and respect by attending Andrea's memorial service. We humbly thank all of you who guided and educated our daughters. Our other bright light, Julie, is a senior honor student at the University of Wisconsin, Parkside.

One of the prouder days for our family in her academic career was when Andrea became a recipient of a KEYS Scholarship at Kewaskum High School. It truly helped ease the financial burden of that first year of college. I remember the pride we felt when during the award ceremony, the effort required by recipients

to receive a scholarship was recognized. It is fitting that in Andrea's memory, other deserving recipients, because of their hard work; coupled with the donations of so many, will benefit. It makes us proud of her all over again. With this check it is hoped that the scholarship will become permanent.

The last several months have been a sad time. As Andrea was a resident of Chicago, we live in Wisconsin and the atrocity occurred in New York, it has been more difficult for us than residents of New York to gather information as we try to assemble and understand the last moments of her life. We have traveled there, first in an attempt to find her and then, sadly to organize her affairs. We have stood where she is now and the horror of what hate can do haunts us. Yet, we seem drawn there to meet with some of the families whose loved ones died with Andrea. We have come away with a feeling that those who were with her in the end would have helped her and surrounded her with love. So many families, so many children senselessly affected. Thousands in New York magnify the weight of grief and sadness Kathy and I feel that at times it is almost unbearable. Our future, along with so many others is not the same as it was just several months ago.

It is when this sense of loss and sadness is the worst however, that we recall the compassion exhibited by so many kind people. Family, neighbors, friends, customers, employees past and present from across Wisconsin and the United States, school children and their teachers, and parents who have experienced their own grief at the loss of a child have all responded to help. While we may not have, or ever meet, all have contributed to the Scholarship Fund; trust that you have provided us with a source of strength that goes beyond the donation. It is hard to articulate feelings; however, Kathy and I have experienced an unimaginable evil while at the same time being a witness to the finest that the human spirit is capable. We never taught our children to hate nor to be afraid of the future. It is important, especially now, for young

people to receive this same message. It is our intention that this donation will further help other deserving students embrace the future and be a credit to their schools, families and communities.

Andrea will never be forgotten in the hearts of Kathy, Julie, Andrea's fiancée and myself.

The Keys Scholarship Fund established in Andrea's name will do the same at Kewaskum High School.

Babies Get Cavities Too

If you have a new baby, you may not realize how important it is to care for the child's baby, or primary teeth. The Wisconsin Dental Association wants parents to know that serious tooth decay may develop by the child's first birthday. Even though the child's primary teeth will eventually be replaced with permanent ones, the primary teeth are critical for proper chewing, speaking, appearance and preserving space for the adult teeth to come in straight. All of this leads to good overall health of the child. As stated in the first ever Surgeon General's Report on Oral Health, good oral health is the key to good overall health.

Baby bottle tooth decay, also called nursing-bottle or nursing-mouth syndrome is a condition that can destroy the primary teeth of an infant or young child. It develops when a baby frequently receives a bottle of milk, formula, fruit juice or sweetened liquids to serve as a pacifier or a comforter. It may result when the child is often allowed to fall asleep with a bottle during naps or at bedtime. Prolonged demand breastfeeding may also cause this condition. Although the teeth most likely to be damaged are the upper front teeth, others may be affected.

Tooth decay is caused by bacteria, which are present in a thin film of plaque that constantly forms on the teeth. The bacteria in plaque use sugar to produce acid, which attacks tooth enamel. If a sugary liquid is allowed to remain in the mouth, acid can attack teeth for several minutes. Tooth decay can occur after frequent, repeated acid attacks.

It's not just what children drink, but how often and for how long their teeth are exposed to decay-causing acids. For example, if you offer a bottle containing sugary liquid as a pacifier many times a day, the teeth experience more acid attacks. Allowing a child to fall asleep with a bottle during a nap or at night also can harm teeth. While the baby sleeps, the flow of saliva decreases. Harmful sugary liquids collect and remain around the teeth, inviting acid attacks. You can prevent this by watching what you give your baby between regular feedings. A bottle should not be used as a pacifier or as an aid to help baby sleep unless it contains plain water. Don't dip pacifiers in a sweet liquid and don't add sugar to a baby's food. Children can be taught to drink from a cup as they approach their first birthday. This will eliminate bottle-feeding or using a bottle as a pacifier.

The Wisconsin Dental Association recommends that after each feeding, parents wipe their baby's teeth and gums with a clean

gauze pad or clean wash cloth. This will remove plaque and prevent acid attacks. Begin brushing as soon as the baby's first tooth appears. Continue cleaning and massaging gums in all other areas that remain toothless.

Visit the dentist by the child's first birthday. While this may seem early, your dentist can determine if you are using the right cleaning techniques. The dentist also can determine if there are problems with the child's primary teeth. And it gets your child used to seeing the dentist, before any problems develop.

Children should receive an optimal amount of fluoride, a mineral needed for the development of decay-resistant teeth. Whether or not you live in a community that has fluorinated water, you should ask your dentist about how your child can get the right amount of fluoride.

Lake Michigan Yellow Perch Hopes Pinned On 1998 Year-Class

MADISON - Egg, population and harvest surveys are showing that yellow perch hatched in 1998 hold the key to continued improvements of Lake Michigan's recovering yellow perch population, spurring state fisheries biologists to seek an emergency rule to protect these four-year-old fish from angling harvest during the 2002 spawning season. Commercial harvest of yellow perch in Lake Michigan was eliminated in 1998.

"The 1998 year class is the only moderately good one in the last decade, and their numbers will rapidly decline as a result of high natural mortality," says Bill Horns, Department of Natural Resources Great Lakes fish specialist. "We just want to give these fish the best possible chance to reproduce. By changing the season closure for 2002, we will limit the harvest of sexually mature females to maintain adequate spawning stock and increase our chances for an early recovery of yellow perch in Lake Michigan."

Horns and other biologists will ask state Natural Resources Board members at their March 27 meeting in Madison to change the yellow perch season dates so the closed season starts earlier - in May instead of June - and lasts 15 days longer. Now, the open season runs from July 1 to May 31, with the season closed for the month of June. The proposed emergency rule calls for an open season from June 16 to April 30 with a closed season from May 1 to June 15.

In 2001, biologists noted that anglers targeted spawning concentrations of yellow perch during late May, when the spawning fish are closer in. Anglers in May 2001 harvested an estimated 10,000 yellow perch, significantly more than the 848 harvested in May 2000, 1,022 in May of 1999, and 3,077 in May 1998.

The emergency rule seeks the same changes fish biologists are asking voters to approve at the DNR Spring Fish and Wildlife Hearings, set for April 8 in all 72 counties.

If the permanent changes pass at the spring hearings, and the Natural Resources Board adopts those permanent changes, they would take effect in 2003. "That's too late to protect reproducing yellow perch during the coming spawning season, so we need to get an emergency rule in place," Horns says. "These fish, as four year olds in 2002, hold most of the reproductive potential of the Lake Michigan yellow perch population."

For most of the last 15 years, annual surveys of young-of-the-year perch using bottom trawls and

beach seines in the fall found dramatic decreases lakewide in the number of young fish surviving their first year. In most recent years, the surveys have fisheries crews cautiously optimistic that they're seeing the beginning of a recovery, but convinced they need to protect the 1998 year class during the spawning season to aid that recovery.

For one thing, the 1998 class faces increasing pressure from anglers. Fish from that year class comprised 71 and 87 percent of the sport harvests in 2000 and 2001, respectively.

"When yellow perch stocks are low, a single moderate year-class is highly vulnerable, and the pressure on this year class would be even greater in 2002 if we don't protect them," Horns says.

In addition, SCUBA diving surveys conducted during yellow perch spawning in 2001 showed 7.29 yellow perch egg masses per 1,000 square meters of area searched compared to .50 in 1997, zero in 1998, and 1.89 in 2000.

"These surveys show that egg deposition has increased since 1998 and that there are good numbers of mature fish in the population," Horns says. "We need to protect these fish to maintain adequate spawning stock and increase our chances for an early recovery of yellow perch in Lake Michigan."

The proposed emergency rule is the latest in a series of regulation changes since 1995 to try to halt the slide of yellow perch populations in southern Lake Michigan and to encourage an early recovery there. Significantly cutting the sport daily bag and closing the commercial harvest are among those actions.

Meanwhile, a similar problem is facing fisheries biologists in Green Bay. Yellow perch populations in

Green Bay have decreased an estimated 90% in the last decade, and surveys have shown there are few young fish coming up in the population.

In Green Bay, as in Milwaukee, much of the attention and hopes are being pinned on the 1998 year classes, which represent the only good years for reproduction out of the last 10. Sport bag limits have been cut, and commercial harvests have been cut.

Controlled Burns Proposed For Surrounding Counties

MILWAUKEE - The Wisconsin Department of Natural Resources is proposing to conduct controlled burns during March and April at several locations in Washington County, Ozaukee County and eastern Dodge County. Burn sites range in size from one acre to 40 acres and are located at Theresa, Allenton and Jackson Wildlife Areas, the Loew Lake Unit of the Kettle Moraine State Forest, and on private lands in Washington, Ozaukee and Dodge counties. About 450 acres in total may be burned.

Controlled burns are conducted to increase plant diversity and stem density on grasslands, for site preparation for seeding warm season grasses, to set back undesirable woody vegetation and to improve waterfowl brood and migration habitat. A primary goal on upland sites is to improve nesting habitat for bird species such as mallards, blue-winged teal, pheasants, boblinks, dickcissels and grasshopper sparrows. Burning is also conducted on wetland sites where levels have been drawn down over winter to improve habitat for waterfowl and other wildlife by providing more areas of open water and a larger variety of wetland plants.

This type of project does not have the potential to cause significant adverse environmental impacts; therefore, the Department has made a preliminary determination that an envi-

Lake Winnebago Sturgeon Season Runs Full 16 Days

OSHKOSH -- Wisconsin's largest and longest-lived fish finally got a season to match.

The 2002 Lake Winnebago sturgeon spearing season closed at the end of spearing hours last Sunday with spearmen registering a total of 847 sturgeon. The 16-day run was the longest season since 1997 -- and the longest allowed by law -- and it represented a dramatic departure from the two previous seasons.

Spearmen in 2001 and 2000 on opening day hit the harvest triggers that prompted the closure of the season at the end of the second days.

"We are very pleased with the harvest and the way the season went," said Ron Bruch, Department of Natural Resources sturgeon biologist stationed in Oshkosh. "The new half-day rule, along with some poor ice and cloudy water, definitely helped slow the harvest down and extend the season."

The Natural Resources Board in December approved an emergency rule effective for the 2002 season to cut in half the hours people could spear each day to avoid a repeat of 2001. In that year, spearmen registered 52 percent more adult females than the safe harvest level allowed, causing concern about the fate of the Lake Winnebago population.

Females don't start spawning until they are 20 to 25 years old, and then spawn only every three to five years. Adult females are also more frequently targeted by spearmen because they are larger than male sturgeon; removing too many of them can cause a population to crash, and

recovery might take more than 100 years.

In 2002, the safe harvest cap for adult females was 400; spearmen didn't reach 320, the level triggering the closure of the season at the end of the next day, until Saturday, when spearmen registered five adult females to push the number to 322.

On Sunday, spearmen registered another three adult females, for a preliminary season total harvest of 325 adult females. Spearmen registered 178 juvenile females and 344 males.

Warm weather played a significant role in helping slow the harvest of adult females, contributing to poor ice conditions, which hampered travel on the ice and forced spearmen to set up their shanties in areas with good ice that they typically didn't fish, Bruch said.

The warm weather and the clear ice it spawned also allowed algae to continue blooming, which decreased water clarity and made it more difficult for spearmen to see their prey.

"We heard from most spearmen that they were very happy with the long season and the harvest, although they would have preferred better spearing conditions," Bruch said.

The half-day spearing hours will be considered for a permanent change at DNR's Spring Fish and Wildlife Hearings scheduled for every county on April 8. The Natural Resources Board will make its decision on the permanent rule later this year.

Hello friends,

Little Bay de Noc is on the north end of Green Bay. It covers 75 square miles of water and has become my home for about eight days each February. Trophy walleye and northern pike are what lured 11 members of the Red Brush Gang (our deer camp) to its frozen waters, where we spent four days this past week camped on the ice, fishing and socializing.

Thursday, February 21
High 36-, Low 26-

The Wildman (Harold Moll) and I pulled into Gladstone, Mich., and decided to have lunch at 4J's Restaurant before we hit the ice. The big talk in 4J's was about a helicopter rescue of two ice fishermen just minutes before. The discussion also included the imminent loss of 12 shanties on an ice floe that was floating south towards the big lake.

After a fine lunch, we headed north a couple of

miles to where I had built a camp on the ice last week. Unfortunately, a powerful windstorm had blown several shacks over. Fortunately, mine was not one of them. The Wildman and I each put out two tip-ups and then moved into the shack.

An hour after dark, just as Jeff Moll was pulling into camp with three of his boys, one of the Wildman's tip-ups went up. The boys were just in time to see their grandpa catch the first fish of the trip. It was a 22-inch walleye. As always, a good time was had by one and all at camp that night.

Friday, February 22
High 38-, Low 27-

My brother, Mike, and my brother-in-law, Dick Schuster, along with his boys, Shane, Riley and Trent, pulled into camp at sun-up. It wasn't long before our camp was complete with three shacks, 11 fishermen and four golden retrievers. Our crew took over about three acres of ice after setting out 22 tip-ups.

The morning fishing was slow, with just three north-erns in the 20-inch range being iced. I knew we had our turf covered well and that sooner or later the flags would be going up.

Just after lunch, the action began. Unfortunately, over-excited fishermen made some rookie errors. In several situations, the fish we were trying to catch had just let go of our six-inch suck-ers.

Toward mid-afternoon, Jeff Moll came through when he landed a 29 1/4-inch walleye. That put everyone in a great mood. Jeff was now sitting pretty in our big walleye of the weekend bet of \$3 apiece.

Just because the sun goes down does not mean fishing is over for the day. Our crew became nomads, roaming the ice under a full moon. I was hanging out at camp when Dick Schuster let me know I had a flag. Unfortunately for me, it was

Mike's tip-up that had a fish consuming his sucker. By the light of a Coleman lantern, our crew watched as Mike landed a truly massive 29 1/2-inch walleye. Mike's fish found a new home on his living room wall. About the same time, my nephew, Riley, iced a five-pounder, and our camp was ready to party!

Saturday, February 23
High 38-, Low 28-

A strong south wind, combined with blowing snow, made our day a challenge. We moved our campfire to the north side of the shacks and enjoyed the day. The Wildman caught a 24-inch walleye. What was surprising is that it was blind in both eyes and appeared to have been caught before. Our guess is that whoever released it had carried it by the eyes, a practice proven long ago to blind fish. Mikey sealed a great weekend for himself when he won the big northern bet with a 34-inch-er.

It used to be everyone thought I was nuts camping on the ice. Now they know it's all a frame of mind.

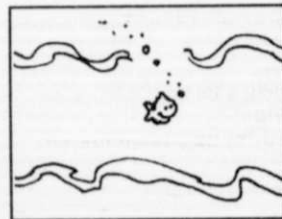
Boys' Basketball Traveling Team To Assemble
