Ogi to Move Veterinary Clinic To Former Sison Medical Clinic

Kewaskum-Allenton Veterinary Clinic owner, Dr. Greg Ogi received approval on a conditional use permit from the Kewaskum Village Board Monday night allowing him to move his veterinary clinic from its 1511 Fond du Lac Avenue location in the village to the former Sison Medical Clinic, also in the village, which closed in 1996 after the West Bend Clinic erected a new clinic on Highway 45 north.

The Sison Clinic has remained vacant since that time. The lower portion of the clinic has housed The Randall Gust American Family Insurance Agency and Morrissey Law Office.

Ogi's father, Dr. Charles Ogi has been operating Kewaskum-Allenton Veterinary Clinic since 1954. Dr. Greg has been following in his father's footsteps since 1982 but says his father continues to play a huge part in the clinic's success. Dr. Greg purchased the clinic in 1988 and is the sole owner. He and his father work with two other doctors that are employed by the clinic.

Ogi came before the village's planning commission in March and received a favorable recommendation at that time. Zoning administrator Gordon Hoffmann, in a letter to Village Administrator Daniel

Schmidt stated "The expanded services Mr. Ogi can provide at this location should be an asset to the Village of Kewaskum."

Prior to the public hearing held this past Monday night, Ogi's soon to be neighbor, - Maple Dale Manor's administrator, Lisa Stockhausen stated issues she hoped would be included in the conditional use permit Ogi needs to operate his clinic.

Those were: proper disposal of dead animals; all feces and waste must be plastic-bagged and disposed of in a dumpster; no composting of any material on the property; no animals left outside unattended and any fenced areas must be privacy-covered.

Stockhausen was in the audience at the public hearing. In addition to her letter she voiced concerns over barking dogs. Ogi retorted, "There are two things I hate, barking dogs and crying children."

Barking dogs is a problem all too common to Stockhausen who had a previous problem with barking dogs from another neighbor back in 1995.

At that time residents at her facility voiced concern and even lobbied to have a kennel permit held by Hon-E-Kor Country Club in the Town of Kewaskum revoked.

After learning her conditions were being met on a conditional use permit she

wished Ogi the best of luck.

The trustees unanimously approved the issuing of a permit to Ogi for his new location with these conditions:

- ◆ All pets boarded (dogs and/or cats), will be kept inside.
- ◆ All animals when outside will not be left unattended after dusk.
- ◆ Owner will use proper disposal of all dead animals and surgical waste.
- ◆ Owner will dispose of all feces and waste must be plastic-bagged and disposed of properly.
- ◆ There will be no composting of any animal or surgical material on said property.
- ◆ Any fenced areas must

School District Proposes Budget Cuts For 2002-2003 School Year

On Monday, April 15, the Kewaskum School District Finance/Transportation and Grounds Committee met. Their major agenda item was the proposed 2002-2003 budget. Administrators spend most of the day discussing ways to make up for an original \$1,004,478 shortfall.

The projected revenue for next year is \$15,301,848 and is projected to be down in other revenues, due to the drop in interest rates. This accounted for over \$37,000 that the school district is expected to no longer have. Revenue is projected to be up, however, from aid and taxes.

What it comes down to overall is a 3.3% increase in revenue and a 10.0% increase in expenditures.

To try to make up for this, KSD is freezing the level of staffing. There will be no new positions next year. They also froze all the things that didn't need to be increased.

Administrators went back and re-looked at some of the items in the budget and were able to rework the budget to a \$613,061 shortfall. In doing this, they decreased money allowed for salaries, benefits, purchased services, materials and supplies, equipment and other expenditures.

This still didn't work and the budget was looked at a third time.

With an additional \$100,00 found in increased revenue from transfer service exemptions and increased enrollment projections, the revenue was raised to \$15,401,848 with expenditures still at \$15,914,909.

The district then proposed numerous cuts to help them balance their budget. Their proposed cuts included:

- Eliminating four half-time teaching positions.
- Eliminating one 1/3 position.
- Eliminating three full-time teaching positions.
- Reducing Teacher in Charge Salary by 1/2.
- Eliminating Athletic Coordinators/Directors/Secretary.
- Having Elementary and High School students come up with other ways to pay for field trips.
- Reducing clerical overtime.

- Reducing extended contracts.

- Reducing high school athletics/co-curriculars; eliminate middle school sports/co-curriculars; eliminate elementary sports. This includes clubs and at the high school level freshman, sophomore and JV sports.

- Eliminating the curriculum director.

All of these cuts will save the district \$540,024, leaving them with \$26,963.

A major concern brought up by members of the committee was by making these cuts to sports and clubs, why would students want to come to our district? They were afraid that by cutting sports and clubs more students would opt for open enrollment and attend other schools.

Clubs and positions to be cut at the high school include: weight room advisor, student government,

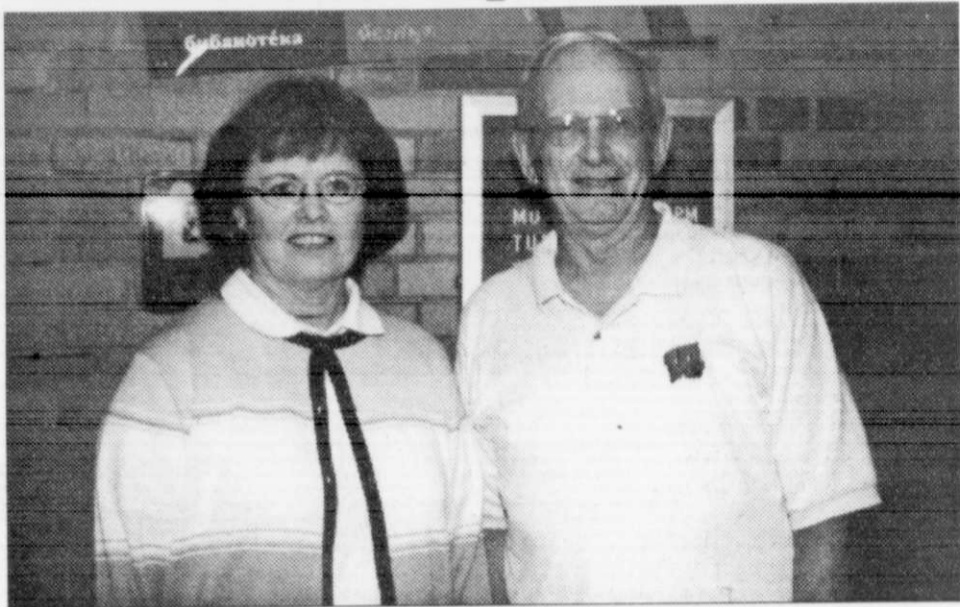

As of press time, he was in serious condition in ICU at the hospital.

Placing his bread on the conveyer belt, Gramps continued to watch them through the large wall of windows as they walked outside. But no sooner had they gotten beyond the expansive overhang of the building than the clenched hands were opened and the balloons lifted.

Gramps wailed, "Oh, no!" as he went darting out the door. Reaching them, he continued to lament, but no one seemed to hear. be privacy-covered with cedar or decorative material in which animals may be temporarily housed.

◆ The number of animals to be boarded, will be no more than thirty.

◆ The Kewaskum Veterinary Clinic, will apply for a kennel license annually as well as generic 30 animal licenses (dog and/or cat).

The Morrissey Law Office that currently operates in the lower level of the clinic will be moving at the end of their lease. Ogi stated that at that time he will decide whether he will occupy the space himself or pursue a business that will be complimented by his clinic to occupy the space.

As far as his current

location Ogi says he is open to leasing or selling the property as soon as he is settled in his new location.

Local Teen Faces Charges for Family Disturbance

A Washington County deputy responded to St. Kilian Drive residence in the Town of Wayne on Tuesday, April 9 at 8:35 p.m. for a domestic abuse situation that had occurred 45 minutes prior.

While the reporting officer was traveling through Kewaskum he was informed the suspect had left the residence and was going to his apartment in Kewaskum.

The deputy then went to the suspect's apartment and waited for backup. He was joined by a Kewaskum officer and later by Sheriff Jack Theusch, the department's captain, a lieutenant and other deputies then kept watch over the apartment. Kewaskum police chief Richard Knoebel was also called and responded to the scene.

The responding officer then went to a Kewaskum residence to speak to the original complaint and victim. He and his wife were at the home of a family member who resides in the village.

Allegedly the suspect had been working on the family farm for the day and at one point left and went to his apartment in Kewaskum. He returned to the farm later in the evening and an argument ensued between the complainant and suspect.

The suspect allegedly grabbed an aluminum bat and swung at the victim and missed. He later hit six cows with the bat and threw it in an unknown direction and went to the farmhouse for a gun. He returned to the barn and threatened to shoot himself. The complainant and his wife fled

the barn and the suspect went out of the barn and discharged the gun into the air. The suspect and his girlfriend then left for the apartment in Kewaskum.

After questioning the victim and his wife the deputy joined other members of the sheriff's department and tried to gain entry to the apartment.

The suspect at one point did try and escape through an upper window.

A key was retrieved and officers arrested the suspect. He became ill and Kewaskum Rescue Squad was called and transported him to St. Joseph's Community Hospital in West Bend.

He is being charged with one count of disorderly conduct, one count of mistreating animals and one count of negligent handling of a weapon.

The suspect is scheduled to be in Washington County court on April 29 at 9:45 a.m. for a hearing on the charges against him.

'Walk a Mile Club' Goes the Distance

The Restorative Nursing Assistant team, CNAs and nursing staff at Cedar Lake Health Care Center have received a Best Practices Award from the Wisconsin Department of Health and Family Services, Bureau of Quality Assurance. Their program, the "Walk a Mile Club" will be placed on the BQA's Nursing Home Best Practices website, www.dhfs.state.wi.us/rl_dsl/nhs/nhbestpracts.htm.

The Best Practice Program is a collaborative project between the BQA and consumer, professional and industry representatives. Its mission is to compile a repository of innovative practices and guidelines that are "improving the quality of care and life for nursing home residents."

Cedar Lake's Walk a Mile Club was created to encourage residents to increase ambulation and, consequently, enjoy increased endurance, balance and independence. Successful participants also would benefit from the boost in self-esteem associated with achieving their goal of walking one mile.

Progress was tracked and displayed on one large poster in a common area, as well as individual posters in each participant's room. Both posters depicted a large, mile-long oval track, broken into 100-foot sec-

tions. Bright stickers moved along the tracks, representing the participants' weekly progress. When the program was completed, family members, staff and administrators threw a party in the participants' honor and awarded Certificates of Completion.

Of 36 residents participating in the program, 31 completed it. Residents continue to walk, with one participant going on to complete 10 additional miles. Staff has seen great improvements in residents' health and well-being due to their increased activity. "It takes so little time to work on the tracking tools and to help the residents walk," said Kathie Worthman,

assistant director of nursing. "It's a simple program to run at a minimal cost, and families and staff really value it."

The health care center is a division of the Benevolent Corporation Cedar Campuses, a regional leader in providing superior health care, education, rehabilitation and senior housing. Cedar Campuses also has been named the West Bend Chamber of Commerce's 2001 Largest Business of the Year.

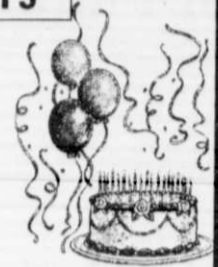

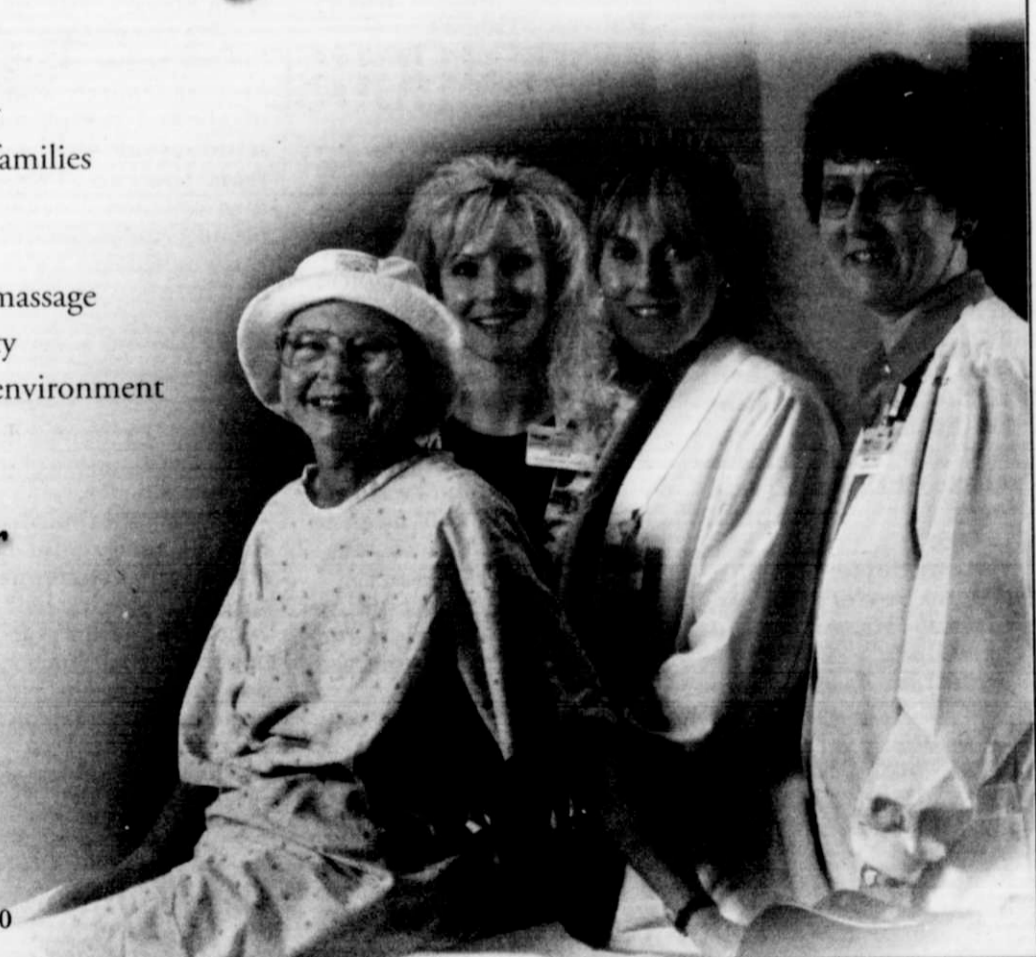

Dear Town of Auburn Residents:

Many people are very misinformed about matters concerning the town. I would just like to share with you some facts about the role of a town treasurer.

The town treasurer has no power on the board (State Statutes 60.20(1)). After the town treasurer's report is read at the board meeting, the town treasurer's job is done with the town board. The town treasurer has no power to discuss town matters with town board members. The treasurer must follow the same rules as the town of Auburn residents, to sit in the audience, to address the board on town matters.

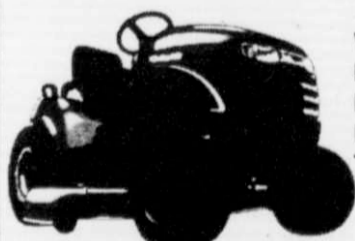

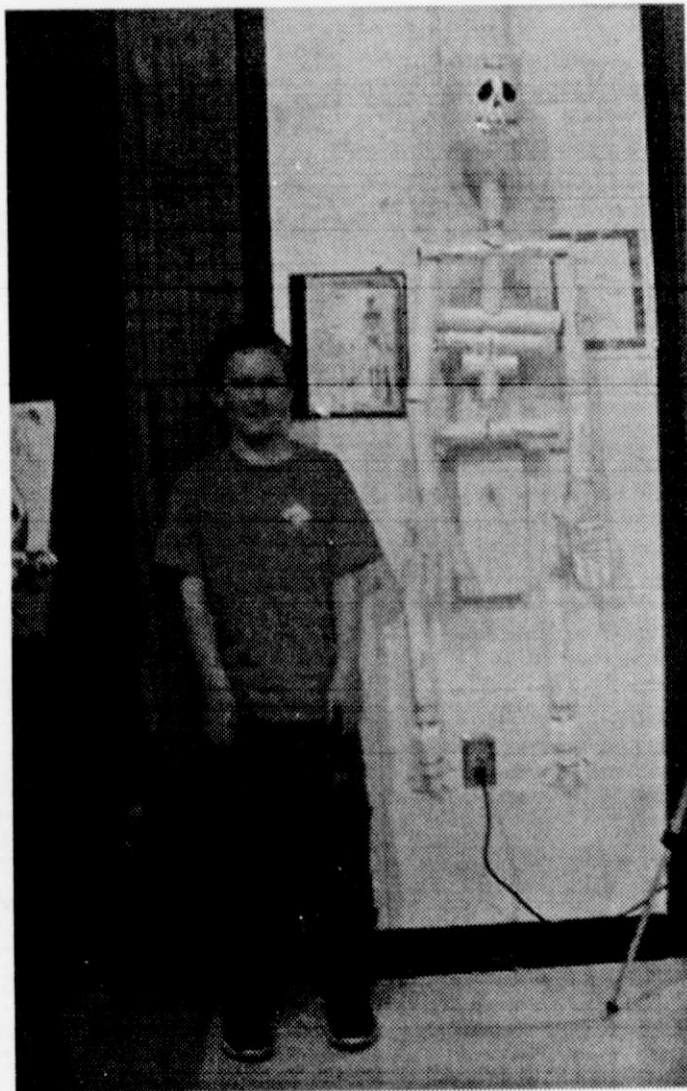

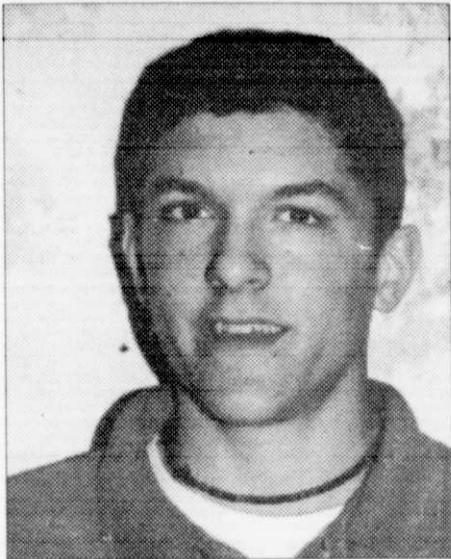

Hello friends,

My golden retriever, Pearl, is in the last days of her pregnancy. I am trying to stay close to home with my outdoor activities and still put out an interesting column.

Tuesday, April 9
High 52-, Low 35-

Last night I attended the Conservation Congress meeting in Marquette County along with 322 other outdoor enthusiasts. This beat last year's attendance of 255.

The rumor of an anti-hunter running for the board proved to be just a rumor, and I was impressed by the very well-mannered and knowledgeable sportsmen and women that took the time to vote and voice their opinion on the issues concerning hunting, fishing and the preservation of our outdoor sports.

On Saturday, a friend and neighbor of mine showed me a good spot to catch walleye from the shoreline of the Yellow River, which begins in Wood County and empties into Castle Rock Lake in Juneau County. We hiked half a mile through an oak forest on public land, and by day's end, we had landed eight walleye.

Well aware that warm weather was on its way, I

figured the true walleye run was just days away. I scheduled an overnight trip fishing and sleeping in my boat on the Yellow River for today.

The rest of this column is a series of blunders made by yours truly.

High 59-, Low 39-

Not a bite did I have last night. My luck changed in a positive way this morning when I almost called in a turkey and caught four walleye measuring 16-19 inches.

The sun shone even brighter over Star and me when the old Johnson fired up on the first pull. Thus a happy ending was had by one and all.

briefed the Village Board on the status of the states proposed budget fix. It is still being proposed to eliminate state shared revenue over 2003 and 2004, which would equal a loss of \$370,640.00. The State has indicated village spending has rose 99.1% during 1990 2000 or an average of 7.1%. The Village of Kewaskum, during that same period, has seen their cost rise by 80.0%, an average of 1.57% a year. The reason for these increase as per the state are the cost of inflation (state average being 31.8%) and population growth (village state average being 13.2%), while the Village of Kewaskums population grew 20.4%. If the village then totals the inflation 31.8%, then population total of 20.4 % as well as the loss of shared revenue during that same period of time at 17.0% would equal 69.2%. This would leave 10.8% to growth in value and providing services to that growth. The Village of Kewaskum during this same timeframe had their values grow by 128.1% and even if we then subtract the inflation rate of 31.8% that leaves us with a growth of 96.3%. The villages growth in value grew 9 times of that of the levy to cover the cost of those services.

Resolution Opposing Governor McCallums Budget Reform Bill

WHEREAS, the levying of Ad Valorem property taxes is a local issue in Wisconsin; and

WHEREAS, Ad Valorem property taxes are used to fund the cost of local services provided by Wisconsin municipalities, not the cost of State Government; and

WHEREAS, the levying of Ad Valorem property tax is under the direct control of the citizenry through their duly elected municipal officials; and

WHEREAS, interference by the state in the levying and use of Ad Valorem property taxes violates the Home Rule doctrine; and

WHEREAS, the Governors budget Reform Bill proposes to immediately freeze property tax levies while eliminating all state shared revenues prior to December 31, 2004; and

WHEREAS, this plan will adversely affect the quality of life of the citizens of our municipalities; and

WHEREAS, Wisconsin municipalities are burdened by Wisconsin statutes which arbitrarily increase the cost of local government, specifically public bidding laws, and interest arbitration, none of which would be altered by the Governors plan; and

WHEREAS, the current fiscal problems affecting the State of Wisconsin are of the States own making through its imprudent budgeting and financing of the State share of the cost of local education and not the result of increased funding for municipalities;

NOW THEREFORE BE IT RESOLVED that the Village of Kewaskum strongly opposes Governor McCallums Budget Reform Bill; and

BE IT FURTHER RESOLVED that the Village of Kewaskum, calls upon the Governor and State Legislature to recognize the authority of duly elected officials of Wisconsin Municipalities to manage their communities as their citizens require and deserve; and

BE IT FURTHER RESOLVED that the Village of Kewaskum calls upon the Governor and State Legislature to cease interference in the use of the local Ad Valorem property taxes for the funding of local needs; and

BE IT FURTHER RESOLVED that the Village of Kewaskum calls upon the Governor and the State Legislature to develop a more prudent plan which spreads the impact of budget reform to all areas of government, including the reduction of State Shared Revenues, without the imposition of restraints upon Wisconsin municipalities and their elected representatives; and

BE IT FURTHER RESOLVED that copies of the Resolution be sent to the Governor and the State legislative delegation representing the community and to the League of Wisconsin Municipalities; and

BE IT FURTHER RESOLVED that the Village of Kewaskum offer their efforts to meet the objectives of the Governor and the State Legislature in reducing the heavy tax burden in the State of Wisconsin while at the same time meeting the needs of the citizens of our communities.

Resolution Adoption of Amendment to the Washington County Jurisdictional Highway System Plan

WHEREAS, in 1975, the Washington County Board of Supervisors adopted the jurisdictional highway system plan set forth in Southeastern Wisconsin Regional Planning Commission Report No. 23, A Jurisdictional Highway System Plan for Washington County; and

WHEREAS, in 1990 the Washington County Board of Supervisors adopted an amendment to the aforementioned jurisdictional highway system plan set forth in Southeastern Wisconsin Regional Planning Commission Report, Amendment to the Washington County Jurisdictional Highway System Plan for Washington County - 2000; and

WHEREAS, that adopted plan and amendment were based on comprehensive study and recommended the capacity improvements and changes in highway jurisdictional responsibilities in Washington County necessary to meet existing and future traffic needs and promote the effective use of public resources in highway transportation; and

WHEREAS, at the request of Washington County board of Supervisors, the Southeastern Wisconsin Regional Planning Commission in cooperation with Washington County, each city, Village, and town within Washington County, the Wisconsin Department of Transportation, and the U.S. Department of Transportation Federal Highway Administration, reviewed and reevaluated the adopted Washington County Jurisdictional Highway System Plan, as amended; and

WHEREAS, the review and reevaluation was based on a comprehensive study, guided by a Washington County Jurisdictional Highway Planning Committee, which included representatives from Washington County, each city, village, and town within Washington County, the Wisconsin Department of Transportation and the U.S. Department of Transportation - Federal Highway Administration; and

WHEREAS, the Washington County Jurisdictional Highway Planning Committee, in preparing an amendment to the adopted plan, carefully considered the record of a public hearing held on a preliminary plan on June 27, 2001; and

NOW THEREFORE BE IT RESOLVED by the Village Board of the Village of Kewaskum that pursuant to Chapter 66.0309(12) Wis. incurred a hamstring strain last Tuesday," reported Coach Gosa.

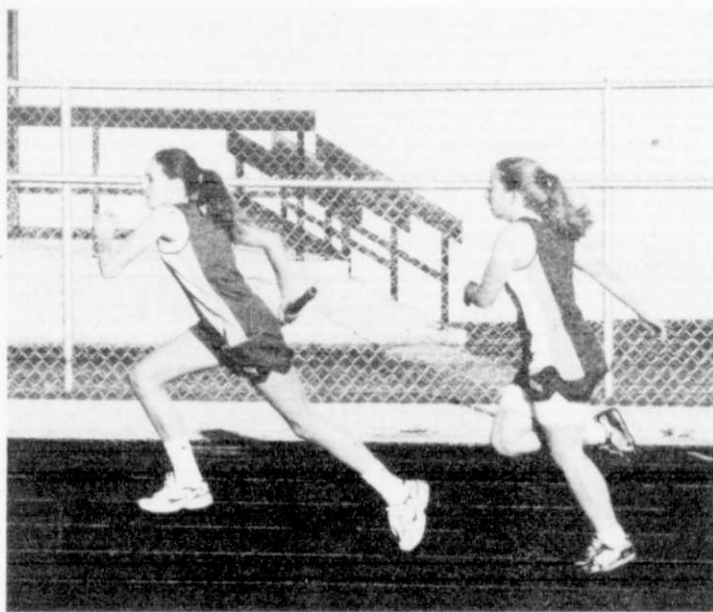

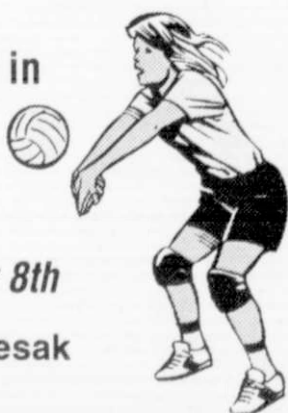

Chris Canter Wins Four Events

KEWASKUM - The Kewaskum boys' track team hosted a triangular meet with Eastern Wisconsin Conference schools Roncalli and Campbellsport on Tuesday night, April 9.

The Kewaskum boys won their first outdoor meet of the season with 114 points and Roncalli finished second with 63 points. The triangular meet ended up being basically a dual meet because Campbellsport only sent their JV boys to the meet. Campbellsport managed only six points.

The Kewaskum boys dominated the meet winning 15 of 17 events and finished 1-2 in six of those events.

Hartman won the 110m high hurdles in 17.2 seconds and the 300m low hurdles in 45.0 seconds, while Koefel won the shot put with a career best throw of 50'1" and the discus with a throw of 122'10". David Cibulka placed second in the discus with a throw of 122'3".

Kewaskum won three of the four relays. The 4x200m relay team of Hartman, Tom Ogi, Andy Lickel and Tony Fitts won with a time of 1:37.0 and the 4x100m relay team of Josh Uelmen, Ogi, Lickel and Fitts won with a time of 46.7 seconds. Ogi also won the tiebreaker in high jump at 5'4" over

teammate Kyle Rabuck who also cleared 5'4".

The 4x400m relay team of Hartman, Lickel, David Wicklund and Josh Meyer also won with a time of 3:47.

Kurtis Cochran won the tiebreaker in the pole vault at 9'6" over Peters of Roncalli.

Josh Meyer and Chris Baker went 1-2 for the Indians in the 1600m run with times of 5:01.2 and 5:05. Alex Herriges and Tom Ramthun also went 1-2 in the 800m run with times of 2:18.0 and 2:22 respectively.

Bryan Kraft finished second in the 3200m run with a time of 11:34.

The 4x800m relay team of Ramthun, Kraft, Meyer, and Baker finished second to Roncalli with a time of 9:02.06 compared to 8:52.4.

"We definitely had good efforts by the boys' team. Koefel going over 50 feet in the shot put for the first time is great, and Canter's 52.3 in the 400 is very good for this early in the season. Relays need work and everybody needs to keep working hard in order to keep improving. We thought we were hosting a quad and then Slinger didn't show up and Campbellsport only sent their JV boys' team. A quad would have provided more needed competition. Good competition only helps you get better and we know that we definitely need to get better if we are going to
