## BFD Responds to FES



Farmington Elementary School was evacuated for a second time Friday morning because of an unknown odor making students and staff ill. Kewaskum's superintendent of schools Wayne Graczyk stated that students were removed via bus and transported to Kewaskum Elementary where they were picked up by their parents. Two secretaries were treated and released from St. Joseph's Community Hospital in West Bend. The cause of the incident is suspected to be a change made to the computerized regulator that controls air return. Boltonville Fire Department members checked the school again Friday and found nothing. Superior Services, an environmental firm found nothing. A test was conducted by turning the regulator back to its factory settings. The test was completed Monday and the problem was then corrected. School resumed Tuesday morning.

The Kewaskum School District has finally sold Beechwood School for \$70,000. Buyers Randal and Kimberly Narbatovics of Adell closed on the former school last Thursday.

The school was put on the market last June with an asking price of \$175,000 after being closed in 1985 due to low enrollment. This was the second highest offer the district received. The highest offer had a clause that the offer would be void if any major defects were found.

Narbatovics's father bought the first Beechwood School and remodeled it to be his home. Randal and Kimberly plan to do the same. They plan to use the library for living quarters and move the books to another room. They would like to keep the library and gym open for community use.

The board will discuss what to do with the money at the next board meeting on June 10.

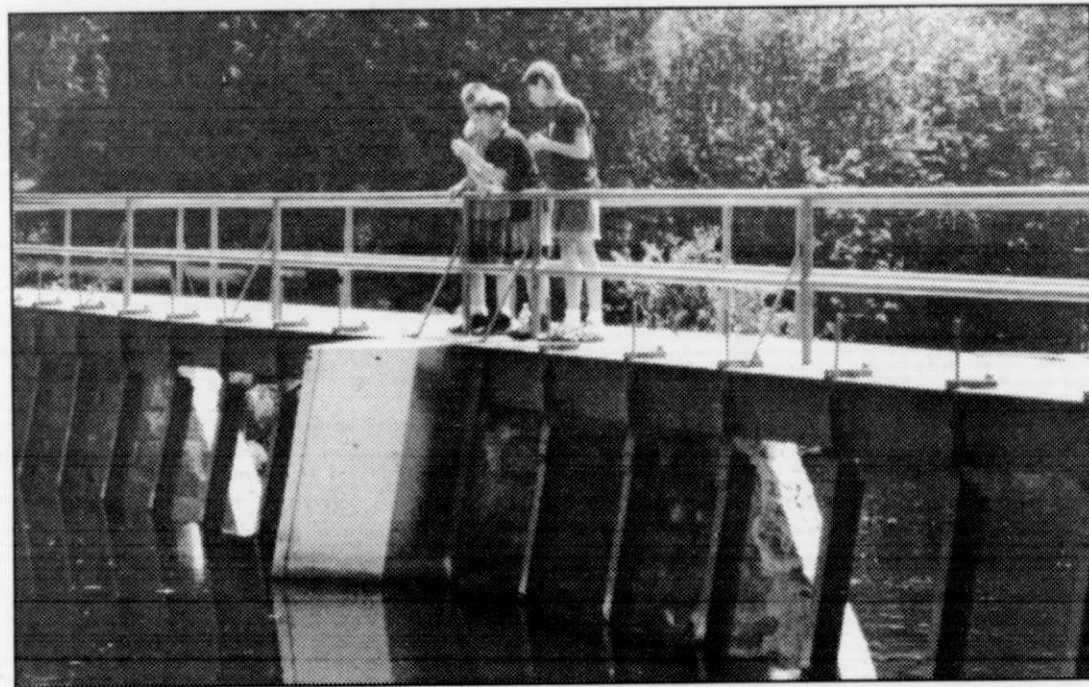
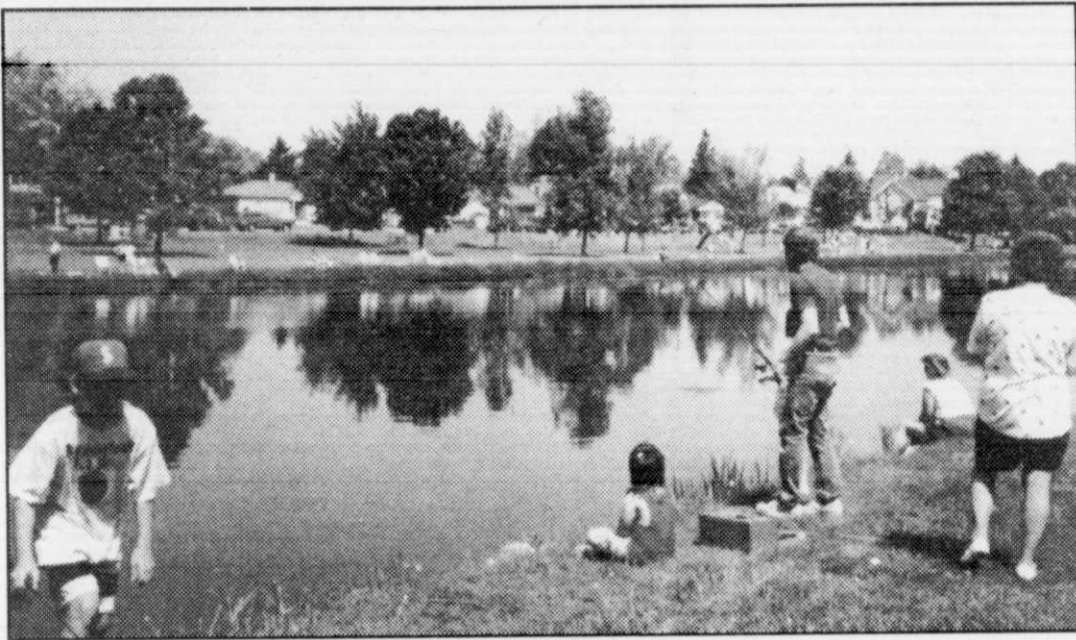

## Village of Kewaskum NEWS NOTES

### RECYCLING TIPS

#### CORRUGATED CARDBOARD

**Type of Corrugated Cardboard:** The cardboard that peels apart with two outside layers is corrugated. The middle section not exposed is wavy or corrugated.

**Colors:** Some waxed and pressed cardboard may also be recycled.

**Preparation:** Flatten boxes and cut into 2'x2" pieces. Tie in bundles with twine or strong string. Bundles should be limited to 8" in height.

Place bundles at the curb next to the dark green recycling bin or blue recycling bag. Place the bin or bag at the curb on the same day that your solid waste is to be collected. Pick up will be Wednesdays for both solid waste and recyclables. Multi-family dwellings of six or more, remember, your recycling pick up will be the 1st and 3rd Wednesday of each month.

**NOTE:** If raining on collection day, please hold cardboard until the following week.

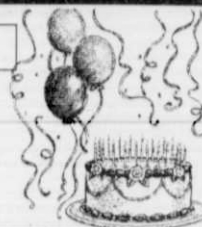

## Three Car Crash on Highway V

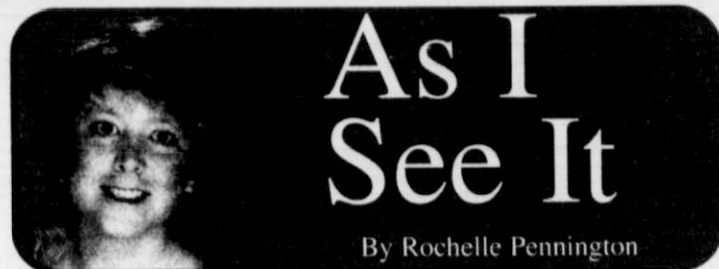
Auditions will take place in the Random Lake High School Auditorium. Ages seven to 13 are scheduled from 5:30-8 p.m., while ages

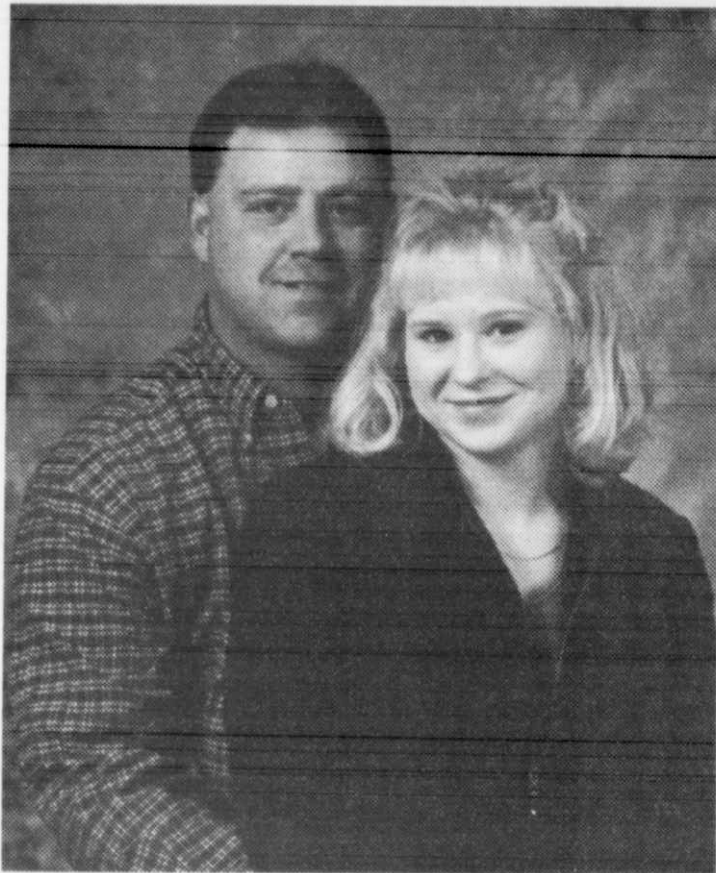

## Education... It's Everyone's Business

### Why Won't They Come to Kewaskum?

I arrived in Kewaskum nearly three years ago and must share that I heard many negative things said about the School District, whether real or perceived or based on past happenings. However, I have found the Kewaskum community, and school district, to be simply outstanding and a great community to educate children. Now I could be accused of being biased, but I have found the opposite. Our schools are well accepted and respected by those living here. That's my point.

Those living in the district, who have their children in our schools, find them to be excellent. However, there is a startling bit of information I would like to share with our readers, particularly since it costs the district a much needed revenue source. This loss of potential revenue has to do with the State's Open Enrollment Program. Parents, by law, are allowed to complete an application form to have their children reside in one district, and attend school in another. You may have read how the Kewaskum School District had 72 children leave our district in 2001-02 and another 51 new applicants applying to leave in 2002-03. The fact that people don't know is that only 8 actually left the Kewaskum district for another. Eight! This tells me that parents who are already in the district keep their children in our schools. Then why do we keep hearing that 72 students left the district this year and another 51 next year? Allow me to explain.

When you hear or read that Kewaskum is losing students, keep in mind that they may not have ever attended school in our schools. For example, of the 51 new Open Enrollment applicants for 2002-03, only six actually left the district. Twenty-three, having moved into the Kewaskum district, chose to remain in their prior district, 18 attended parochial/private schools and continued in other similar schools outside the district, and four others would have been incoming kindergartners. Of the 72 "leaving" this year, only 2 actually left our district schools.

That means that this year we had six students leaving our district to attend other school in other districts, but 45 chose not to send their children to Kewaskum. The question is to determine why. On one hand, the good news is we

don't have a mass exodus from our district, contrary to published reports, but the bad news is we have a significant number of parents choosing not to send their children to Kewaskum. In the Open Enrollment program, most of the state aid money follows the child transferring out of their resident district (approximately \$5100 per child). This means this year alone, as we struggle with a \$1M deficit, we project an estimated loss of over \$225,000 in lost revenue, money that would have remained in the district if the students had chosen Kewaskum. We need to find a way to encourage parents and children alike to want to attend school in the Kewaskum School District.

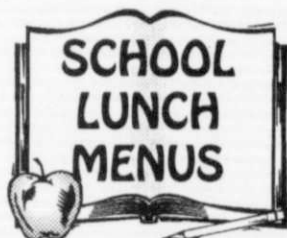
Our new Kewaskum elementary school and remodeled Wayne and Farmington schools have brought a new sense of pride to the community members and parents in the school district. We have taken great strides in increasing our technology capabilities for all students. Our high school technology program has gained statewide recognition for the classes and programs they offer our students. Our art program remains one of the best in the area, if not the state. Our athletic teams have had solid successes in conference level play and at state competitions. Our 4-year and 5-year old kindergarten facilities are simply outstanding. Our administrative/community building has received more than its share compliments from those who have used it or been in it. Our curriculum has been tightened and aligned to state standards.

We, you and I, must do everything necessary to encourage parents and students to want to attend school here in Kewaskum. This won't be done through misinformation, negative headlines in the paper, negative Letters to the Editor, speaking in negative terms about something in the district. If you have a complaint, go to the source. Voice your concerns to the proper people. For three years I have worked hard to create a positive image for the district but I need your help.

There are reasons parents choose not to send their children to Kewaskum and we must ask "Why?" Is it facilities, or lack of quality facilities? (We have brand new elementary schools and a district office and it has promoted many positive

feelings in our students and parents and hopefully the community at large). Would a few high school/middle school influence a parent/student's decision in attending school here? Is it the past history/reputation of the District, whether perceived or real? Have we done a good enough job of selling our district?

We are a part of a very important team. When 45 parents have the option of sending their children here, and don't, we need to stand up and take notice, and act. I know the new elementary school and remodeled schools have enhanced interest in our school district. Do we need more? Are we speaking positively about our schools or are we taking them for granted?

## Buy a Brick, Build a Memory

The Kewaskum Elementary School Parent / Teacher Organization is in the process of building a multi-functional space at the new elementary school. The area is to be to the southeast side of the school. The area will be called the "Richard Zarling Bell Tower."

The purposes of the space are:

- To remember Richard Zarling, past principal of KES. He was employed with the district for 36 years. He was also involved with the Kewaskum Auxiliary Police, was the Kewaskum Village Zoning Administrator and a member of the Kiwanis Club. In 1996, Mr. Zarling presented the children of the Kewaskum Elementary School with a bell that was removed in 1924 from the first village elementary school. The bell will be incorporated into this space.

- To remember the first Kewaskum High School, which was constructed and finished in 1924. The old elementary school was the first high school in this community and graduated many area students. Last year the building was torn down to make room for the new elementary school. The original date stone, from the old high school, will be incorporated into this space.

- To create a space for the community to reflect and classrooms to learn. As you can see in the drawing above, the space will have four benches and a bell tower. A paved area will host bricks with the names of past graduates, friends and current students.

Bricks are 4x8 and are available for \$40 each. They can include up to three lines with 14 characters per line including spaces.

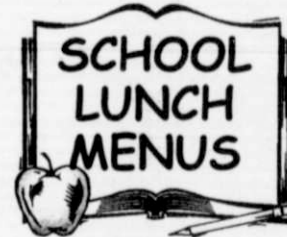

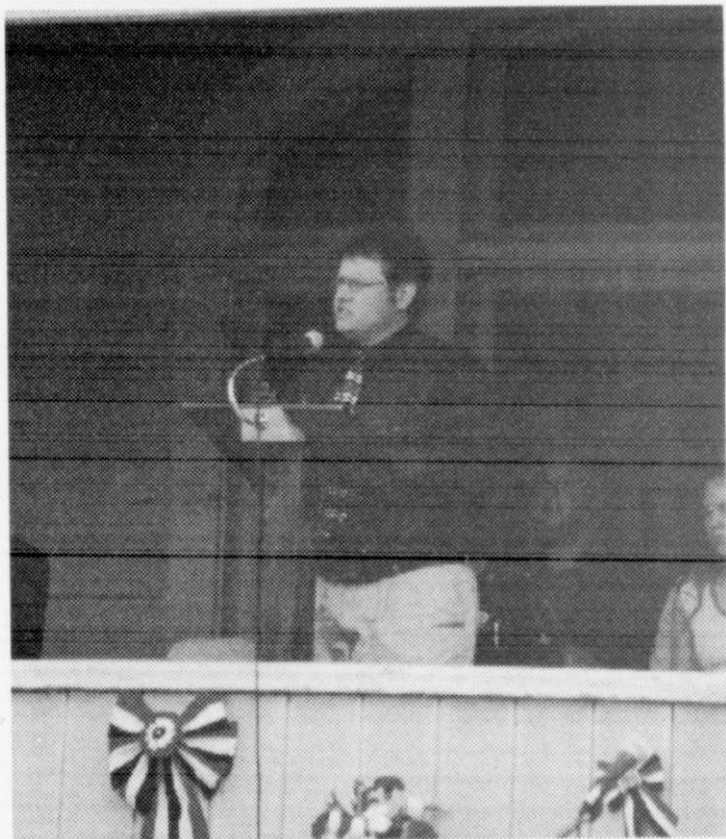

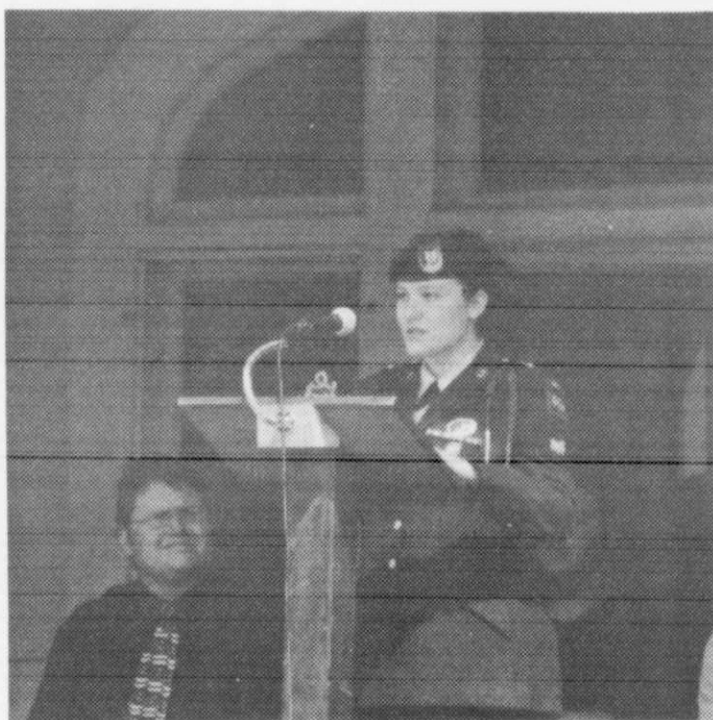
Shown left to right, Adam Smith, Bethany Hermann and Kyle Lickel perform a patriotic tune for the Fillmore crowd

# KHS Track Athletes Advance to State

NEW BERLIN WEST - The Kewaskum High School track and field team advanced 10 athletes from Sectionals to the state track meet at UW-LaCrosse, Friday-Saturday, May 31-June 1. The first three finishers in each event qualify for state competition. Individuals and relay teams whose performances in Sectionals rank among the eight best of all Sectional performances, including winners and runner-ups also qualify for state competition. Both the KHS girls and boys teams each finished sixth in team scoring.

Jenna Roecker finished second in the finals of 100m high hurdles with a time of 15.9 seconds. Earlier in the preliminaries, Roecker ran a time of 15.7 seconds to equal the school record time set by Carrie Wiesner in 1996.

Jessi Graham placed second in the pole vault at 9' 3" and broke her own school record of nine feet even that she had set earlier this season. Lindsey Doedens of Grafton won the pole vault with a jump of 11' 5". Graham and Krista Moroder, also of Grafton, both made 9' 0" on their first attempt without any misses in the competition and were thus tied. Both then failed to clear 9' 6" on three attempts. After Doedens won the competition, both Graham and Moroder each were given another attempt at 9' 6" in attempt to break the tie and both missed their attempt. The bar was then lowered to 9' 3" and both cleared the bar on their first attempt. The bar was then raised back to 9' 6" and both missed and then the bar was lowered back down to 9' 3" again and both cleared the bar. The WIAA Field Event judge then flipped a coin to break the tie and Graham won the flip for second place.

The Kewaskum girls 4 x 400m relay team of Becky Herriges, Jessi Graham, Jenna Roecker, and Breyan Donath finished second in a very exciting race taking five seconds off their season best with a time of 4:08.6. "The girls all ran with a lot of heart and great focus," reported head coach Jerry Gosa. This is the second year in a row that this relay team has qualified for the state track meet. Last year this same relay team placed eighth. Eastern Wisconsin Conference opponent Kiel won the 4 x 400m relay with a time of 4:06.4.

Jolene Clark placed third in the high jump with a season best height of 5' 2". "Jolene cleared 5' 2" by over two inches. She jumped very well tonight," reported an excited coach Bill Cain, the KHS jumping coach.

placed third in the shot put with a throw of 36' 6" and thus qualified for state. "Coco missed qualifying for state last year by one inch. We are always very happy for our seniors when they make it to state and sad for those seniors that don't make it," reported head coach Jerry Gosa.

The Kewaskum boys 4 x 100m relay team of Josh Uelmen, Tom Ogi, Matt Hartmann, and Tony Fitts finished third with a season best time of 43.8 seconds to qualify for the state track meet. This is the third year in a row that the Kewaskum boys team has qualified their 4 x 100m relay team for state. This is also the third year in a row that Fitts is a member of the state qualifying 4 x 100m relay team. In 1999, Chris Canter, Tony Fitts, Jim Thelen, and Charlie Sparks finished fourth and in 2000 the relay team of Canter, Fitts, Kevin Miller, and Sparks won the event and became state champions.

Tony Fitts placed fourth in the long jump with a career best jump of 21' 1", just one spot out of qualifying. However, late in the afternoon on Friday results of the four sectionals on the WIAA Web site showed that Fitts had made it as an extra qualifier. His jump of 21' 1" ranked him seventh among all the long jumpers in Division 2.

Both Matt Hartmann and Mike McKee just missed qualifying for state as Hartmann finished 4th in the 300m hurdles in 40.8 seconds, and McKee placed fourth in the pole vault at 12-0. Chris Canter also missed qualifying for state as he finished fifth in the 220m dash in 23.3 seconds, 6th in the long jump at 20-9, 7th in the 100m dash in 11.3 seconds, and seventh in the 400m dash in 51.4 seconds.

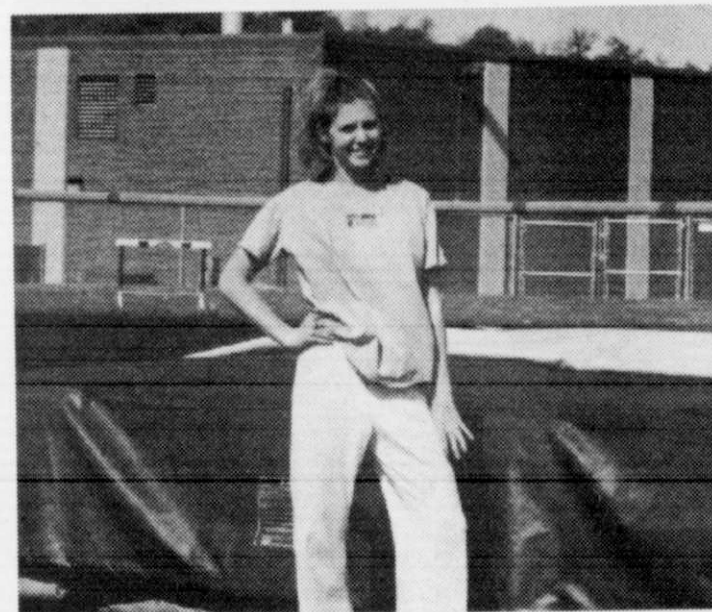

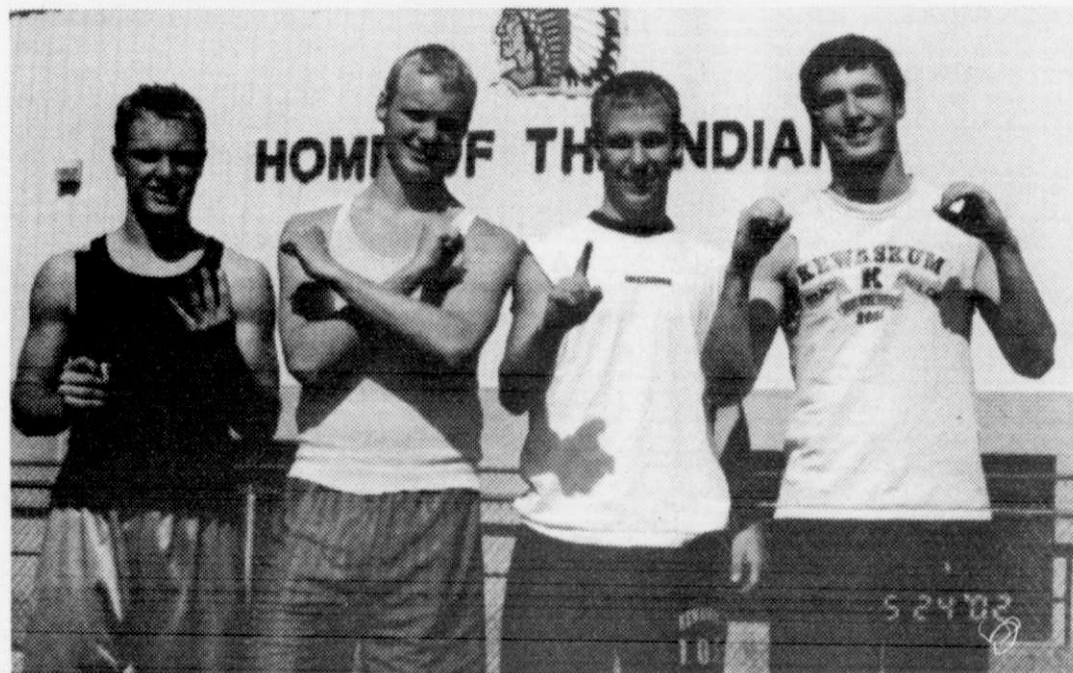

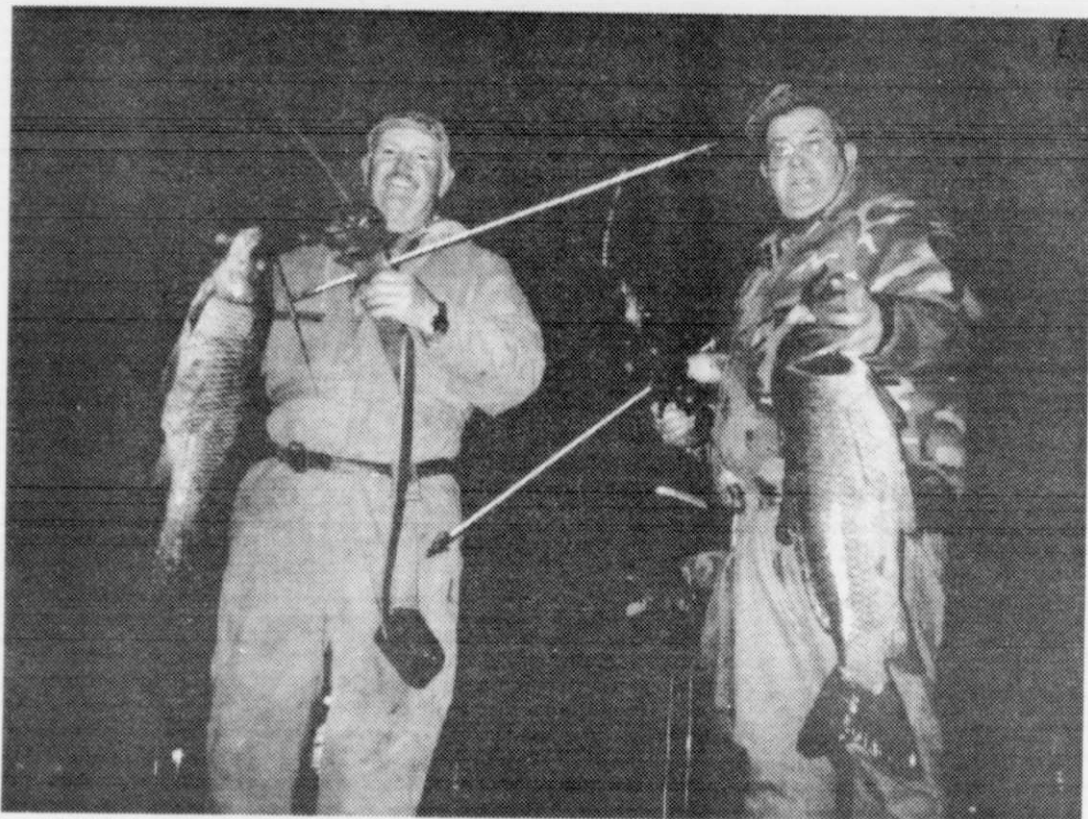

## Night Time is the Right Time

Hello friends,

Last August, I had the pleasure of bow fishing for carp after dark for the first time. Fred Christen, owner of F and D Archery in Osseo, is an avid after-dark fisherman and member of the Wisconsin Bow Fishing Association.

When Fred invited me shoot, along with his partner, Lonnie Klundby, in the WBA State Championship, which was being held on Castle Rock Lake, I was quivering with excitement for the big night.

**Tuesday, May 14**  
**High 64, Low 41**

Today, I met Lonnie for the first time. Fred is the man that introduced me to this sport last August. Tonight, we pre-fished Castle Rock, just like the bass or walleye angler would for an upcoming tournament. Our goal was to locate as many fish as possible, and get this rookie some after-dark bow fishing experience.

Fred set me up with a Renegade Fish Master compound bow, which is the same model he uses. Lonnie, whom I found out is a meat

maker, was shooting a 45-pound Shakespeare recurve that is probably older than I am.

Today's experience began mid afternoon and lasted until just after midnight. We found carp in a feeder creek that had clear water.

We also found literally millions of carp in some backwater marshes. The water was so muddied up that we couldn't see them to shoot them.

Destruction of lake habitat is why carp are considered a rough fish, and millions of dollars are spent each year across the country to eradicate them.

The rookie shot three fish for 20 arrows flung then proceeded to really embarrass himself his partners advised him to forget about the sights and shoot natural.

I shot six carp in the last hour and was happy we had pre-fished.

**Saturday, May 18**  
**High 50, Low 28**

Today would be a big learning experience for me. Once again, we scouted before dark. The tournament began at 8 p.m. and

lasted until 6 a.m.

After our scouting adventure, we had a couple of hours to watch as a total of 24 two- and three-man teams arrived for the big tournament of the year.

Since last August, Fred has put a 42-inch fan on his 18-foot boat. It's powered by a 22 hp motor, can turn 360 degrees and along with his 70 hp outboard and 74-pound thrust trolling motor, can push his rig just about anywhere he wants to fish.

About half of the rigs have a fan. I observed bow fishermen from Wisconsin, Illinois and Iowa fishing in boats valued between \$500 and \$30,000.

I also saw passion for this sport in the eyes of each bow fisherman as they talked about boats and trips.

If these guys aren't in a tournament in Wisconsin, they're after monster gar in Texas or paddlefish out west.

Just to stand over the bow of a boat, watching the water being illuminated by a half dozen 500 watt halogen lights from dusk until after dawn takes a person

with a strong backbone.

Twenty-four boats hit the lake at 8 p.m., fishing in two classes, sportsman and open, with 14 teams in the sportsman, which was the class we entered in.

The clear water we had fished Tuesday was fishless due to a cold spell, so we hit the muddy marsh.

When we found water less than 18 inches deep, we could actually see fish. By 11 p.m., we had 35 carp in the buckets.

The team that won this tournament last year finished with 330.

The cold spell and muddy water was saving the lives of hundreds of carp. I couldn't believe it when at 3:15 a.m., the night started showing signs of daylight.

I felt like I wanted to bow fish for another 20 hours. At 5:15 a.m., we started our six-mile journey back to the landing. We had 75 fish on board, which gave us fifth place in the sportsman division.

Sam Wood and his crew from Milwaukee won with 232 fish. The open division was won by Doug Engel, Joe Pease and Josh Pease from Wyocena.

The Pentenwell and Castle Rock Association was on hand to pay 25 cents for each fish harvested. This rookie bow fisherman was impressed by this sport and the members of the Wisconsin Bow Fishing Association.

## KHS Boys Track Team Wins Regional

RANDOLPH - The Kewaskum High School boys track and field team amassed 150.5 points to win the WIAA Regional at Randolph on Monday night, May 21st on another cool and windy day. Mayville placed second in team scoring with 134 points.

Kewaskum advanced a total of 16 athletes in 13 different events. Kewaskum had two individuals qualify in the long jump, pole vault, discus and 800m run.

Chris Canter led the way for the Indians winning the 100m, 200m, and 400m dashes and also qualifying in the long jump with a fourth place finish. The top four individuals and relay teams advance to sectional competition on Thursday at New Berlin West High School.

Canter won the 100m dash with a school record breaking time of 10.8 seconds. The old record was held by Mike Steinhardt set back in 1985. The regional win was the first for the Kewaskum boys team since 1985. Canter won the 200m dash with a season best time of 23.0 seconds and the 400m dash with a time of 51.7 seconds.

Troy Koefler won the shot put with a throw of 49' 3" and also placed fourth in the discus with a throw of 129' 10". David Cibulka placed second in discus with a personal best throw of 138' 11".

The Kewaskum 4 x 100m relay team of Josh Uelmen, Tom Ogi, Matt Hartmann, and Tony Fitts won with a time of 45.0 seconds and Mayville finished second with a time of 45.4 seconds. The Kewaskum foursome had to regroup after an apparent win and disqualification in the 4 x 200m relay earlier in the meet. "They ran their fastest time of the season by almost three seconds in the 4 x 200m relay only to be disqualified," reported coach Jerry Gosa.

"The official said that the outgoing runner was out of the zone. It was definitely close, but the rule states that the baton must be exchanged within the zone. Kewaskum felt that when our runner stopped at the end of the zone, extended his arm back, and received the baton, that the baton was still within the zone. They were definitely disappointed. They only had to finish in the top four to advance," concluded coach Gosa. Kewaskum won both the 4 x 200m and 4 x 100m relays at the state meet last year.

Kewaskum's Matt Hartmann and Cambellsport's Jon Fenrick finished in the same order in the 300m intermediate hurdles

as they did in the conference meet. Fenrick of Cambellsport won with a time of 41.1 seconds and Hartmann finished second with a time of 42.0 seconds.

Chris Baker finished second in the 800m run with a time of 2:10.3 and teammate Alex Herriges finished fourth with a time of 2:13.5 to both move on to sectionals.

Mike McKee and Kurtis Cochran finished second and third in the pole vault with vaults of 12' 3" and 12' 0" respectively. Cochran's height of 12 feet was a personal best. Christian of Mayville won with a vault of 13 feet.

Tony Fitts and Chris Canter both moved on to sectionals by placing third and fourth in the long jump with jumps of 19' 7" and 19' 3" respectively. The winning jump was 20' 2 1/2".

Meyer also qualified in the 1600m run with a fourth place finish with a time of 4:49.6

Mike Wagner finished fifth in the 110m high hurdles with a time of 16.9 seconds. Tom Ogi placed fifth and Brian Cotter tied for sixth in the high jump. Both Kewaskum jumpers cleared 5' 8" with number of misses determining their place.
