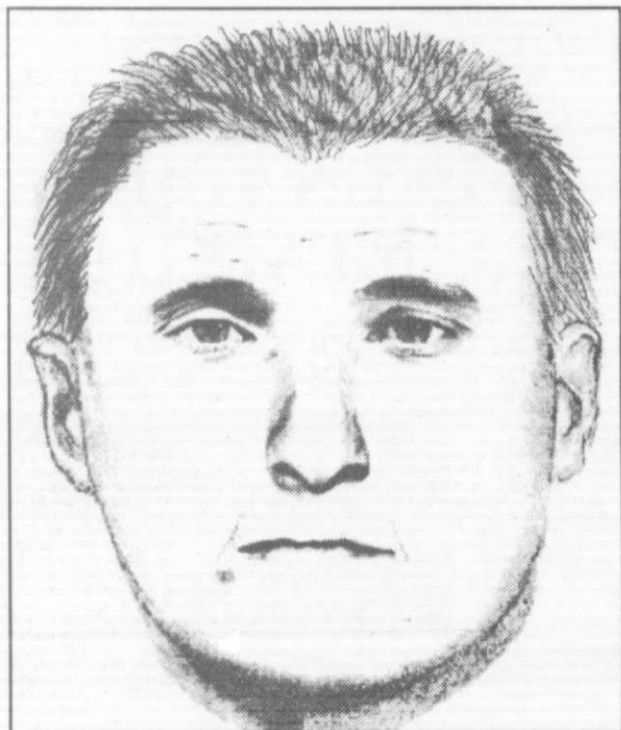

FBI Aiding FDL Sheriff's Department In Attempted Abduction Case

The small rural community of Ashford was shocked Monday morning after the Fond du Lac Sheriff's Department received a report of an attempted abduction of a 16 year old girl who was riding her bike on State Highway 67, at 10:42 a.m..

The girl reported that a truck had passed her while she was riding up a hill and then she saw it parked at the top of the hill. When she got to where the truck was parked the man yelled at her and when she ignored him, he got out of his truck and ran toward her. After he reached her, he grabbed at her arm, but she managed to get away and run for help at Urban's Grocery Store.

The vehicle is described as a square shaped pickup truck with a cap, early to mid 90's, red/maroon in color. The make and model are unknown. The cap on the back was level with the cab and was darker than the color of the truck.

The suspect is described as a white male, 30 to 40 years of age, heavy set, but not having a beer belly, no facial hair, no glasses, bleach blonde hair with dark roots cut in a crew cut style. He was wearing a blue work

type shirt that buttoned down the front, blue pants and black shoes.

Weisinger, of Campbellsport, was stopped at a stop sign at Sandy Ridge Road. She allegedly then proceeded through the intersection and was struck by an eastbound Roger G. Schmidt, of West Bend. Weisinger was injured and her daughter, a passenger required medical transport to St. Joseph's Community Hospital in West Bend by Kewaskum Rescue Squad. Schmidt and his passenger were uninjured. Another crash, an hour later in the village on Fond du Lac Avenue also injured a teen girl and tied traffic up for almost an hour. Lisa M. Amerling of Campbellsport was southbound on Fond du Lac Avenue just north of Highway H West when she rear-ended Anthony K. Simon of Milwaukee. Amerling and a passenger required medical transport to St. Joseph's Hospital. Simon stated he was stopped in the southbound lane when he was struck. He had two infant passengers. School Board Discusses Middle School Breakfast Program and Filling the Open Board Seat

The Kewaskum School Board met Monday night for their regular monthly meeting. The board decided how they would go about filling the open seat left when Andy Degnitz resigned.

They decided they would like to have a full board if they plan on a referendum and therefore did not want to wait for the April elections. They concluded that they would accept letters of intent with optional resumes through 4 p.m. on Friday, August 30. Following the deadline, the board will then meet with the applicants. The newly appointed board member would only serve the board until April and then would be up for election.

Kathy Robinson, Director of Food Services, was on hand to present the board with her idea for a middle school breakfast program. Robinson stated that she received a state grant of \$8,153 for the program. She stated that this would cover the cost of a hot/cold food cart and the cost of employees to make and hand out the meals. She stated that Mary Reilly-Kliss had started a mini breakfast program at the high school a few years ago and the new program would extend the option to more students.

The cost for the service would be 90¢ for students who take a regular lunch, 25¢ for those with reduced lunch and free for those with free lunch. Some of the items that will be on the menu are a wrapped cinnamon roll, applesauce cup, wrapped breakfast sandwich on bagel or croissant, hot ham and cheese on a bun, French toast sticks, and much more.

The menu will be printed out weekly and it will be paid for the same way as lunch is.

Jason Piittmann, Athletic Director, was on hand to present the board with a proposal to name the high school football and track facility after Mr. Ernie

Mitchell.

Mitchell served the Kewaskum School District for 40 years as a teacher, guidance counselor, interim principal, coach and athletic director. His coaching included football from 1942-66, basketball from 1942-59 and baseball from 1942-52.

Piittmann stated that in talking to community members there were a few other names that came up but Mr. Mitchell's name came up over and over and over.

The board decided to take no action on the naming of the field until next month's board meeting.

Also at the meeting, the board accepted extra-curricular resignations from head soccer coach Jim Mathia, phy. ed. department chair, teacher and middle school basketball coach Janet Molebash, so she can take a principal position with the Kewaskum School District, and Jason Piittmann as

head softball coach.

The board approved extra-curricular contracts for Dennis Gutbrod, freshmen boys basketball; Scott Rohlinger, JV girls golf; Dane'e Brinkman, cheerleading; Tracy Chrobak, freshmen girls basketball; Jim Westphal, freshmen football; Dennis Bigley, head boys soccer, and Alexander Hill, JV boys soccer.

They also approved instruction staff contracts for Thomas Krause, KHS math, Jason Olsen, phy. ed at KHS, Tiffany Zarling, KHS English, Diane Schad, 70% CD at KMS, Jason Last, HS special ed and Lynn Jambor, FES special ed.

The next regular board meeting will be Monday, September 9, 7 p.m. in the District Office. Also the Annual Meeting will be Monday, September 23, 7 p.m. at the District Office.

Local Resident Initiates Efforts For Hospice In Loving Memory Of His Wife

SynergyHealth to Build 'The Kathy House' Residential Hospice

A home-like, eight bedroom hospice for the terminally ill will be built by SynergyHealth on Mayfield Road in the Town of Polk. The idea for the residential hospice, the first of its kind in Washington County, was proposed by Ron Komasa, a Richfield resident whose wife Kathy died of cancer in June 2002. Komasa is leading efforts to raise funds, including his own, for the \$1.5 million facility.

Construction of The Kathy House, named for Kathy Komasa, is scheduled to begin in spring 2003. The free-standing building will be located on the site of the new hospital to be built by St. Joseph's Community Hospital of West Bend at the intersection of Highway 45 and Pleasant Valley Road.

The Kathy House will provide care and comfort to individuals diagnosed with a terminal disease. The residential setting will provide an array of services to make the patients' last days more comfortable, and address the medical, emotional, physical, and spiritual needs of patients and their families. Registered nurses, aides, social workers, and volunteers will provide care at The Kathy House.

The Kathy House will include eight bedroom suites with private baths, outside patios, overnight accommodations for families, individual temperature controls, and other home-like features. The facility will include a family lounge, kitchen, dining room, sunrooms, meditation rooms, nursing office, children's playroom, pond, serenity gardens, and a garage. The rural, wooded site will provide a natural and quiet setting for the hospice facility.

"The Kathy House is Ron's dream in memory of his wife, and a gift to all those families in our area who, unfortunately, may also face a termi-

nal illness. The Kathy House will provide a peaceful, comforting environment and will answer a very real need in our community. It will be a blessing in difficult times," said Deb Lauenstein, director of marketing and planning for SynergyHealth.

The Kathy House Fund Drive through the

SynergyHealth Foundation is providing potential donors with several naming opportunities for the various rooms and suites. Donations will be used to help finance the \$1.5 million estimated development costs and also to fund a \$1.5 million endowment reserve to support future operating costs.

Kathy Komasa was a wife, mother, grandmother, and a teacher with a master's degree from UW-Milwaukee. Residents of Washington County since 1980, Ron and Kathy were married in 1965 and raised three children, Greg, Kristin, and Bryan. Kathy was an enthusiastic teacher, having started an

all-day kindergarten program at a Milwaukee school in 1969, long before such programs were common. She and Ron also sponsored scholarships for high school students who wanted to teach. A gifted artist, Kathy also volunteered as a docent

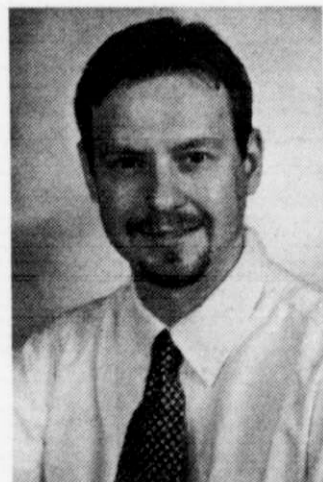

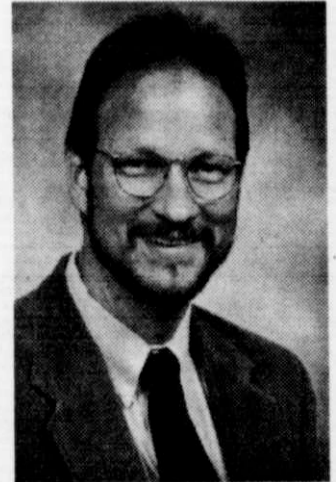

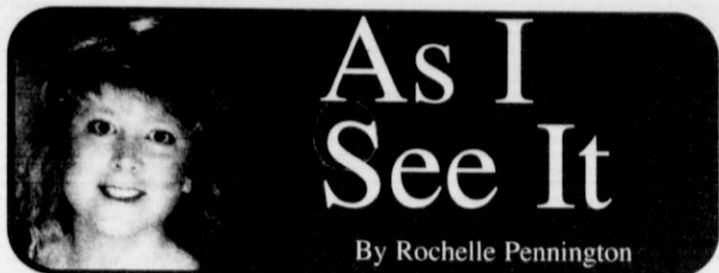

at the West Bend Art Museum, and she helped cancer patients as a Reach to Recovery volunteer.

Kathy was diagnosed with breast cancer in 1995 at St. Joseph's Community Hospital of West Bend and underwent a mastectomy at a Milwaukee hospital. When the cancer spread a year later, Kathy went through difficult chemotherapy and radiation therapy treatments. After five years of being cancer-free, cancer returned again in June 2001. Despite additional treat-

ments at several different hospitals outside the area, Kathy learned the next spring that she had only weeks to live. Hospice care in Milwaukee, while far from home, provided a comforting place where Kathy could continue to see her family and be cared for with dignity and fullness. Kathy died on June 18, 2002 at the age of 56.

July 15, 2002
8:00 p.m.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Regular Session in the Council Room of the Municipal Building, 204 First Street.

President John D. Kenworthy presided. Trustee Robert Stoltzmann asked to be excused and was absent. All other Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Larry Ammel, seconded by Trustee Thomas Piwoni and unanimously carried by voice vote, the minutes of the June 17 & 25, 2002 meeting were approved as printed, with one name correction on the minutes of June 17, 2002.

County Supervisor Daniel Stoffel was present to report on the financial situation of the county and also of the County Library system. It was noted that the shared revenue program is still in jeopardy and that the purse strings will be tight. The Board thanked Supervisor Stoffel for attending.

The three residents located adjacent to the water tower painting project were present to ask for help in reference to cleaning up the mess caused by the sandblasting of the tower and to receive some assurances that the Village would help with monitoring the clean up and the covering of cost related to the clean up by the residents.

Village President John Kenworthy assured those in attendance that the Village would be supportive and was sorry for any inconvenience. Mr. Tom Van Gemert with Dixon Engineering, the Engineering hired by the Village of Kewaskum, concurred with the Board. Several points were addressed as follows: 1) No sandblasting will be allowed when the wind/breeze is out of the east. 2) Assured the property owners the material used for sandblasting and the paint does not create any health hazard. 3) That approximately 2 to 3 days are left on the sandblasting, depending on weather. 4) The paint would be rolled or brushed on. 5) Acknowledge the project could and should have been handled in a better manner. 6) The contractor should have notified the parties involved and stated in the contract. 7) Damage done to private will be corrected. 8) The mess will be cleaned up or paid for.

Mr. Van Gemert indicated he would notify the insurance carrier. The Board also told the people that consideration would be given to tarping or skirting the tower prior to having the work completed next time.

Two candidates for the 59th Assembly District, Mr. Rick Karshna and Mr. Mark Brunner, were present to introduce themselves to the Board; Mr. Brunner addressed the Board briefly.

Fire Chief Mark Groeschel was not present; the department was assisting with the train derailment in the Town of Addison. It was noted they have and are still participating in the fire fighting efforts in the Town of Lomira at Quad Graphics.

Cranberry-Pumpkin Bread

Makes a 2 pound loaf

- 1 cup dried cranberries
- 3 tbsp. brandy
- 1 cup water
- 1/2 cup pumpkin puree
- 3 tbsp. nut oil
- 4 cups bread flour
- 1/4 cup light brown sugar
- 3 tbsp. dry buttermilk powder
- 1 tbsp. plus 1 tsp. gluten
- 2 tsp. salt
- 1 3/4 tsp. pumpkin or apple spice
- 2 1/2 tsp. SAF Perfect Rise Yeast

1. Sprinkle dried cranberries with brandy in a small bowl. Cover with plastic wrap and let stand at room temperature for 1 hour to macerate.

2. Place ingredients, except cranberries, in pan according to the order in manufacturer's instructions. Set crust on medium and program for the Sweet Bread cycle; press Start. (This recipe is not suitable for use with the Delay Timer.) When machine beeps, or between Knead 1 and Knead 2, add cranberries and any extra brandy in the bowl.

3. When the baking cycle ends, immediately remove the bread from the pan and place it on a rack. Let cool to room temperature before slicing.

Outdoor Adventures

with
Mark Walters



Hello friends,

I'm going to jump off the main trail with this week's column. When you have finished reading, I hope you will have been entertained, learned a thing or two and understand how my family and I are trying to stay as close to Mother Earth as possible.

When I was 5 years old, I had two goals. The first was to spend as much time hunting and fishing with my dad as I could. The second was to become a farmer. By age 9, I was playing and working on the Lavern and Vivian Gorman dairy farm. Bruce Gorman was in my class and was my number one hunting buddy (besides my dad). Our time together on the farm was either spent doing chores, baling hay, picking up rocks, shooting guns or fishing. At age 12, I believed I was reaching my goals.

Fast forward eight years to when I was 20. A friend and I rented a broken down farm for a hundred bucks a month. We fixed it up and proceeded to become farmers while I worked full time across the road on another farm. On our farm we raised hogs, which we farrowed from 10 sows. We bottle fed and raised 10 pailer calves until they were ready to be butchered. We sold eggs from our flock of 30 chickens and kept hundreds of rabbits which we butchered and sold about 10 a week.

At the age of 21, I had pursued my goal to be a full-time farmer. I realized after two years of record keeping, I was going deeper into debt and working at least 60 hours a week.

At the top of this column I wrote that I had two goals - the first being a hunter and fisher. The hunting and fishing took a big step backward in my farming days. When I broke my back in a car accident, I spent 14 days thinking about my life while lying in University Hospital in Madison. I decided another career was in order and became an apprentice welder.

Are you still with me? Maybe wondering what the heck this is doing in the outdoor section?

Let's fast forward again

for exactly 20 years into the present. Life is full of change, but in the end, so many things stay the same. I am in my 13th season as an outdoor writer, happily married and the father of four hungry kids.

Two years ago, my wife Laurie and I purchased a home in Juneau County near the Petenwell Flowage. Last summer we attempted to grow a garden as we have done for years. Unfortunately, the sand we live on has no nutrients in it to grow a crop unless it is given supplemental feed.

Last fall, we began heating with wood in our attempt to become self sufficient. This spring, I was in a store picking up some hamburger meat. Once again I became disappointed with the choice I was given. Steaks were \$7 a pound and the burger was more white than red and had water running out of the package. With all these kids around to eat beef and help raise it, I decided we could build a fence and grow some quality meat.

I started doing my research in May (calf prices, local on-site butcher and someone to feed the calves when the Walters are gone for the night). In high school I took agriculture classes. Even after getting off the farm, I still listened to the farm markets, I am sorry to say calves are the same price they were in 1982 and corn is 75 cents a bushel cheaper.

These prices are good for a hobby farmer, like myself, but devastating to the full-time farmer. He pays twice as much for a pickup truck and just about everything else he uses.

At this point in my life, I am fortunate to be able to say I am reaching my goals. Unfortunately, for my friend the farmer, finances are not good. This is chasing the majority of their children from the farm and, in many cases, the land goes to housing developments instead of fields and forests.

Laurie and I will always do our best to stay on top of our game. I wish there was something we could do for the farmer.
