Kenworthy Won't Seek Re-Election as President

Village President John Kenworthy has announced he will not

seek re-election this spring.

In an email to the media received Monday afternoon, Kenworthy stated "I just wanted to inform all of you that at tonight's Village of Kewaskum Board meeting, I will be announcing that I will not run for re-election in the Spring."

Kenworthy had served on the board since 1996 when he won a trustee seat.

He cited several reasons for his decision. Most importantly Kenworthy states, "Probably most important, I will be seeking to work, assist, help folks on a more personal level as a Stephen's Minister for my church,

Trinity Lutheran in West Bend. I feel that I can bring more to the one on one interaction with folks than perhaps I can banging a gavel every other week on the Village Board. Or, to paraphrase Albert Camus... Perhaps we can not stop this from being a world in which children suffer, but we can lessen the suffering of one child. I aim to try."

Those interested in running for the seat or a trustee position can start circulating nomination papers Dec. 1. Papers can be picked up at the village hall.

Fillmore FD Battles Blaze in Farmington

Fillmore Fire Department was called to 8020 Indian Lore Road in the town of Farmington for a structure fire on Saturday at 6:40 p.m..

According to information released by the Washington County Sheriff's Department a decaying outbuilding, consisting of a wooden frame with a sheet metal roof and sides, burned down to its foundation. The flames additionally caused damage to some surrounding trees.

According to the owner of the property, Carl R. Johnson of West Bend, there were some items inside the

building, they were of little or no value. No total dollar damage estimate was available.

The fire was extinguished by the Fillmore Fire Department with the assistance of tankers from Boltonville. The exact cause of the blaze was not readily explainable. It remains under investigation at this time.

McCallum Visits Washington County, Regal Ware

Governor Scott McCallum spent his day Thursday on his campaign bus along with a crowd of staff members and county supporters. As one of those county supporters, I had the opportunity to ride along. The governor and staffers have put over 18,000 miles on the bus that was

once used to transport children to school and on field trips in this school district.

Our day started off in Slinger where the now infamous bus picked up some very nice ladies from the county's republican women along with two members of the county party and me.

First stop of the day was a tour of the Broan-Nu Tone plant in Hartford. In con-

trast to what *Journal Sentinel* columnist Mike Nichols stated in his column Friday, the governor's visit was received very warmly by the company's vice president, Wayne Losinske and McCallum was taken on a private tour of the company after receiving a welcoming gift. The number of people attending were sparse but this was not a media event,

and was not meant to be publicized, according to McCallum communications staffers. The governor simply wanted an opportunity to meet with the voters, "his employers" as he stated it later in the day. I would have to agree with Nichols, the "suck-up phenomenon" was not present on the visit. But, why should it be?

"Gov. McCallum wanted to go through Washington County to see examples of our industry, to meet and exchange dialogue with the workers... we were asked not to alert media or create a hoopla to distract from the personal atmosphere our Governor loves to be part of. He succeeded... we received several calls from people that crossed his path yesterday, all positive and appreciative," said Crystal Berg of the Washington County Republican Party.

A Broan Nu Tone public relations spokesperson agreed. "We were honored to have the governor visit our operations." When asked about the Nichols column, she stated "I would rather not discuss it, we're trying to forget it."

It might have paid for Nichols to stick around, he

might have gotten a different point of view, but, of course, maybe he didn't want that. Being in the newspaper business I know that good, positive stories do not sell as many newspapers as Nichols negativity does.

The bus then traveled to Kewaskum where once again the governor and the bus riders were greeted warmly by the Reigle family and employees of Regal Ware, Inc.. If you were on the factory floor last Thursday chances are you met the governor's as he did not leave one hand unshaken.

After a quick lunch break at the Washington County Republican Party headquarters the governor was given a tour of the UW-Washington County campus. He later addressed students and their questions. Teachers and students alike were anxious to meet the governor, you could almost see a minute bit of "suck-up phenomenon" by students and instructors.

It seemed as though as the afternoon continued that phenomenon really started catching on, once boarding the bus from the campus Jackson's Village President, Scott Mittelsteadt and "First lady" were more than eager to chat with the governor.

Upon arriving at Jackson's Universal Strap cameras were flashing and video

cameras were rolling. "McCallum Wisconsin" neck straps were given to each visitor before beginning the tour of the new plant. Once the tour began almost the entire village board showed up to see THEIR governor.

McCallum ended the visit by speaking with Universal Strap employees but not before *Journal Sentinel* reporter Peter Maller decided it was ok to take a cell phone call during the governor's presentation.

I thought maybe it was his buddy Nichols calling to see if the "suck-up phenomenon" had escalated. Apparently not though, because, before Maller would allow the governor to get more than 10 feet from the building and say his good byes to the people at Universal Strap, Maller had to play 20 questions about the recent scandal involving Senate majority leader Chuck Chvala.

Maybe I'm in the wrong business, I'm not hardcore enough like my colleges, but, there's something to be said about bringing out the best in the community and I hope our staff and myself never have to resort to the negativity and rudeness these two did on Thursday. *Governor, you may not have the support of big city daily, but you do have much support from your small, family owned and operated weekly!*

Halloween Safety Recommendations

With Halloween and Trick or Treat on Sunday, October 27, the Kewaskum Police Department would like to offer the following safety tips to make this a safe and enjoyable trick-or-treat for everyone:

Costume Safety:

- Use make up or face paint instead of masks, but if masks are used, make sure that they fit properly and have holes large enough for mouth and eyes.

- Choose costumes that are marked flame retardant.

- Wear light colored clothing at night, short enough to prevent tripping. Add reflective tape or reflectors to dark colored costumes.

- Make props such as magic wands and swords out of cardboard, rather than metal or wood.

Trick-or-Treat Safety:

- Give and accept wrapped or packaged candy only.

- Have children bring treats home for adult inspection before they are eaten.

- Accompany small and elementary school age children when they are trick-or-treating and send older children in groups.

- Go out in daylight and carry a flashlight in case of

delay.

- Have the children stay within the neighborhood; only visit homes you know.

- Do not follow your children in your vehicle. Children are excited and may run out in front of a vehicle without thinking.

Thull Wins 2002 KEYS 5K Run, McMahon Wins Women's Division

The cool and rainy weather that persisted Saturday stopped, and Sunday morning brought cool temperatures but plenty of sunshine to welcome 899 runners and walkers for the ninth annual KEYS (Kewaskum Youth Scholarship) 5K Run/Walk. The number of participants was the fourth largest in the KEYS 5K Run/Walk history.

Matt Thull won the race for the sixth time in a row with a time of 15:06, just four seconds slower than last year despite the cool temperatures and wind on Sunday, October 13th. Thull, a former Campbellsport resident and CHS athlete, who competed at the University of Wisconsin - Oshkosh where he earned All-American honors in track and cross country, now teaches Physical Education in Milwaukee. Aaron Nodolf was second in 15:09 and Scott Branta finished third in 16:11.

In the women's division, Dot McMahon won with a near record time of 17:42, just four seconds off the course record held by Sue Daggett-Miller. Lauren Jensen finished second in 18:09 and Sue Daggett-Miller finished third in 18:12.

A total of 899 people registered and almost 700 people crossed the finish line for this popular fundraising event, held in conjunction with Kewaskum's Kettle Kounty Kolors. Students from Kewaskum, Farmington, Wayne, Holy Trinity, and St. Lucas elementary schools, along with students from Kewaskum Middle and High Schools made up a large portion of the participants. "The people of Kewaskum and the surrounding areas again did a fantastic job supporting the KEYS 5K Run/Walk," reported Jerry Gosa, one of the race organizers. Over 60 people registered Sunday morning despite the cool temperatures.

"We are very thankful to all the people who registered and made the run so successful this year," reported Gosa. "We also want to thank all of our sponsors and especially the team captains at the schools, who worked so hard in getting students and their families registered. The help we received from all these captains and all the volunteer high school students, made this event run smoothly and successfully," concluded Gosa.

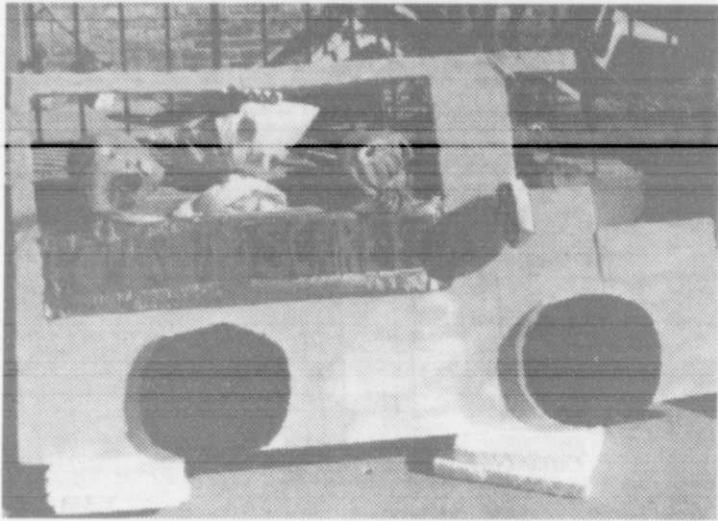

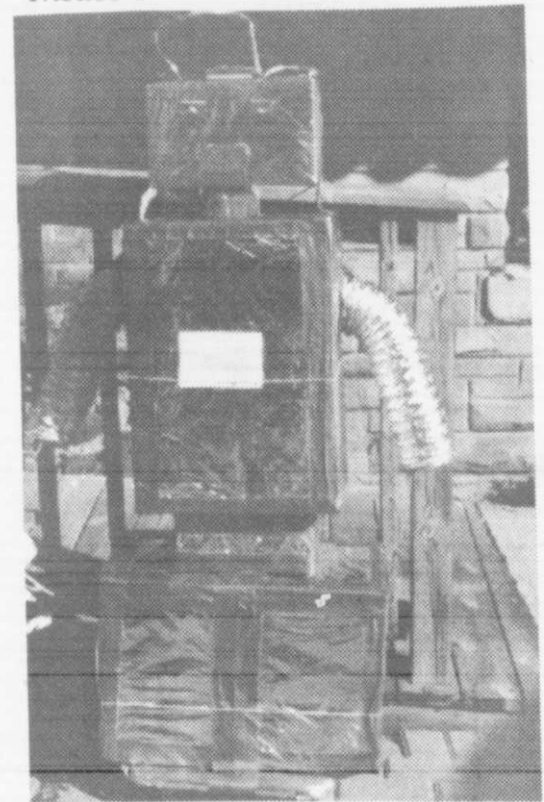

through taxes -- everyone should share in paying for the education of our students, including proper facilities and equipment.

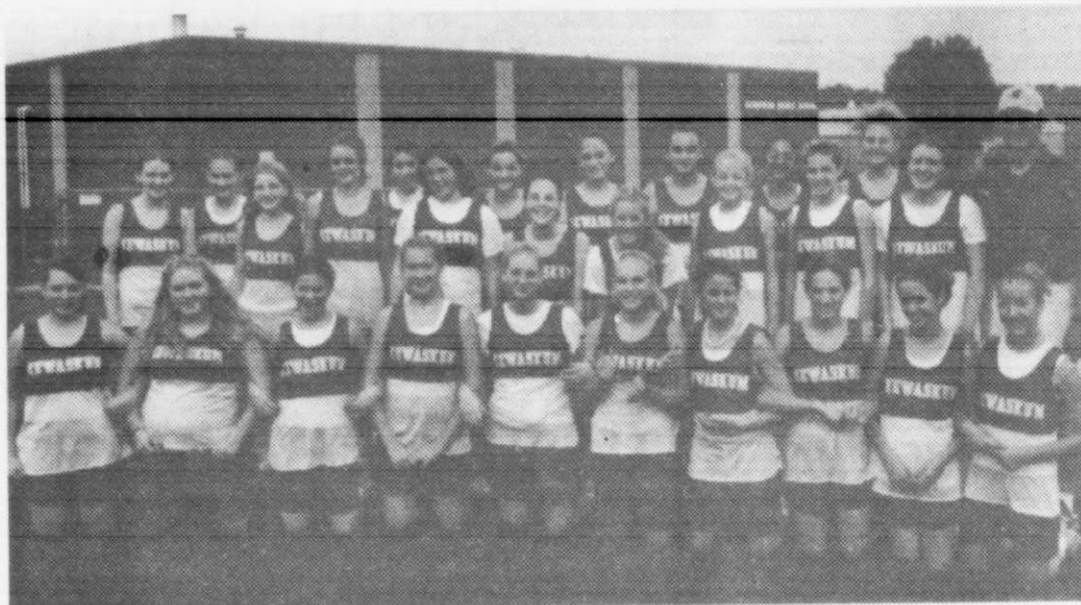

The Kewaskum Middle School girl's track and field team won the 2002 Moraine Conference Track and Field Championships on Tuesday, October 8. The conference championship was the second for the eighth grade team. Last year as seventh graders these same girls also won the seventh grade conference track championship.

Kewaskum edged favorite West Bend's Badger Middle School 107.5 to 101. Slinger finished third with 88 points and Germantown was fourth with 75 points followed by Hartford, 66.5, Pewaukee, 31, Silverboork, 26 and Waupun, 6.

Earlier in the season Badger had defeated Kewaskum 77-42 in a dual meet and had also won the Conference Relays. Kewaskum surprised the competition by not only winning three of the four field events, but also placing 1-2

in two of the field events - the shot put and the discus.

Brytne Sprinkman, last year's conference champ, won the shot put with a throw of 26' 3 1/2" and her sister Caytlin Sprinkman placed second with a throw of 26 1/2". Caytlin had been undefeated for the entire season until her older sister edged past her Tuesday night at the conference meet.

Lindsay Foley won the discus for Kewaskum with a throw of 83' 10" and teammate Bekki Heberer placed second with a season best throw of 78' 0". Both Kewaskum discus throwers beat a couple of very good throwers with Heberer improving by over four feet from her previous best.

"Finishing one-two in both throwing events and scoring the maximum of 18 points in both events for a total of 36 points was huge for the team. I am very

proud and happy for them. They did a very good job," commented eighth coach Jerry Gosa.

Sam Droese cleared 4' 7" on her first attempt and won the high jump for Kewaskum. Droese also was the conference high jump champion last year. Teammate Lindsay Foley tied for fourth at 4' 4". Sam Hedlund placed fourth in the long jump with a jump of 13' 1". Hedlund and Foley later finished third and fourth in the 400m dash both with season best times of 1:11.1 and 1:11.7 respectively. Their third and fourth place finishes in the 400m dash gave Kewaskum 11 points to add to the team total.

Courtney Uttech finished second in the 1600m run with a season best time of 6:22.7 and Sam Droese also finished second in the 800m run with a season best time of 2:47.3. "Both Courtney

and Sam did a great job. They both have a lot of running potential and I hope they and a lot of the other KMS girls run cross country and track at the high school next year," commented Coach Gosa.

Both Crystal Treptow in the 1600m run and Sam Kuphal in the 800m run, ran season best times, but just missed placing in the top eight.

The 4x100m relay team of Caytlin Sprinkman, Amanda Walker, Ashley Turner and Marissa Dehler finished second to Slinger in a photo finish with a season best time of 58.47 seconds, just 0.01 seconds behind Slinger. "We ran a great race and just got nipped at the wire. Our hand offs were very good. I am very proud of their effort," remarked coach Gosa on the 4x100m Kewaskum relay teams.

Ashley Turner also placed third in the 100m dash with a time of 14.8 seconds.

The 4x400m relay team of Crystal Treptow, Tiffany Hedlund, Sam Droese, and Courtney Uttech finished fourth with a season best time of 5:03 to ensure the team victory. "Crystal Treptow set the tone for the relay team when she went out and ran her fastest split of the season to start the race. Hedlund, Droese and Uttech followed with great efforts with Droese recording a 1:11 for the fastest split of the Kewaskum foursome," reported Coach Gosa.

The Kewaskum 4x200m relay team of Tori Schilling, Emily Sedgwick, Bekki Heberer, and Caytlin Sprinkman finished sixth with their fastest time of the season by over two seconds in 2:12.

Tori Schilling and Marissa Dehler finished

seventh and eighth in the 75m hurdles with times of 14.8 and 15.0 seconds respectively. Dehler, who had the fastest time on the preliminaries, hit the second to the last hurdle, fell, got up and finished the race in the finals. "I give a lot of credit to Marissa. She is a tough kid. She got scraped up pretty bad, but then came back and anchored the 4x100m relay to second place. When she went down so hard everybody was worried, but she didn't let it bother her," remarked Coach Gosa.

"We had a lot of very happy girls and parents after they announced the results. I am very proud of the effort, focus and desire the team showed. After we got beat so badly by Badger earlier in the season we all had our doubts about repeating as conference champs. The girls deserve a lot of credit. They went out and performed like champions," concluded Coach Gosa.

The Kewaskum Middle School girls track coaches, Jerry Gosa and Jeff Grotenhuis wish all athletes success in the classroom and in sports for the rest of the school year. The coaches would also like to thank all the parents, teachers, Mr. Soerens, the Kewaskum Middle School principal; and all the people who worked the home track meets this season for their support of the girls and the girls track program. The athletes received their Conference Relay ribbons, Conference Meet ribbons and each girls on the team received a medal for winning the Moraine Conference Track and Field Championships at their annual end of the season pot-luck supper and awards ceremony on Tuesday, October 15.

Indians Pick Up OT Win To Clinch Playoff Berth

After the three yard touchdown run by Ryan DeLaurier in overtime, the Indians sidelines erupted in celebration while the players stormed the field, as underdog Kewaskum varsity football team upset the Plymouth Panthers 27-24 in overtime in Plymouth last Friday, October 18.

The Indians got on the board early when Jake Wilson took the opening kickoff 86 yards for the touchdown. After the Matt Hartmann extra point the Indians took the very early 7-0 lead.

Plymouth however, would answer, despite the several near interceptions, the Panthers marched the ball downfield and capped it off with a one yard quarterback sneak by Kyle Melcher. The Josh Sippel extra point was good and the score was then tied 7-7 with about three minutes left in the first quarter.

After the Indians inability to move the chains on offense, Plymouth took the ball and marched downfield again. This time Kyle Friedrichs ran it in on a draw from 14 yards out. After the Sippel extra point, the Panthers took their first lead of the game, 14-7.

Plymouth would maintain that lead heading into the half. Then early in the third quarter, the Panthers drove again, and once again, Melcher would take the QB sneak in from two yards. After the Sippel extra point the Panthers increased their lead to 14 as the score stood at 21-7.

Then it was rally time for the Indians, and behind some nice running from Keith Schmidt, the Indians drove the ball and scored on a Schmidt one yard touchdown run.

The Hartmann extra point was good and the Indians closed the gap to seven as the score was 21-14, with a minute and a half

left in the third quarter. The score would remain that way for most of the fourth quarter.

Then while scrambling in search of an open receiver, Indian quarterback Travis Kempf lobbed one high in the air to his big tight end Kyle Rabuck. Rabuck jumped the cornerback in coverage and made the catch while landing in the end zone for the touchdown. The Hartmann extra point was good, and the Indians tied the game up, with 2:04 left in regulation.

After a Hartmann interception which was returned to around the Plymouth 30 yard line, the Indians were knocking at the door again. But the Indians offense was unable to convert, so with under a minute to go, they sent Hartmann in to attempt the 40 yard field goal. Hartmann hit the ball hard and it was straight enough, but at the last moment the wind blew the ball wide left.

The Panthers would then take a knee to run the clock out and send the game into overtime.

In overtime high school football works, team A gets four chances from the opposing teams ten yard line to score. Afterwards team B gets a chance to match or beat that score. The process is continued until there is a winner. The Indians won the coin toss and elected to defer.

So the Panthers took the ball at the Indians ten yard line and overtime began, but the Indians' defense would come up with a huge stand and the Panthers were forced to take the field goal on fourth down. The score then stood at 24-21 in the Panthers' favor.

Then it was the Indians turn, as they sent their wishbone offense out onto the field in attempt to overpower the Plymouth defense, with their large backfield of, Ryan DeLaurier 5' 9" 215, Troy Koefler 5' 10" 212, and Keith Schmidt 6' 1" 187. The

Indians picked up short yardage on first and, second down. Then on third and three, DeLaurier followed the offensive line surge by linemen Corey Darmody, Josh Peterson, Mike Donath, Brandon Gitter, and Jeff Bischoff, and lunged onto the pile and into the end zone for the game winning score, to make the final 27-24, and sending the Indians into the playoffs for the fourth straight year.

Offensively the Indians were led by Keith Schmidt who rushed for 105 yards on 19 carries and one touchdown. Dave Wicklund also chipped in 42 yards off seven carries, and he also caught two passes for 56 yards to lead the Indians in receiving. Matt Hartmann caught one pass for 25 yards, and Kyle Rabuck hauled in one for 24 yards which was a touchdown. Jake Wilson led the Indians in returns as he returned three kickoffs for 117 yards and one touchdown.

The Indians had 269 yards of total offense. On the defensive side of the ball Hartmann had his second interception in the past two weeks. While Pat Enright came up with the other Panther turnover, when he recovered a fumble.

Corey Darmody led the Indians with three sacks and he also had twelve tackles which was tied with three others for the team lead. Those three others included Troy Koefler, Ryan DeLaurier, and Mike Donath. Donath also recorded one sack. Defensive end Keith Schmidt also had two sacks of his own.

While the Indians beat Plymouth there was another big upset in the conference last week as Campbellsport toppled off the undefeated Sheboygan Falls 14-12.

With the win Campbellsport is tied for first in conference with Falls, but Campbellsport wins the tie breaker, being the team that beat them. With the Indians win they stopped the Panthers from claiming a share of the conference title, and are now tied with Plymouth for third place in conference.
